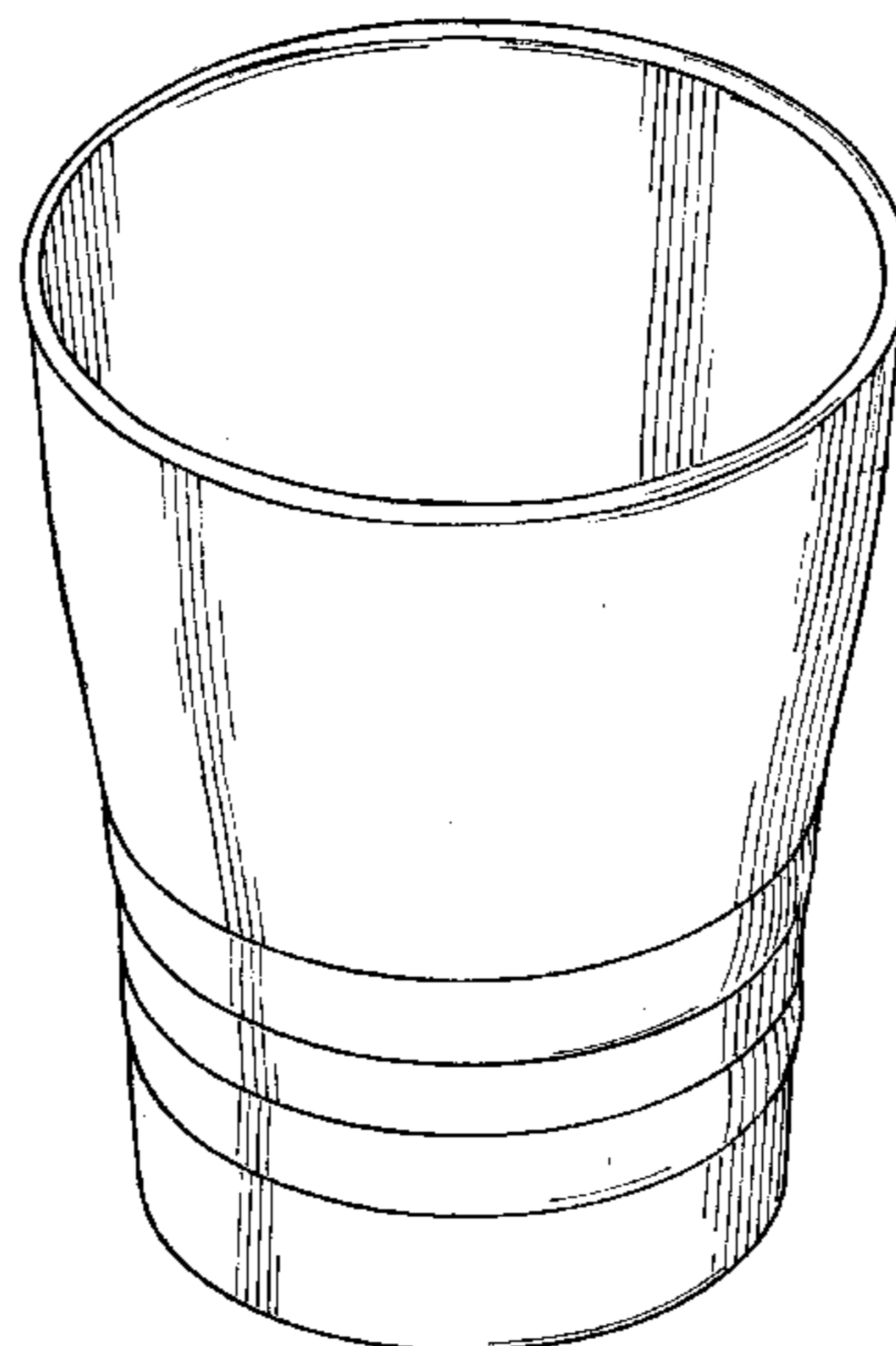
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view illustrating the cup constructed in accordance with the teachings of the present invention. FIG. 2 is an elevational view of the cup of FIG. 1. FIG. 3 is a top plan view of the cup of FIG. 1; and, FIG. 4 is a bottom plan view of the cup of FIG. 1.

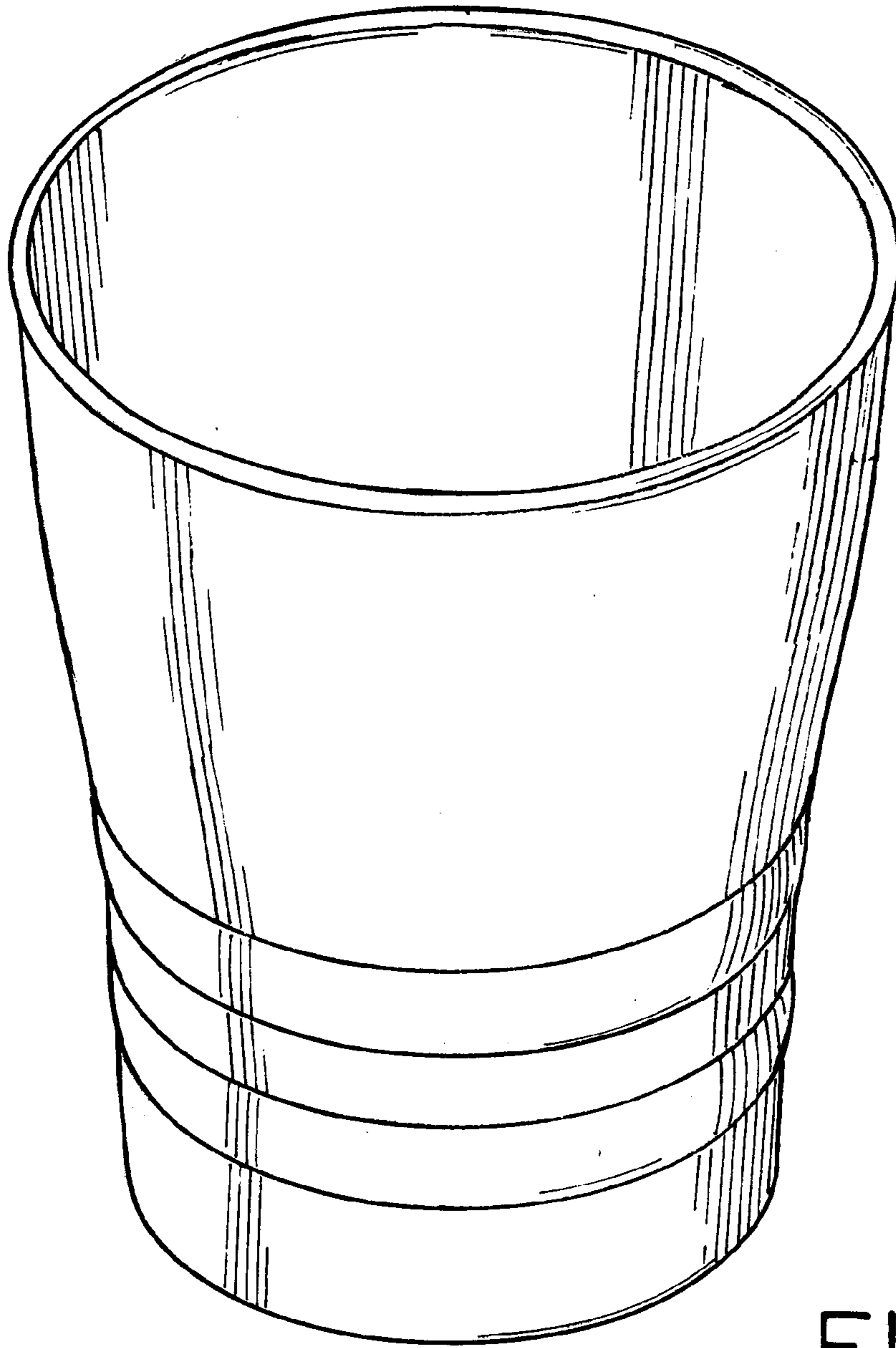

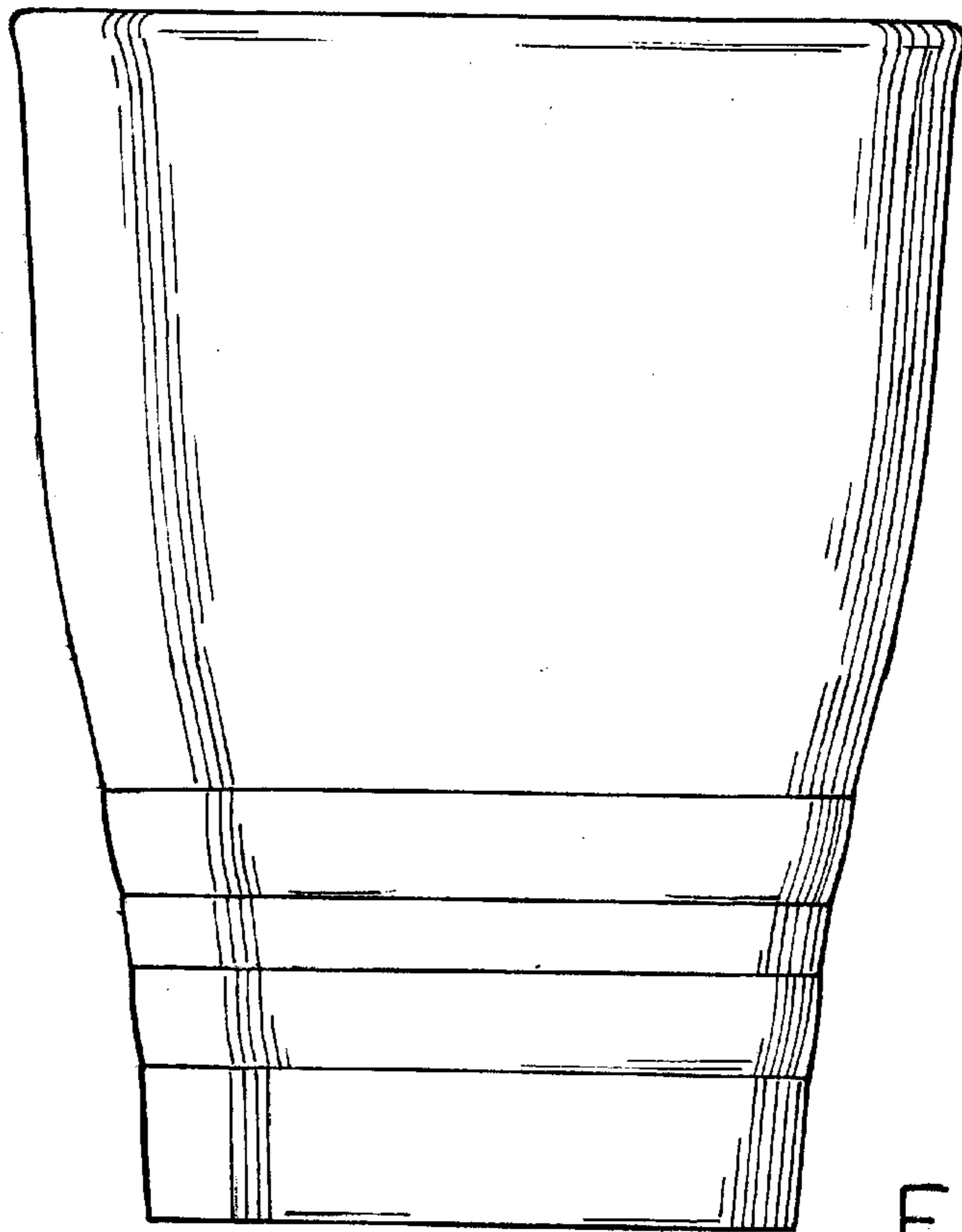

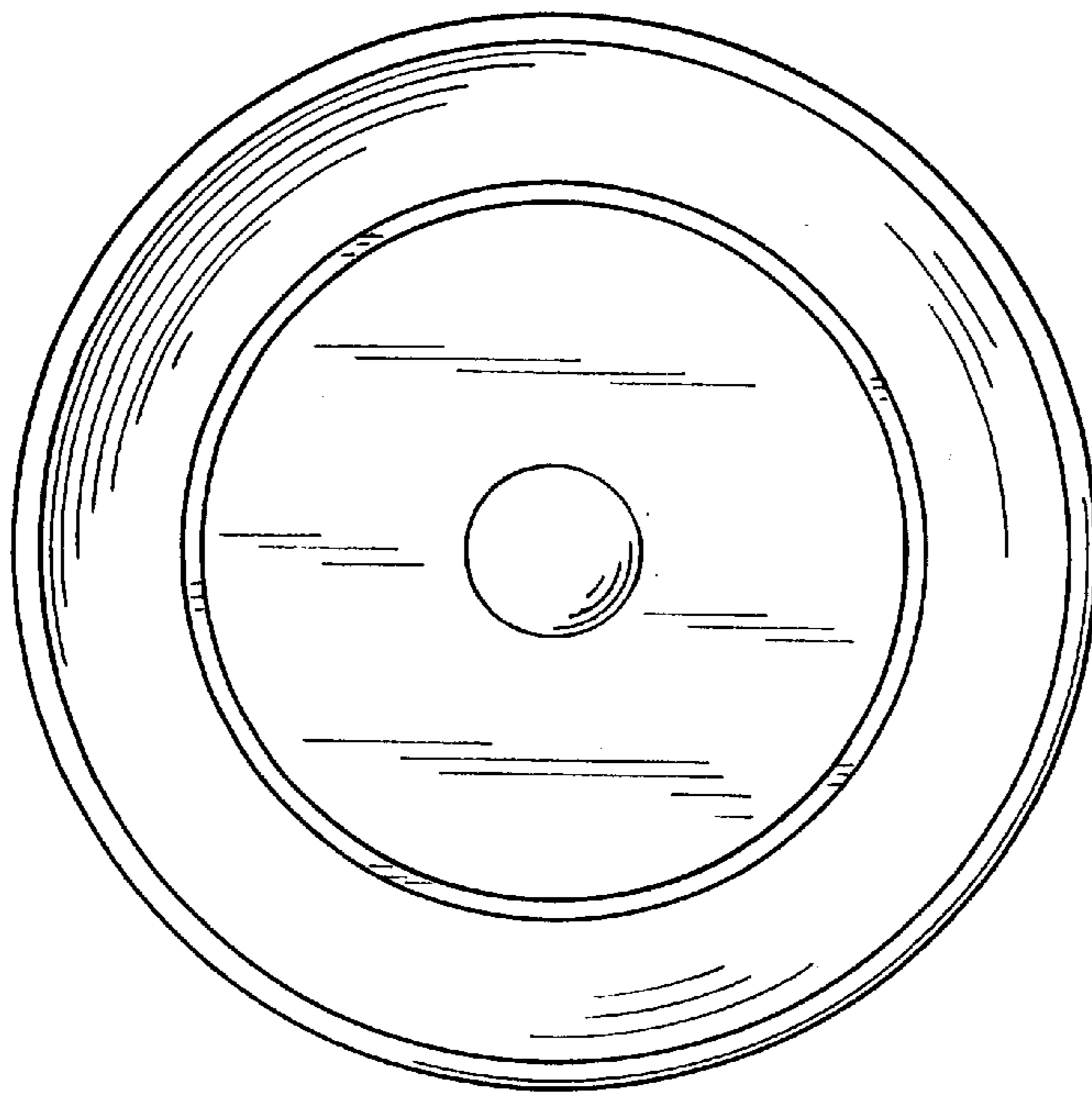

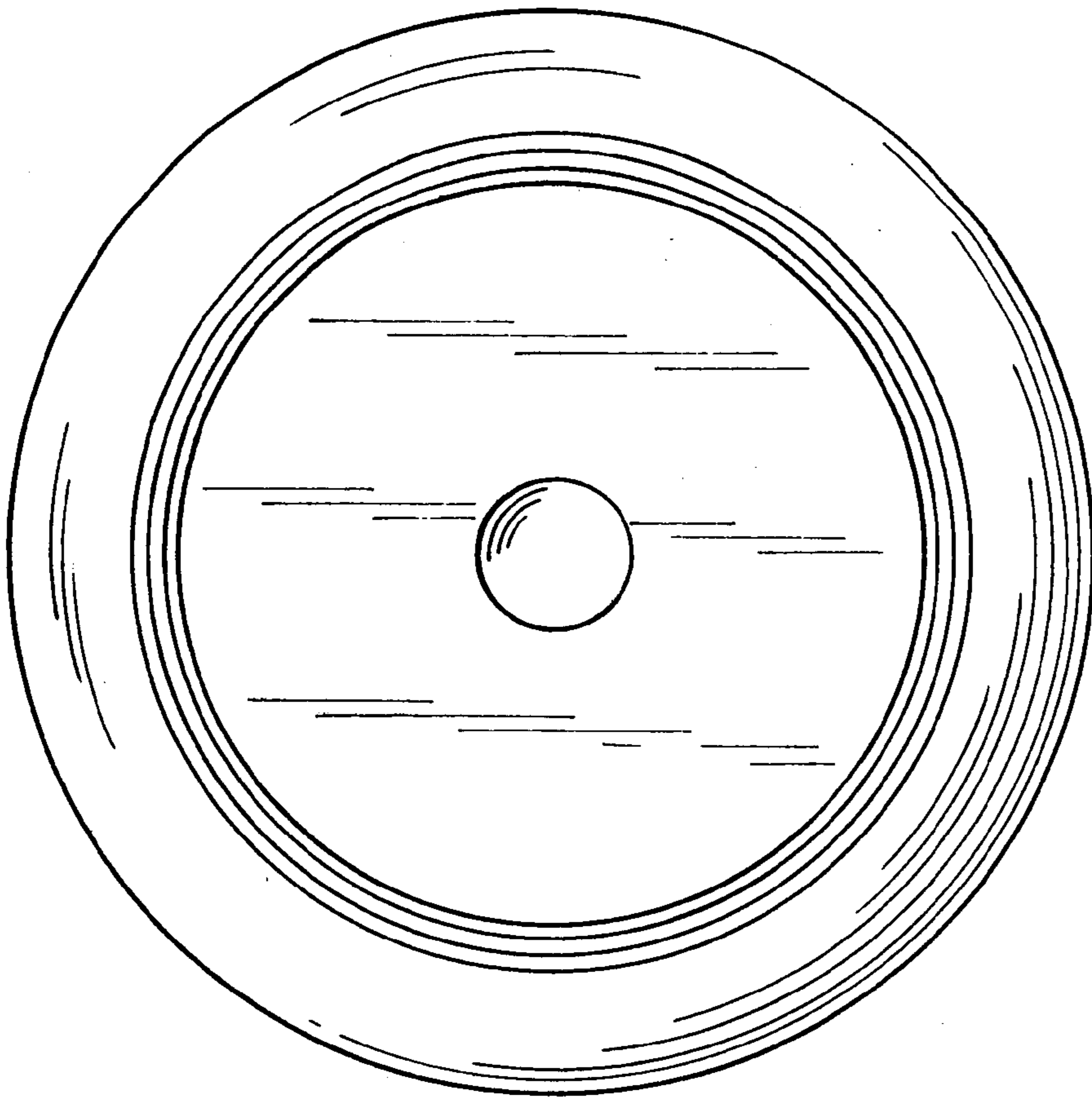
