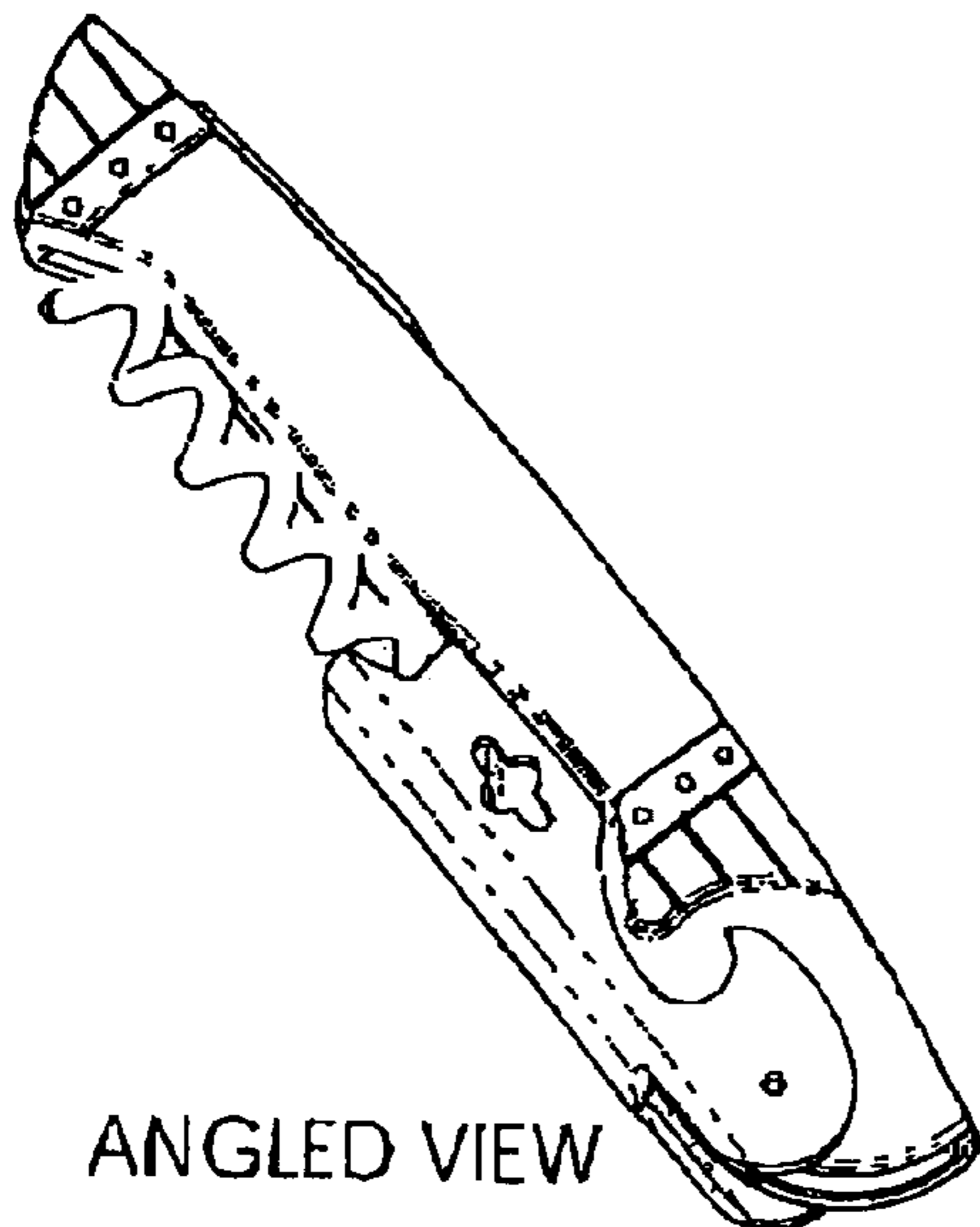
(57) **CLAIM**

The ornamental design for a corkscrew device, as shown and described.

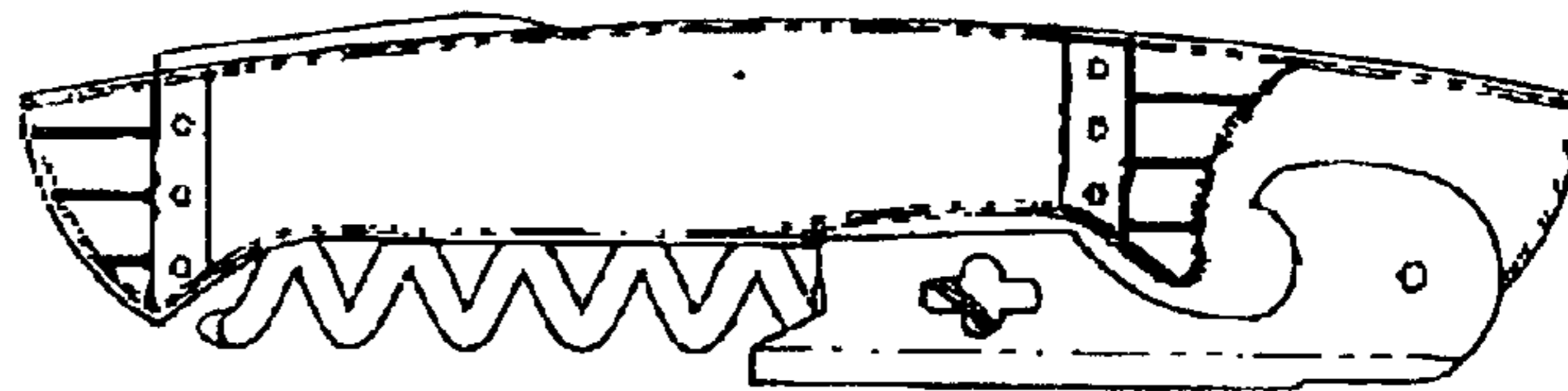
**DESCRIPTION**

FIG. 8 is a rear elevational view thereof.

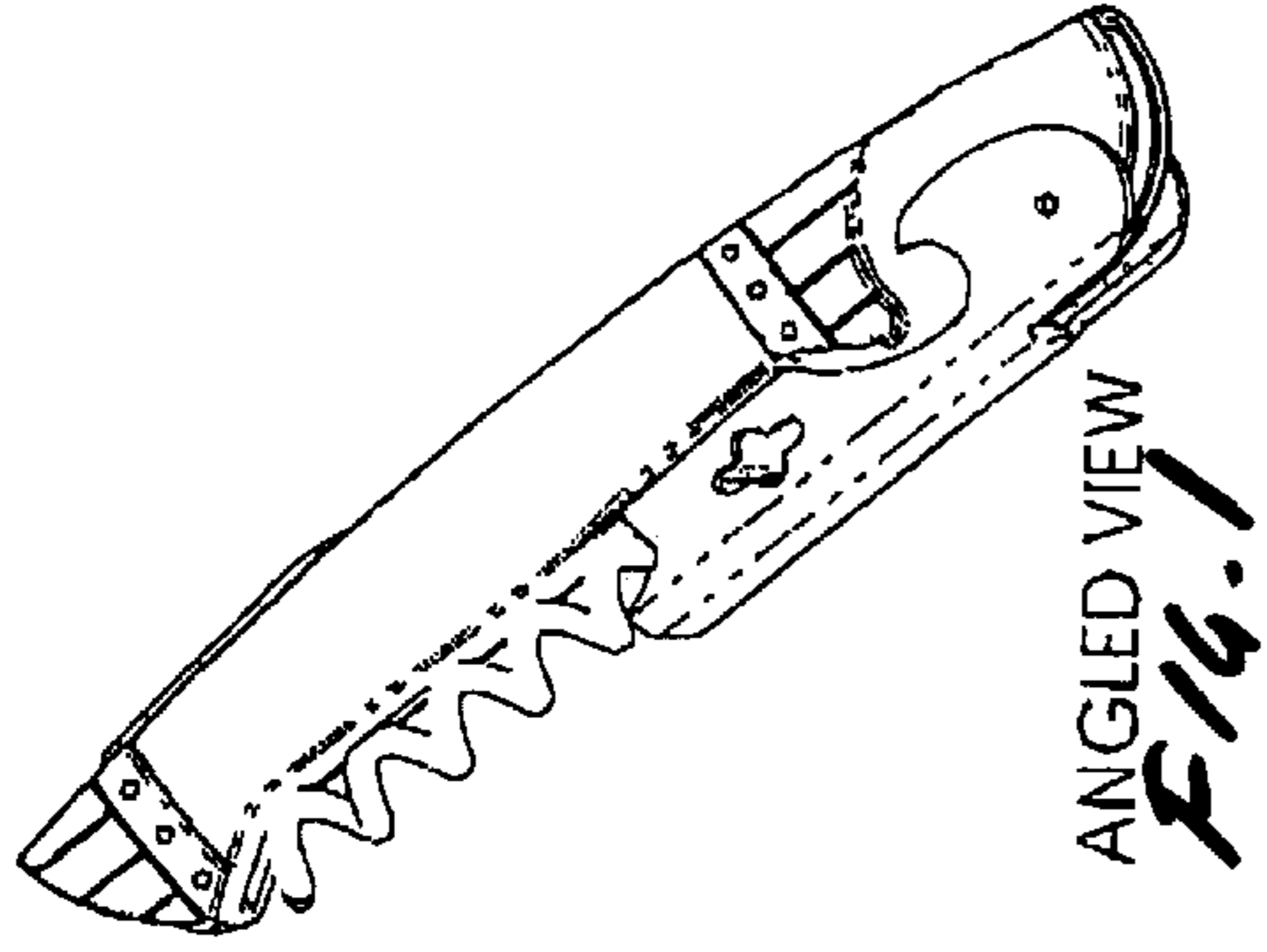

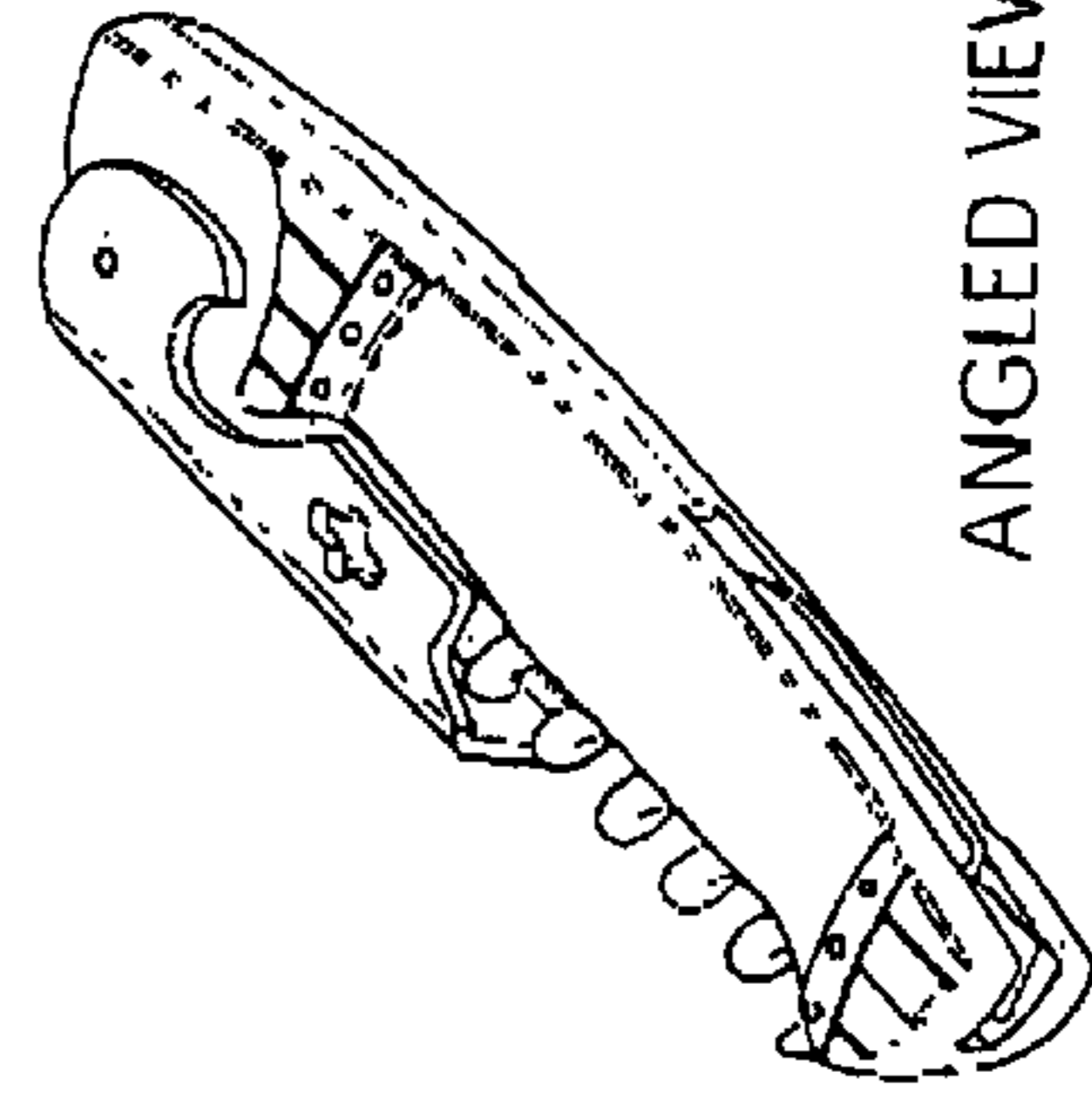

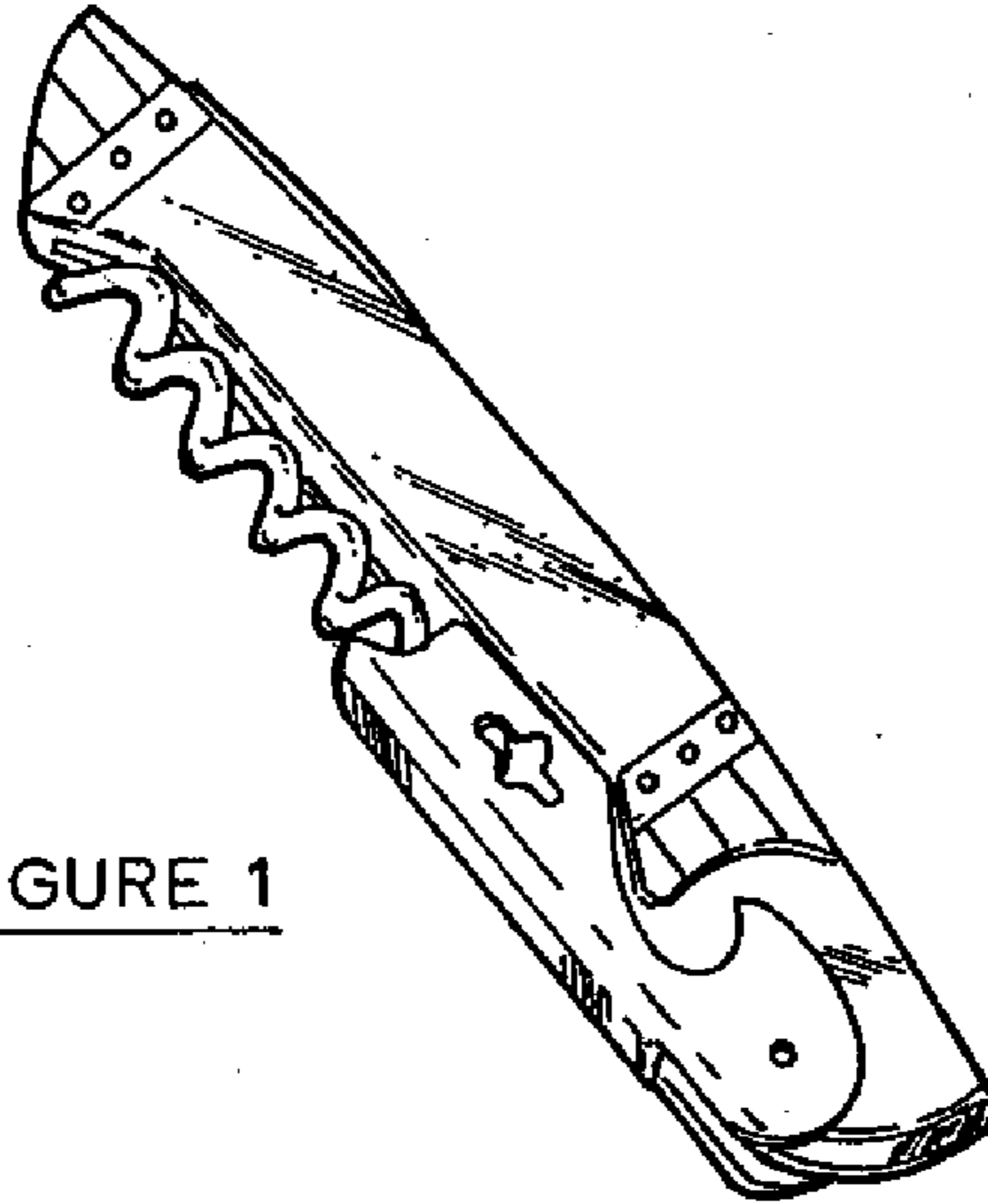

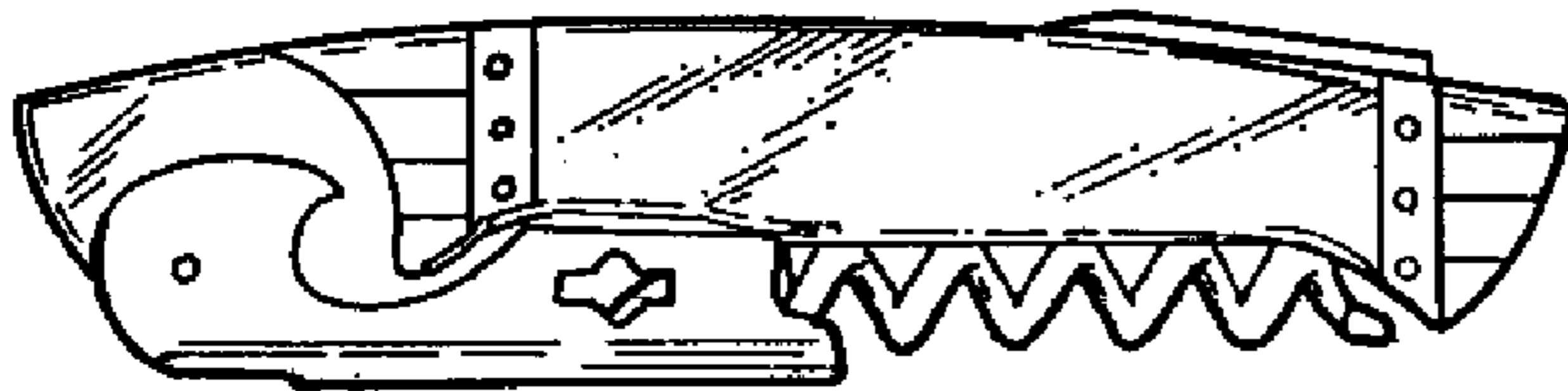

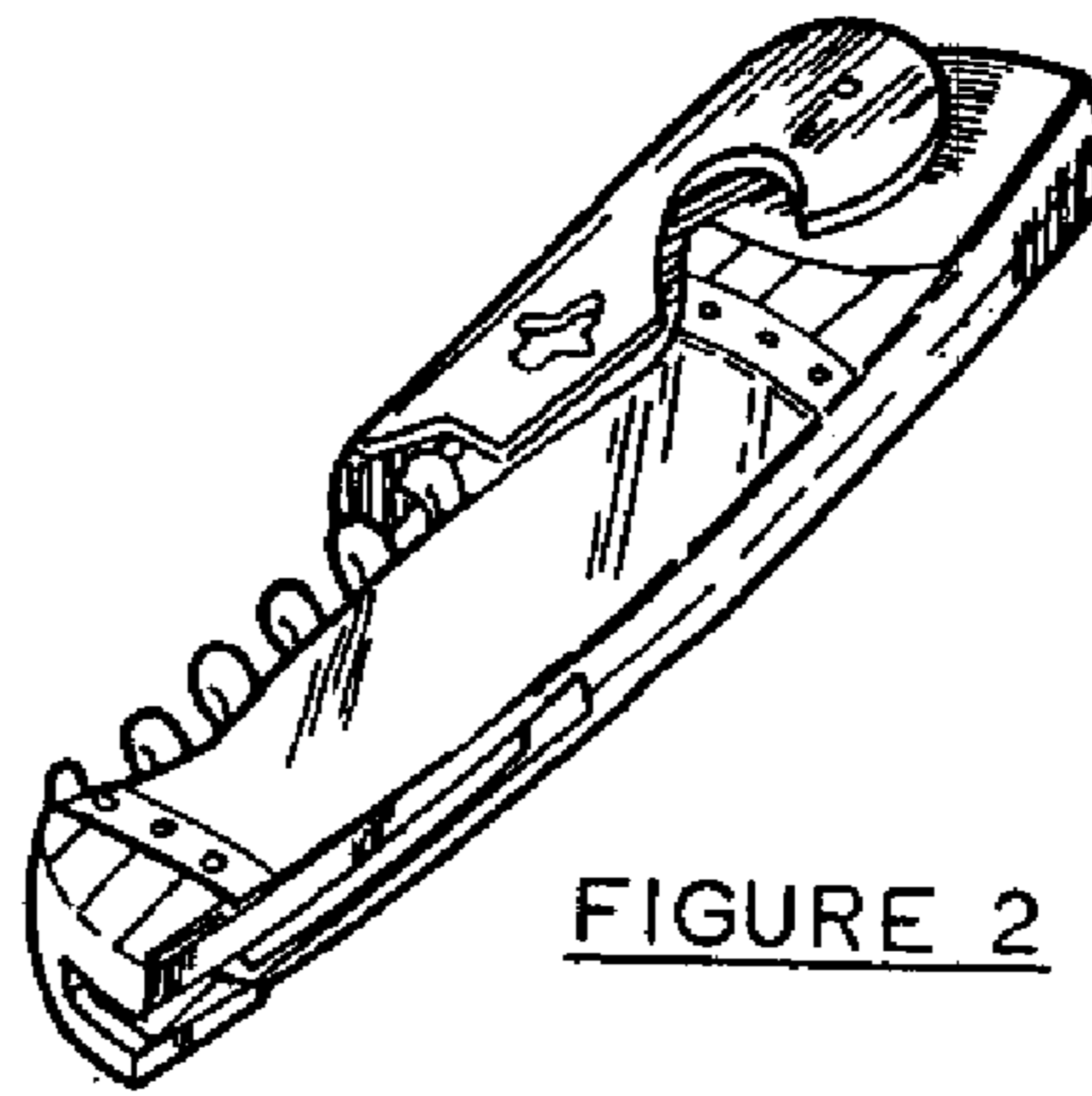

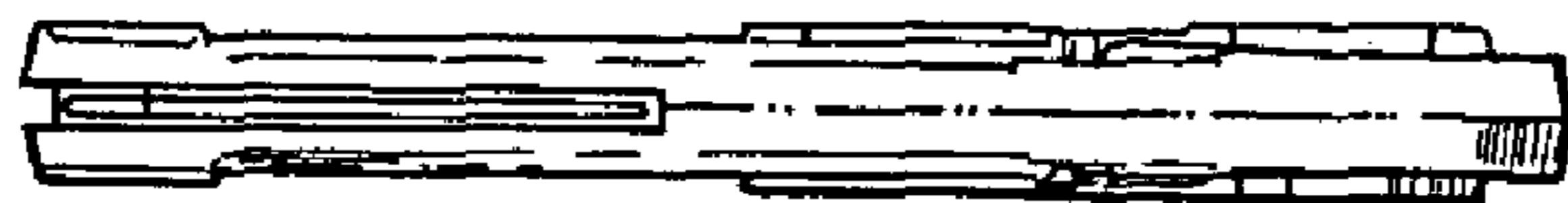
