(57) **CLAIM**

I claim the ornamental design for a DVD head unit, sub-  
stantially as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of the DVD head unit of  
the preferred embodiment of the present invention; and  
FIG. 2 is a front view of the DVD head unit of the preferred  
embodiment of the present invention;  
FIG. 3 is a rear view of the DVD head unit of the preferred  
embodiment of the present invention;  
FIG. 4 is a side view of the DVD head unit of the preferred

FIG. 5 is a top plan view of the DVD head unit of the

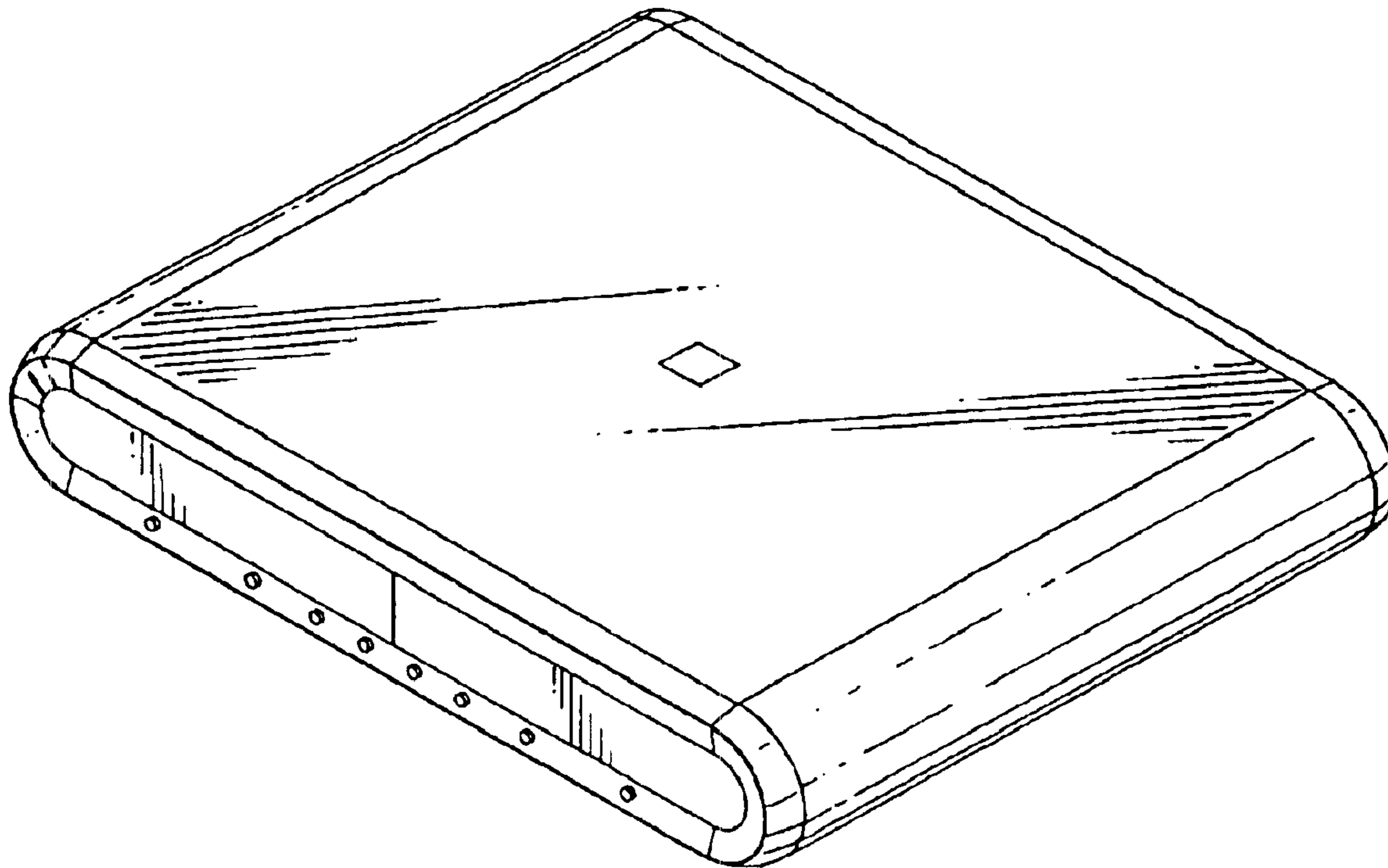

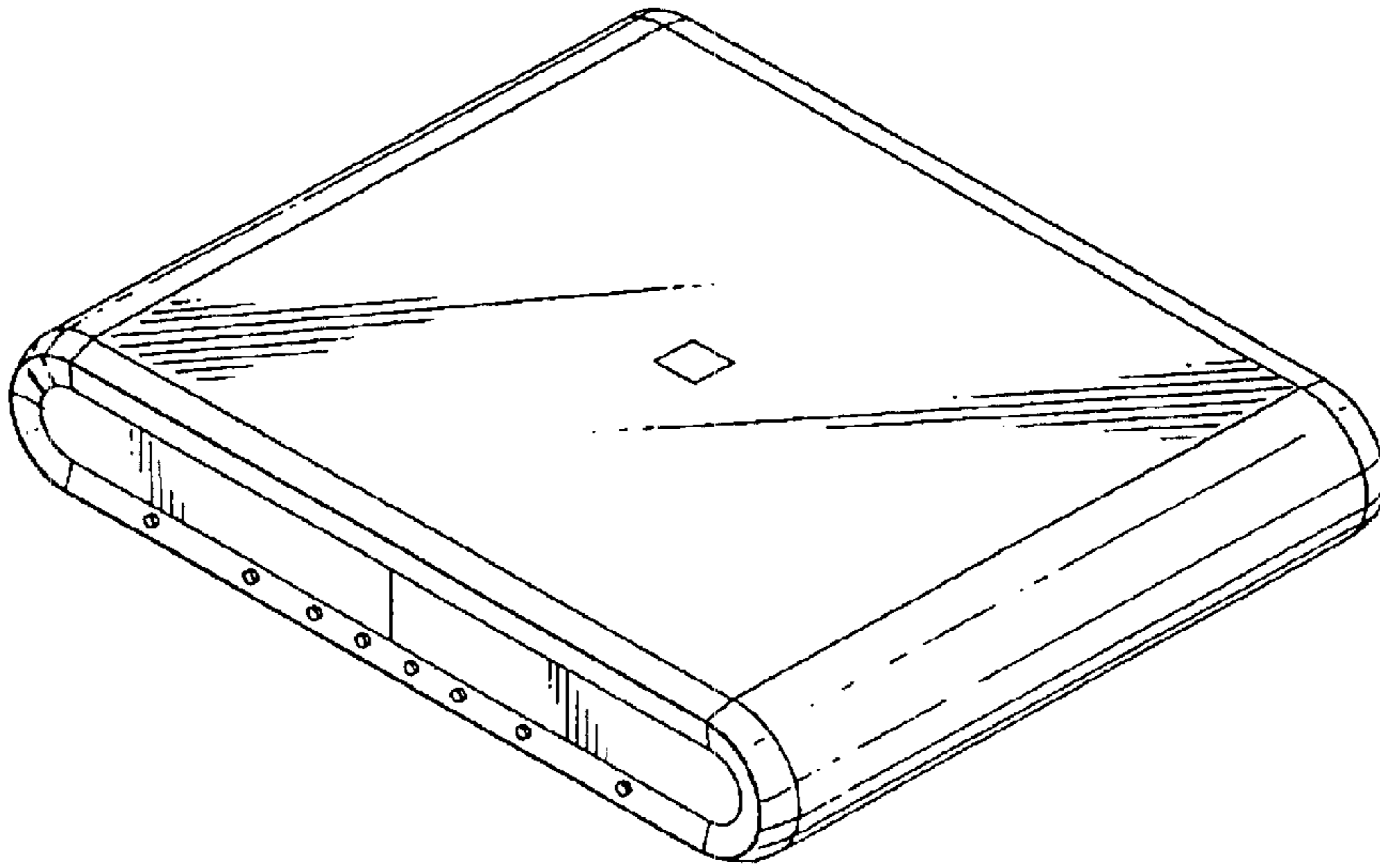

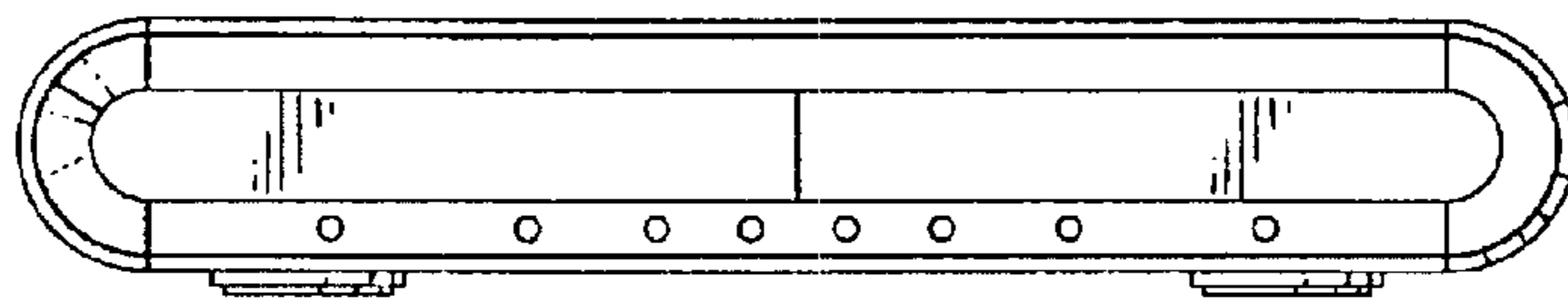

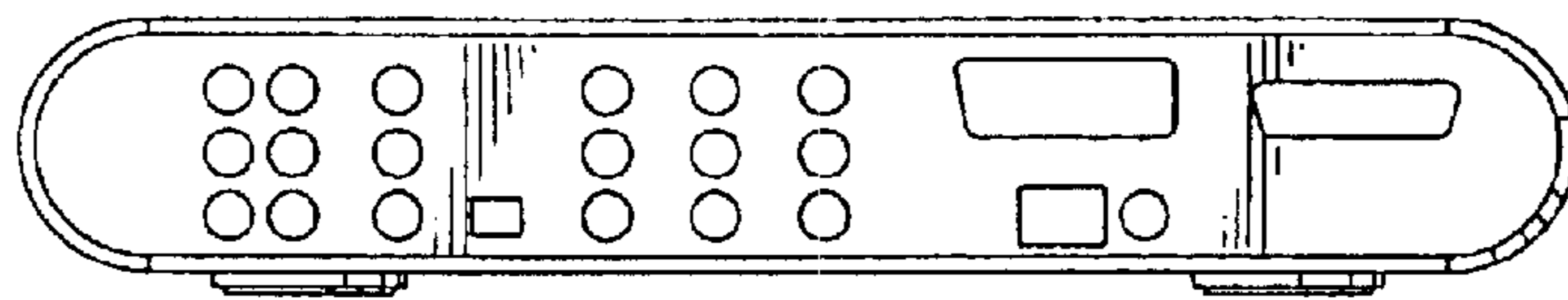

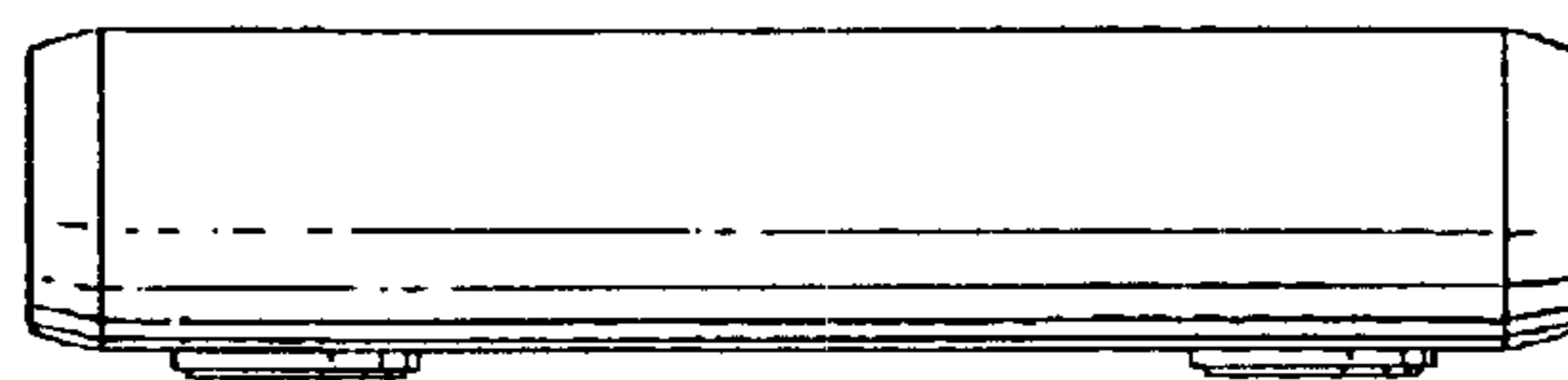

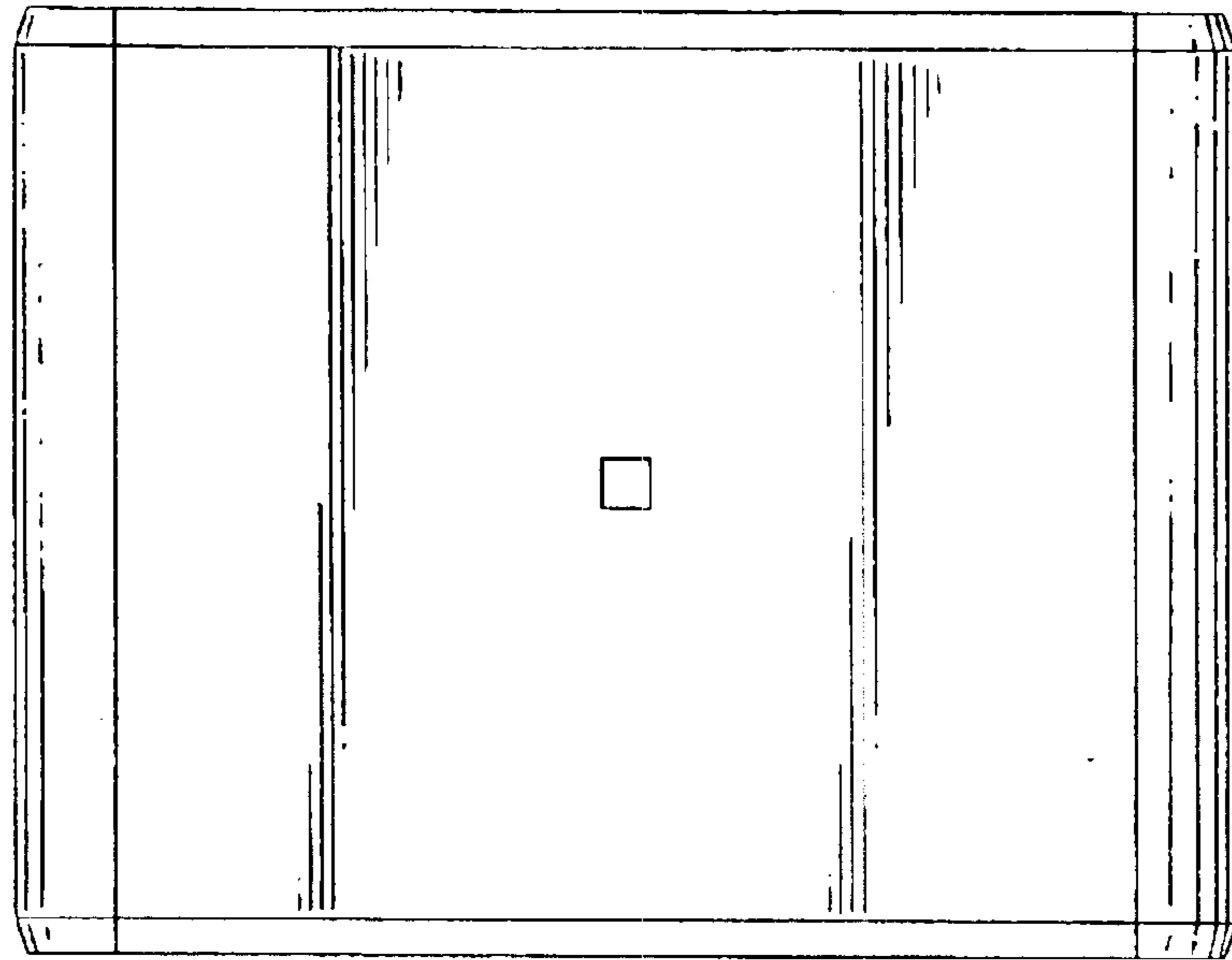
