(57) **CLAIM**

The ornamental design for an air freshener device, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view from above and from one side of the air freshener device.

FIG. 2 is a rear perspective view from above and from one side of the air freshener device.

FIG. 3 is planar view of the front of the air freshener device.

FIG. 4 is a planar view of the rear of the air freshener device.

FIG. 5 is a top planar view from above of the air freshener device.

FIG. 6 is a bottom planar view from above of the air freshener device.

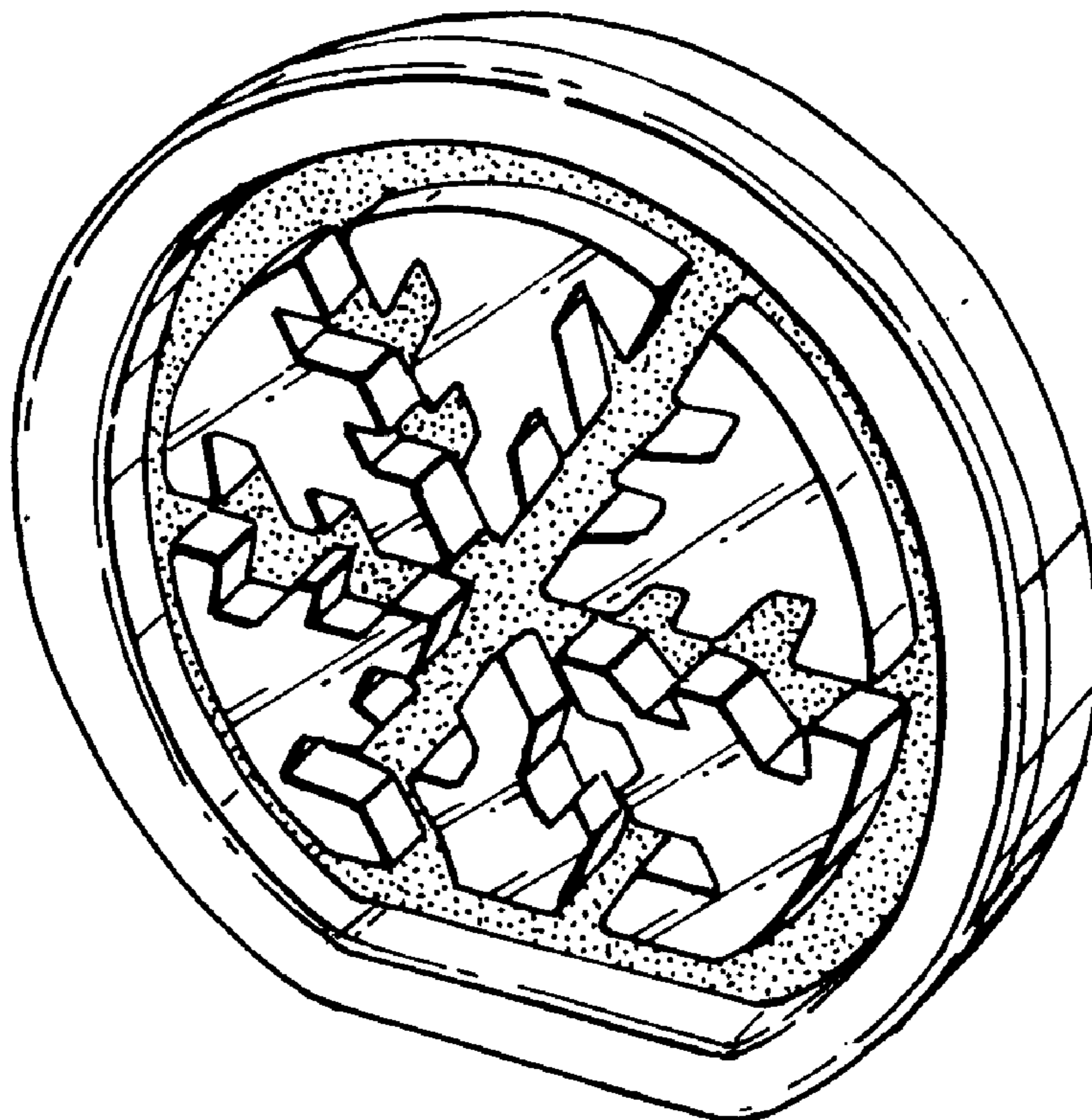
FIG. 7 is a side planar view of one side of the air freshener device.

FIG. 8 is a side planar view of the other side of the air freshener device.

FIG. 9 is a cross-sectional view of the air freshener along the plane defined by line I—I according to FIG. 4; and,

FIG. 10 is a cross-sectional view of the air freshener along the plane defined by line II—II according to FIG. 4.

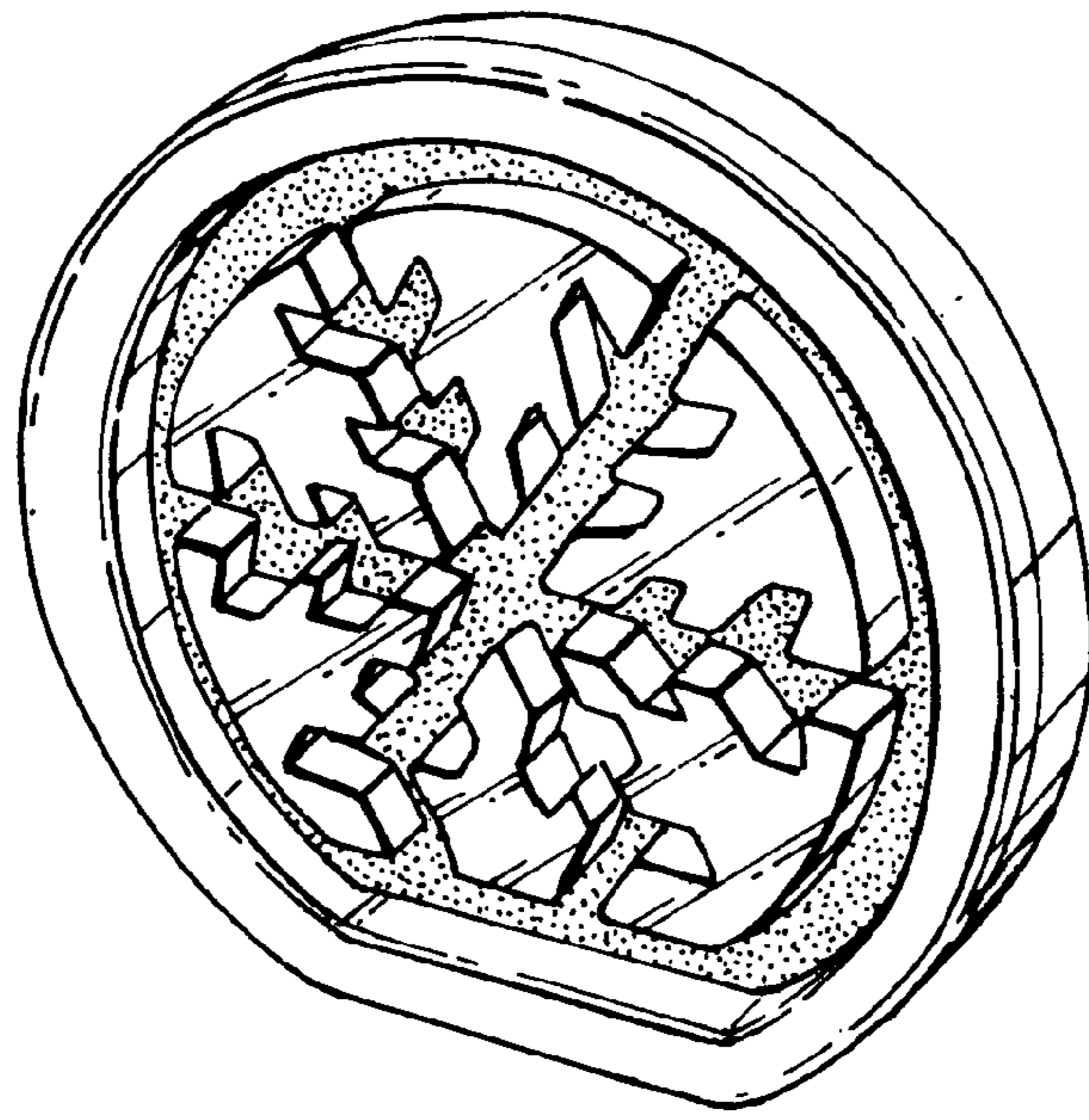

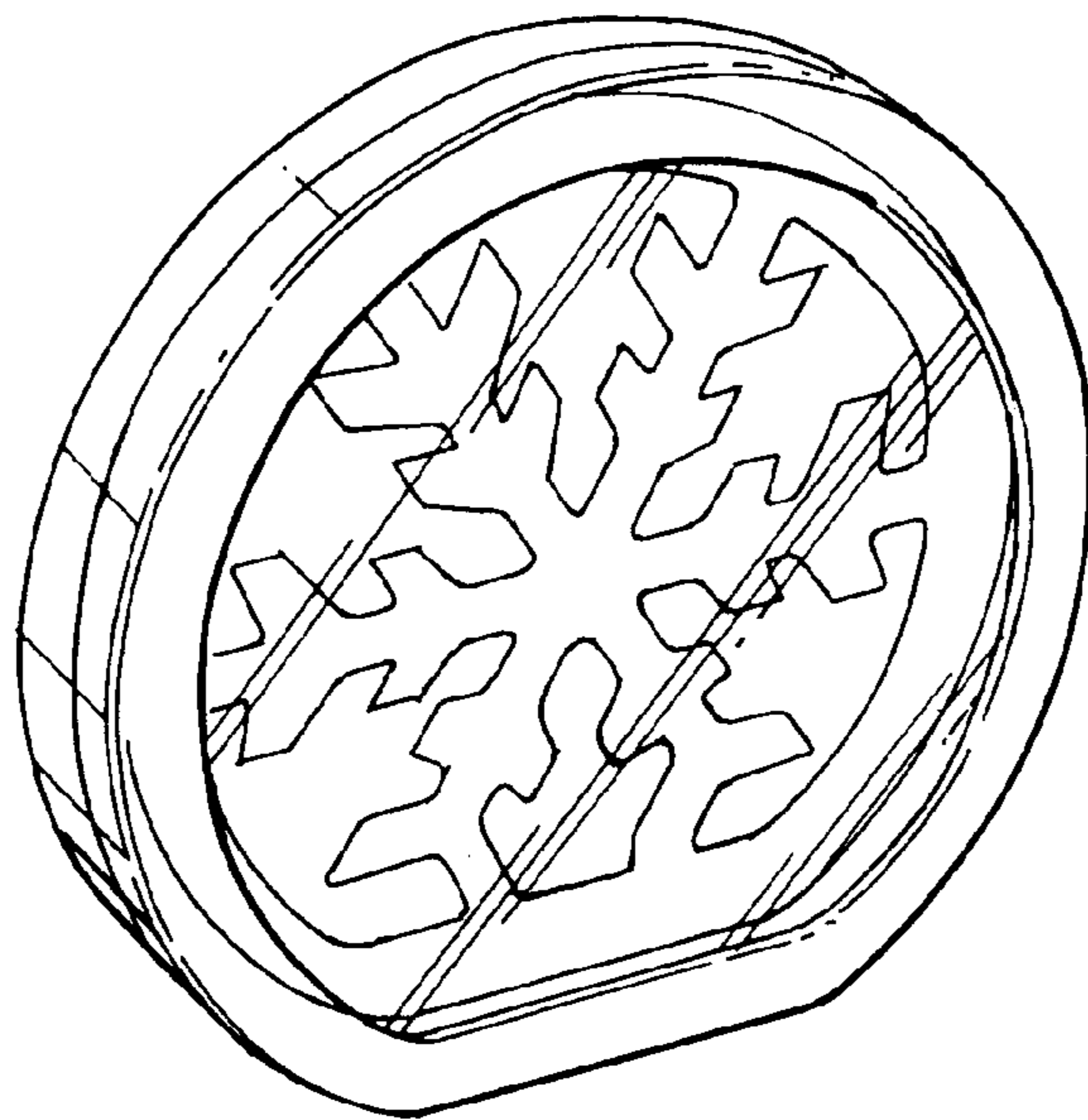

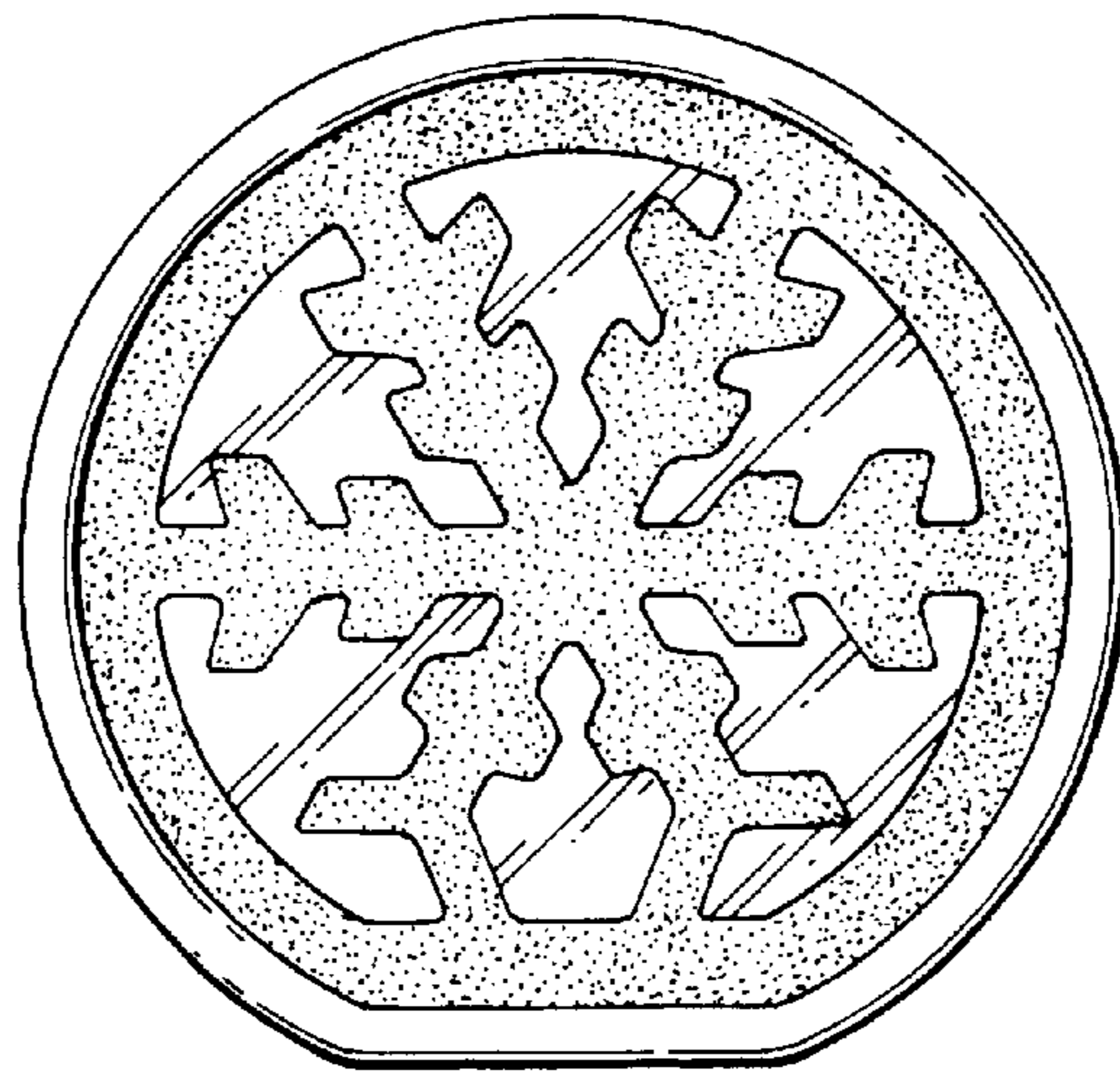

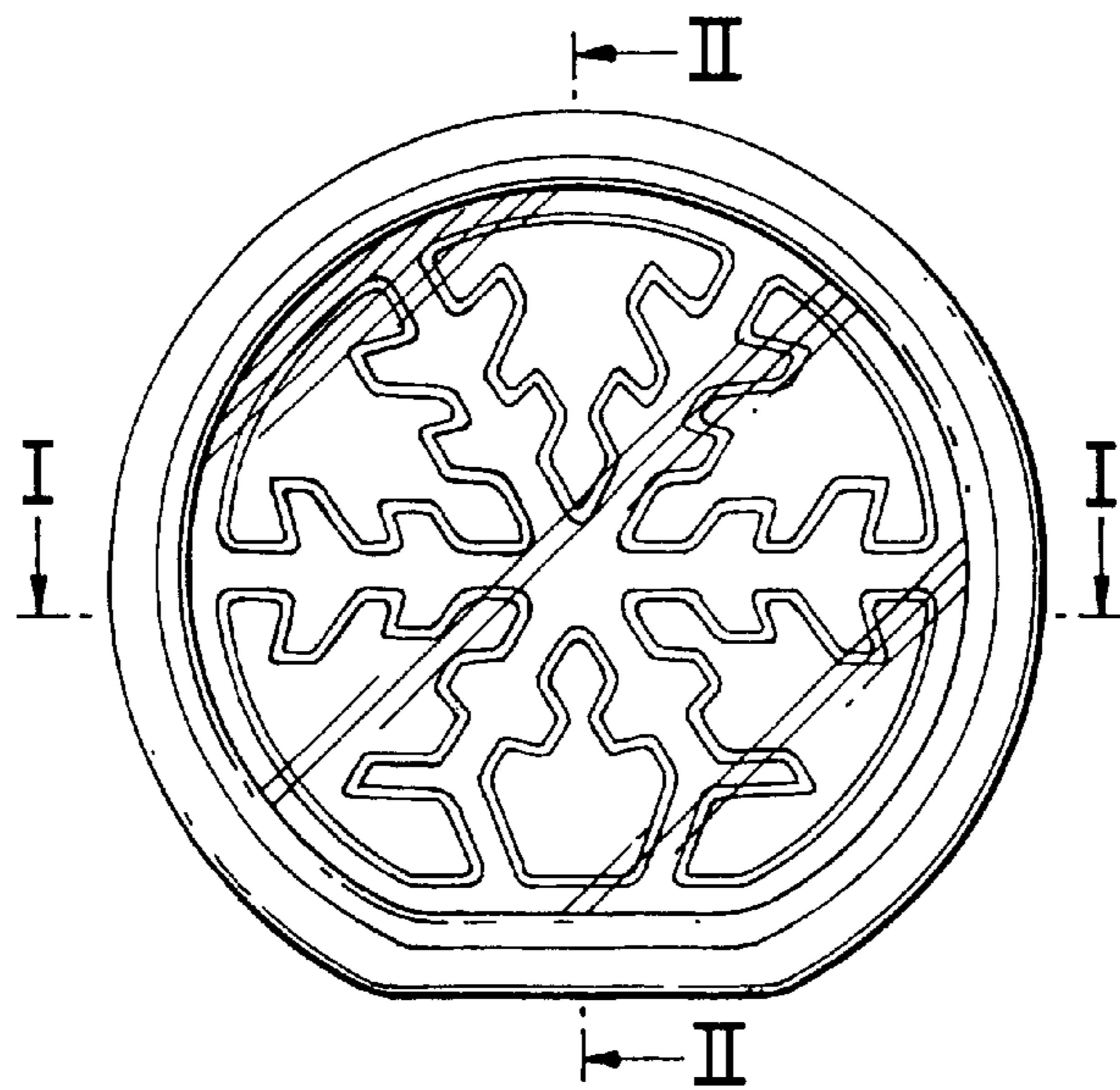

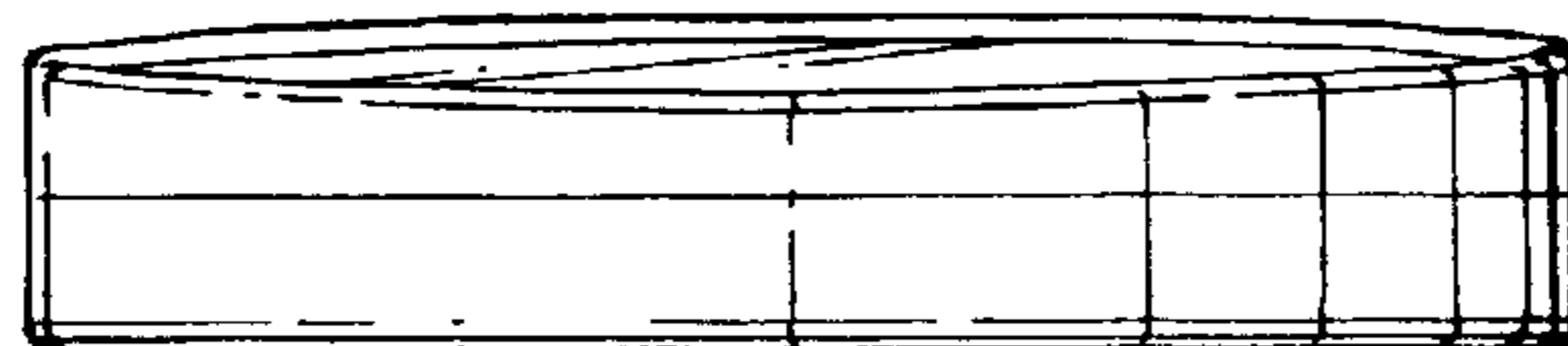

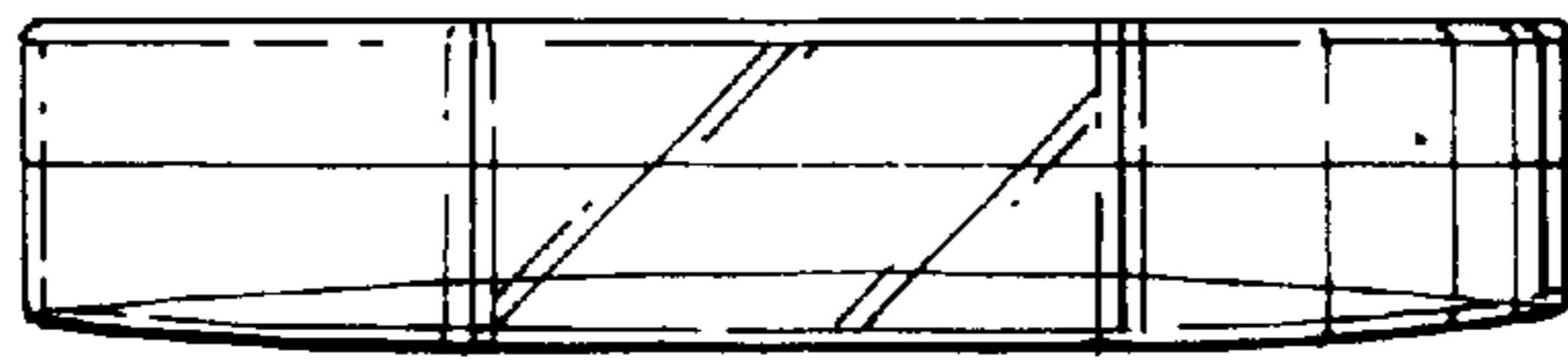

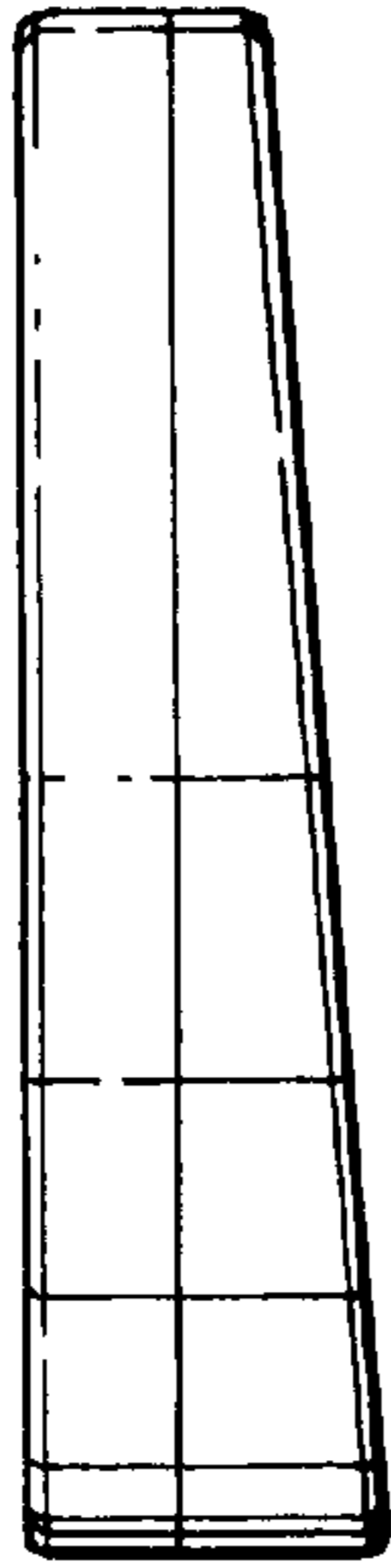

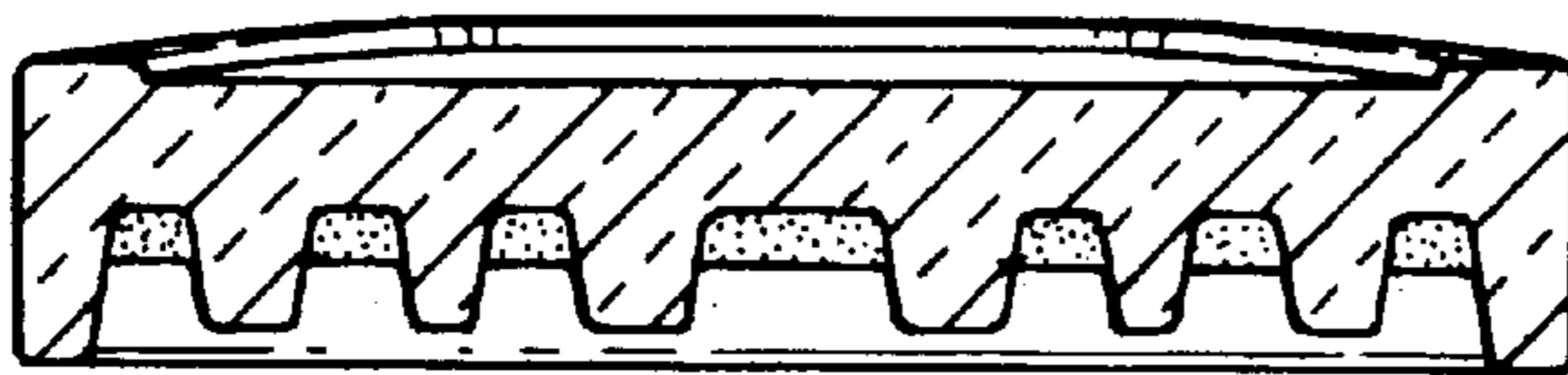

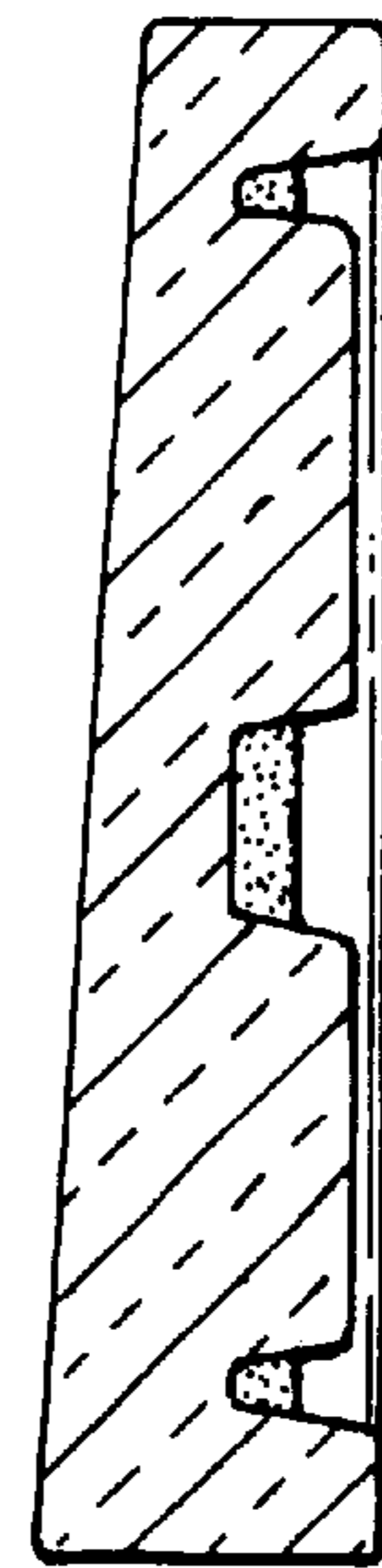
