(57) **CLAIM**

The ornamental design for combined hair cutting machine and stand, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of my design for a combined hair cutting machine and stand;

FIG. 3 is a side elevational view of my design for combined hair cutting machine;

FIG. 11 is an end view of the opposite end of the stand for combined hair cutting machine;

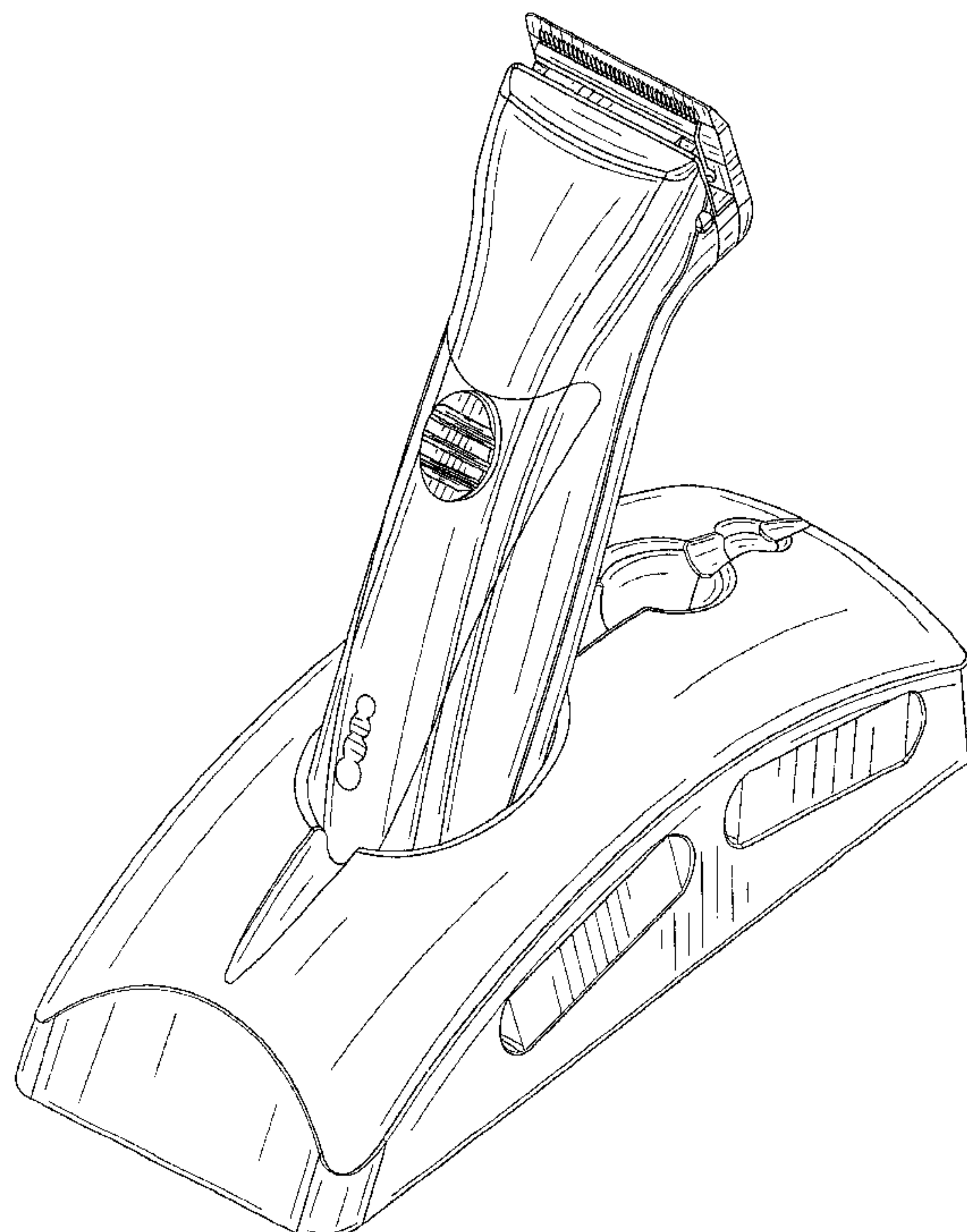
FIG. 12 is a side elevational view of the stand for my combined hair cutting machine;

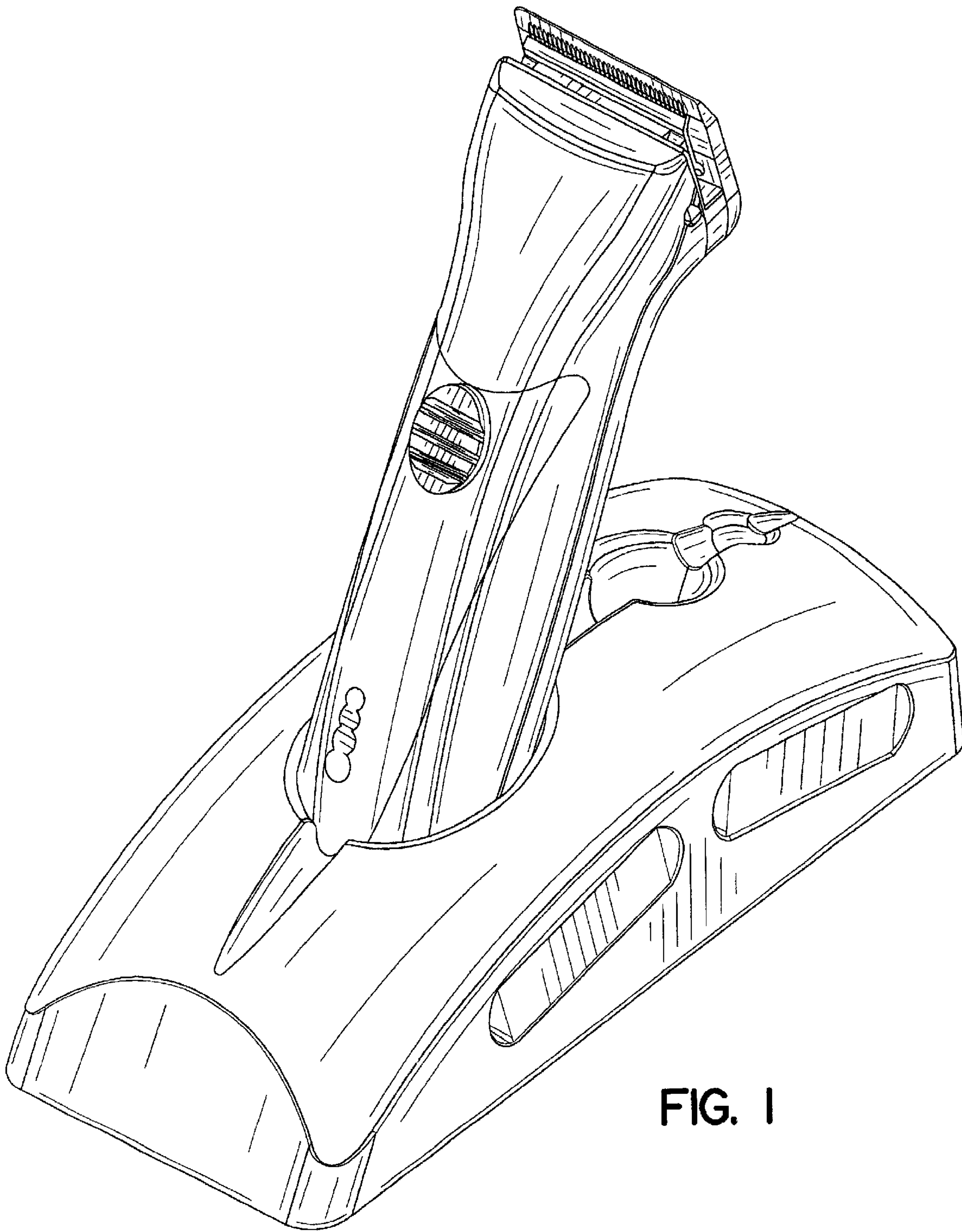

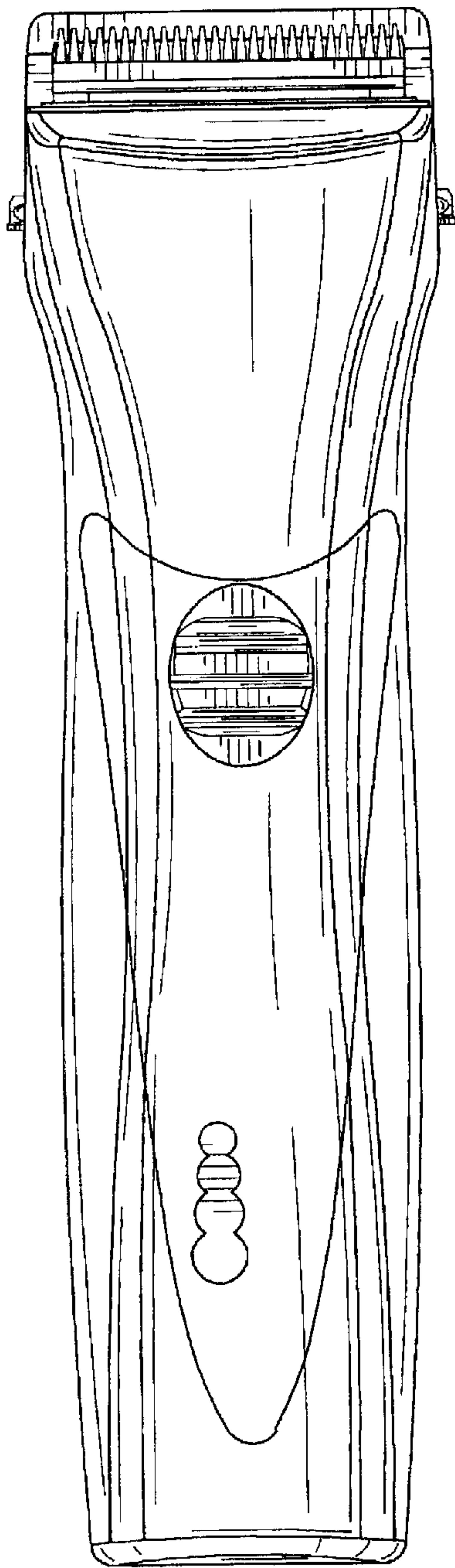

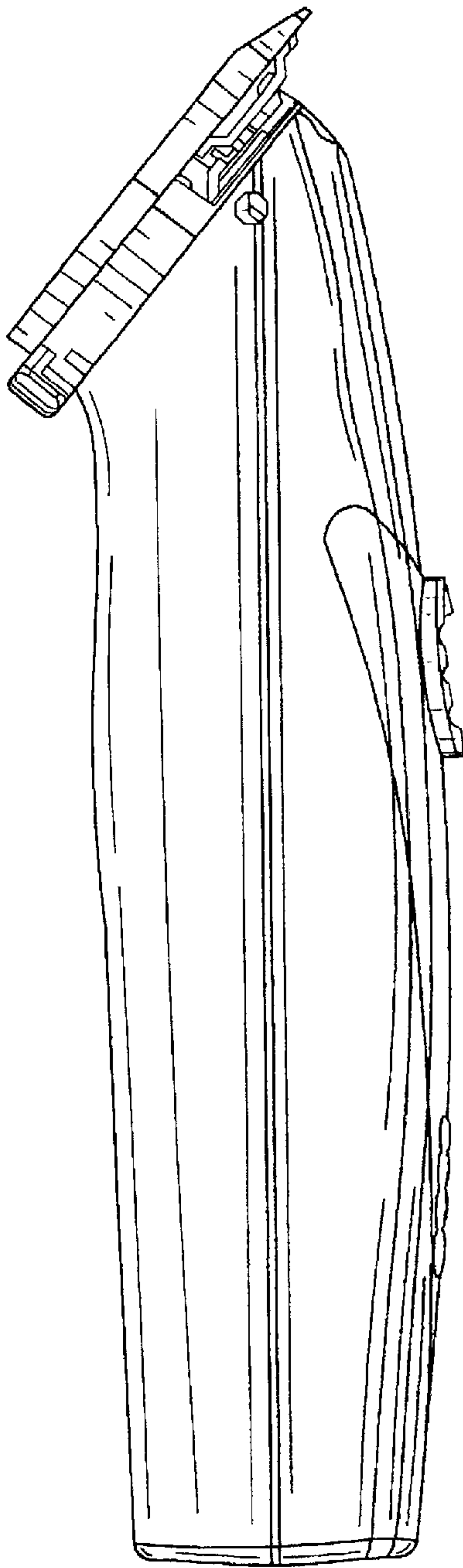

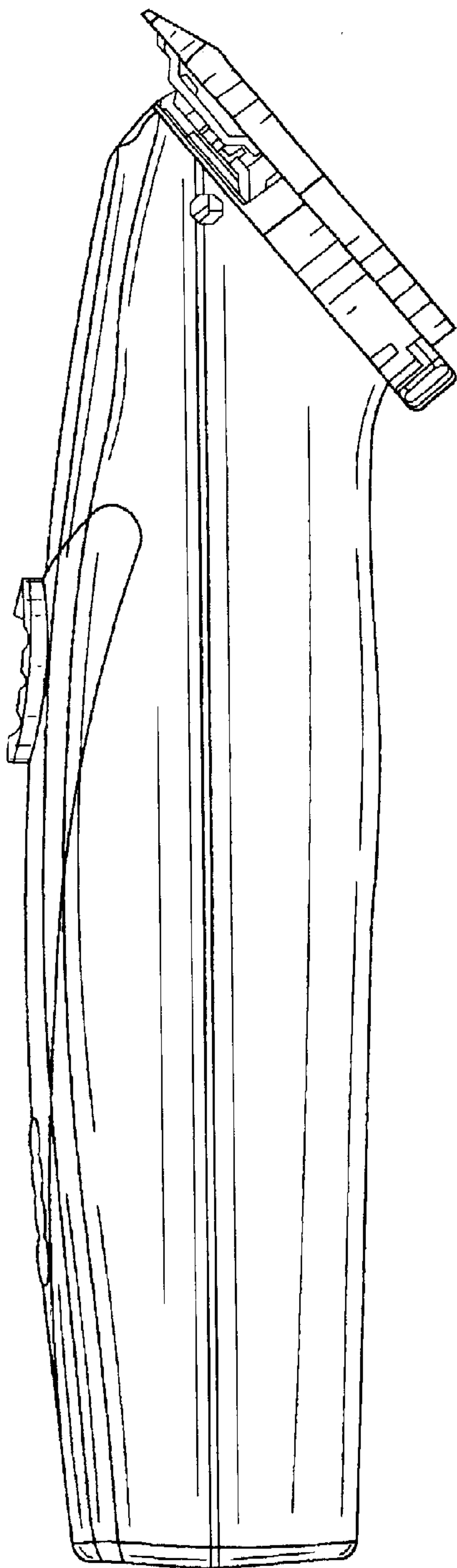

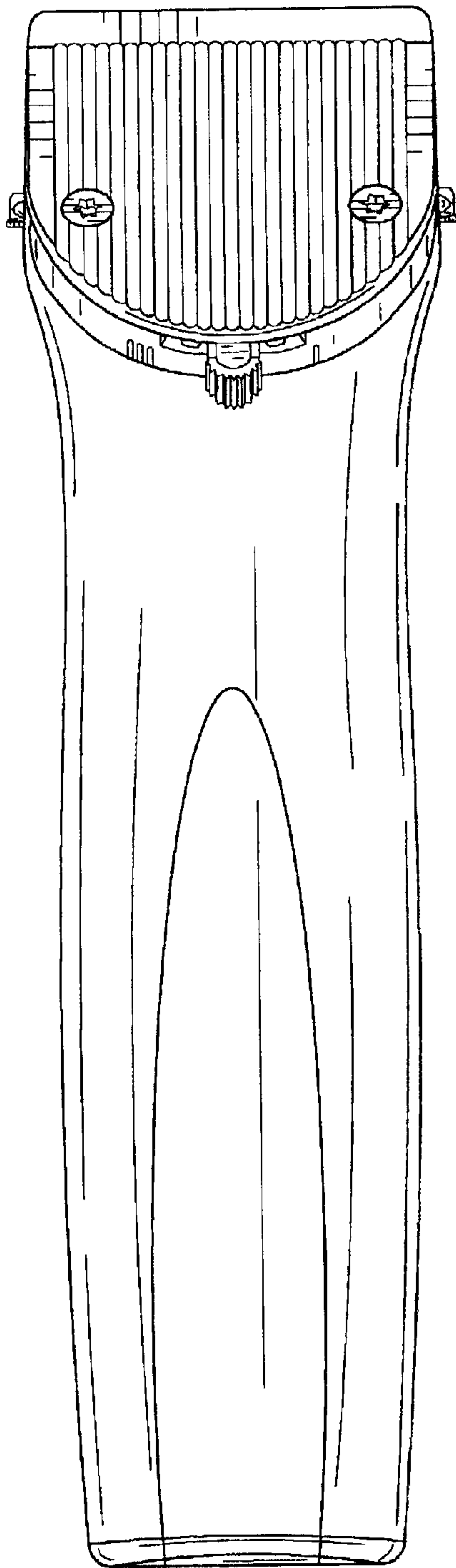

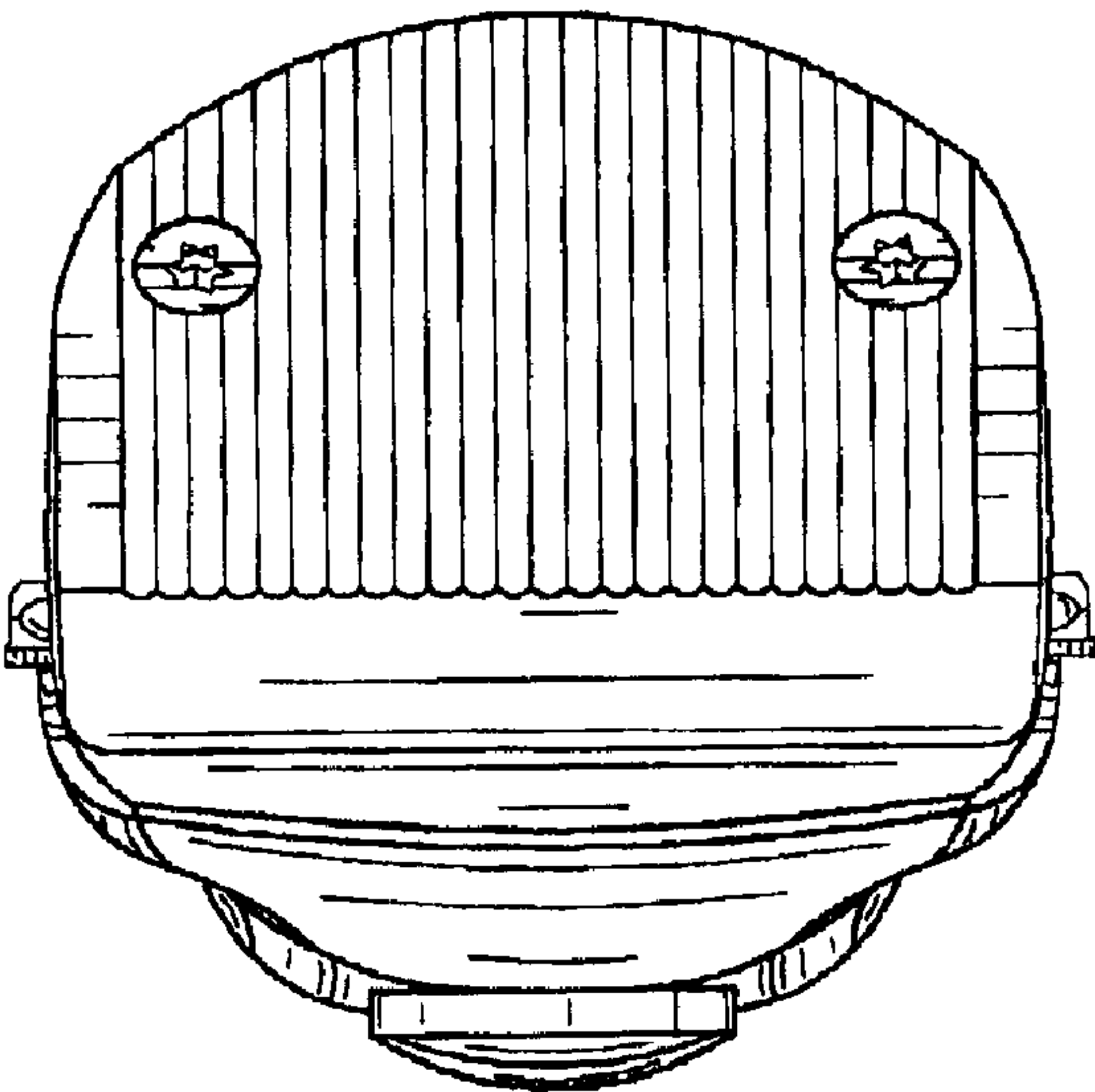

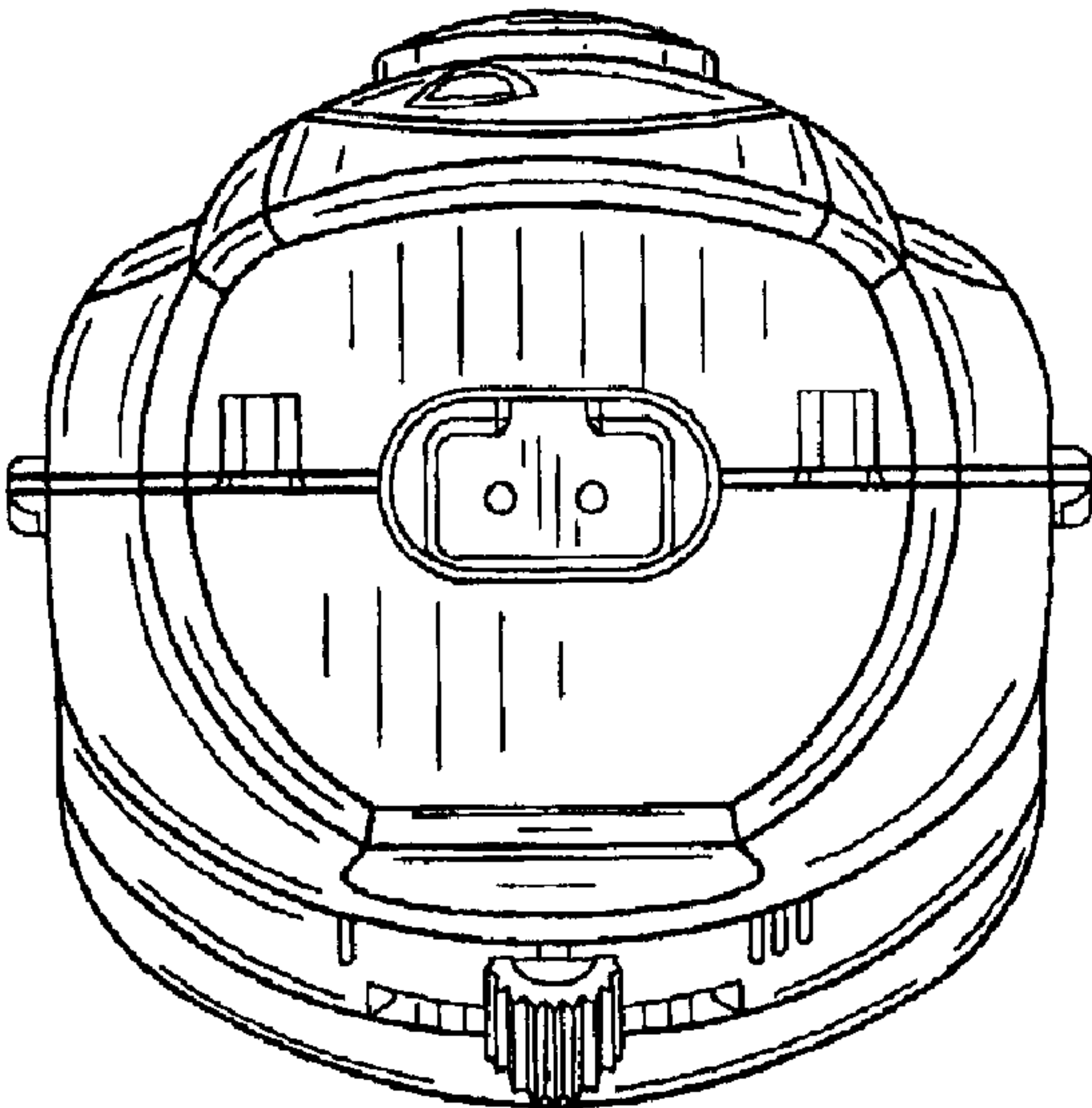

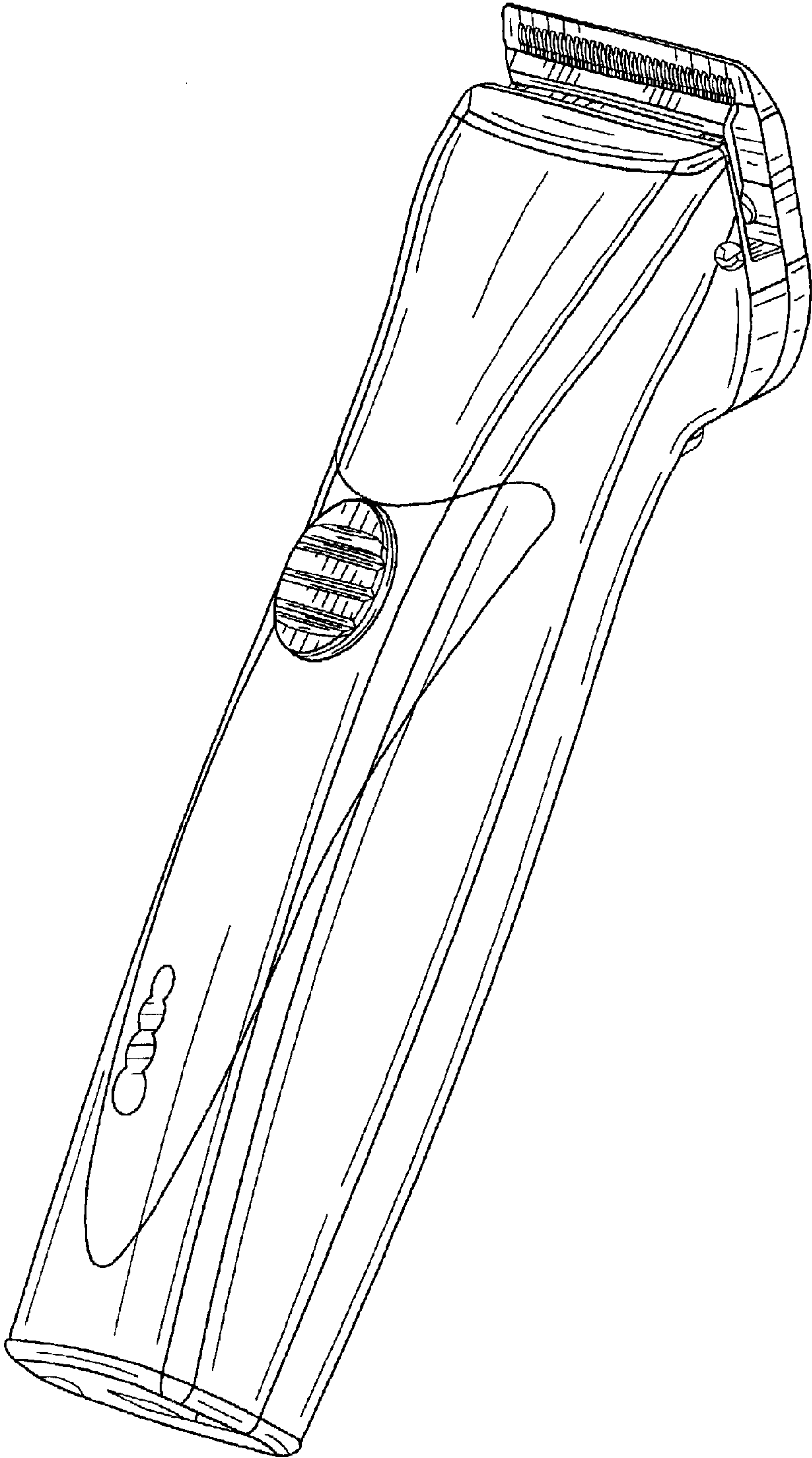

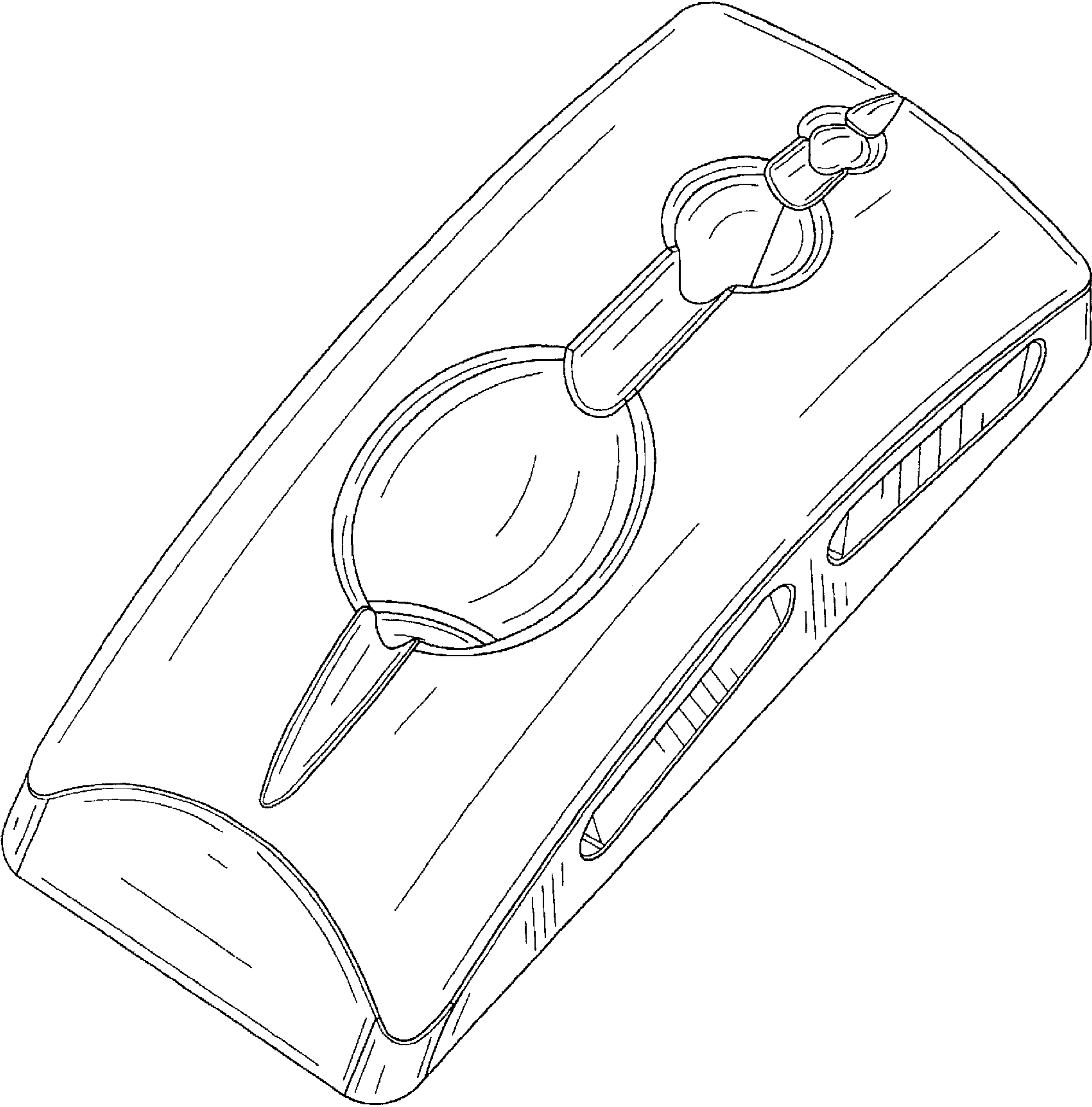

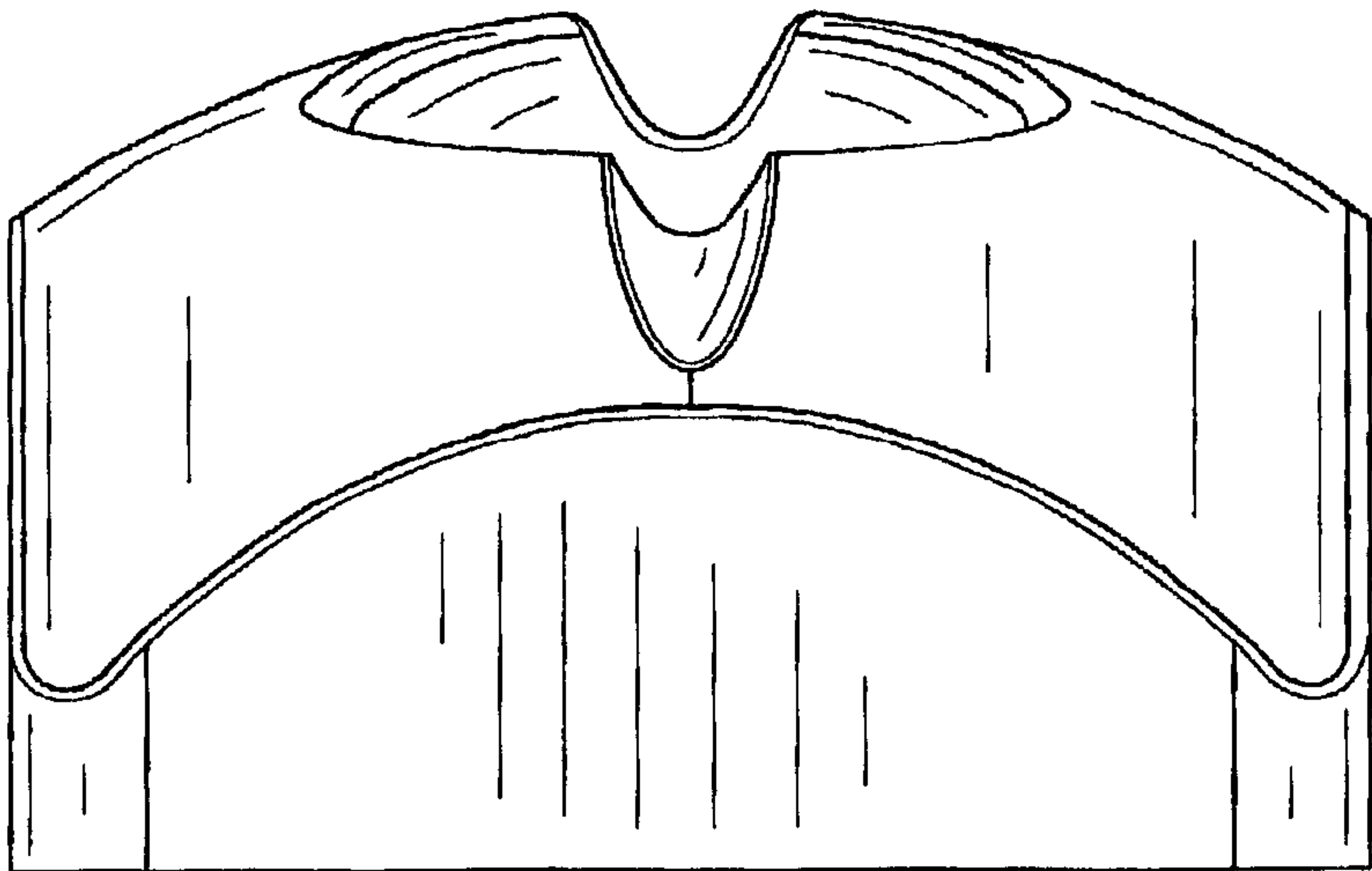

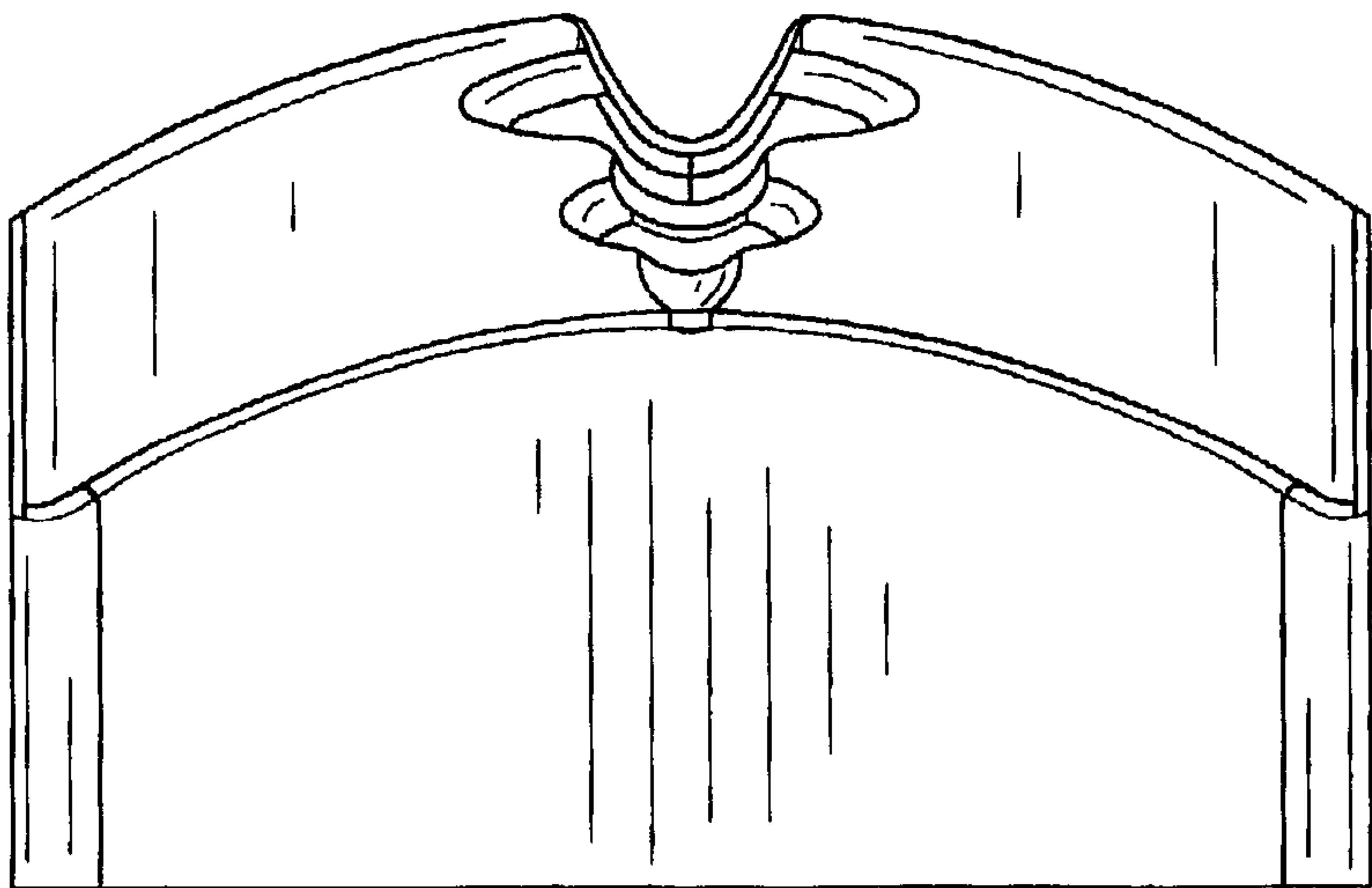

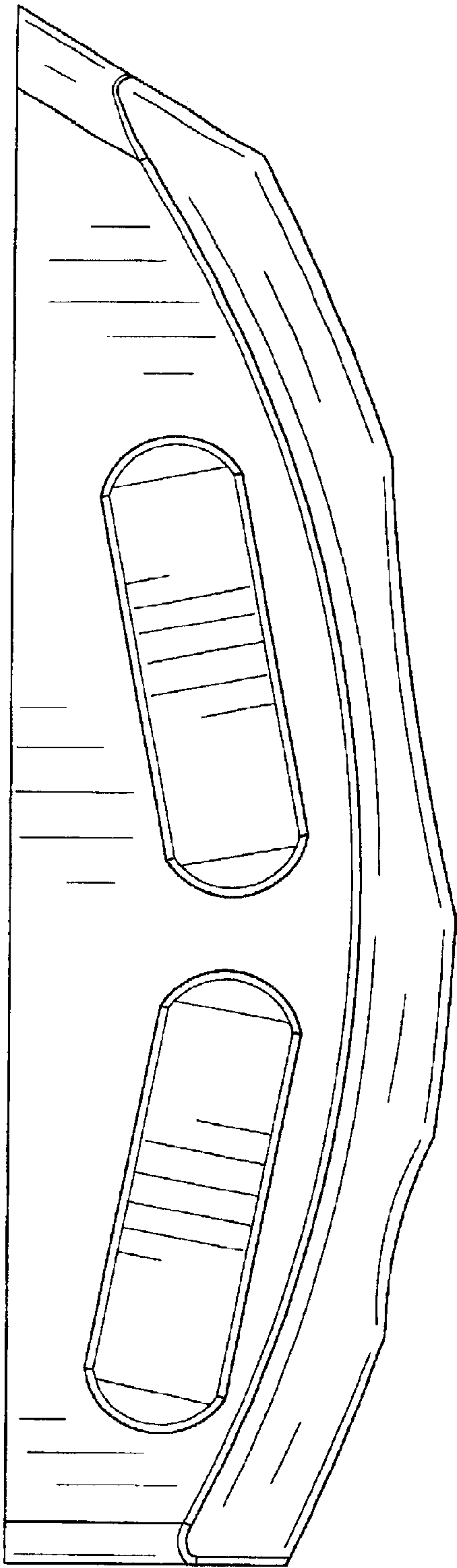

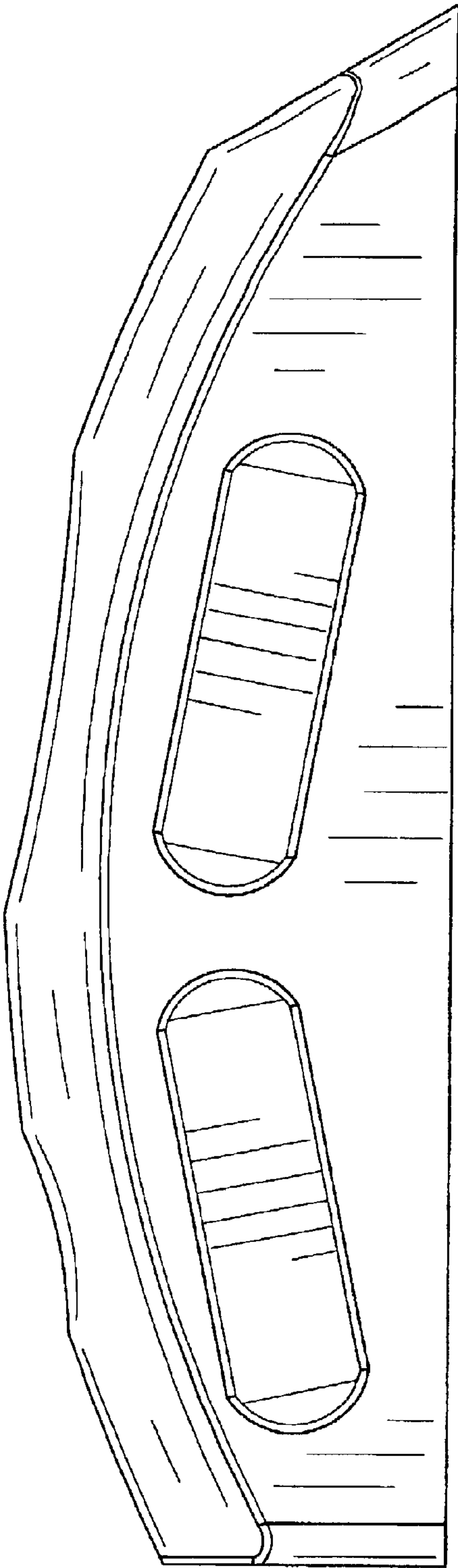

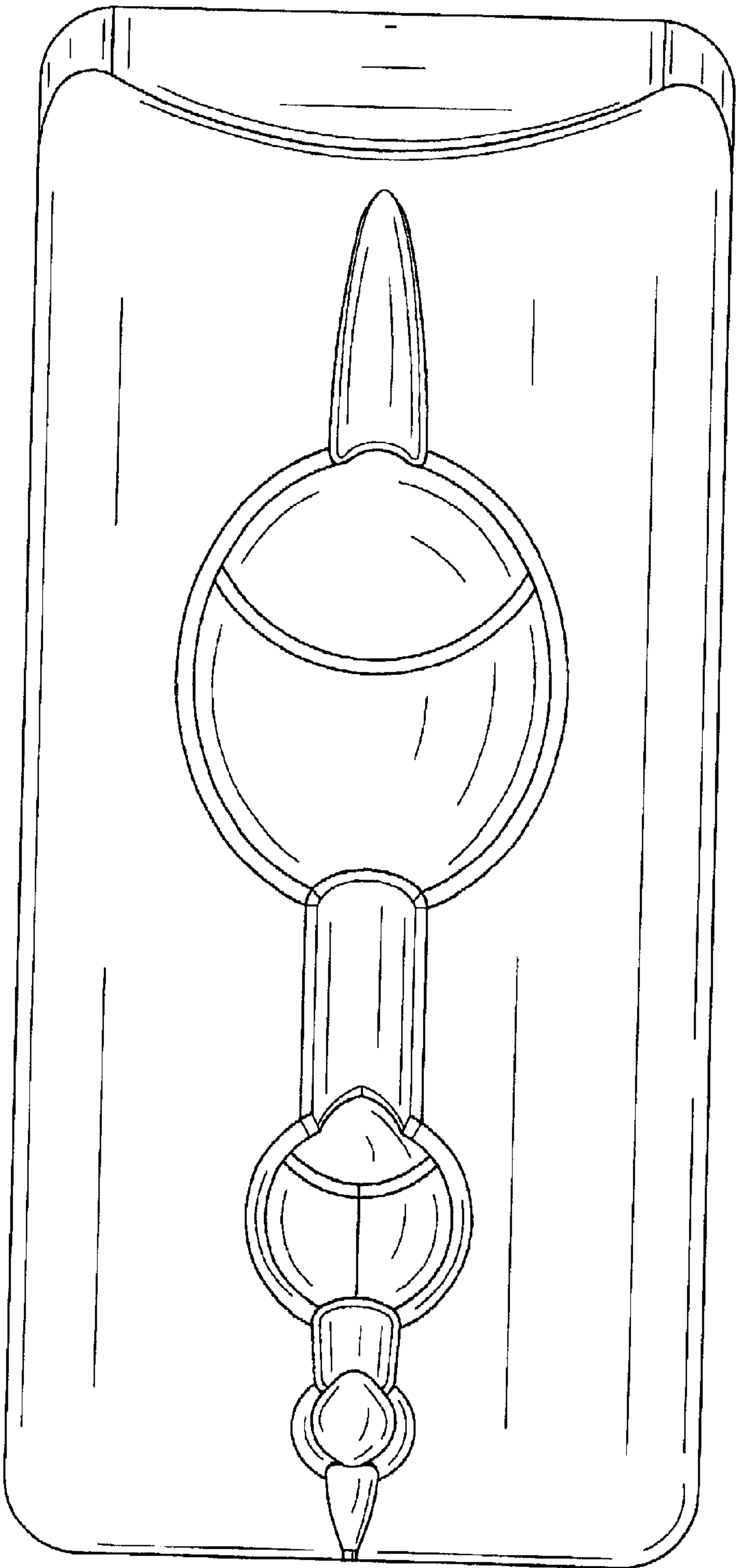
