(57) **CLAIM**

The ornamental design for a glove, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a portion of a glove showing the new design;

FIG. 2 is a side view of the portion of a glove shown in FIG. 1;

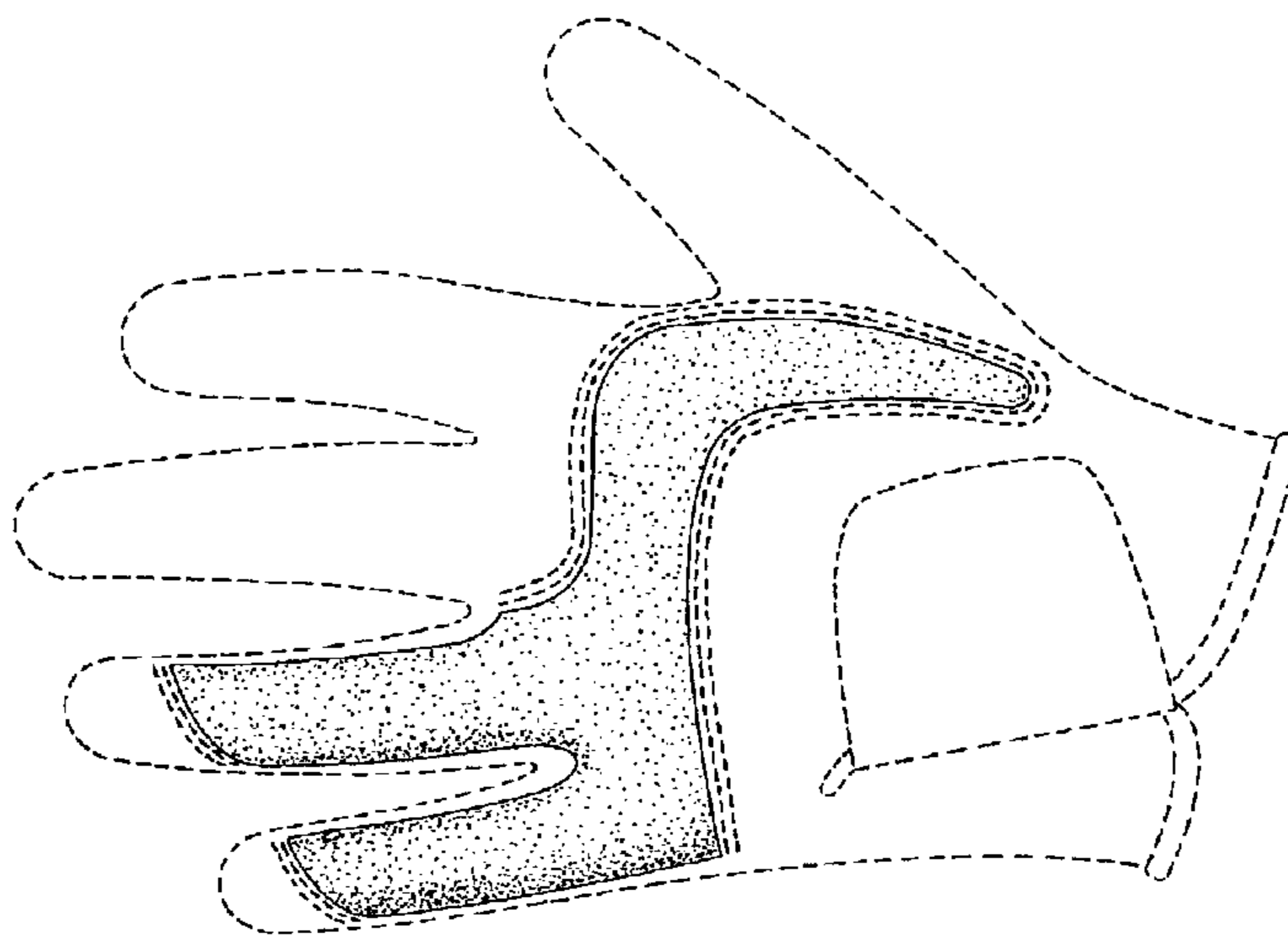
FIG. 3 is a perspective view of the portion of a glove shown in FIG. 1; and,

FIG. 4 is another side view of the portion of a glove shown in FIG. 1.

The bottom view of the glove embodying the new design does not include any design features apart from those shown in FIGS. 1-4.

The areas shown in unbroken lines in FIGS. 1-4 are to be included within the bounds of the claimed design. The broken line representations in FIGS. 1-4 represent the environment in which the design is associated. These broken line representations in FIGS. 1-4 are for the sole purpose of illustrating the environment of the claimed design and form no part of the claimed design.

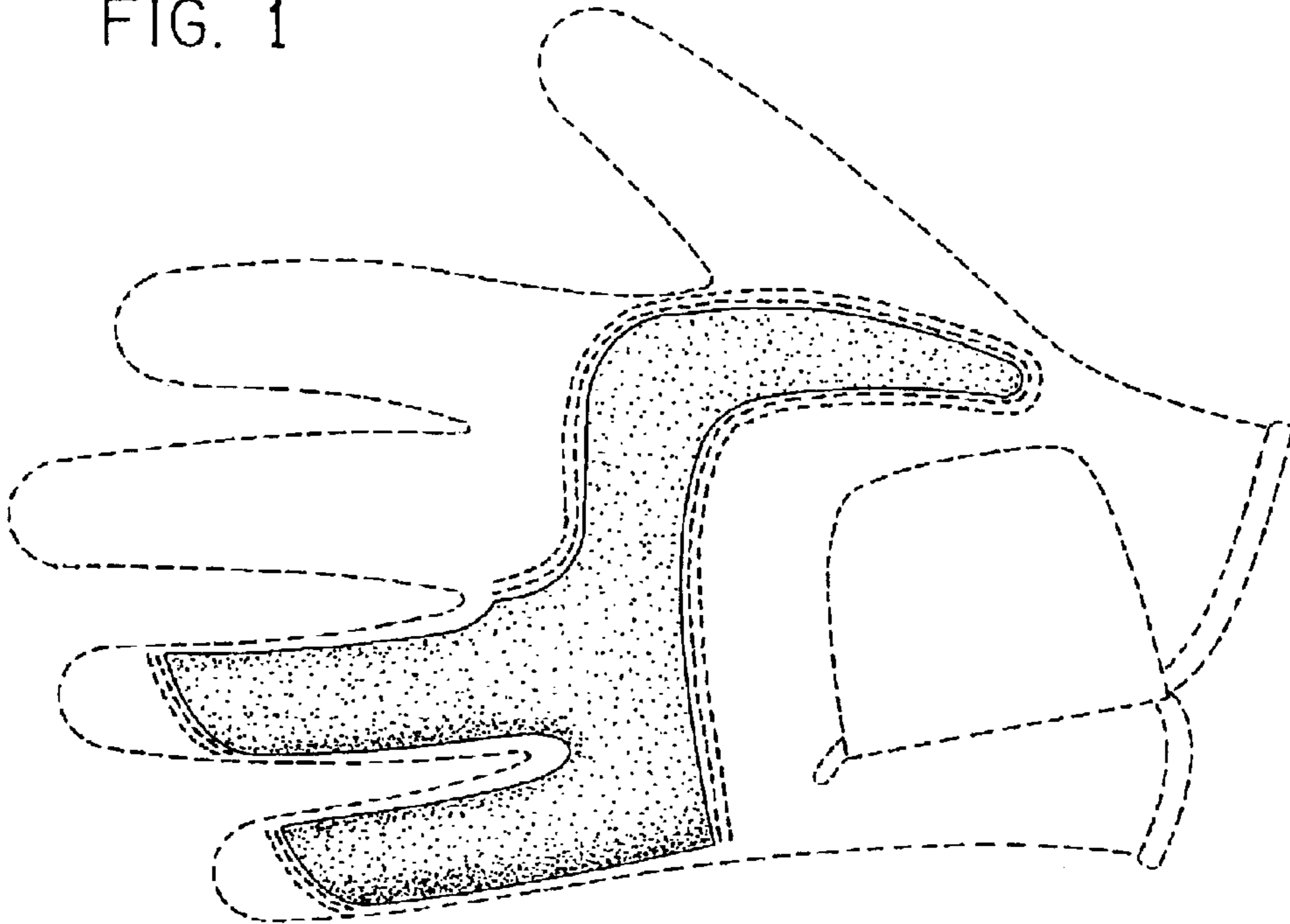

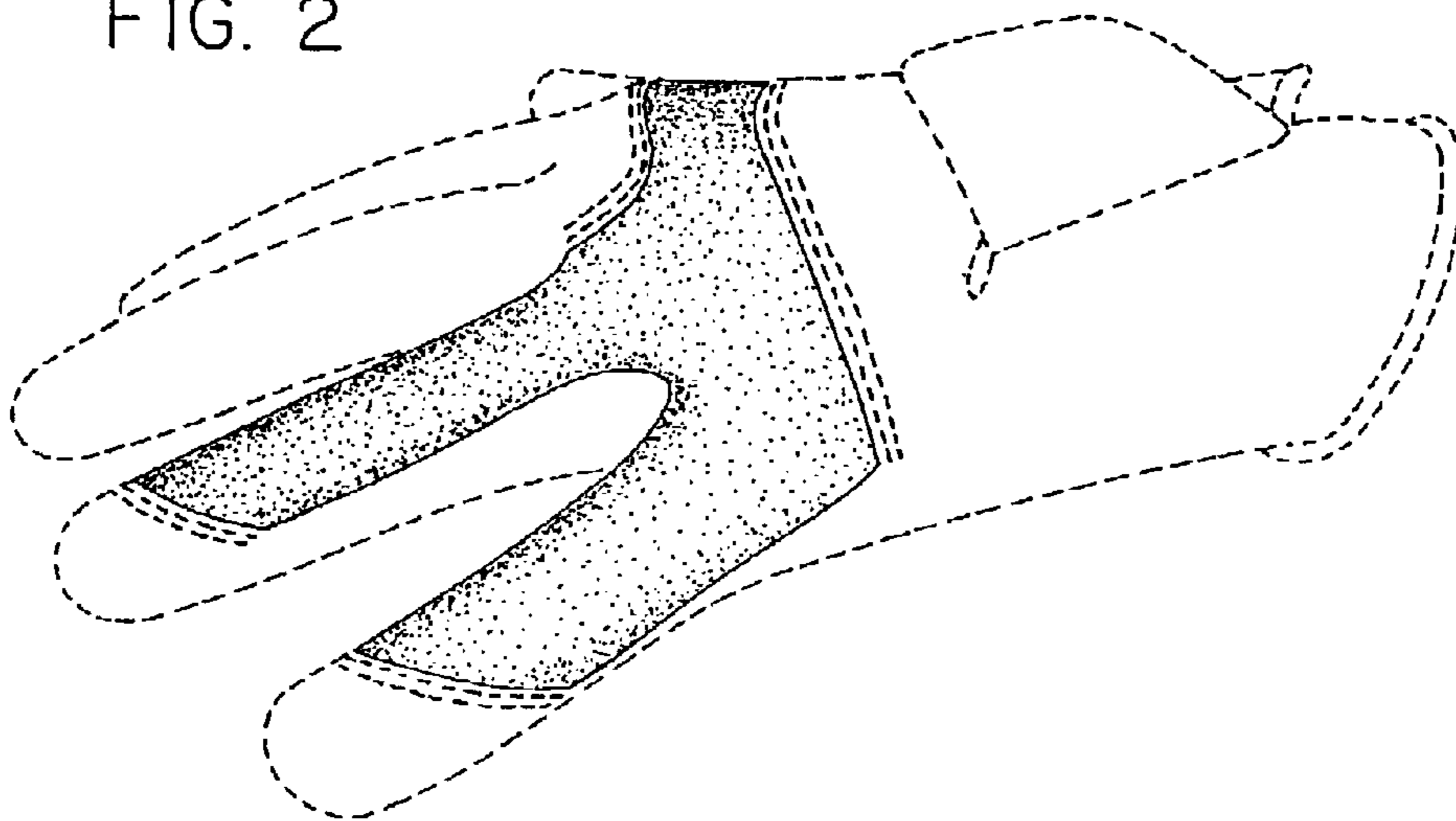

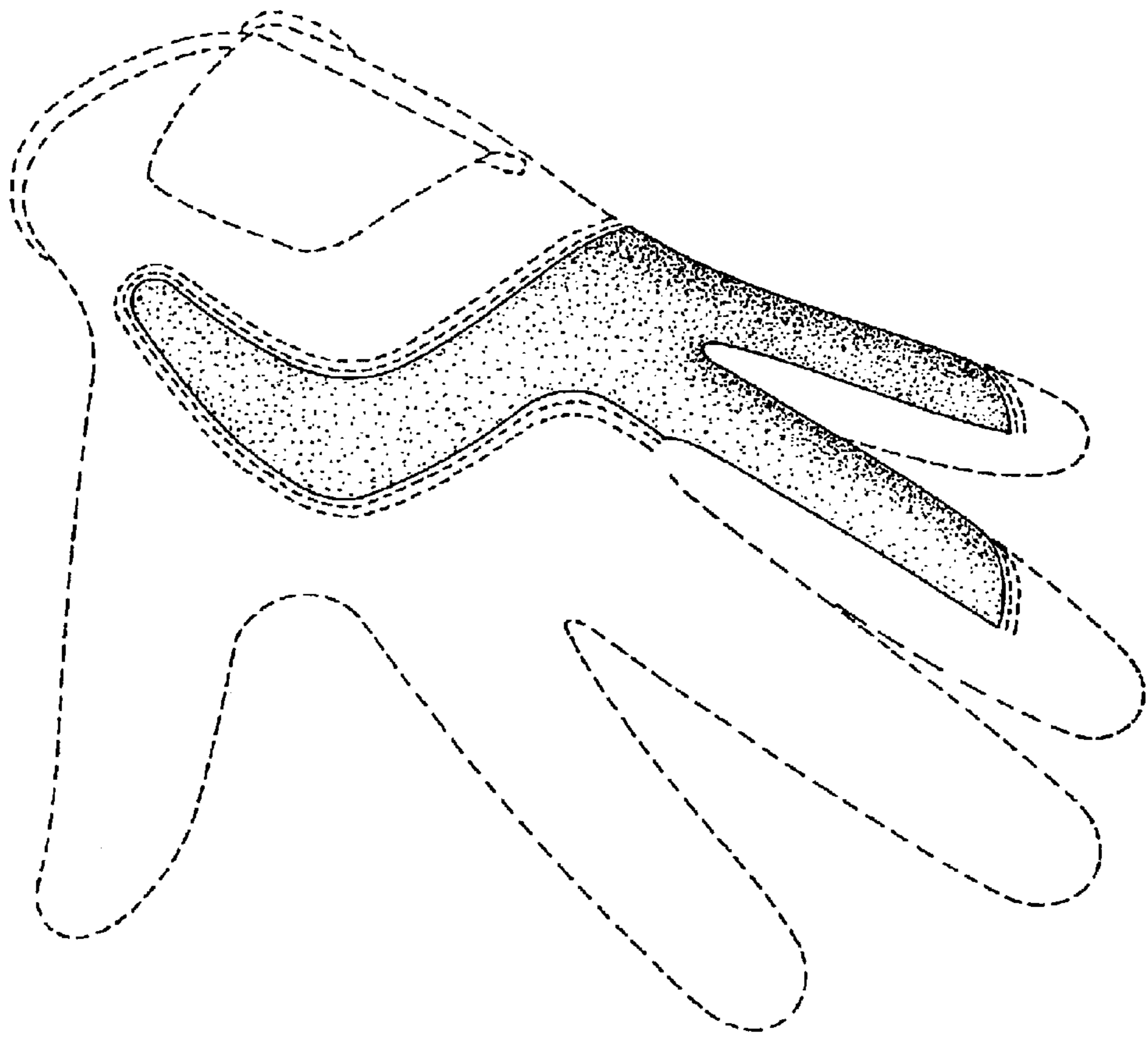
