(57) **CLAIM**

The ornamental design for a combined picture frame and digital voice recorder.

**DESCRIPTION**

FIG. 1 is a perspective view of a combined picture frame and digital voice recorder with back stand opened and in an up-right position showing my new design;  
 FIG. 2 is a rear perspective view of FIG. 1 thereof;  
 FIG. 3 is a perspective view of the combined picture frame and digital voice recorder with back stand closed and in a laid-flat position thereof;  
 FIG. 4 is a front elevational view of FIG. 3 thereof;  
 FIG. 5 is a right side elevational view thereof;  
 FIG. 6 is a left side elevational view thereof;  
 FIG. 7 is a top plan view thereof;  
 FIG. 8 is a bottom plan view thereof; and,  
 FIG. 9 is a rear elevational view.

The broken lines simulating a picture in the photograph area in FIG. 1, FIG. 3, and FIG. 4 are for illustrative purposes only and form no part of the claimed design.

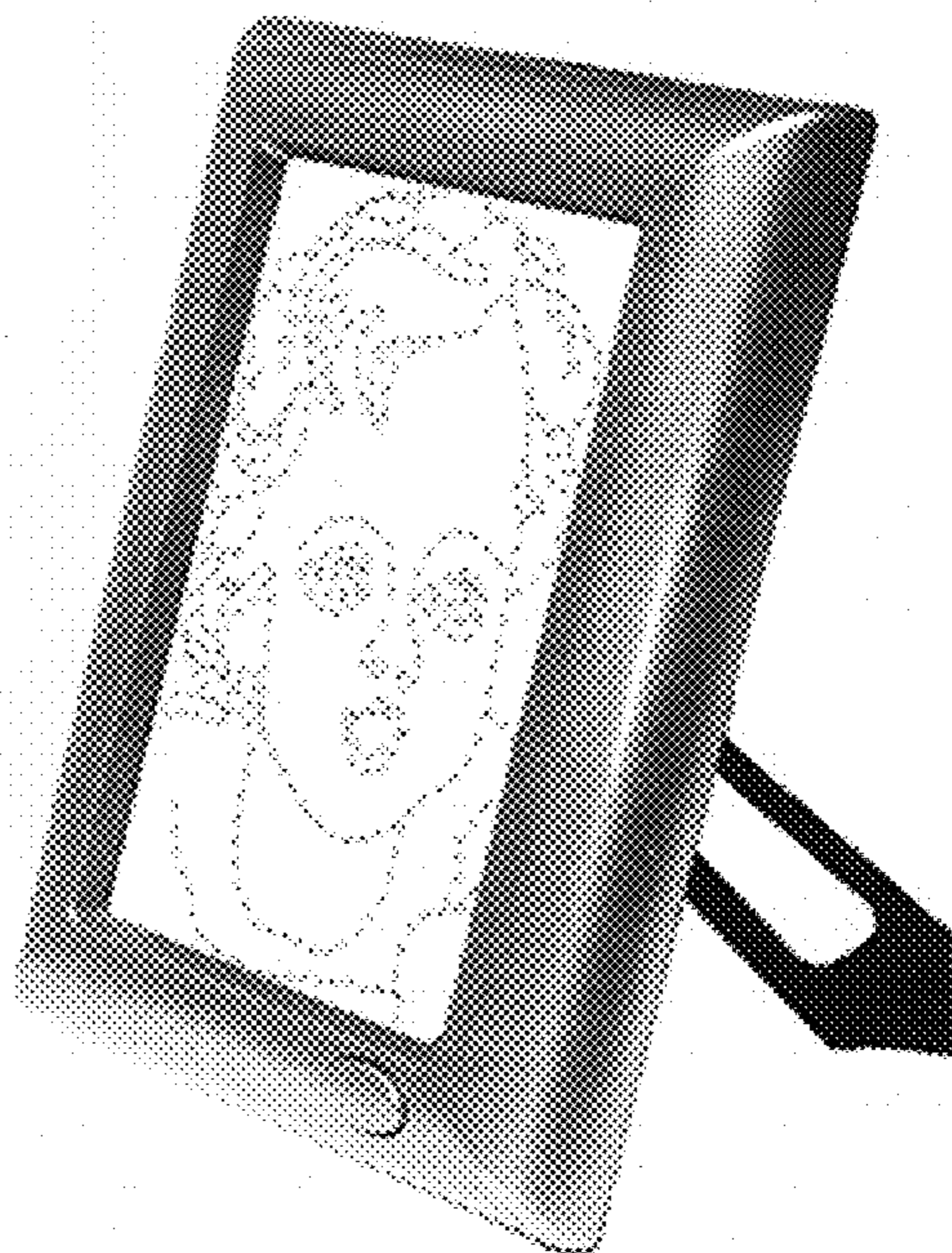
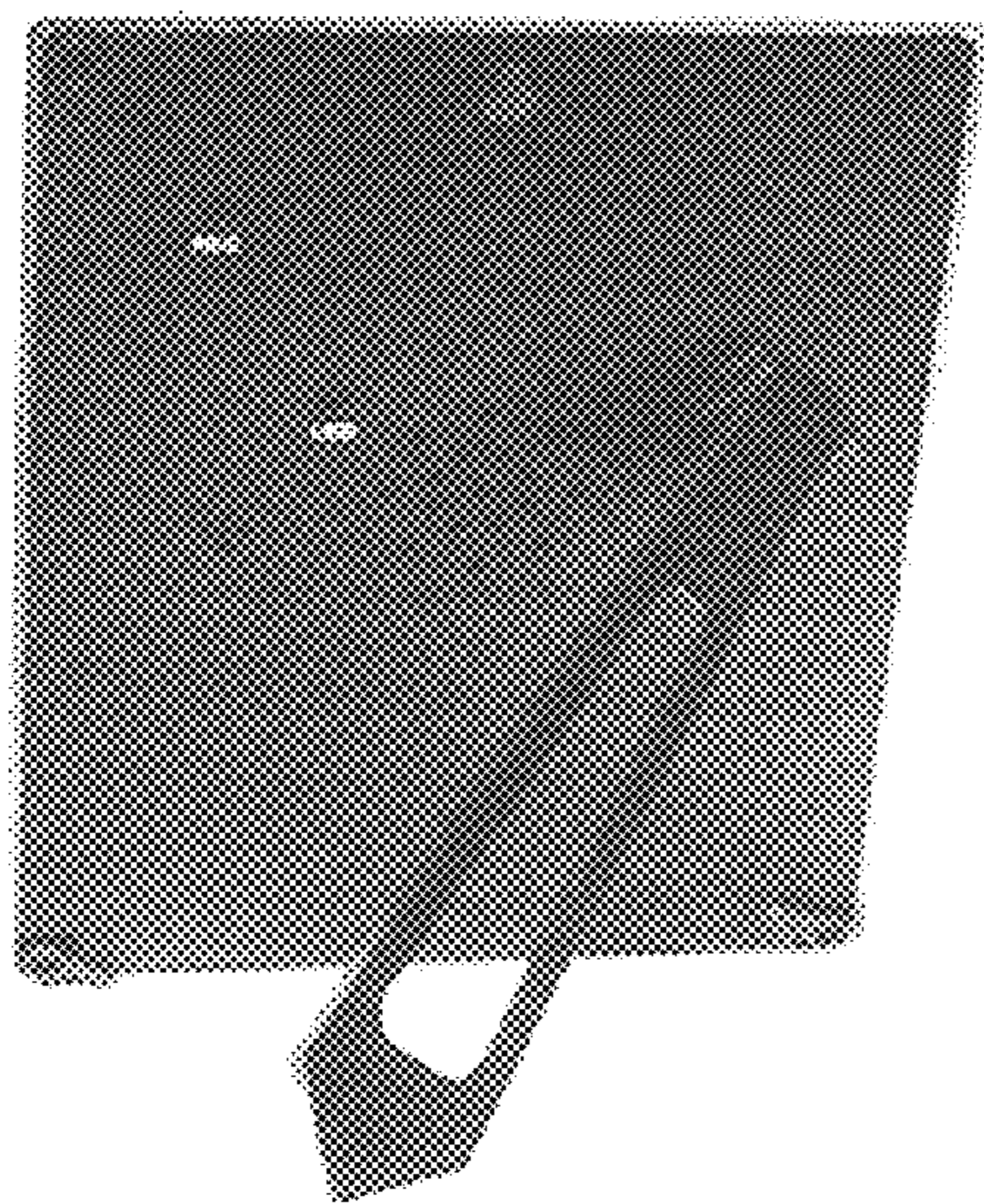

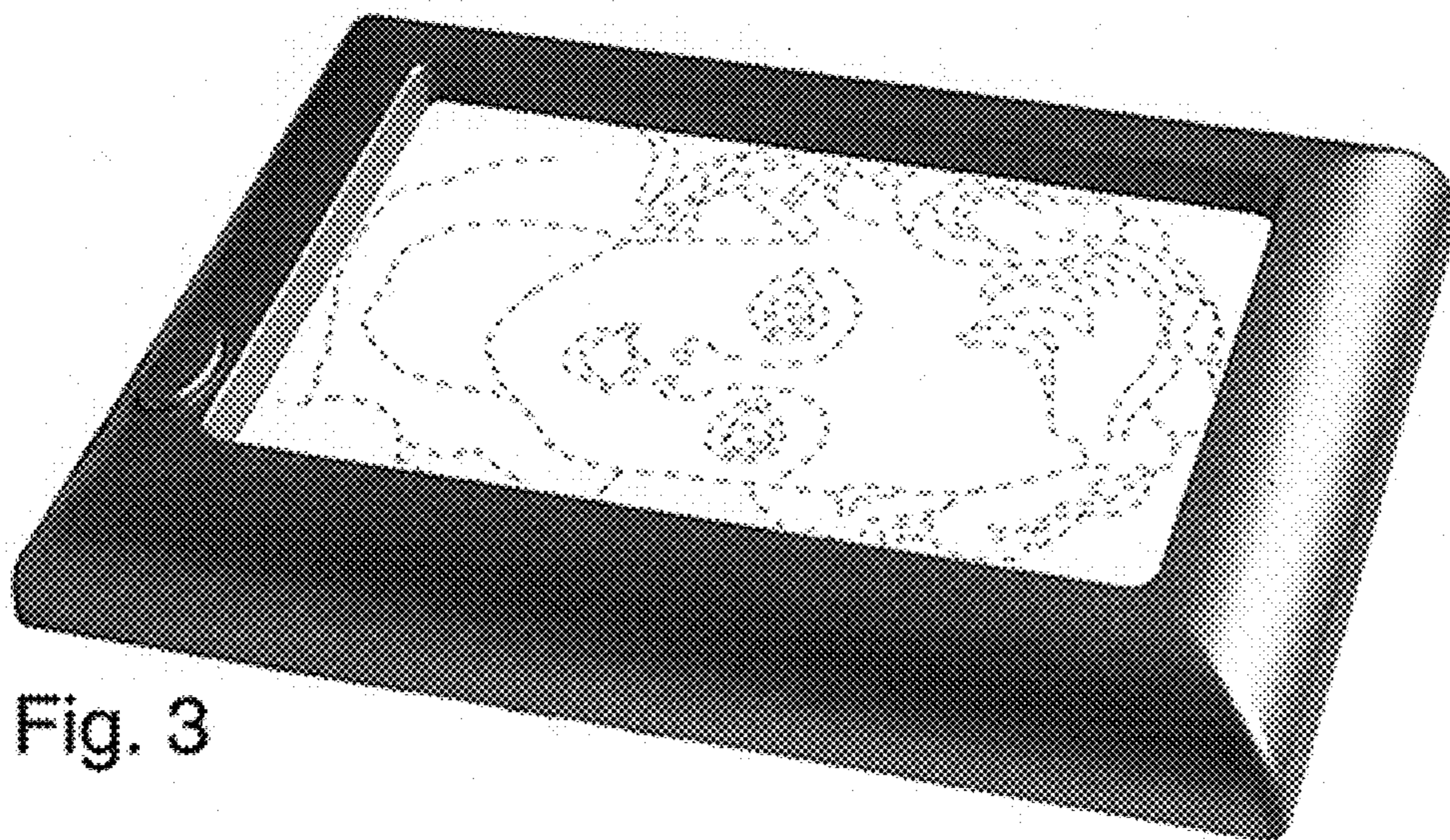
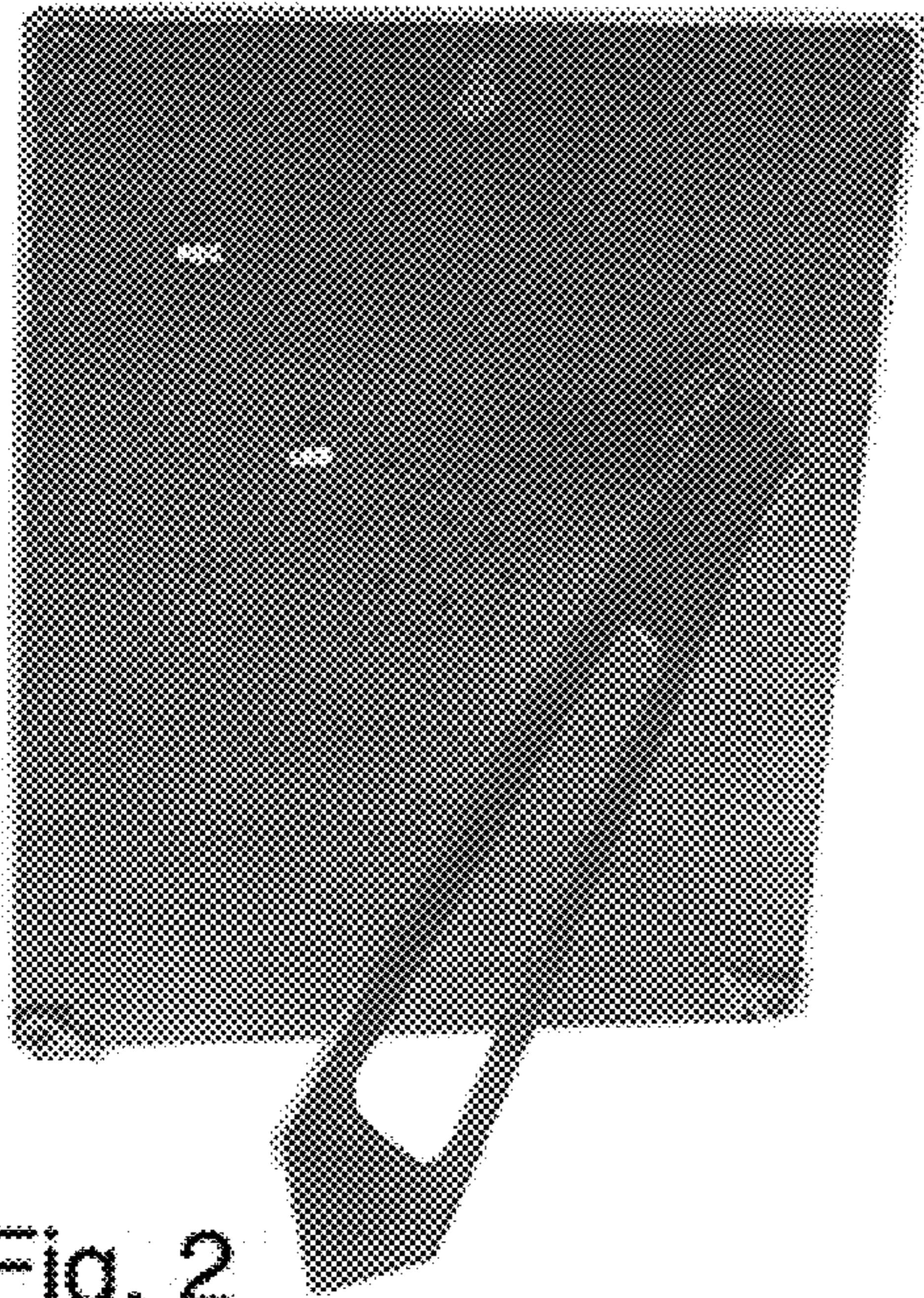

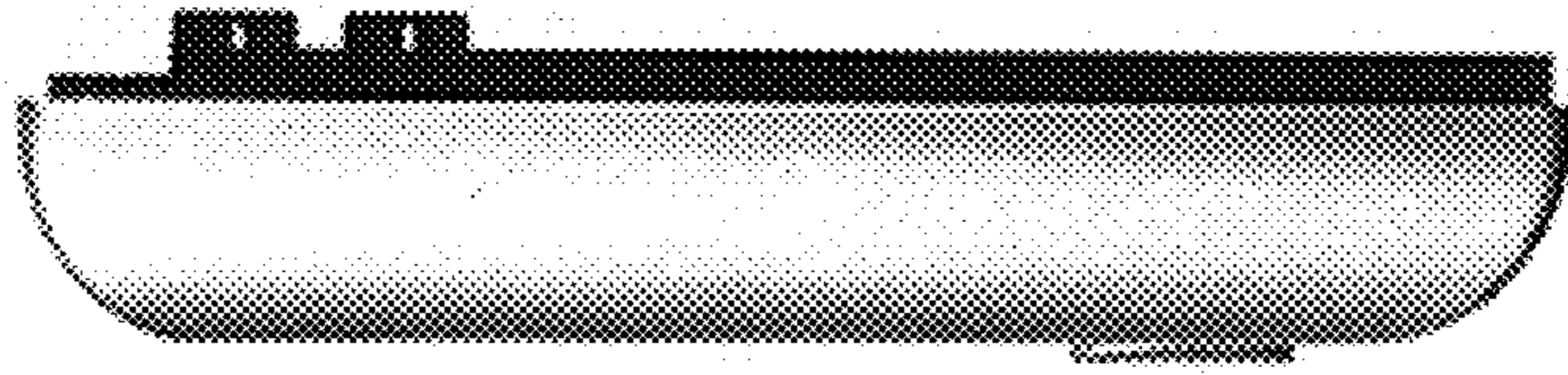

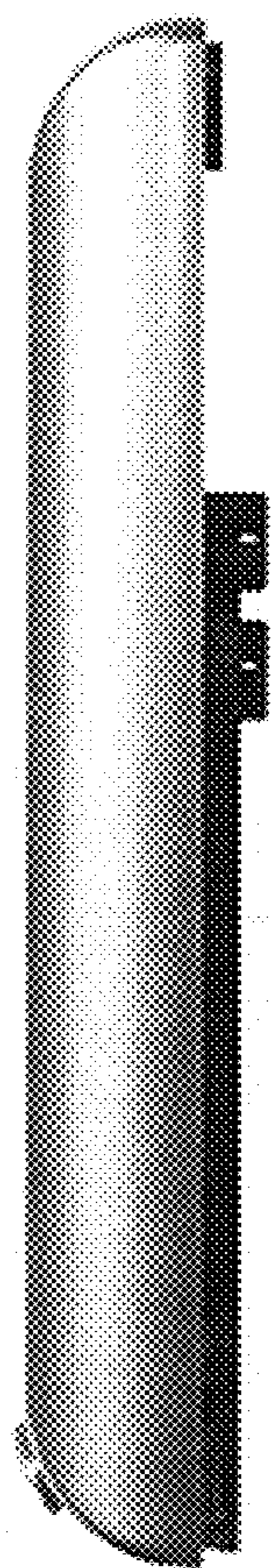
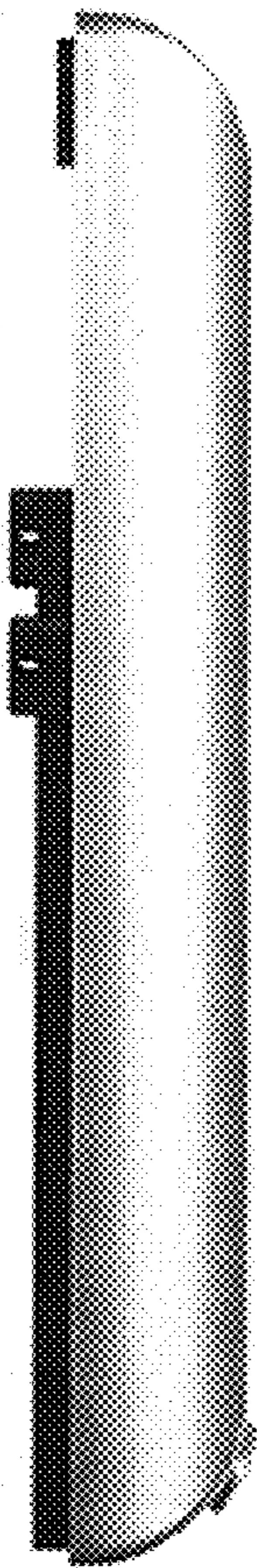
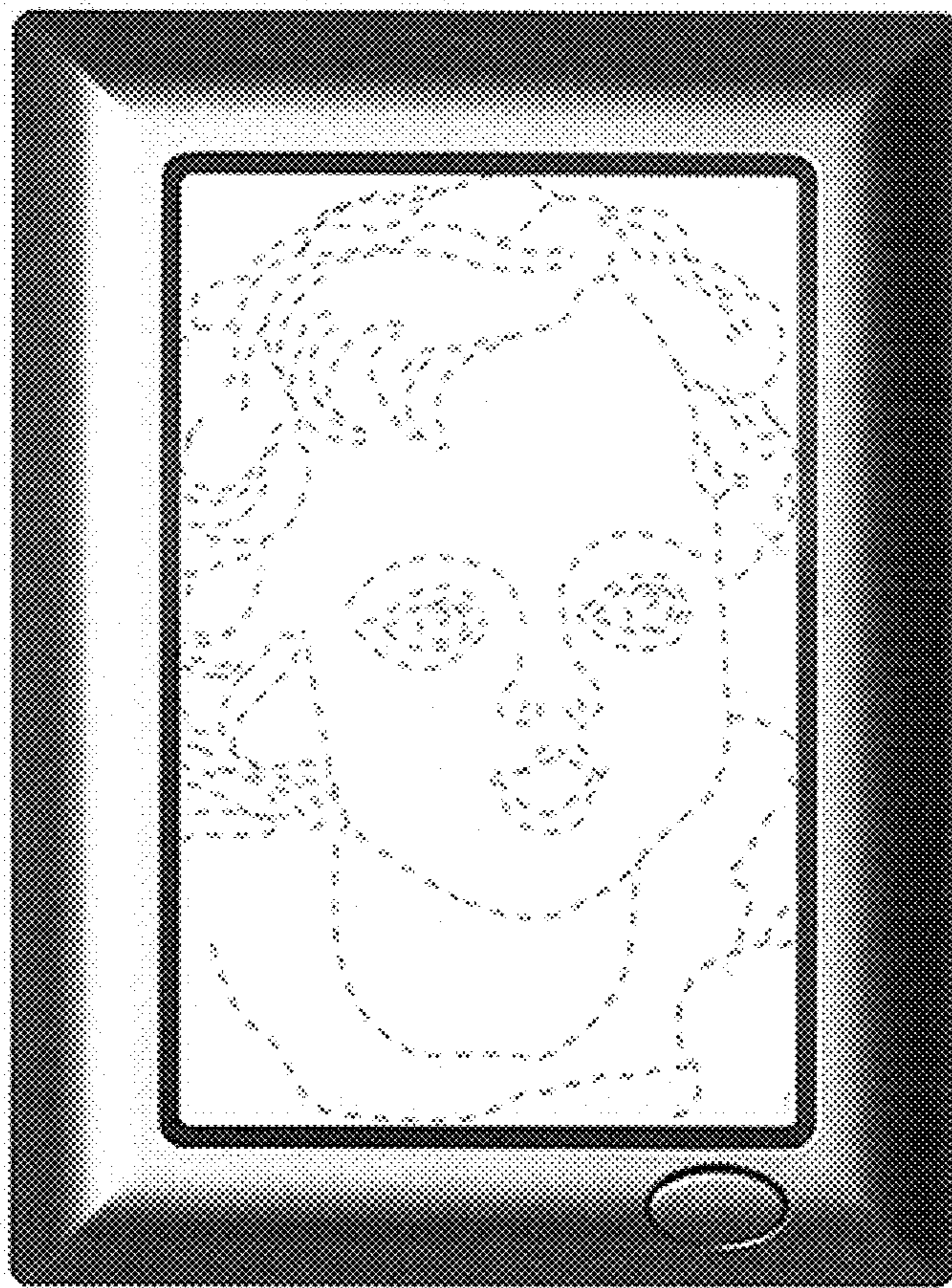
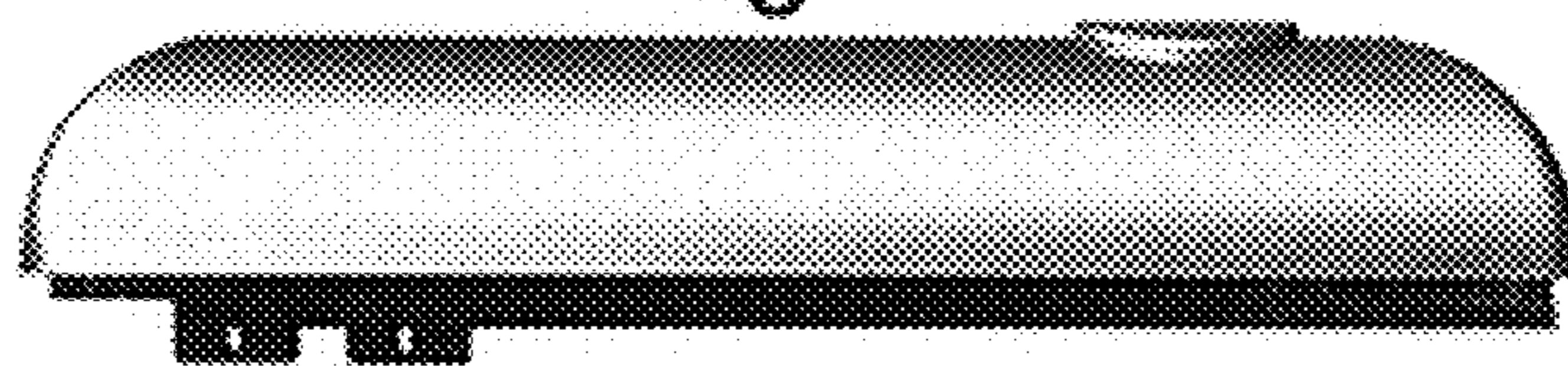

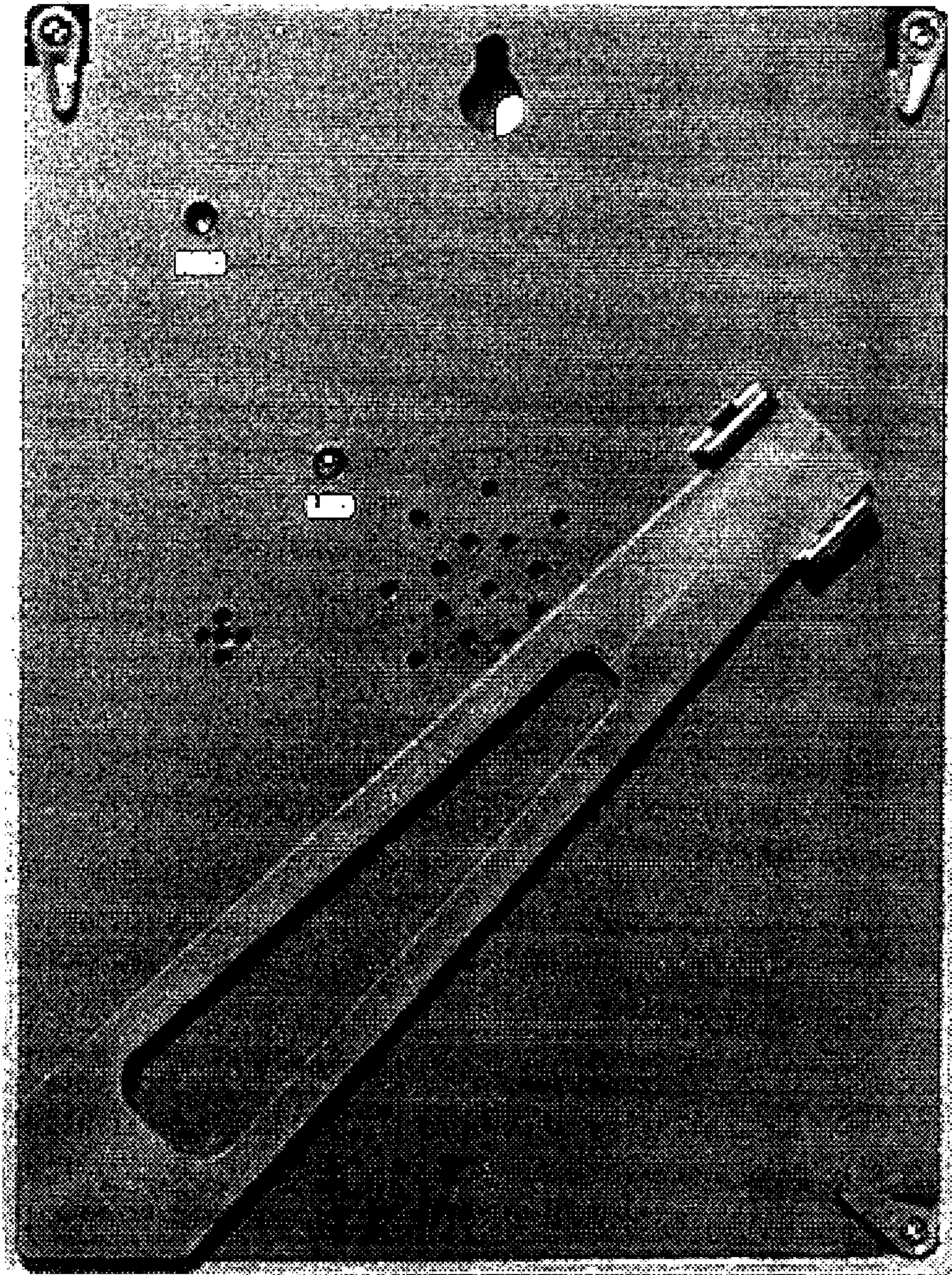
