(57) **CLAIM**

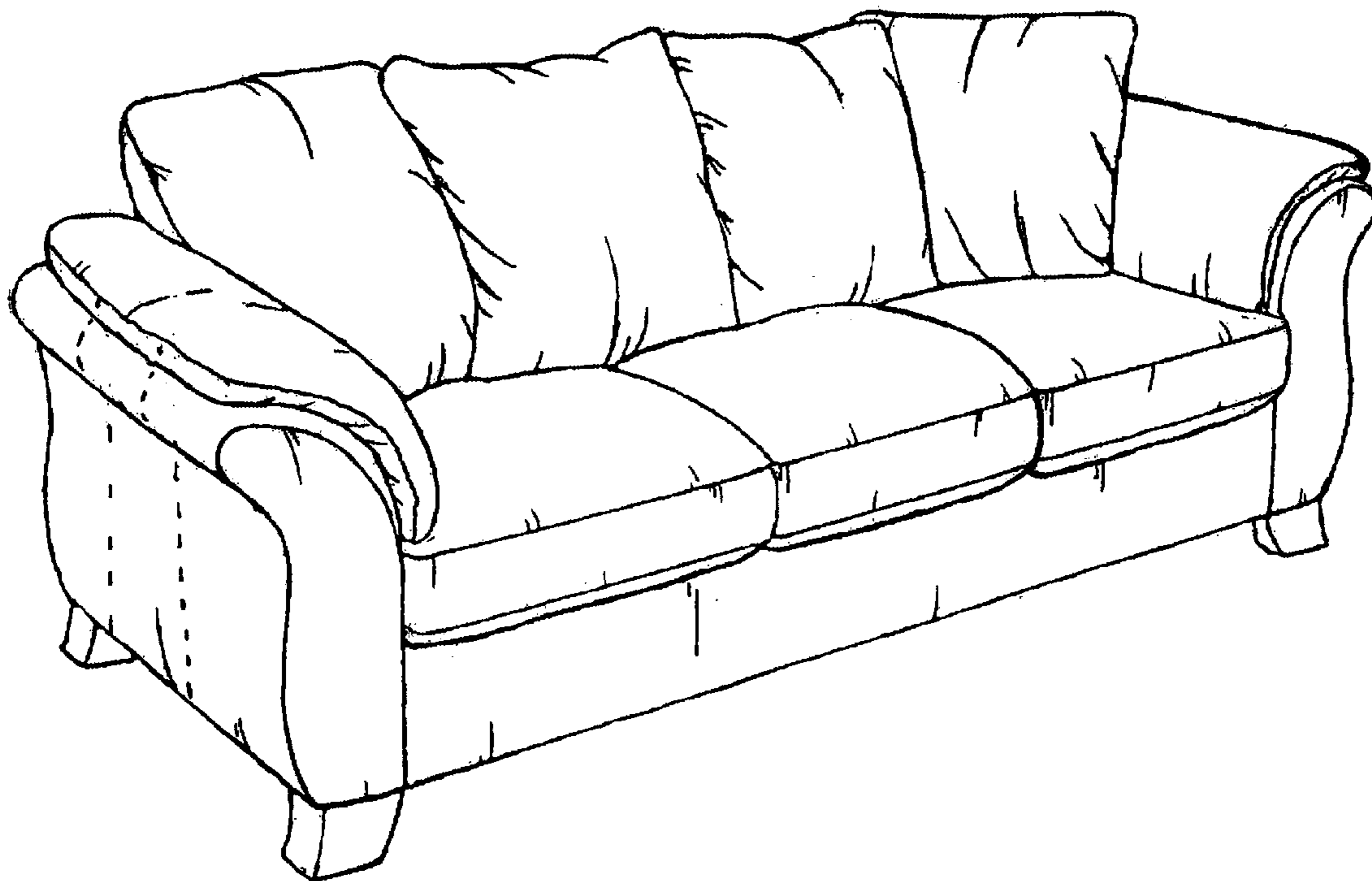
The ornamental design for a sofa, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view of a sofa according to an embodiment of the invention;  
FIG. 2 is a rear elevational view of a sofa according to an embodiment of the invention;  
FIG. 3 is a side elevational view of a sofa according to an embodiment of the invention;  
FIG. 4 is a top plan view of a sofa according to an embodiment of the invention; and,

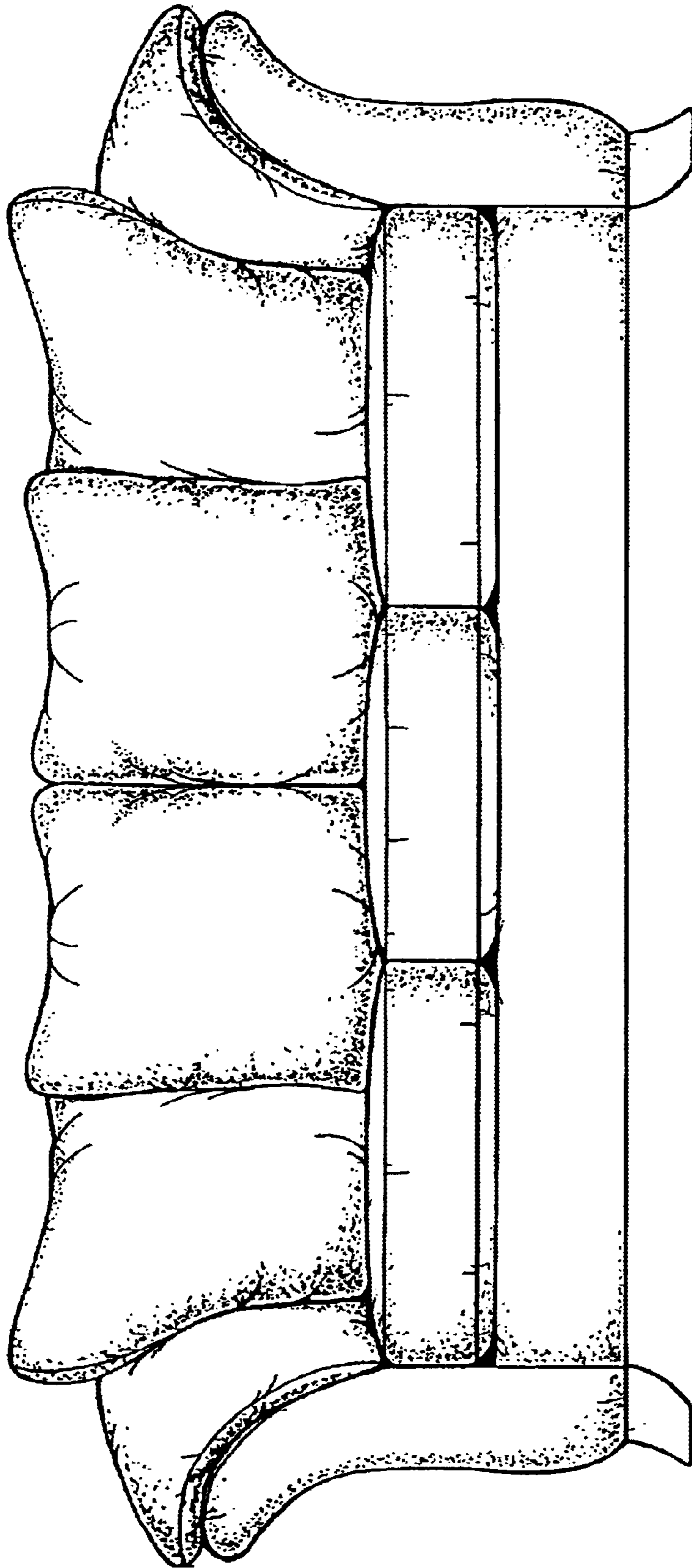

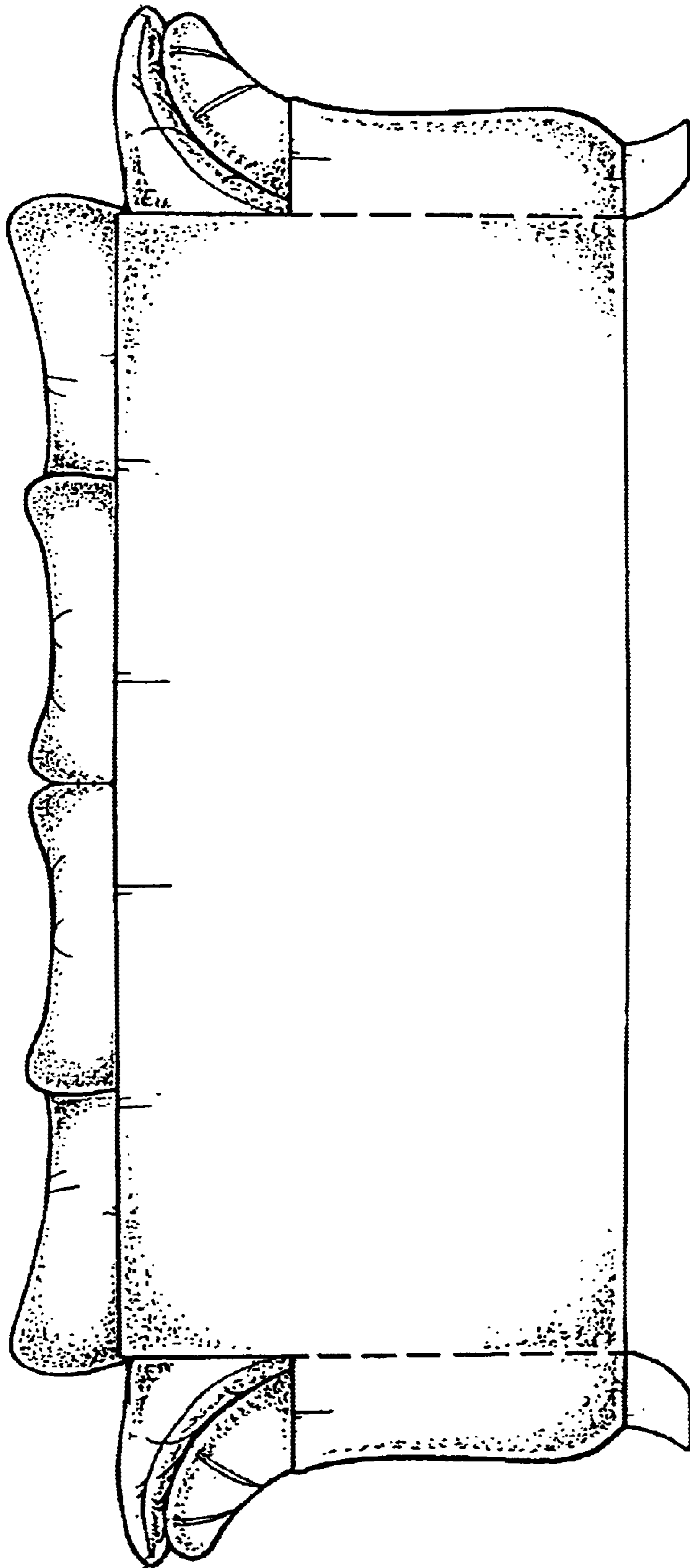

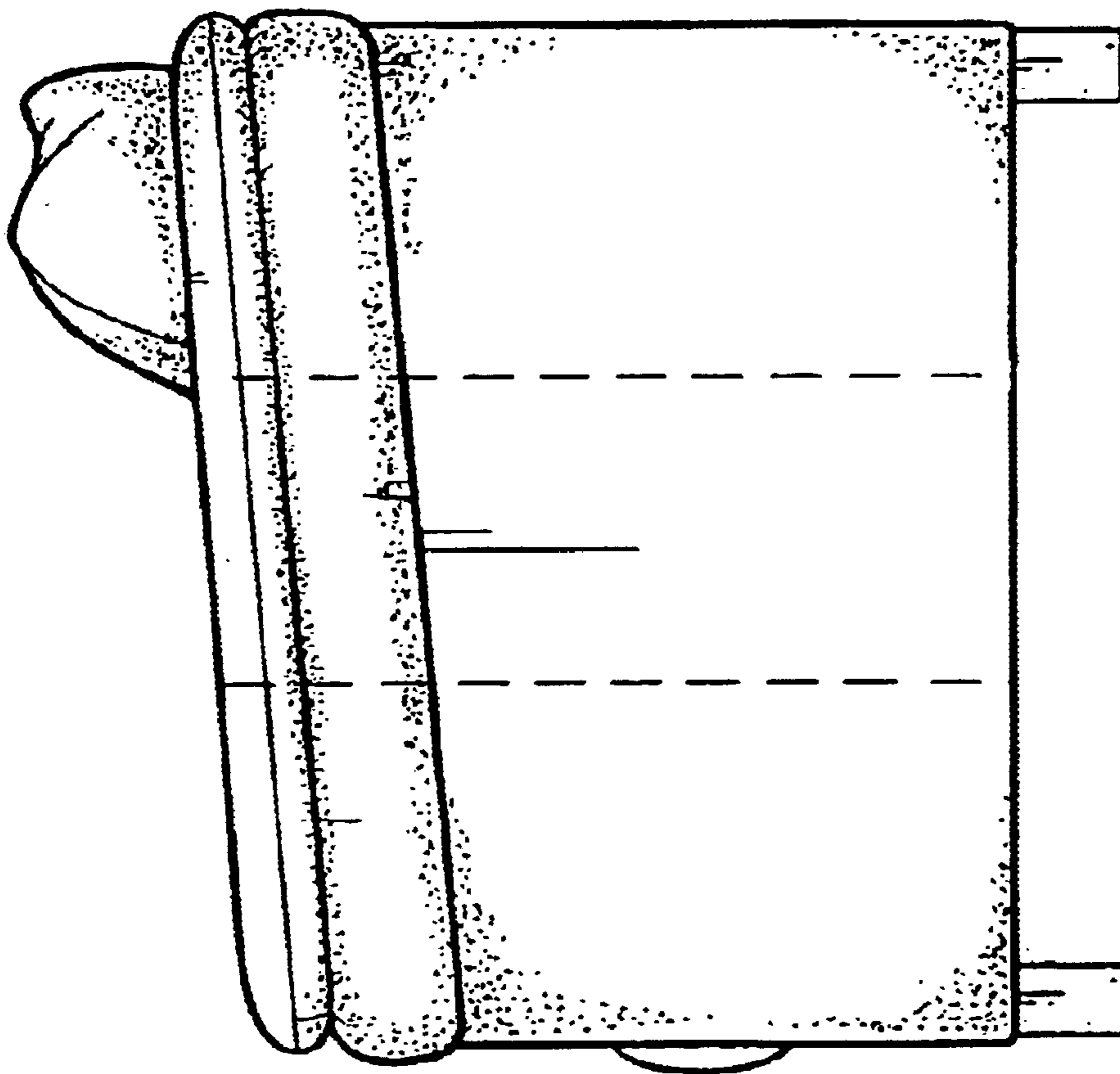

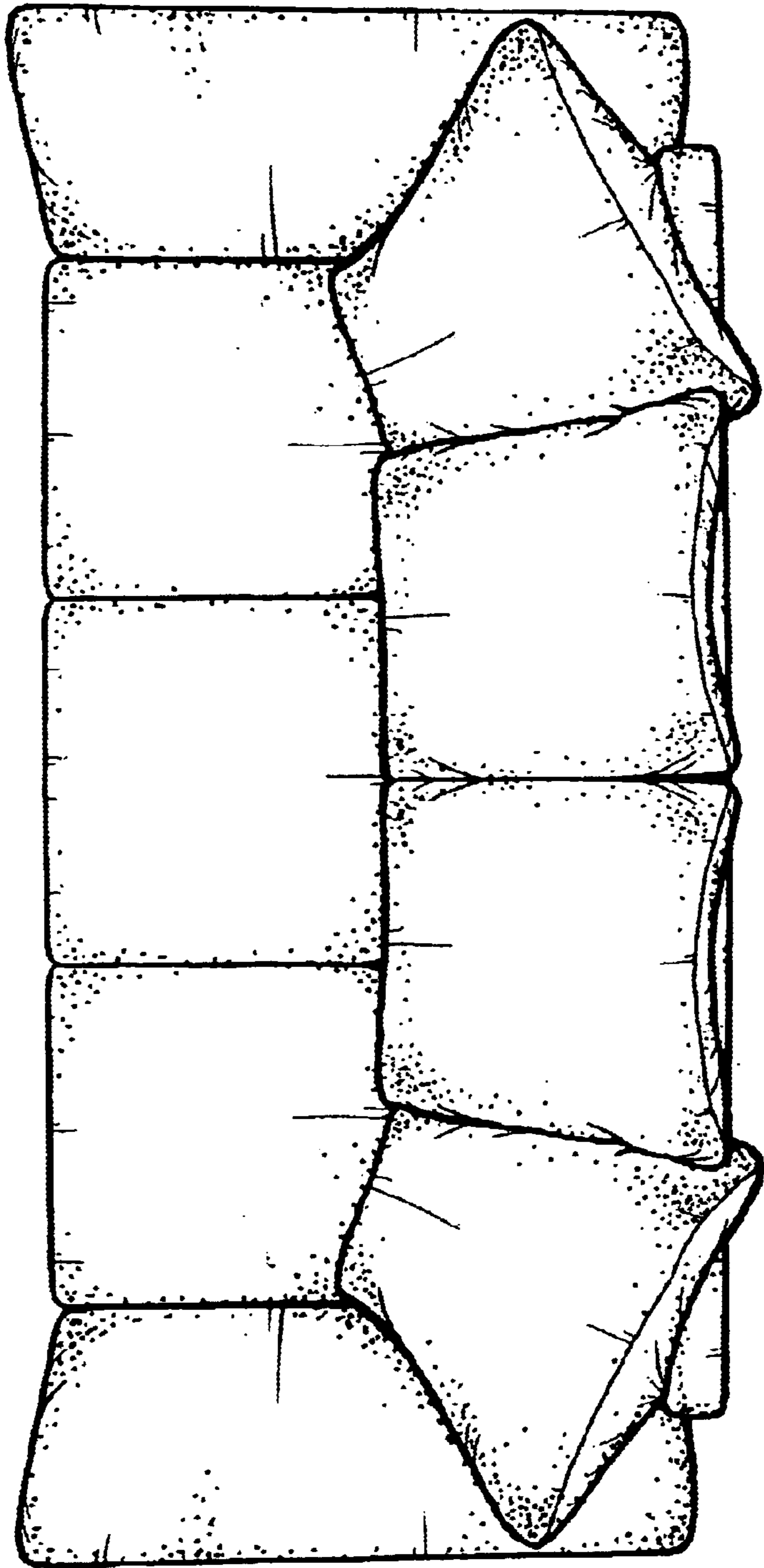

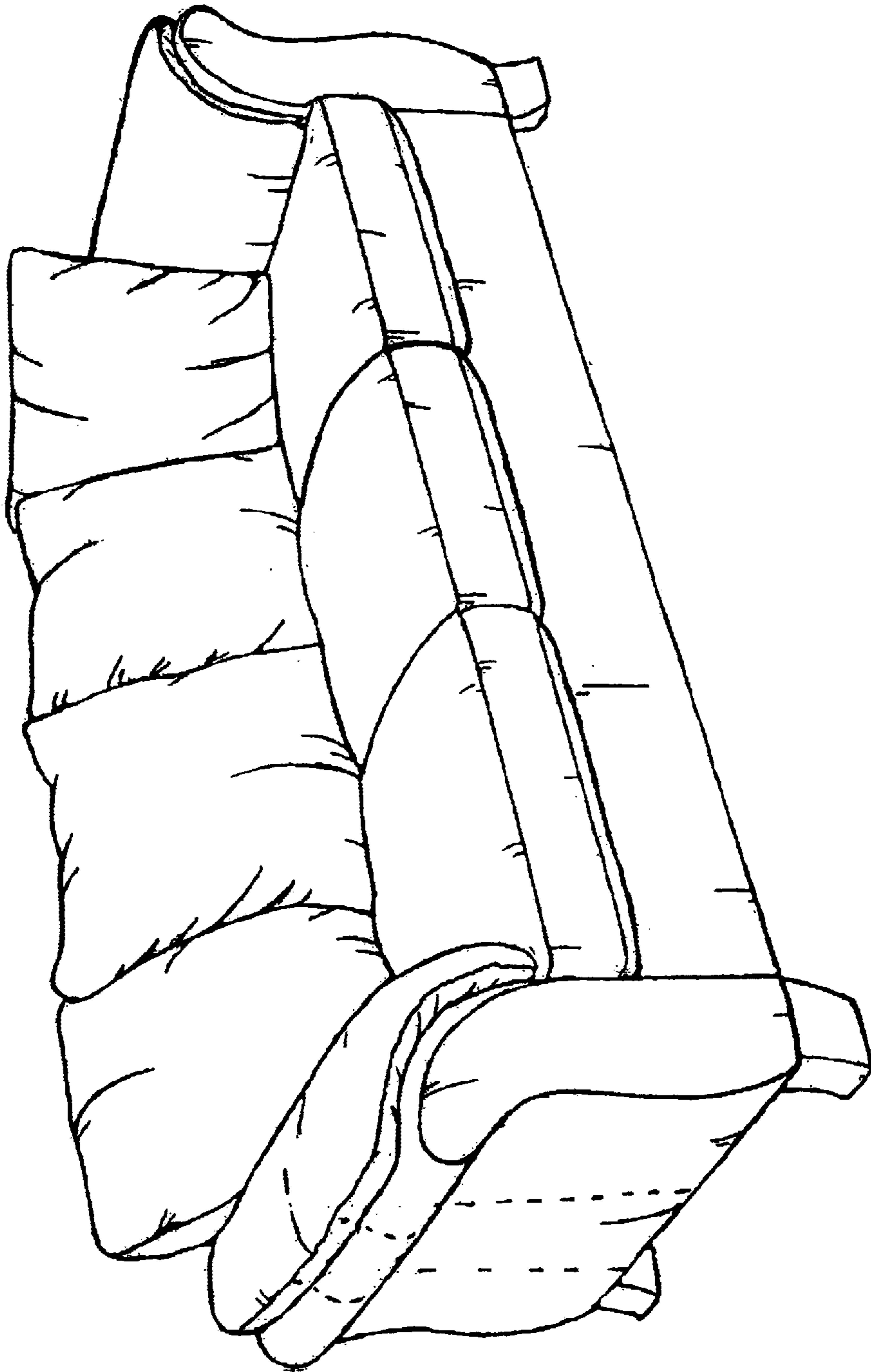
