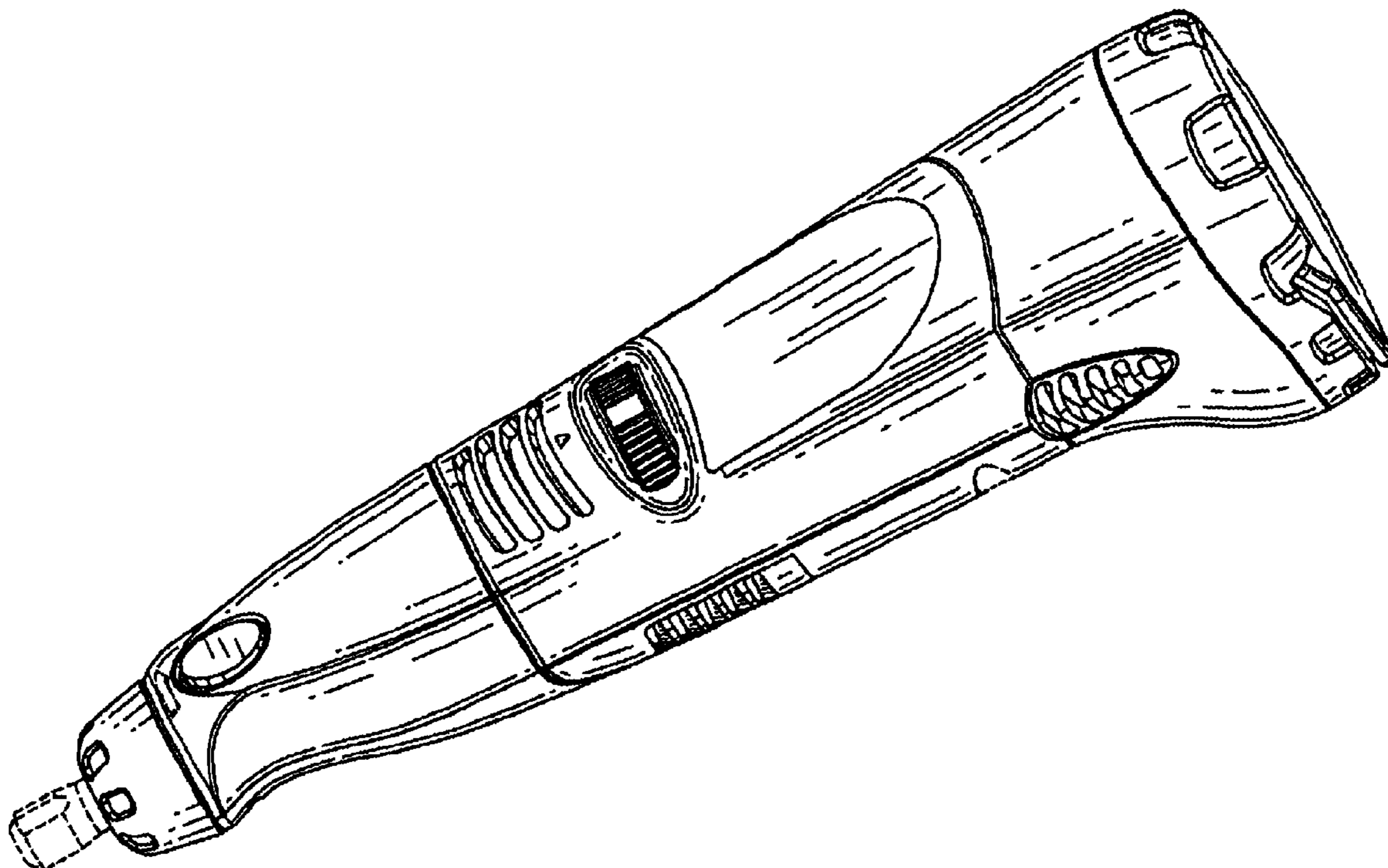
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a bottom right side perspective view of the present new design for a reciprocating saw;
 FIG. 2 is a top plan view thereof;
 FIG. 3 is a left elevational view thereof;
 FIG. 4 is a bottom plan view thereof;
 FIG. 5 is a right elevational view thereof;

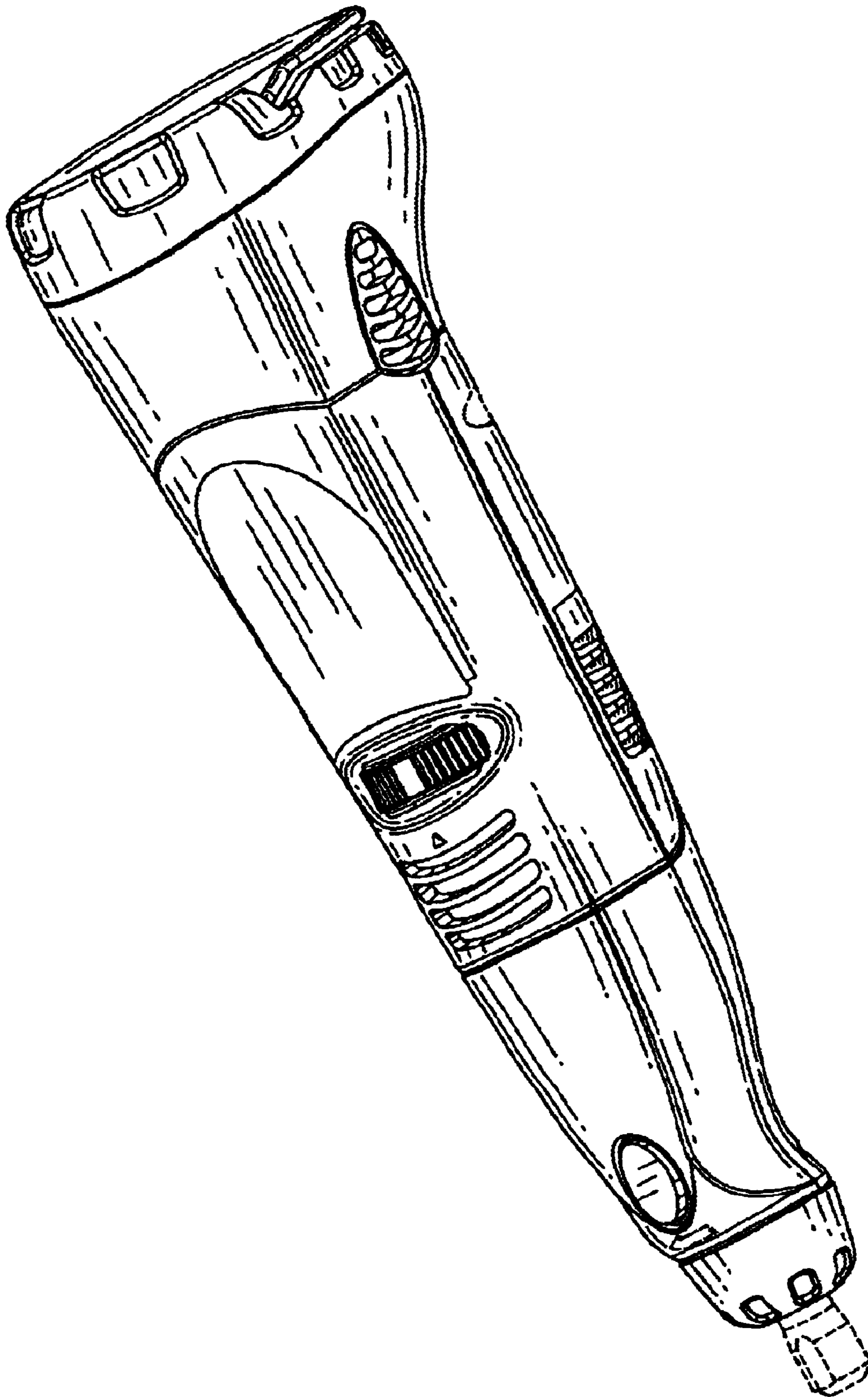

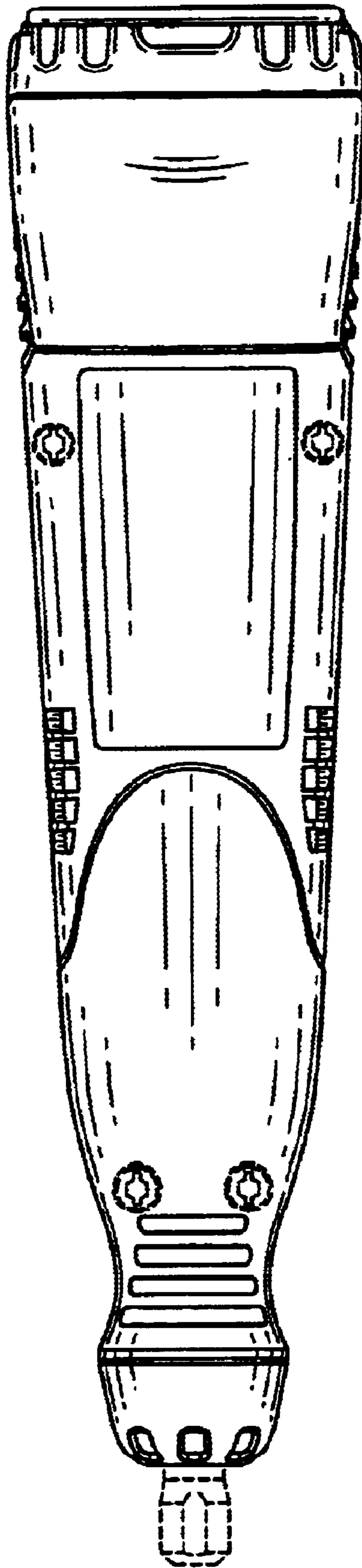

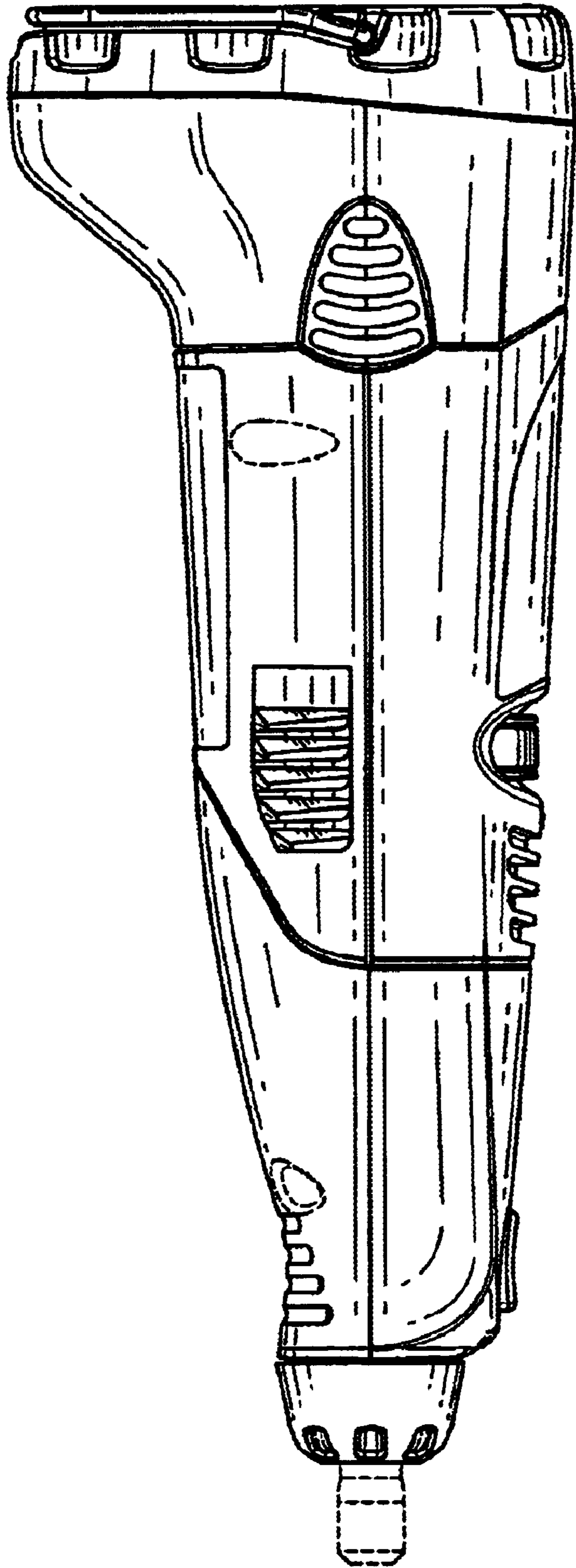

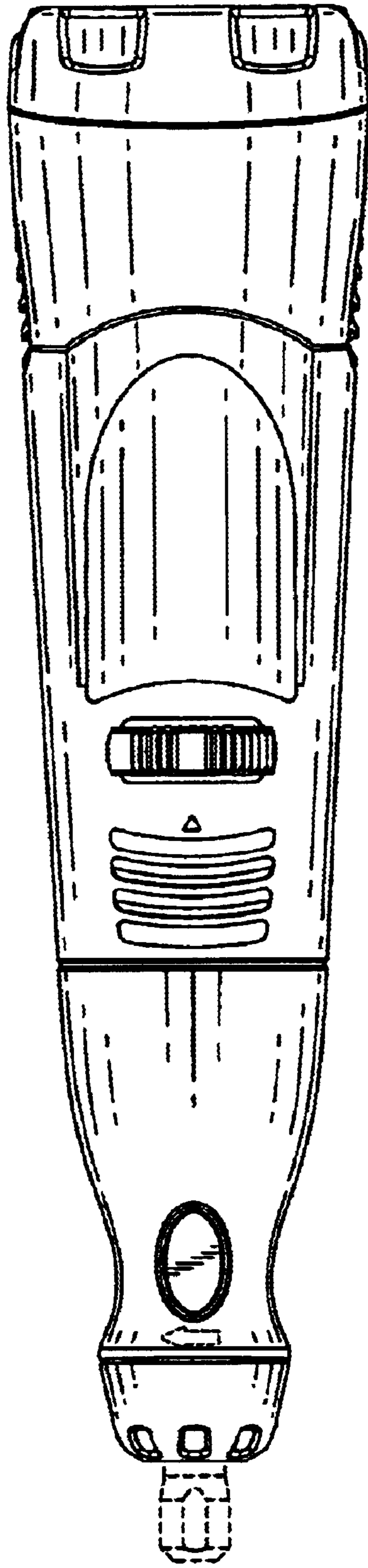

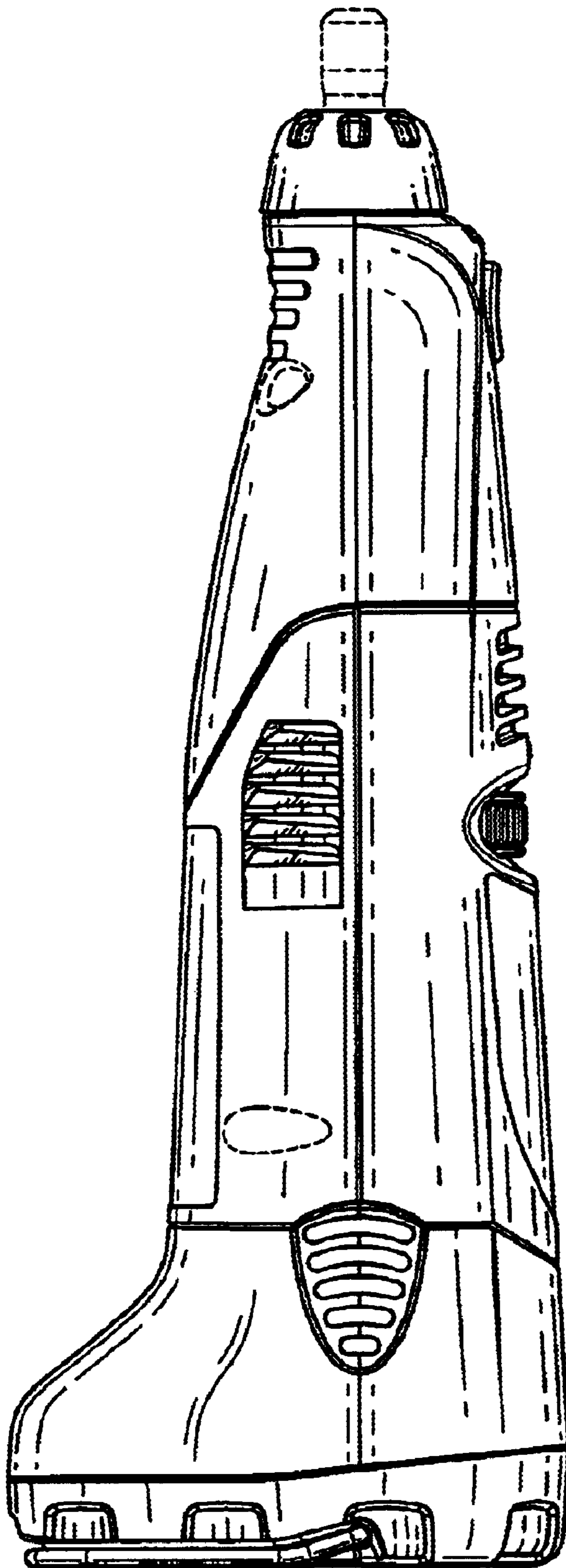

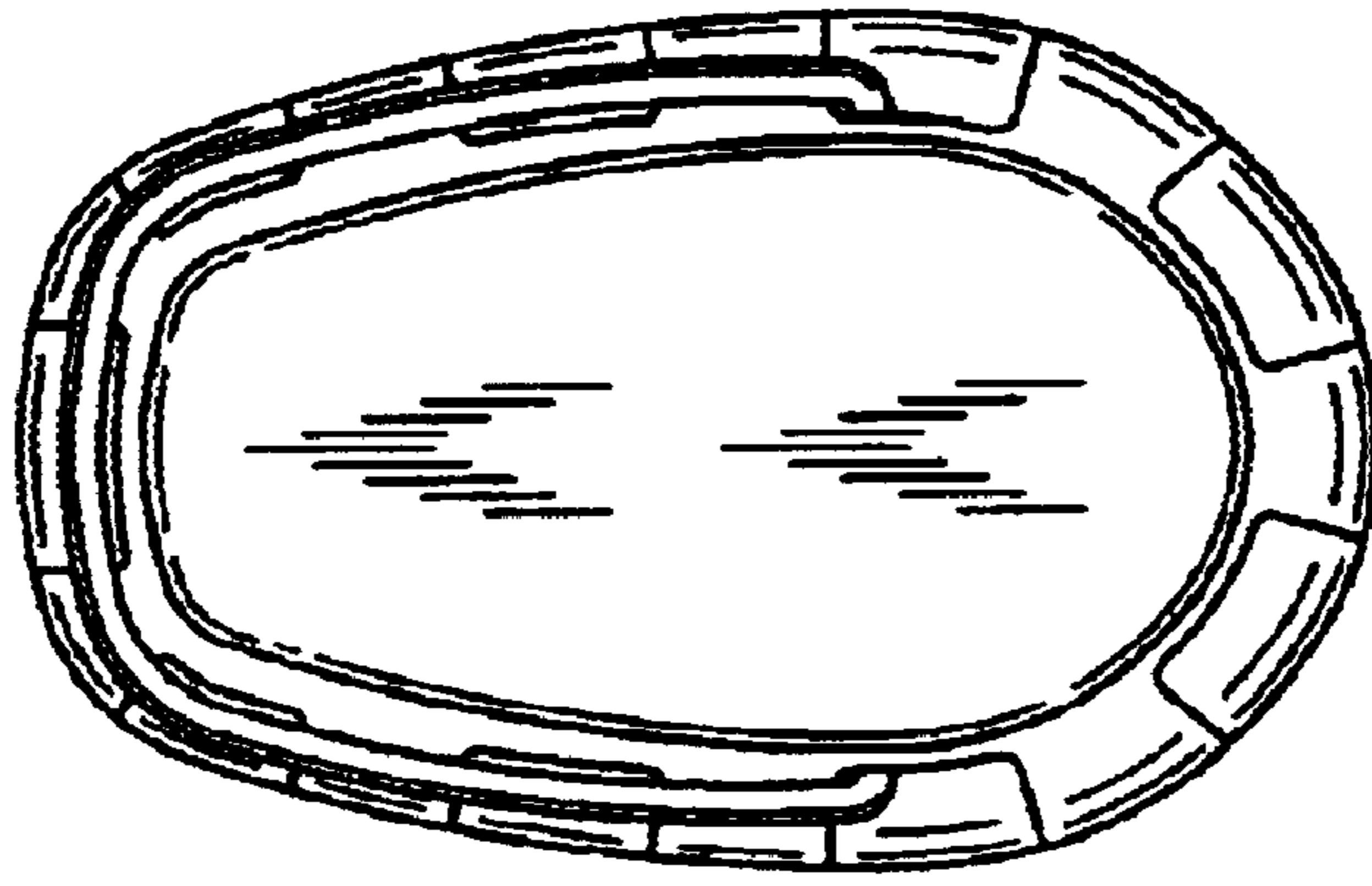

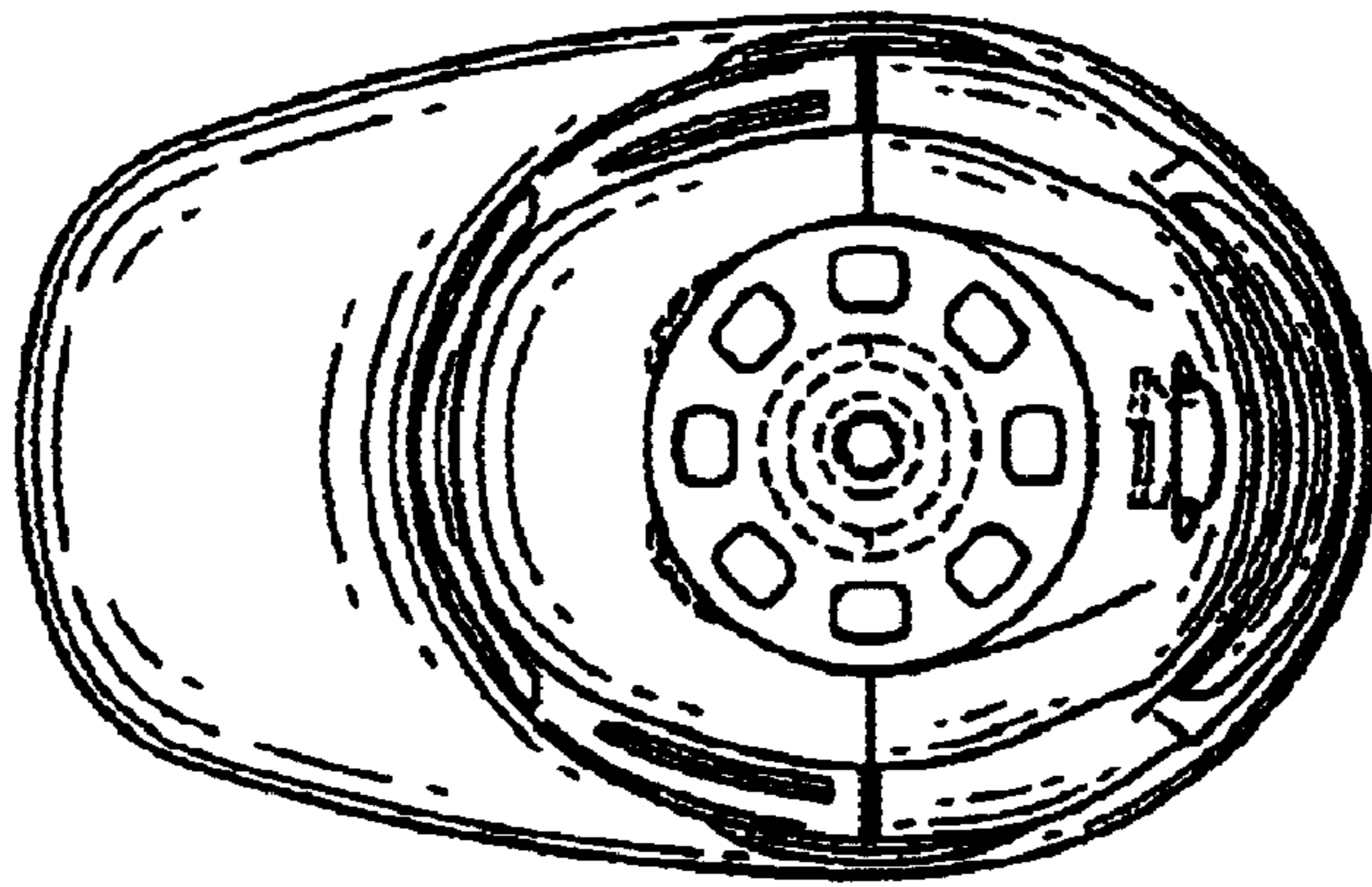
