FIG. 6 is a bottom plan view thereof.

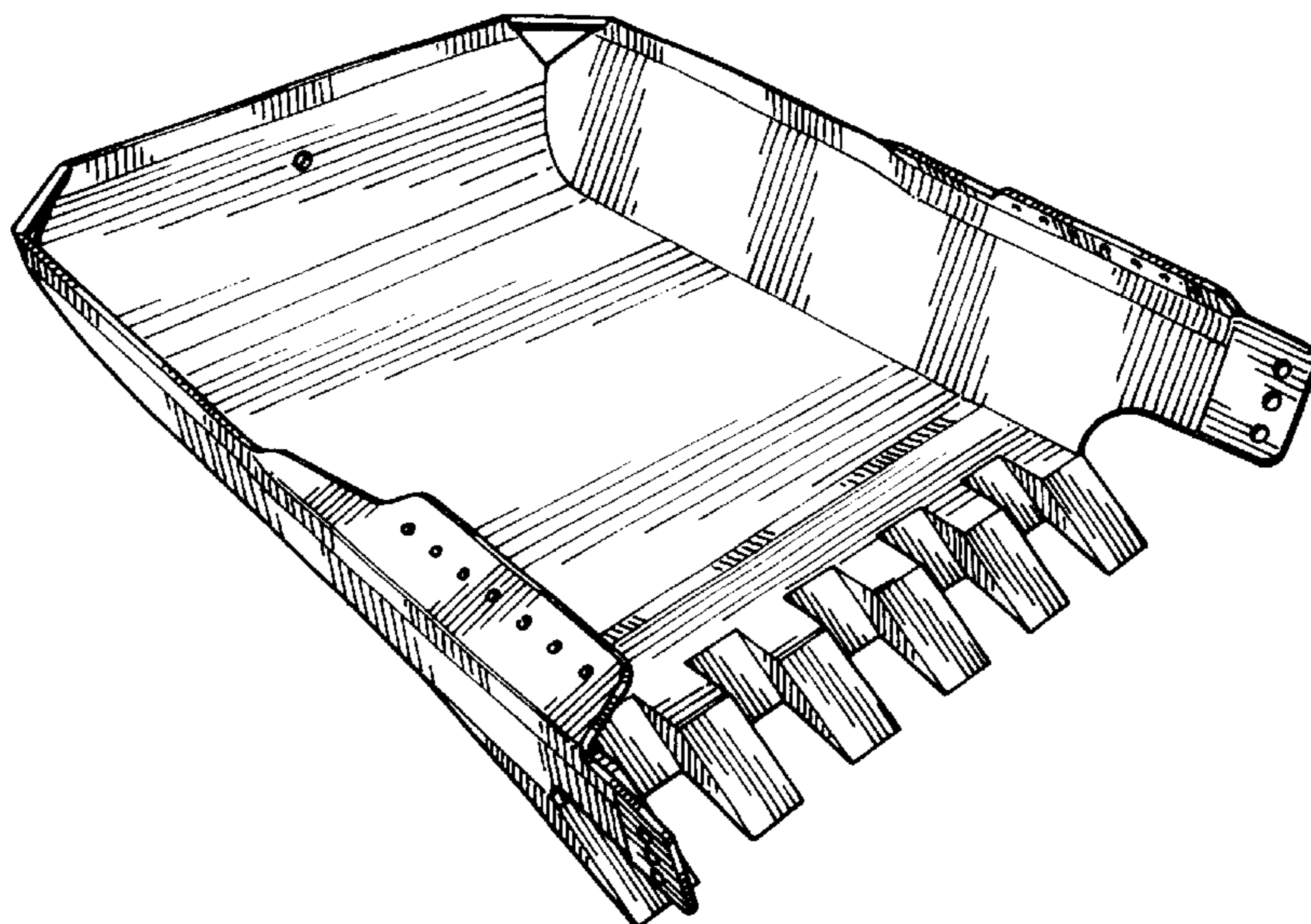
Background features (such as flooring and adjacent fixtures), Alphanumerical characters, other incidental markings and any features indicated in broken lines in the accompanying drawings form no part of the claimed invention. In particular, the shape and configuration of the hoist rope mounting points (seen as inwardly angled upper flanges with rows of seven holes), drag rope mounting points (seen as forwardly extruding flanges with rows of three holes) and cutting teeth form no part of the claimed invention.

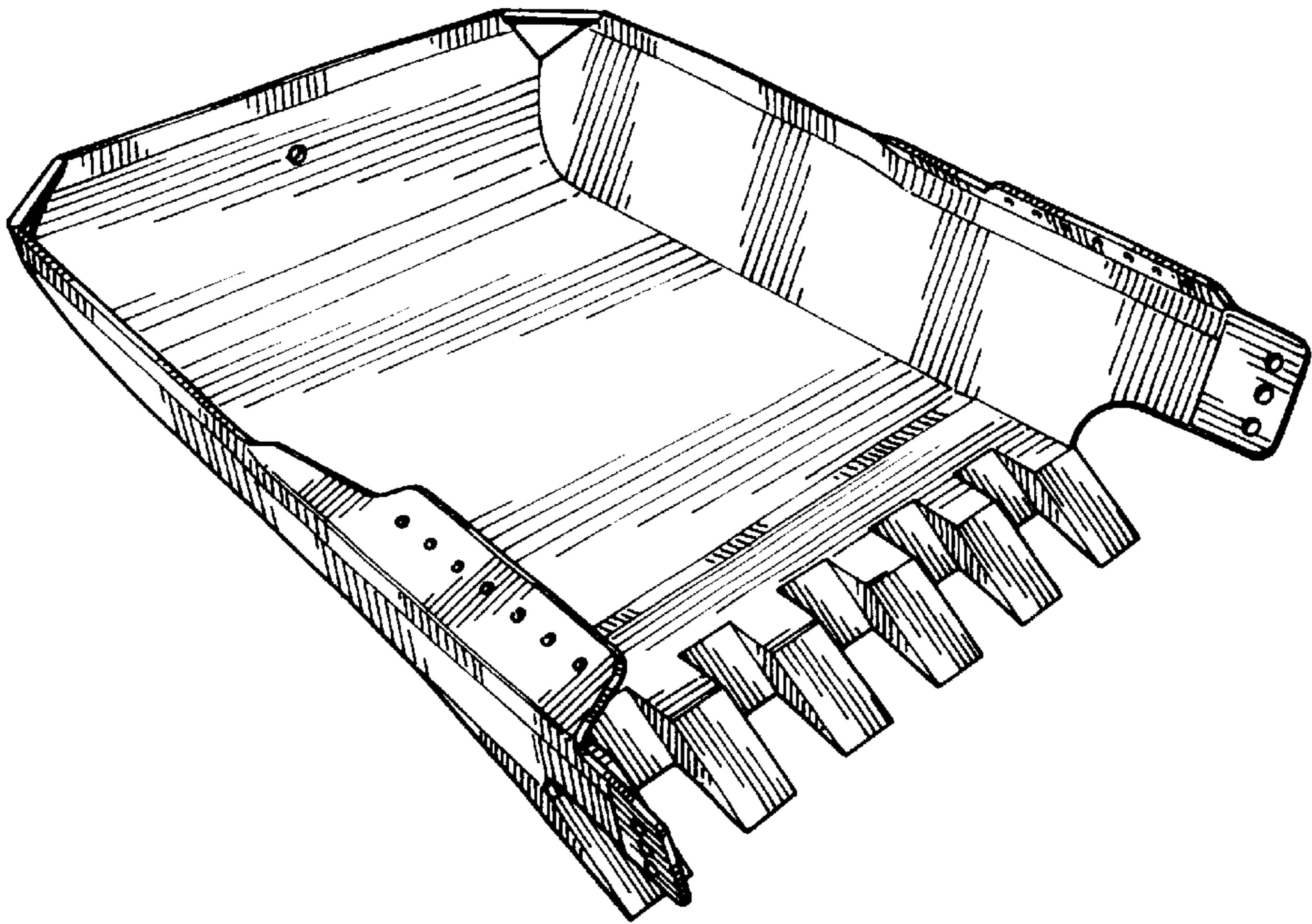

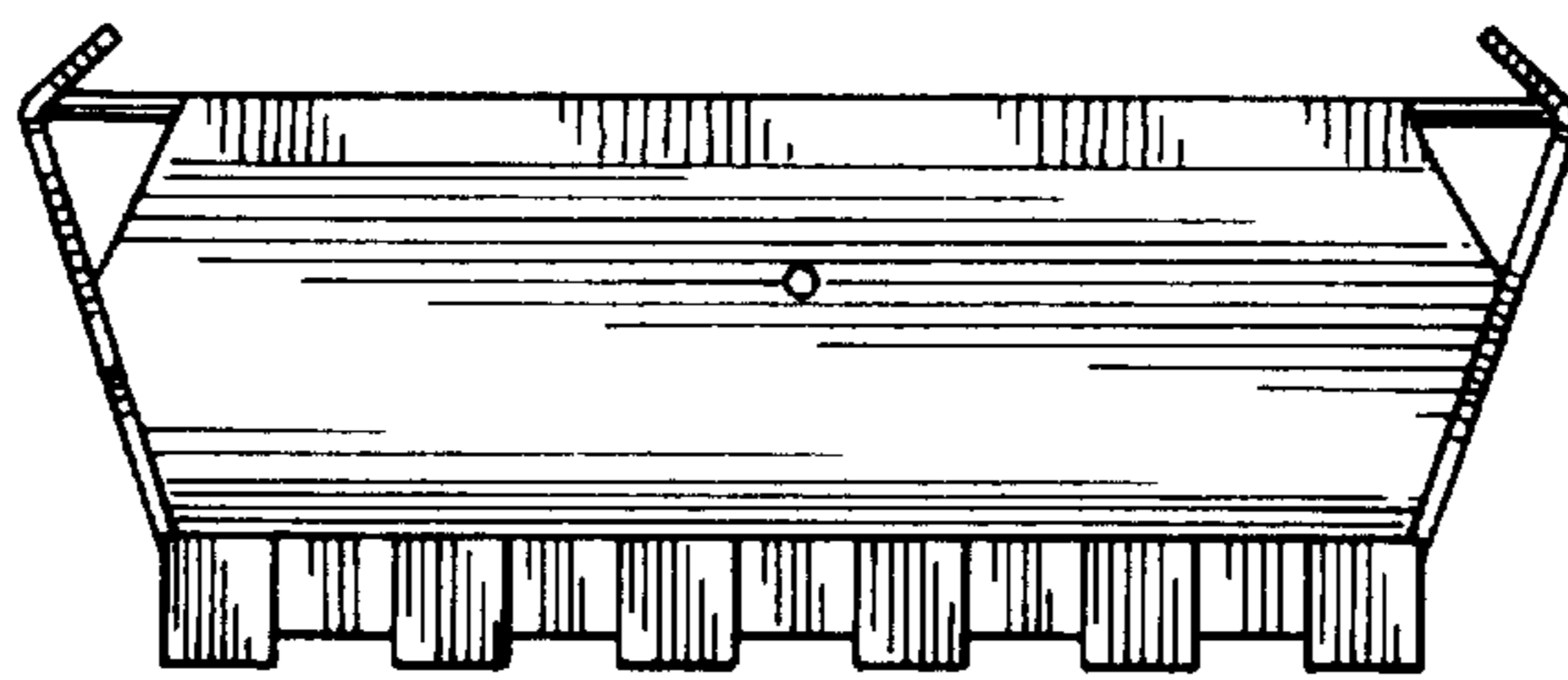

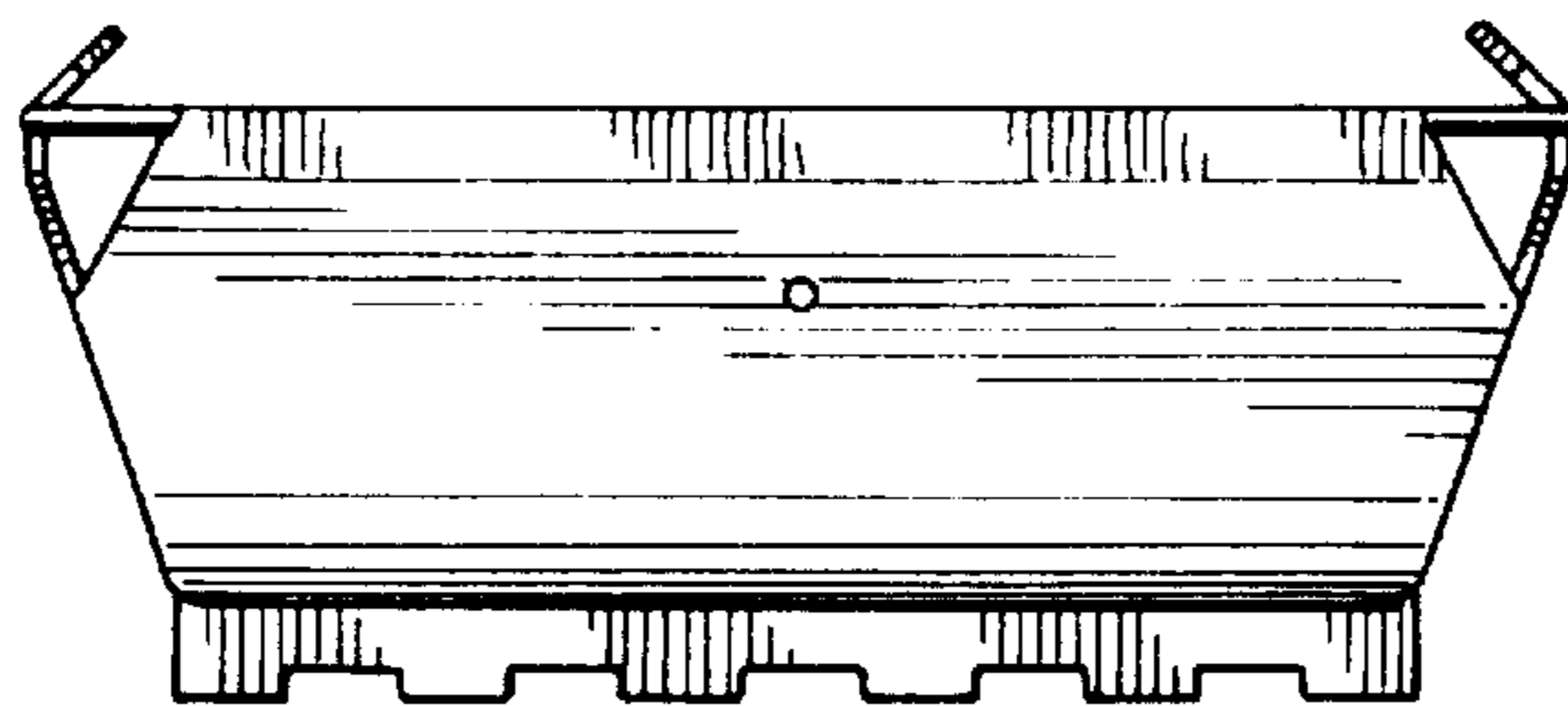
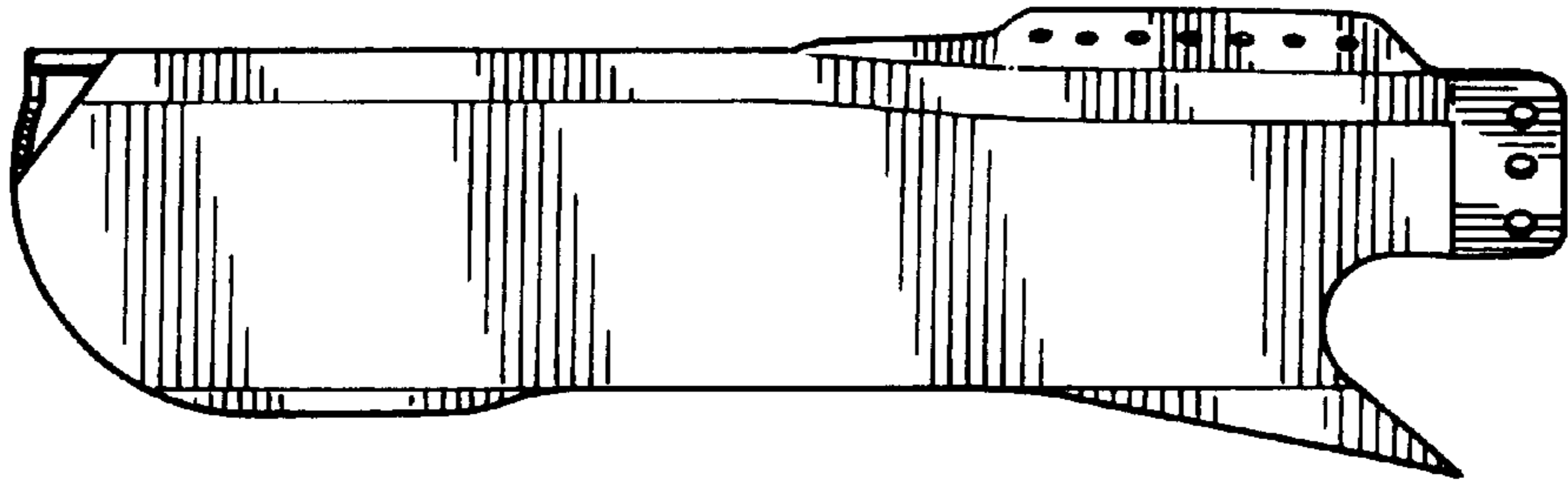
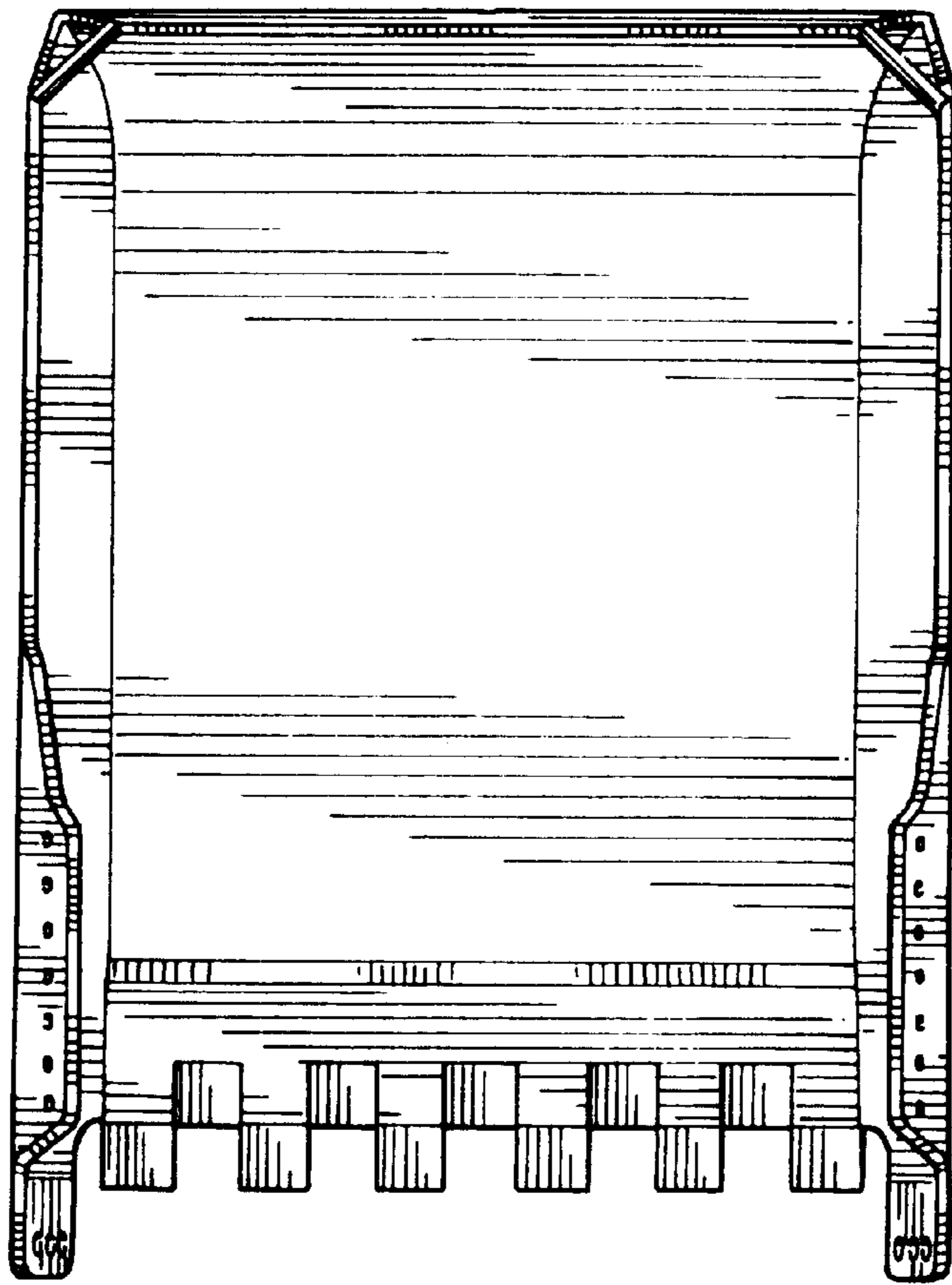


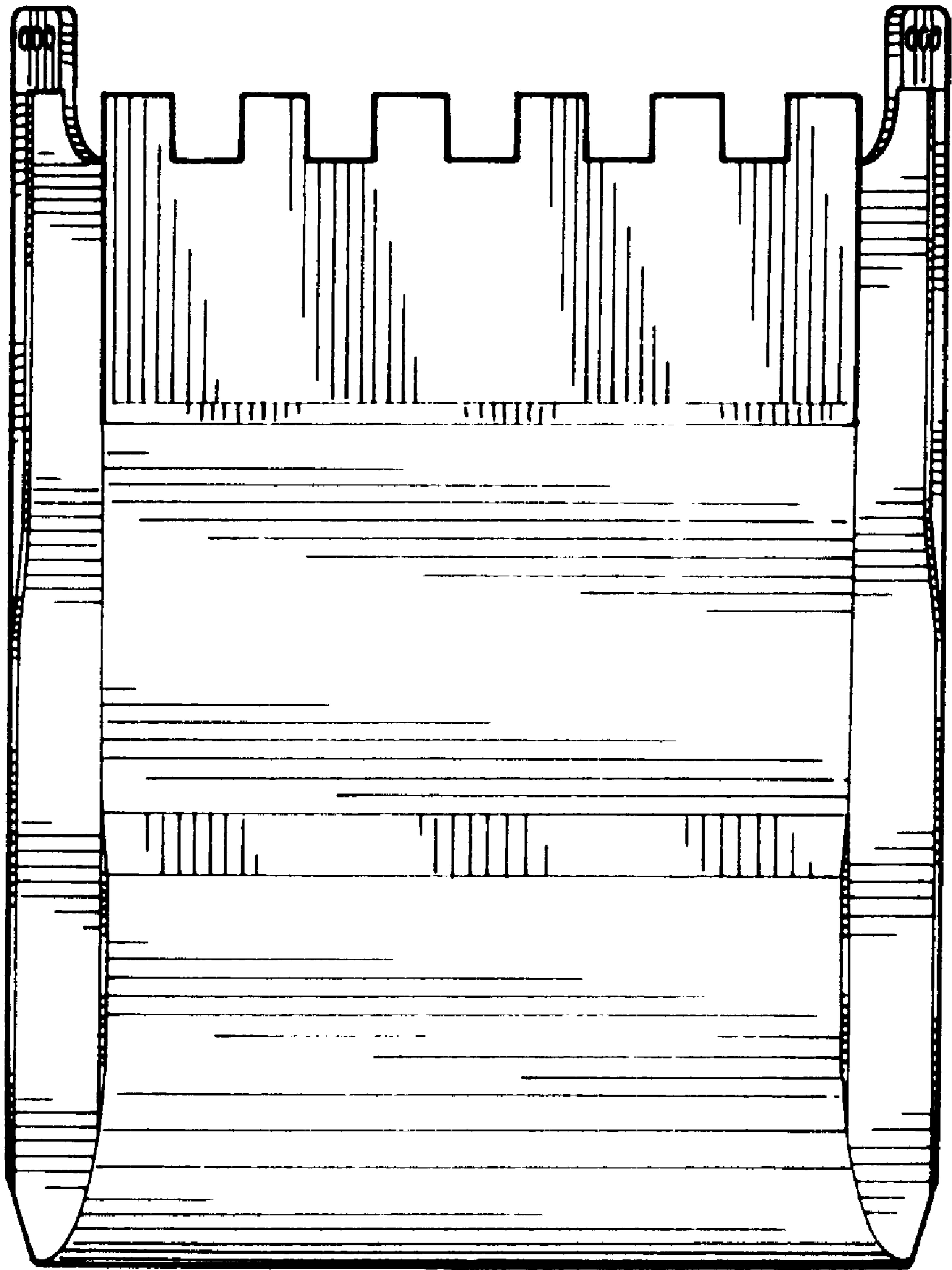
