(57) **CLAIM**

The ornamental design for a tabletop theme fountain with integrateable display board, as shown and described.

DESCRIPTION

FIG. 1 is a front and side elevational perspective view of one side of a tabletop theme fountain with integrateable display board;

FIG. 2 is a front view of a tabletop theme fountain with integrateable display board removed;

FIG. 3 is a top view of a tabletop theme fountain with integrateable display board removed;

FIG. 4 is a rear elevational view of a tabletop theme fountain with integrateable display board;

FIG. 5 is a bottom view of a tabletop theme fountain with integrateable display board;

FIG. 6 is an exploded side elevational view of a tabletop theme fountain with integrateable display board removed;

FIG. 7 is a top view of an integrateable display board;

FIG. 8 is a front view of an integrateable display board;

FIG. 9 is a rear view of an integrateable display board;

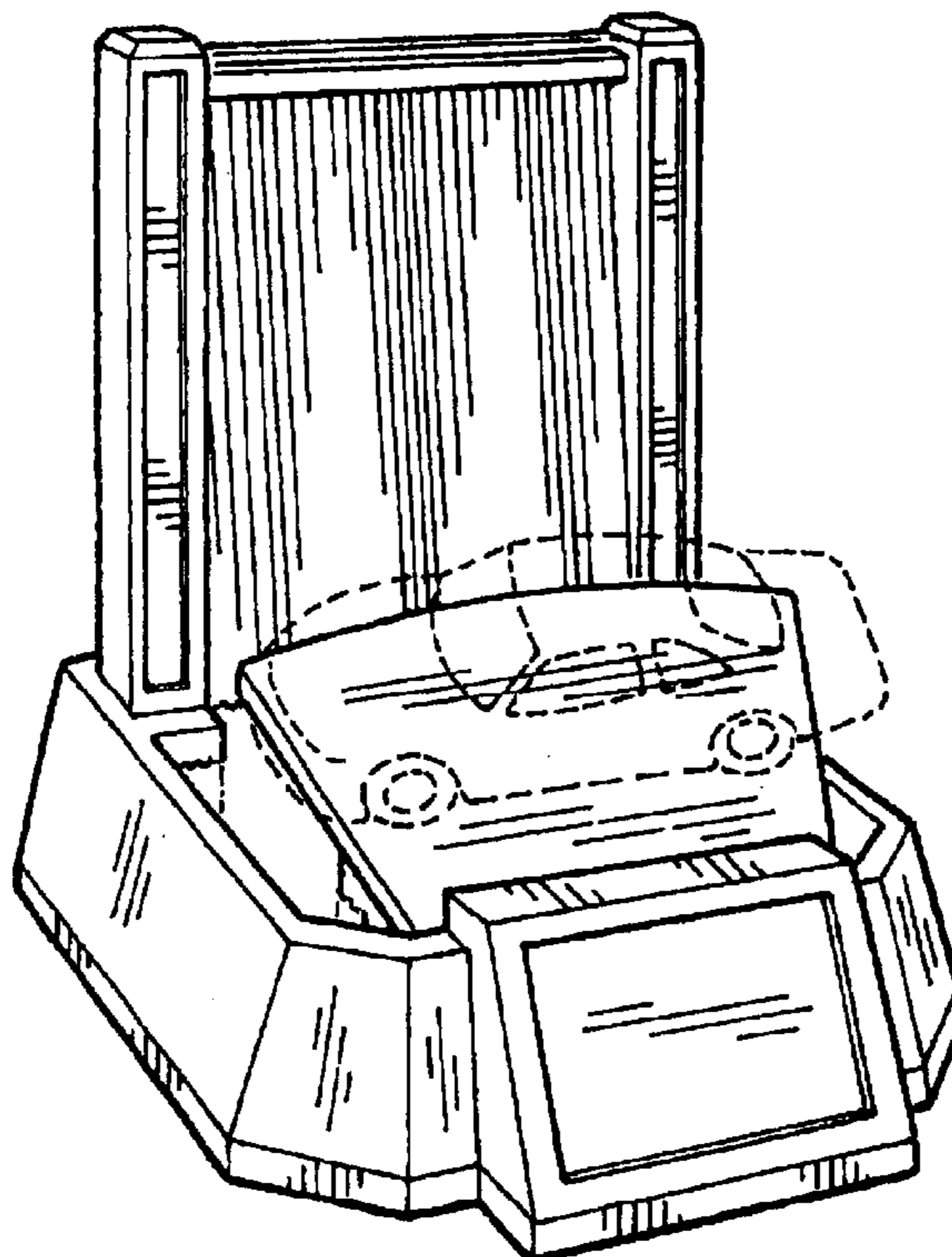
FIG. 10 is a bottom view of an integrateable display board;

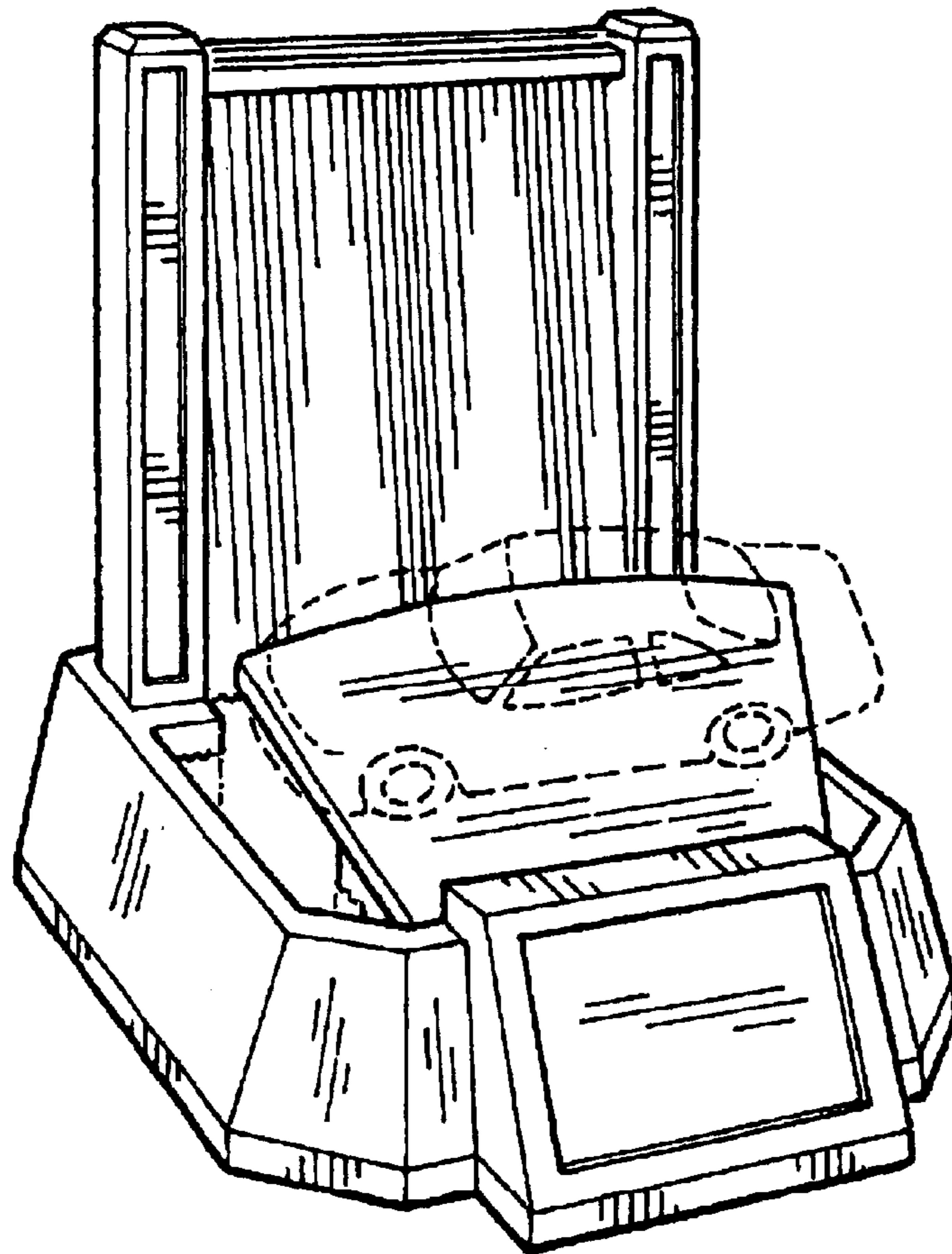

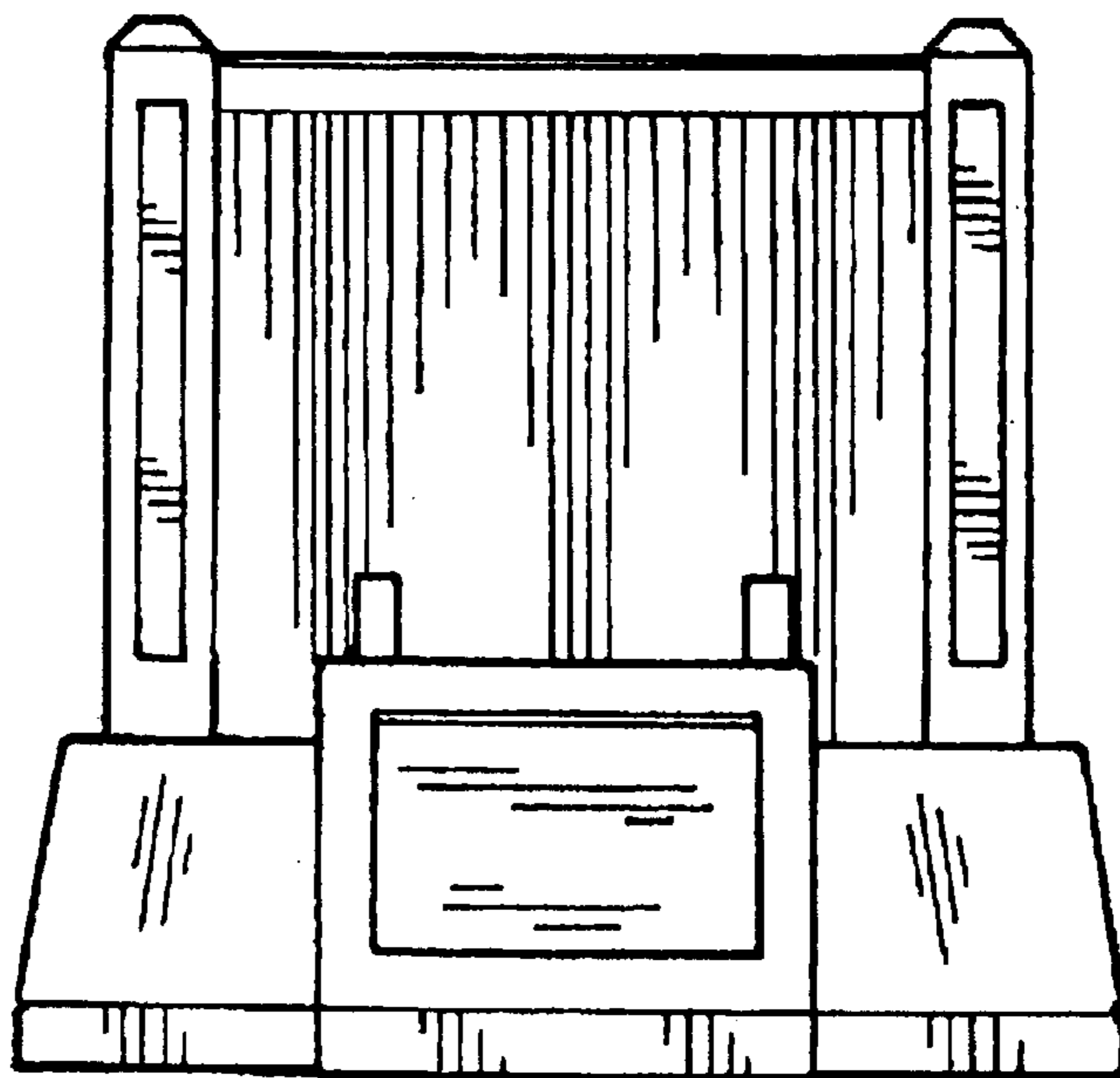

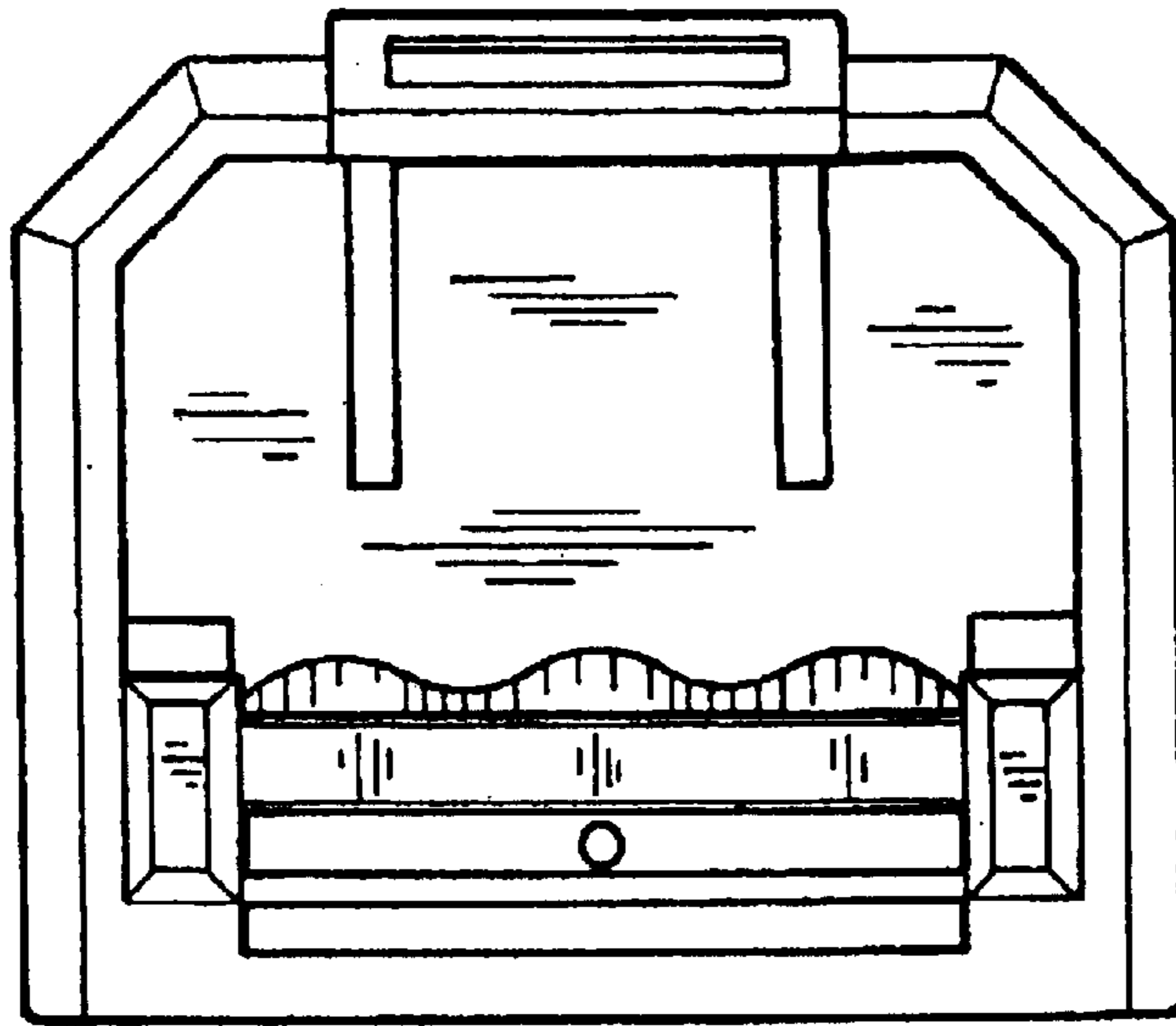

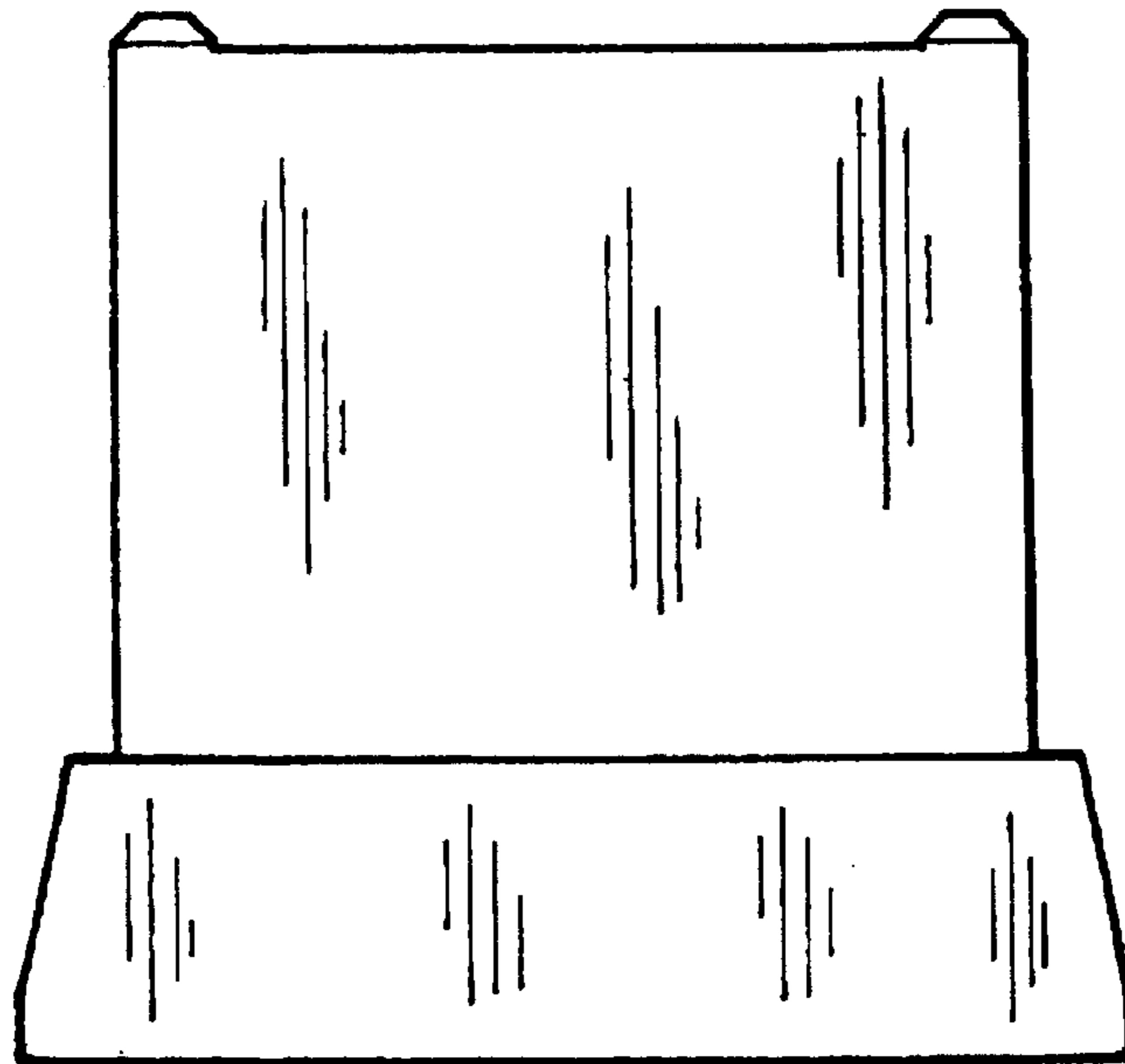

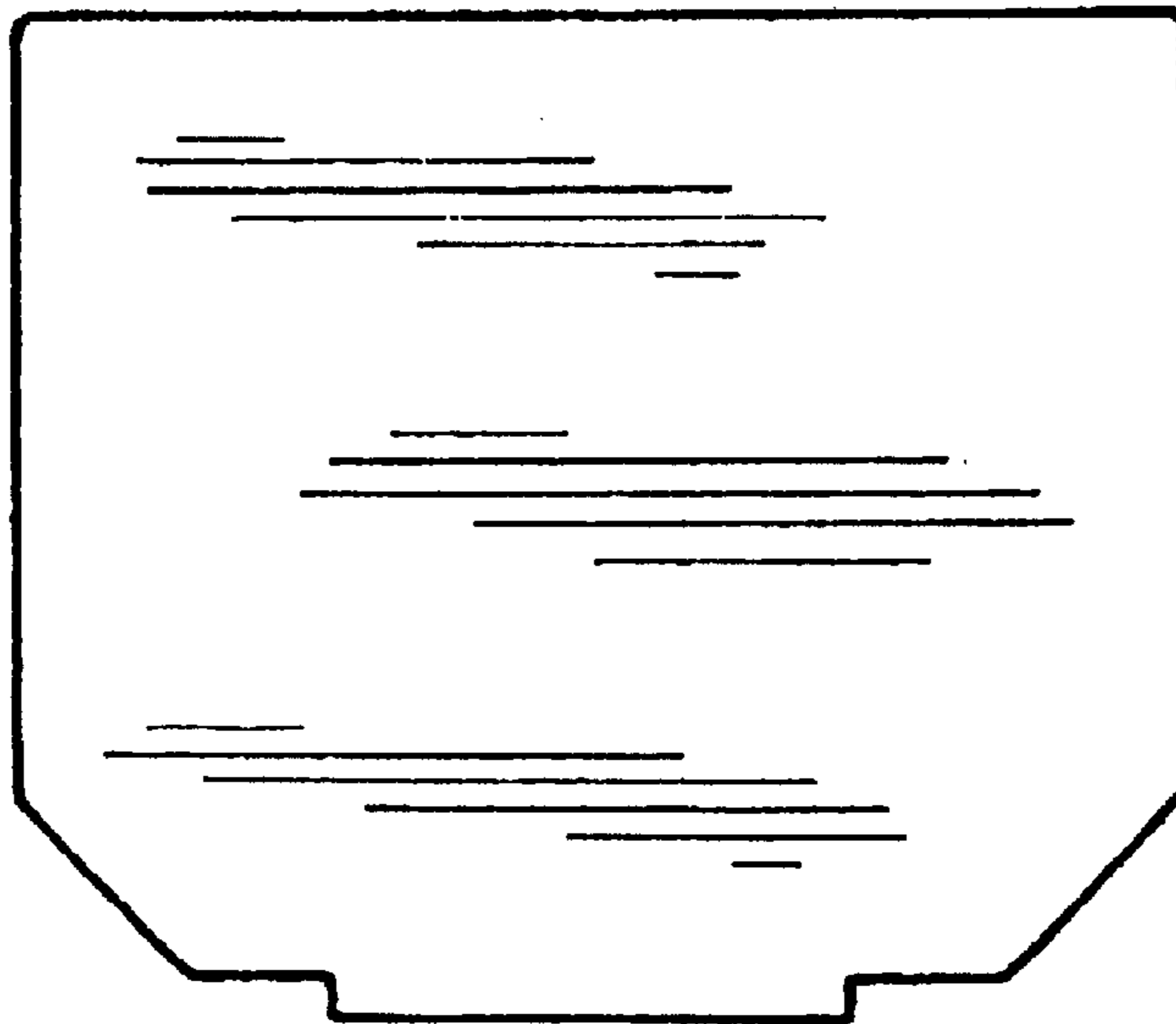

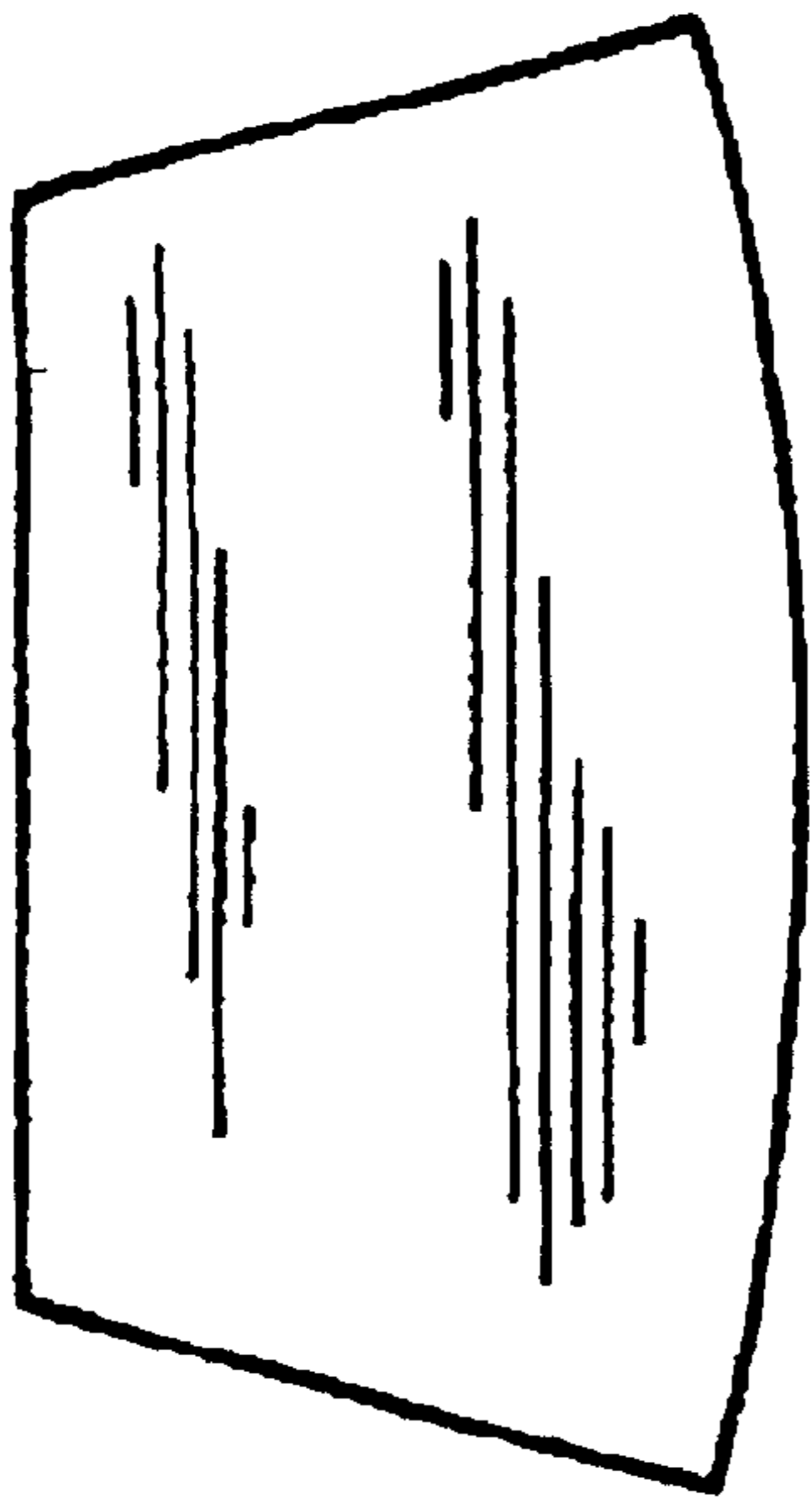

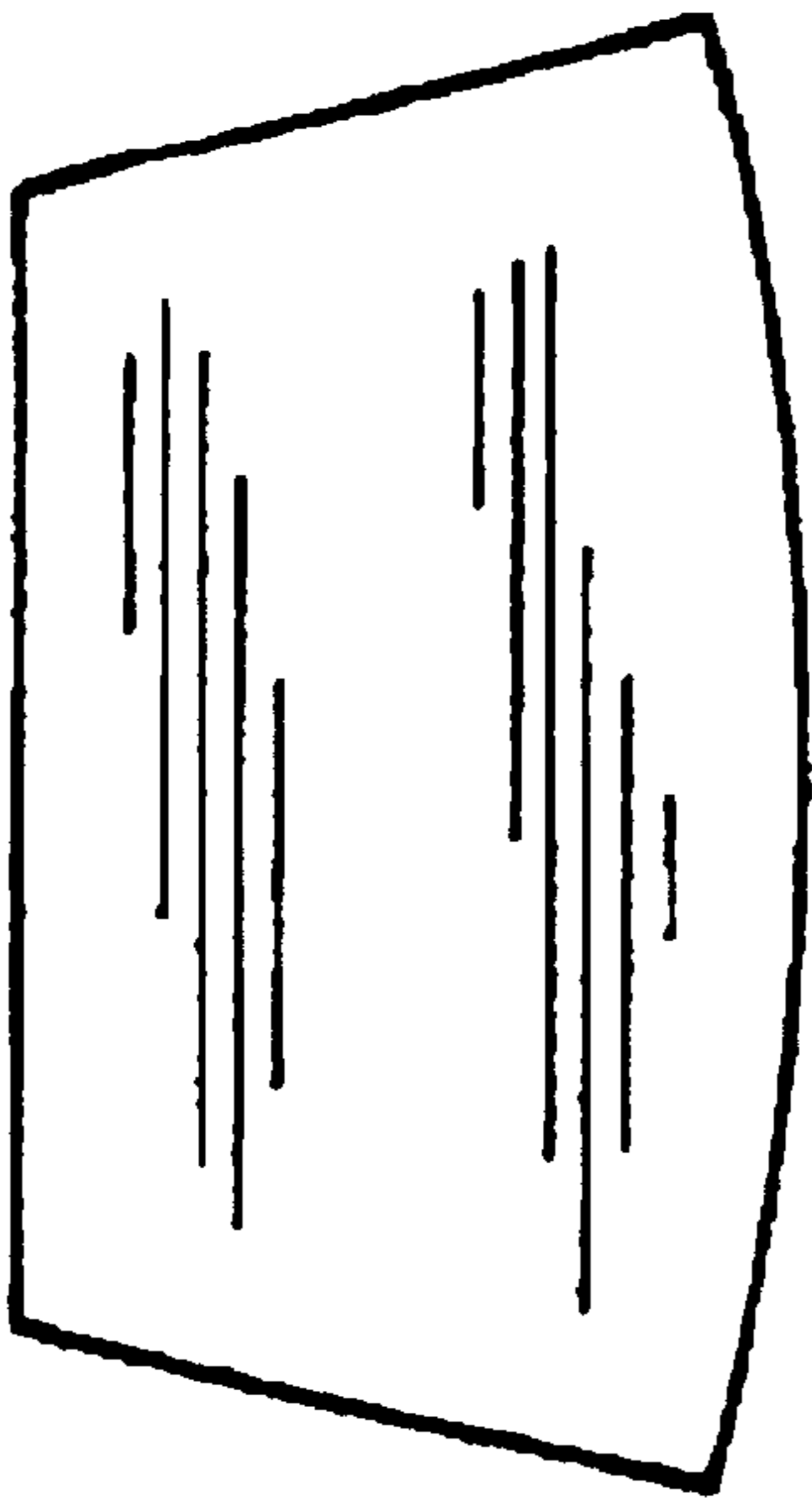
