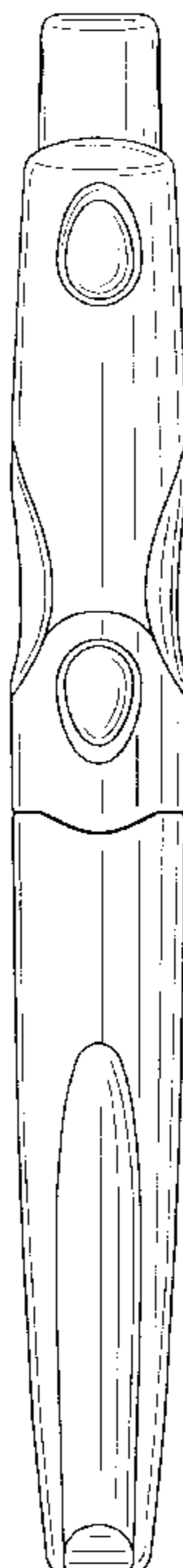
FIG. 4 is the rear view of the first embodiment of our new design;

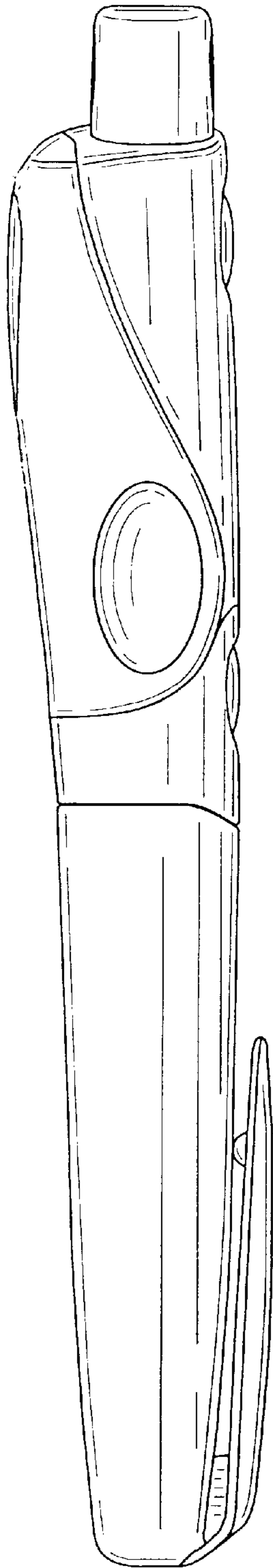
FIG. 5 is a perspective view of the first embodiment of our new design;

FIG. 6 is a top view of the first embodiment of our new design; and,

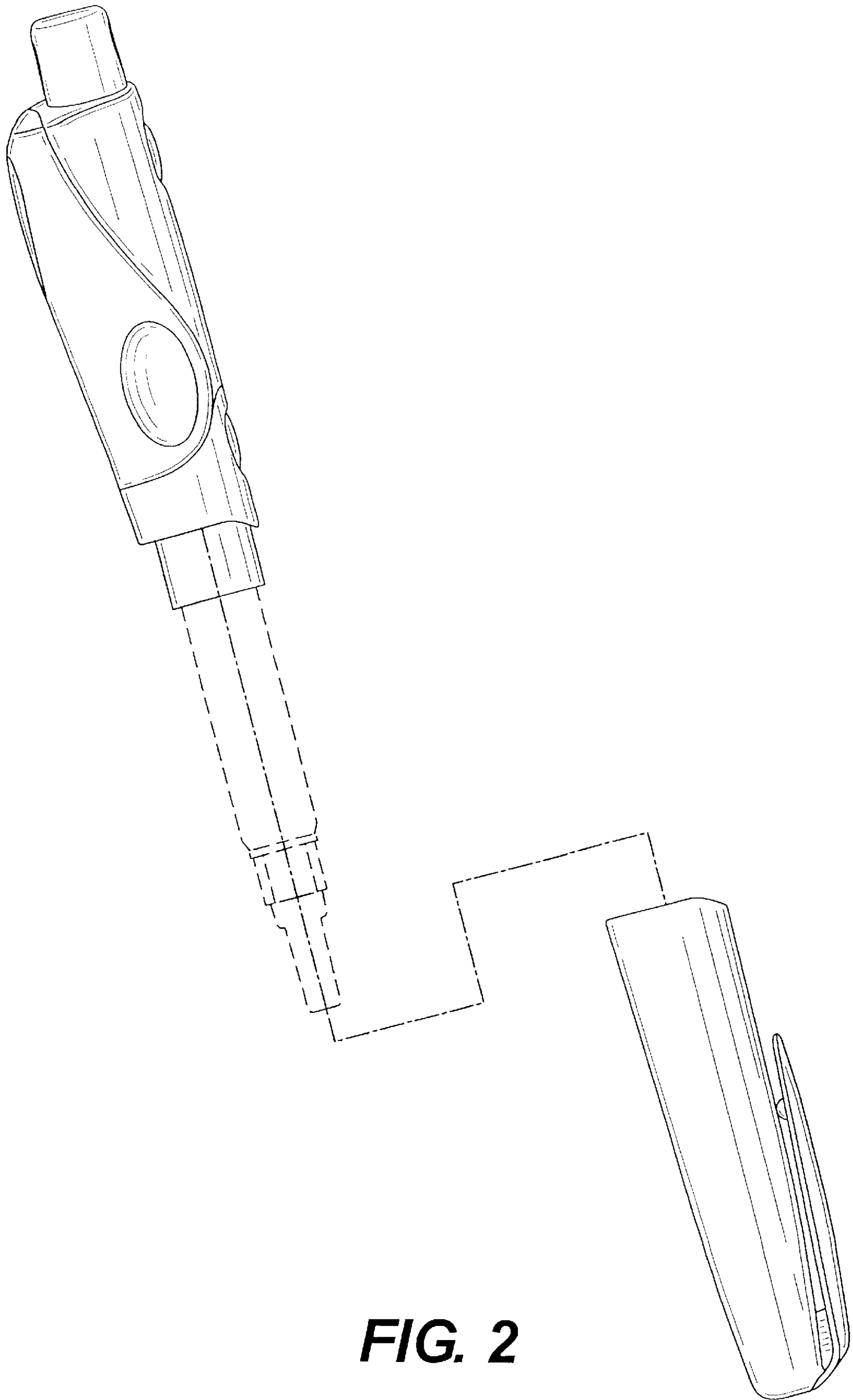
FIG. 7 is a bottom view of the first embodiment of our new design.

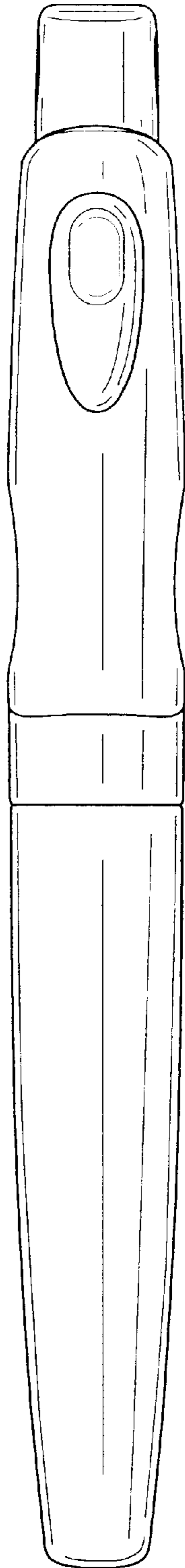




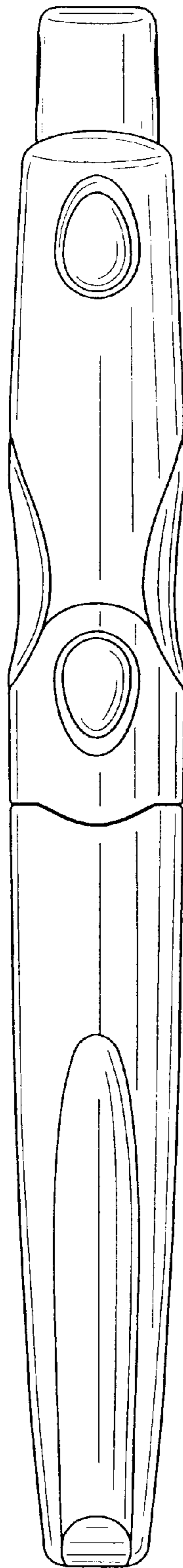

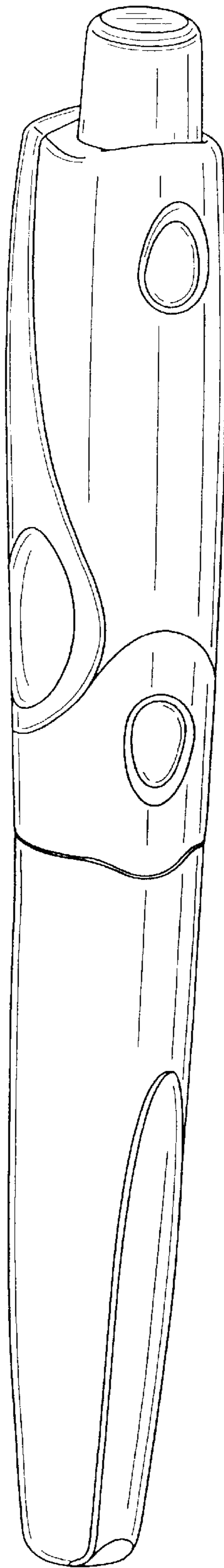

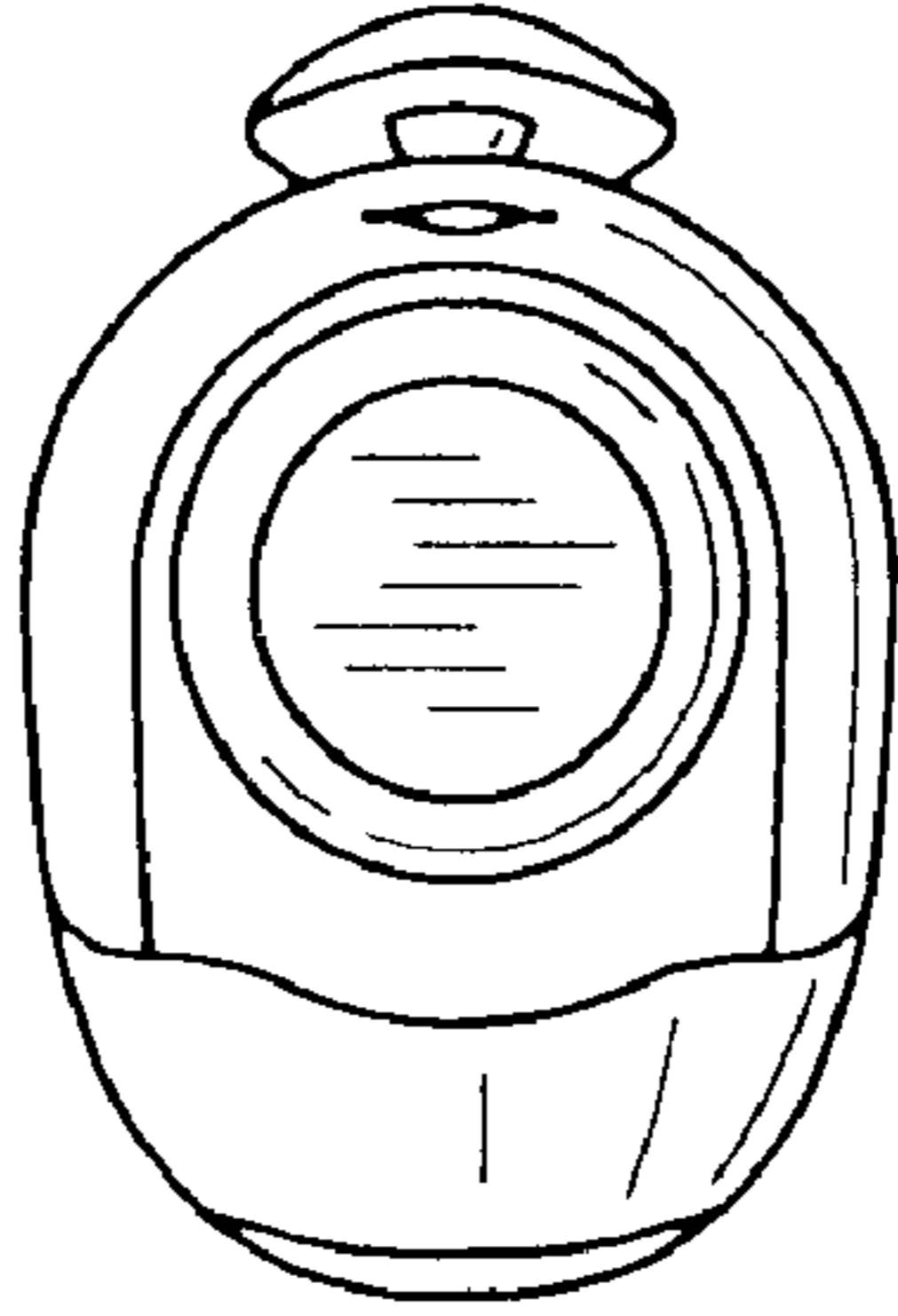

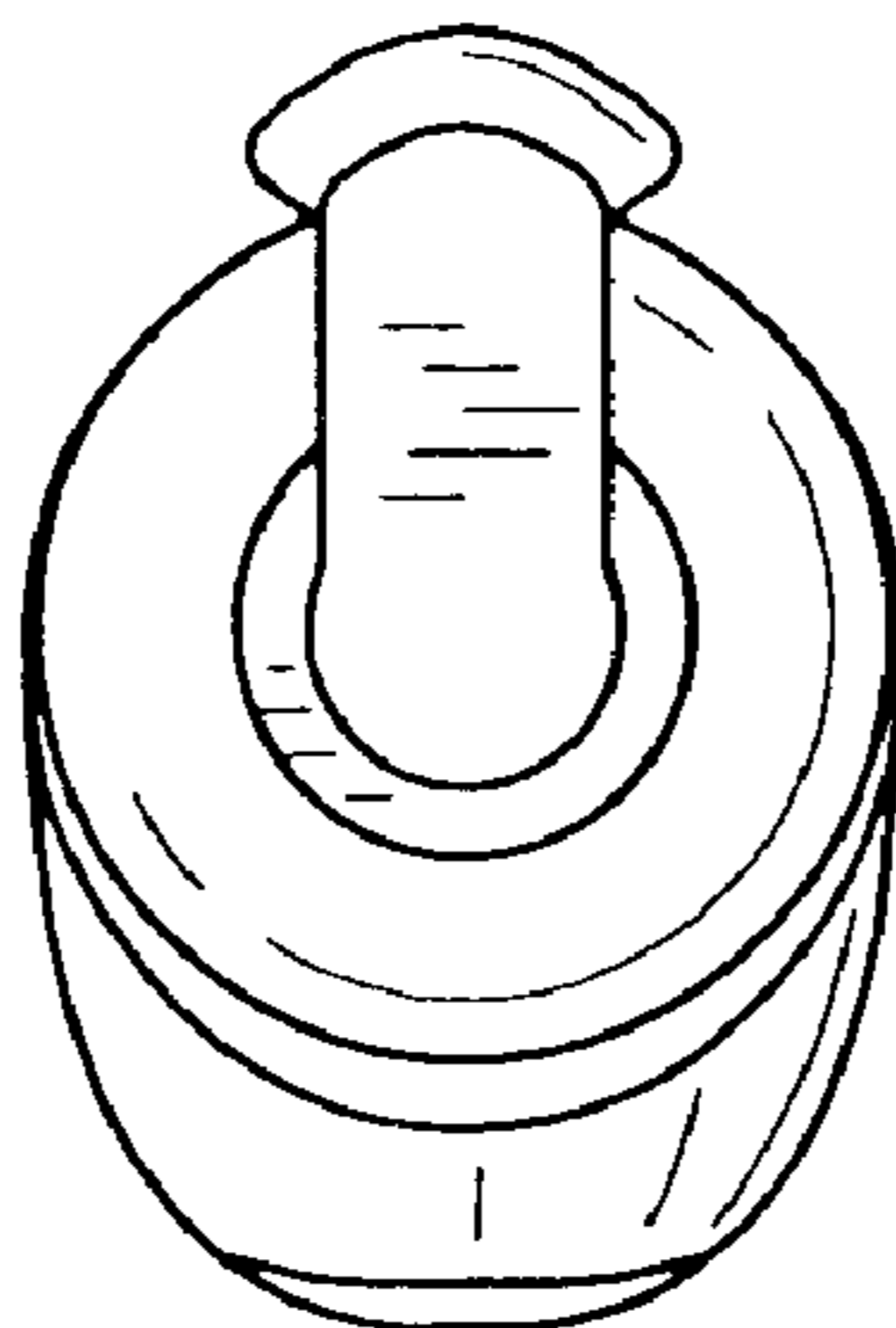
