(57) **CLAIM**

The ornamental design for a bib with pocket and adhesive tape, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a bib with pocket and adhesive tape showing my new design.

FIG. 2 is a bottom view of the bib with pocket and adhesive tape.

FIG. 3 is a top view of the bib with pocket and adhesive tape.


FIG. 4 is a back view of the bib with pocket and adhesive tape.

FIG. 5 is a left side view of the bib with pocket and adhesive tape.

FIG. 6 is a right side view of the bib with pocket and adhesive tape; and,

The broken lines shown in FIGS. 1 &amp; 4 are understood to represent stitching.





