The ornamental design for a wheeled base assembly for a textile luggage case, as shown and described.

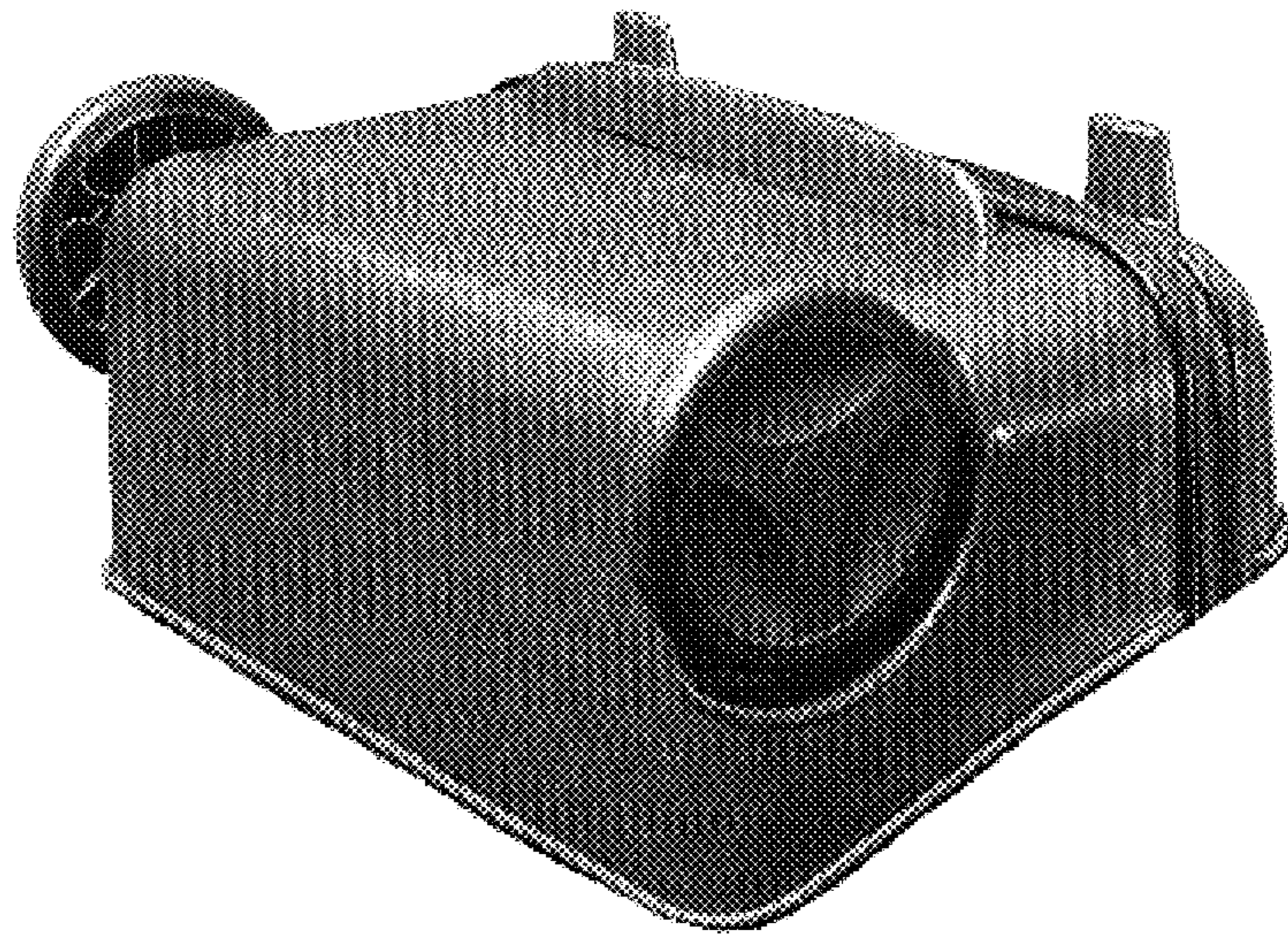

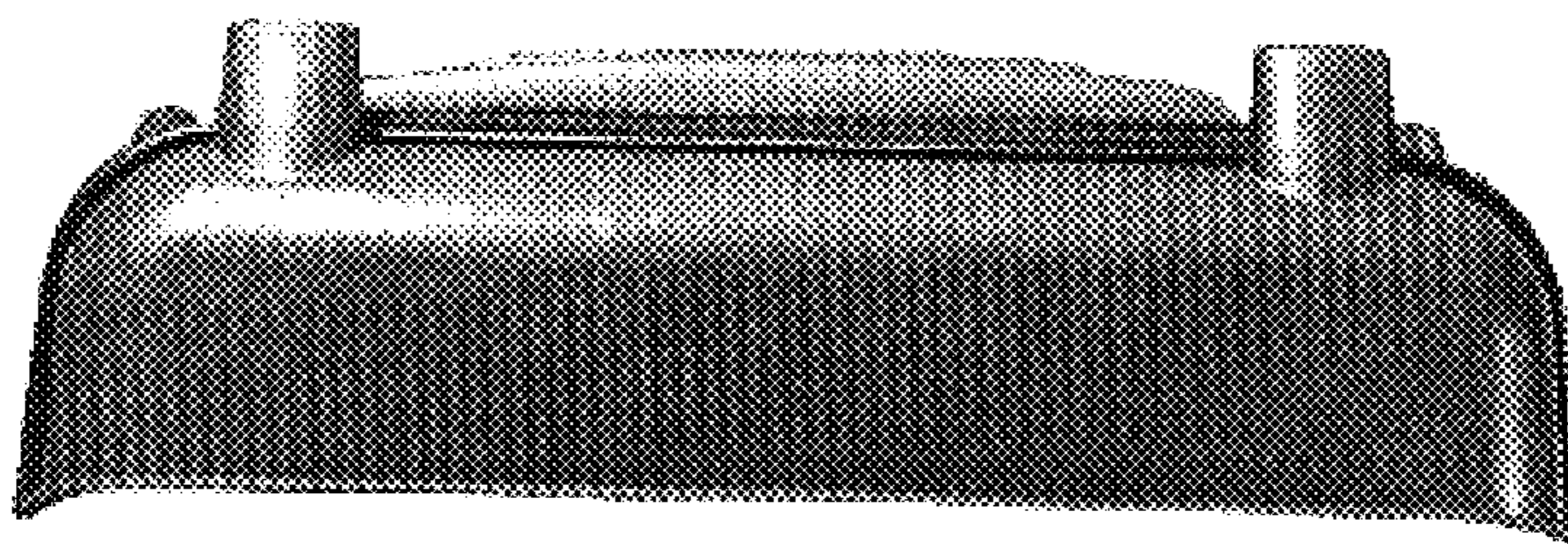

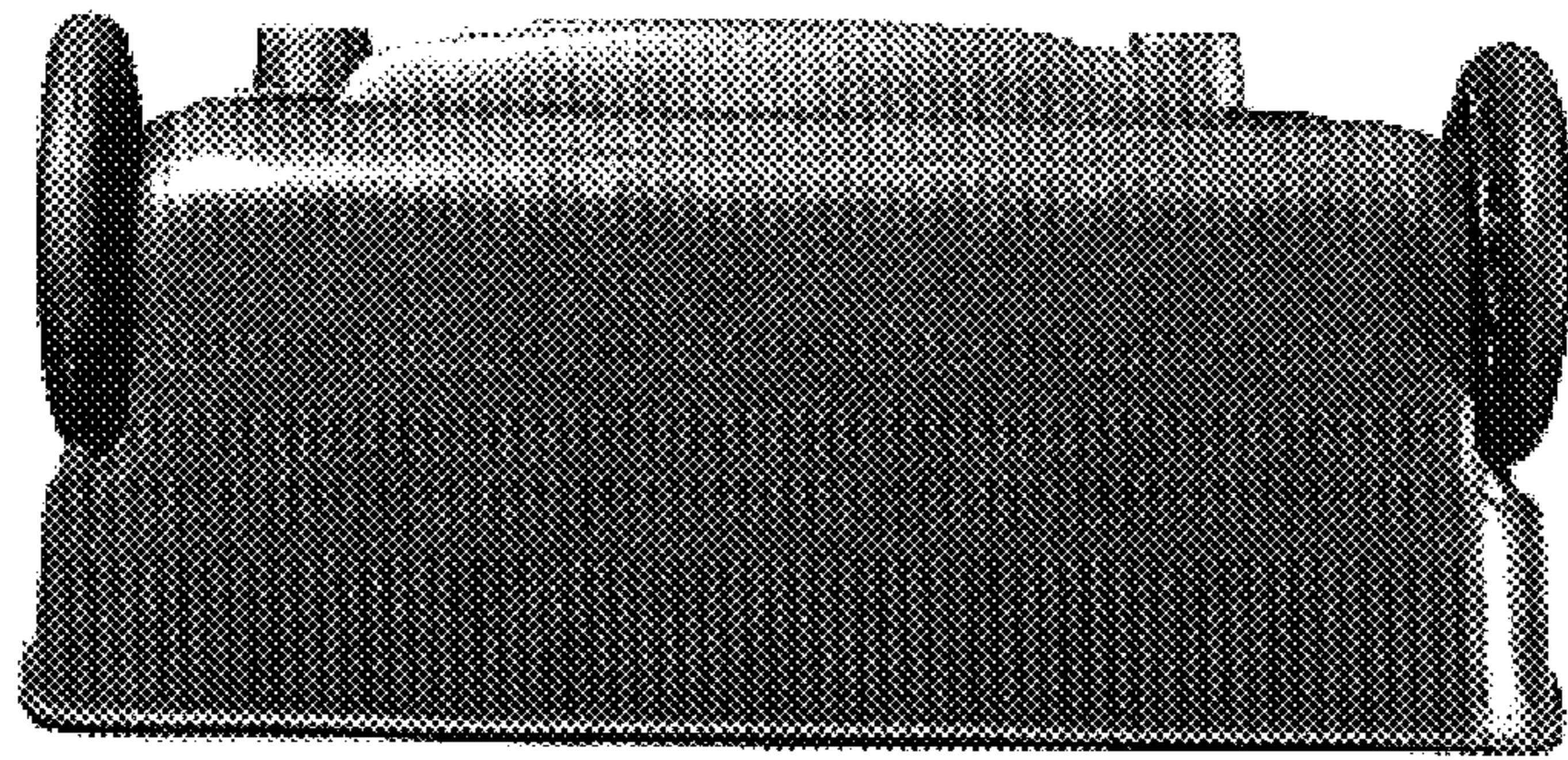

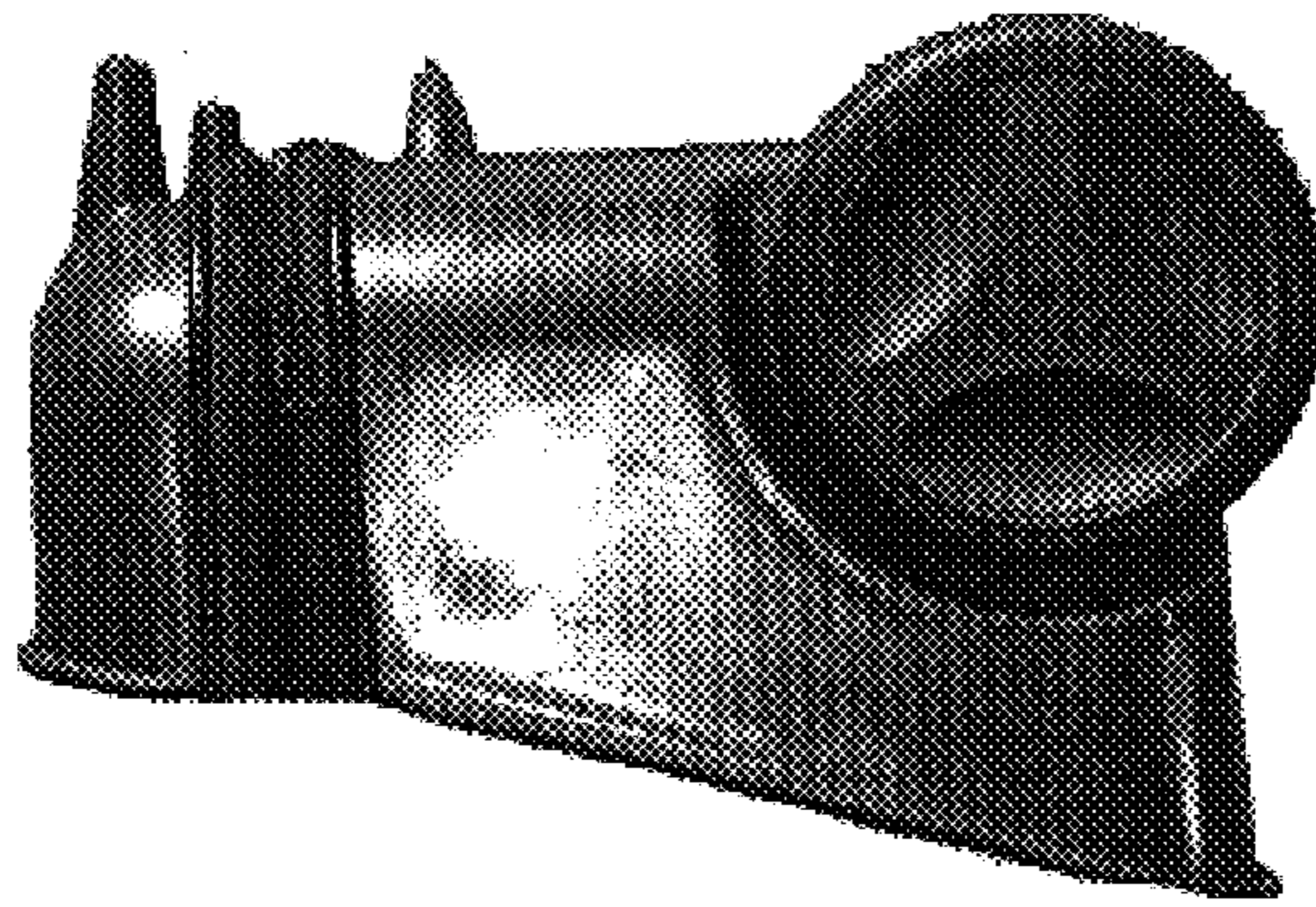

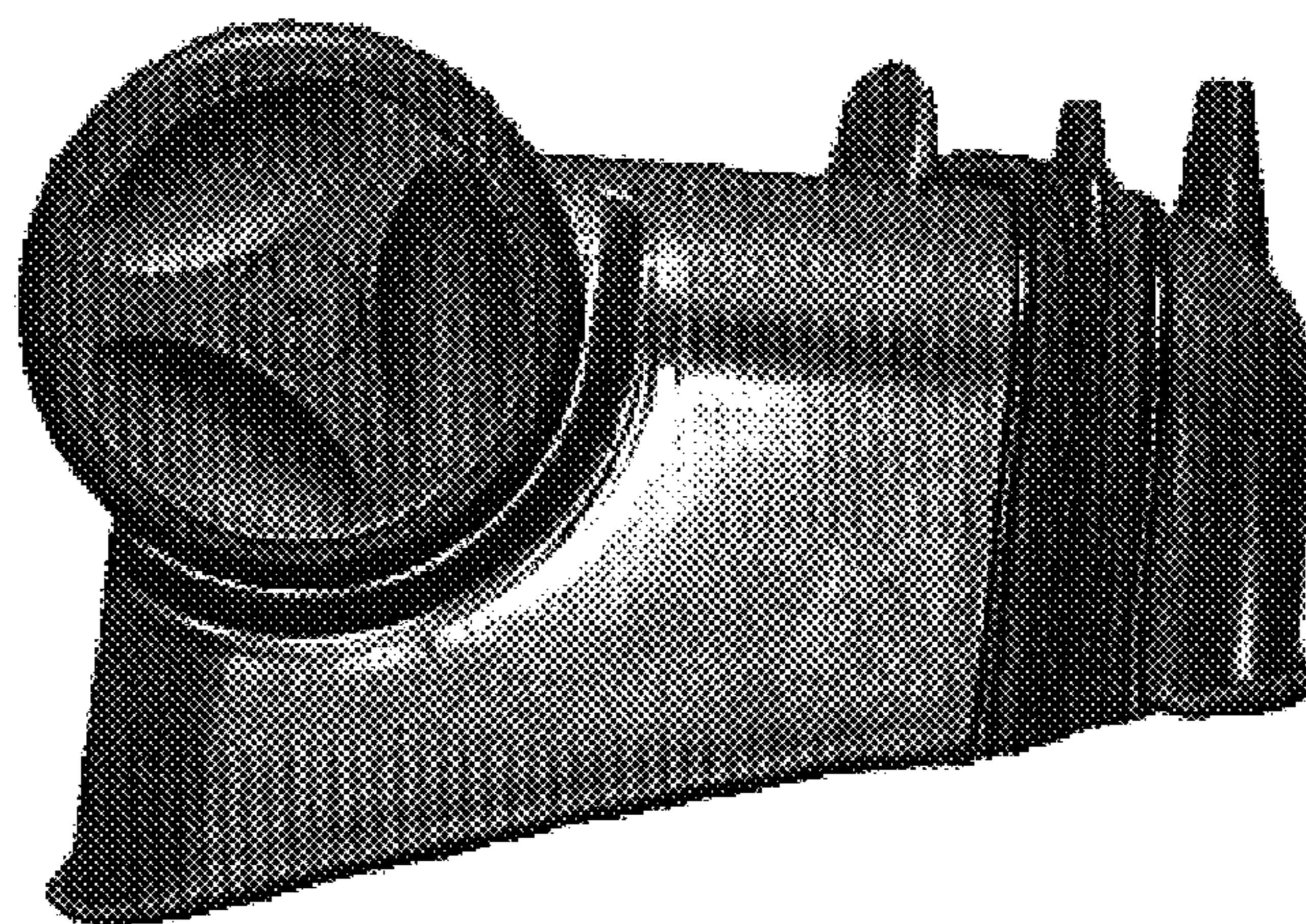
