(57) **CLAIM**

The ornamental design of an outdoor chair, as shown and described.

DESCRIPTION

FIG. 1 illustrates a perspective view of an outdoor chair in accordance with the invention;

FIG. 2 illustrates a front view of the outdoor chair of FIG. 1;

FIG. 3 illustrates a back view of the outdoor chair of FIG. 1;

FIG. 4 illustrates a top view of the outdoor chair of FIG. 1;

FIG. 5 illustrates a bottom view of the outdoor chair of FIG. 1;

FIG. 6 illustrates a left side view of the outdoor chair of FIG. 1, the right side view of which is a mirror image;

FIG. 7 illustrates a perspective front view of a second embodiment of an outdoor chair with a seat cushion in accordance with the invention;

FIG. 8 illustrates a front view of the outdoor chair of FIG. 7;

FIG. 9 illustrates a back view of the outdoor chair of FIG. 7;

FIG. 10 illustrates a top view of the outdoor chair of FIG. 7;

FIG. 11 illustrates a bottom view of the outdoor chair of FIG. 7; and,

FIG. 12 illustrates a left side view of the outdoor chair of FIG. 7, the right side view of which is a mirror image.

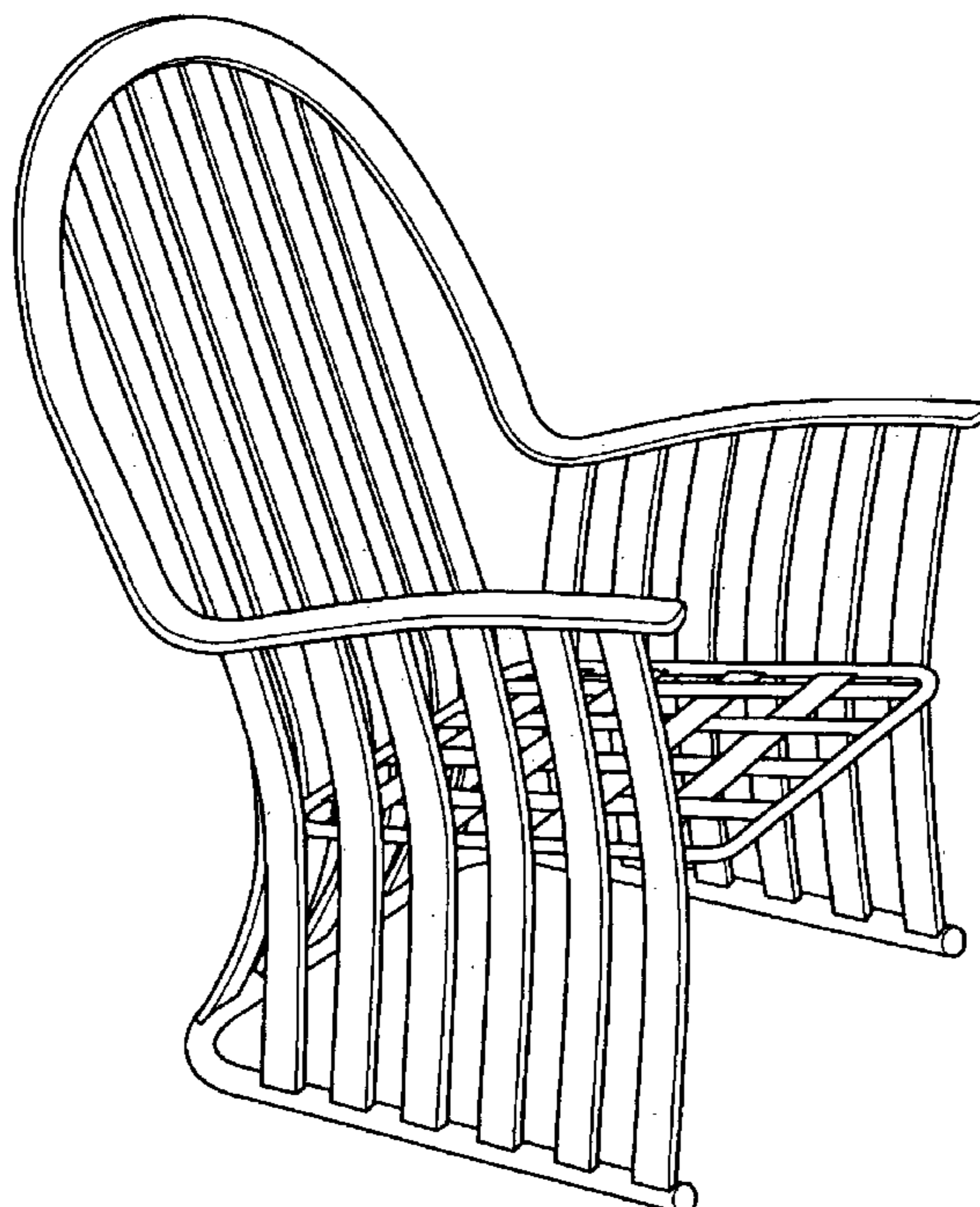

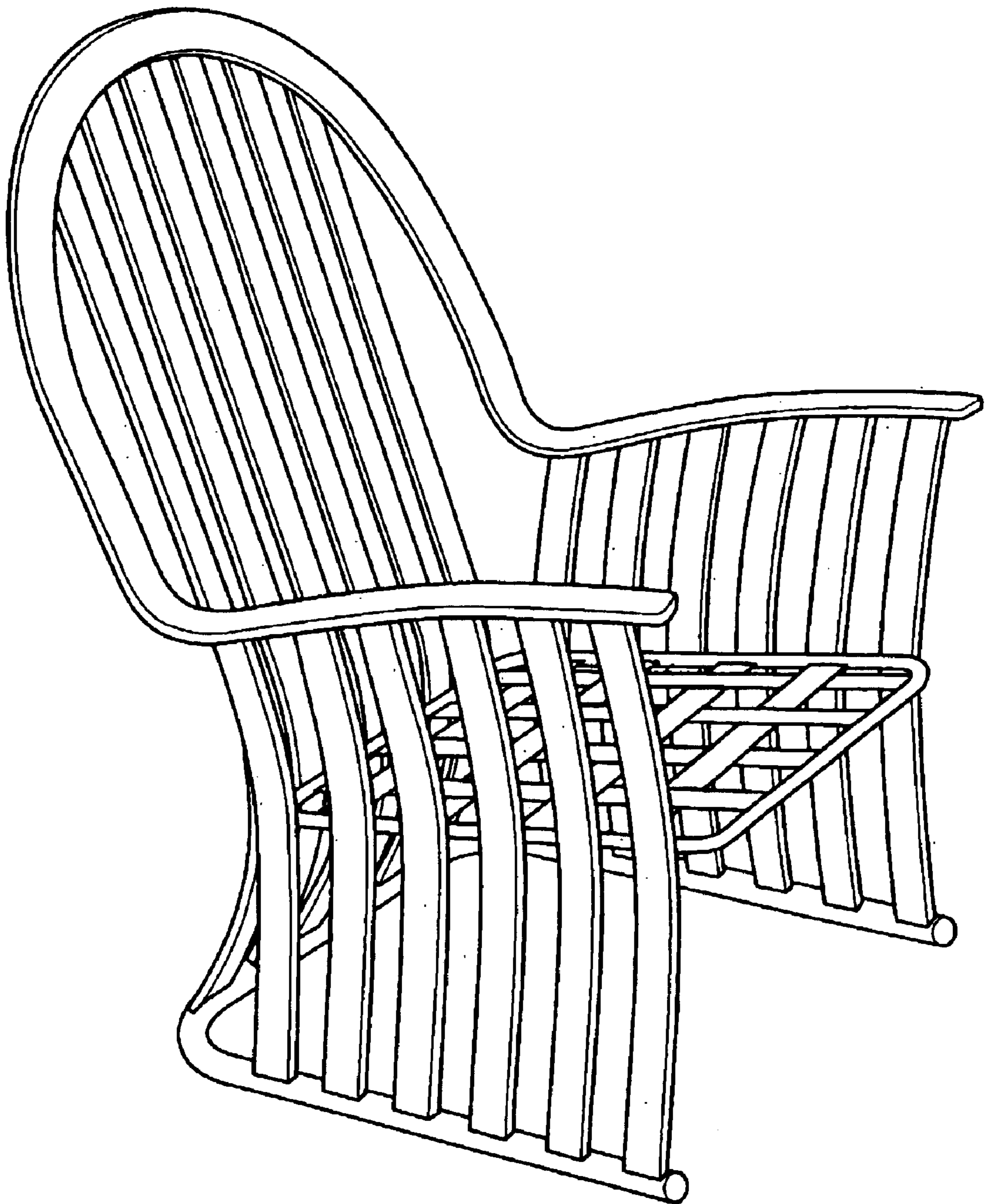

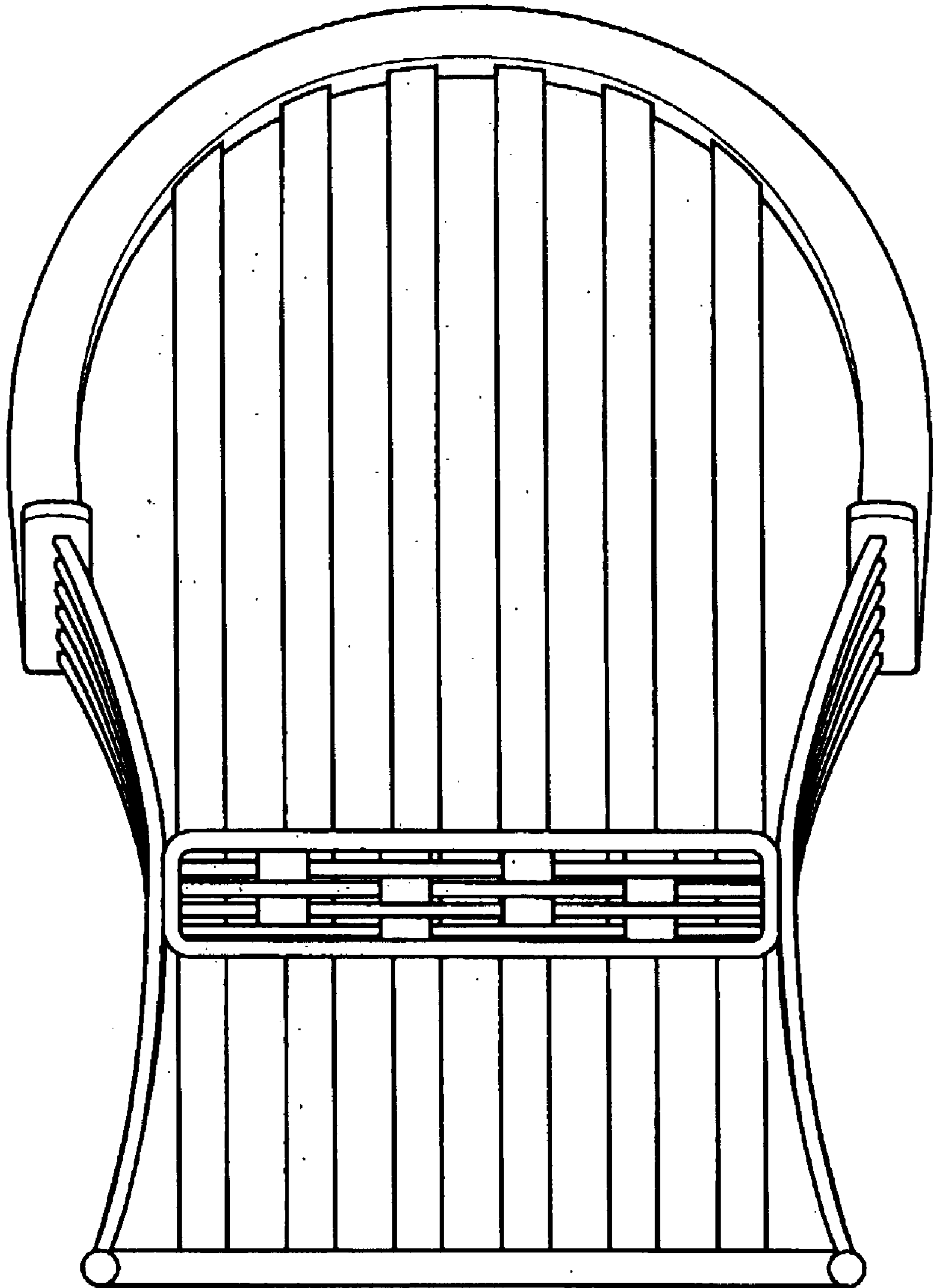

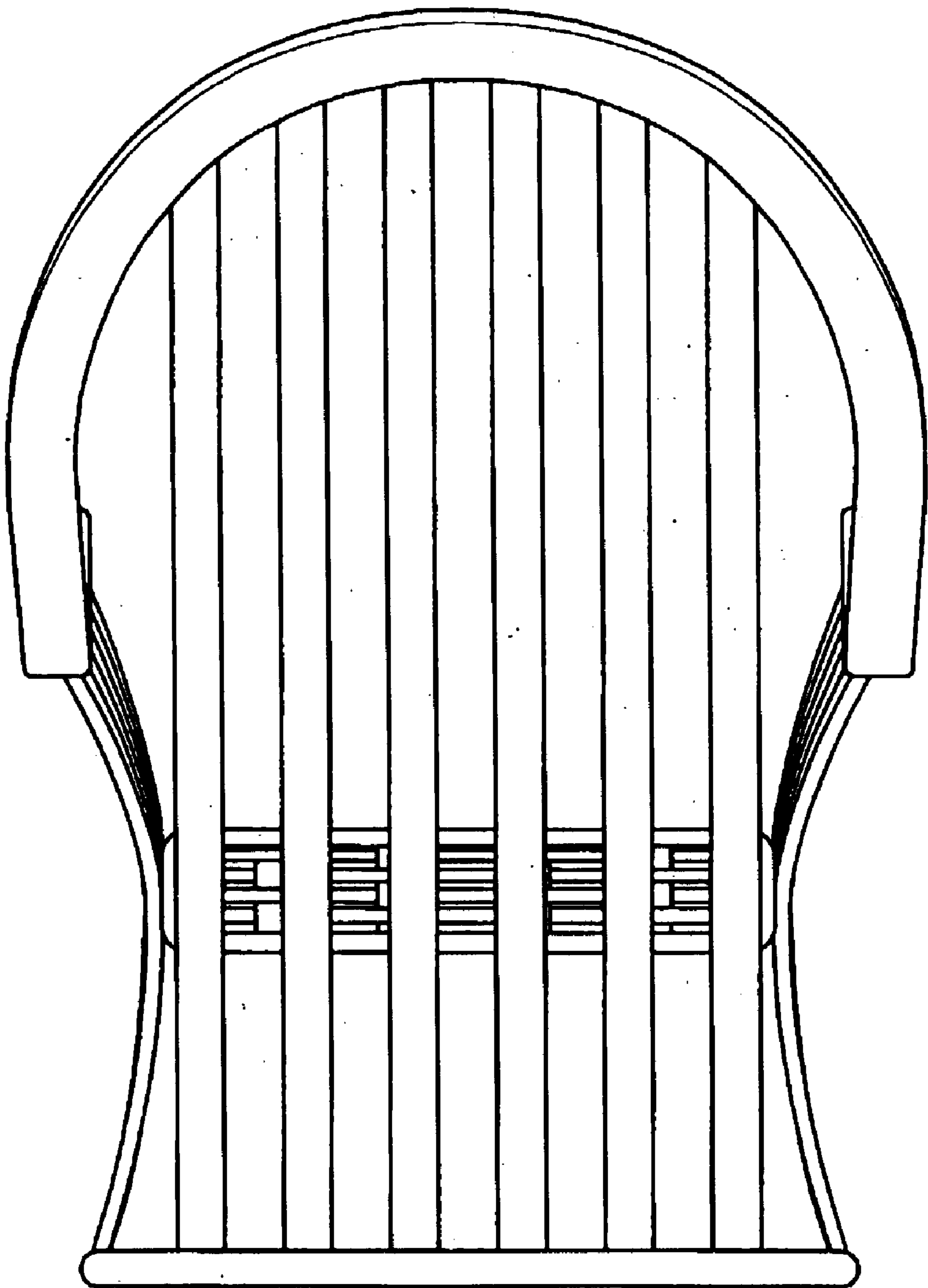

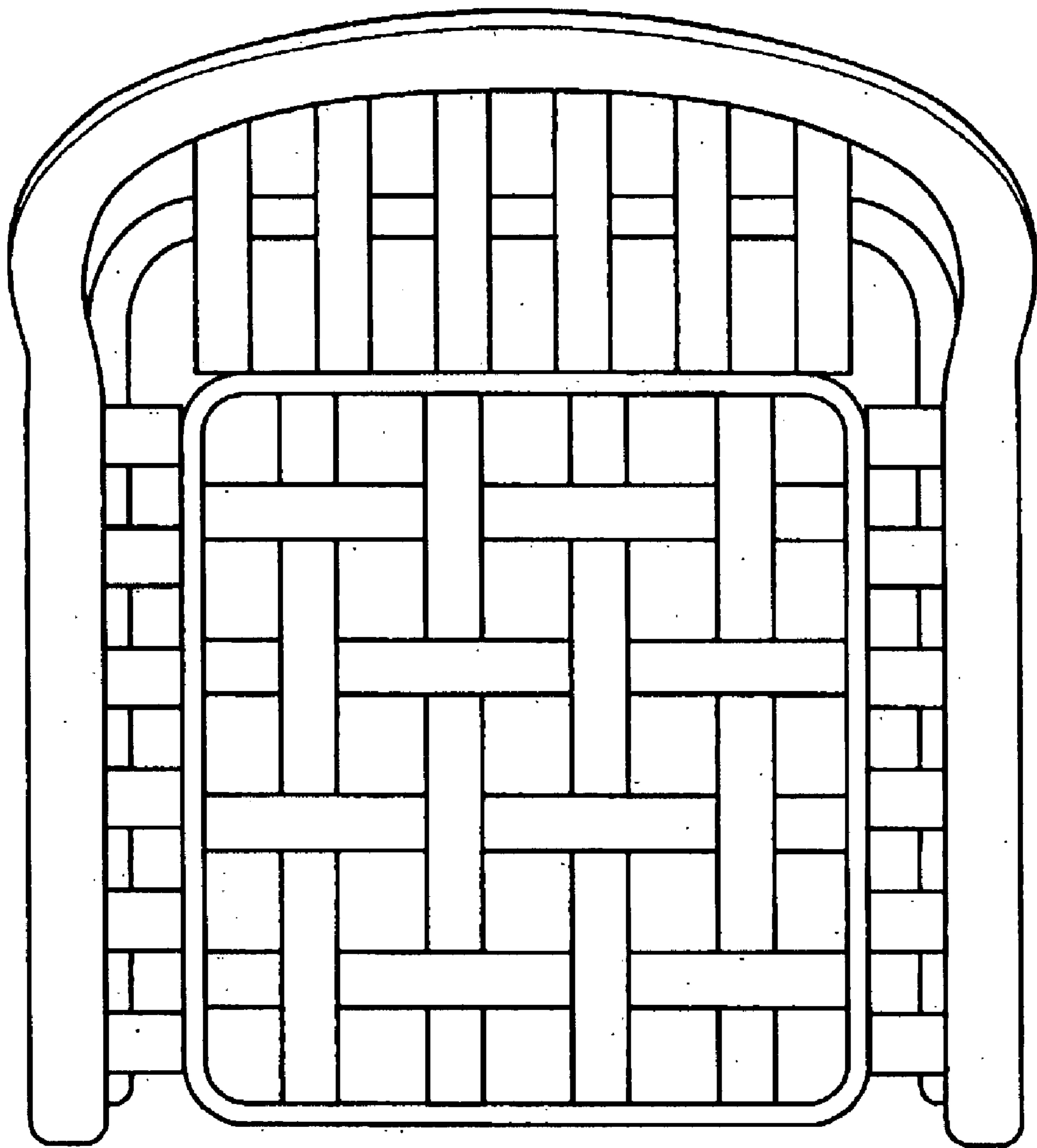

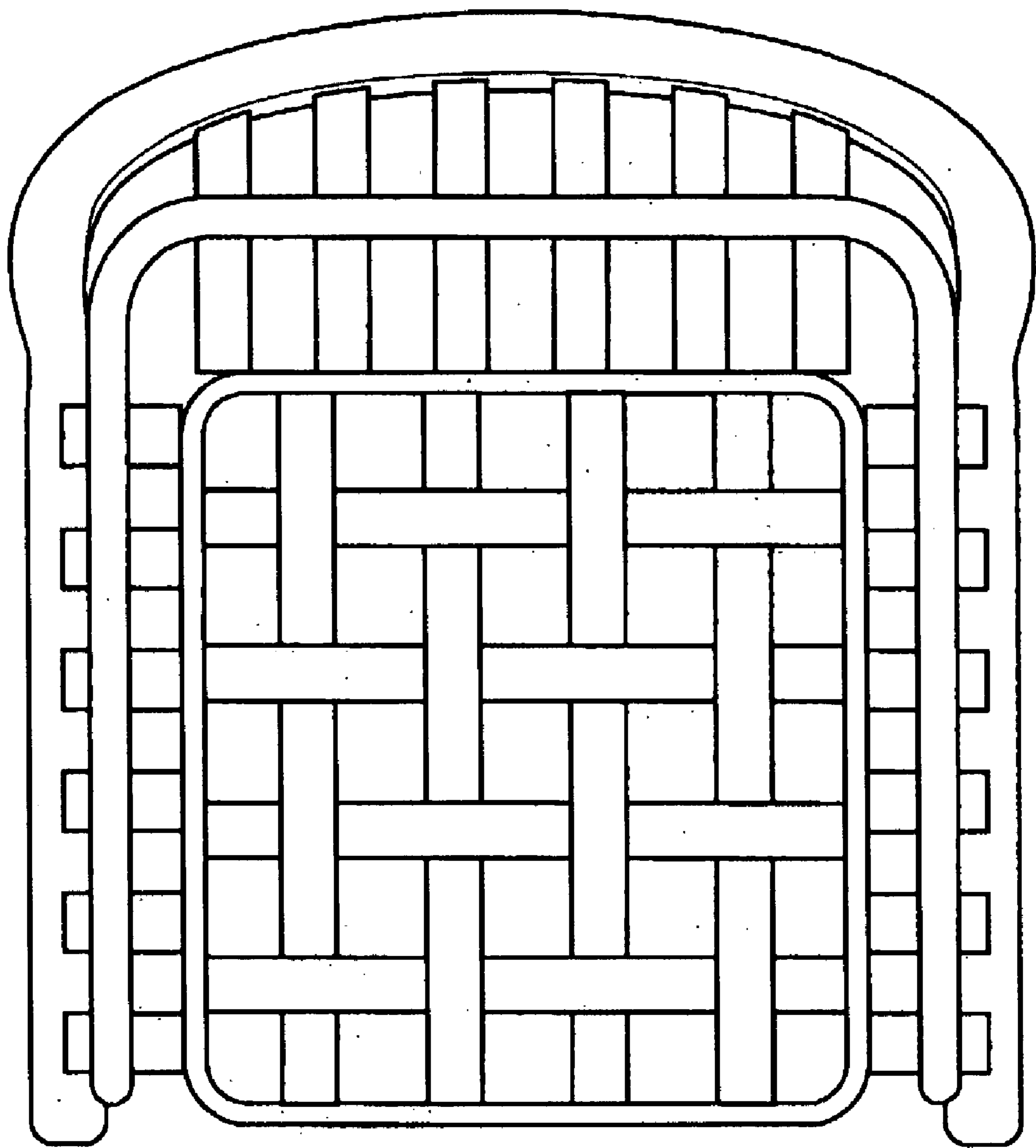

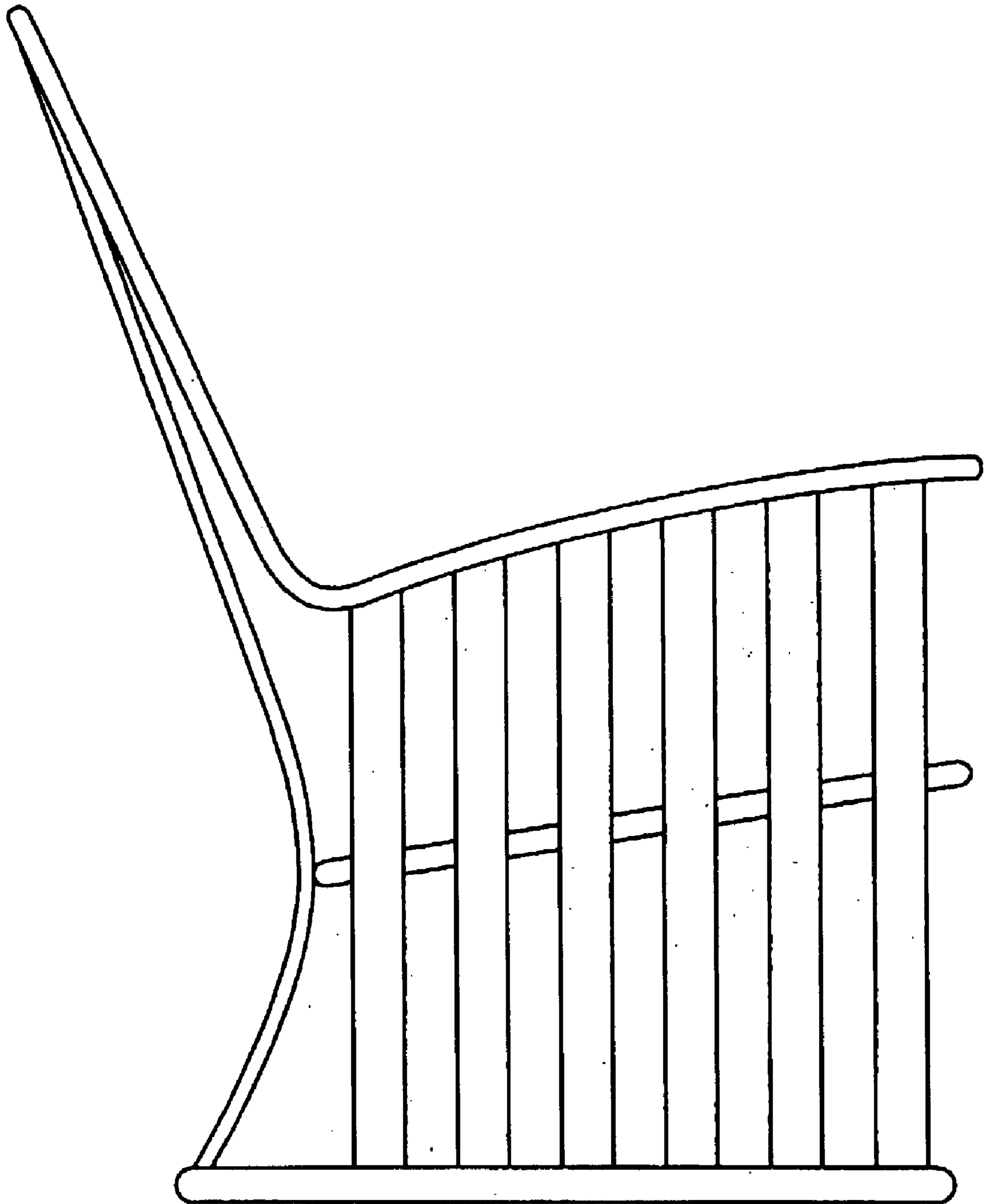

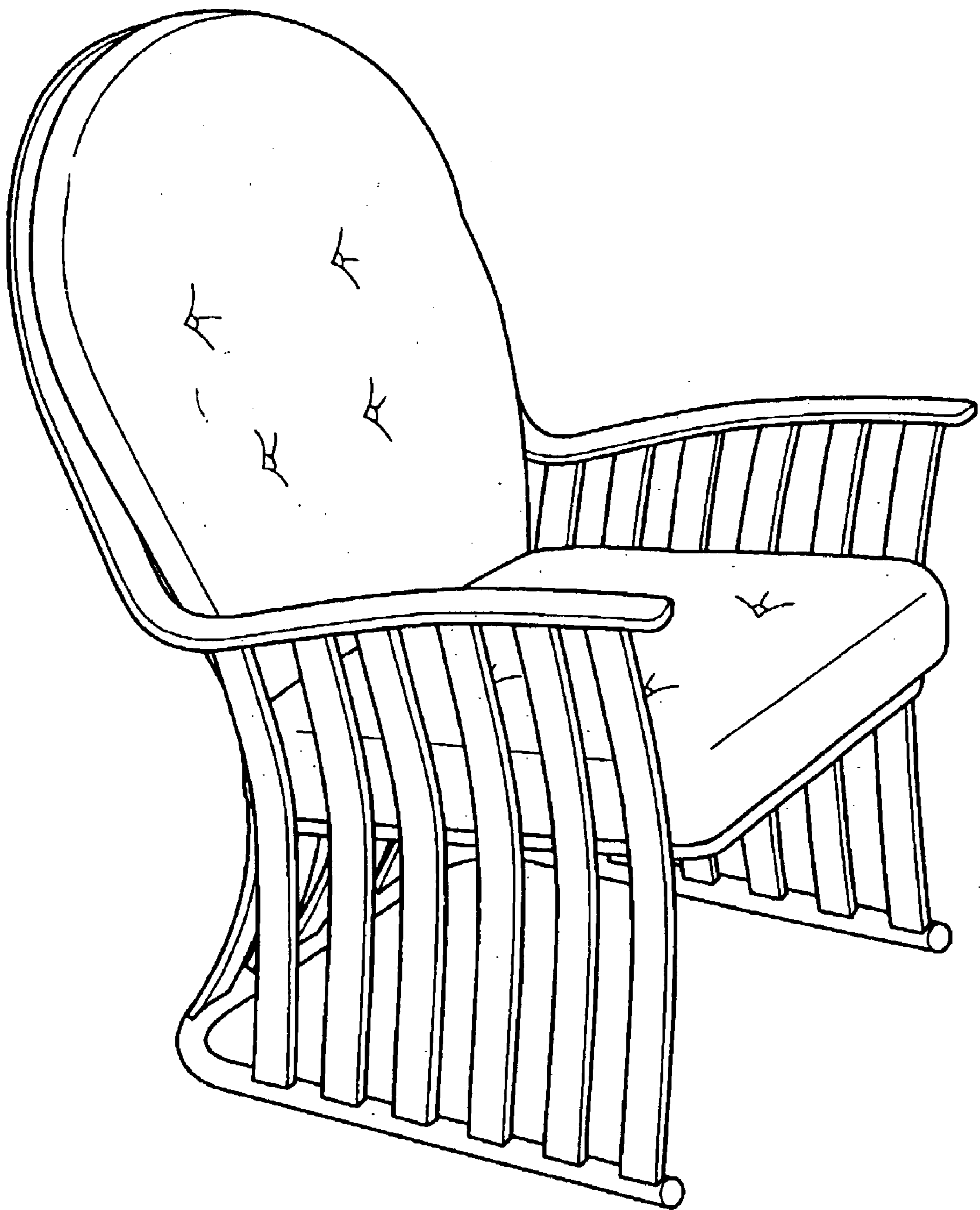

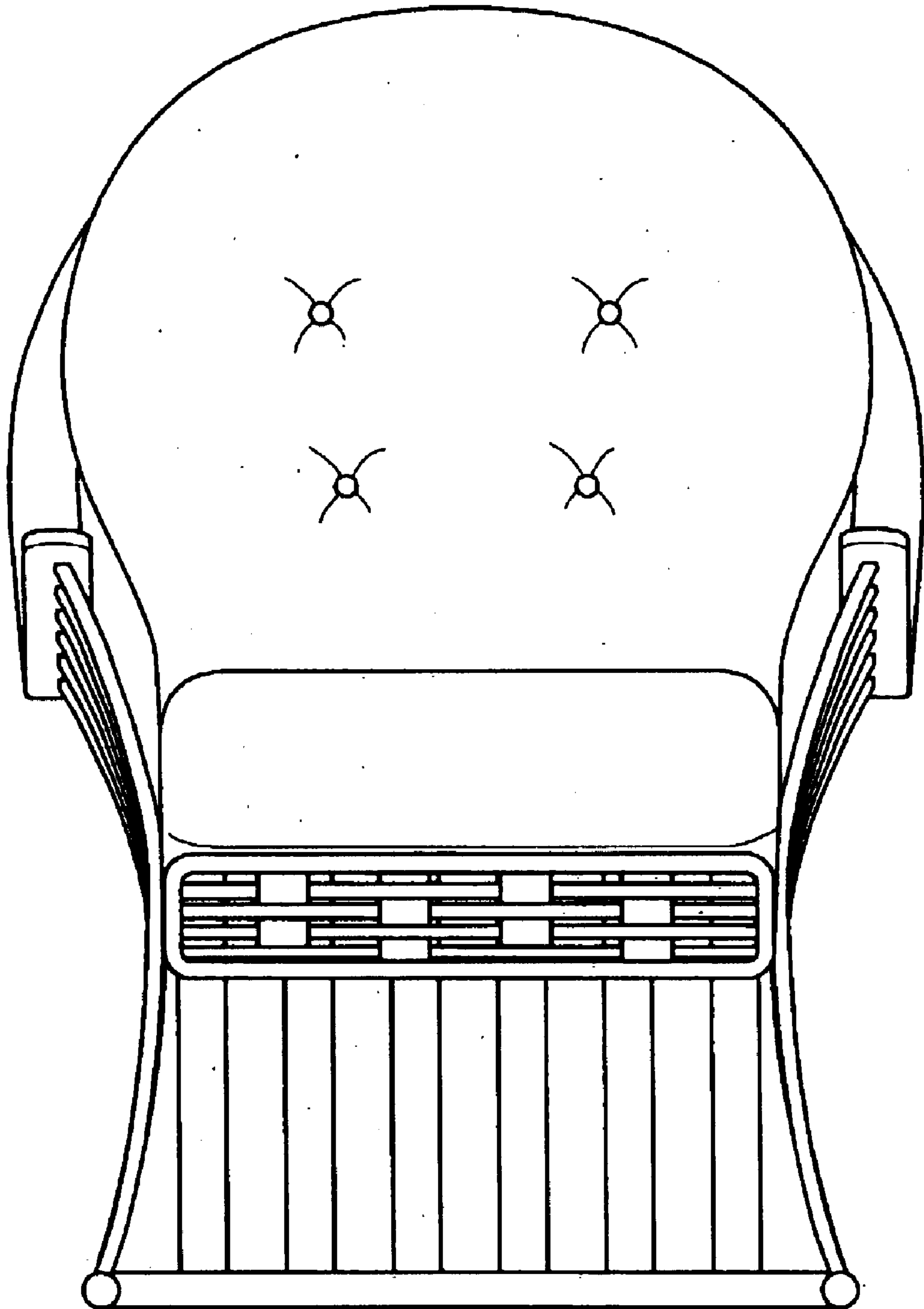

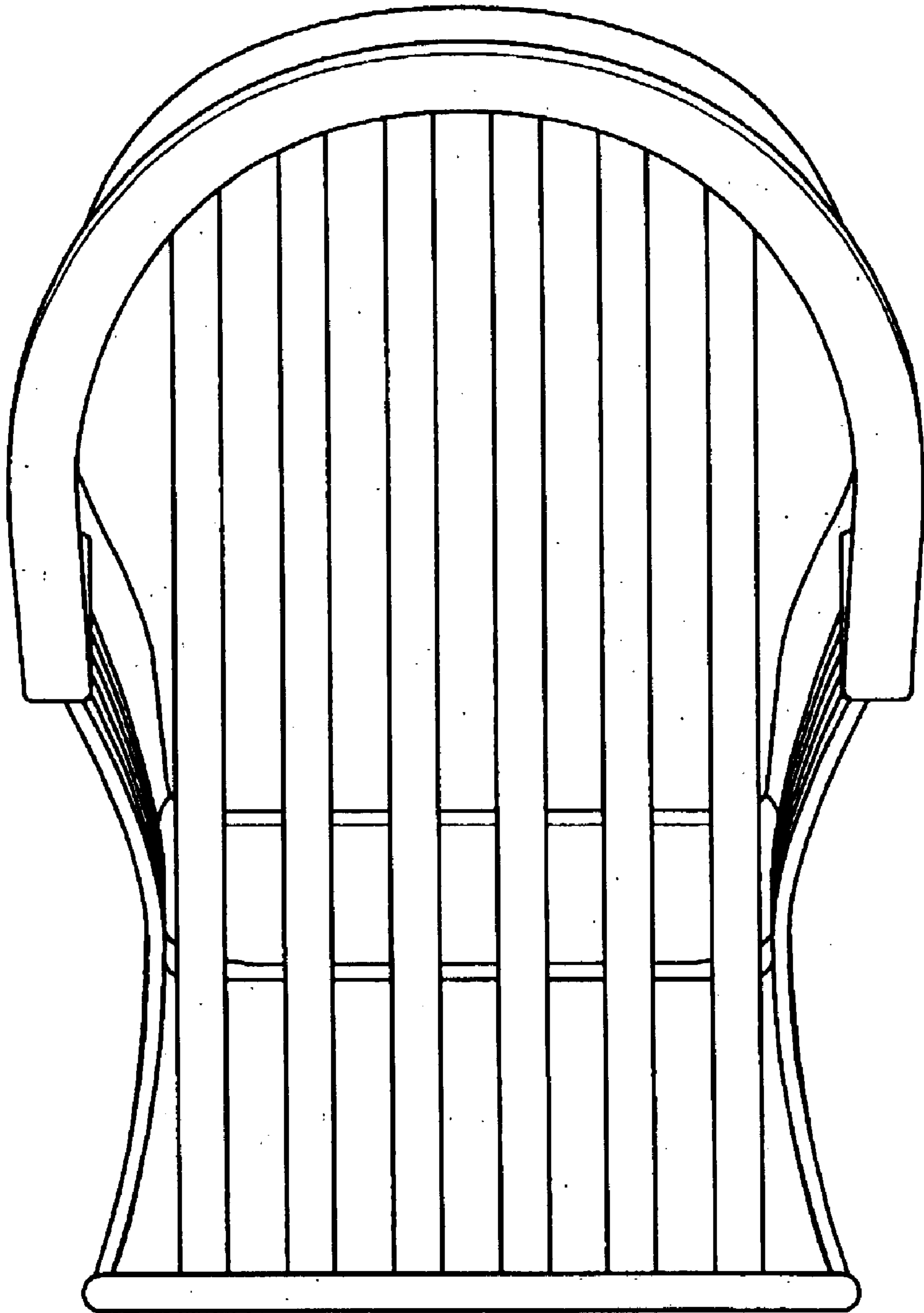

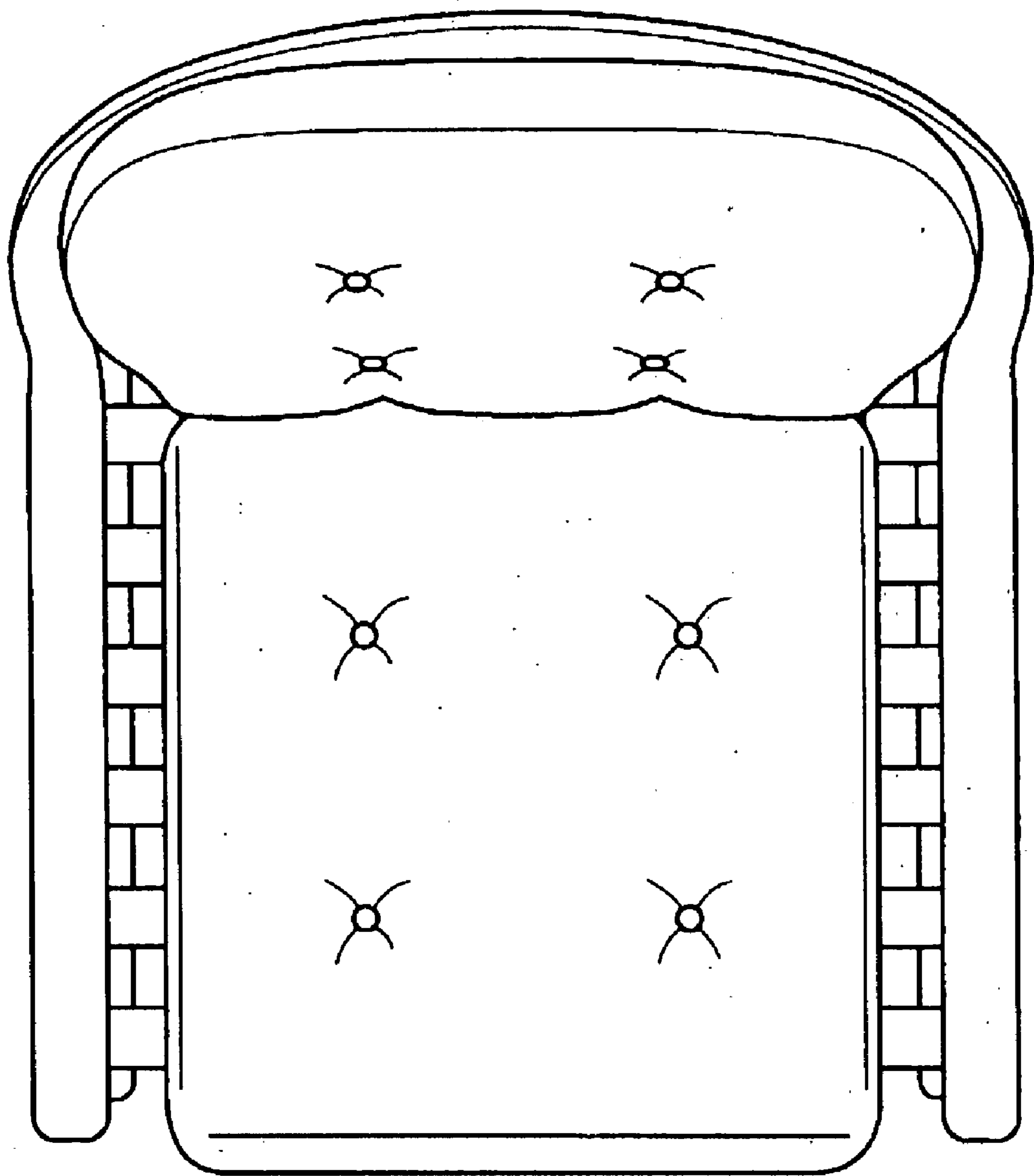

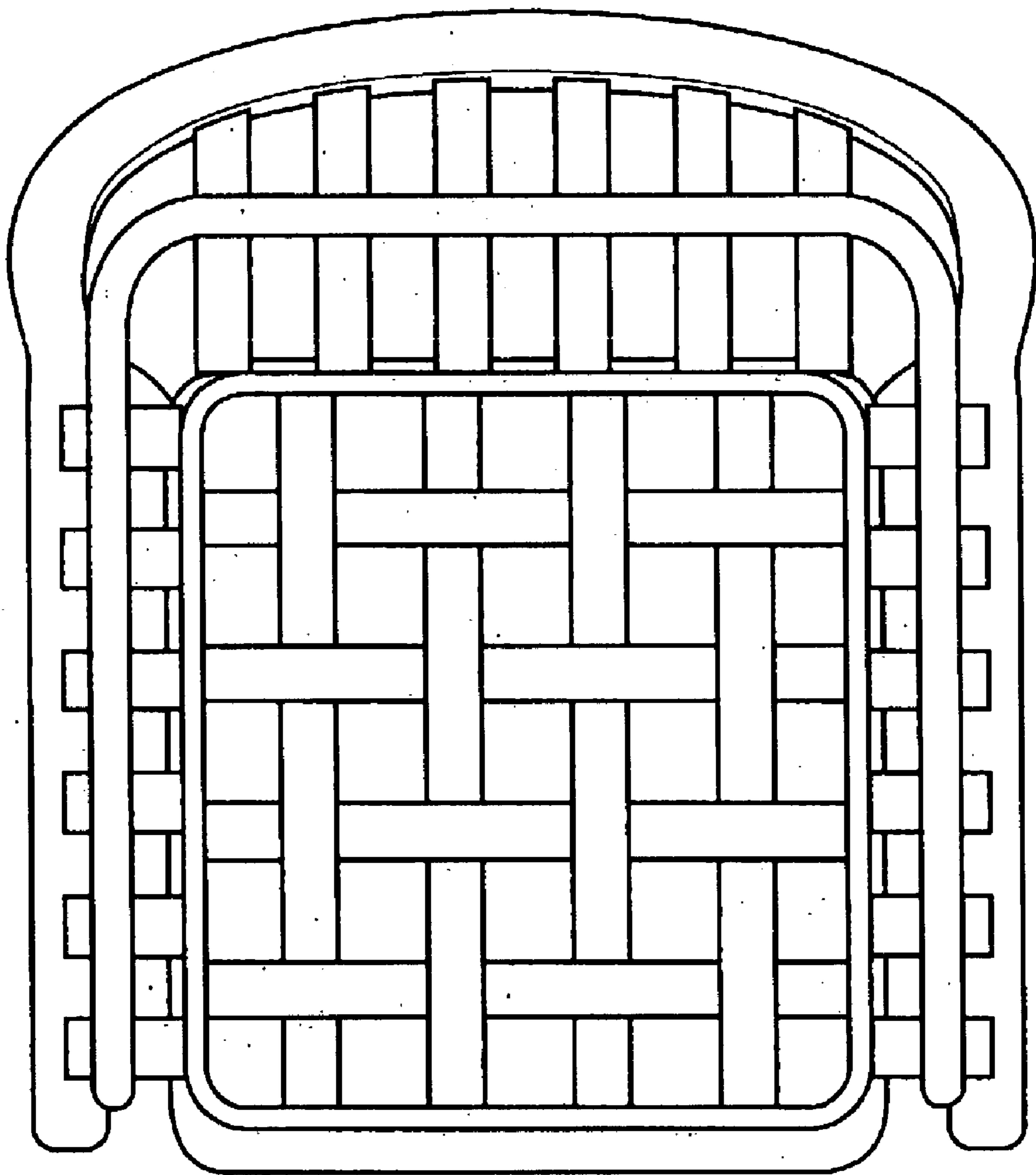
