DESCRIPTION

FIG. 1 is a perspective view of the car seat cover, installed on a bench seat, showing my new design;

FIG. 2 is a top plan view;

FIG. 3 is a front elevation view;

FIG. 4 is a bottom plan view;

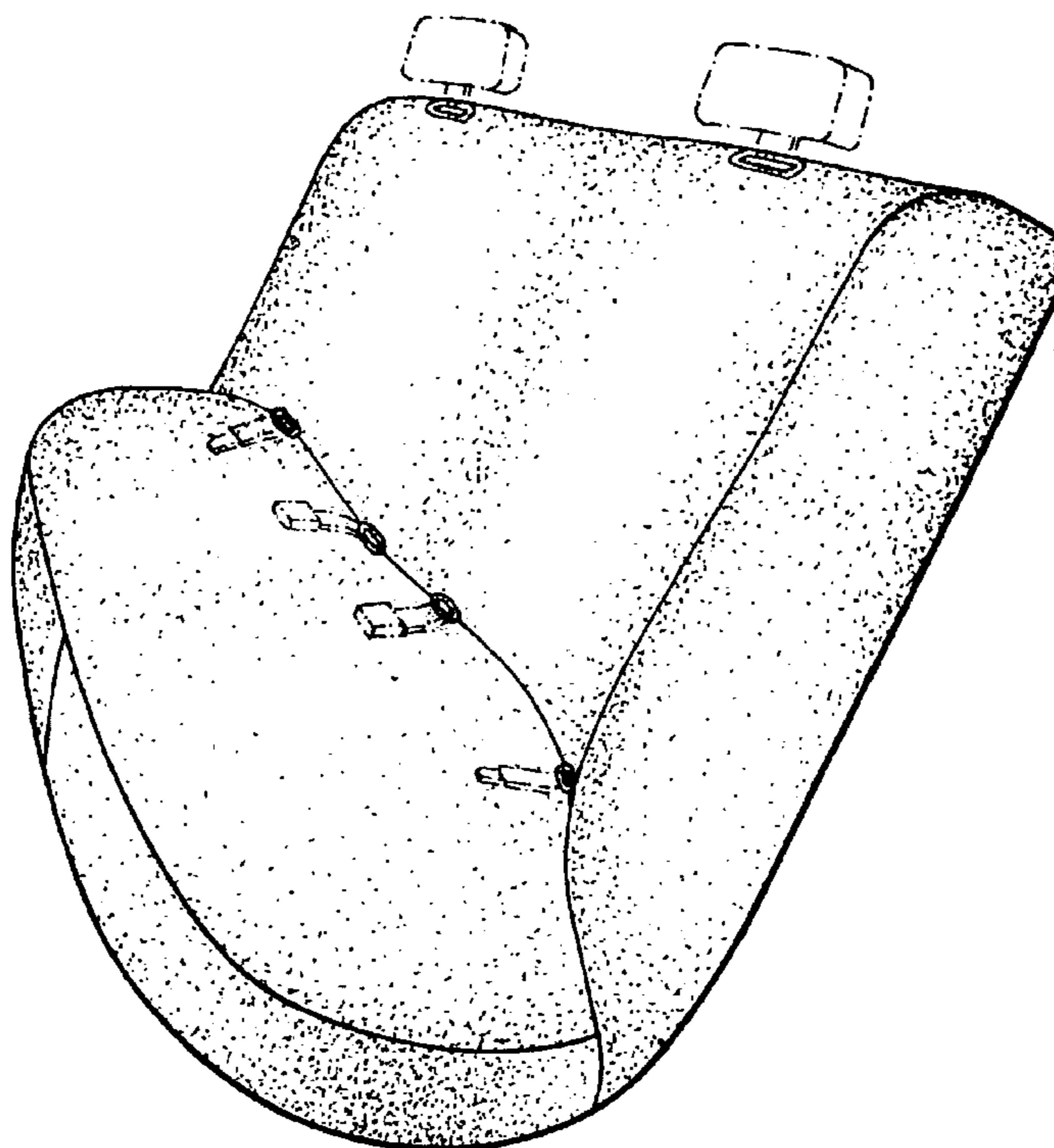
FIG. 5 is a rear elevation view;

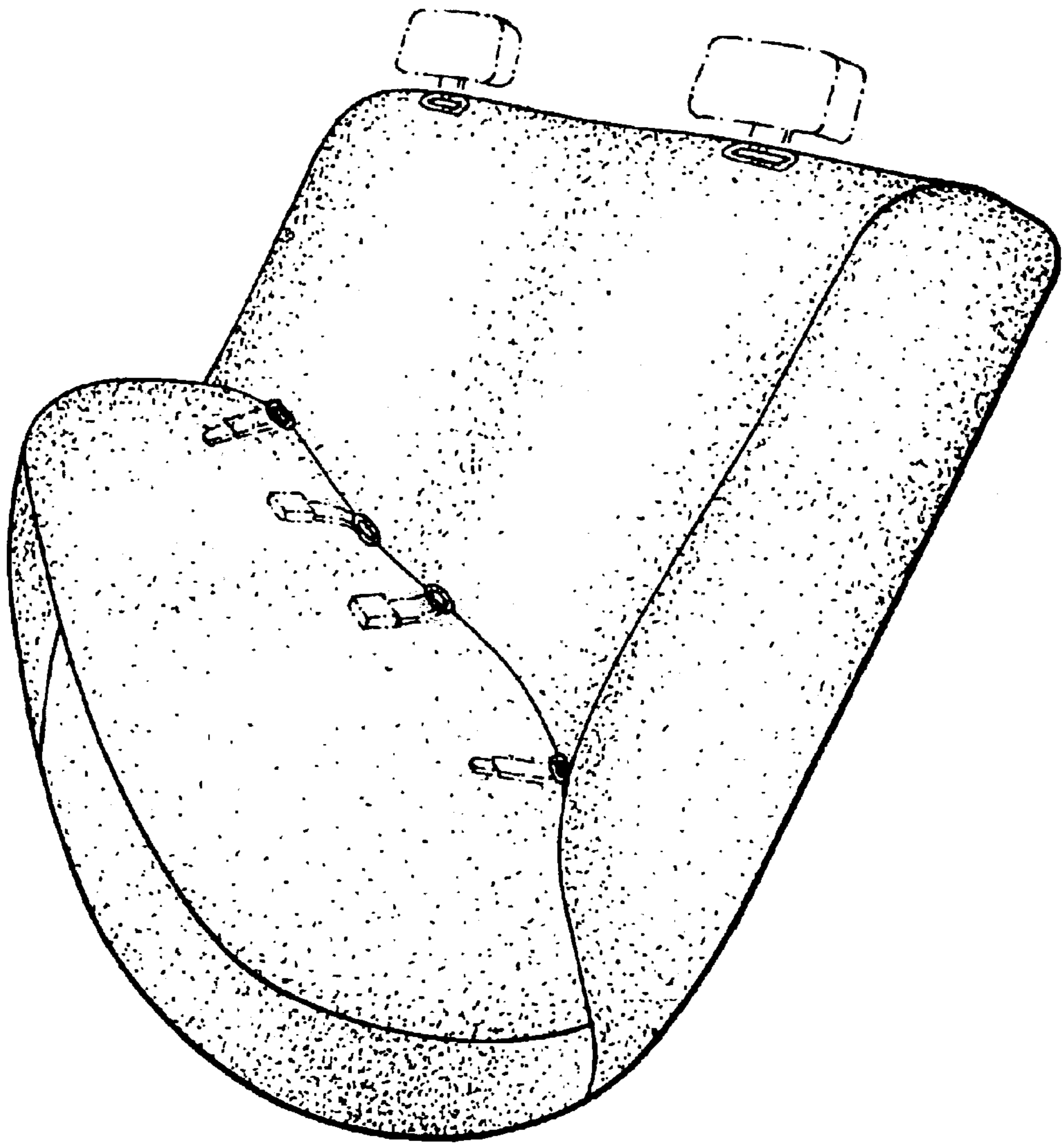

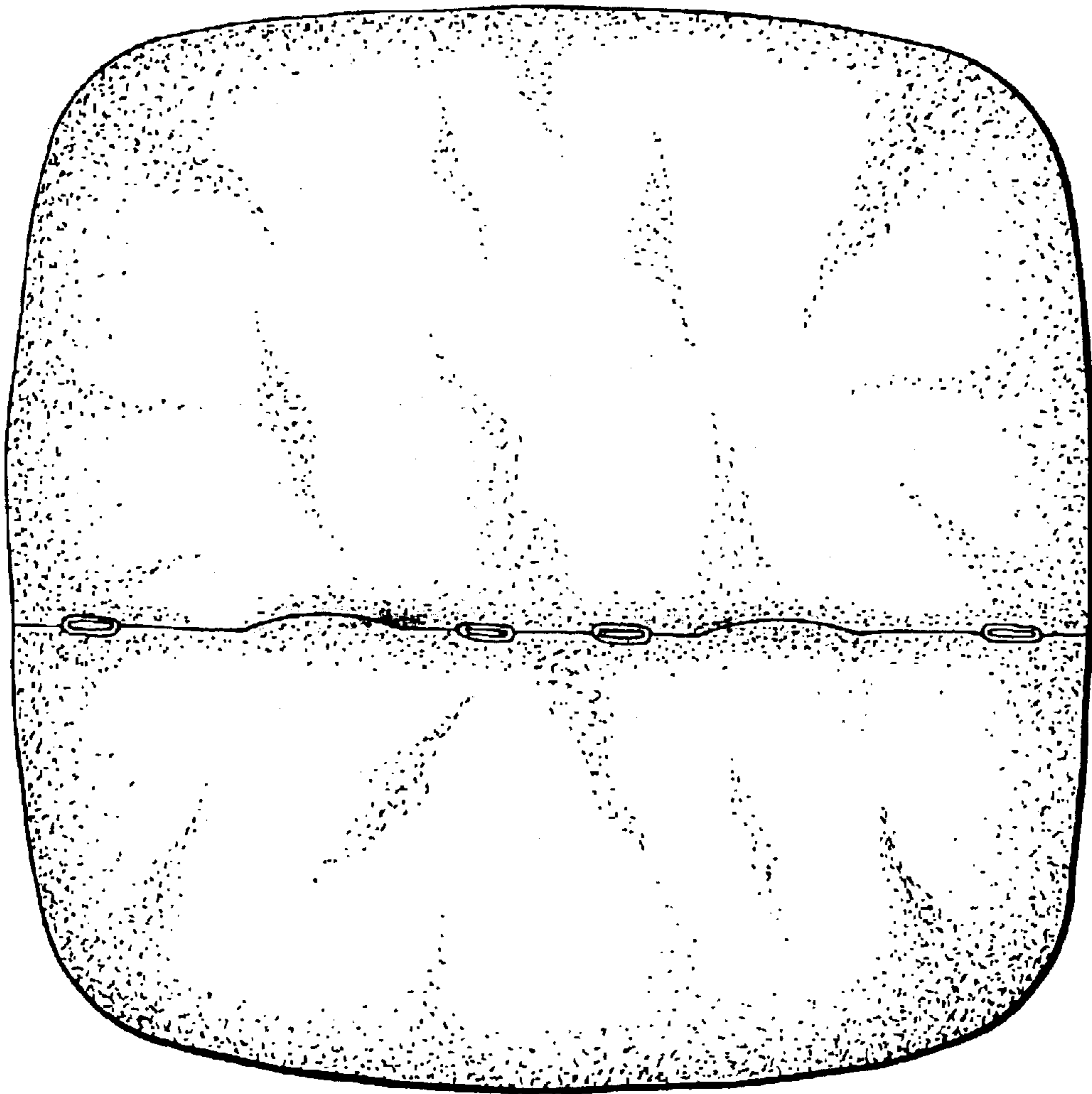

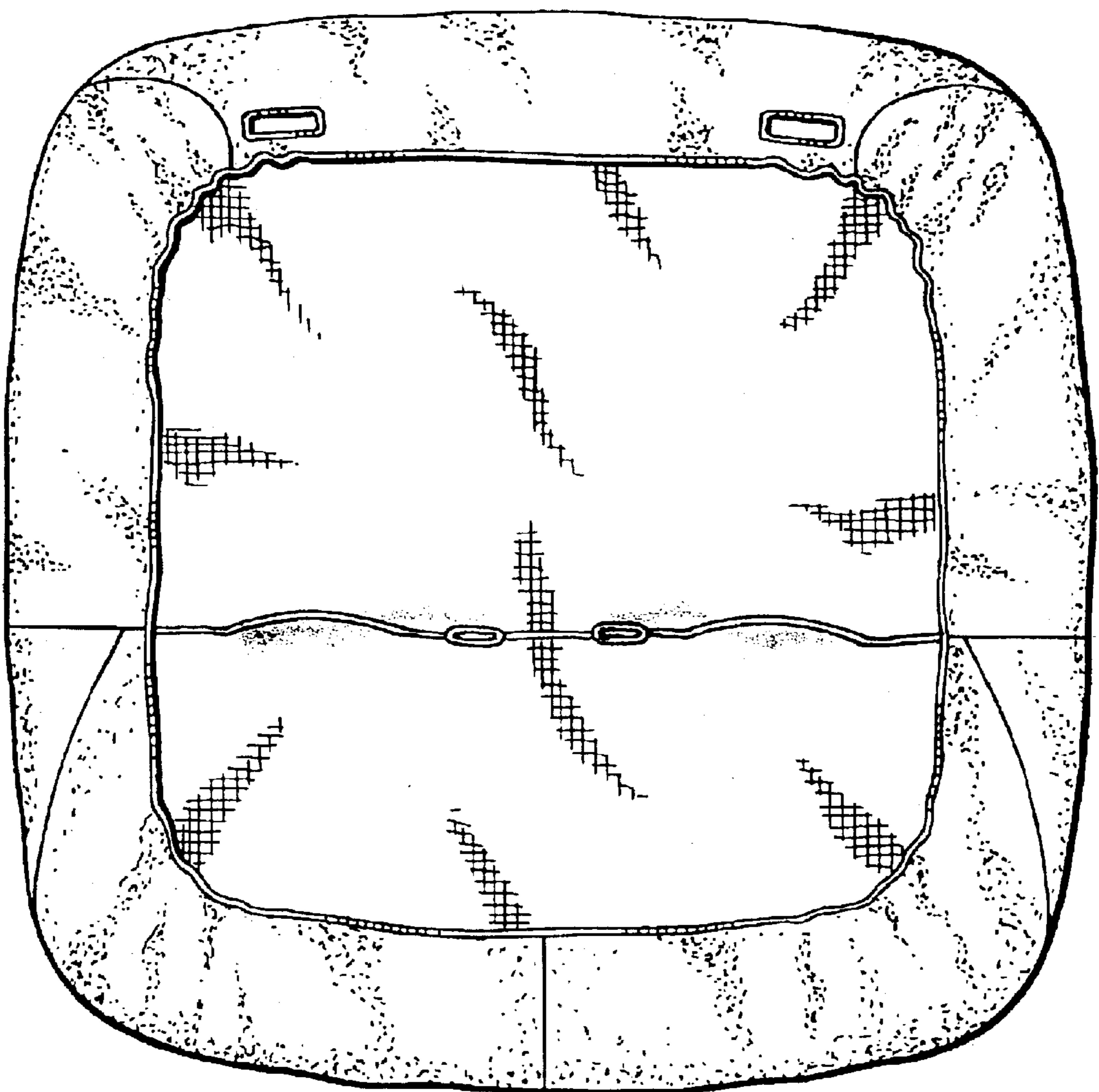

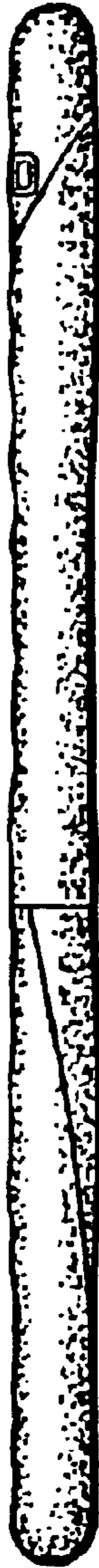
