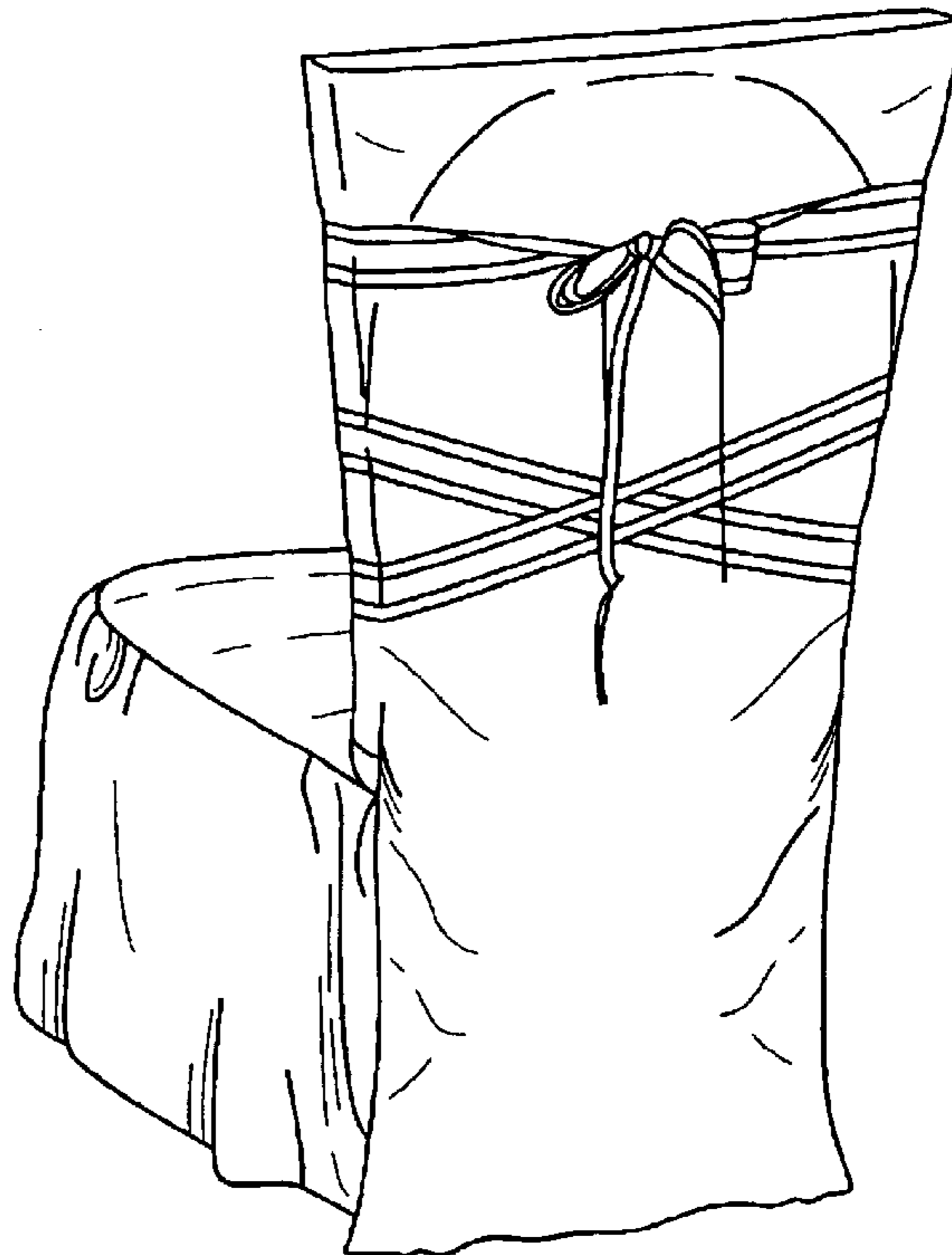
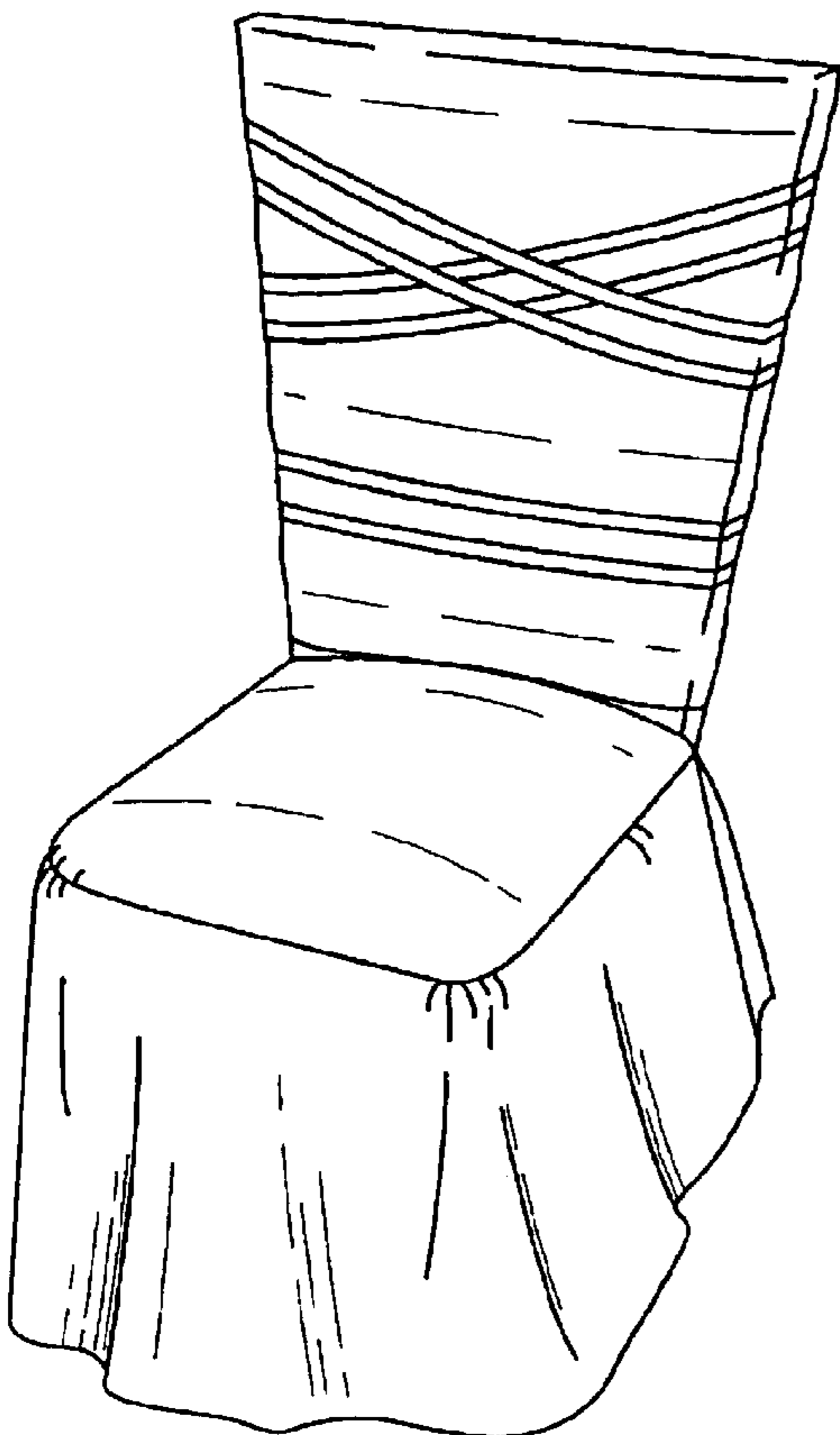
(57) **CLAIM**

DESCRIPTION

FIG. 1 is an elevated, frontal view of the chair cover.
FIG. 2 is a partial side and full-rear view of the chair cover shown in FIG. 1.
FIG. 3 is a frontal view of the chair cover shown in FIG. 1.

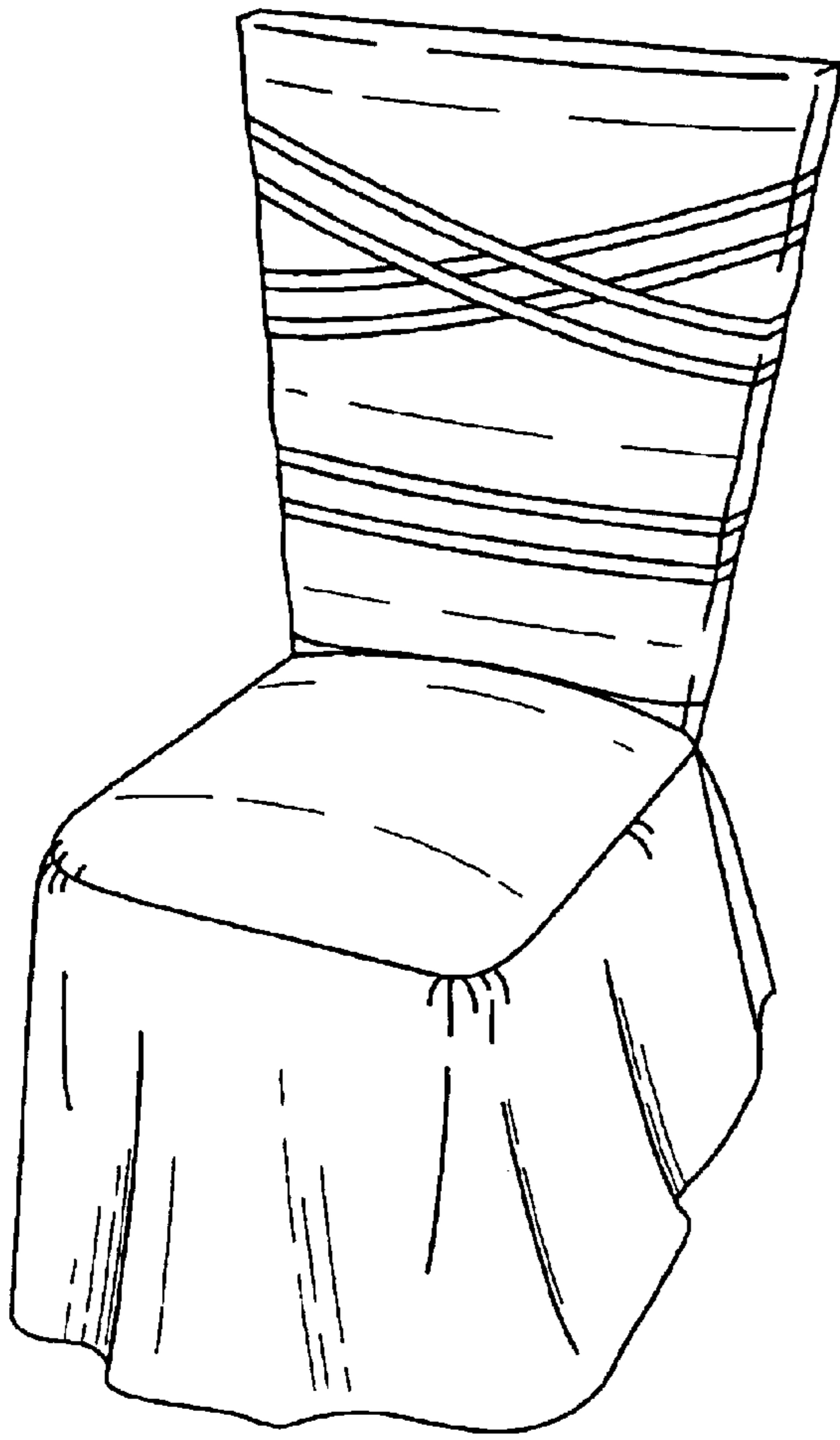

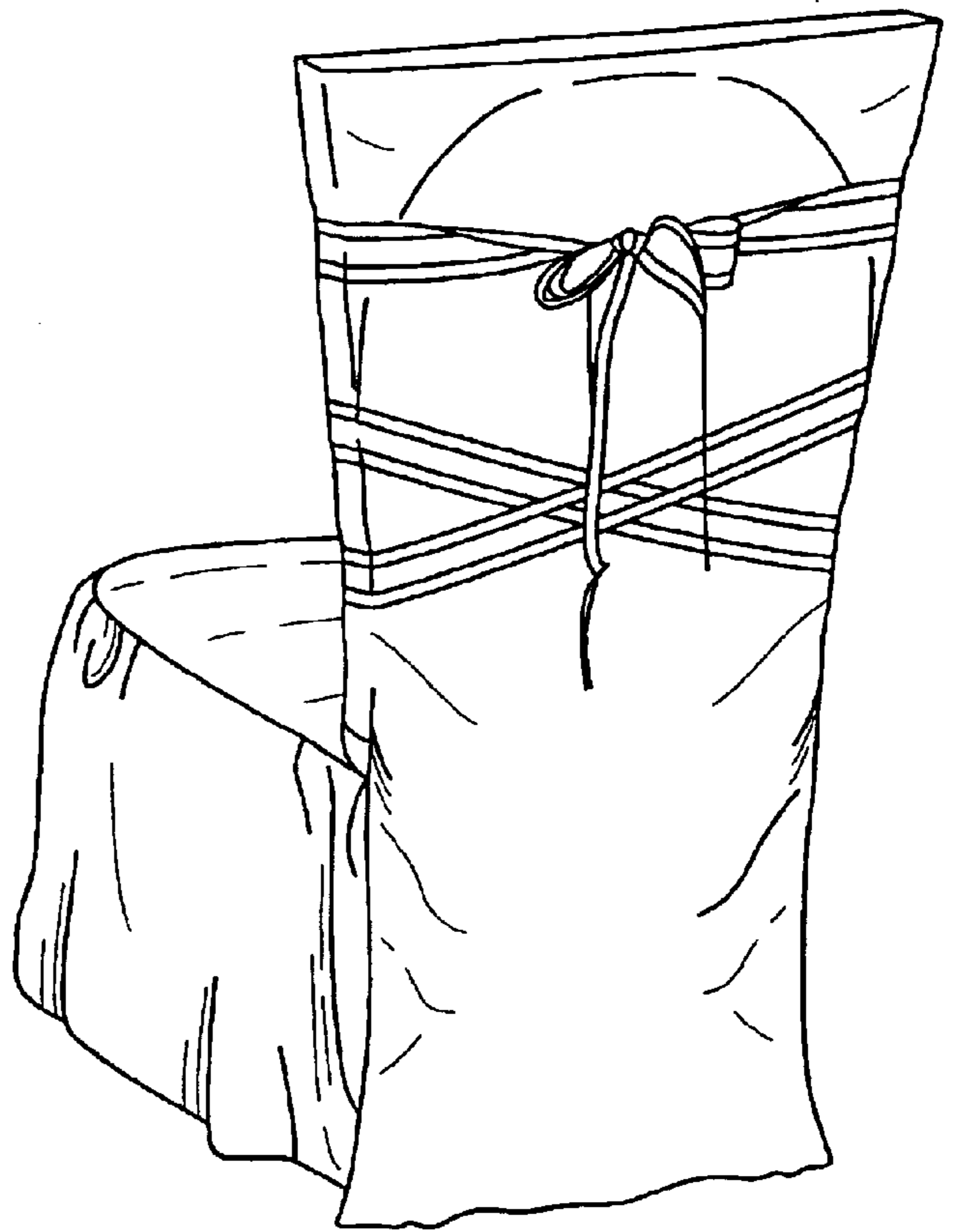

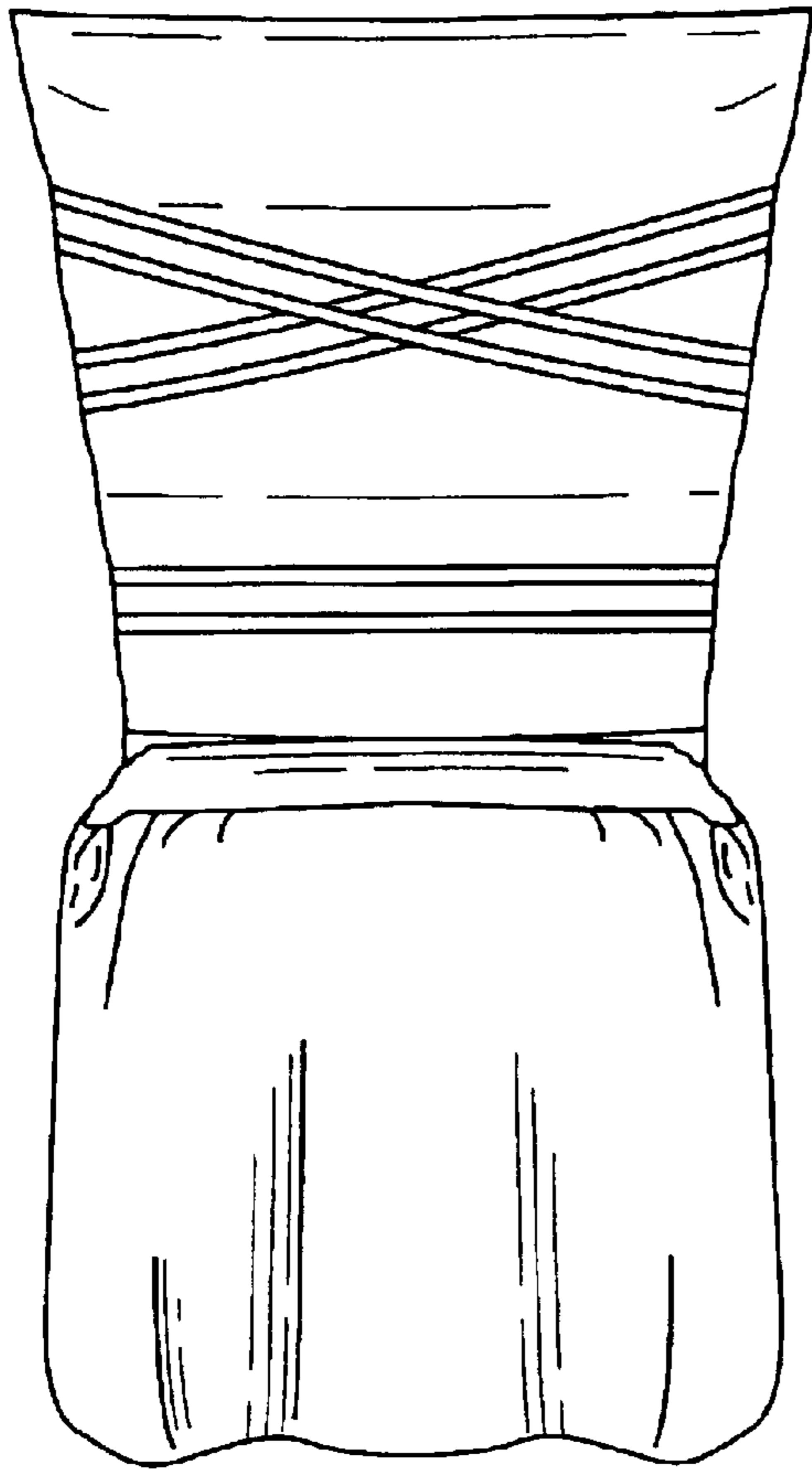

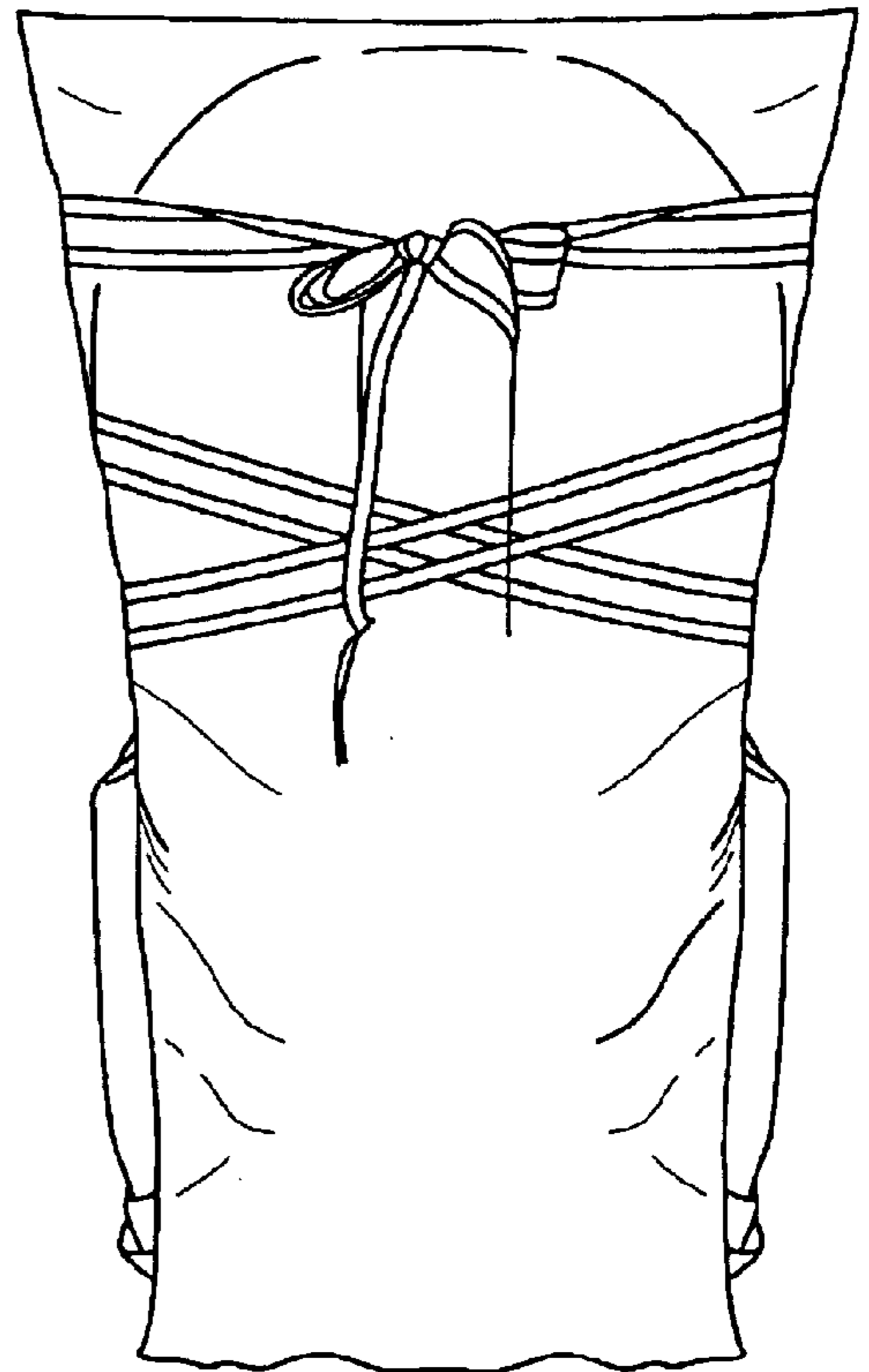

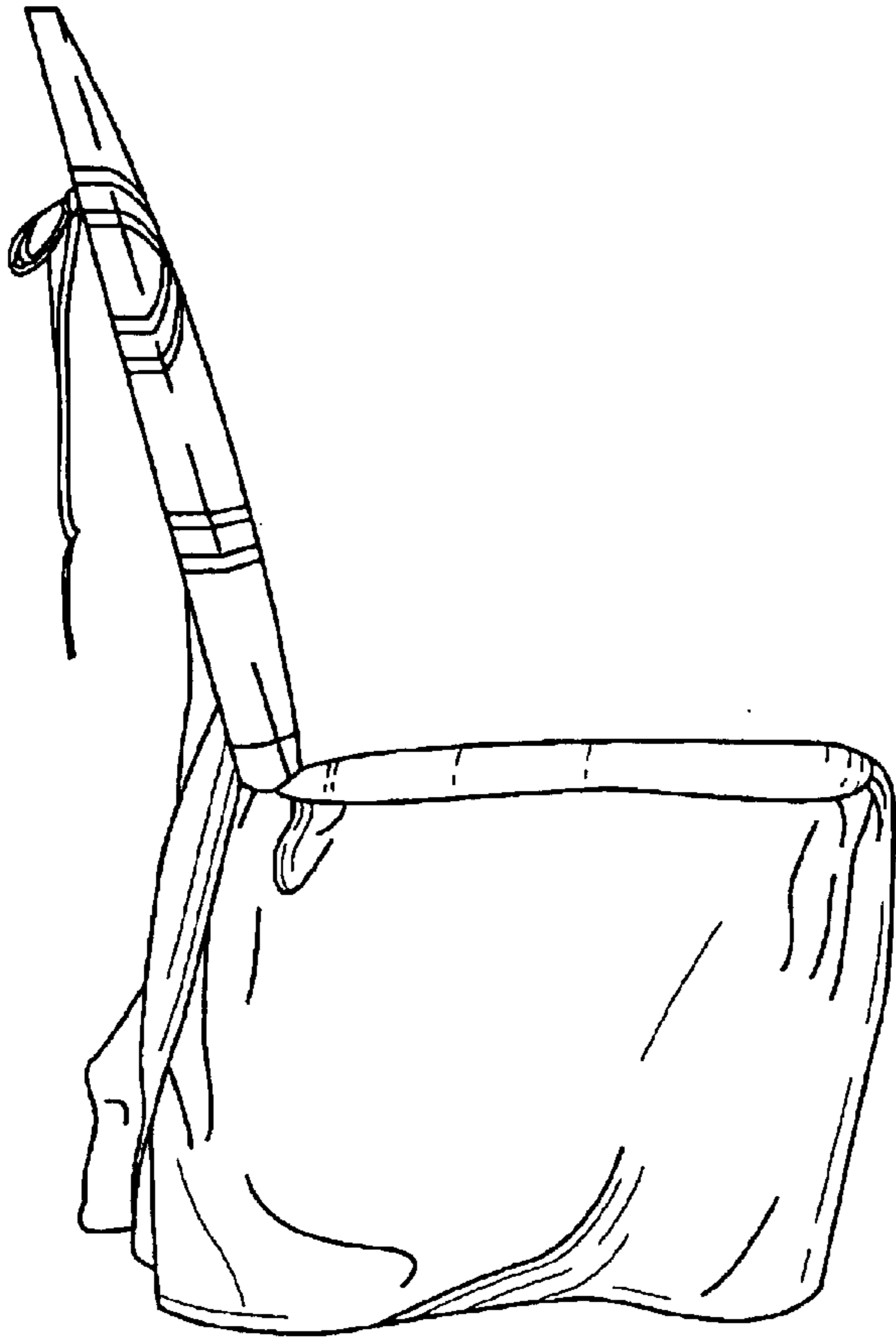

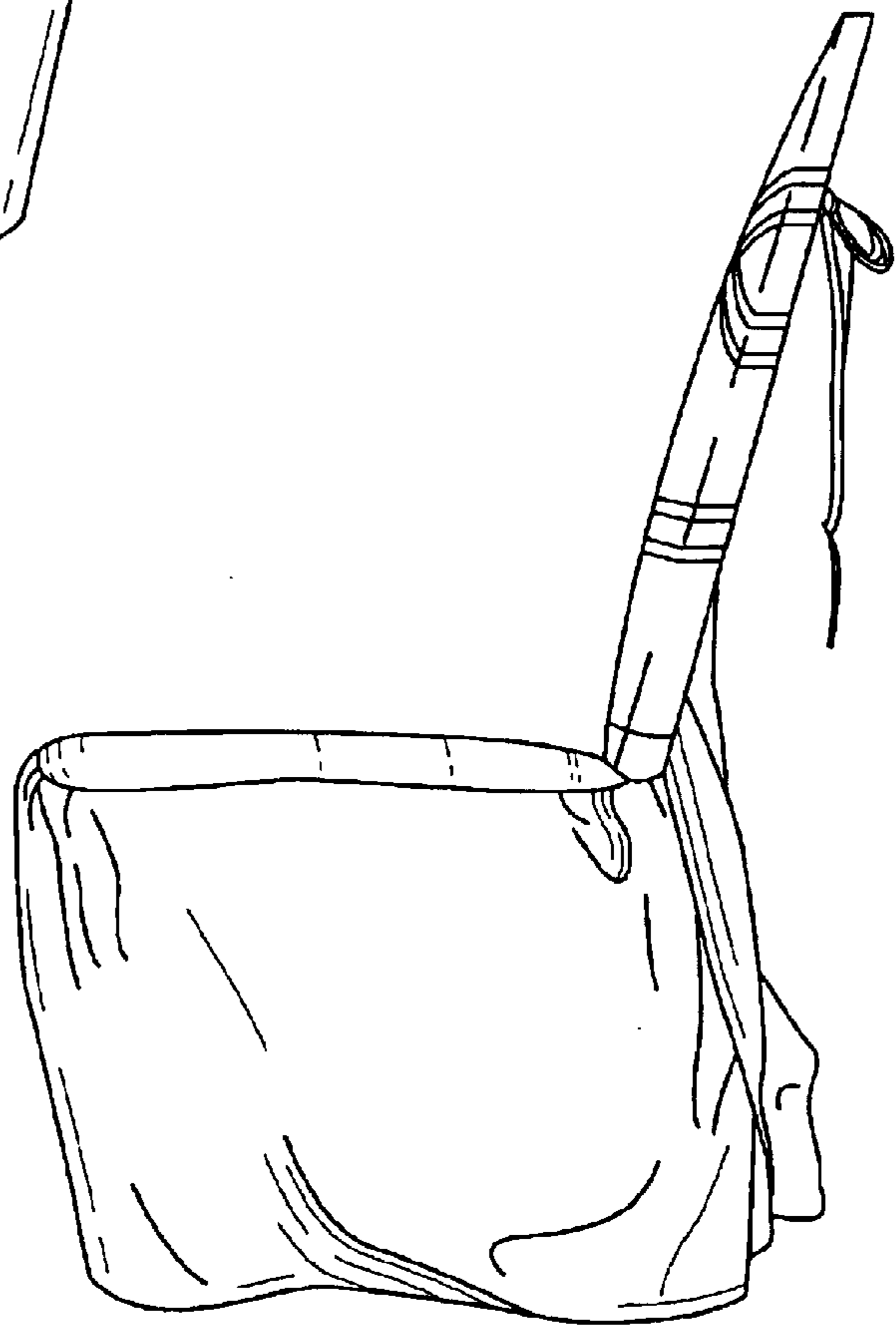
