(57) **CLAIM**

I claim the ornamental design of the clamping pliers, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a first embodiment of a clamping pliers of the claimed design;  
FIG. 2 is a right side view of the clamping pliers of FIG. 1;  
FIG. 3 is a top view of the clamping pliers of FIG. 1;  
FIG. 4 is another top view of the clamping pliers of FIG. 1 showing the clamping pliers in an open position;  
FIG. 5 is another front view of the clamping pliers of FIG. 1 showing the clamping pliers in an open position;  
FIG. 6 is a front view of a second embodiment of a clamping pliers of the claimed design;  
FIG. 7 is a left side view of the clamping pliers of FIG. 6;  
FIG. 8 is a rear view of the clamping pliers of FIG. 6;  
FIG. 9 is a right side view of the clamping pliers of FIG. 6;  
FIG. 10 is a top view of the clamping pliers of FIG. 6;  
FIG. 11 is another top view of the clamping pliers of FIG. 6 showing the clamping pliers in an open position; and,  
FIG. 12 is another front view of the clamping pliers of FIG. 6 showing the clamping pliers in an open position.

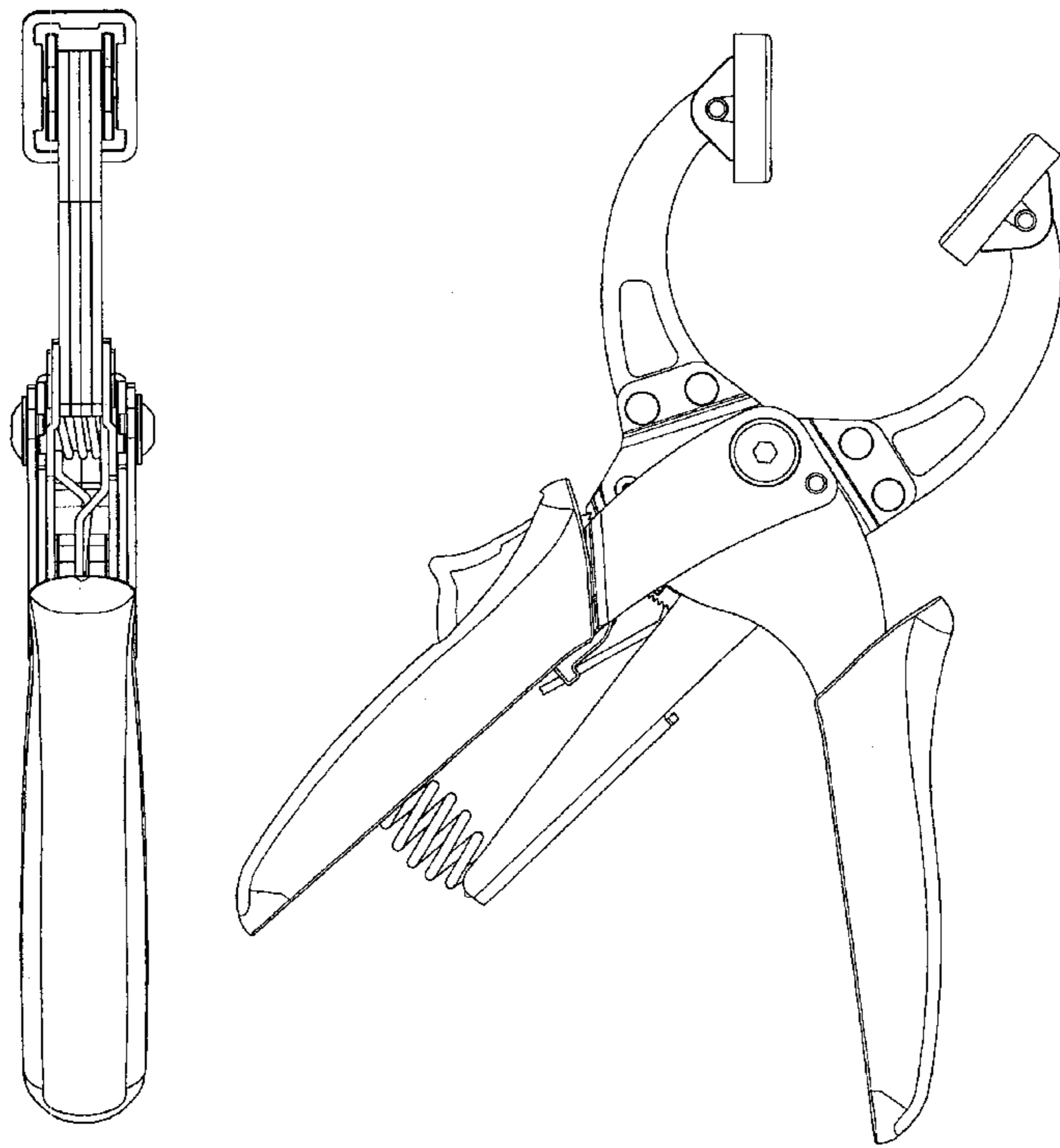

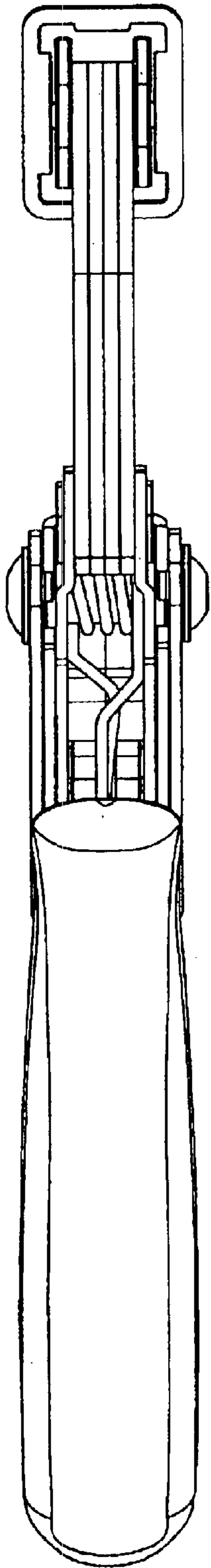

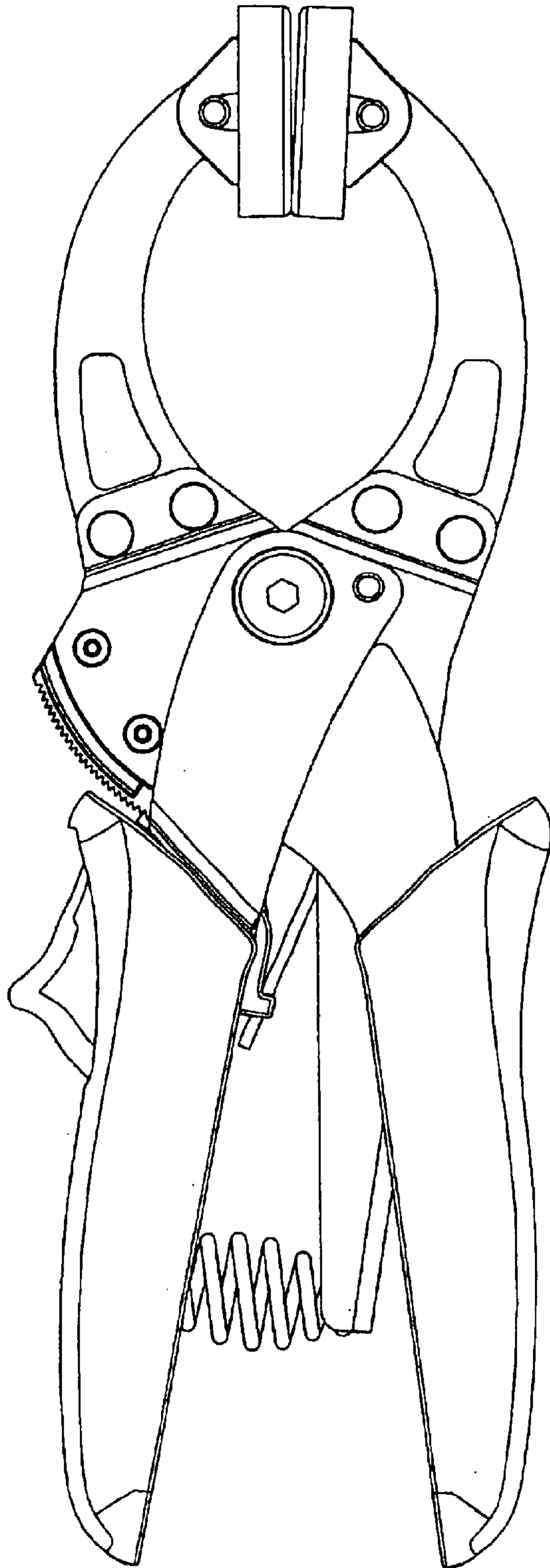

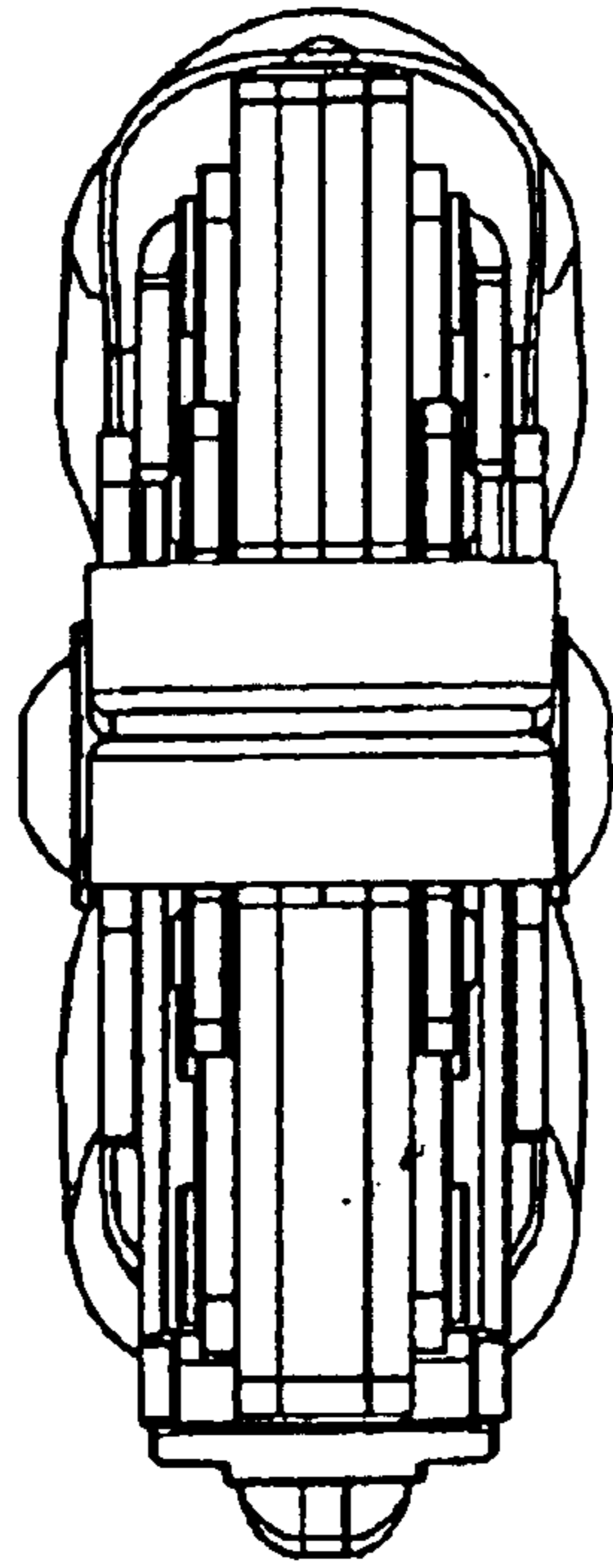

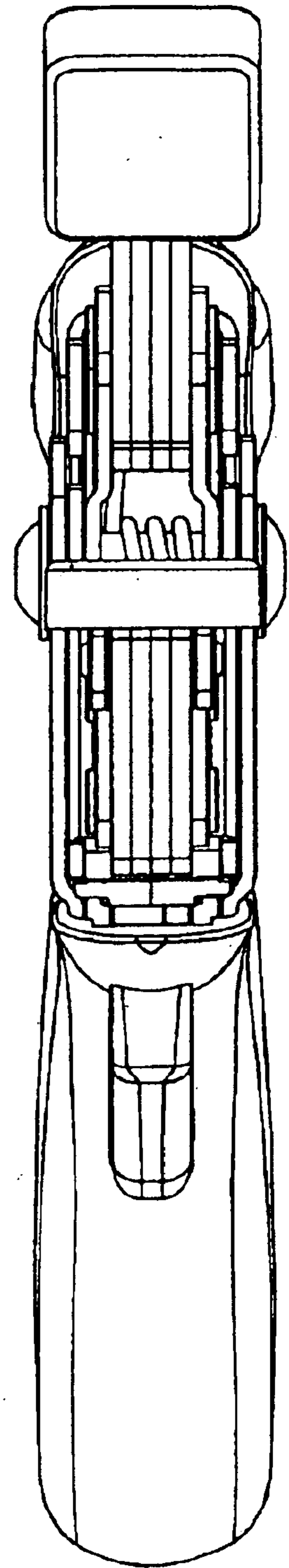

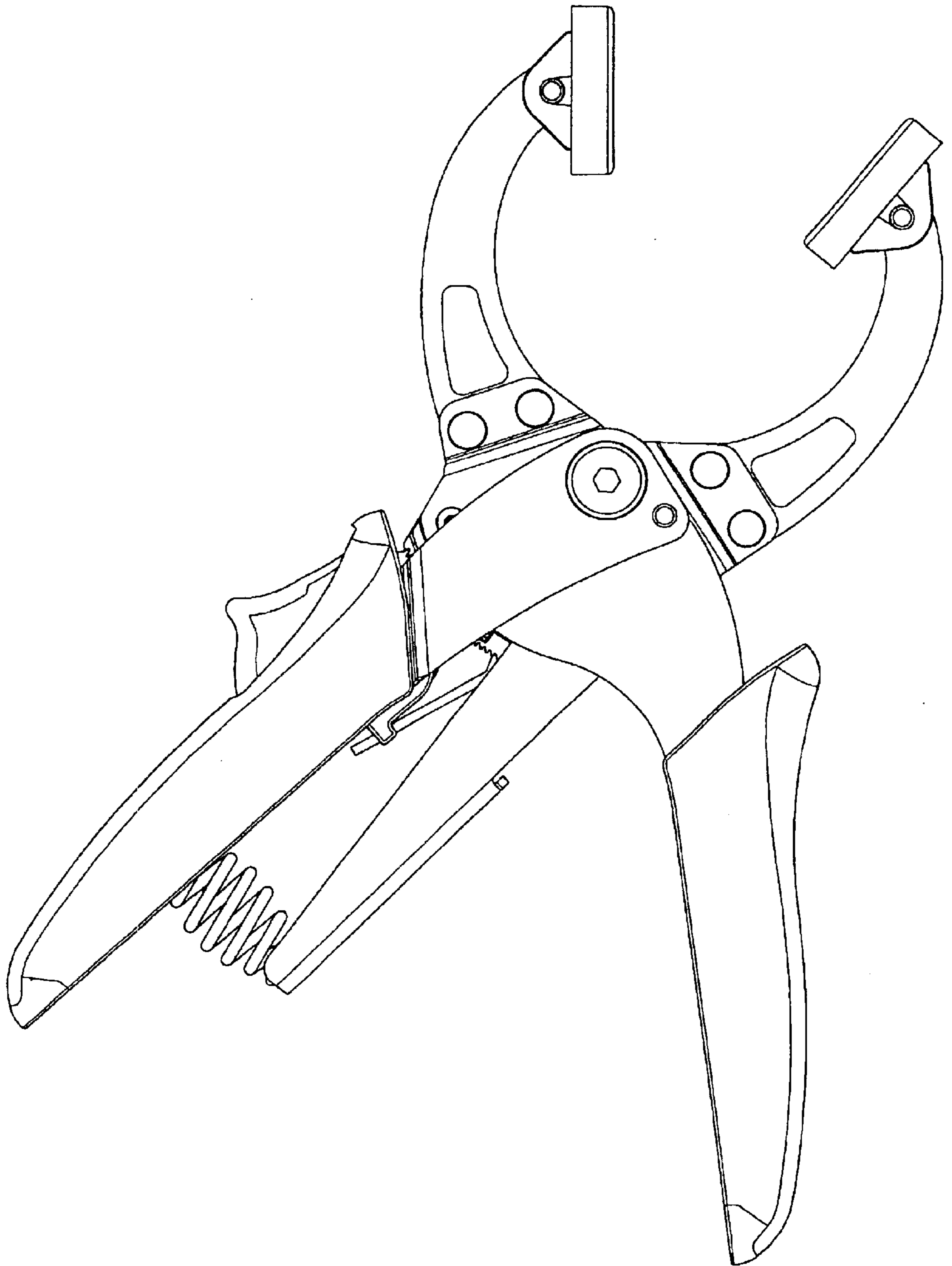

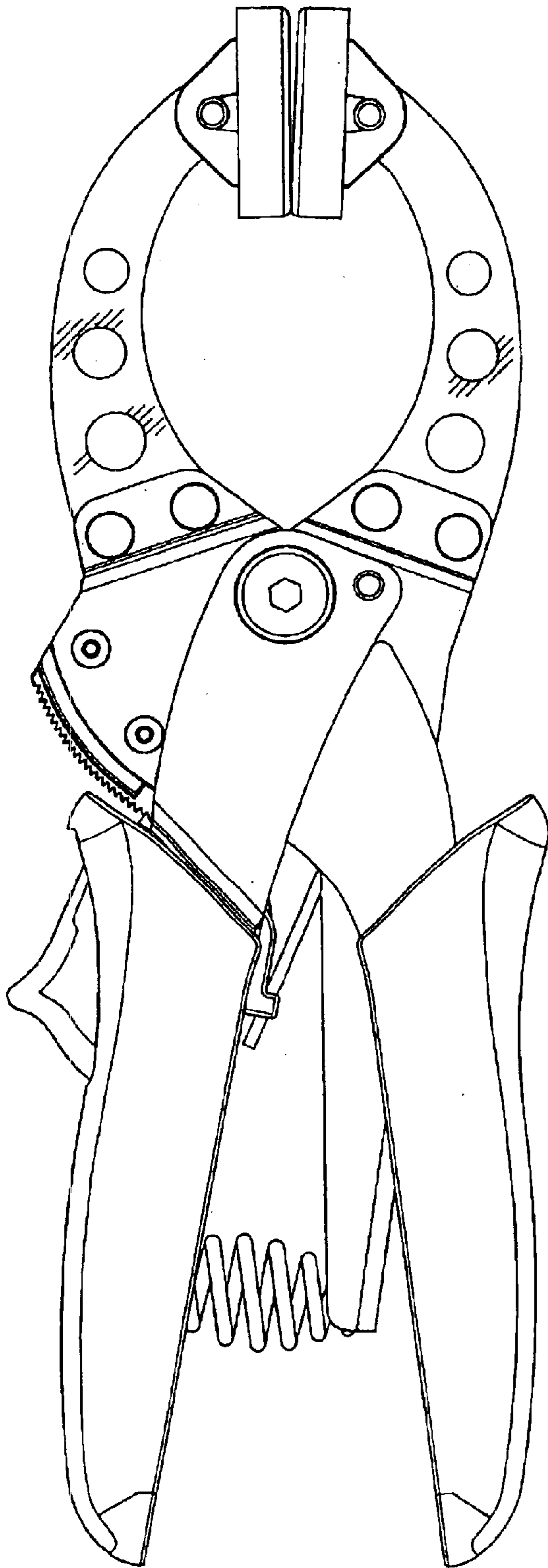

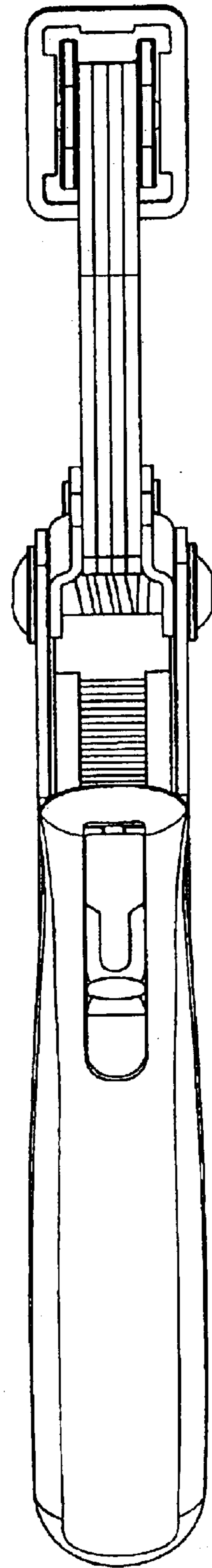

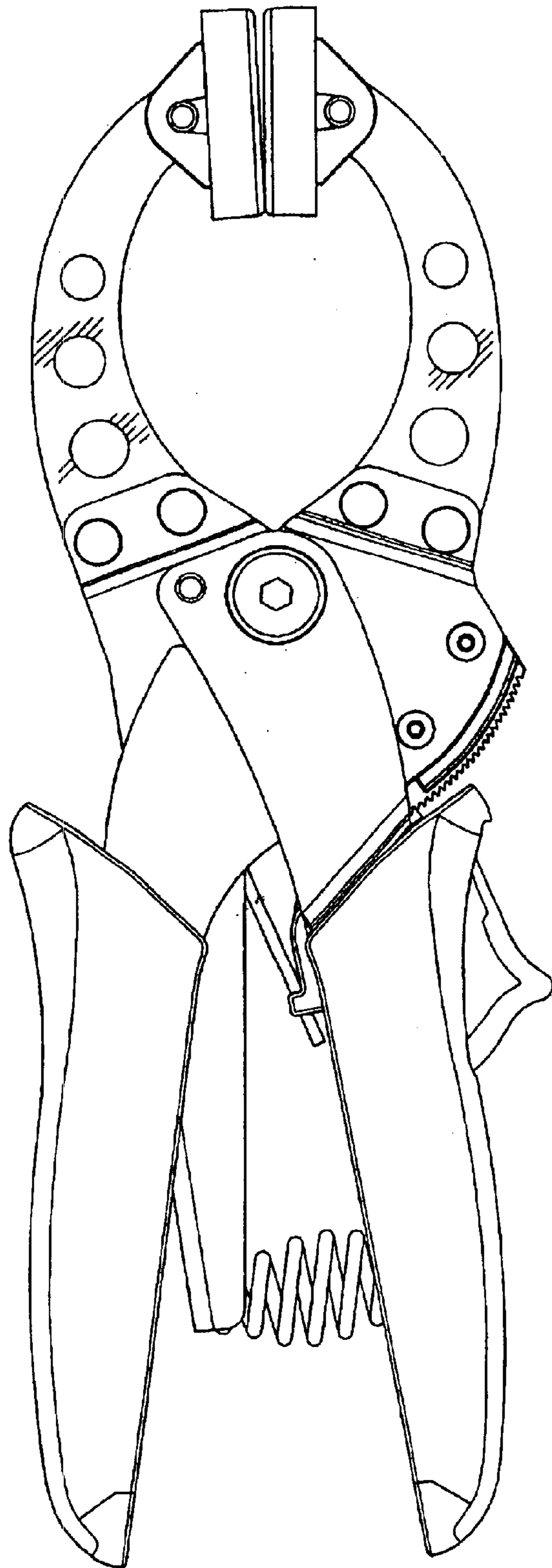

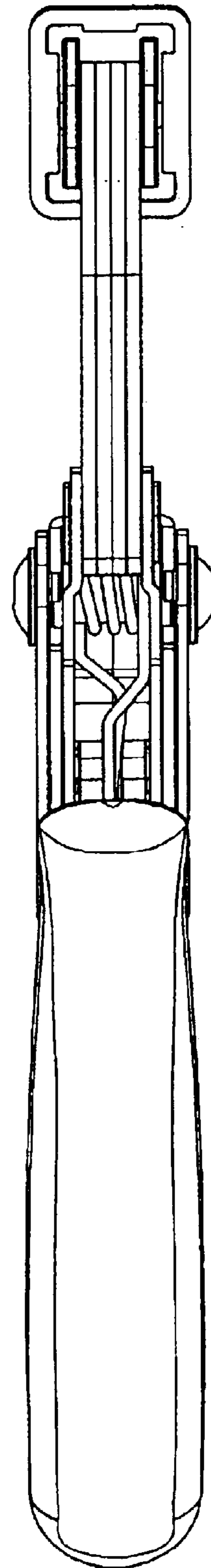

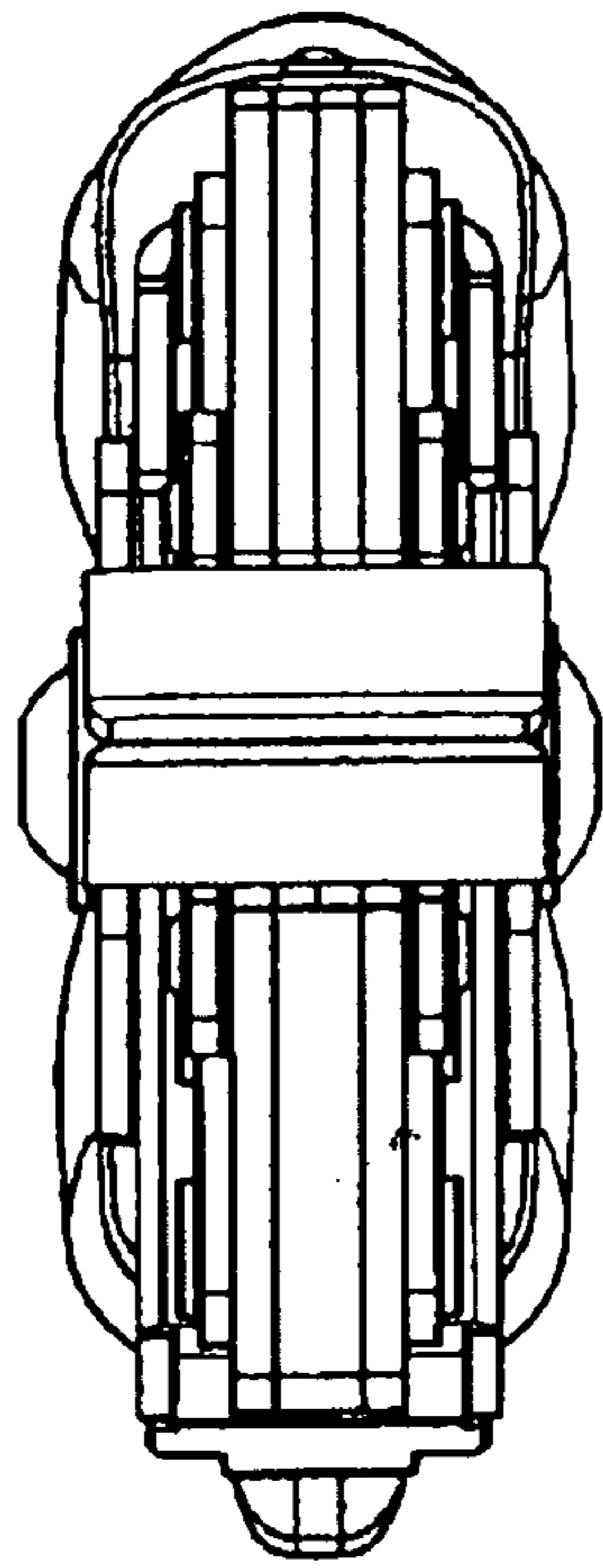

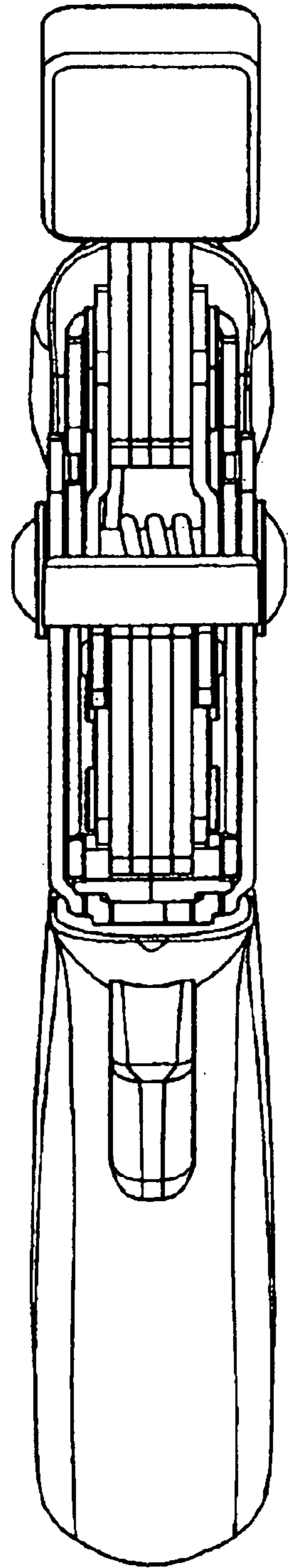
