(57) **CLAIM**

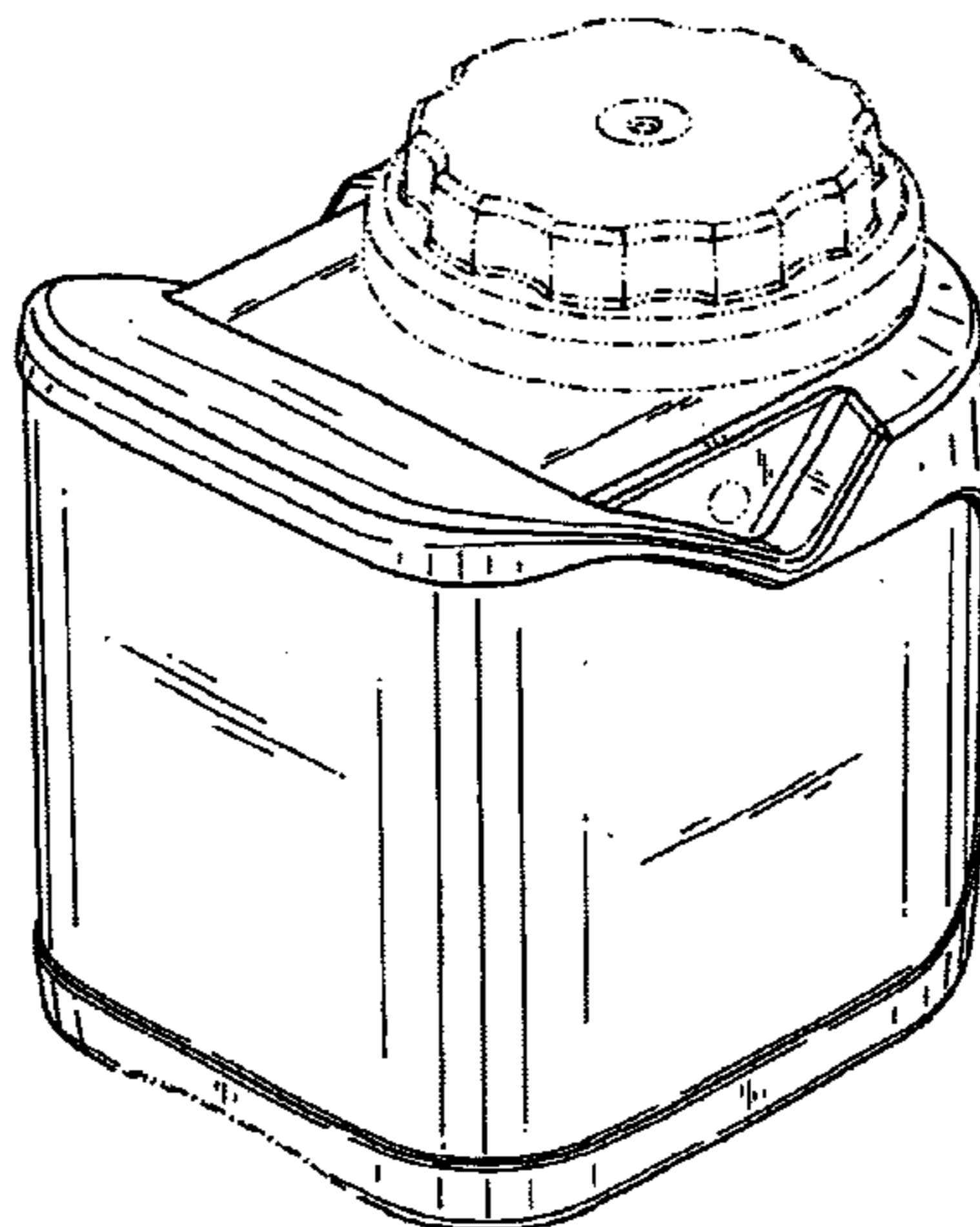
We claim the ornamental design for a container, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a container;  
FIG. 2 is a right side view of a design of FIG. 1, the left side view being a mirror image;  
FIG. 3 is a rear view of the design of FIG. 1;  
FIG. 4 is a back view of the design of FIG. 1;  
FIG. 5 is a top view of the design of FIG. 1; and,  
FIG. 6 is a bottom view of the design of FIG. 1.

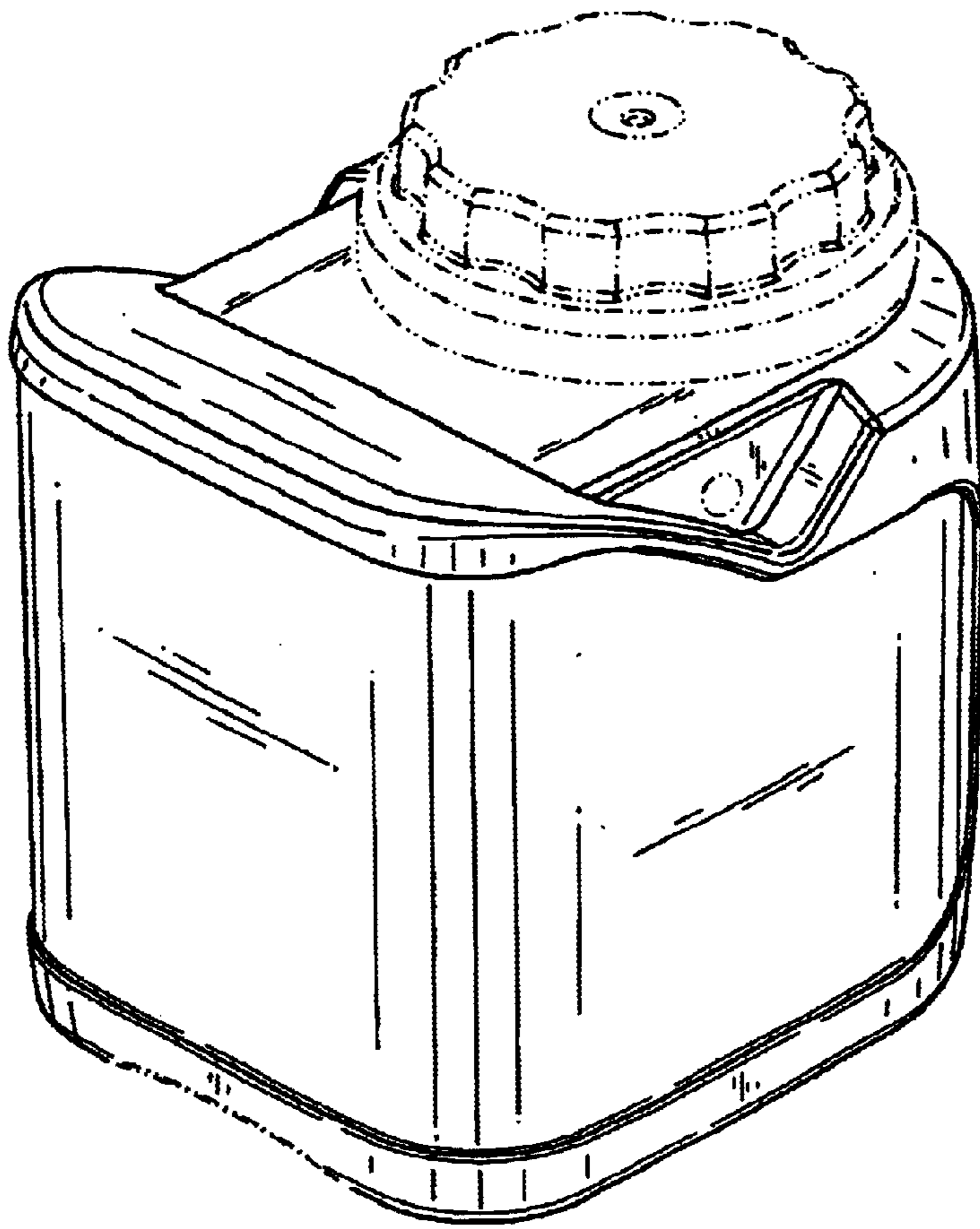

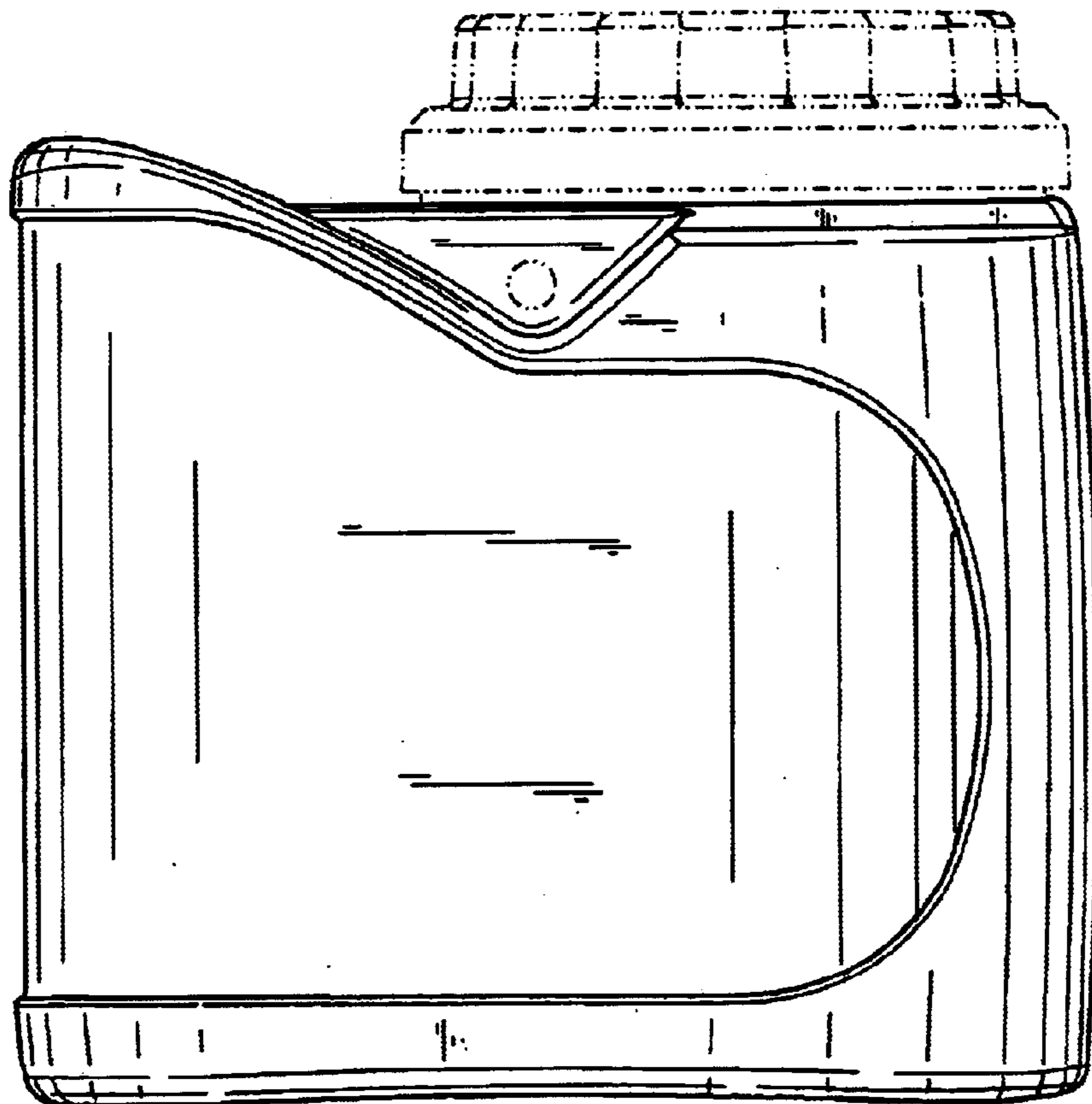

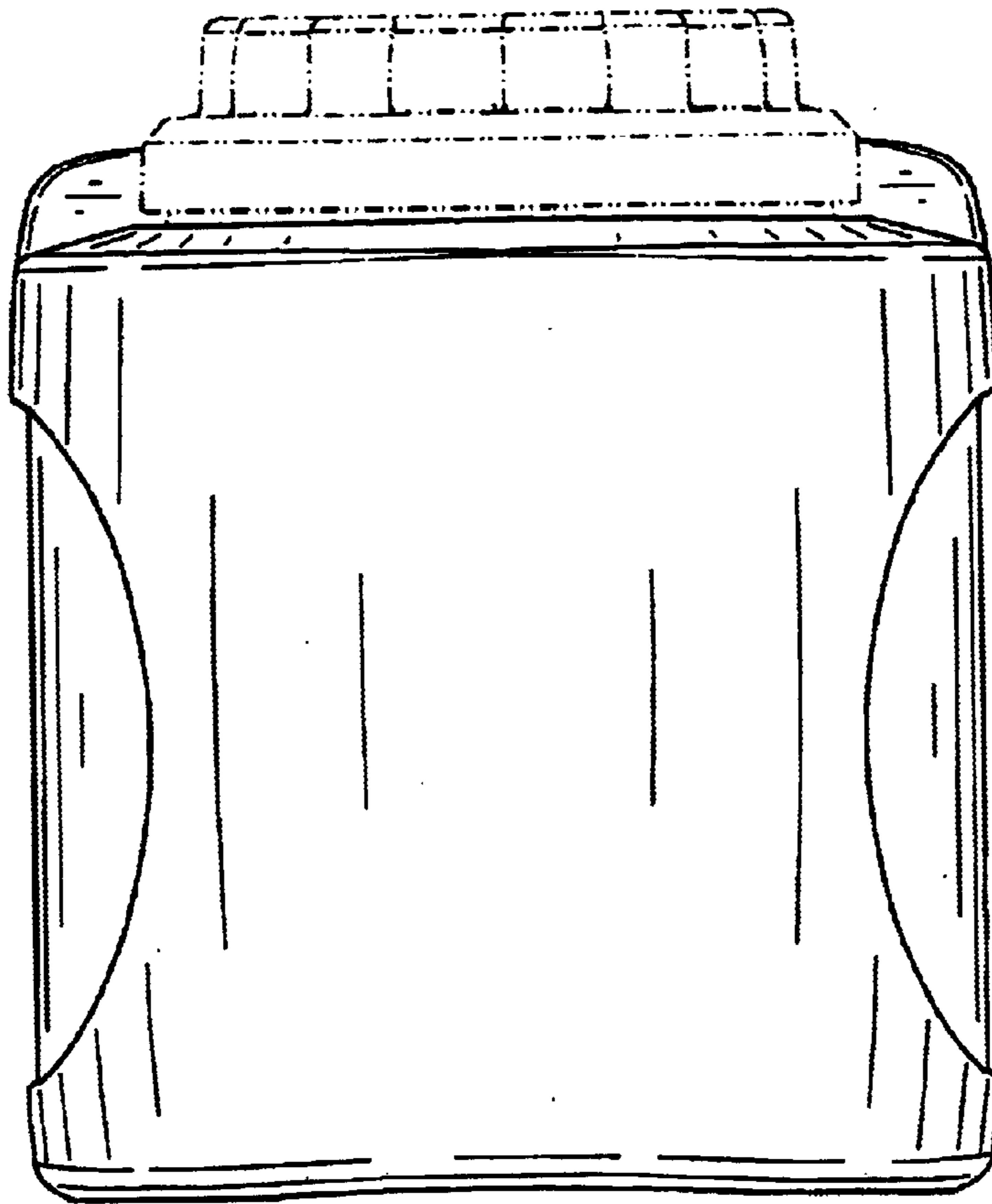

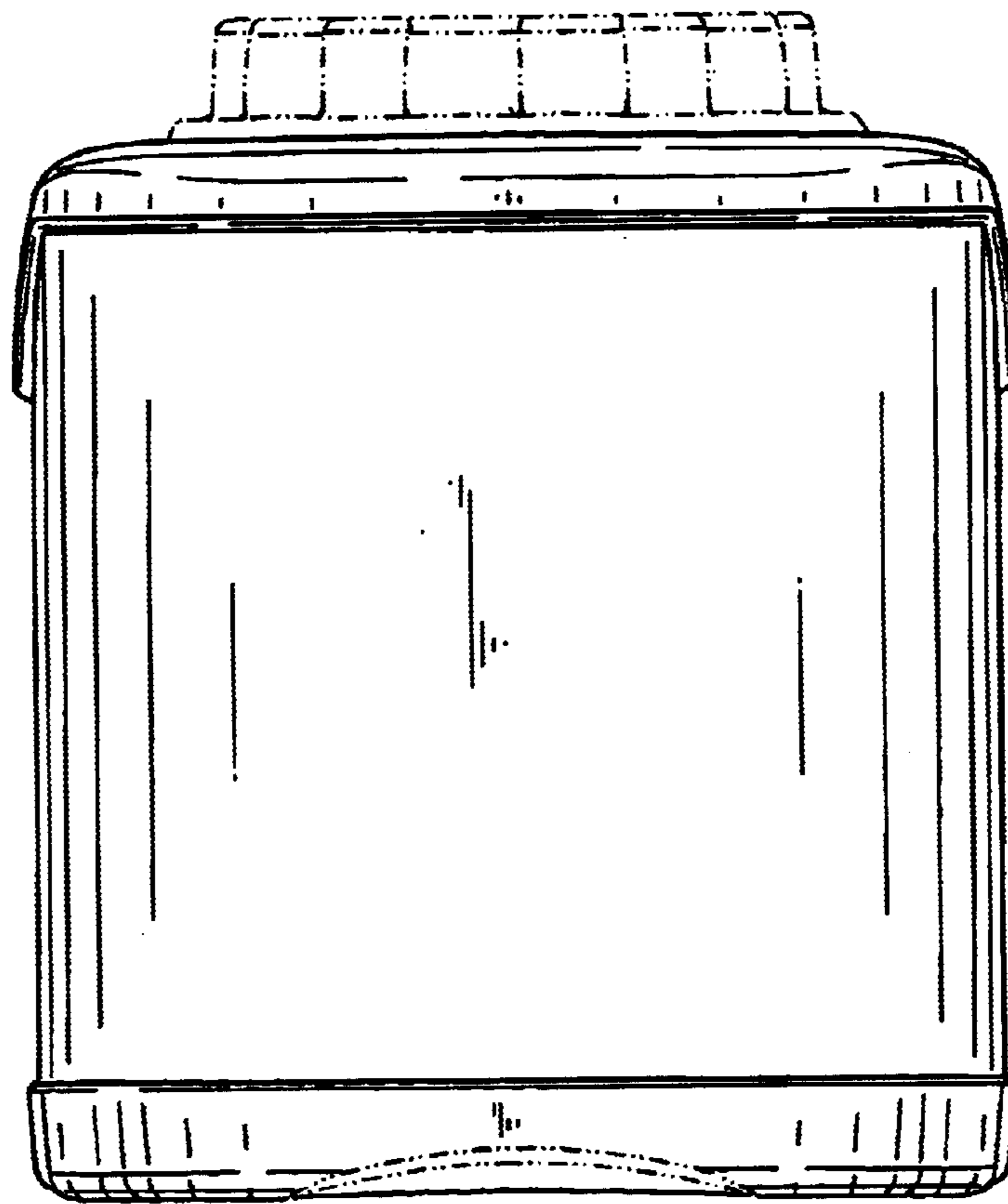

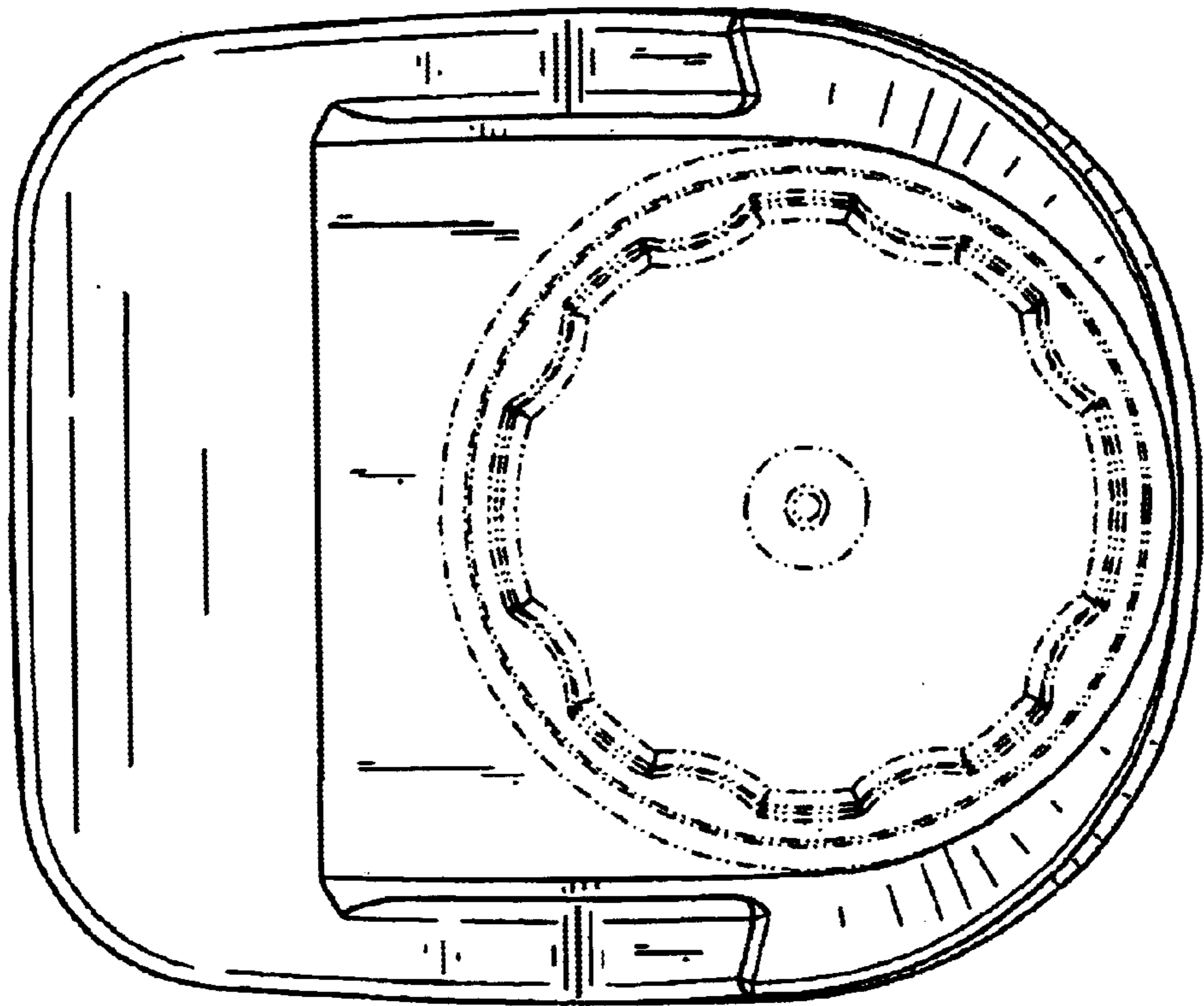
