FIG. 2. Is a top view thereof;

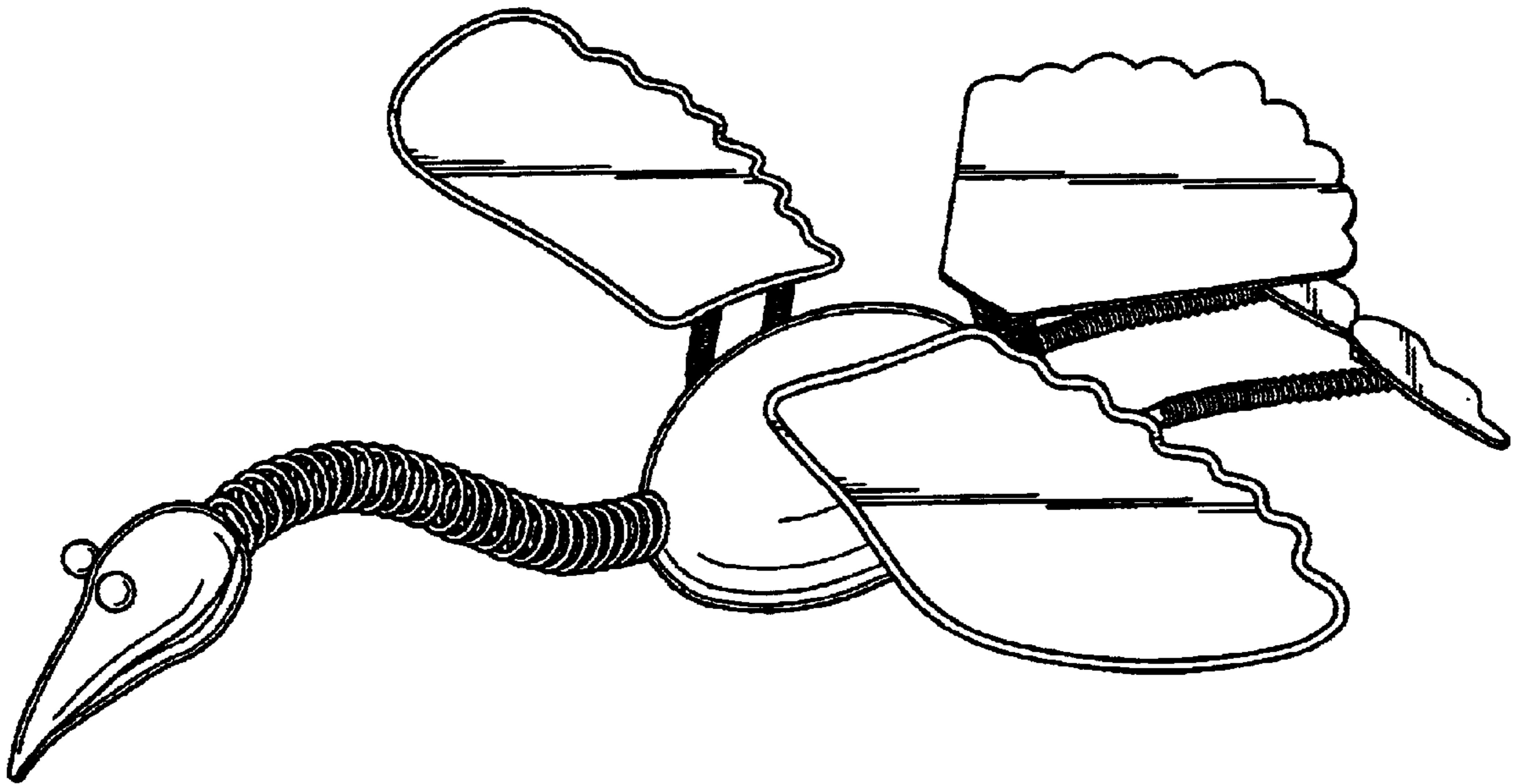
FIG. 3. Is a right side elevational view thereof;

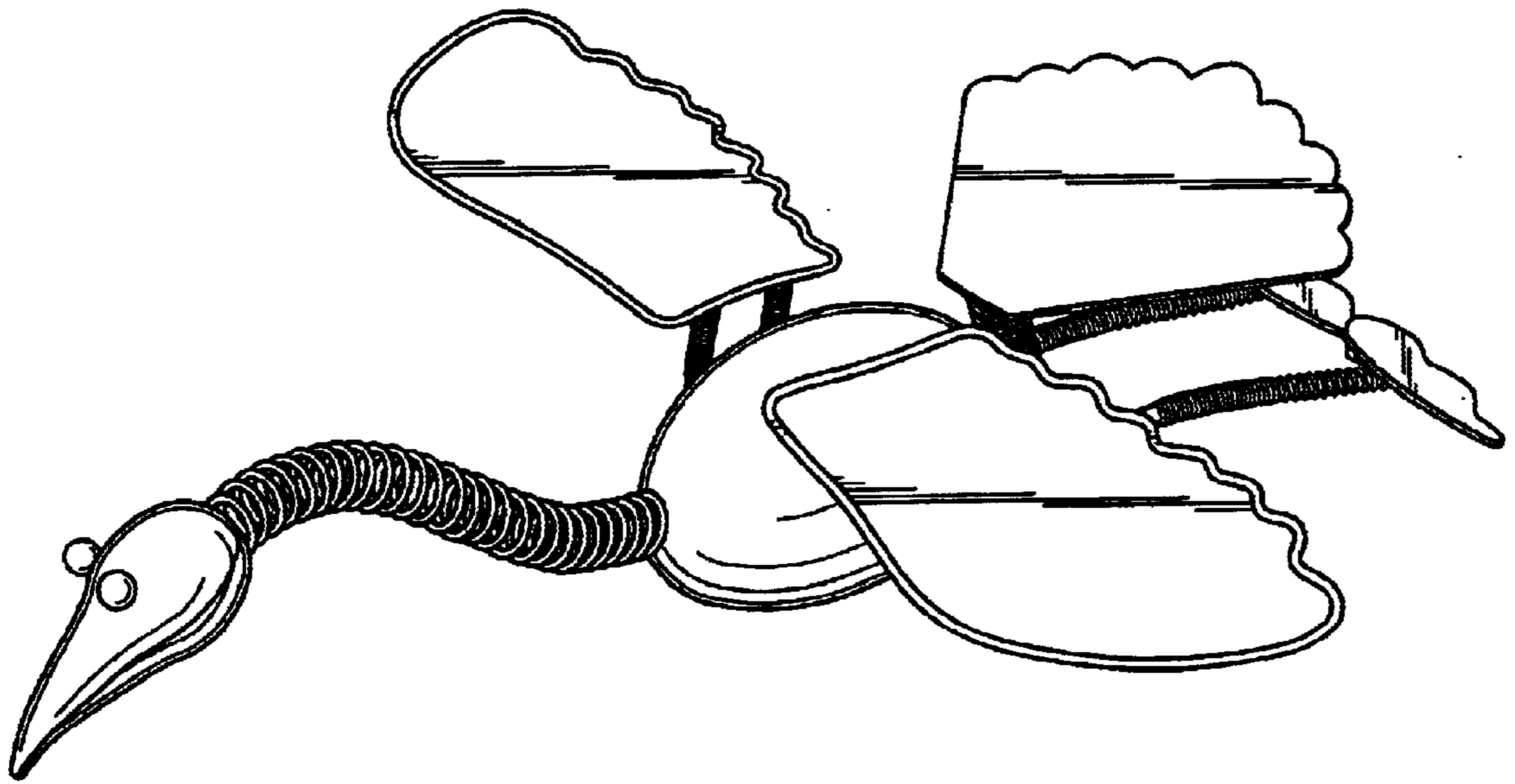

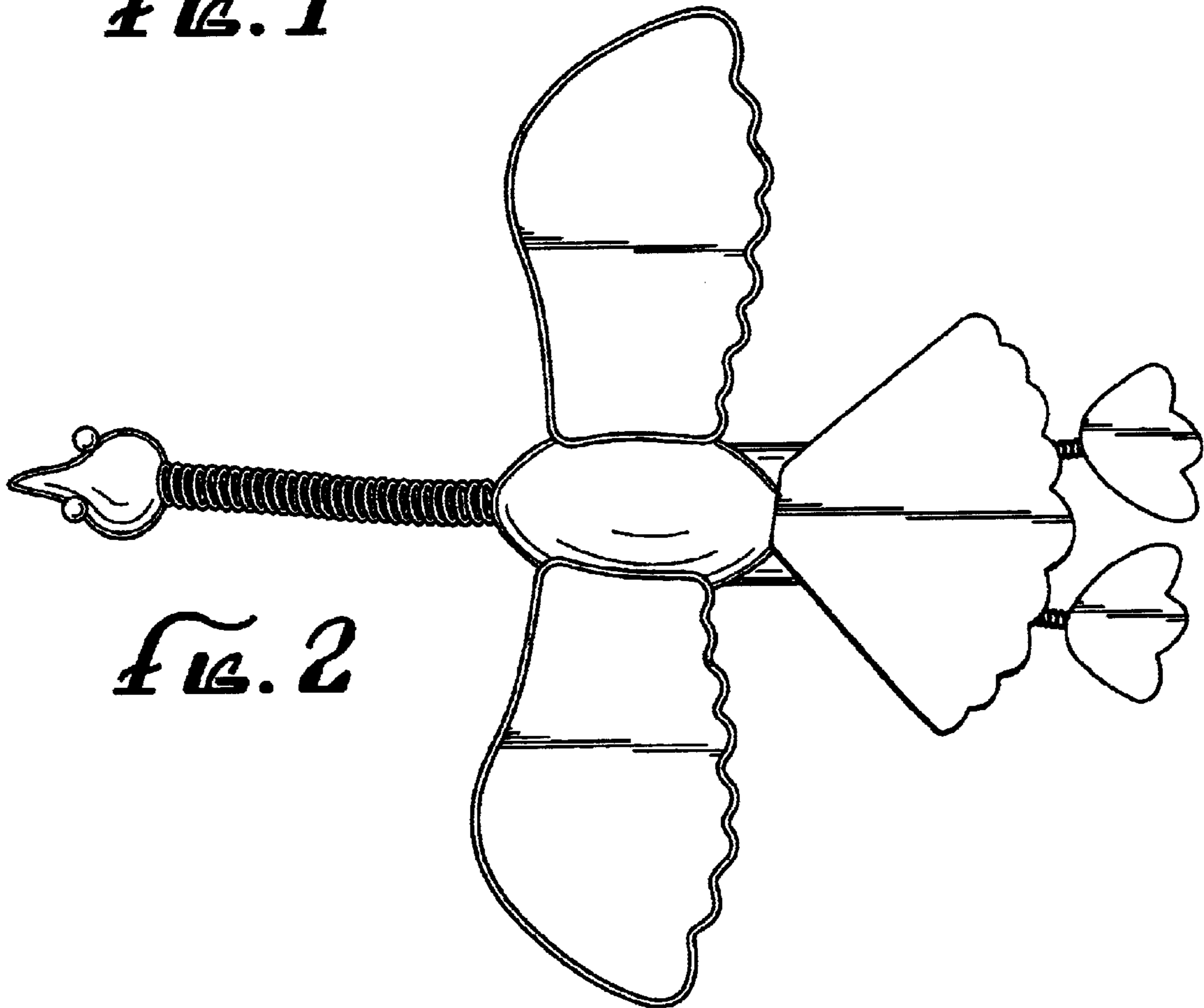

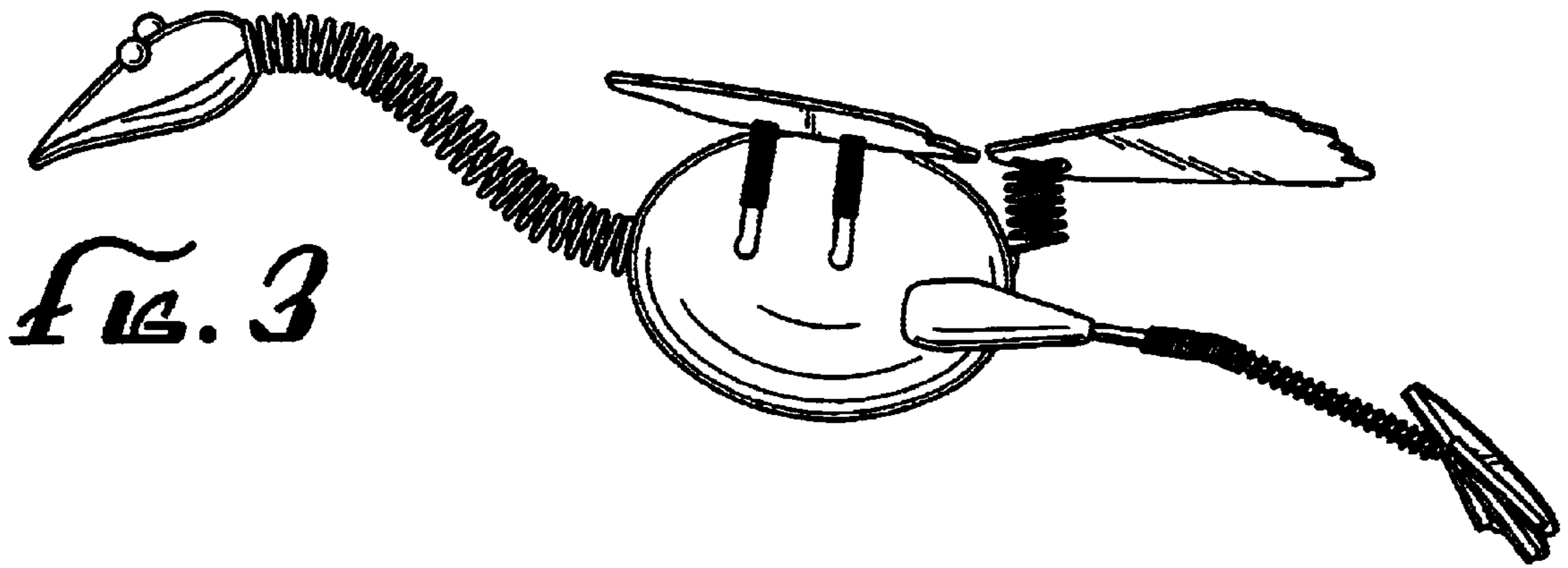

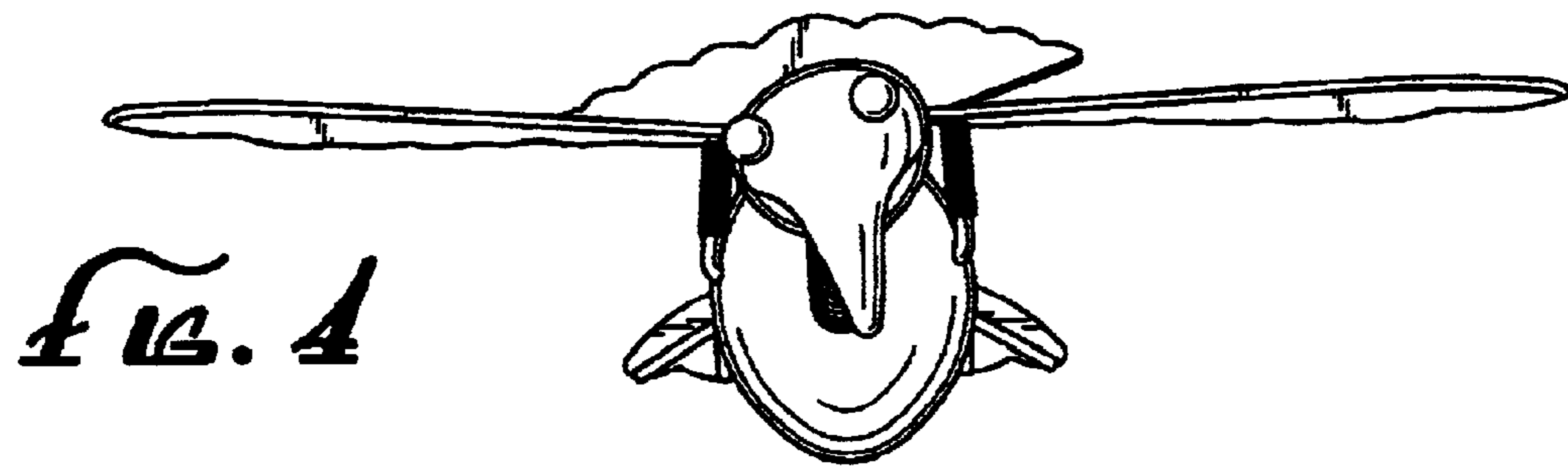

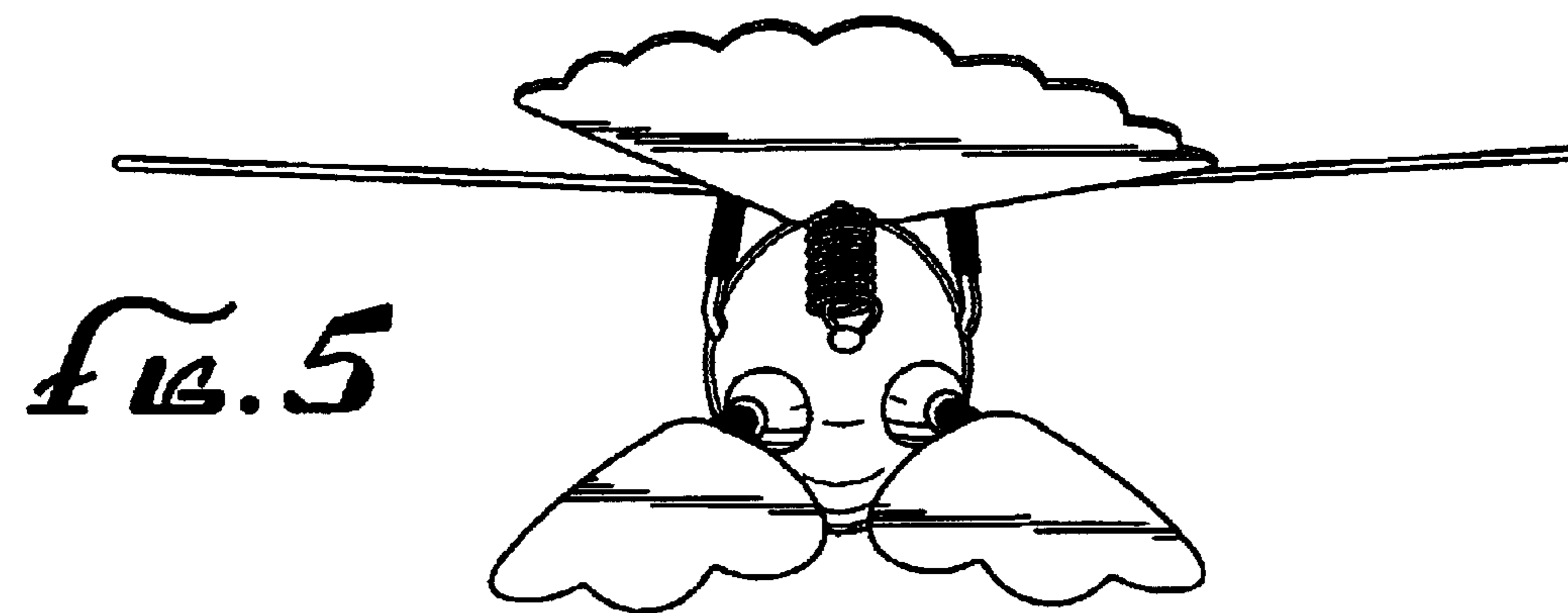
