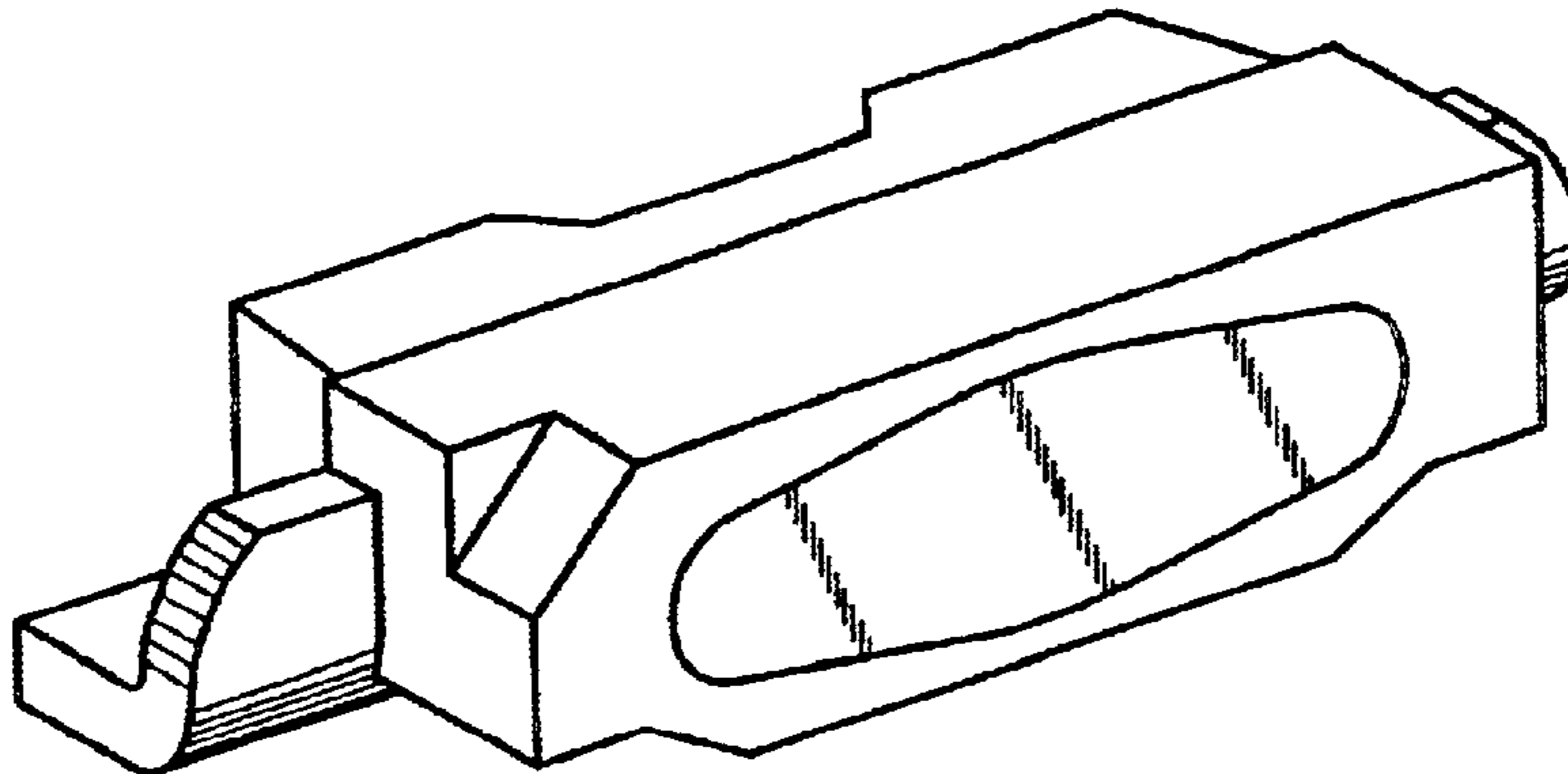
(57) **CLAIM**

I claim the ornamental design for a light emitting diode, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a light emitting diode showing my new design;
 FIG. 2 is a plan view of the light emitting diode according to the embodiment of FIG. 1;
 FIG. 3 is a left view of the light emitting diode according to the embodiment of FIG. 1;
 FIG. 4 is a front elevational view of the light emitting diode according to the embodiment of FIG. 1;
 FIG. 5 is a right view of the light emitting diode according to the embodiment of FIG. 1;
 FIG. 6 is a bottom plan of the light emitting diode according to the embodiment of FIG. 1;
 FIG. 7 is a rear view of the same light emitting diode as showing in FIG. 1;
 FIG. 8 is a plan view of the light emitting diode according to another embodiment of my new design;
 FIG. 9 is a left view of the light emitting diode according to the embodiment of FIG. 8;
 FIG. 10 is a front elevational view of the light emitting diode according to the embodiment of FIG. 8;
 FIG. 11 is a right view of the light emitting diode according to the embodiment of FIG. 8;
 FIG. 12 is a bottom plan view of the light emitting diode according to the embodiment of FIG. 8; and,
 FIG. 13 is a rear view of the light emitting diode according to the embodiment of FIG. 8.

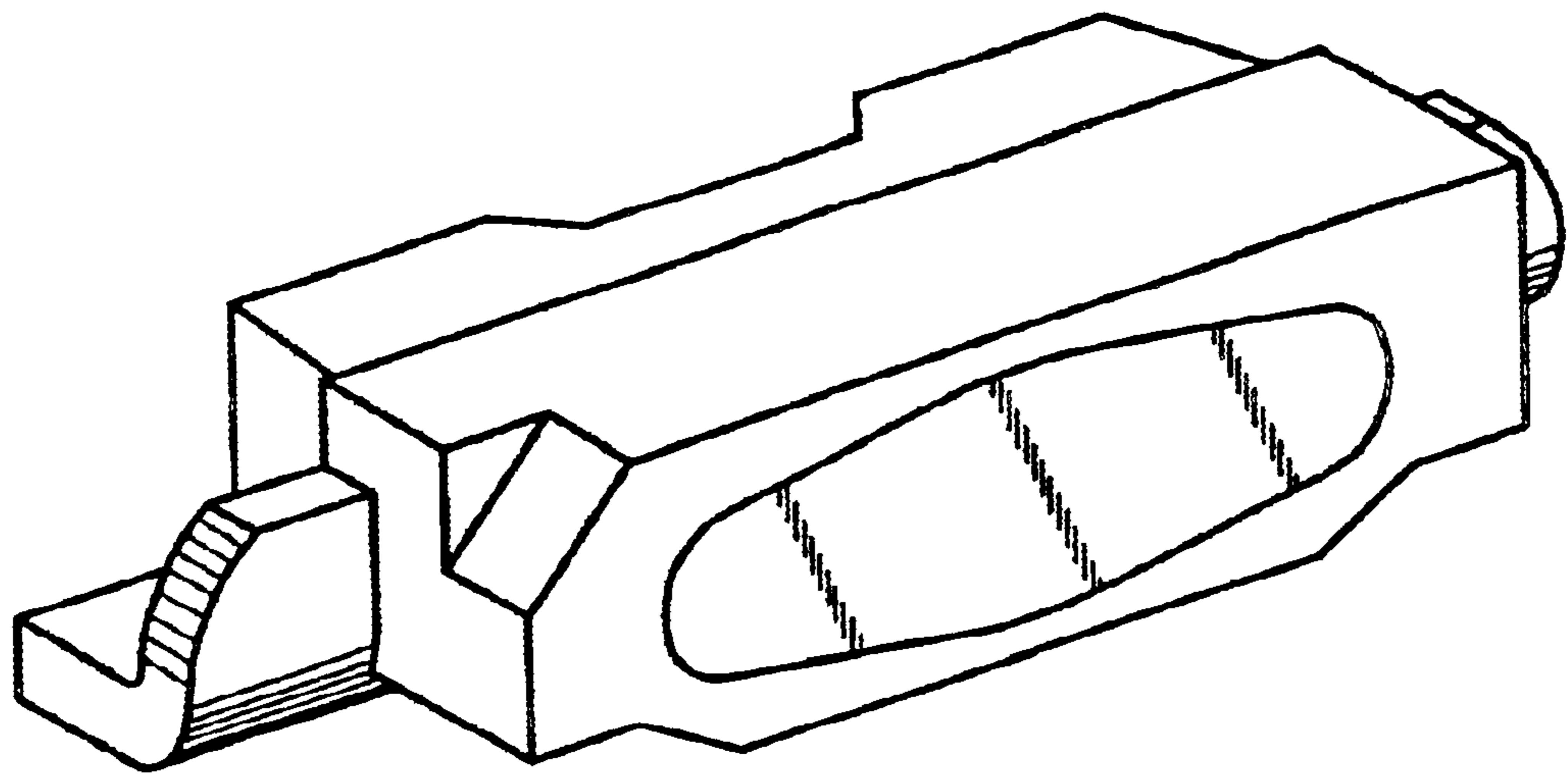

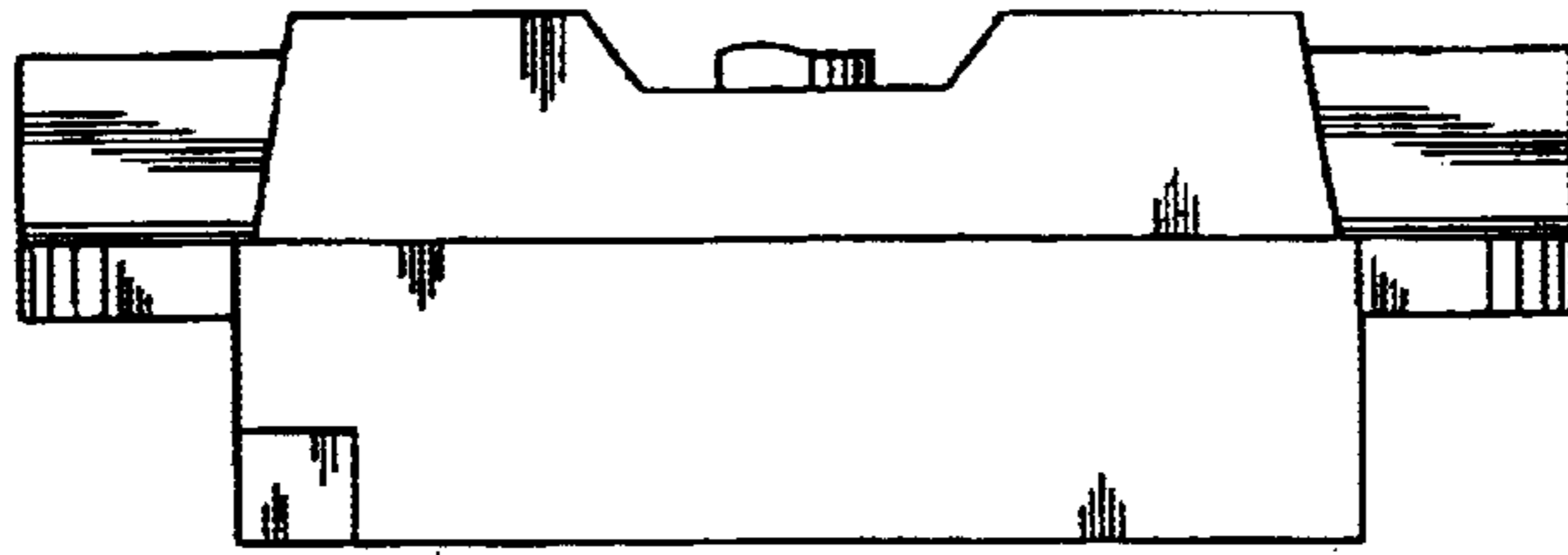

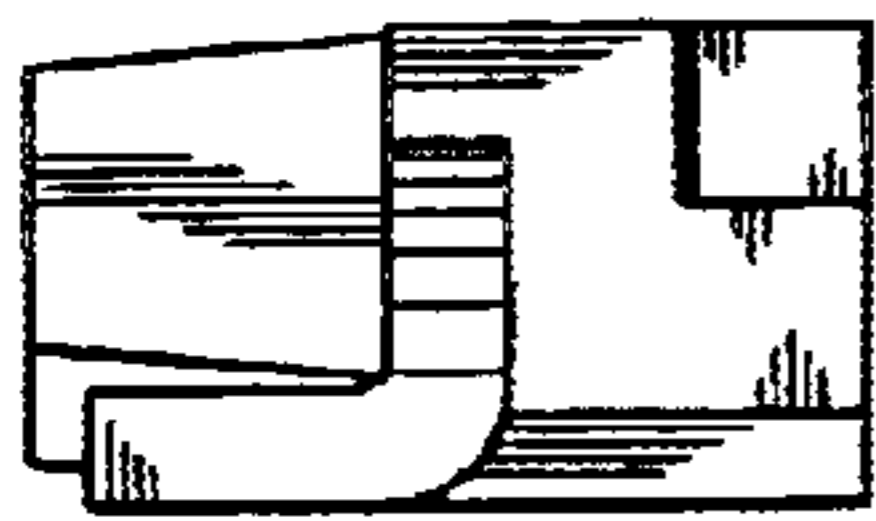

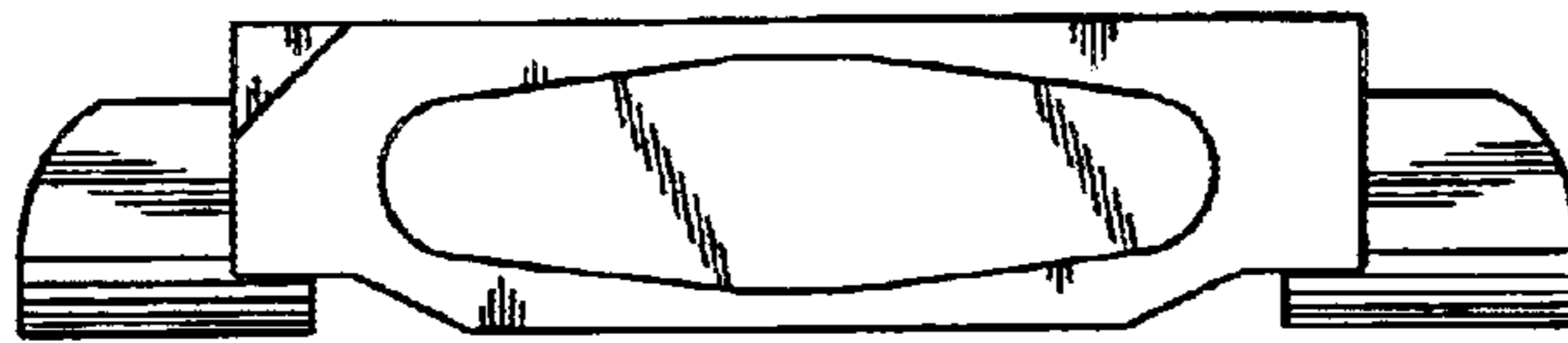

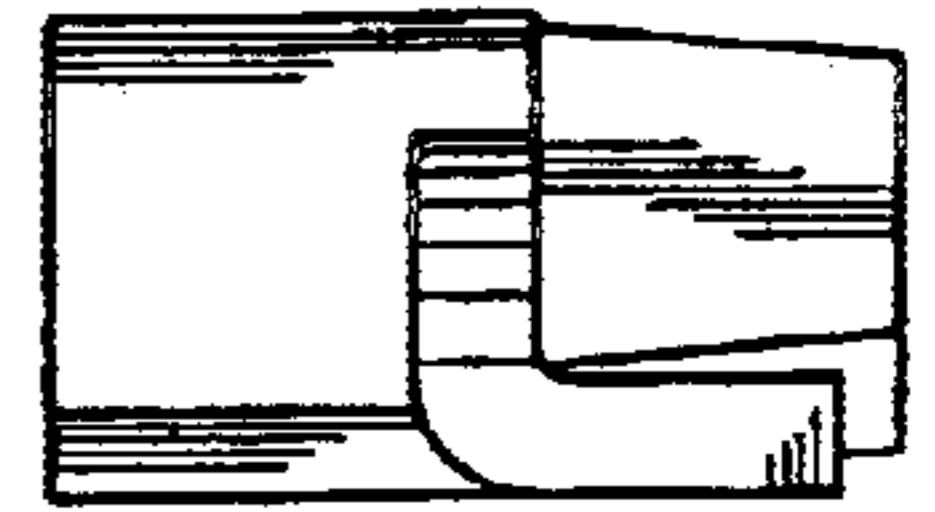

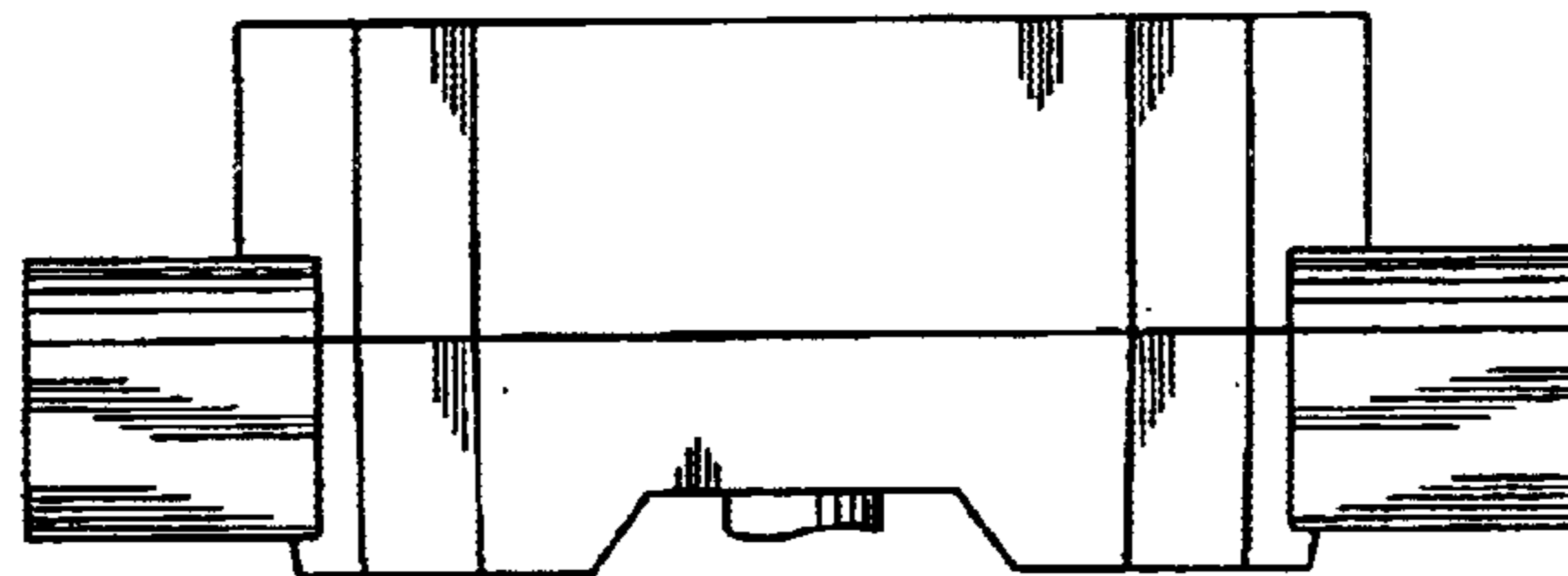

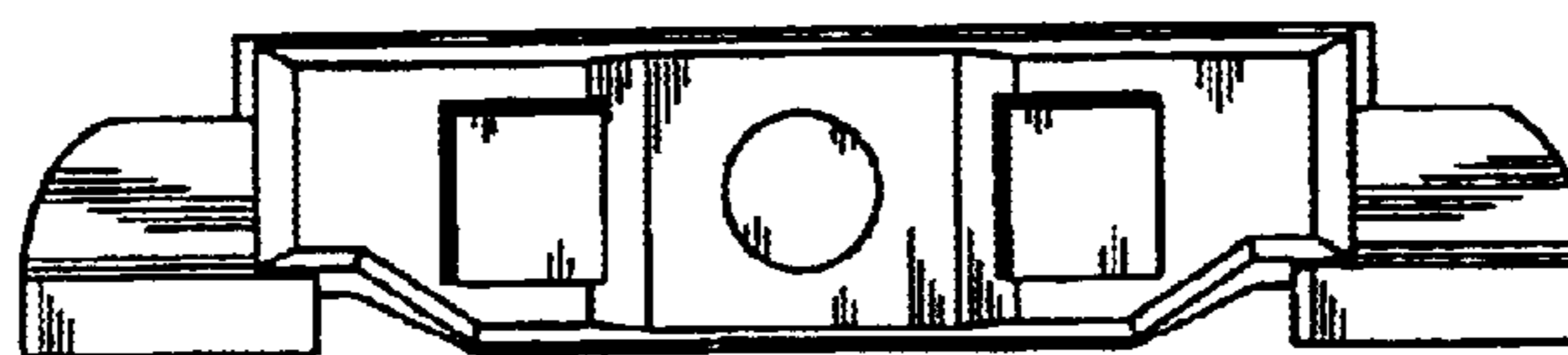

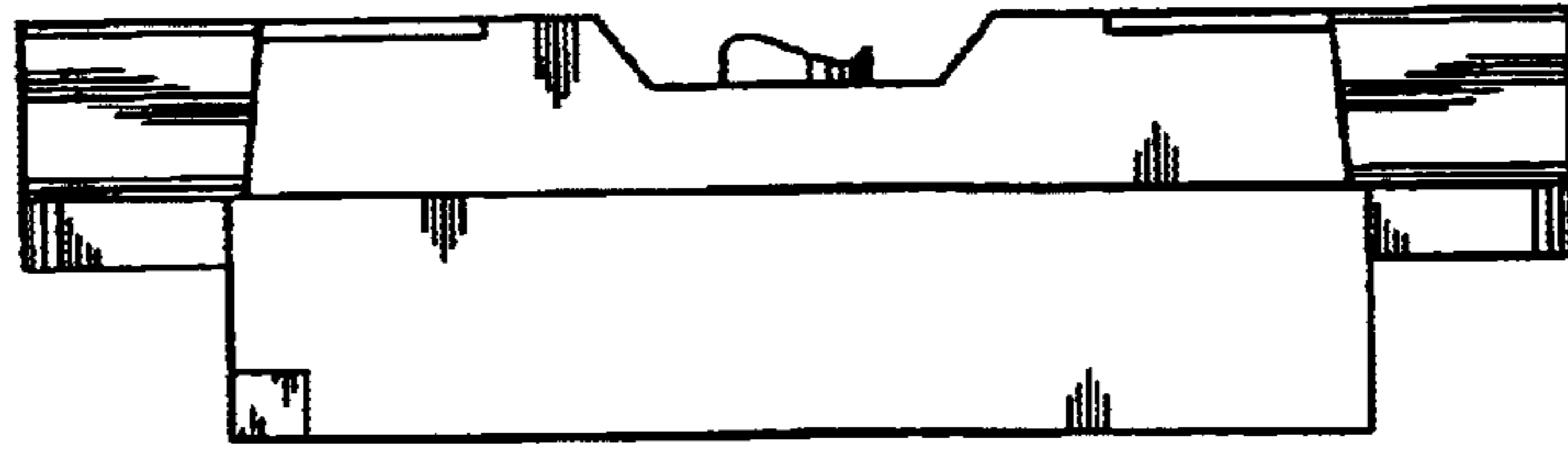

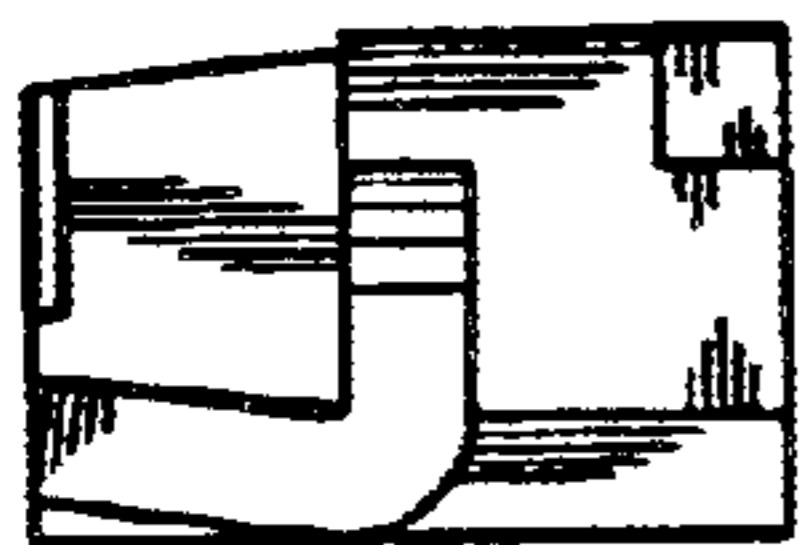

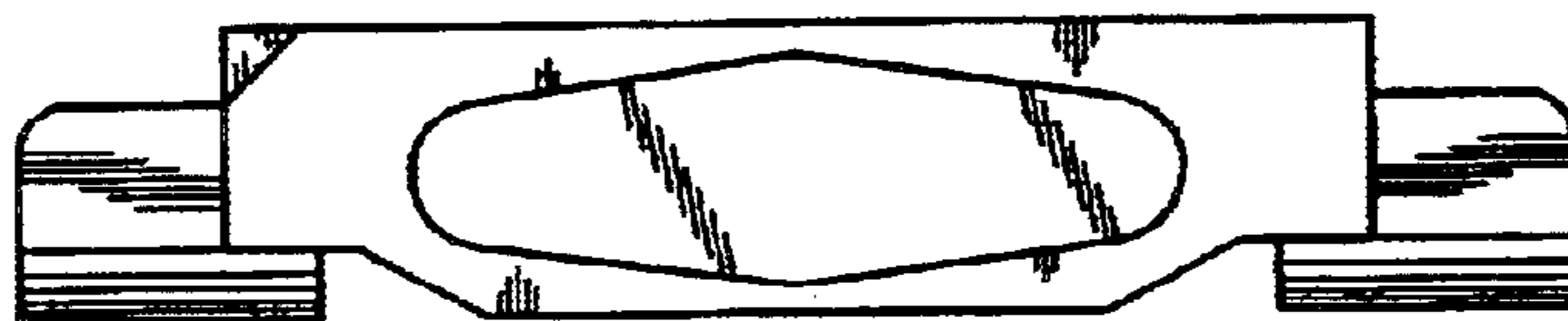

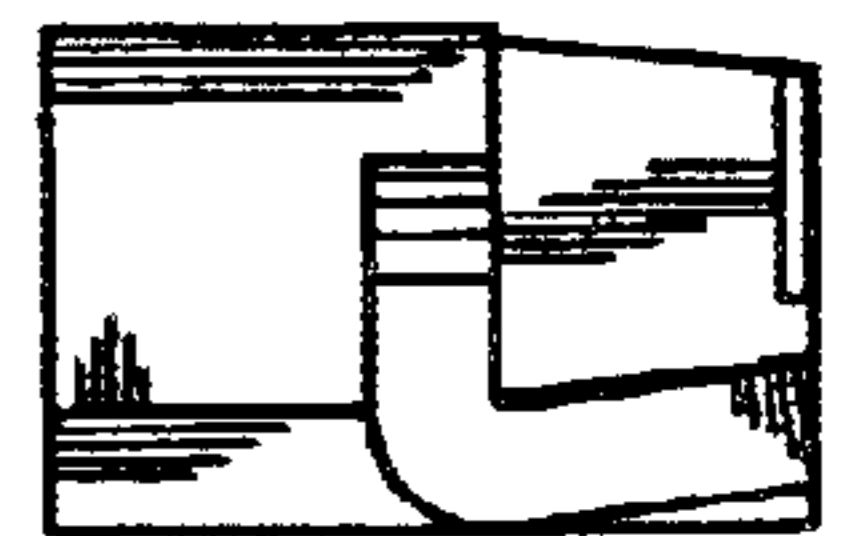

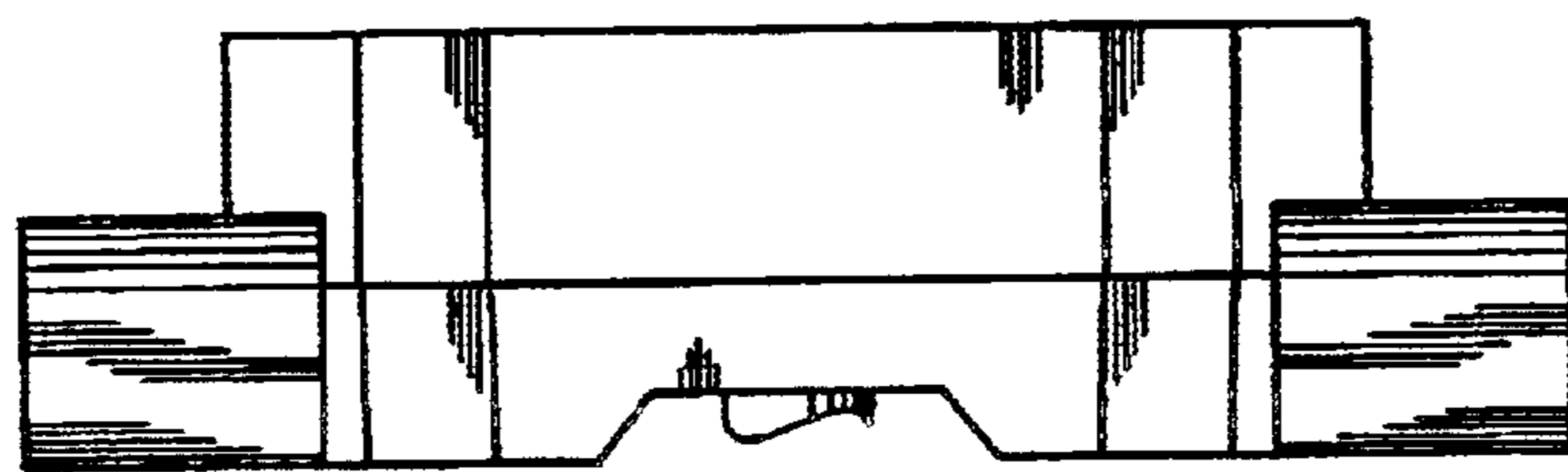

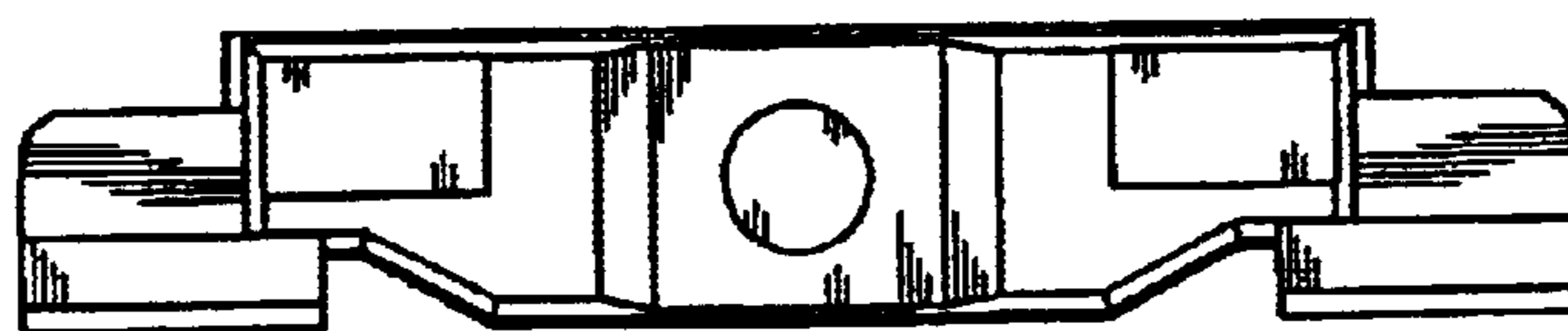
