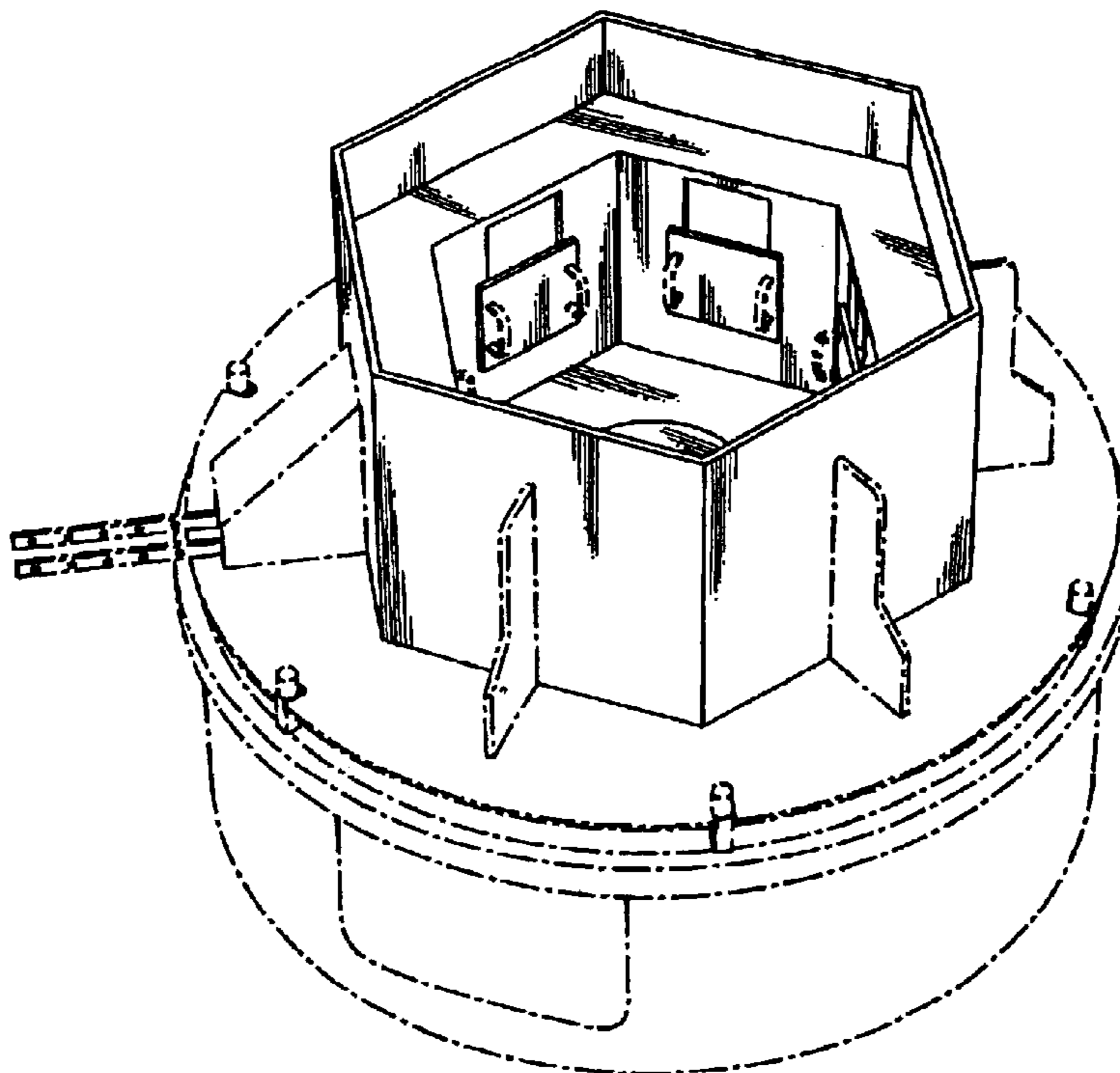
(57) **CLAIM**

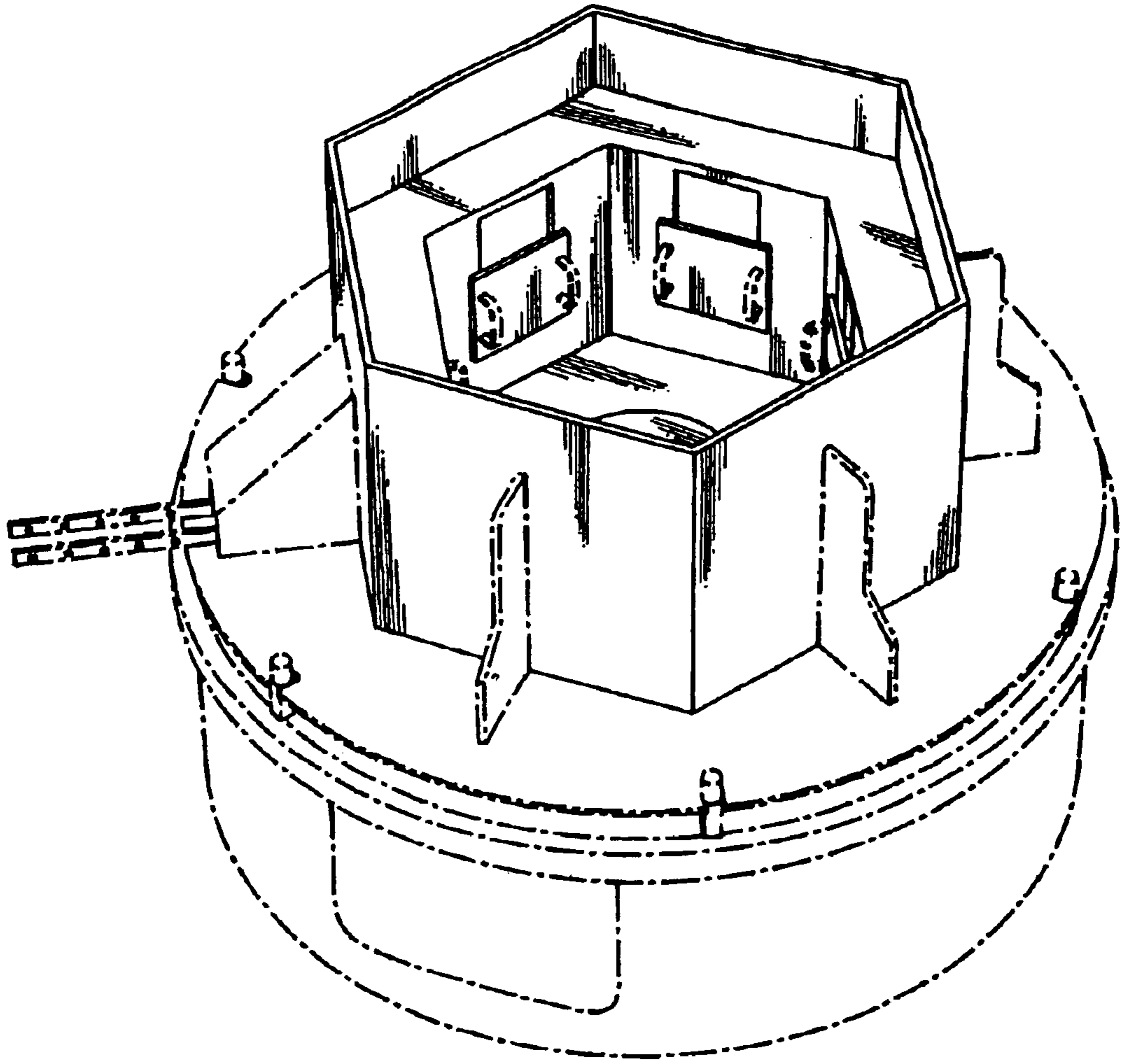
The ornamental design for an inlet for crusher, as shown and described.

DESCRIPTION

FIG. 1.1 is a front perspective view of an inlet for crusher according to the new design; FIG. 1.2 is a rear elevational view; FIG. 1.3 is a bottom plan view; FIG. 1.4 is a left side elevational view; FIG. 1.5 is a top plan view; FIG. 1.6 is a right side elevational view; and, FIG. 1.7 is a front elevational view.

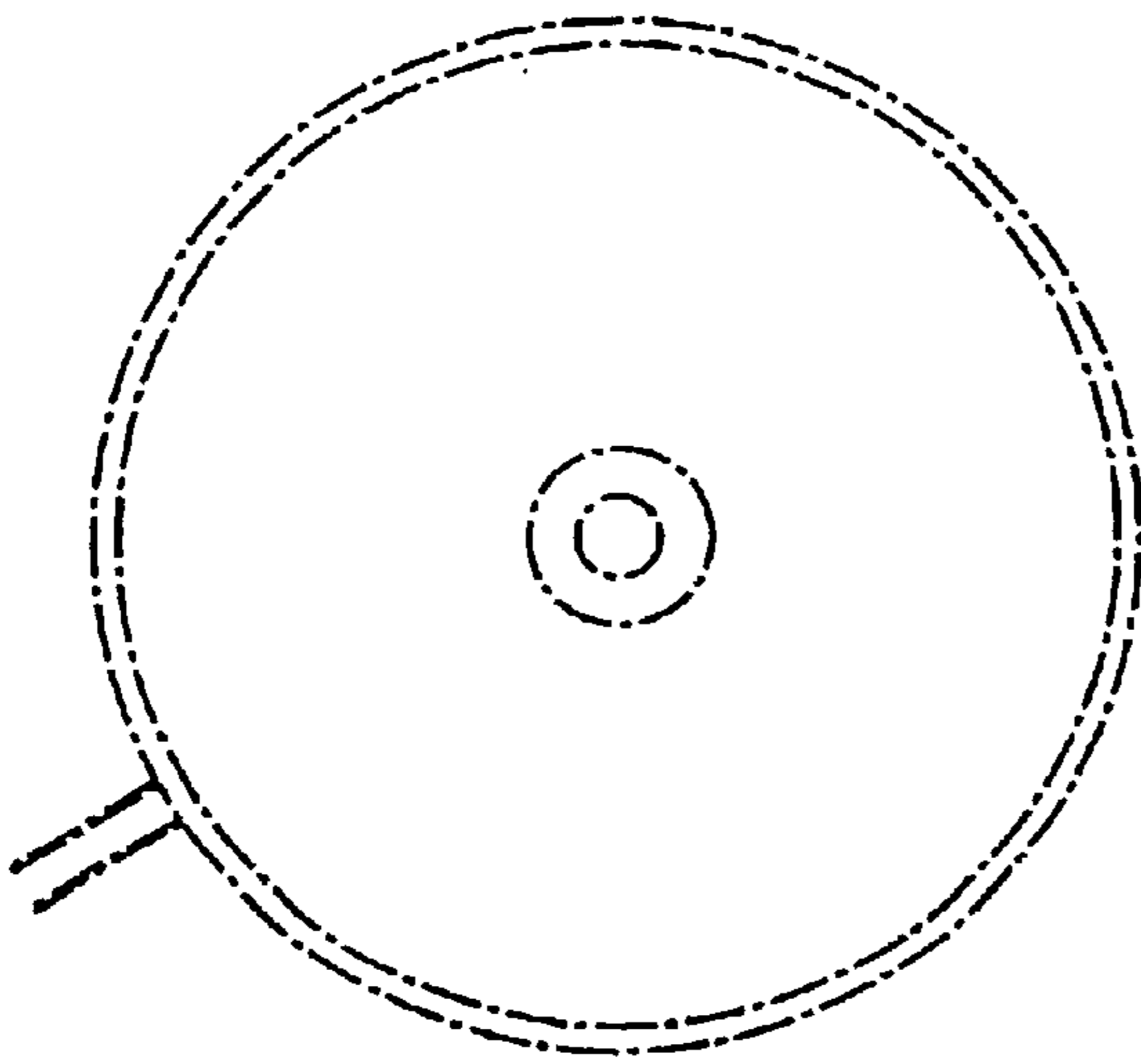




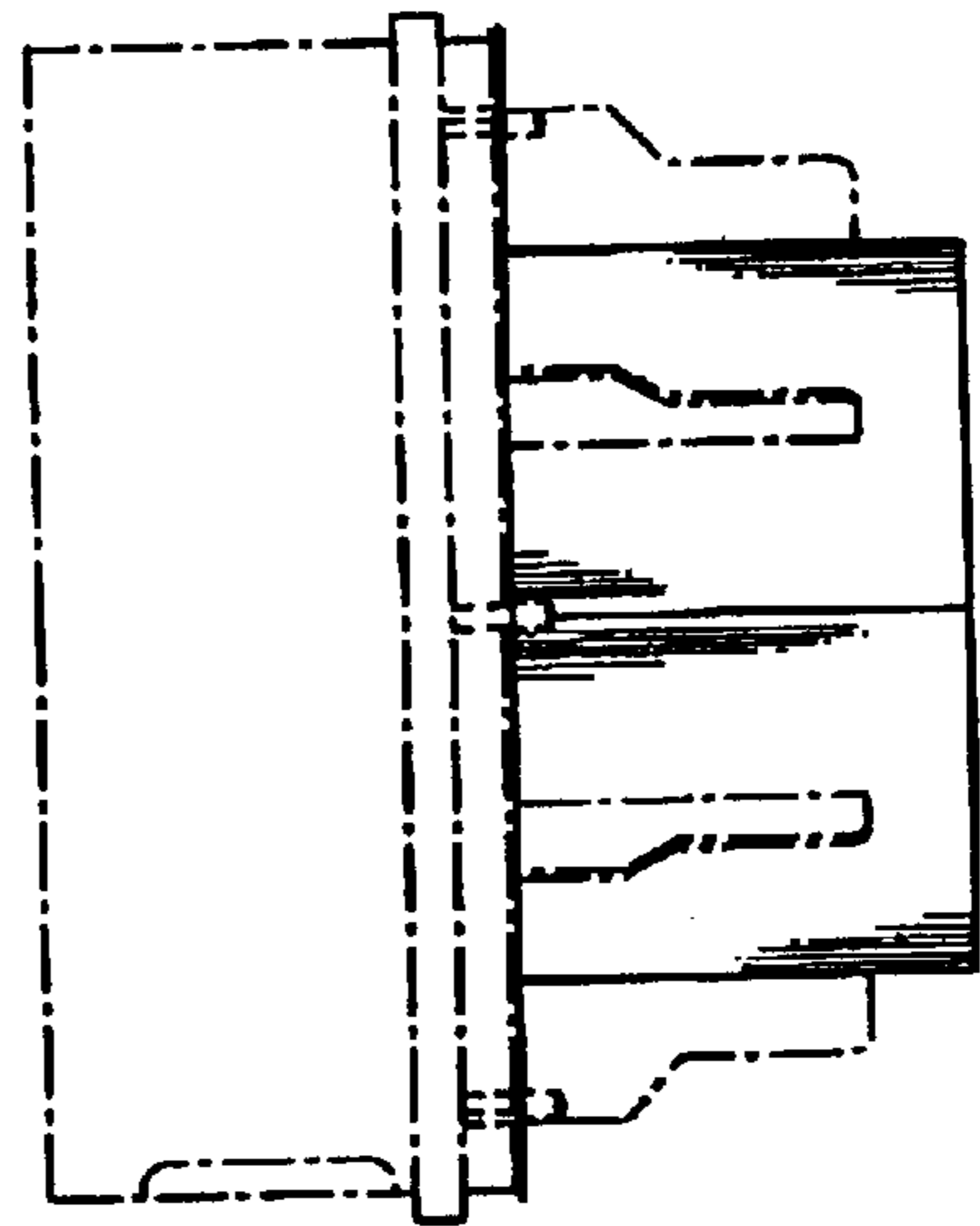

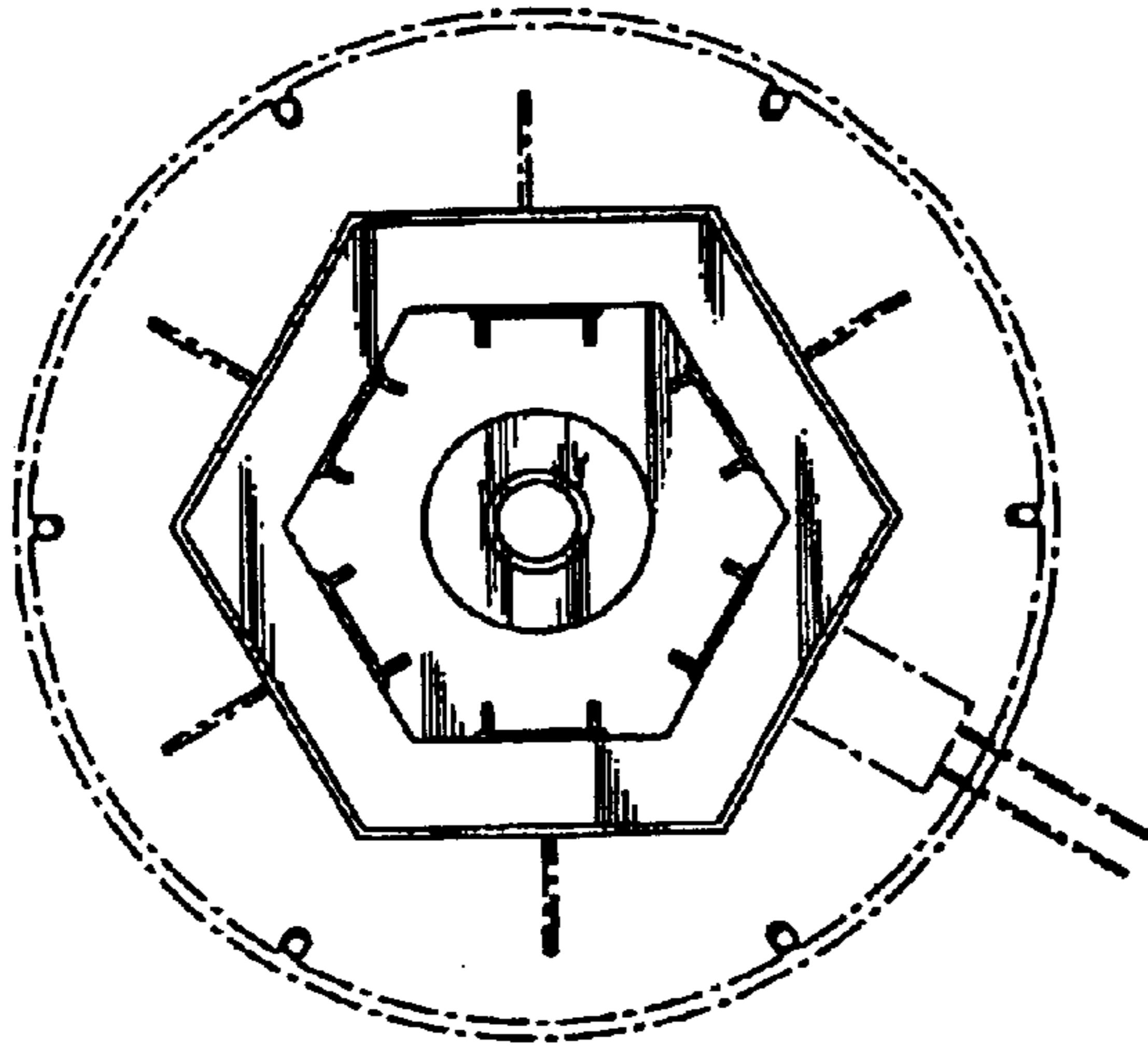

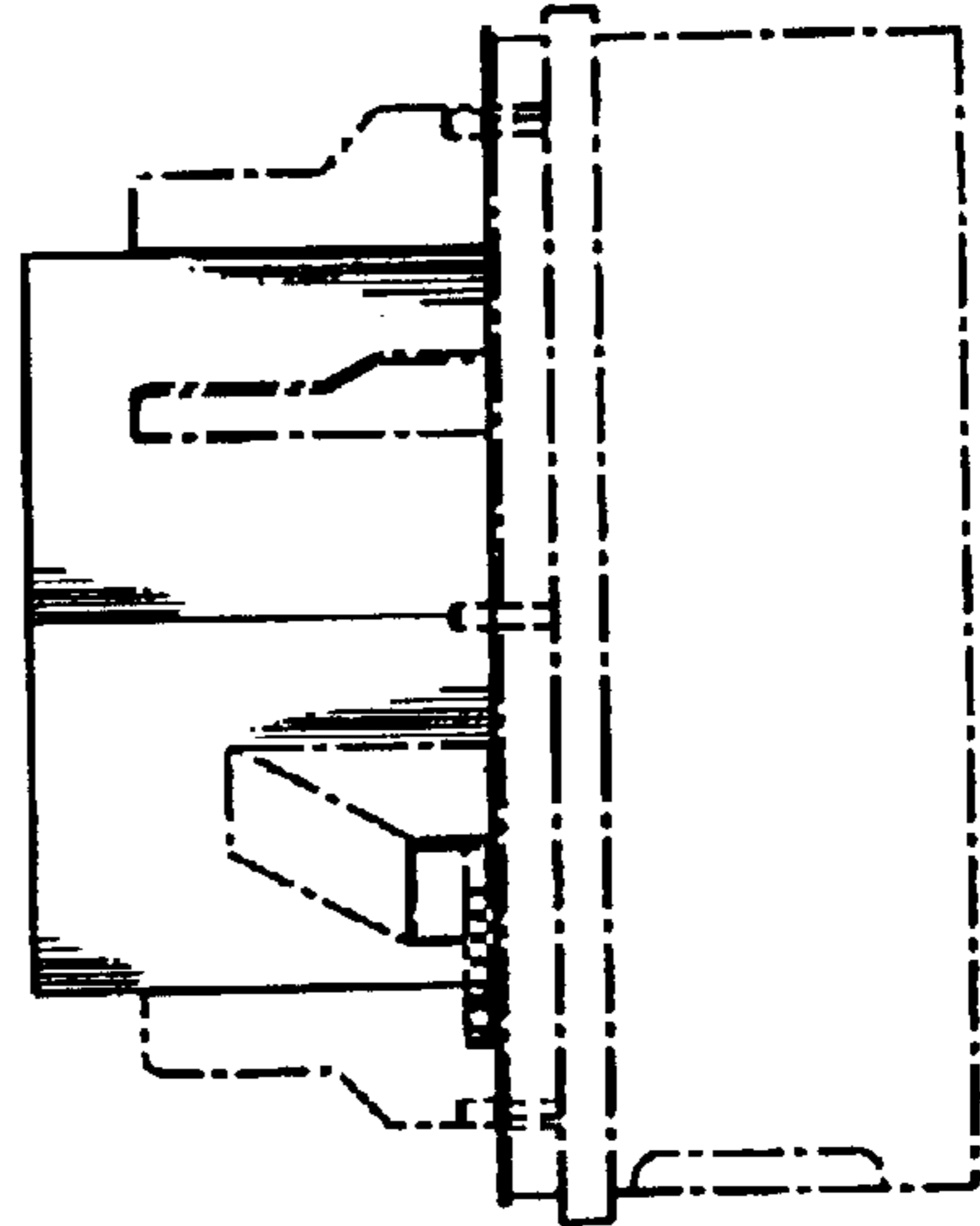

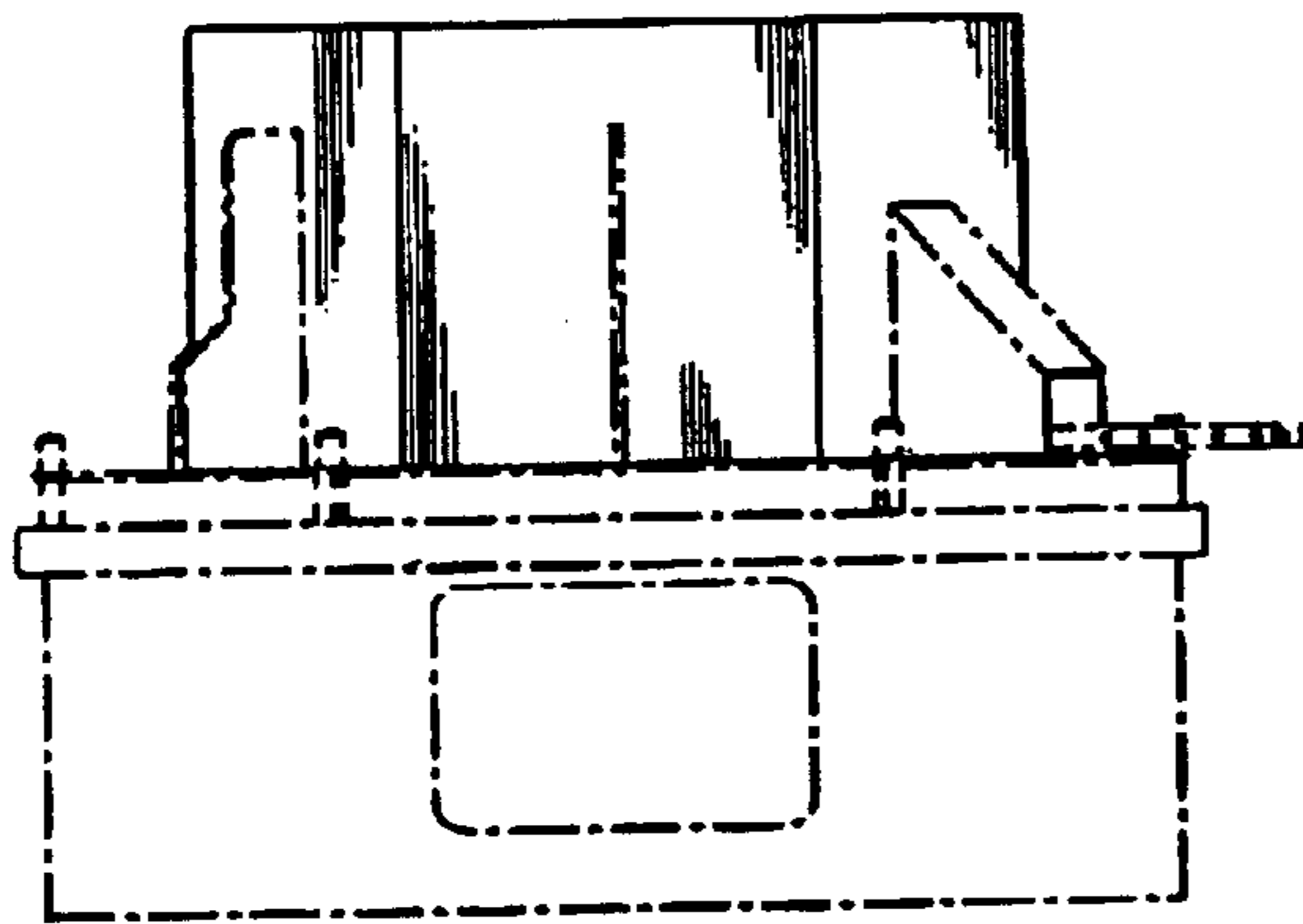
