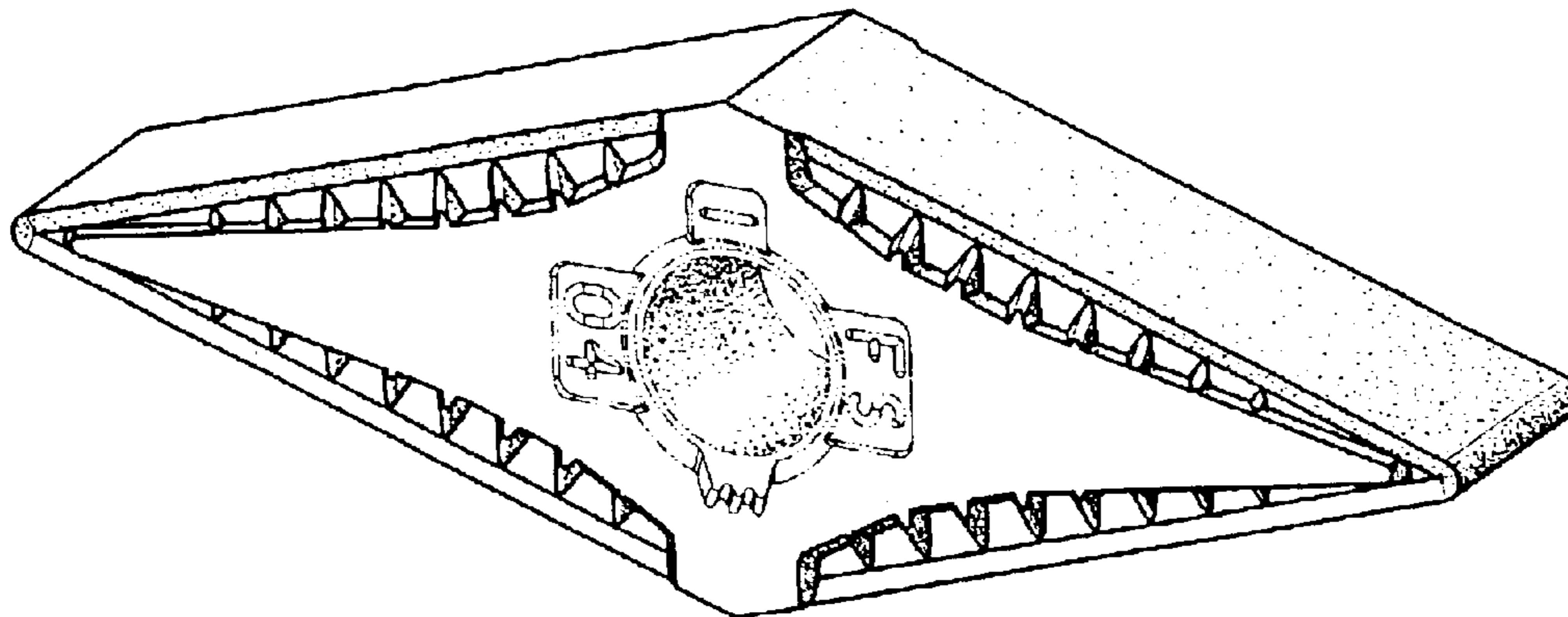
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a front, perspective view of a cutting insert showing our new design;  
FIG. 2 is a rear, perspective view of the cutting insert of FIG. 1;  
FIG. 3 is a top view of the cutting insert of FIG. 1;  
FIG. 4 is a bottom view of the cutting insert of FIG. 1;  
FIG. 5 is a left side view of the cutting insert of FIG. 1;

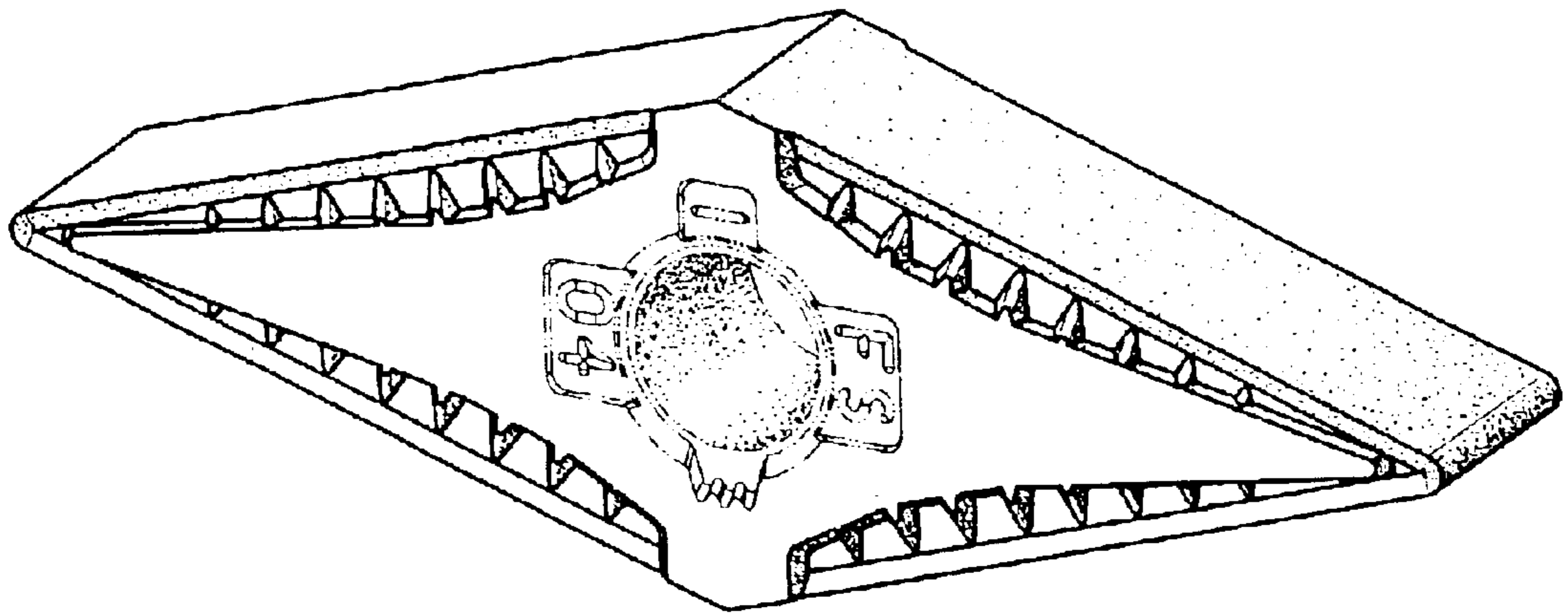

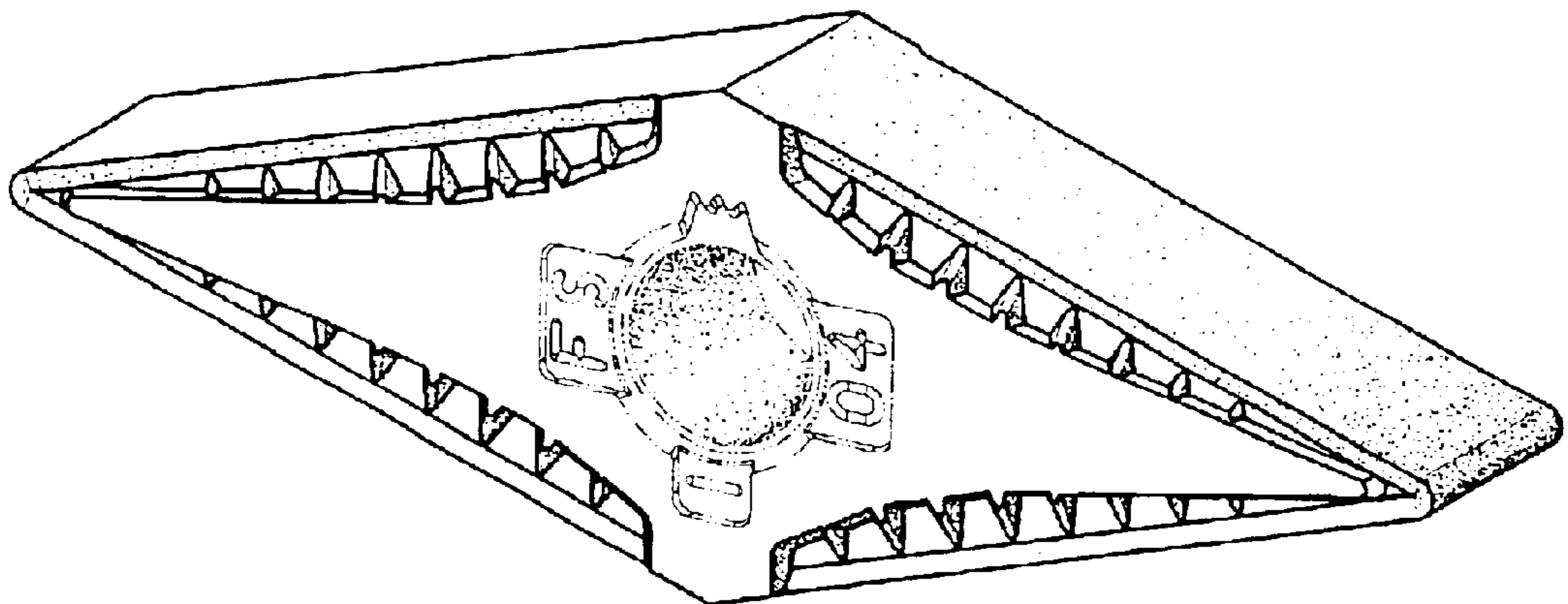

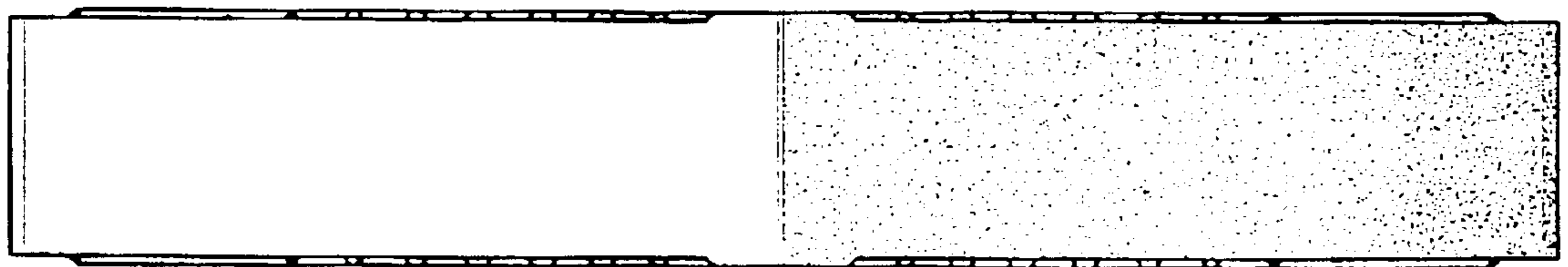

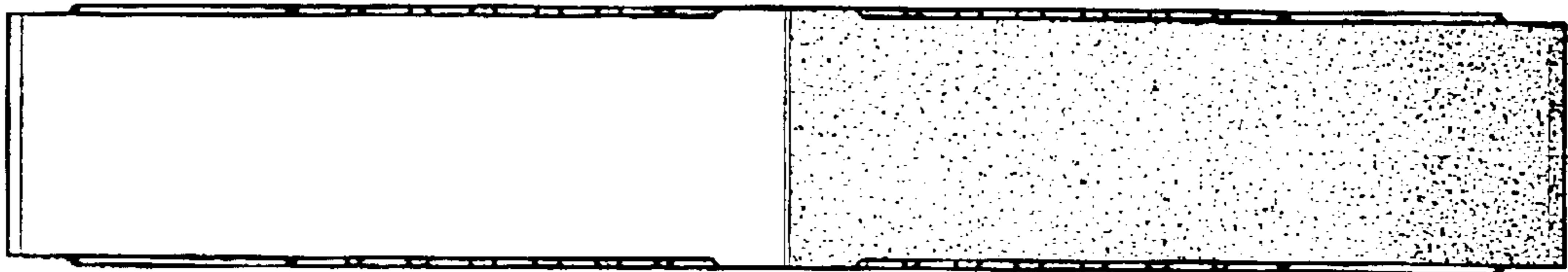

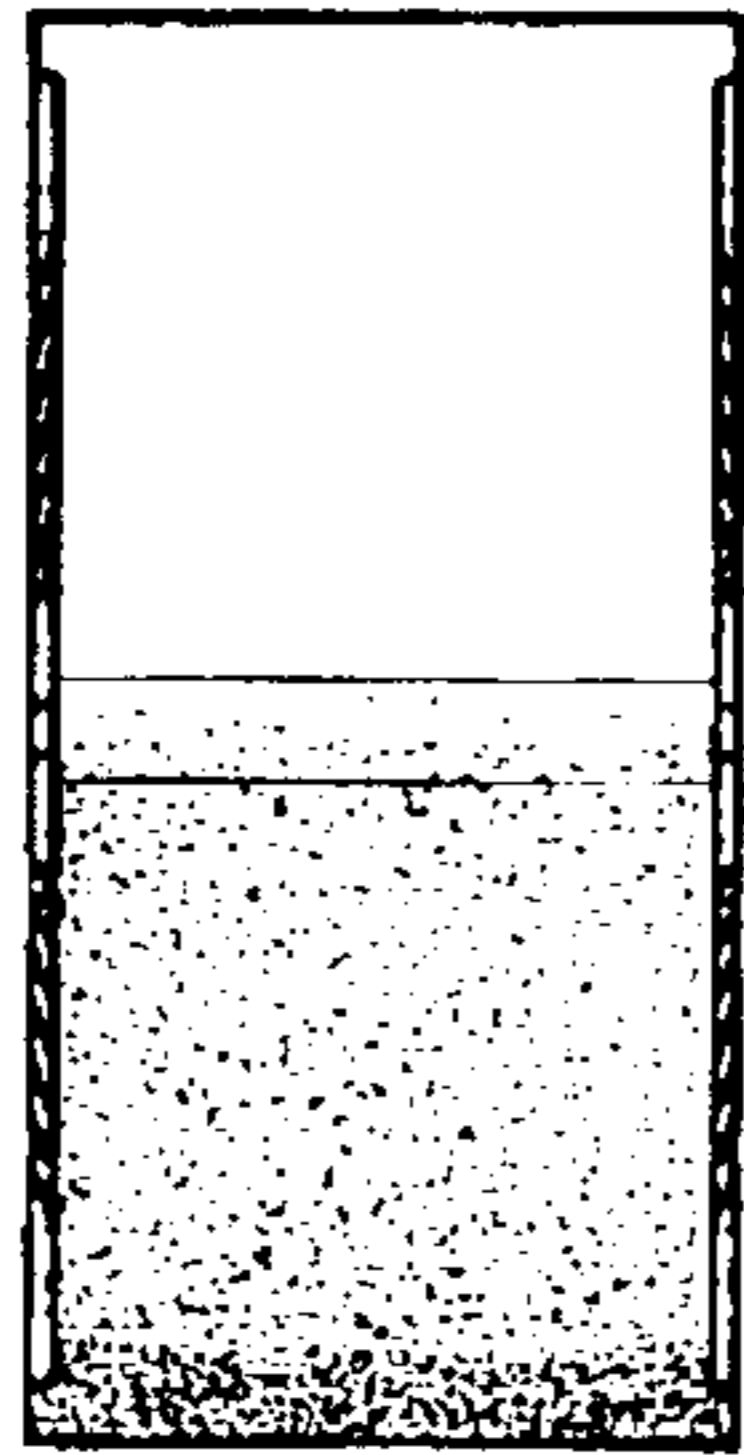

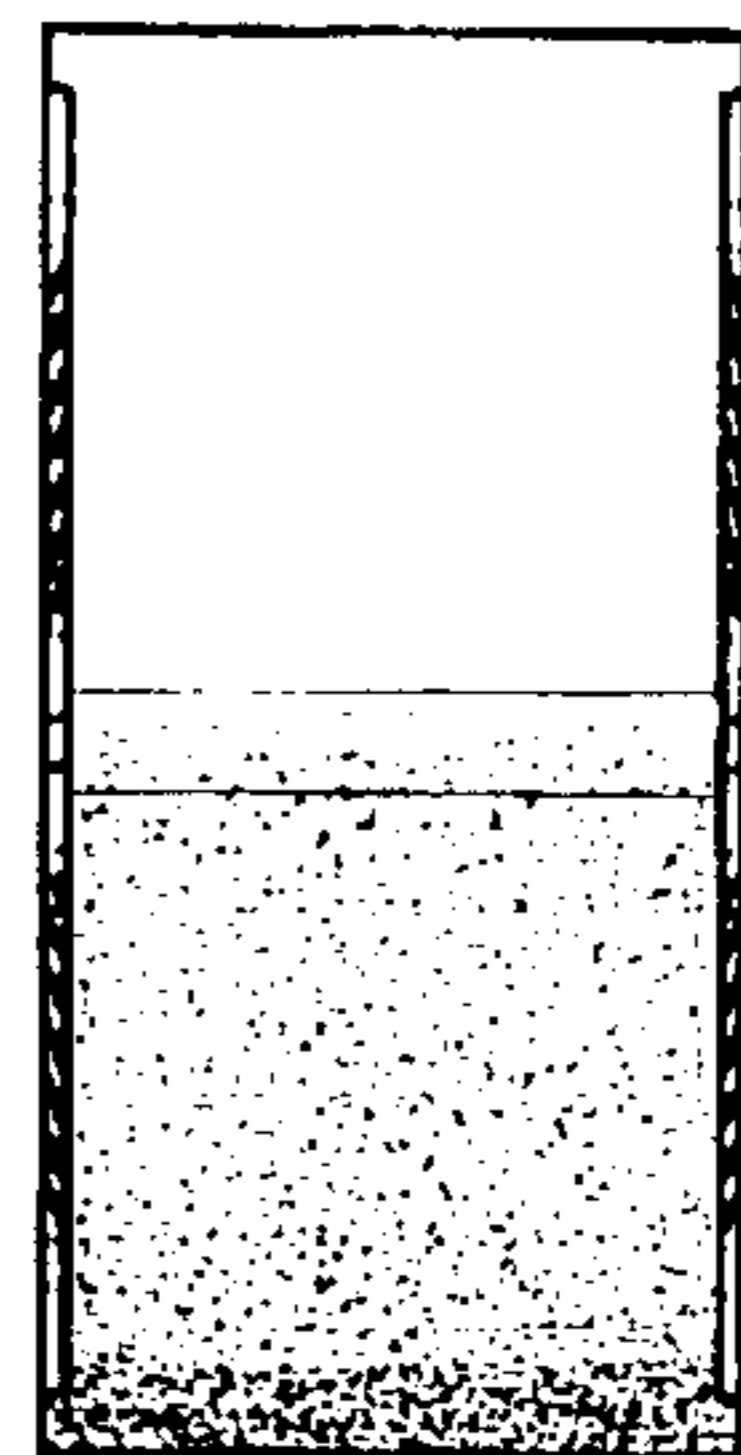

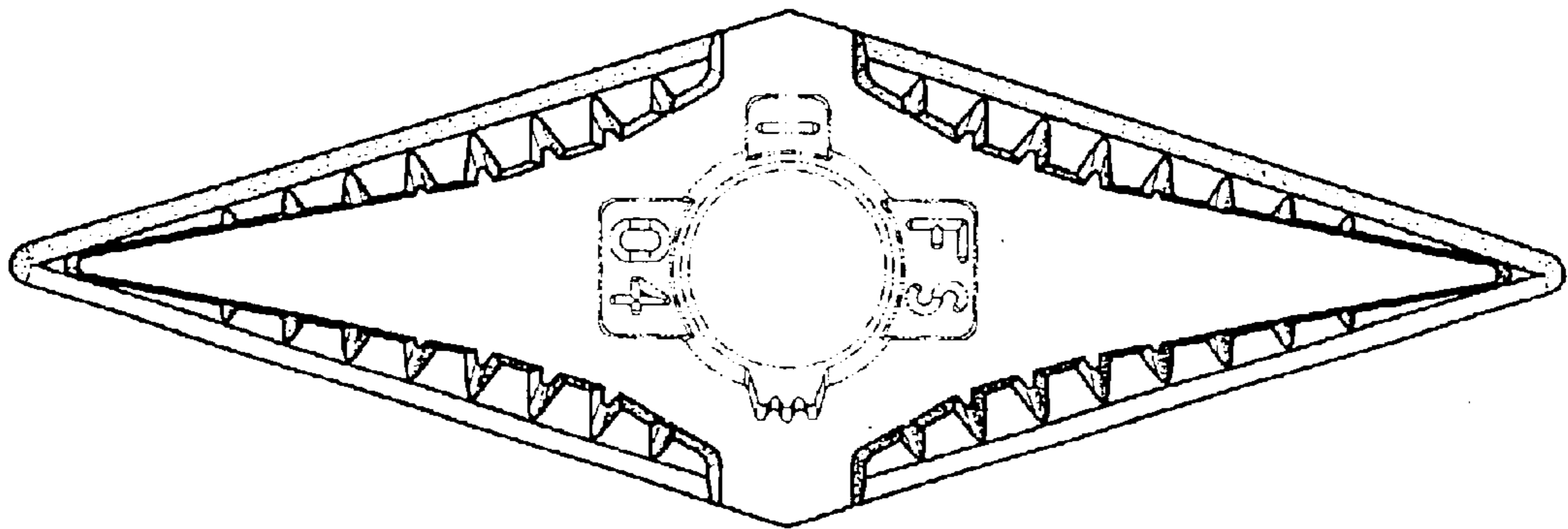

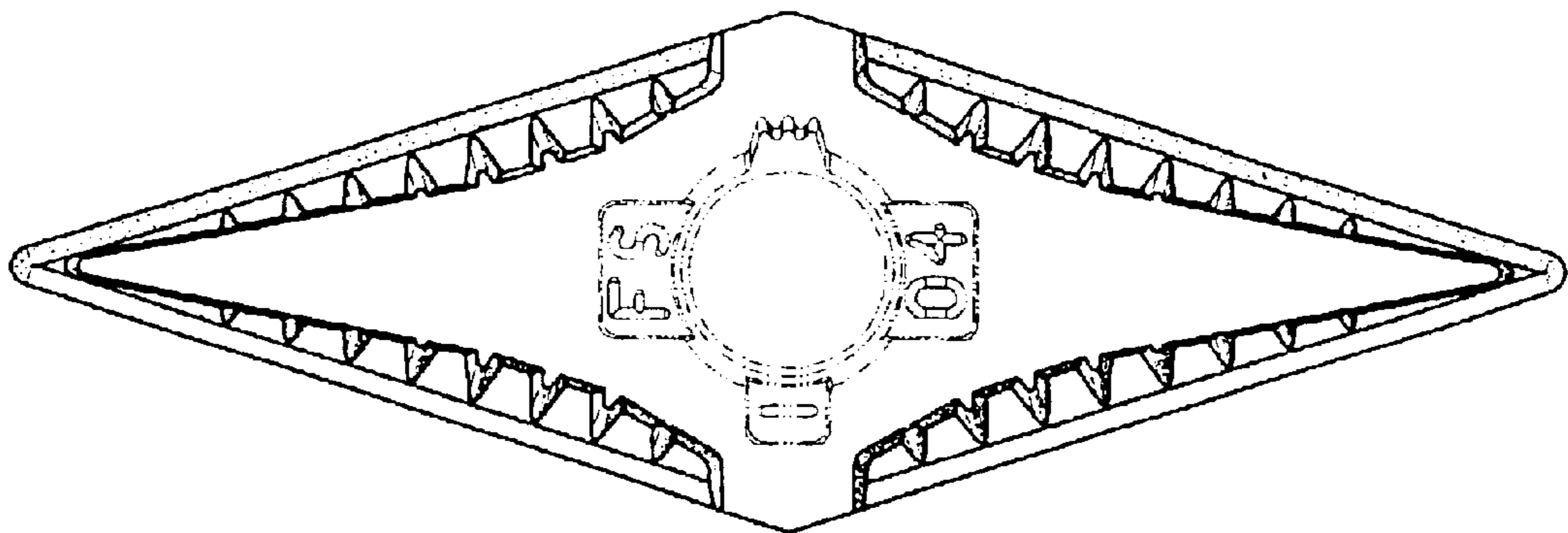
