**DESCRIPTION**

FIG. 7 is a bottom plan view thereof;

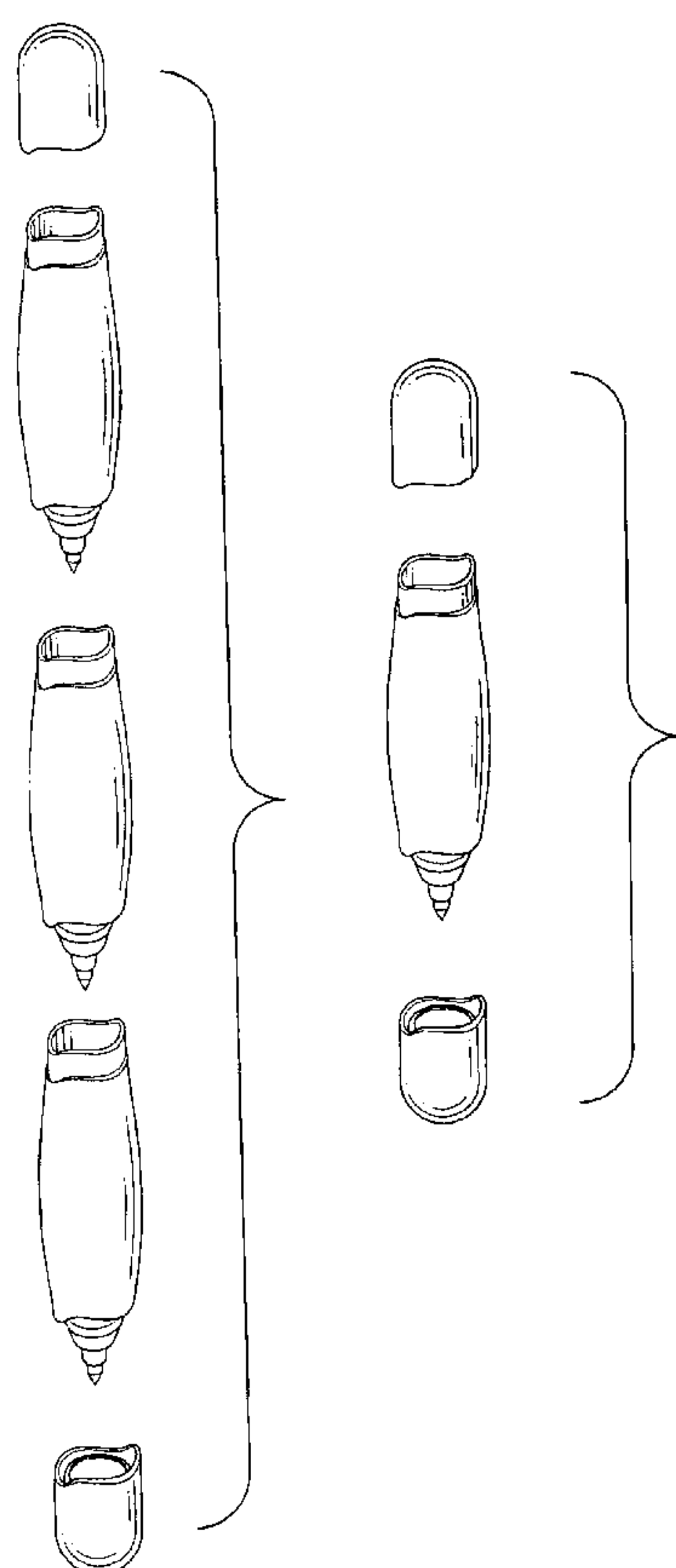
FIG. 8 is a perspective view of FIG. 1 in an exploded condition;

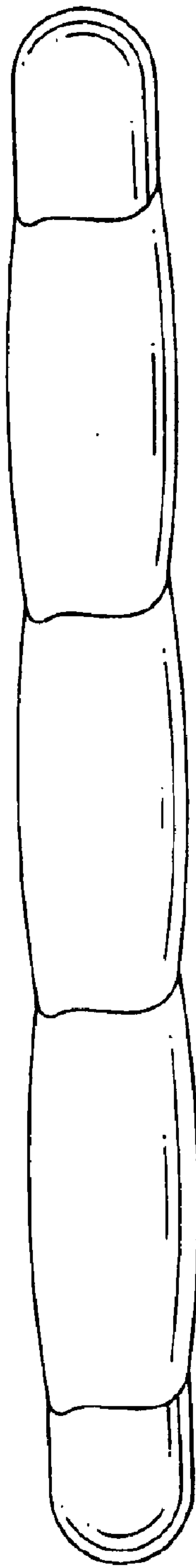

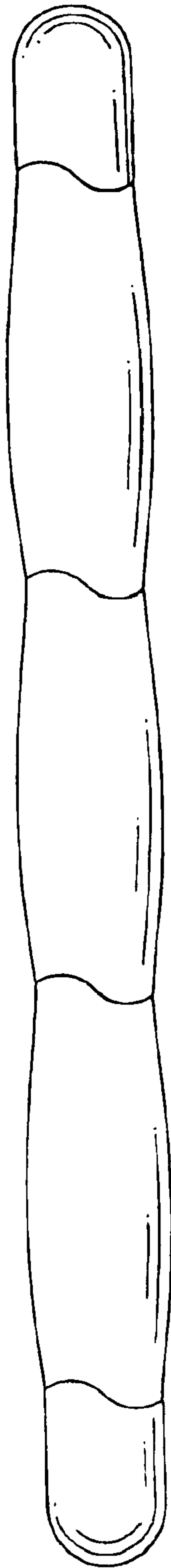

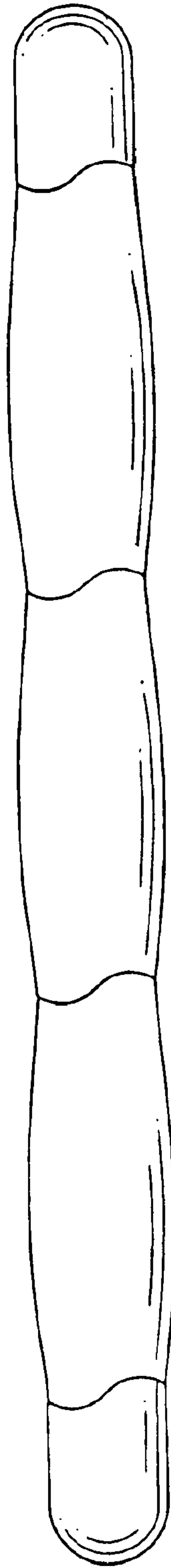

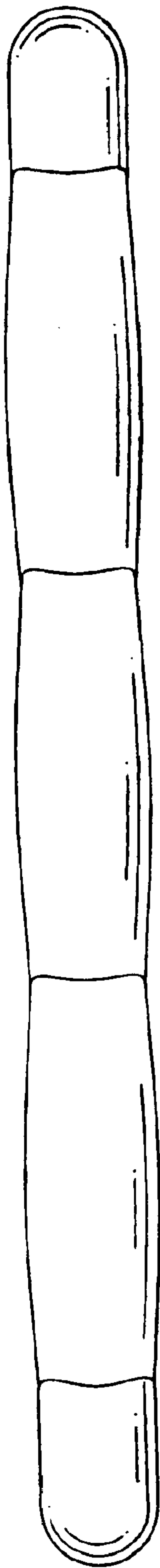

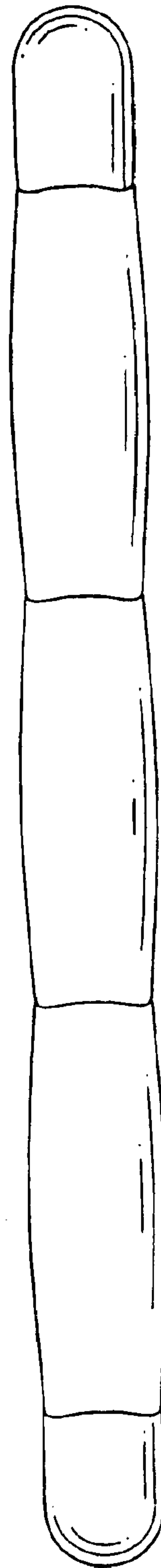

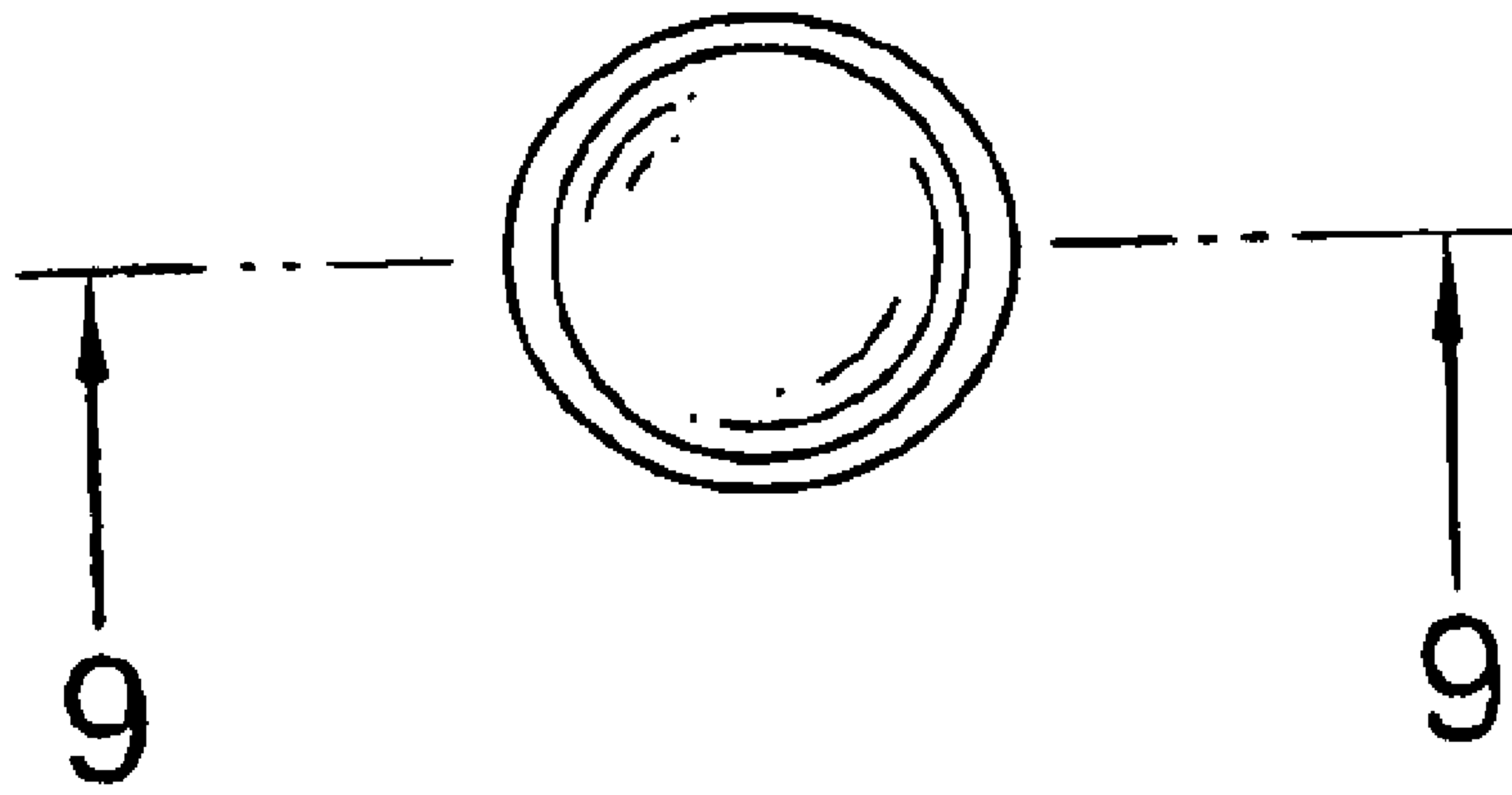

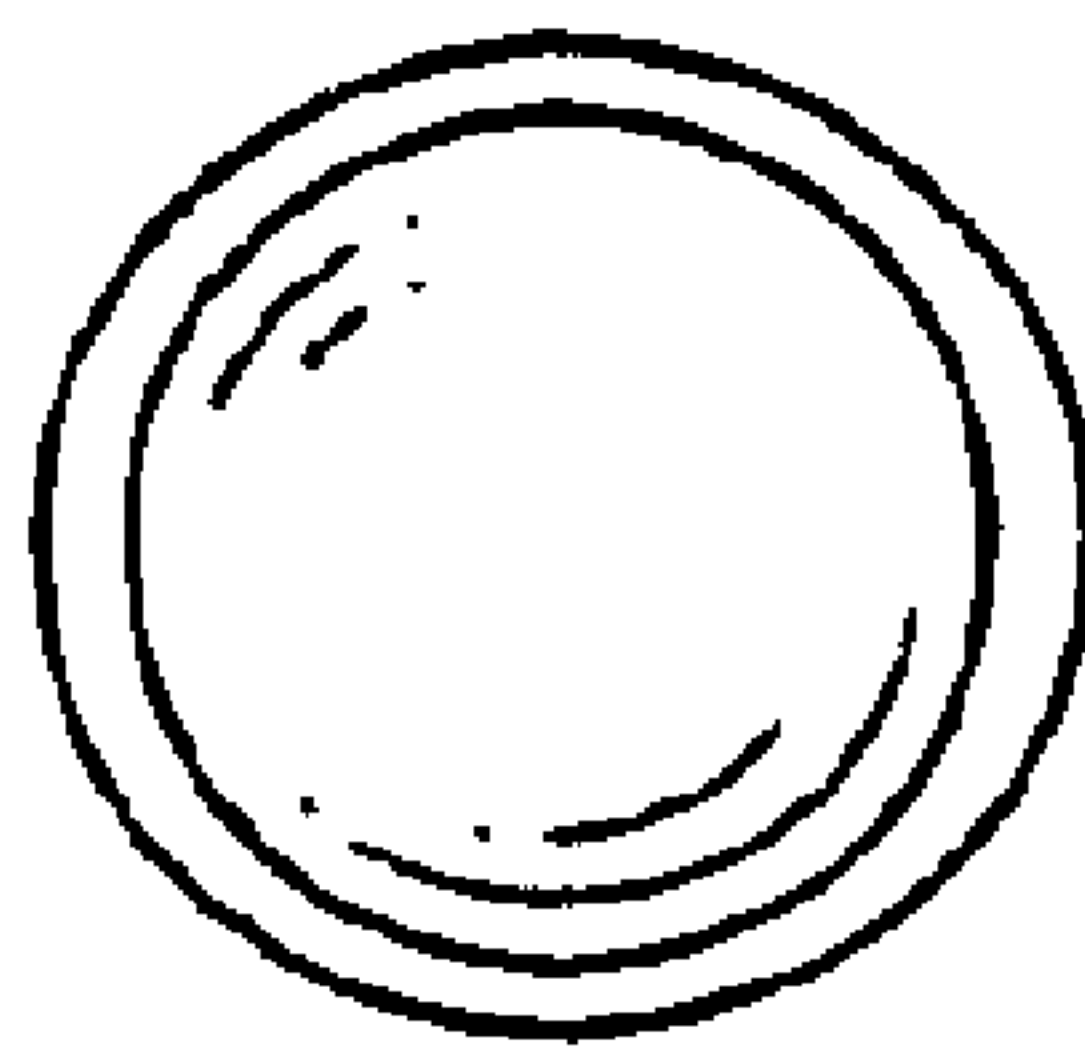

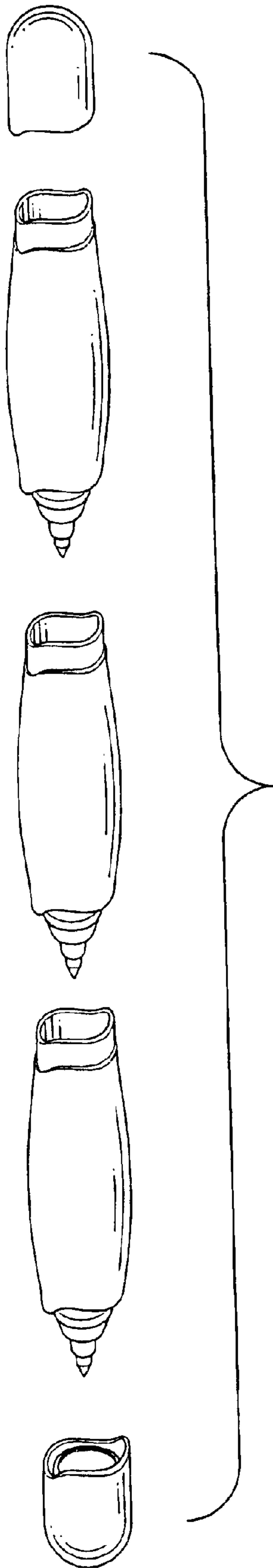

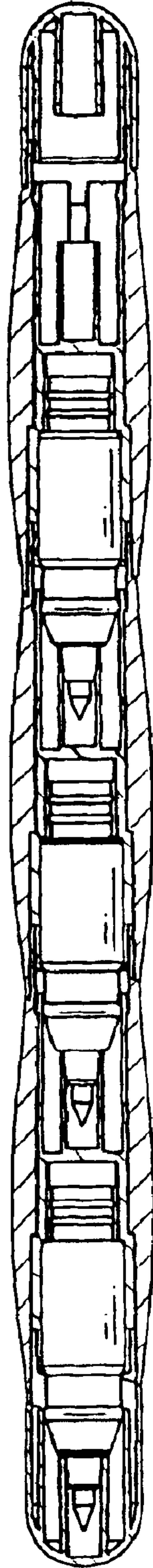

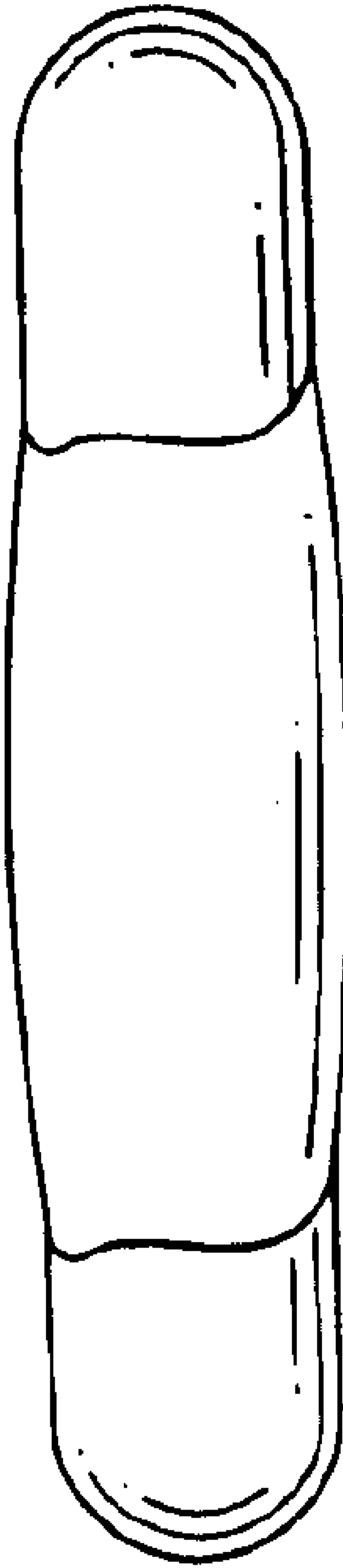

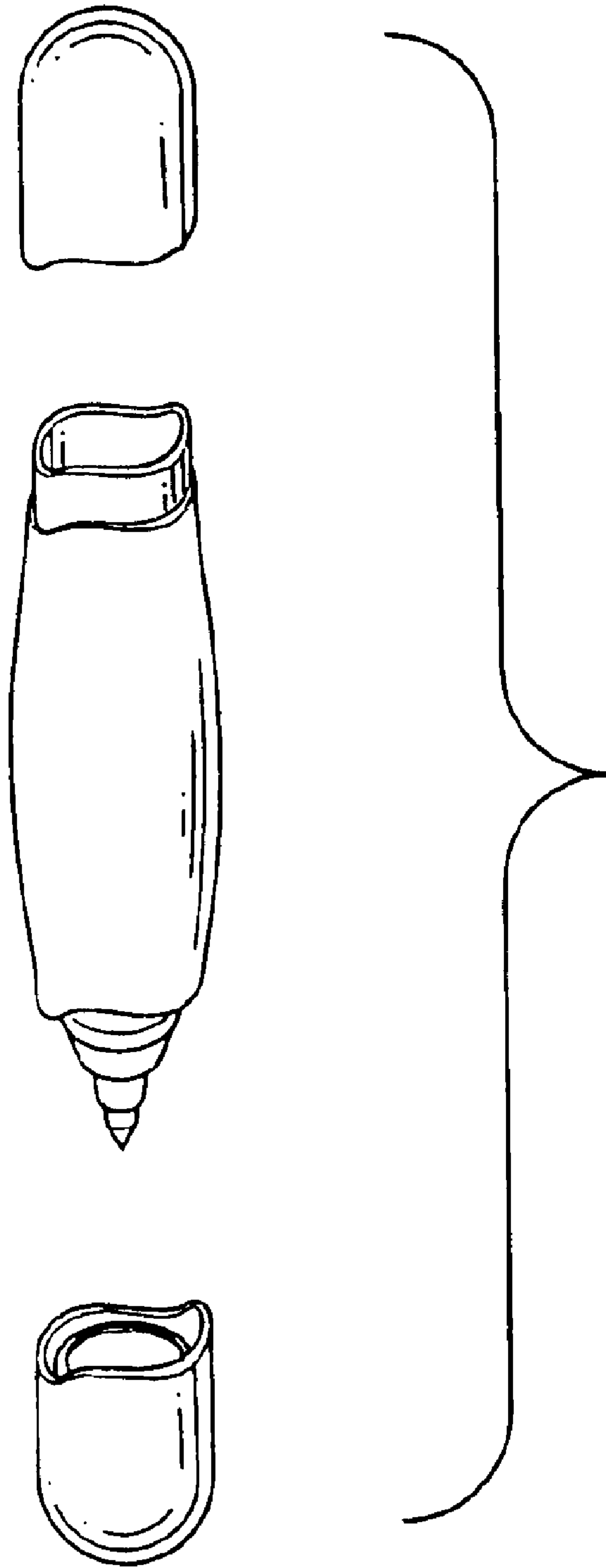
