The ornamental design for a “paint brush keeper”, as shown and described.

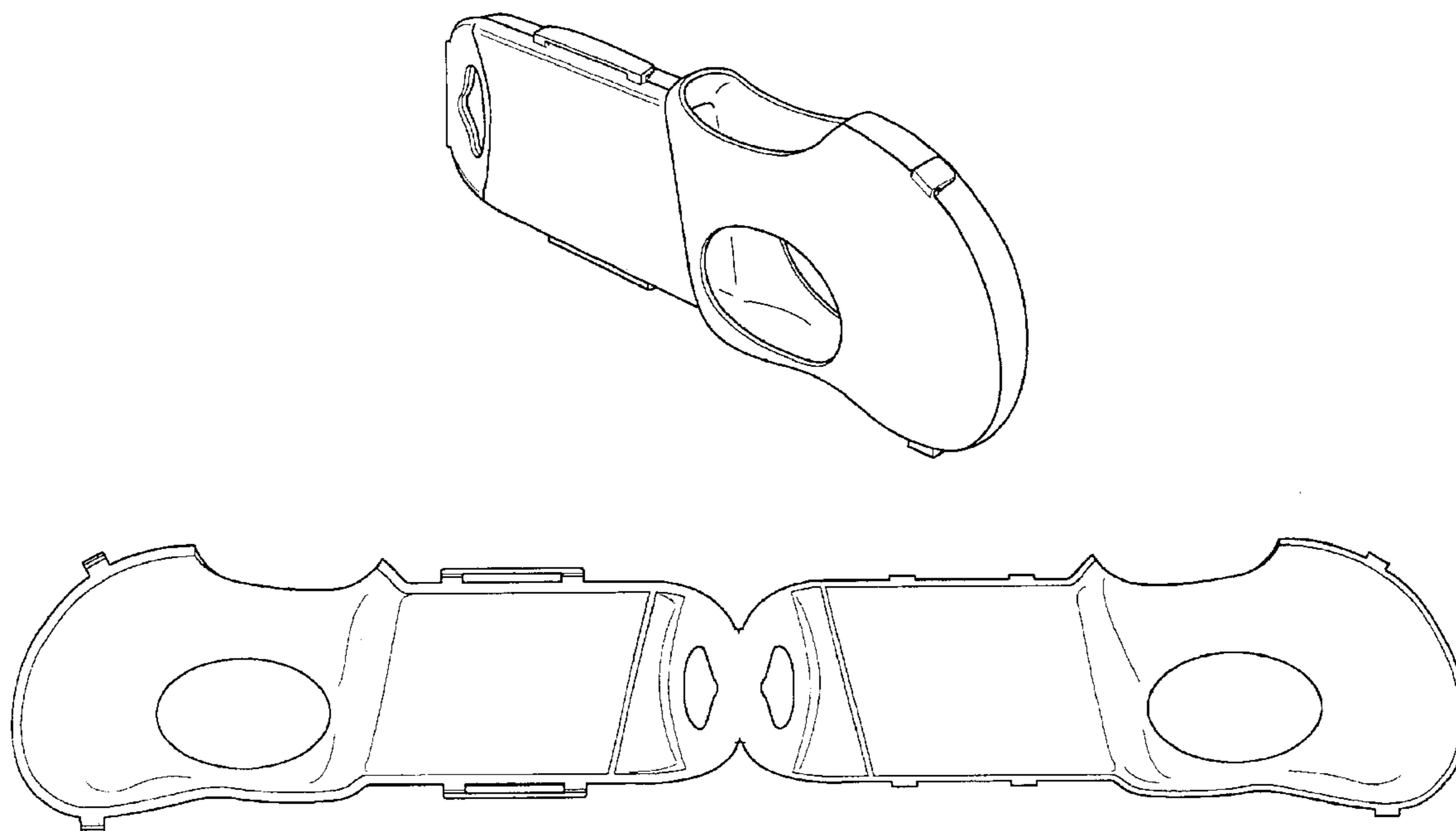
DESCRIPTION

FIG. 1 is a perspective view of a paint brush keeper showing my new design in a storage position;

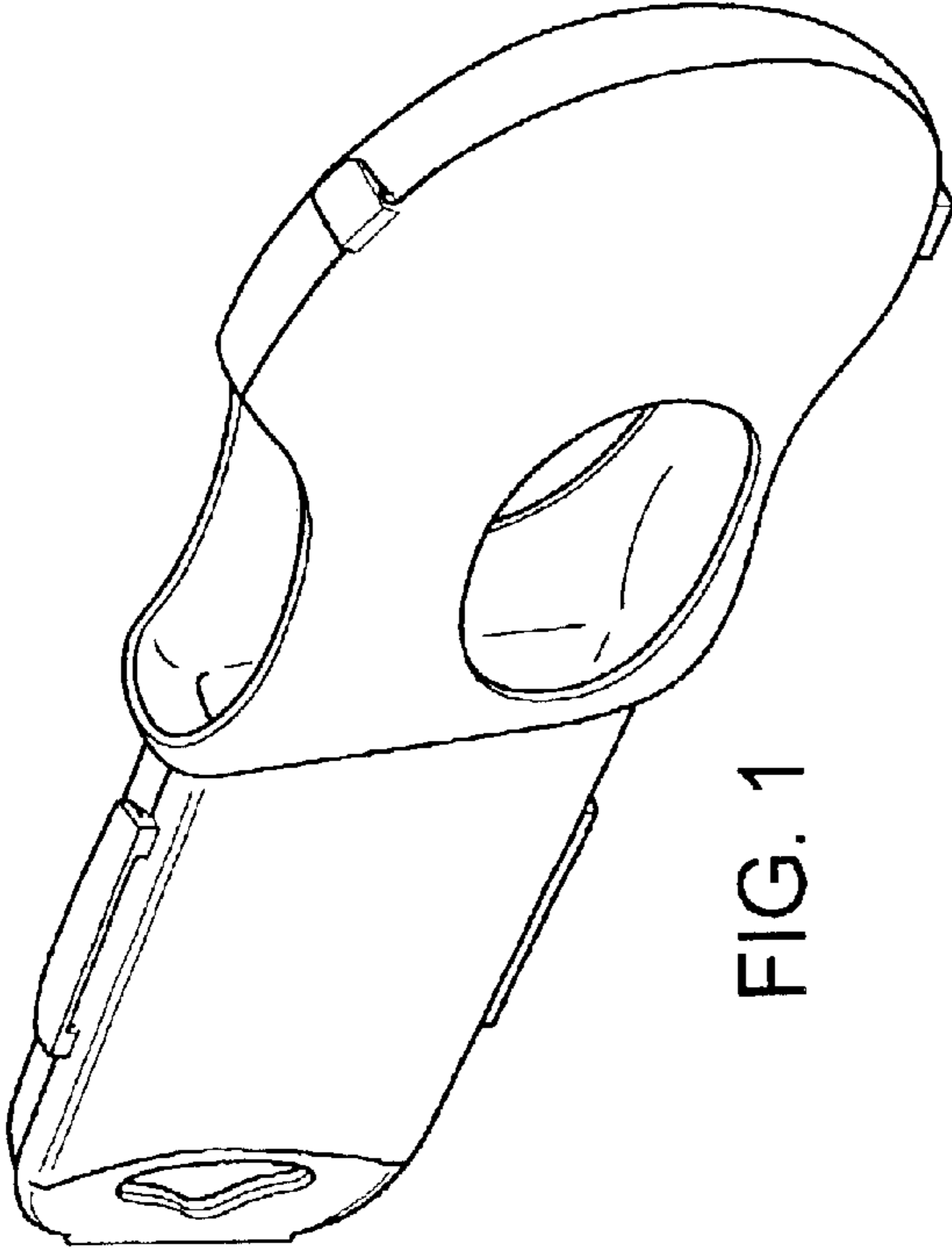

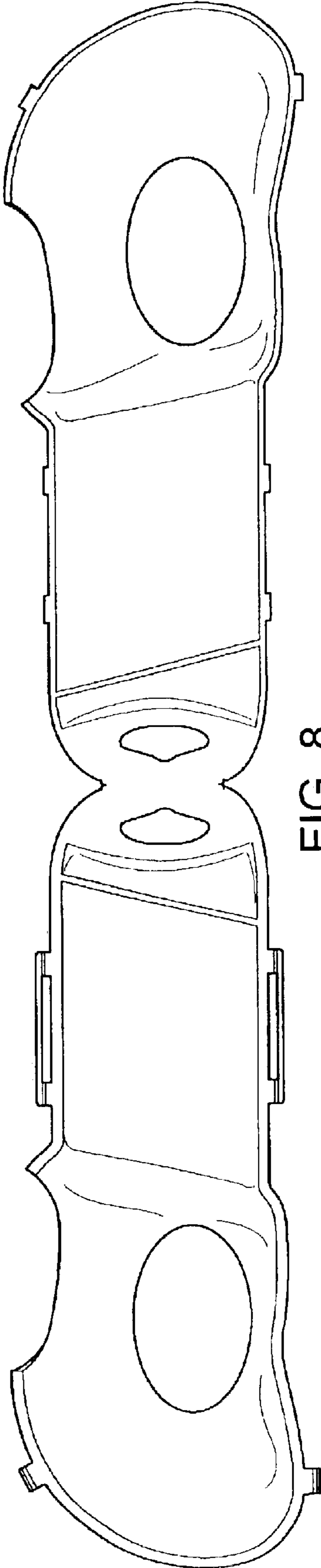

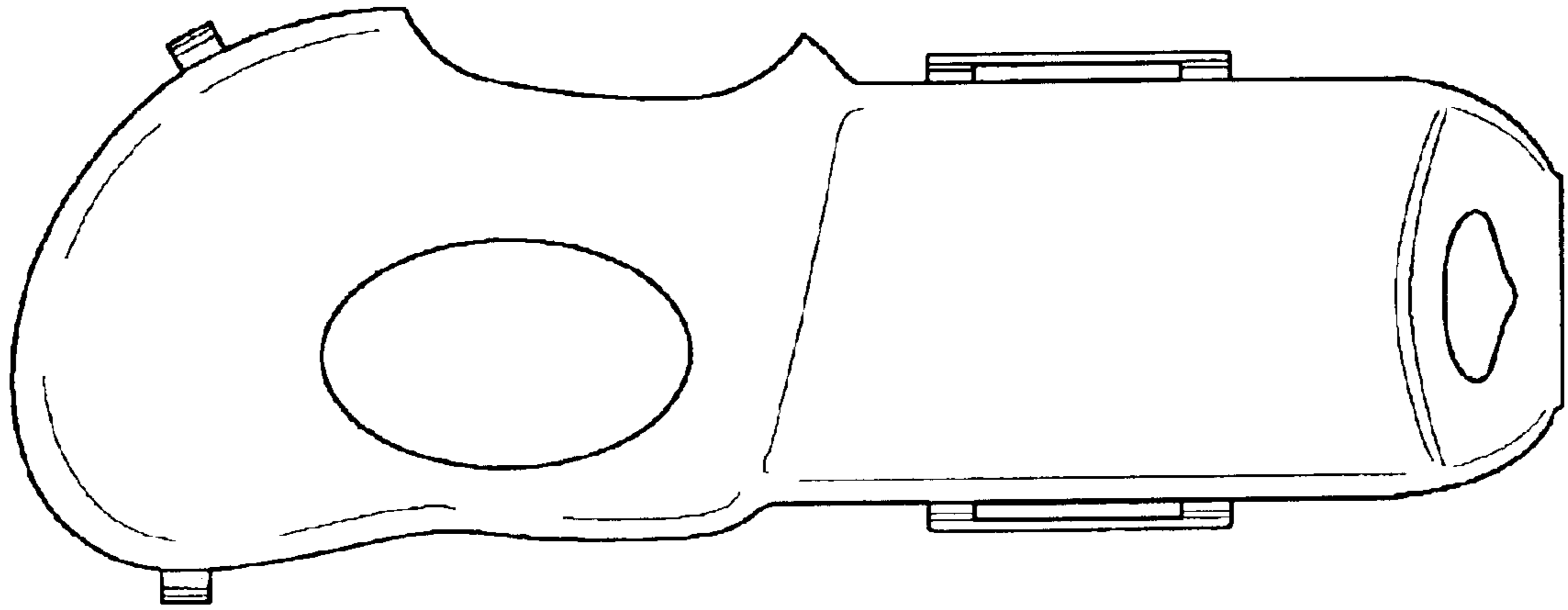

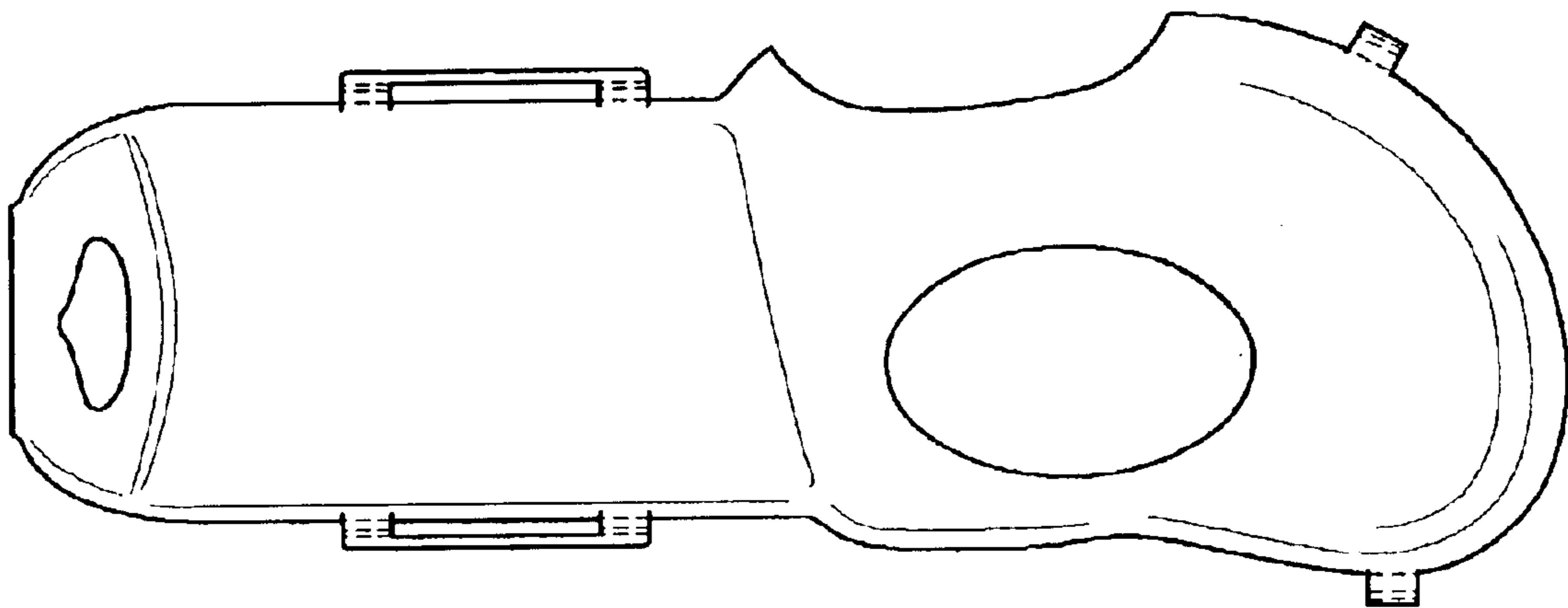

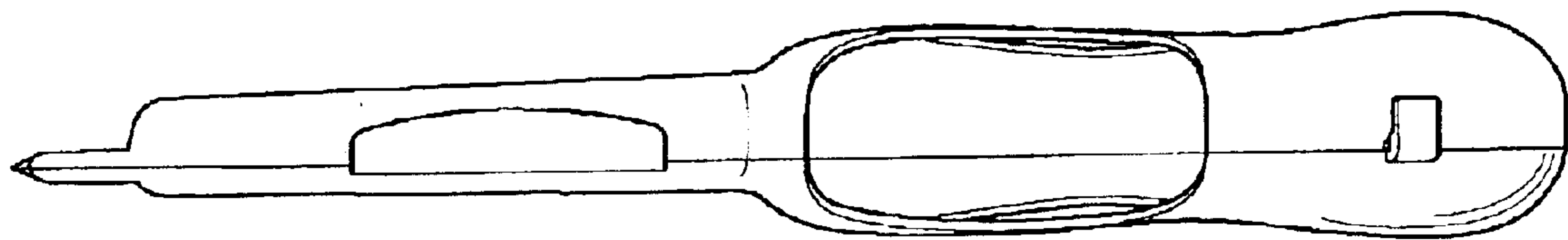

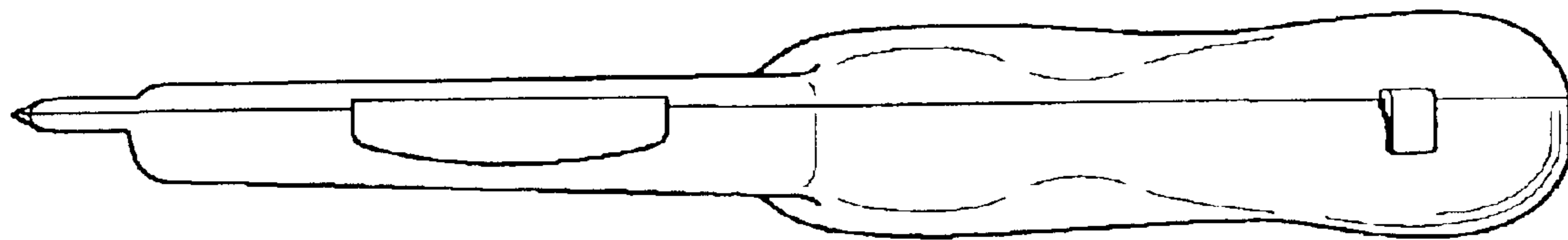

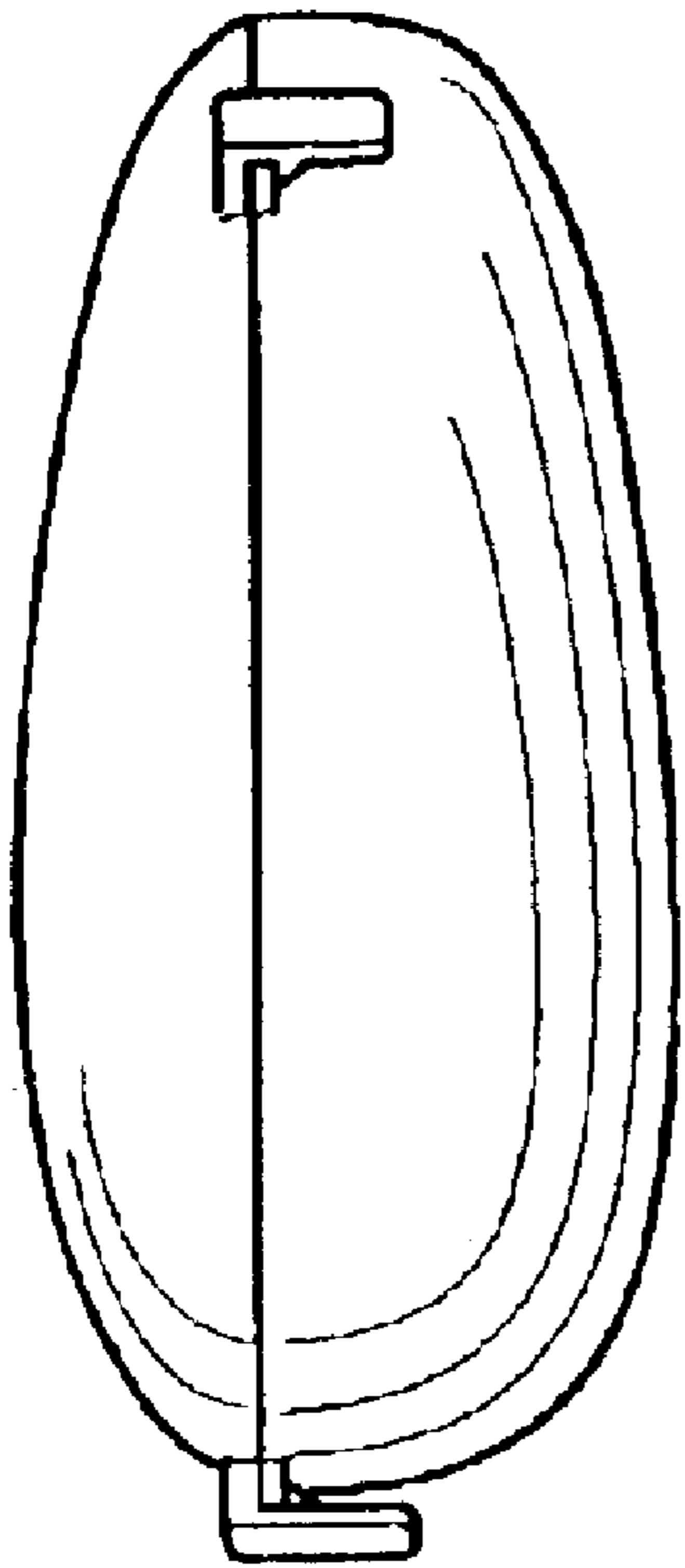

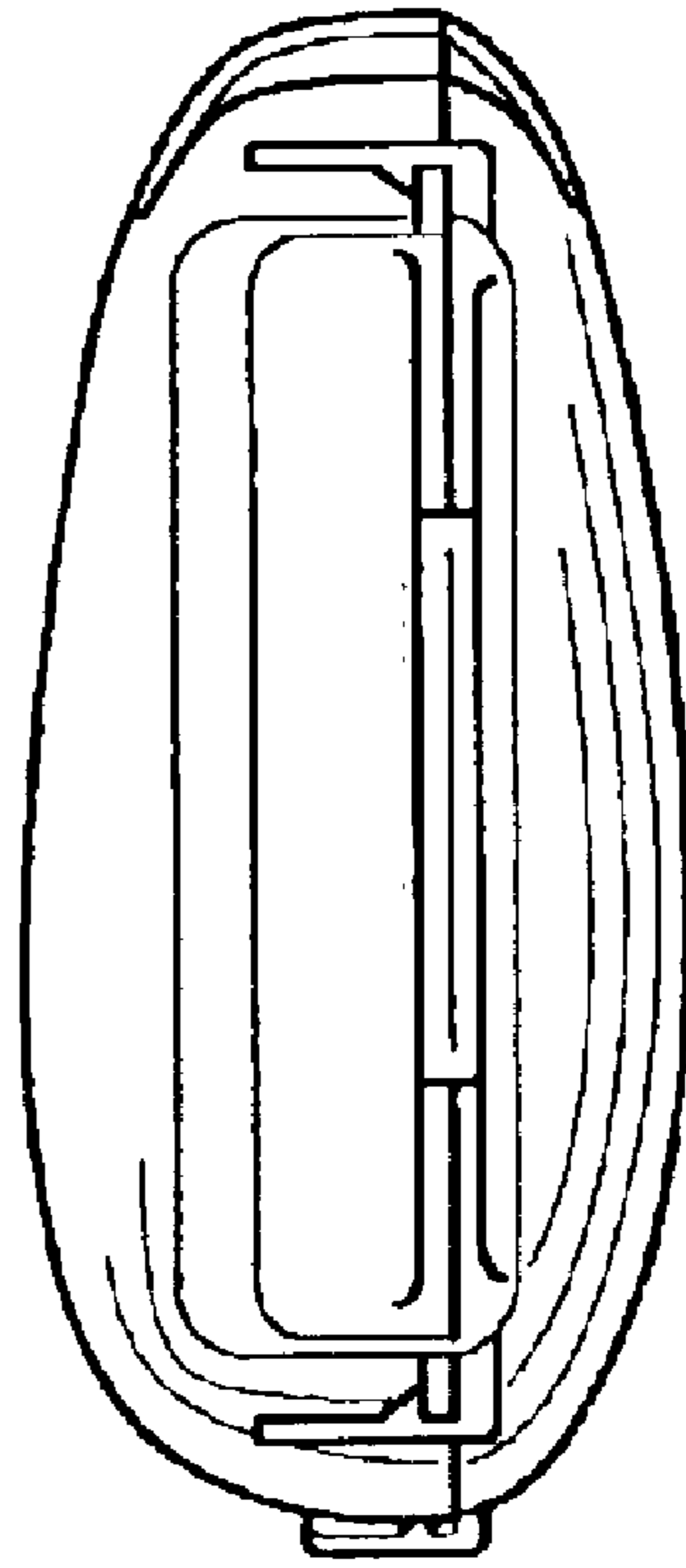
