**DESCRIPTION**

FIG. 1 is a perspective view of a double hook part embodying this invention;

FIG. 2 is a top view of the double hook part shown in FIG. 1;

FIG. 3 is a front view of the double hook part shown in FIG. 1;

FIG. 4 is a right side elevation view of the double hook part shown in FIG. 1;

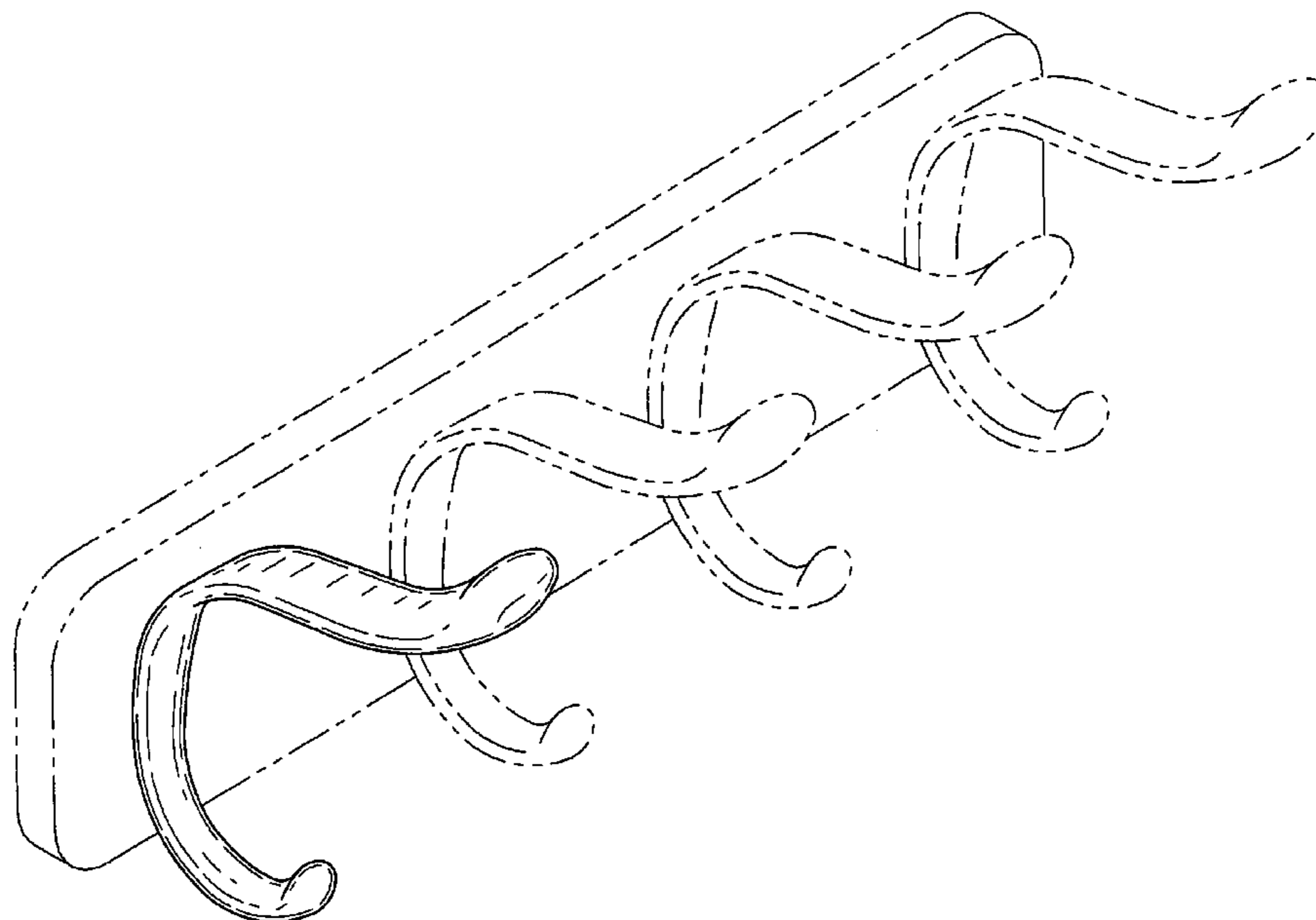
FIG. 5 rear view of the double hook part shown in FIG. 1;

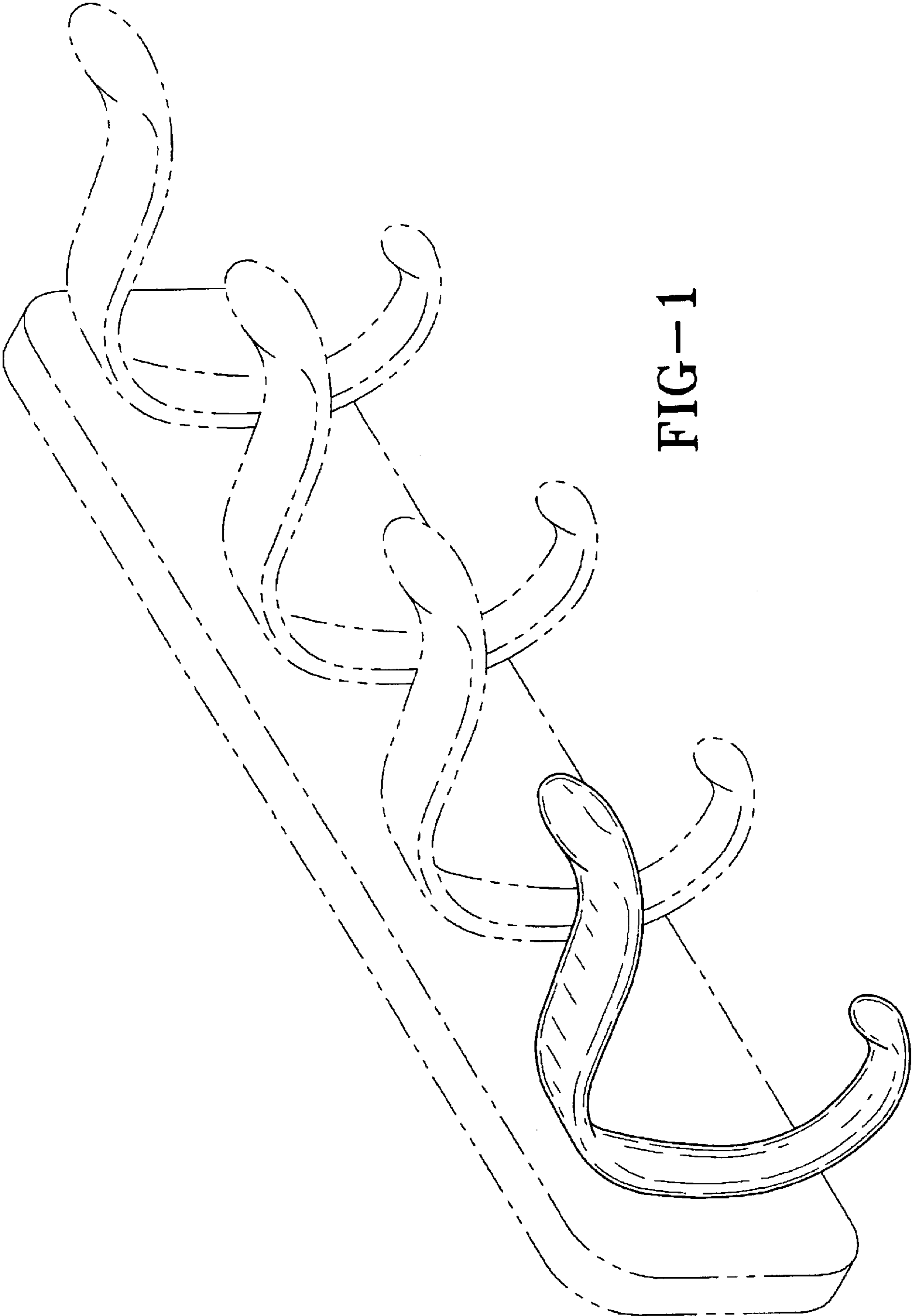

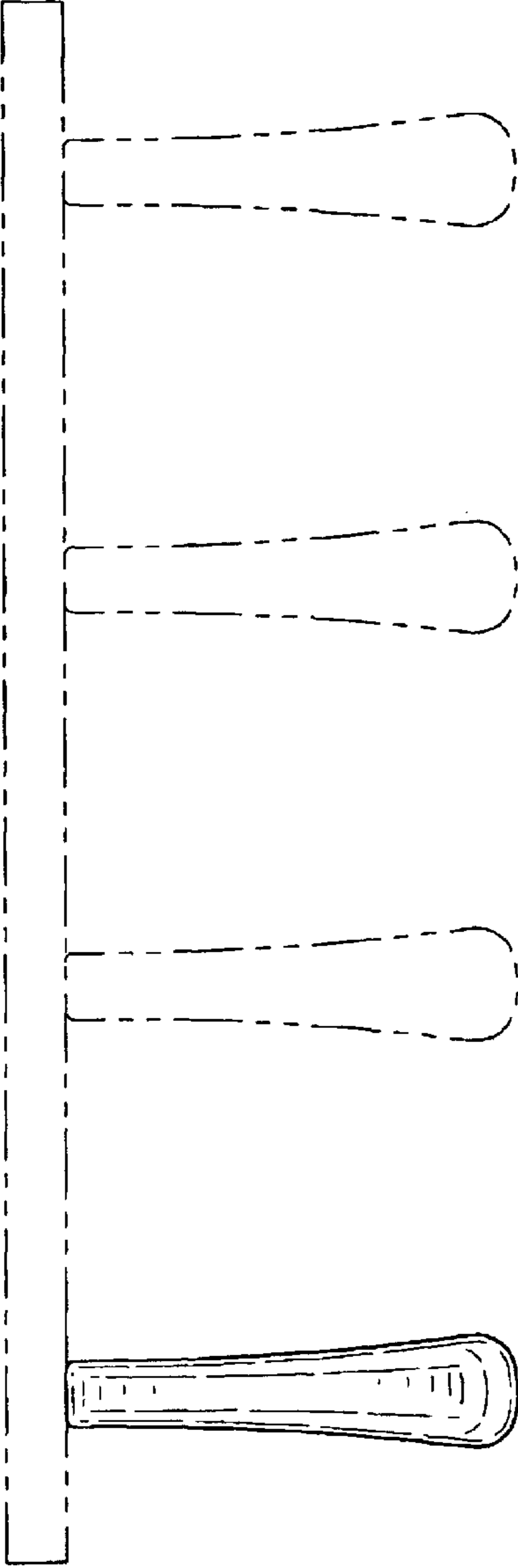

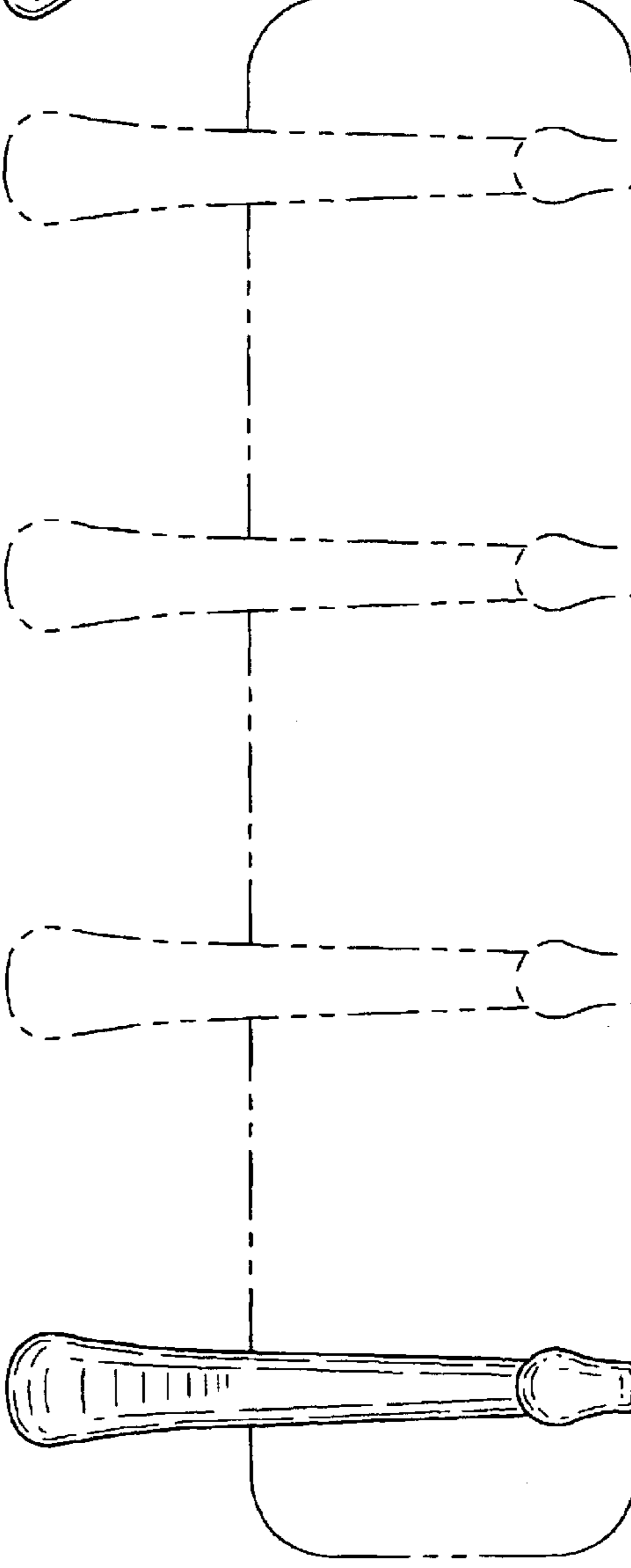

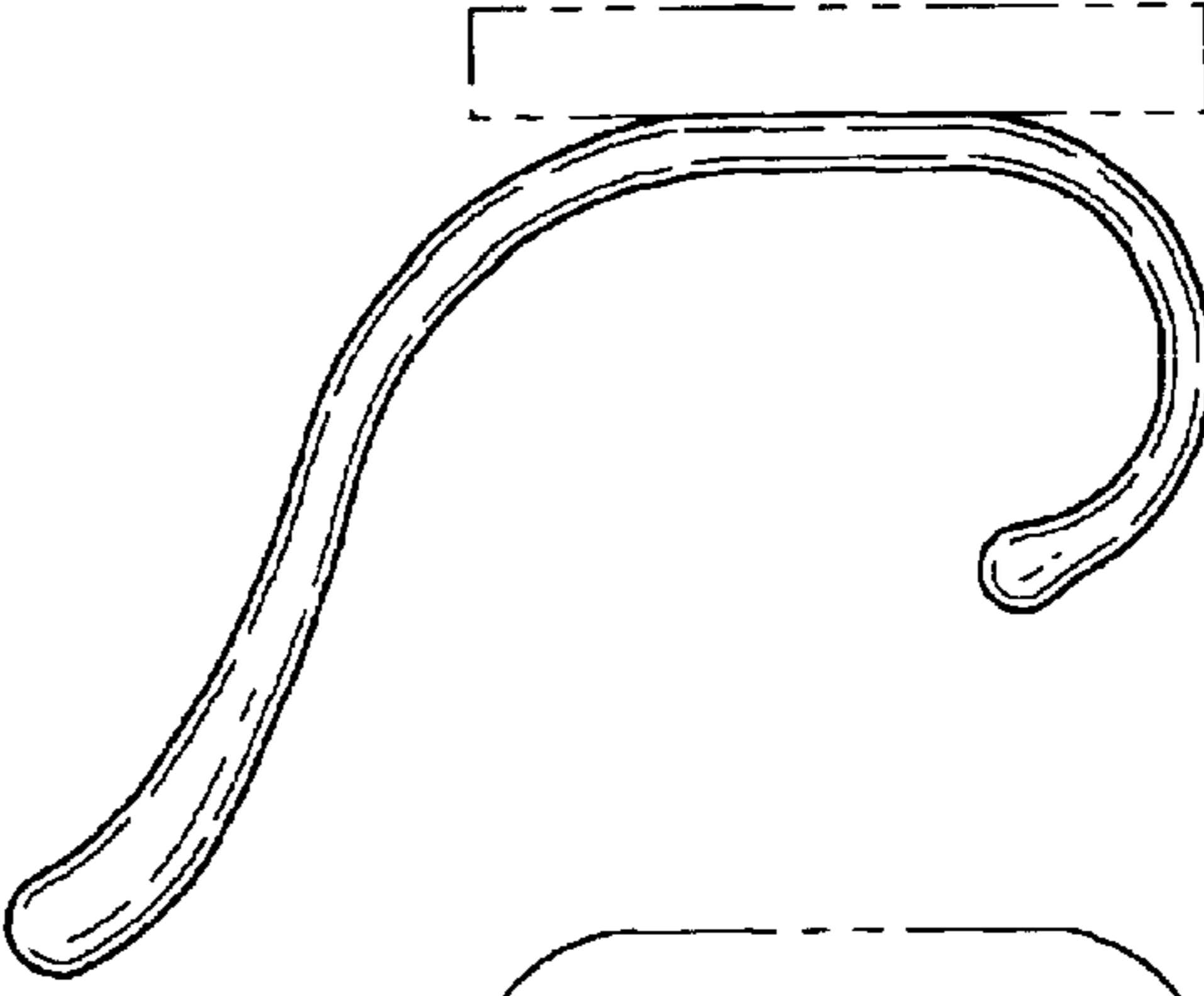

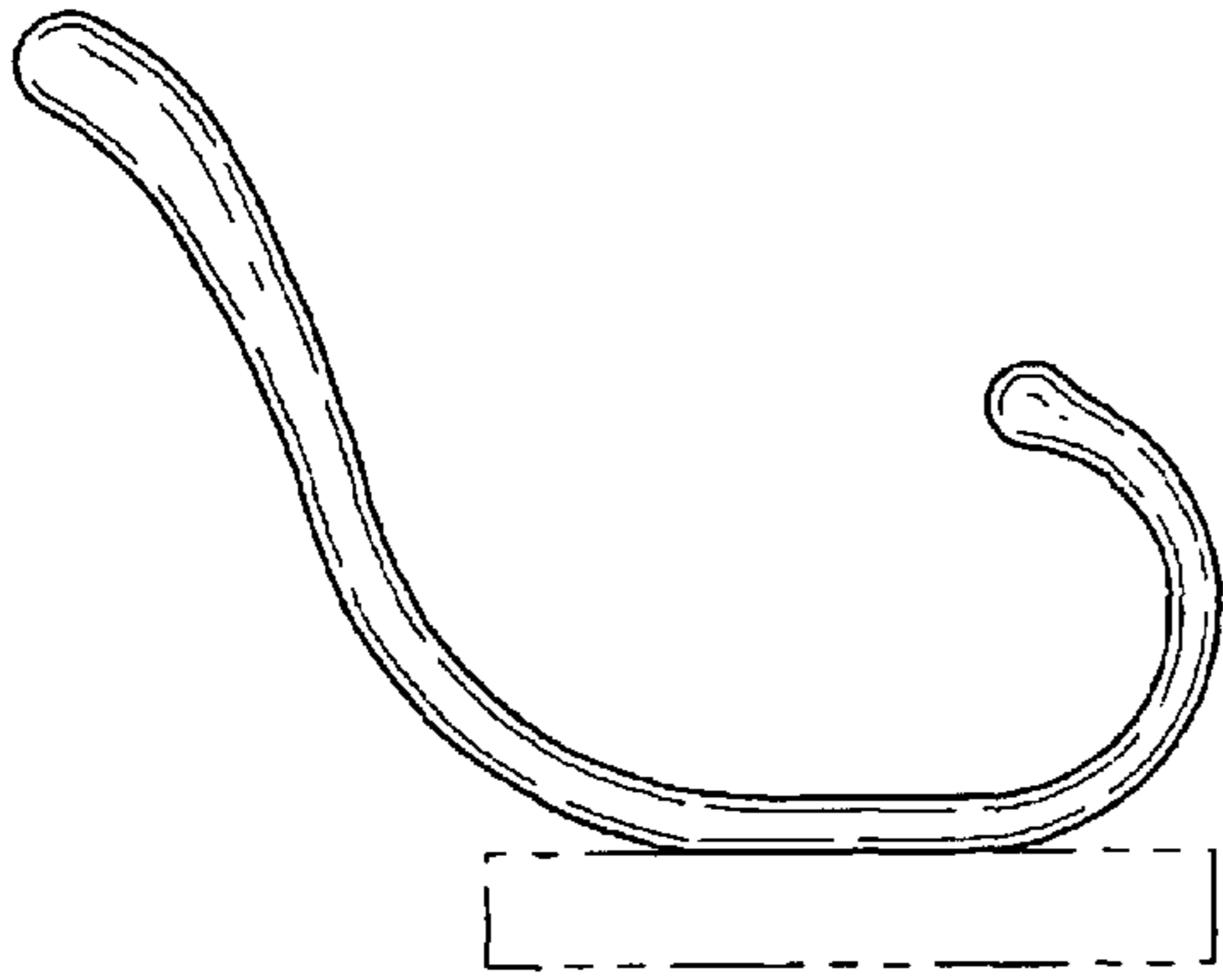

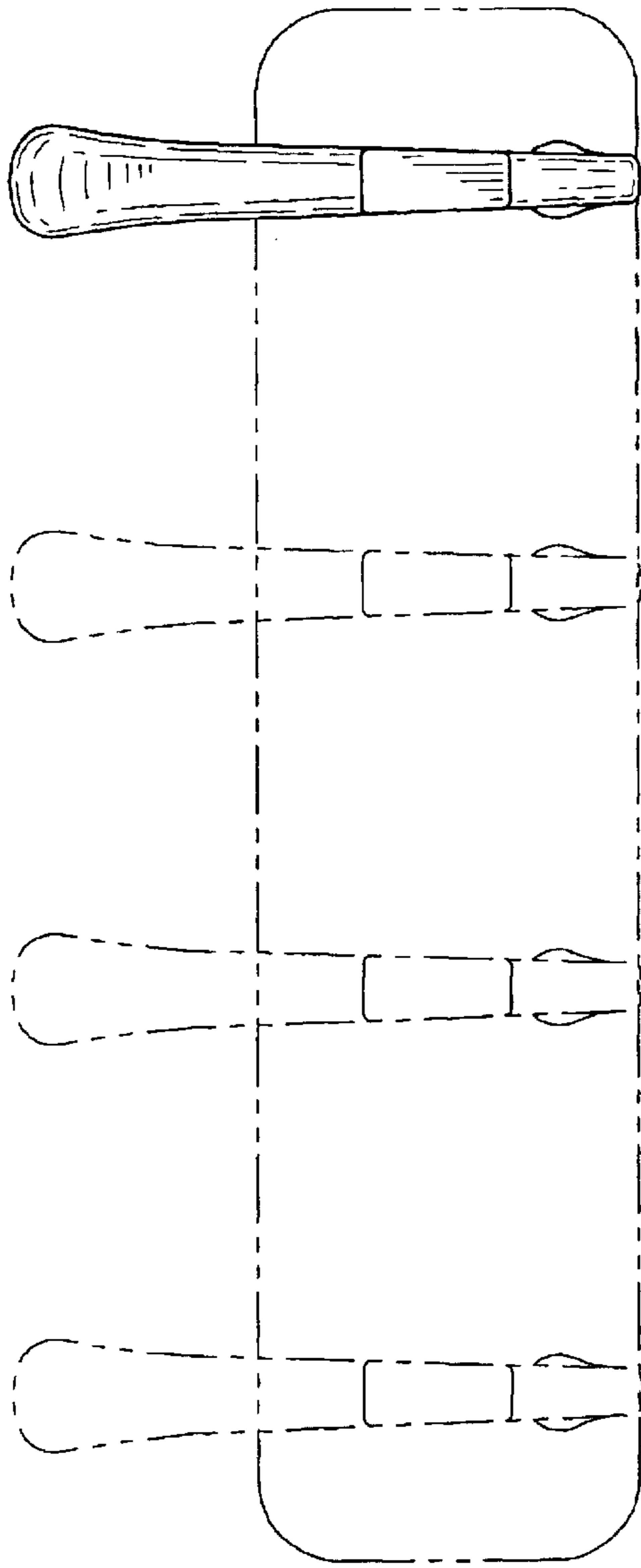

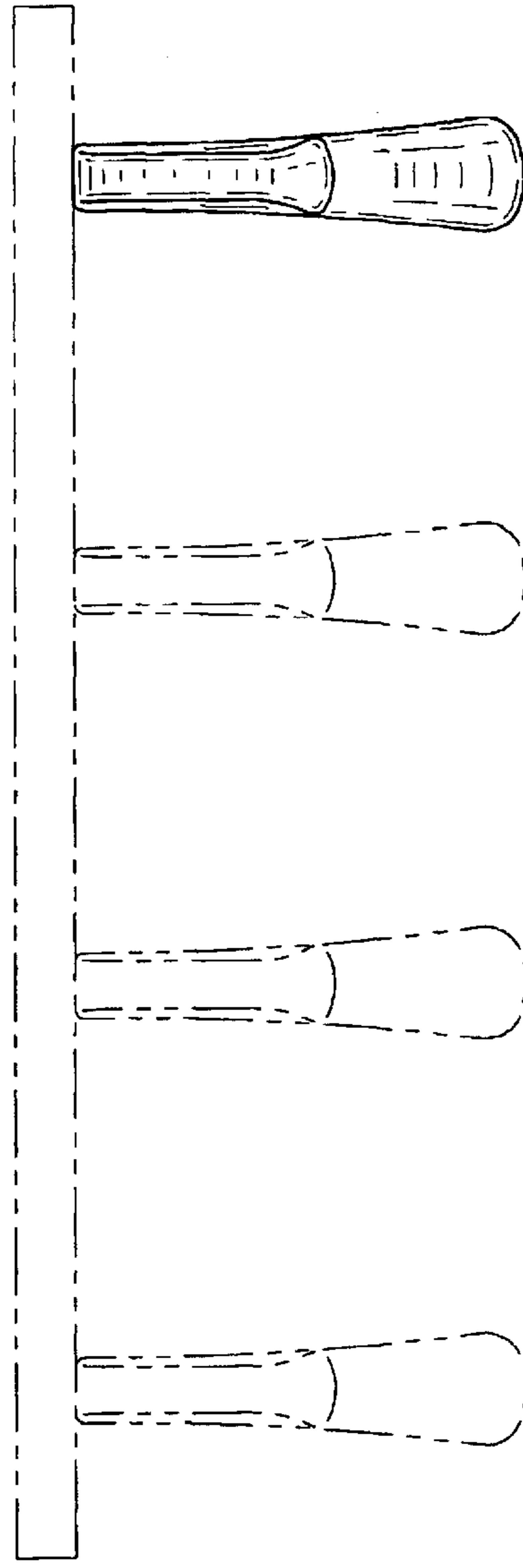
