FIG. 2 is a perspective view thereof taken from the bottom, rear and left side;

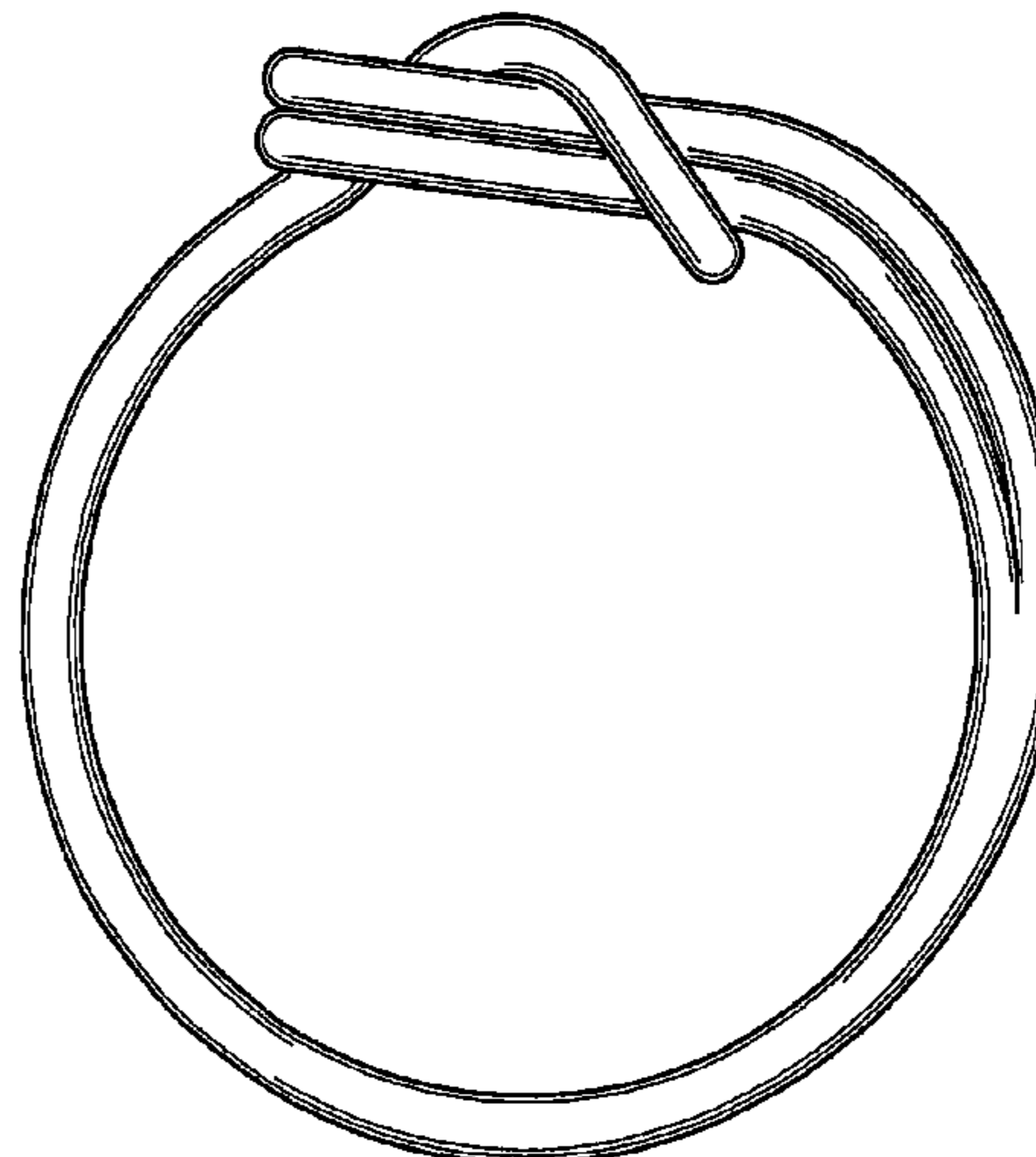
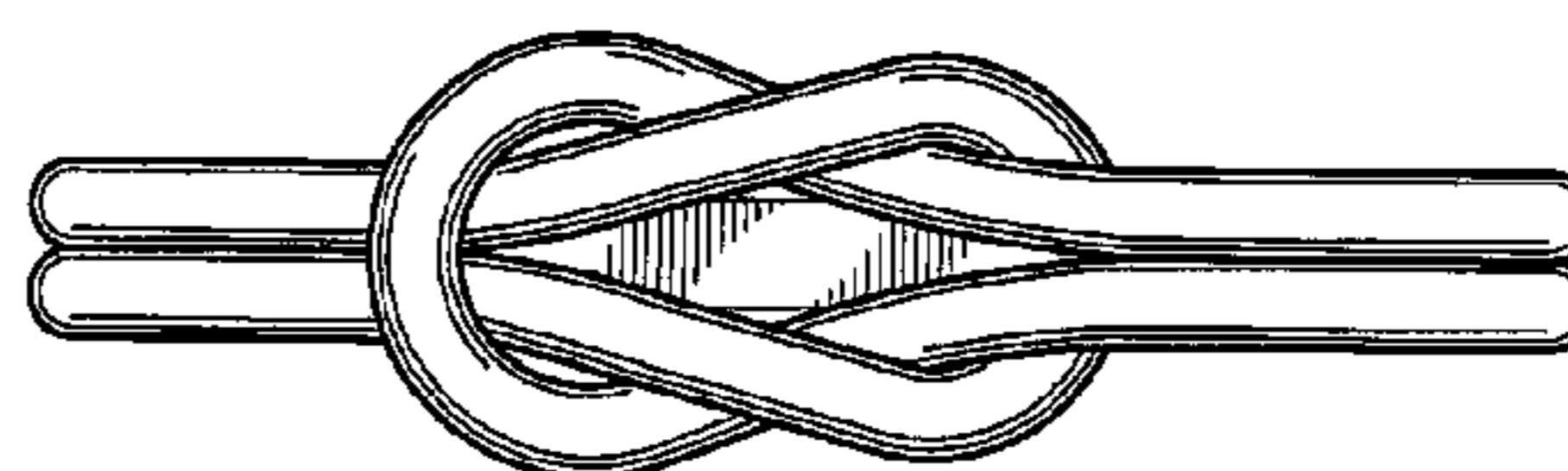
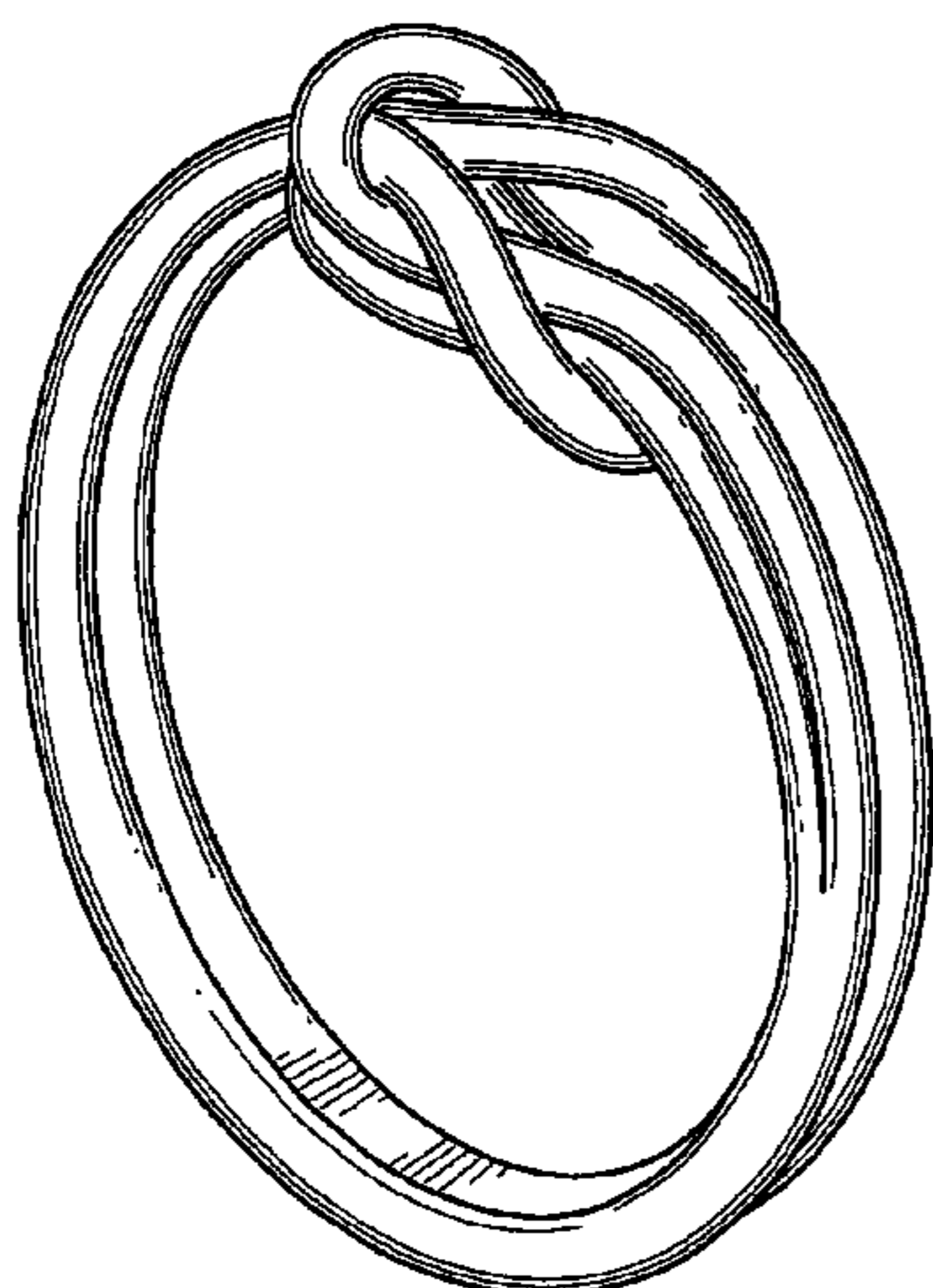
FIG. 3 is a top plan view thereof;

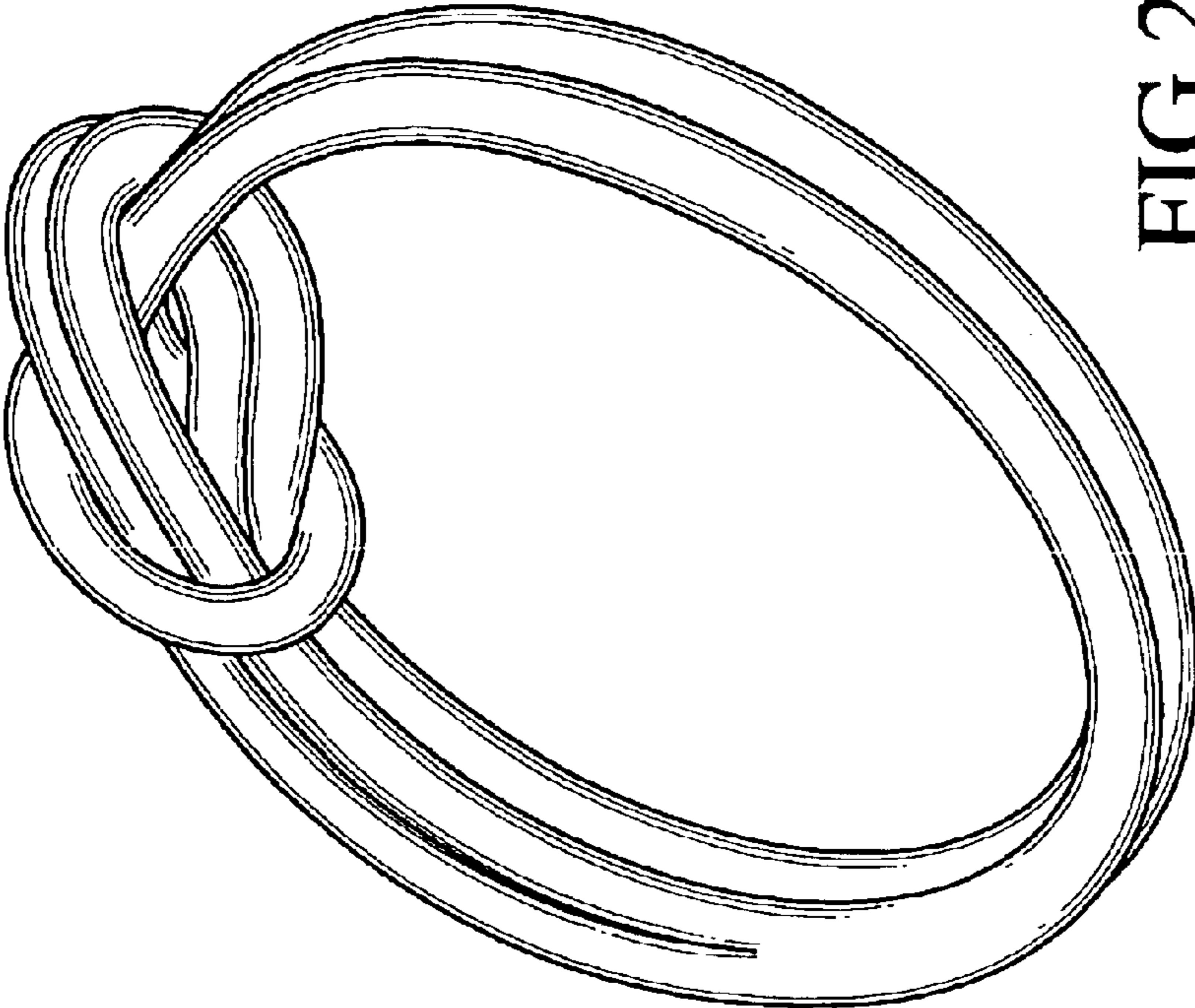

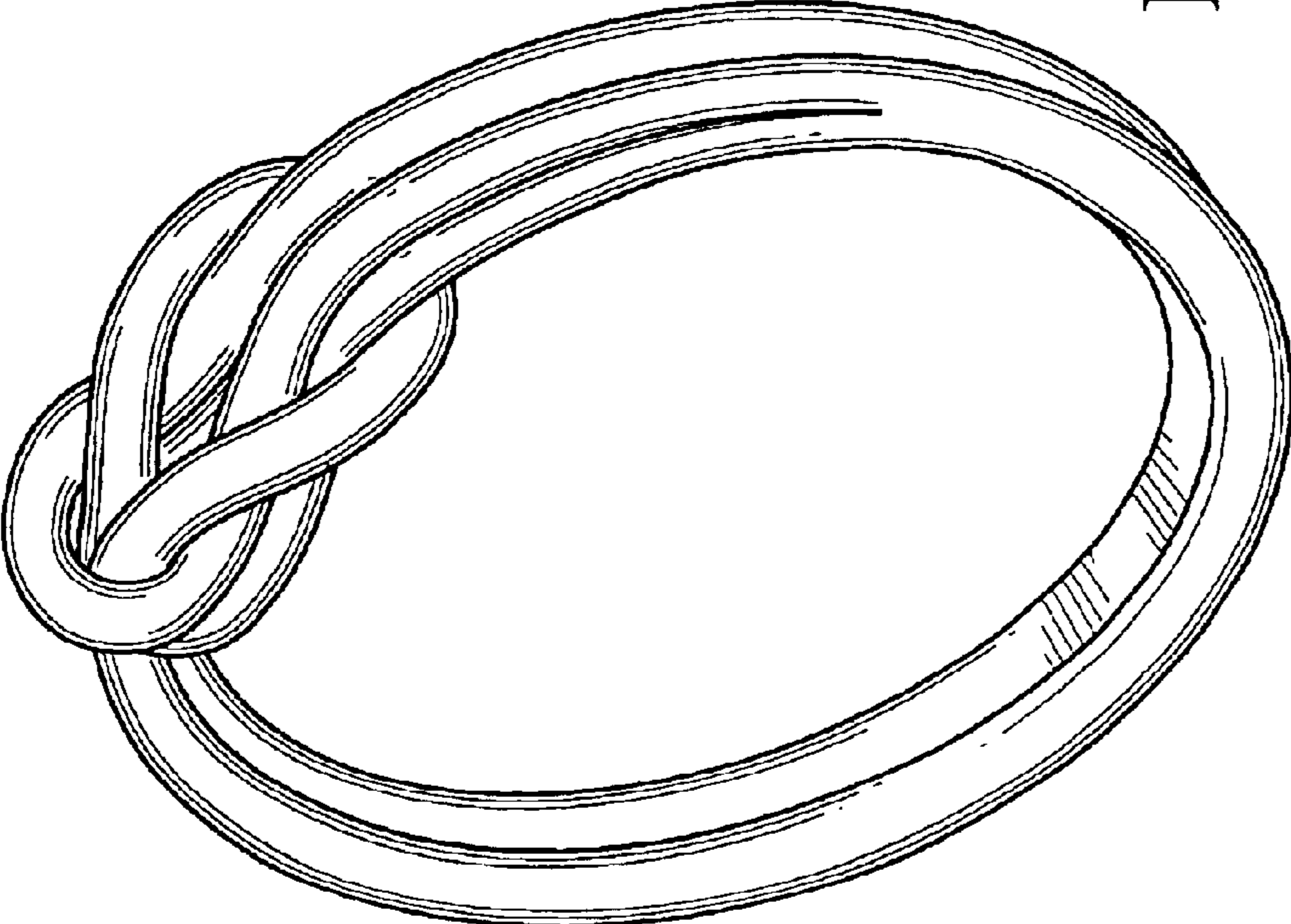

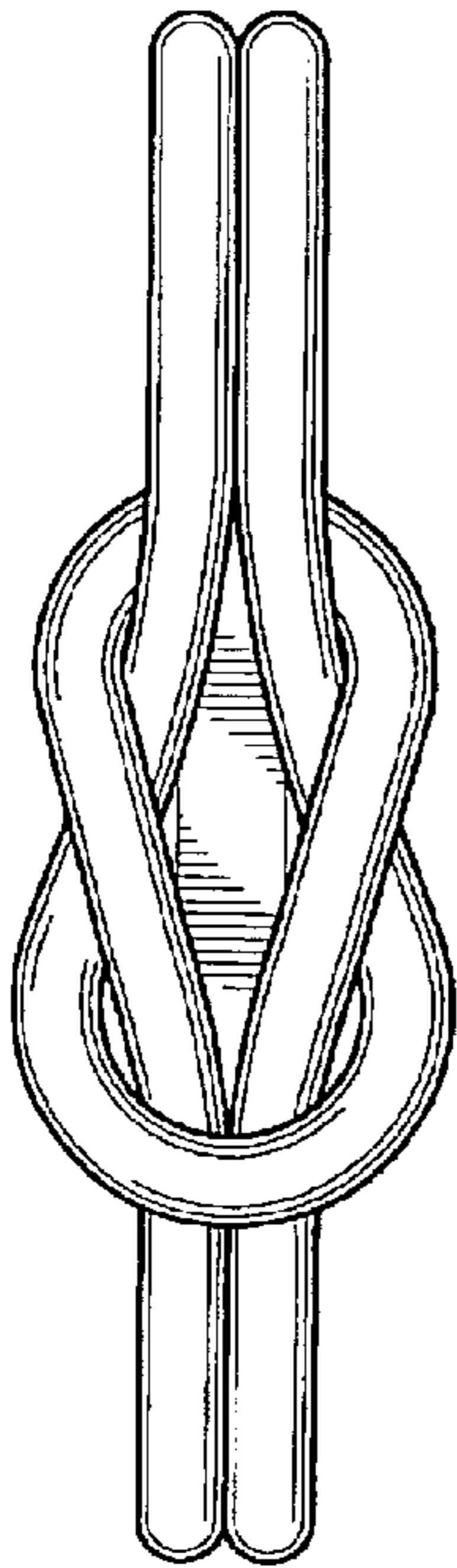

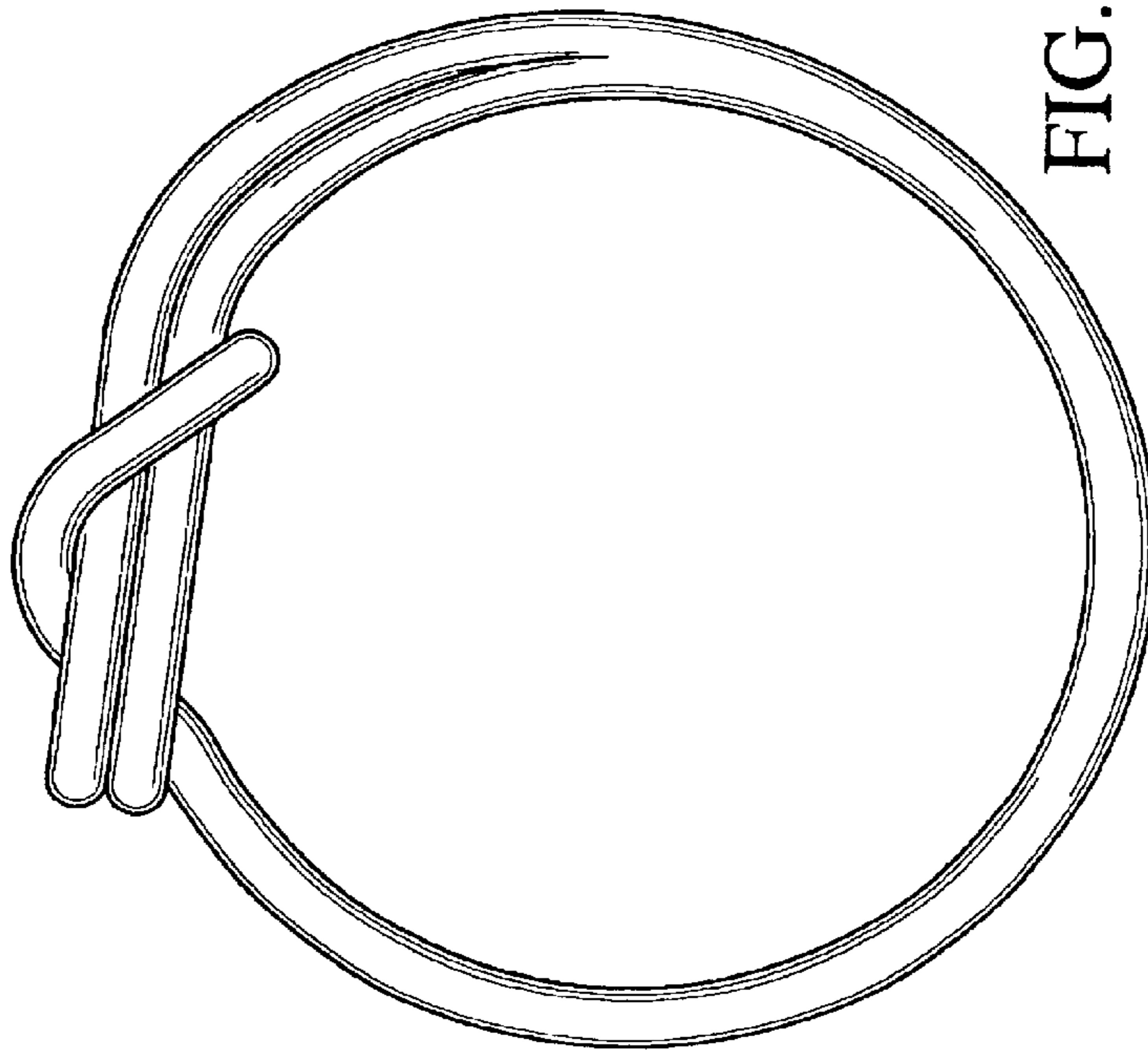

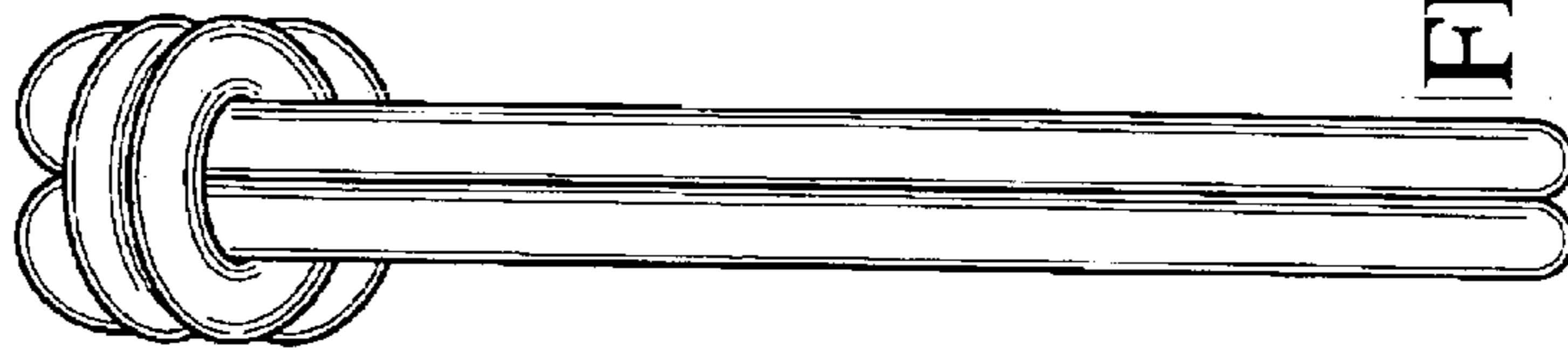

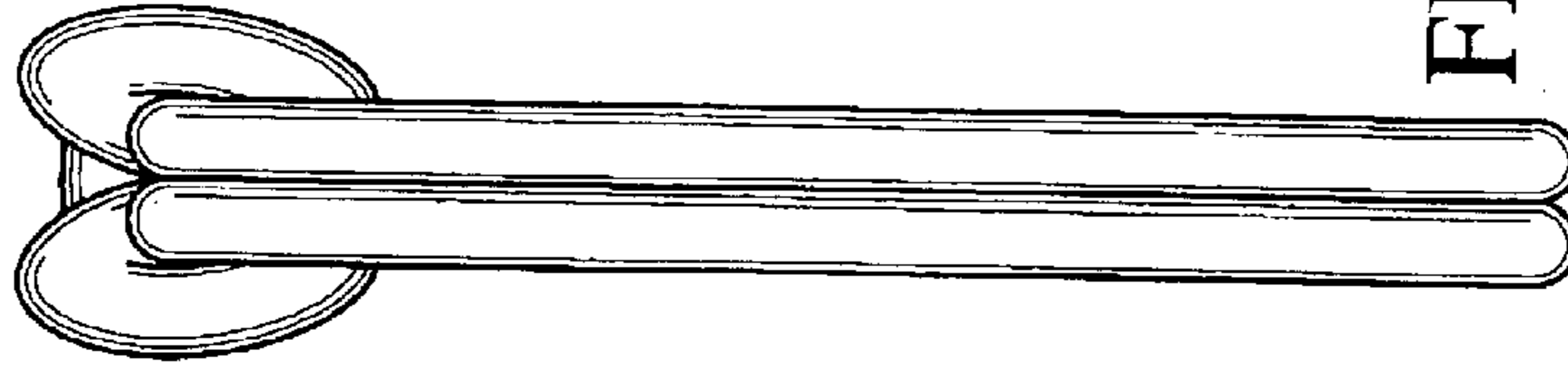
