FIG. 2 is a left-rear, perspective view of our new design;

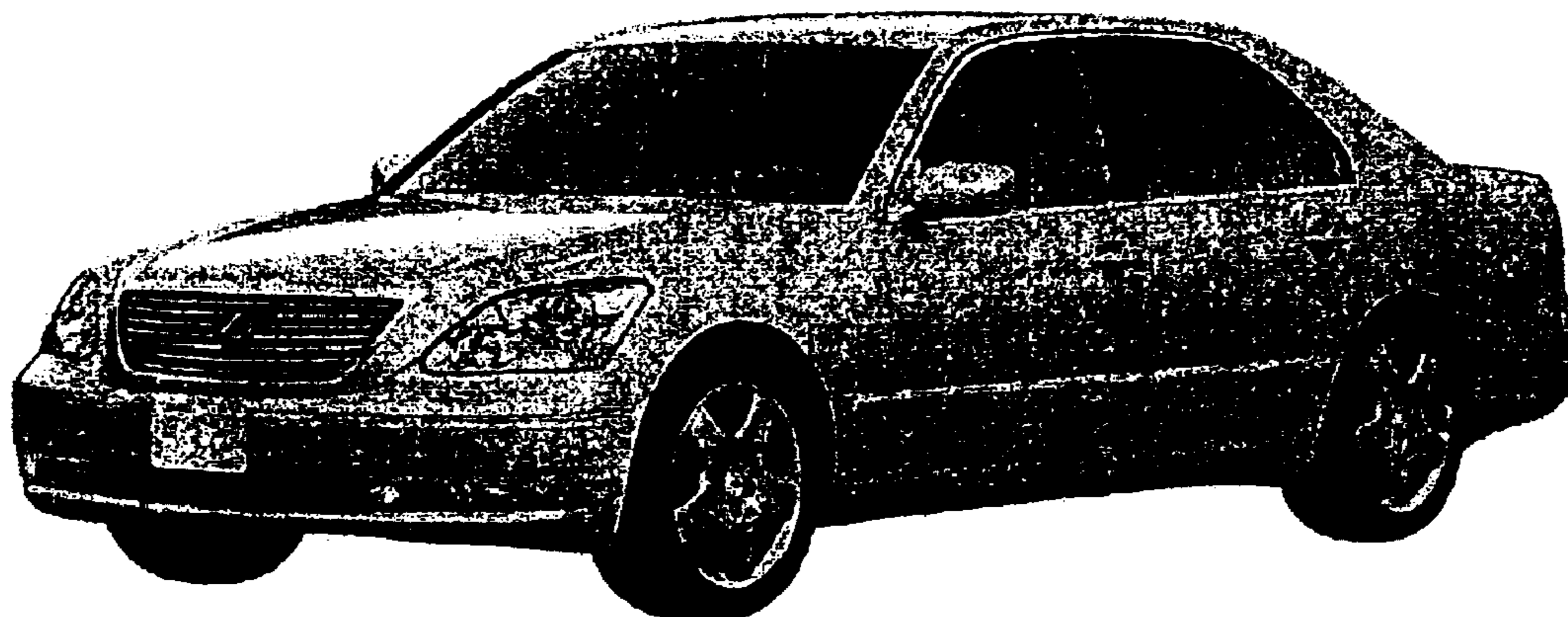
FIG. 3 is a front view of our new design;

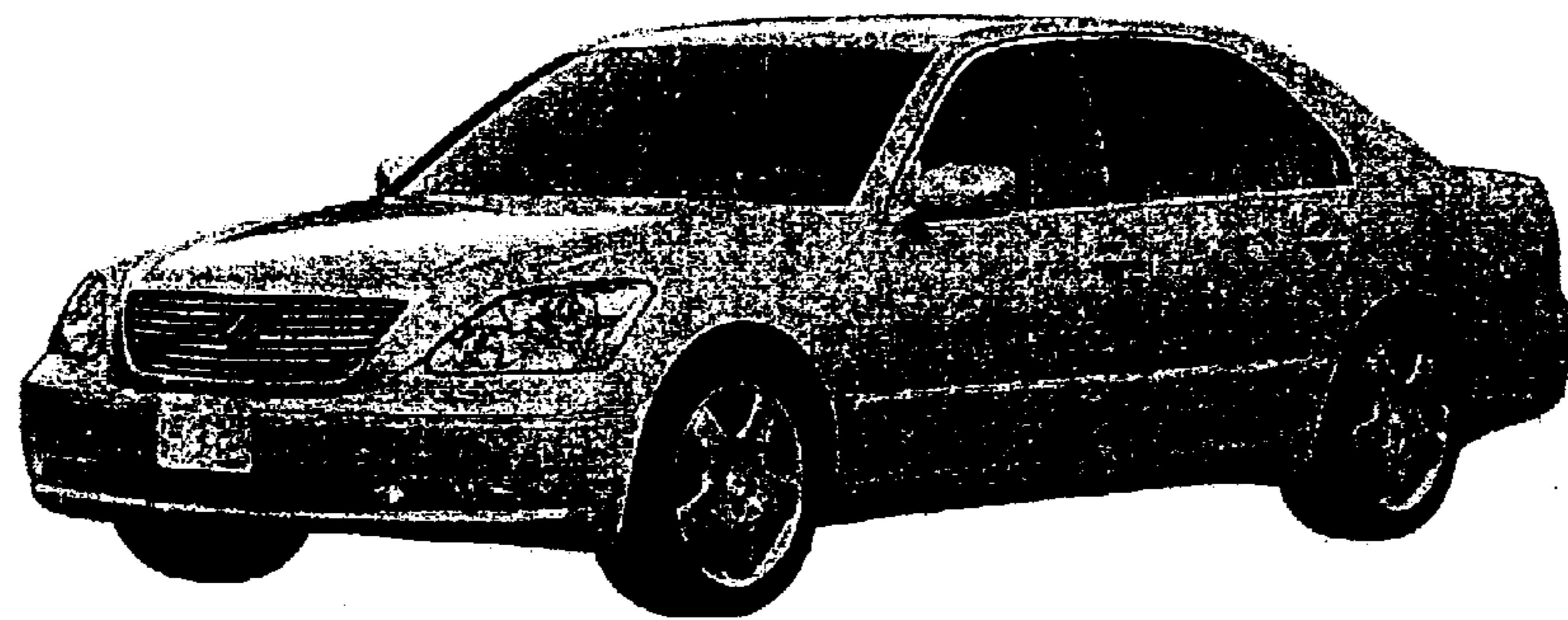

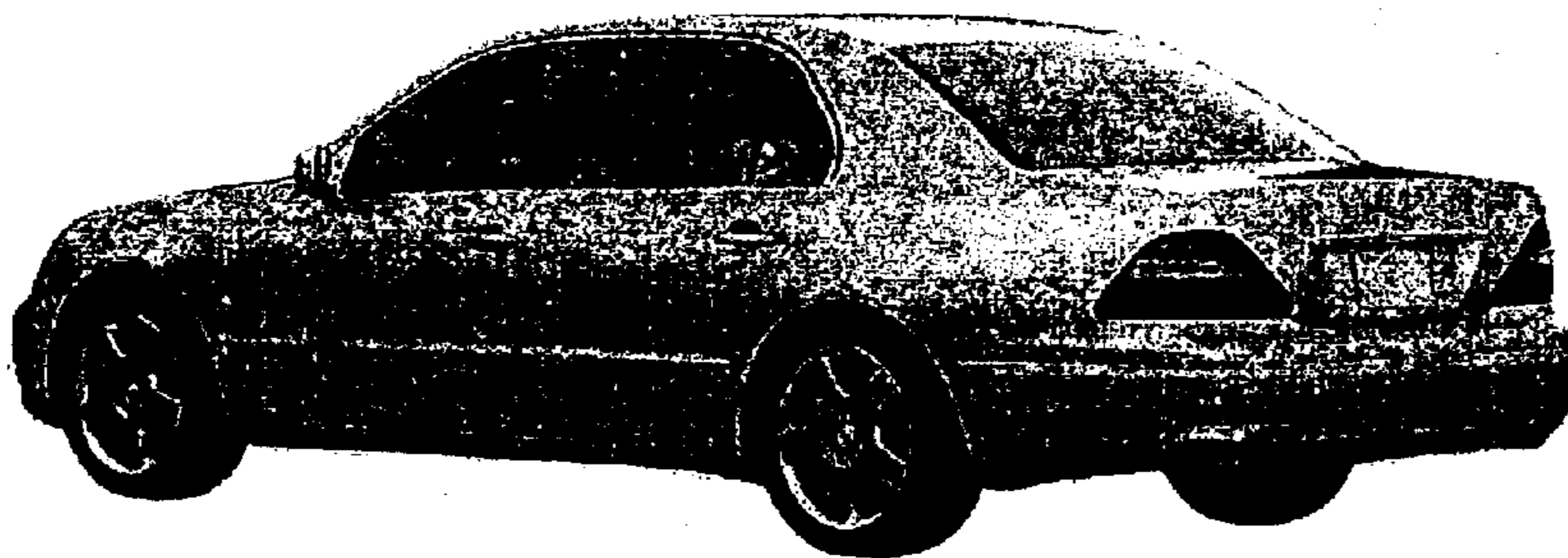

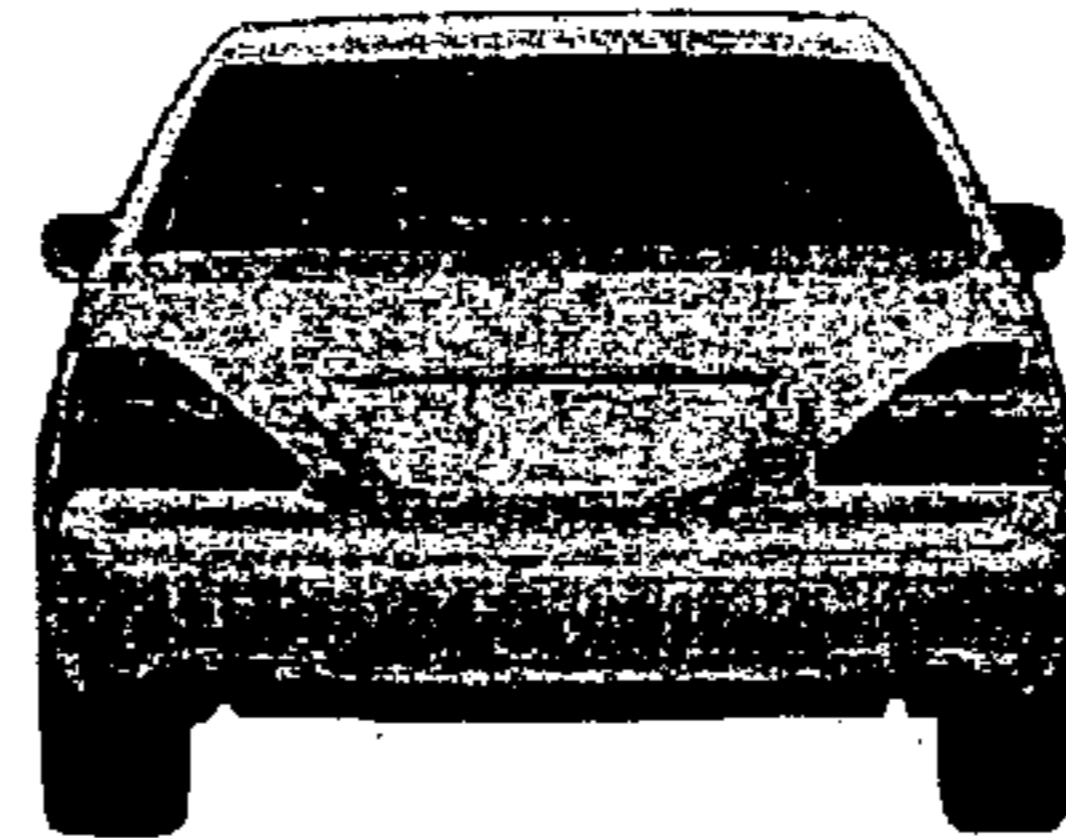

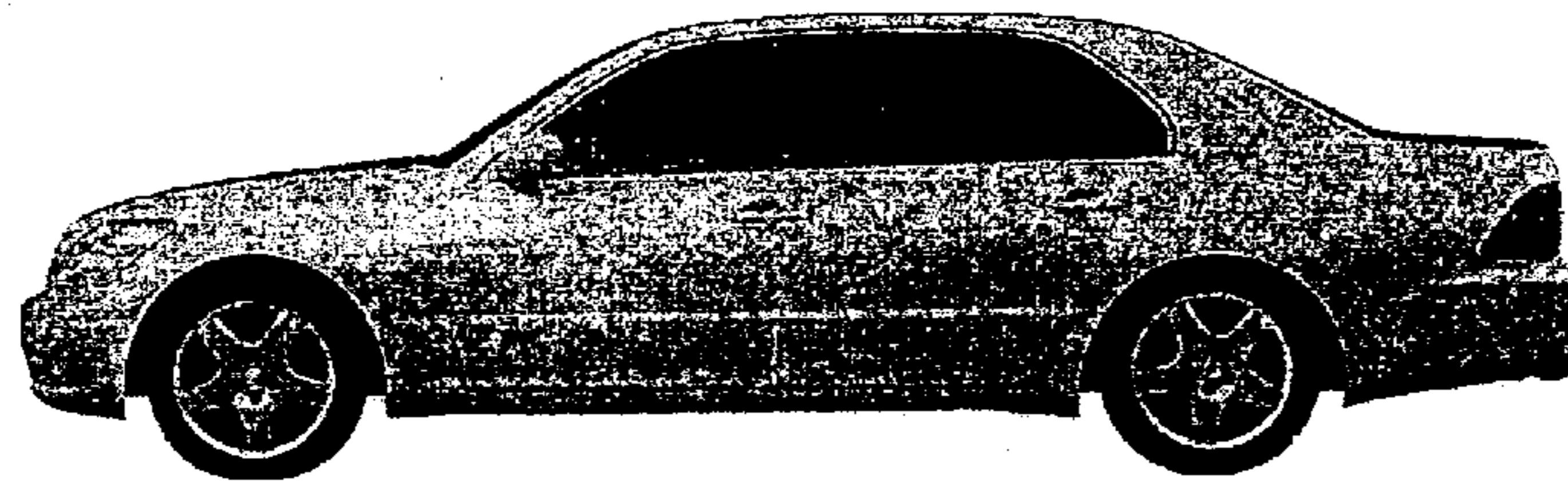

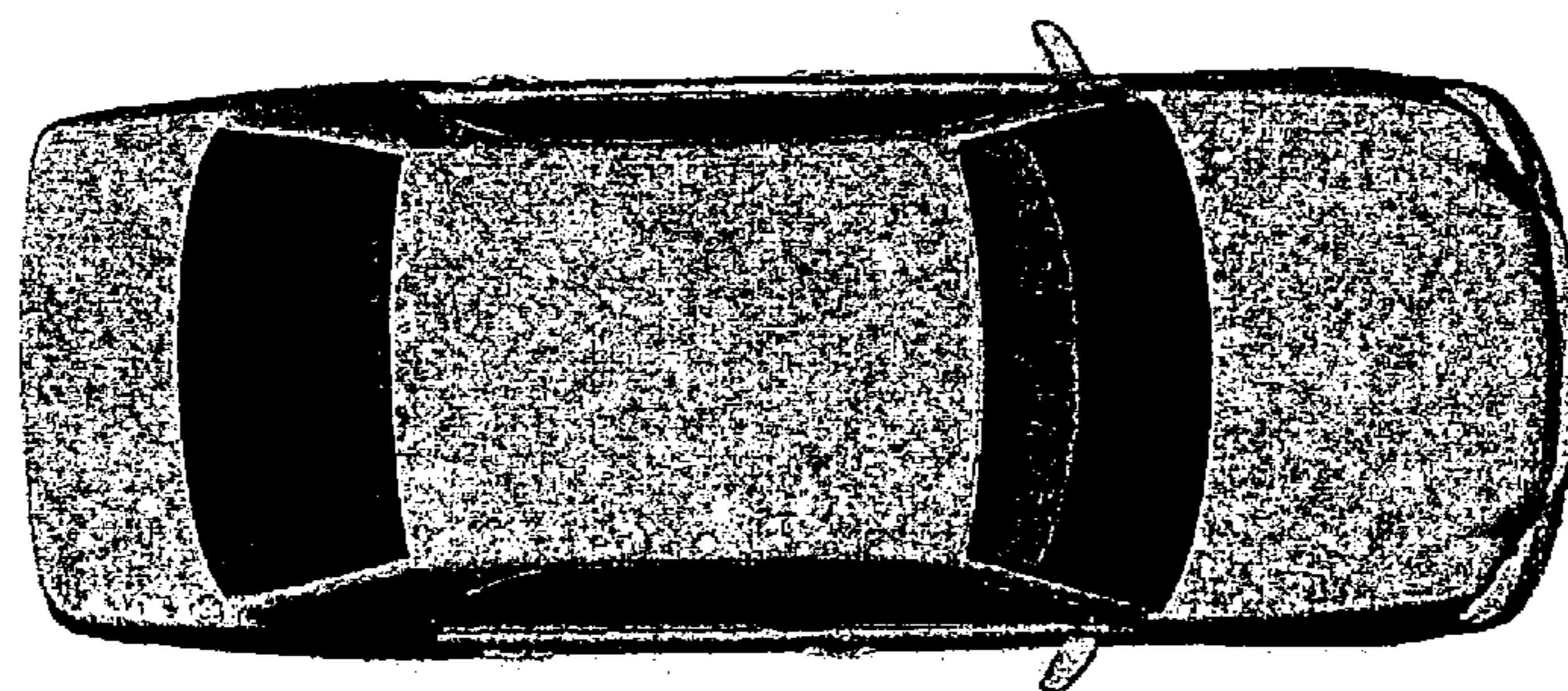

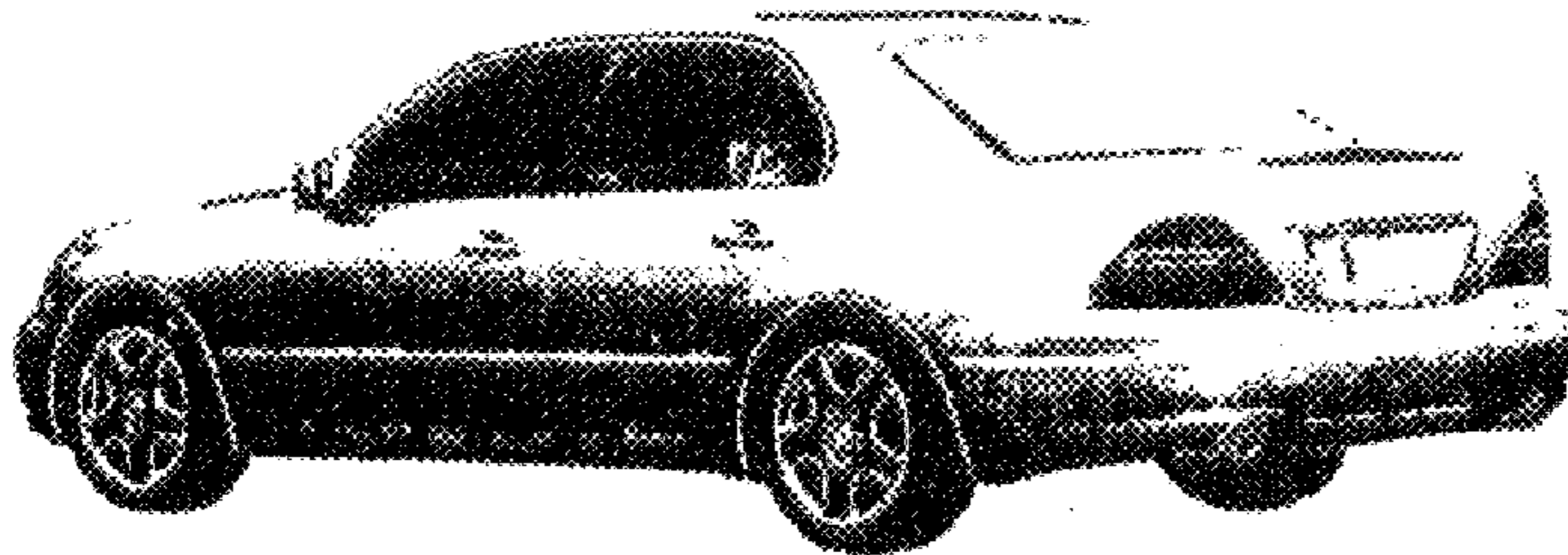

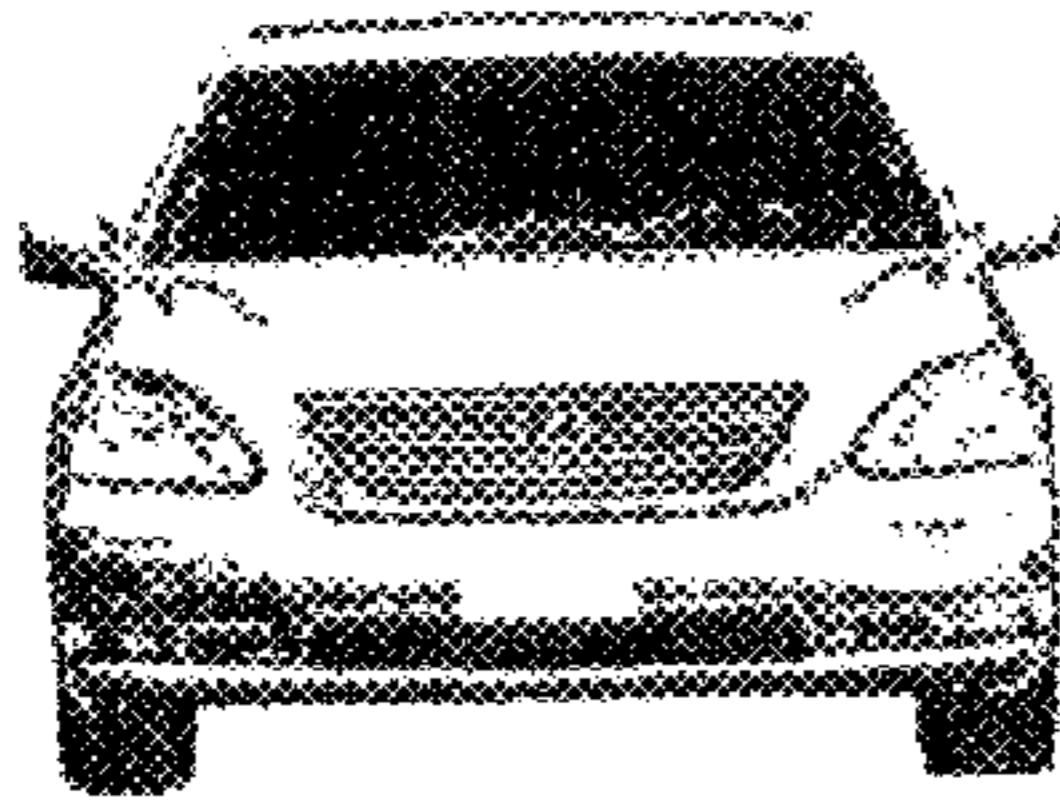

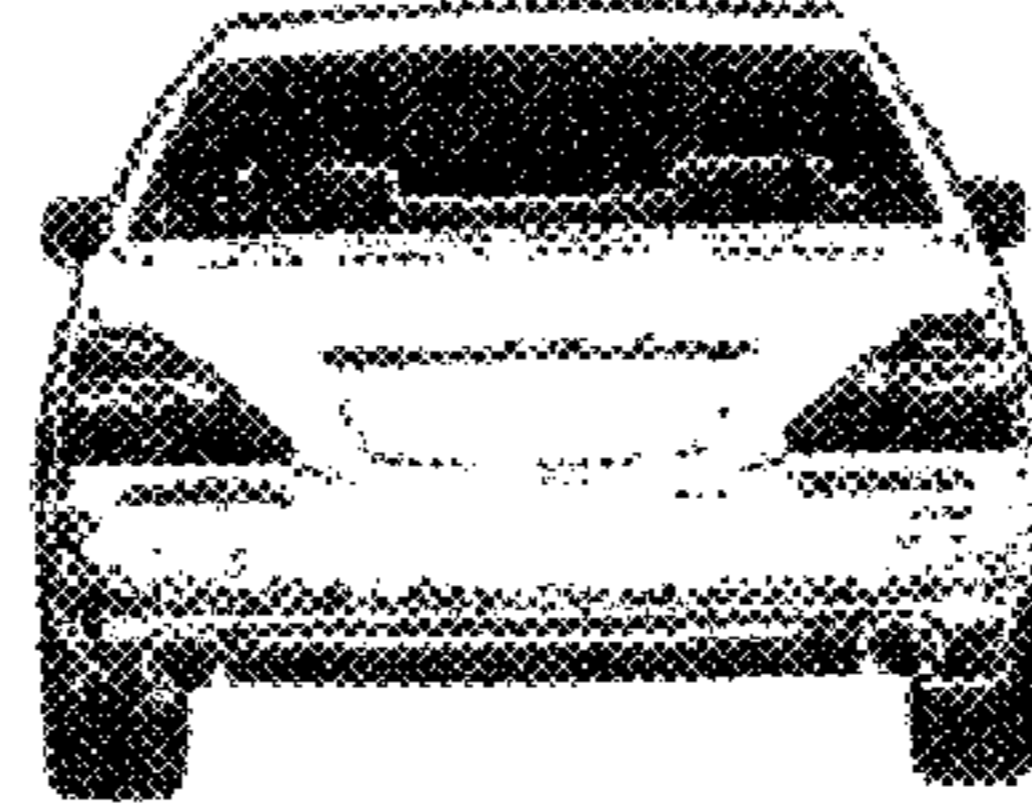

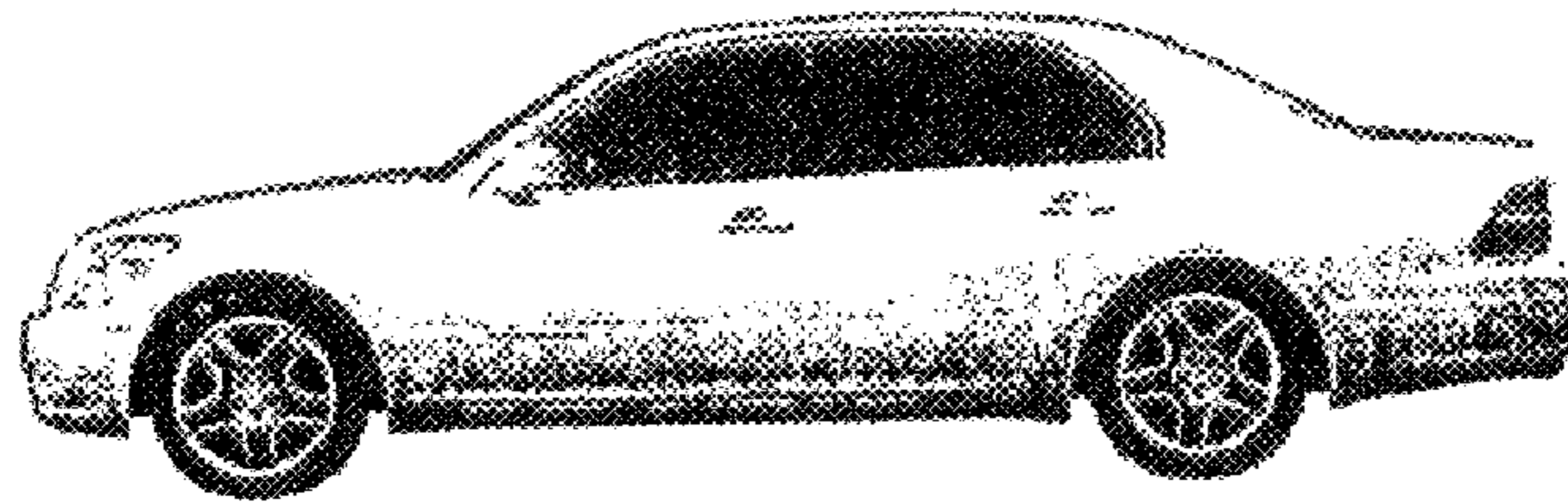

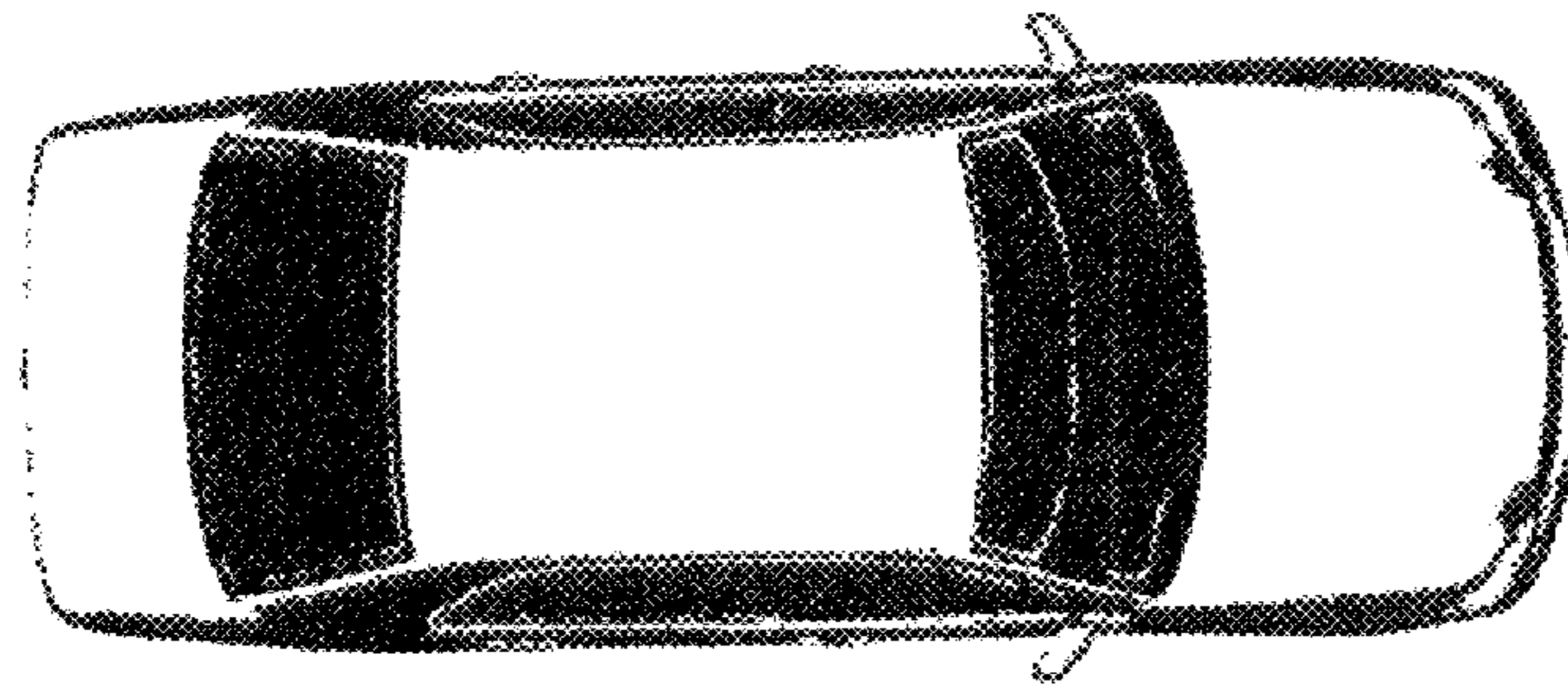
