FIG. 2 is a front elevational view thereof;

FIG. 6 is a left side elevational view thereof;

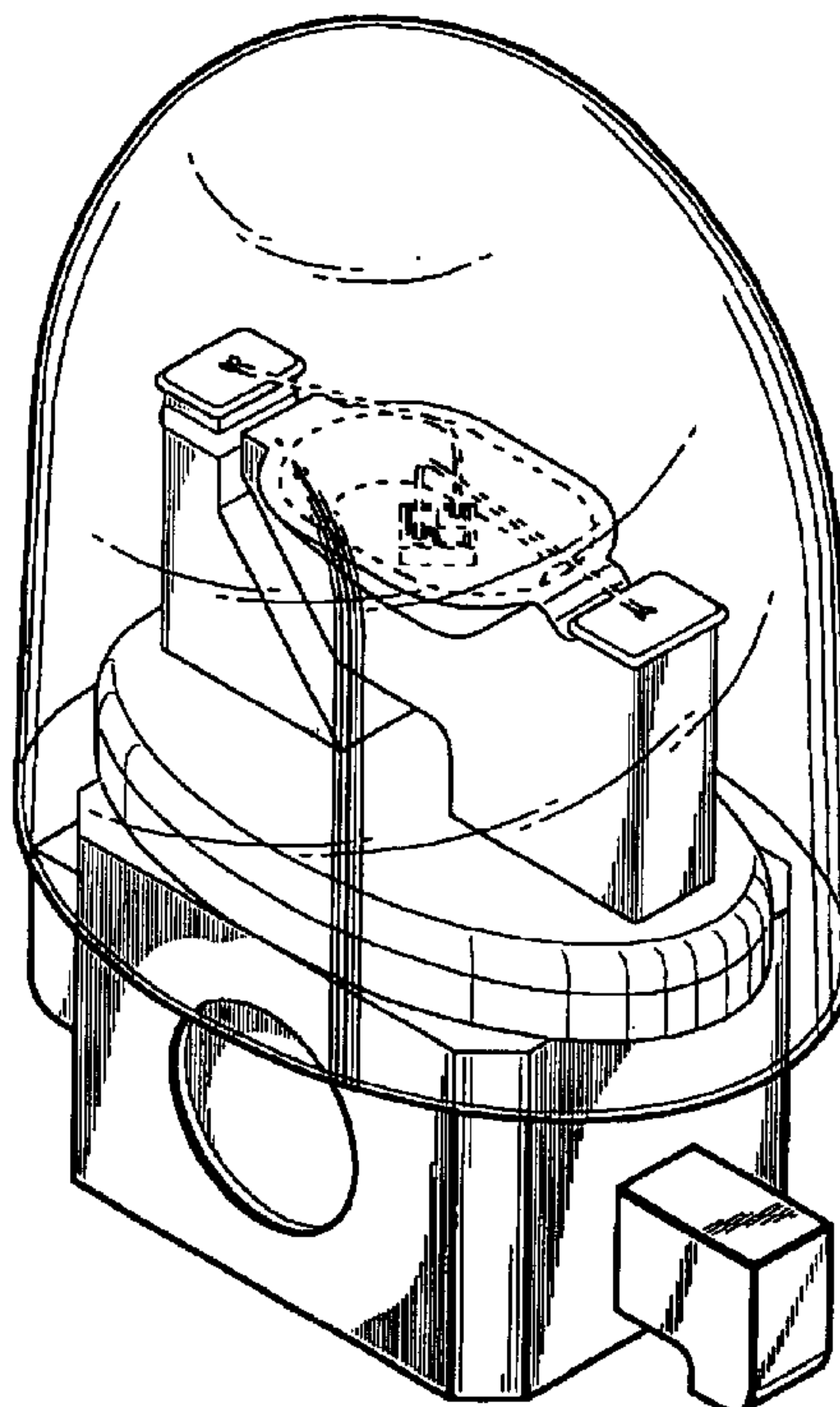

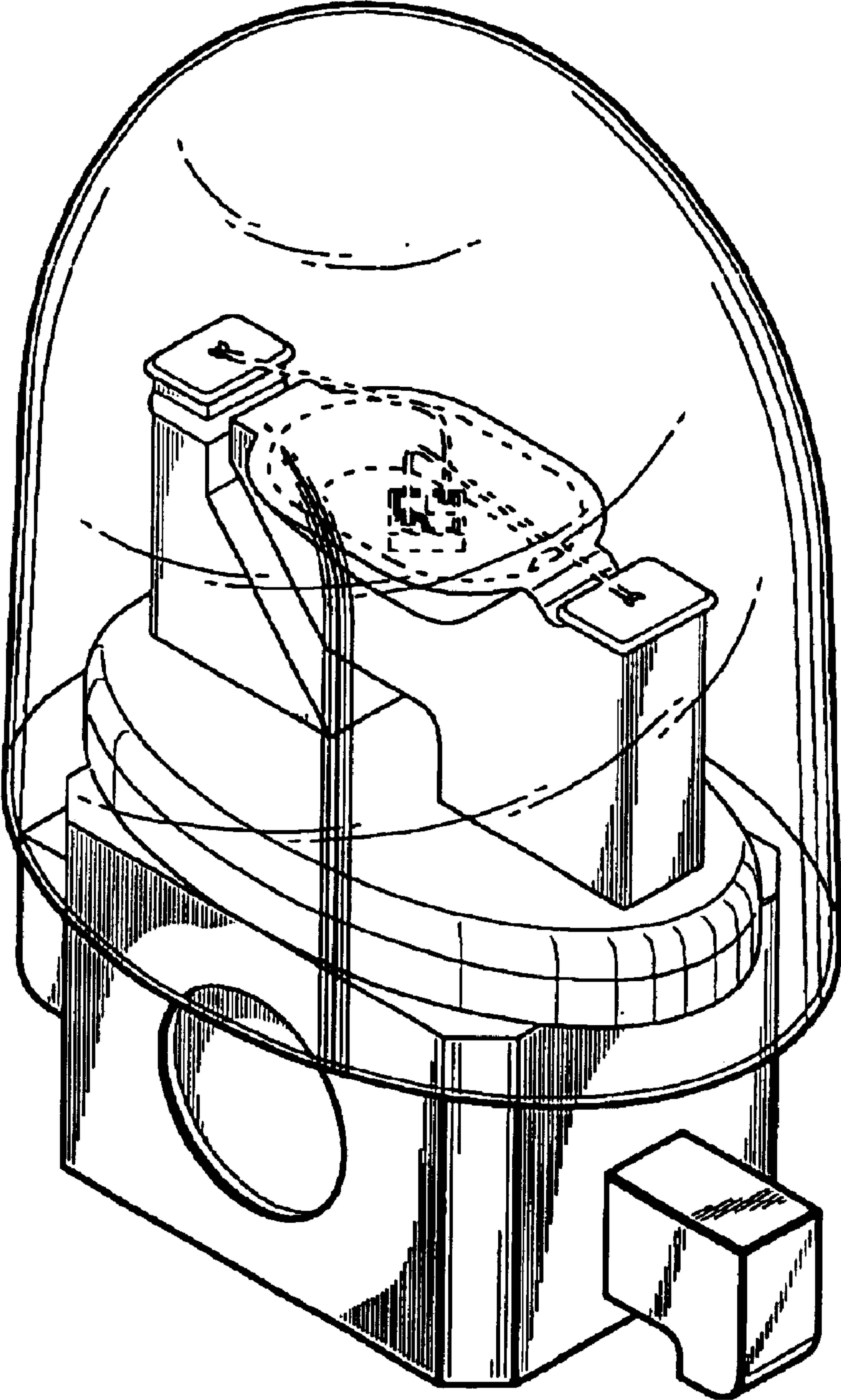

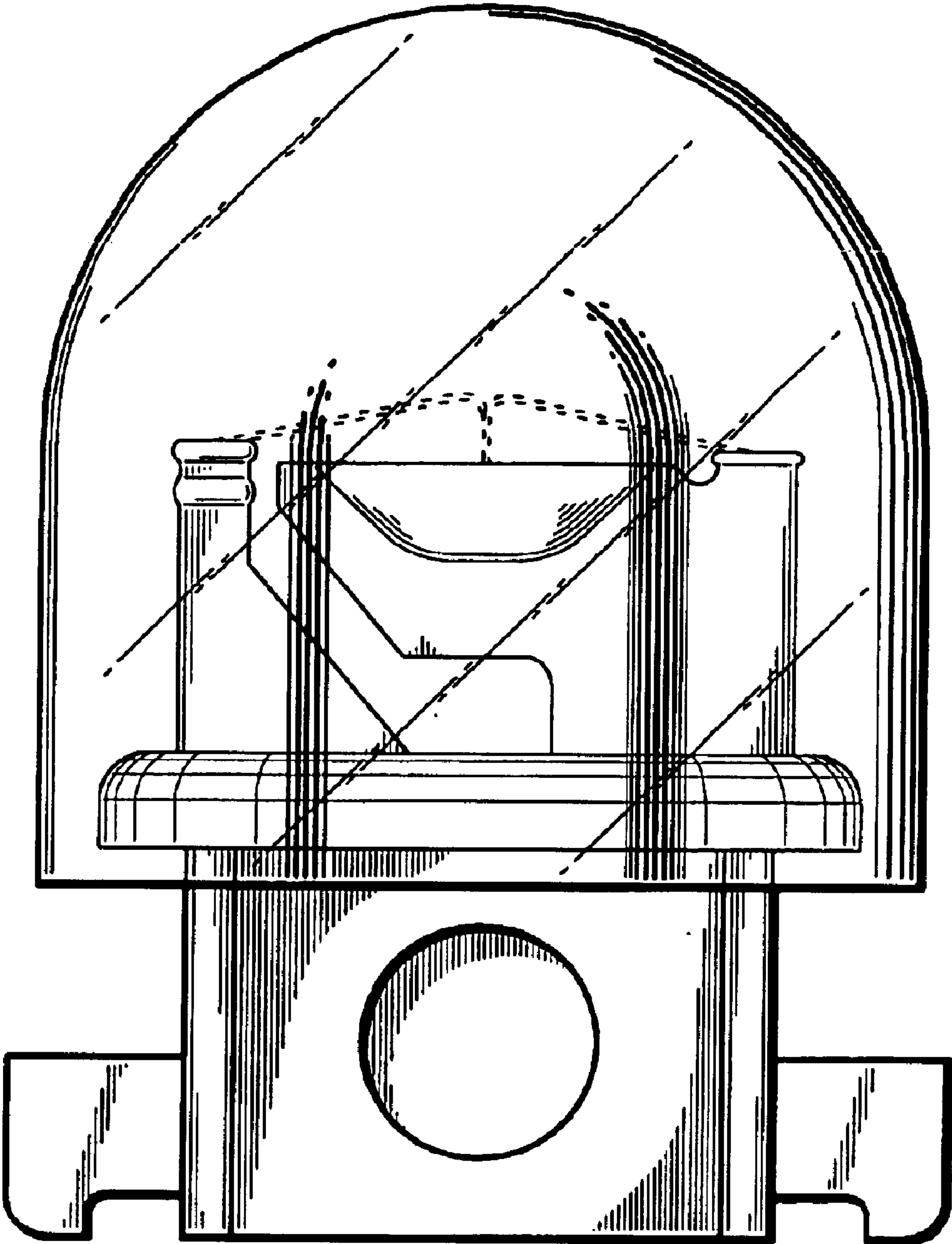

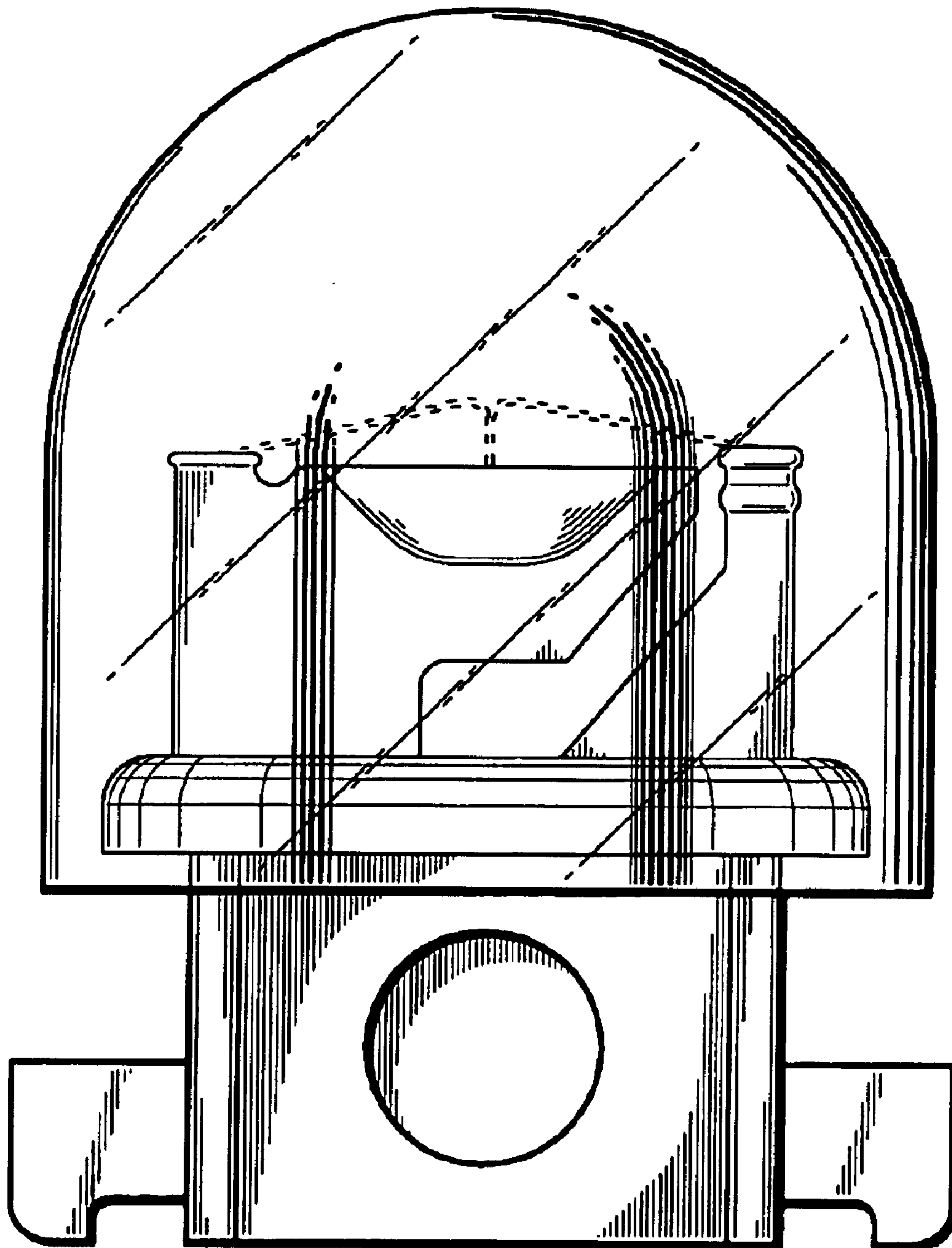

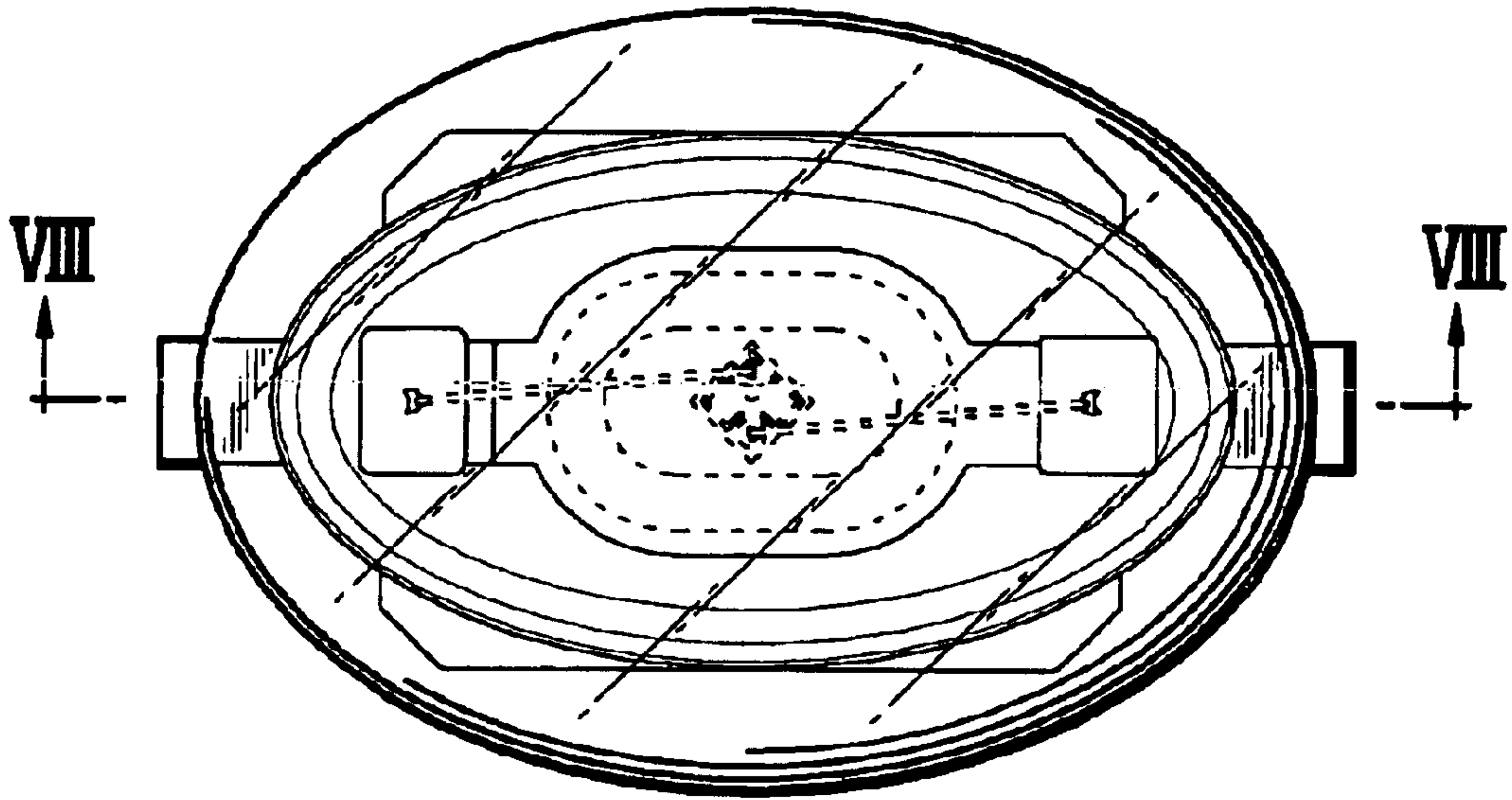

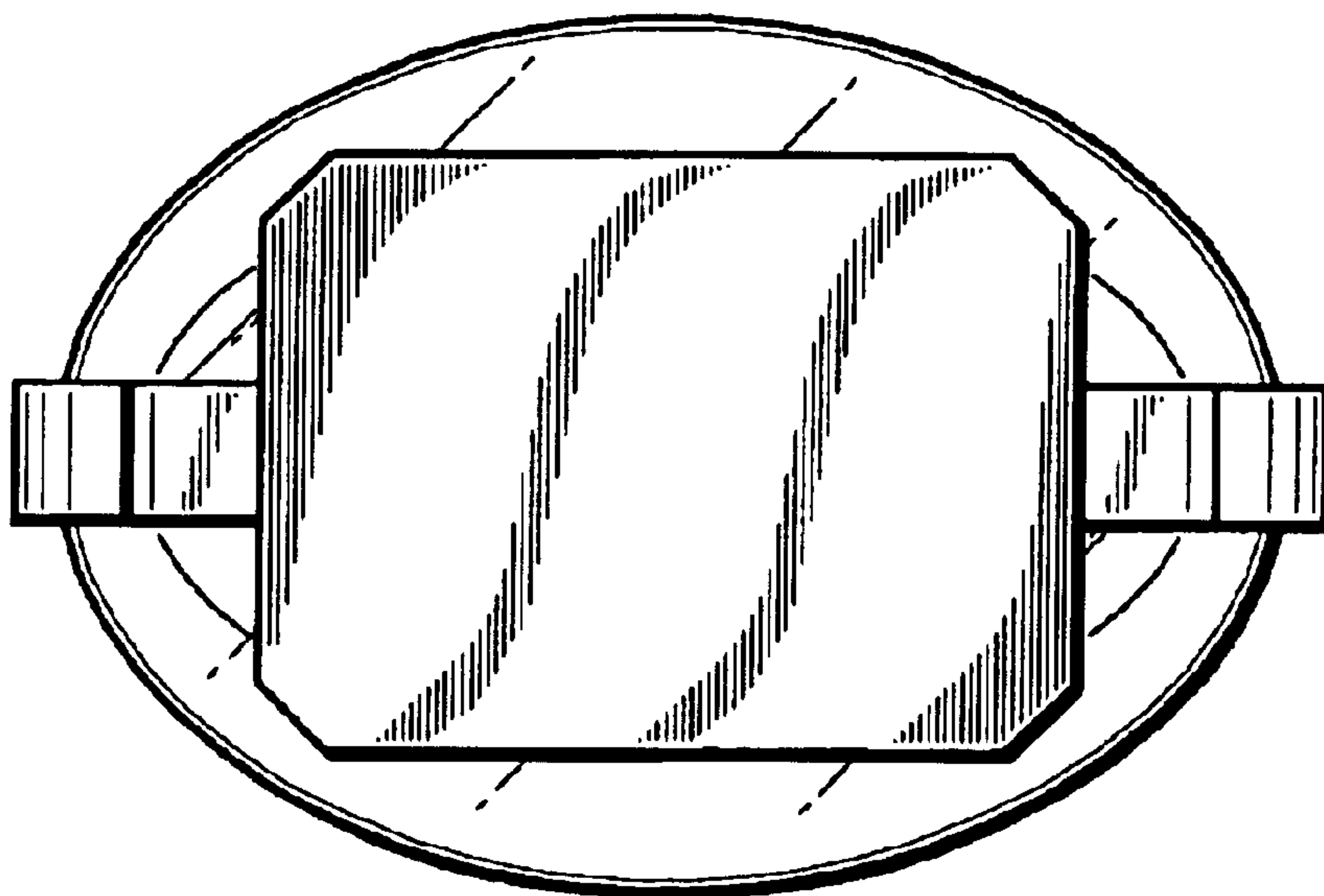

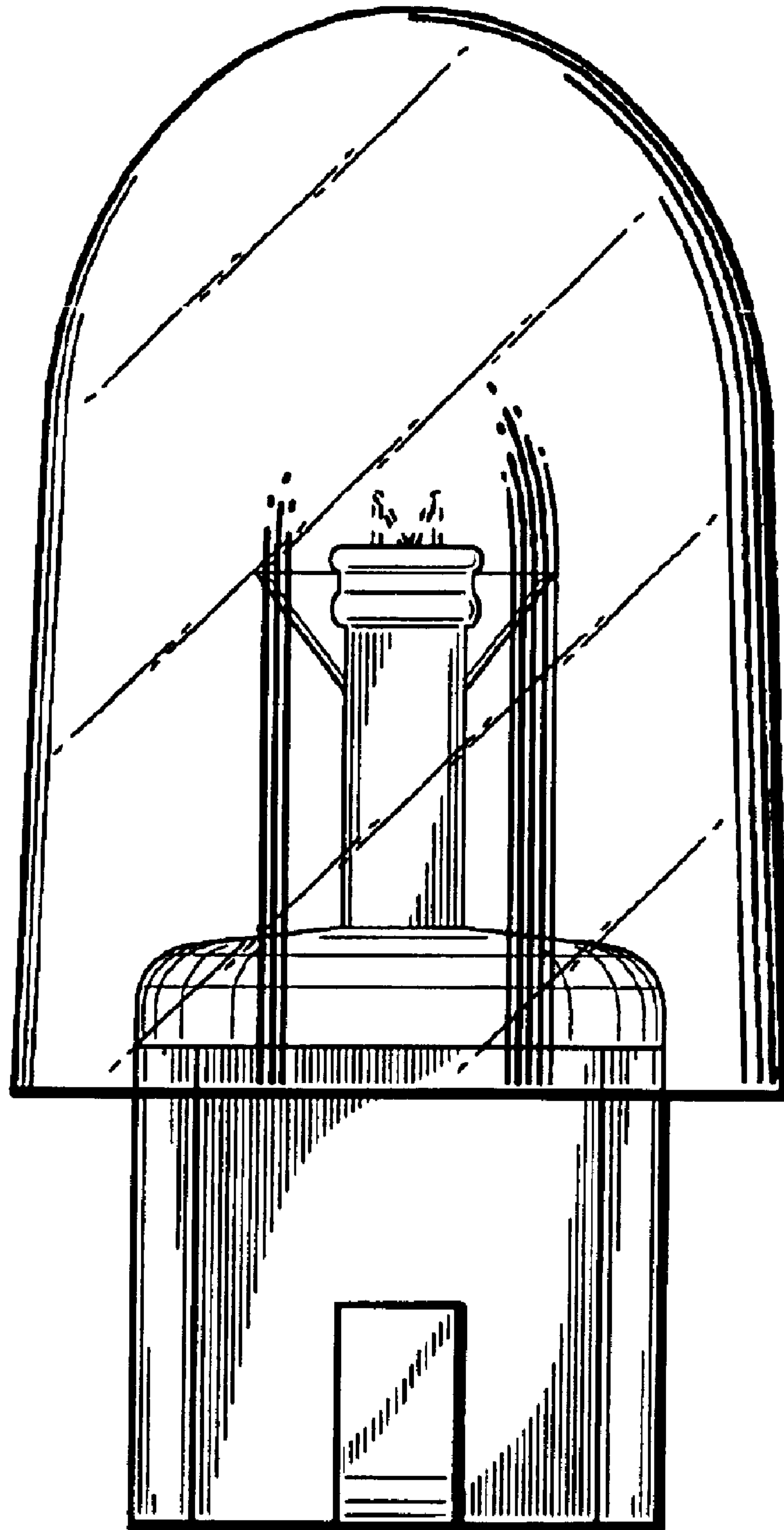

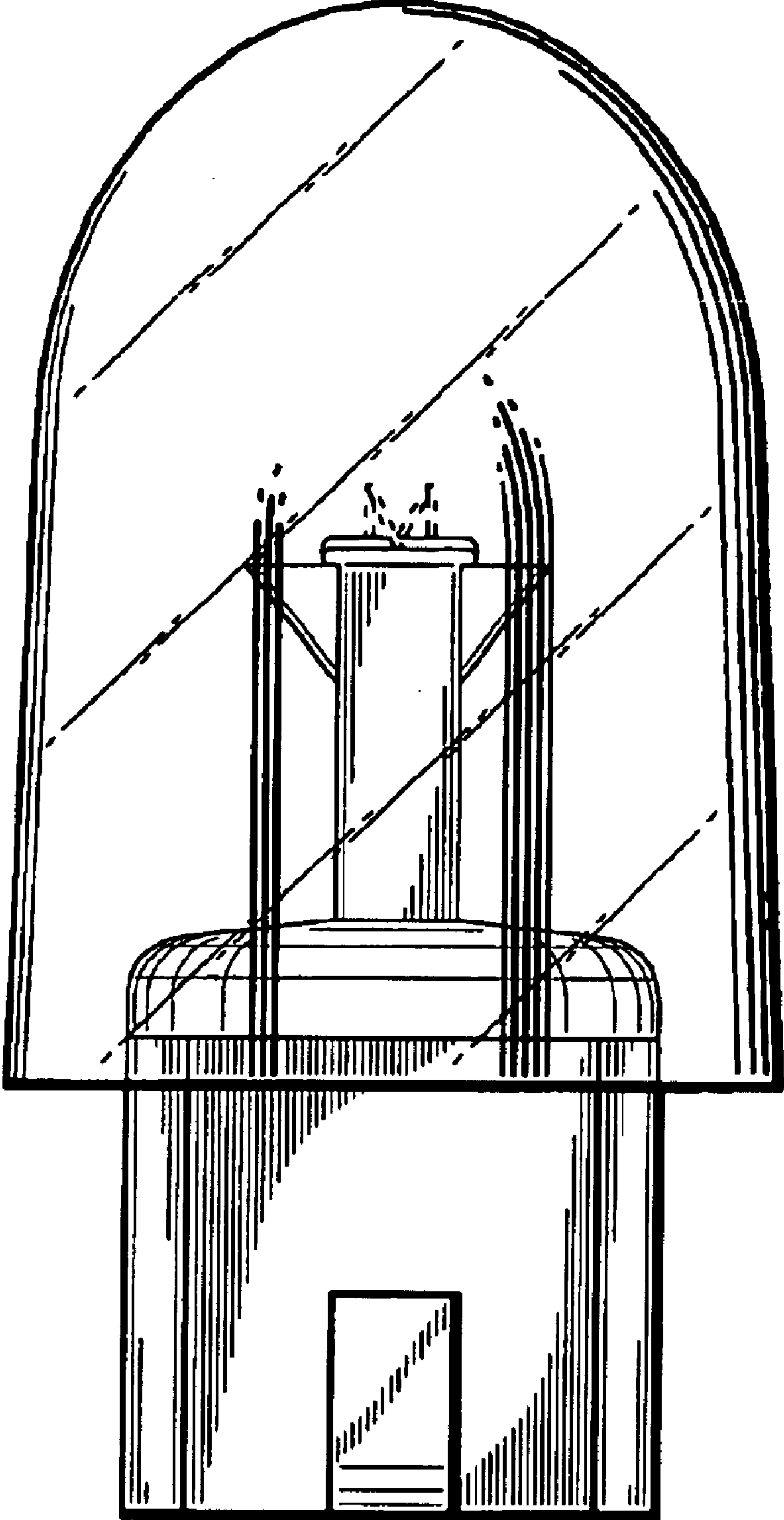
