The ornamental design for a front cover for a handset, as shown and described.

DESCRIPTION

FIG. 1 is bottom end view of the front cover for a headset of the invention;
FIG. 2 is a left side view of the front cover for a handset of FIG. 1;
FIG. 3 is a front elevational view of the front cover for a handset of FIG. 1;
FIG. 4 is a right side view of the front cover for a handset of FIG. 1;
FIG. 5 is a top end view of the of the front cover for a handset of FIG. 1; and,
FIG. 6 is a perspective view of the front cover for a handset of FIG. 1 taken from the front and left.

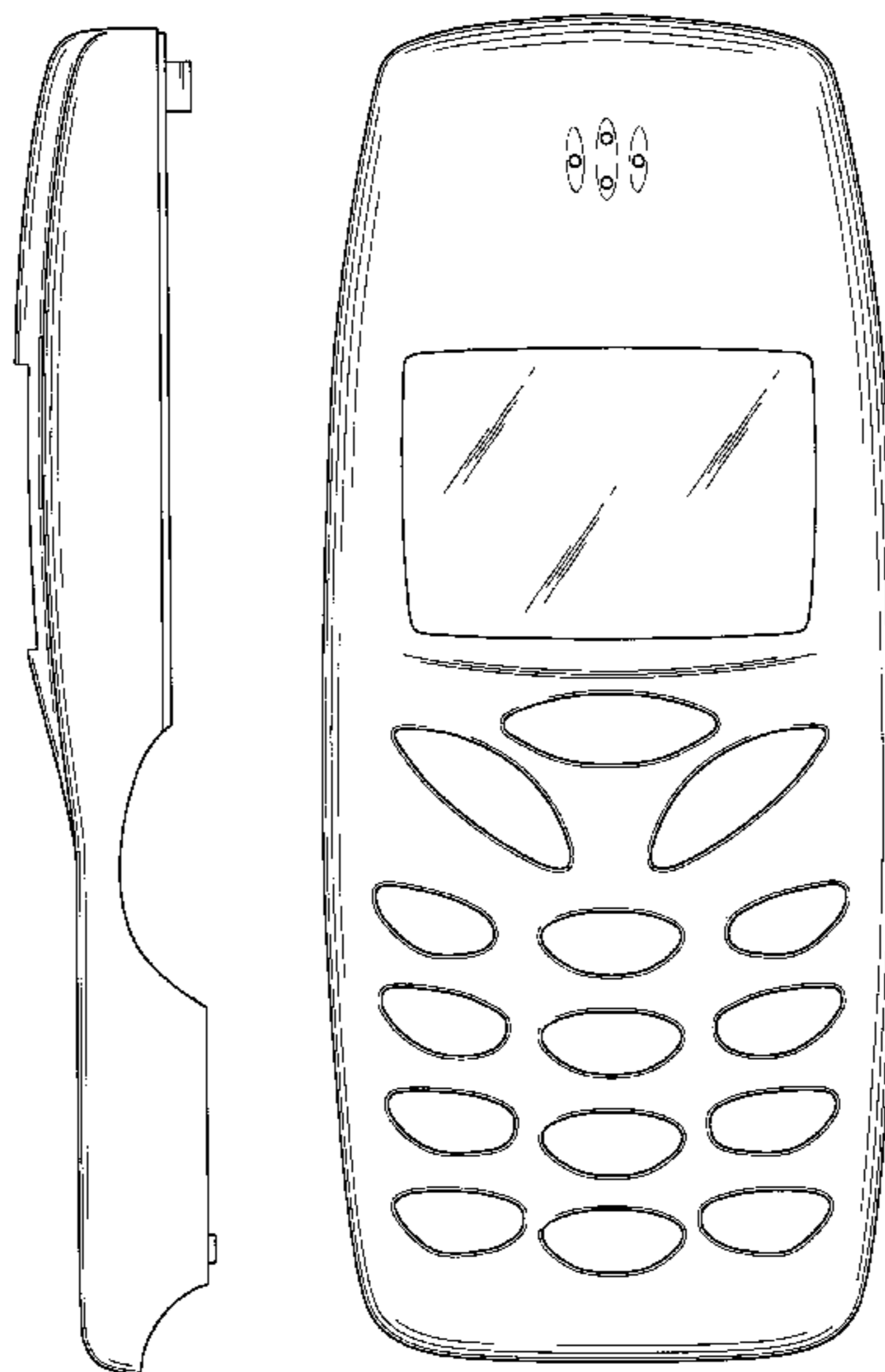

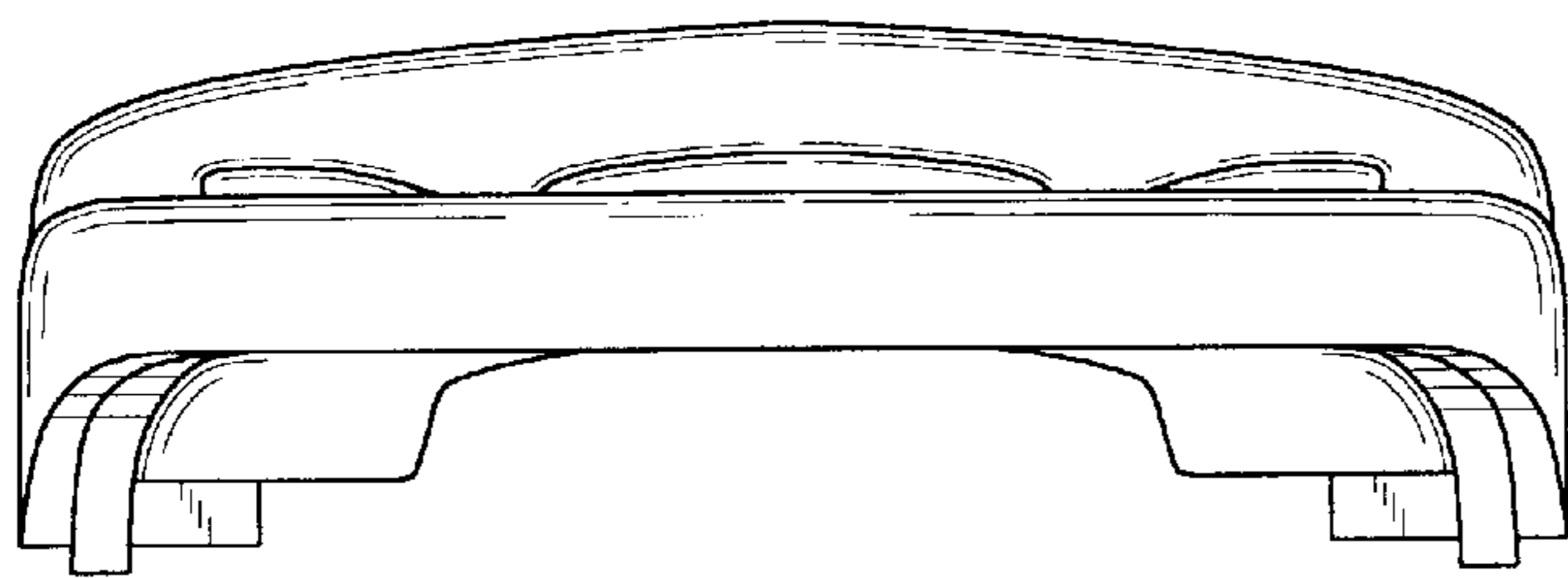

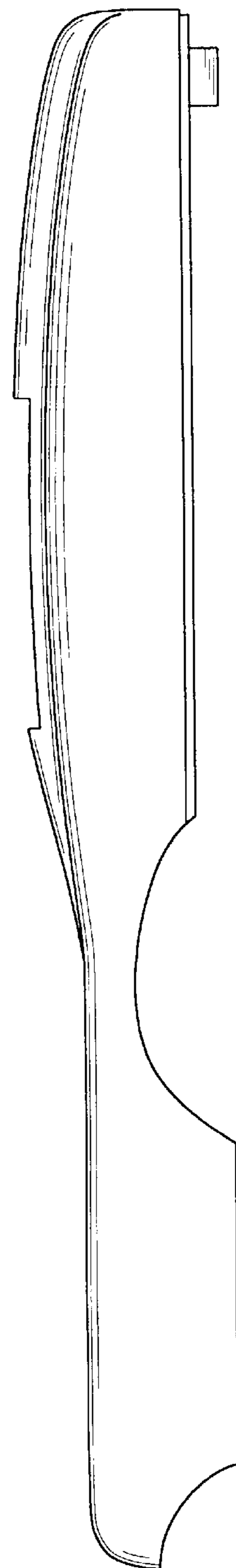

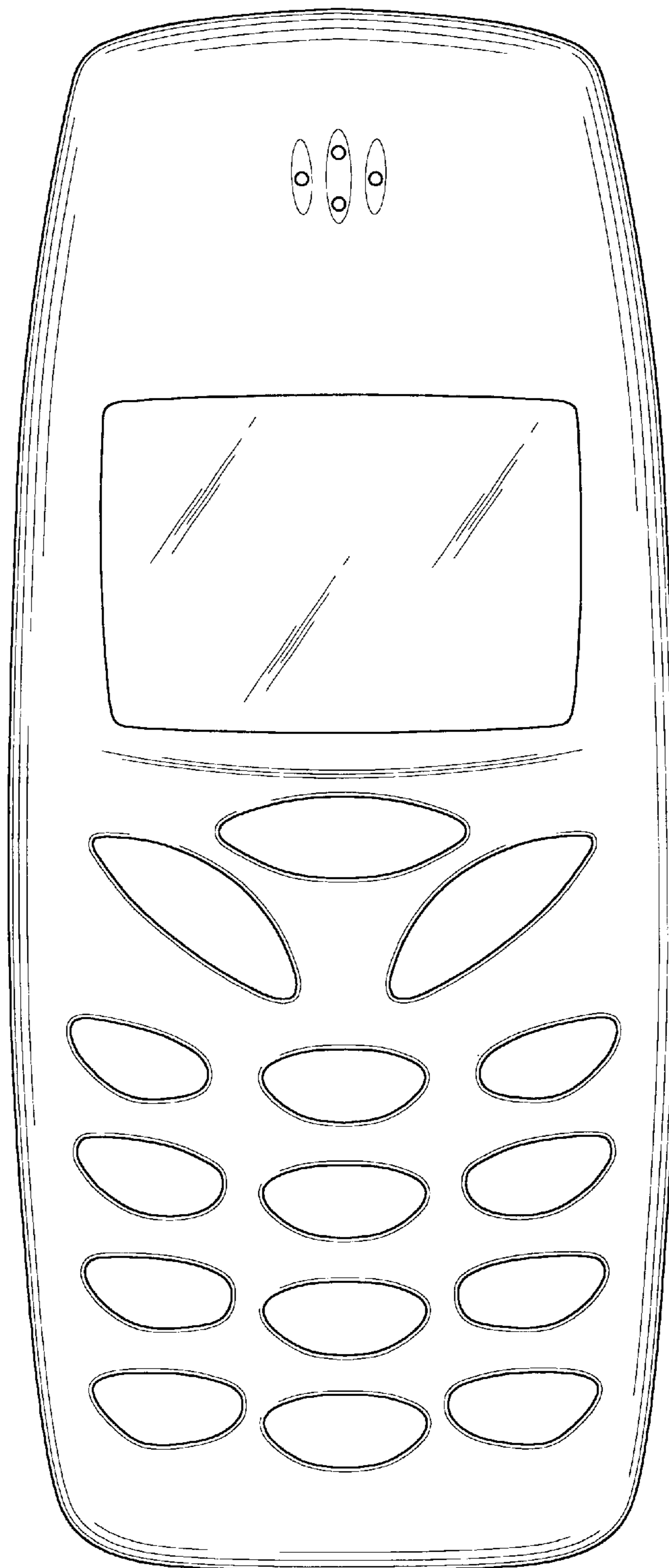

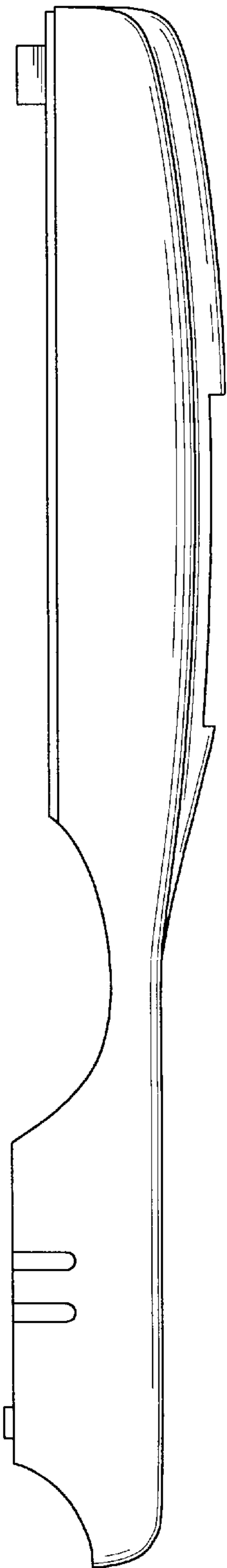

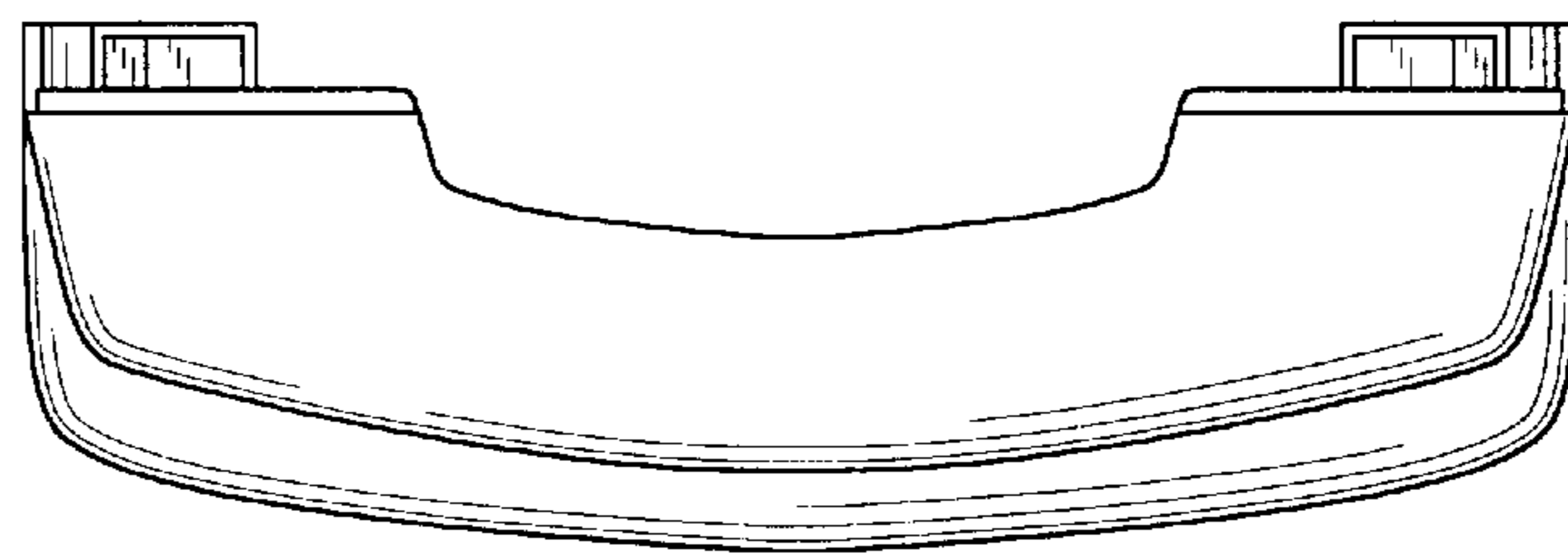

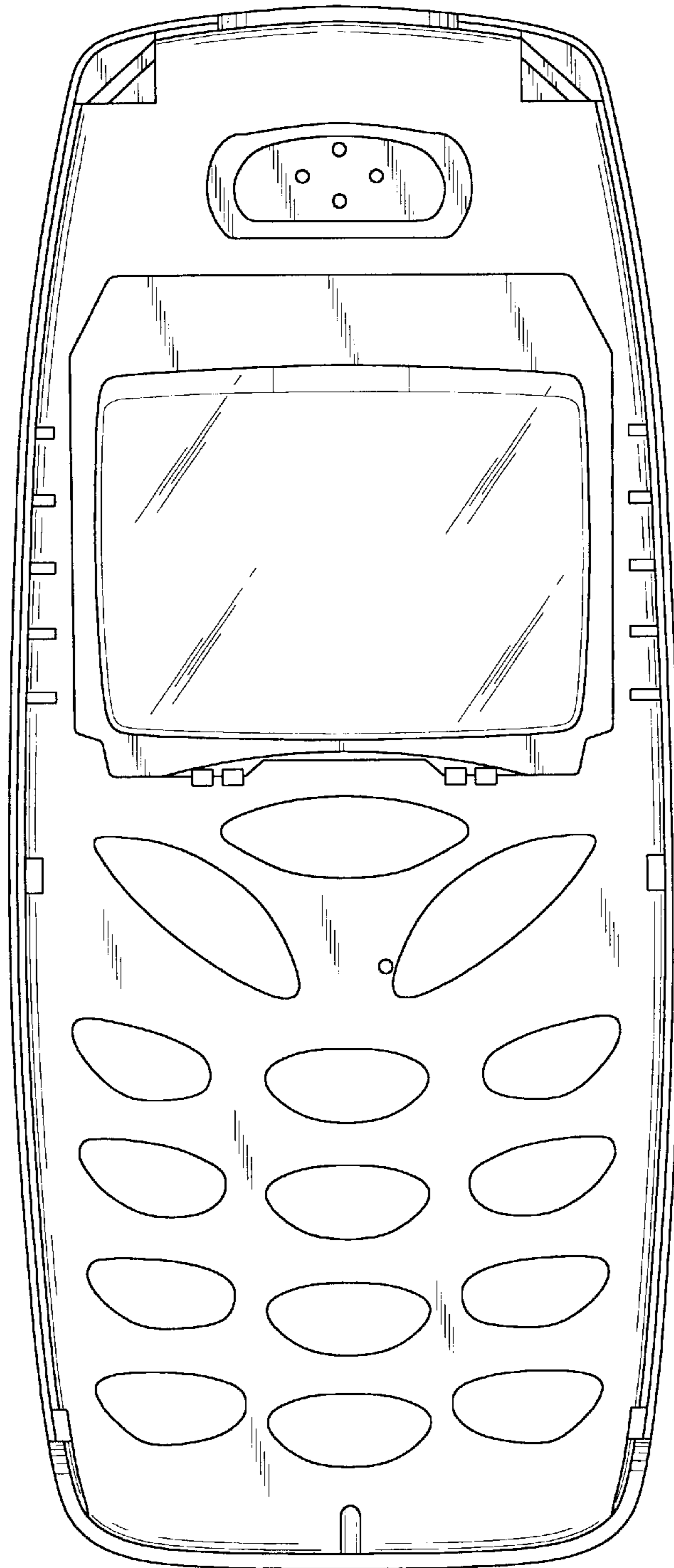
