FIG. 20 is a front view of a twentieth embodiment thereof;

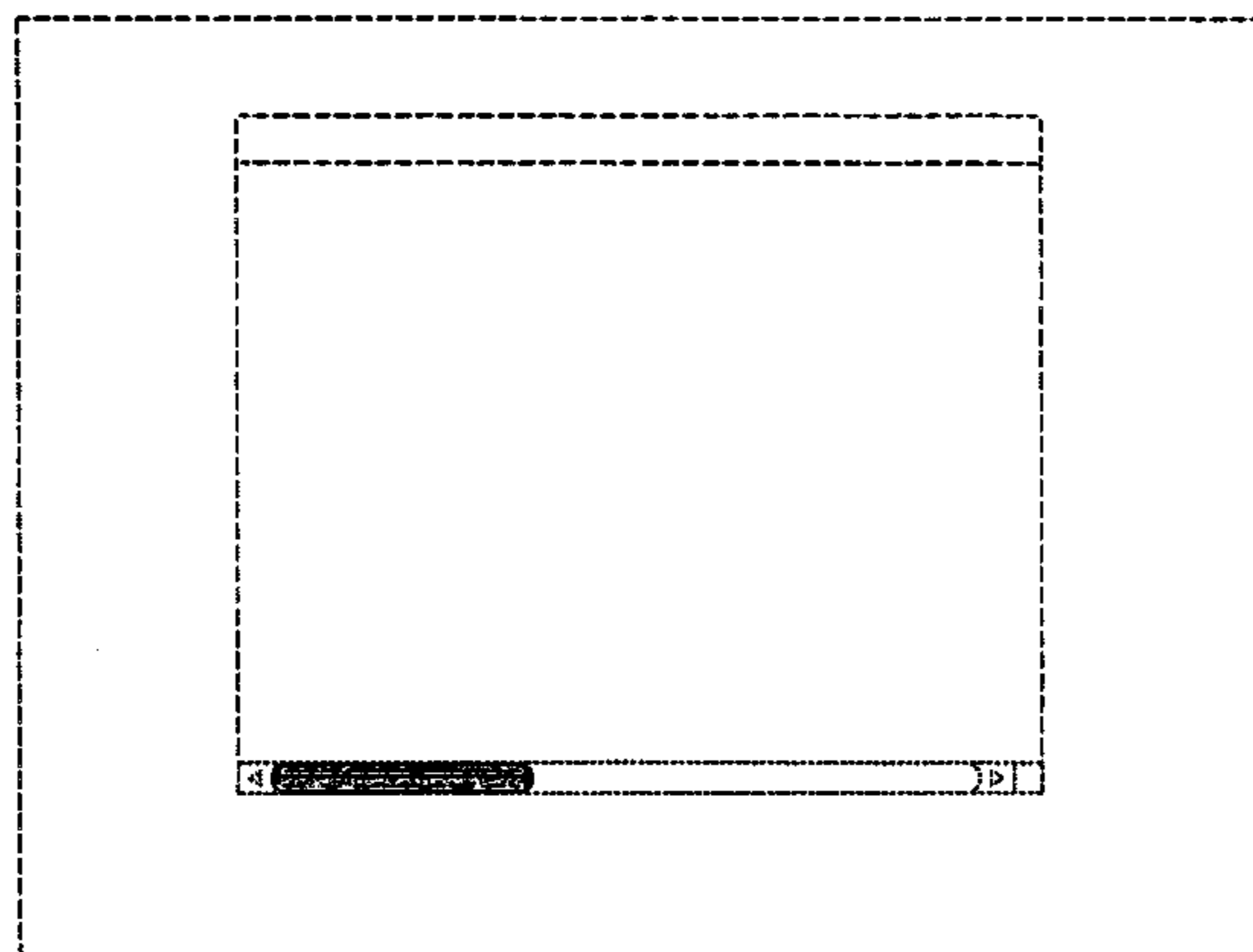
FIG. 21 is a front view of a twenty-first embodiment thereof;

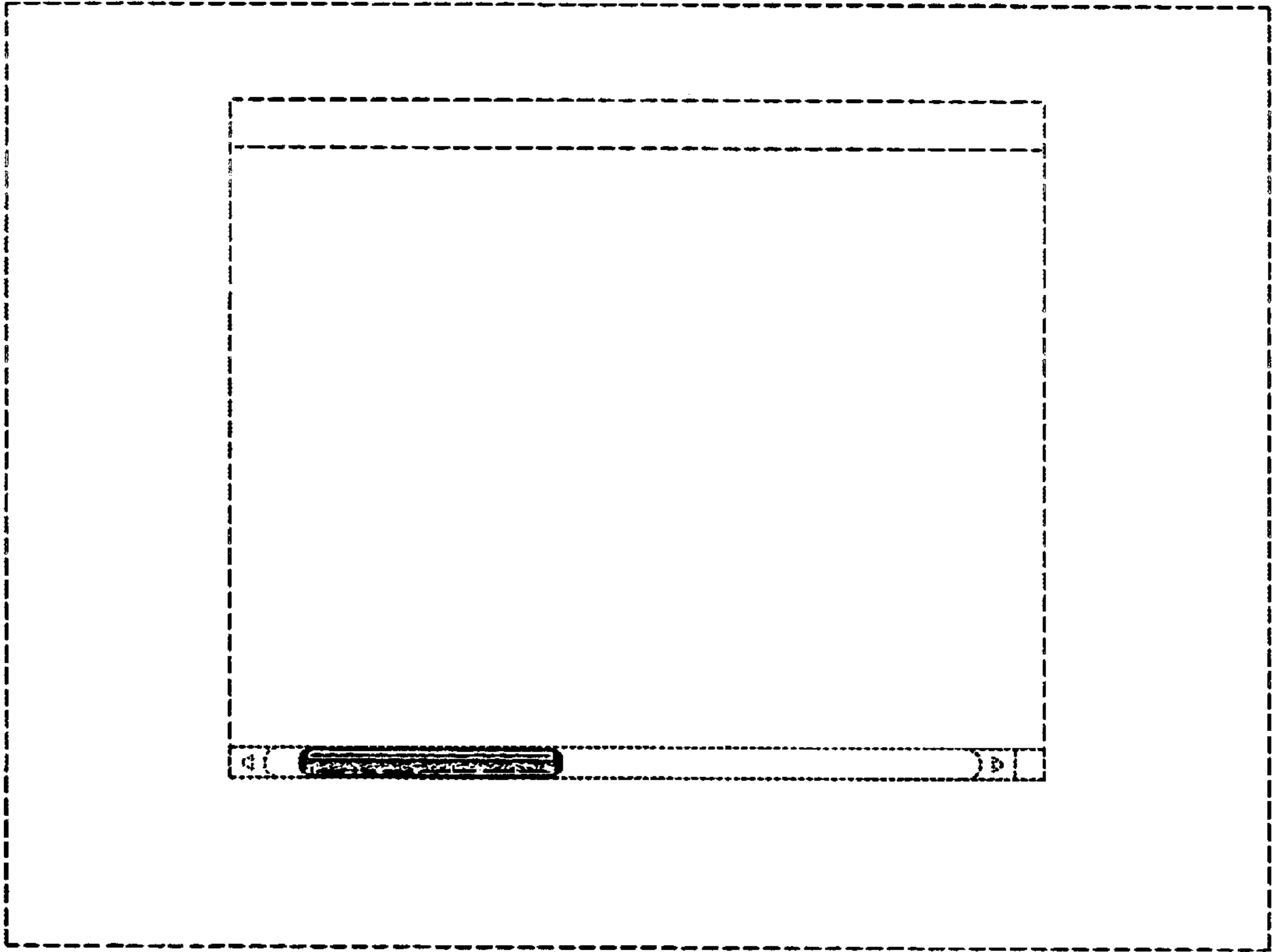

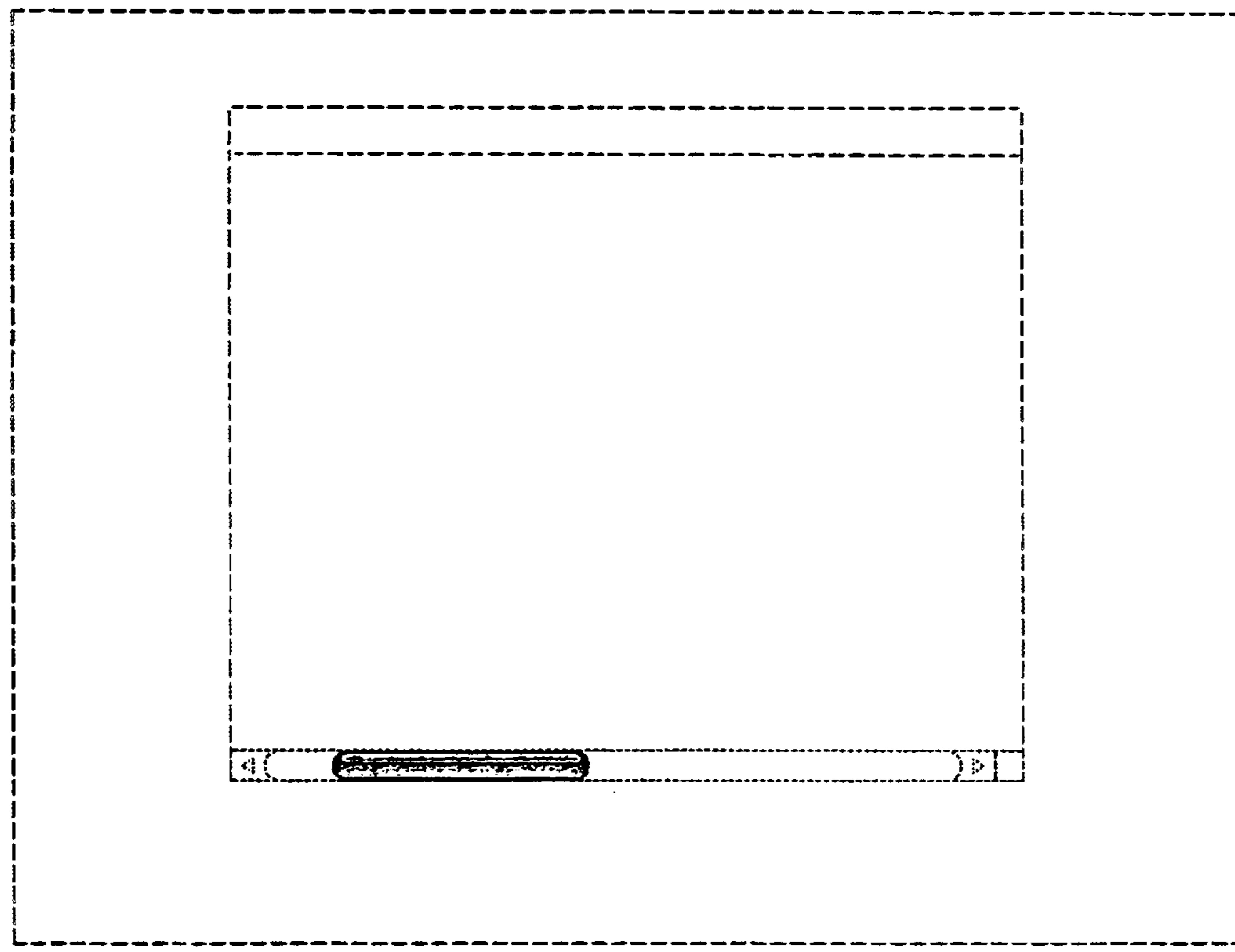

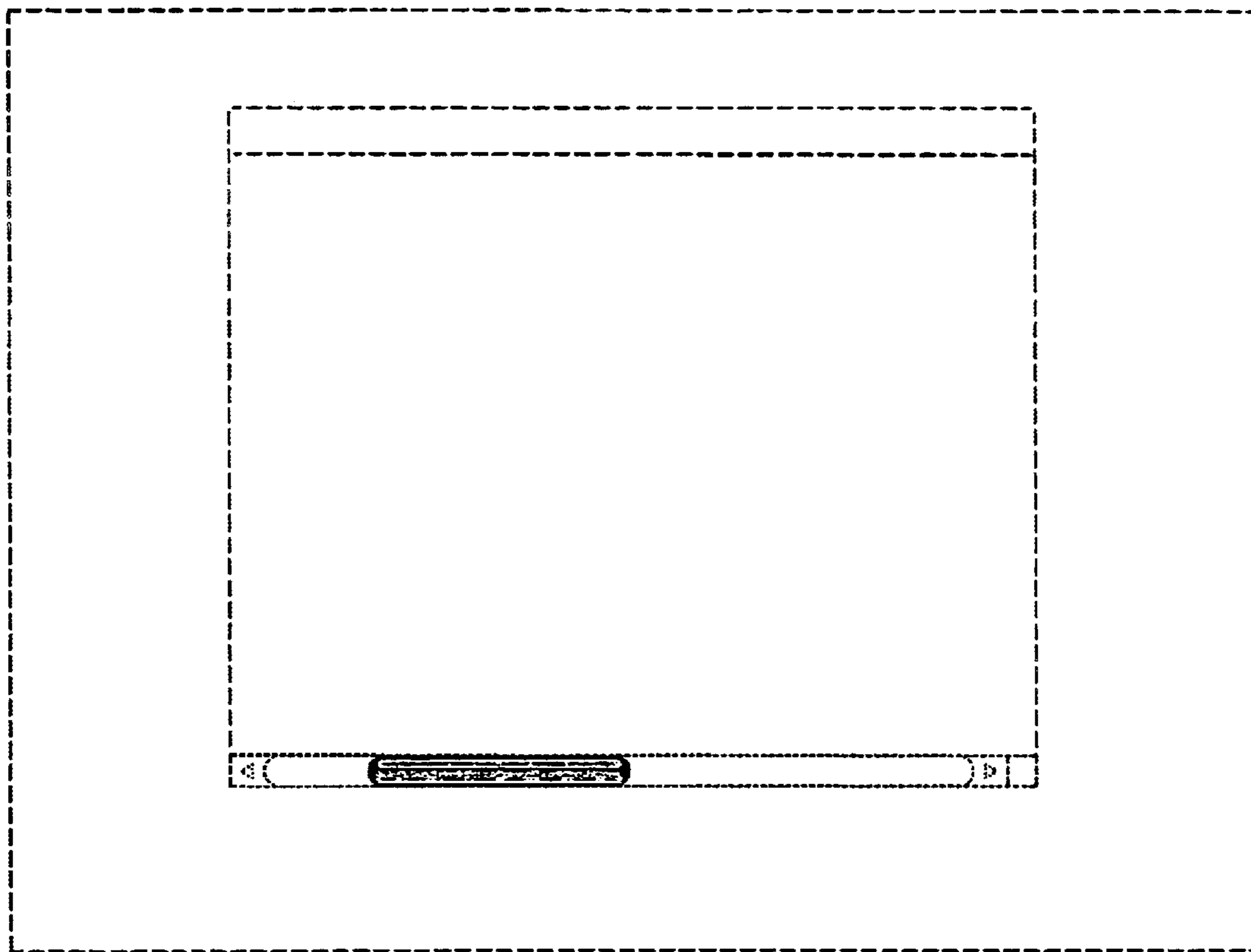
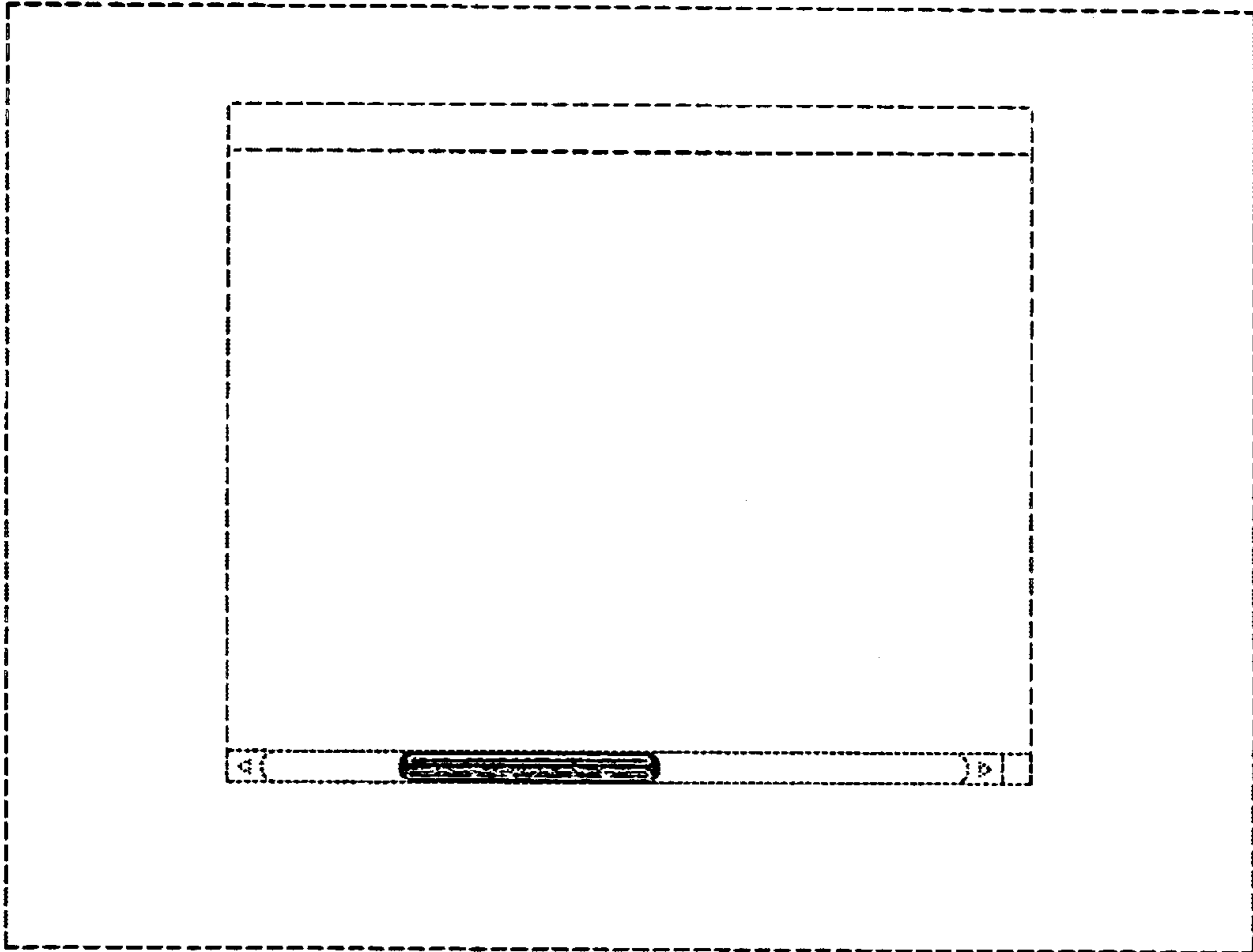
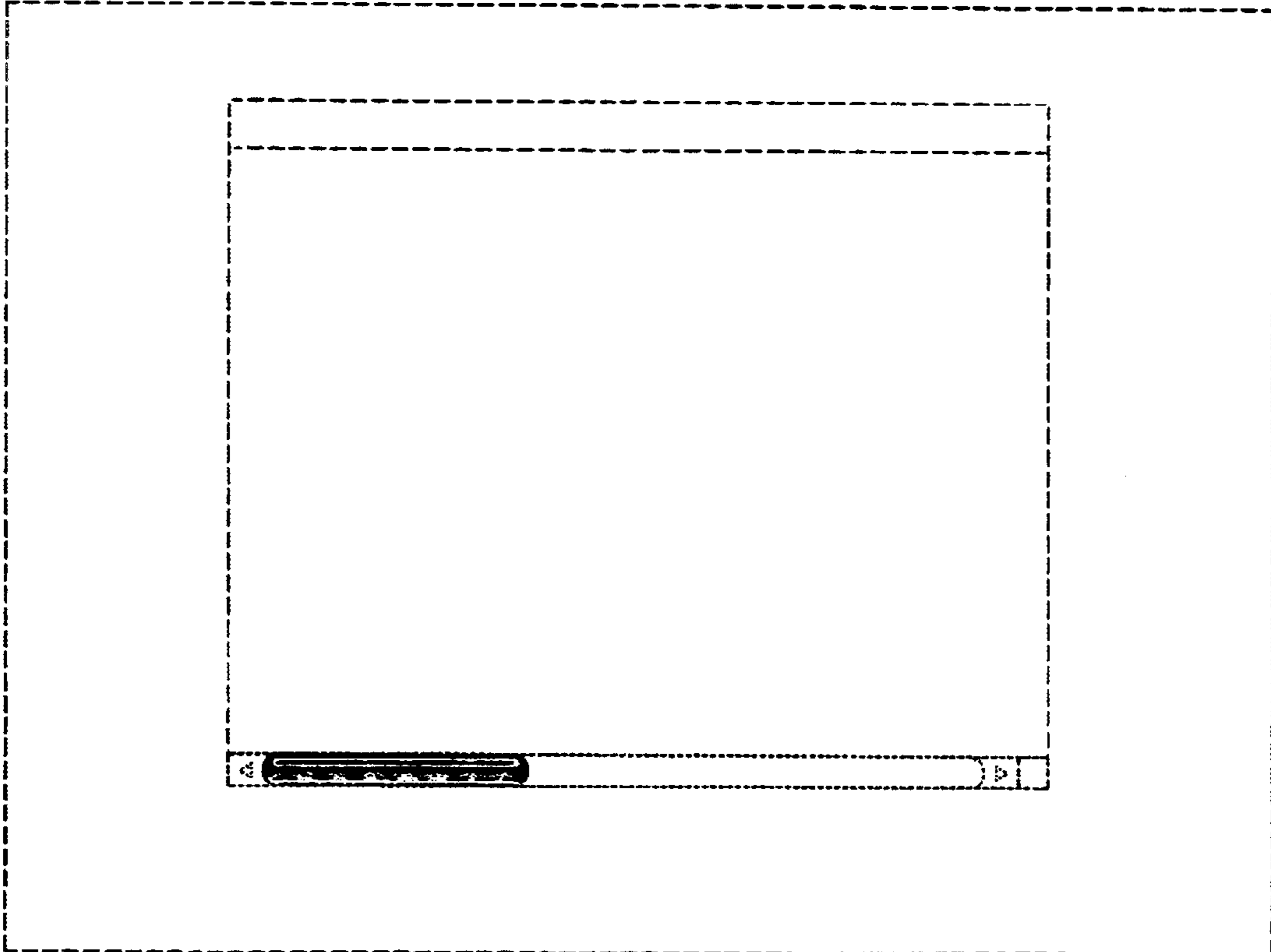

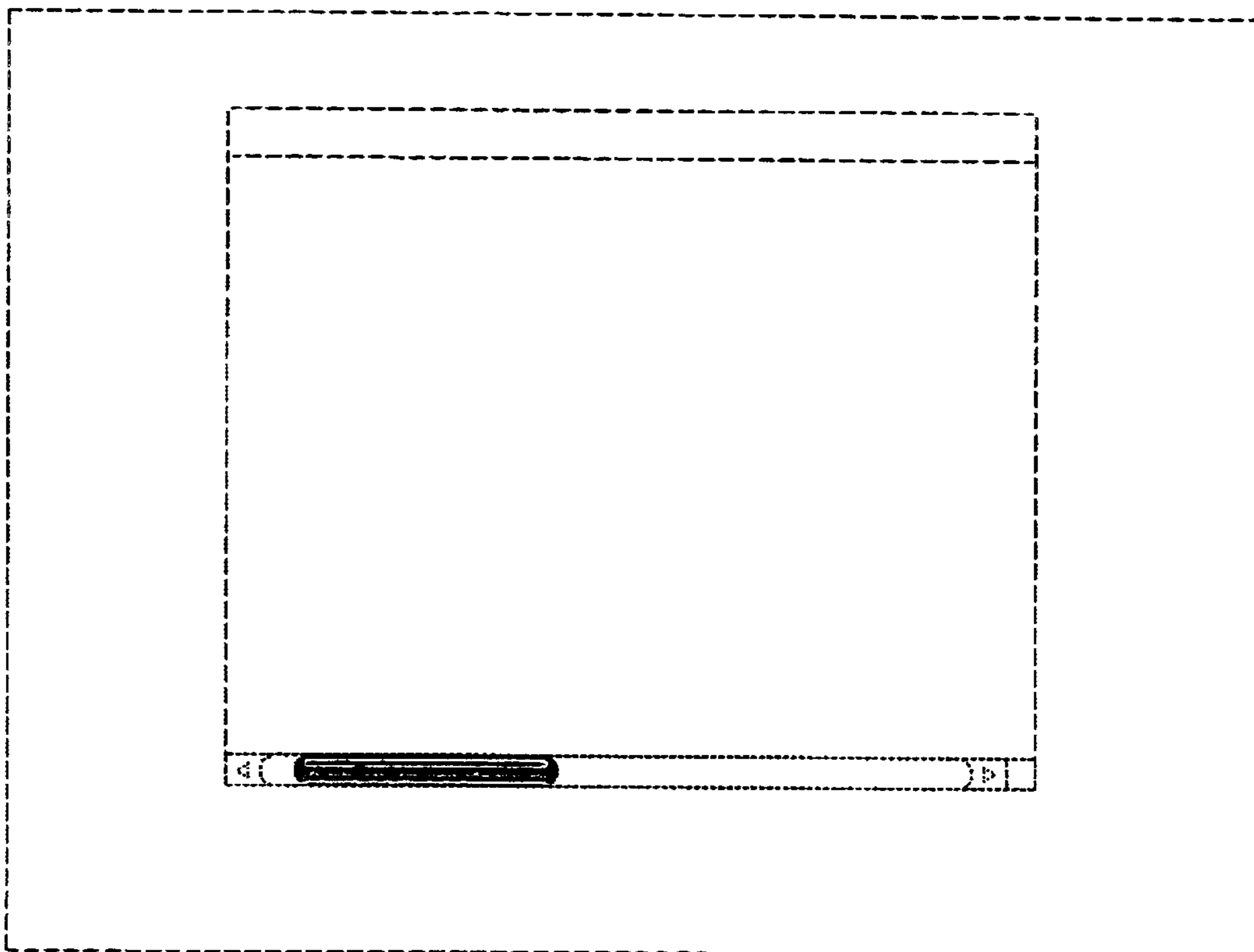

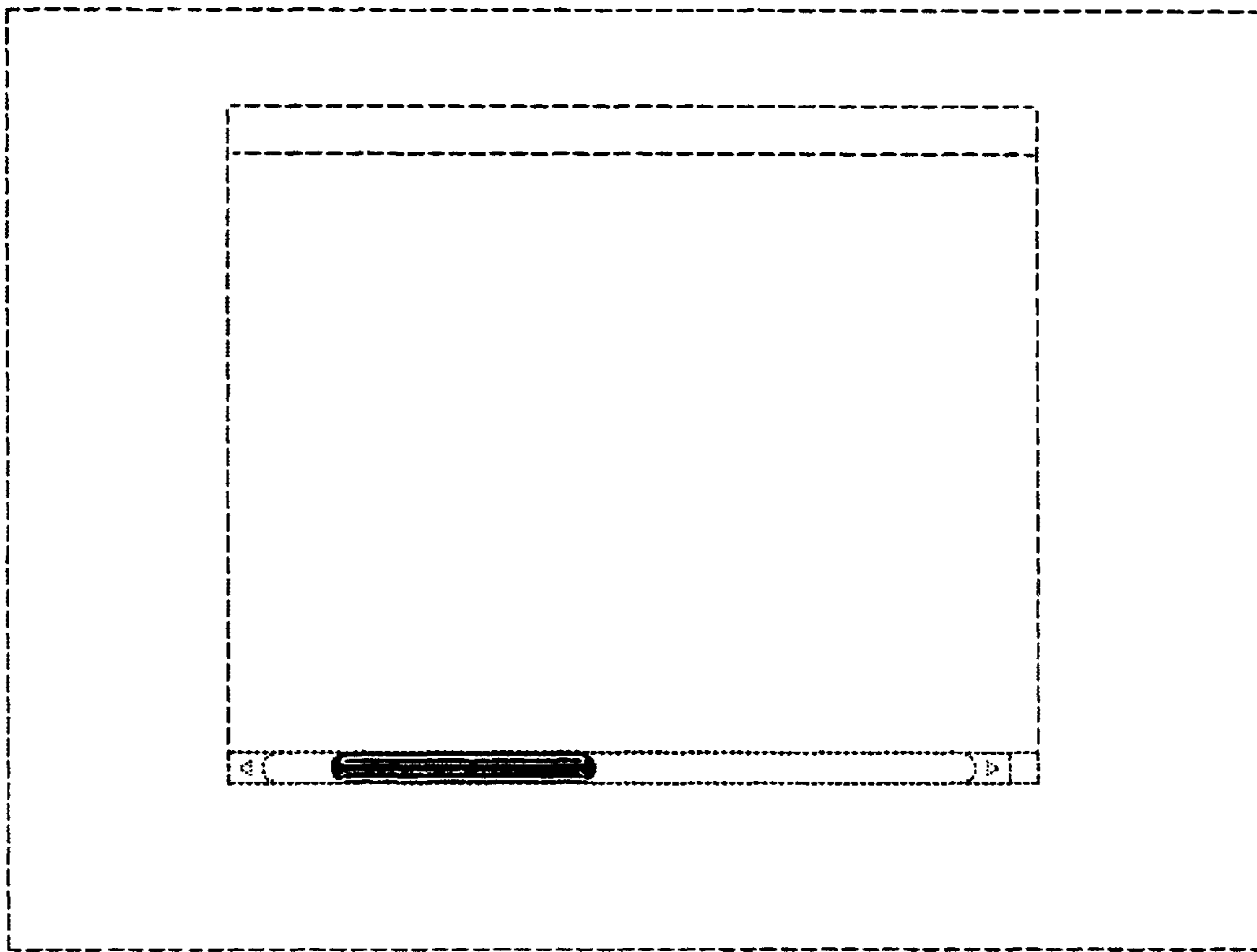

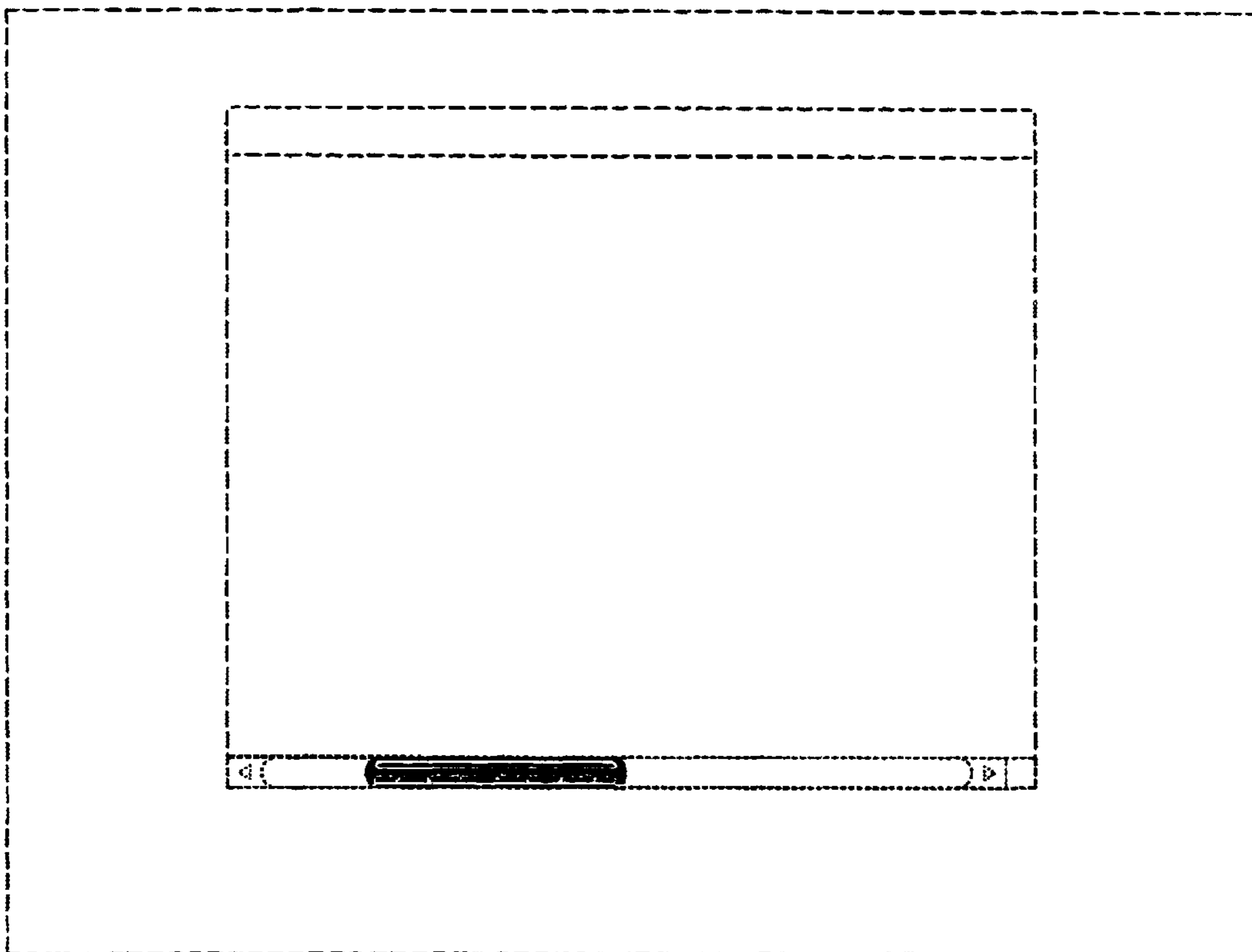

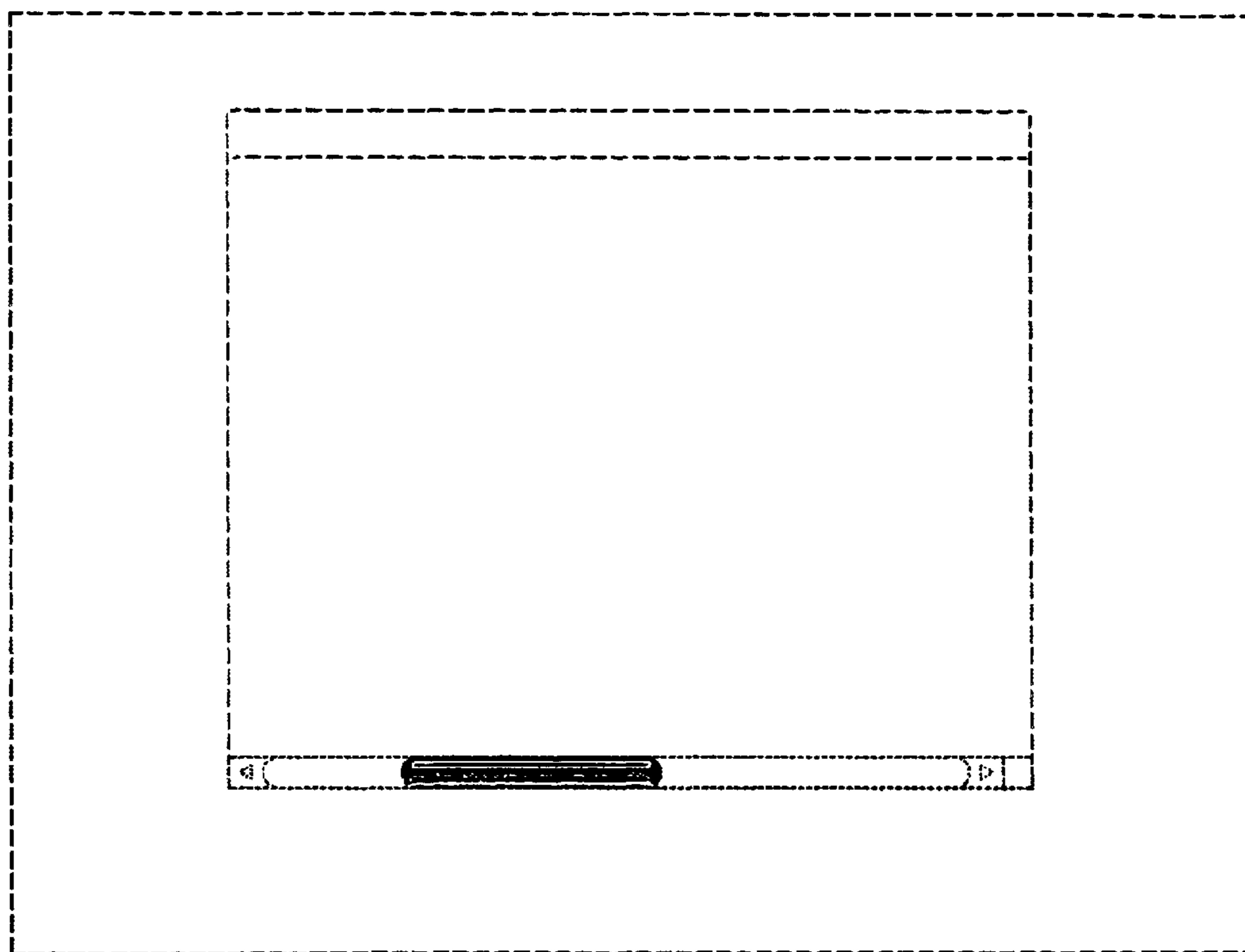


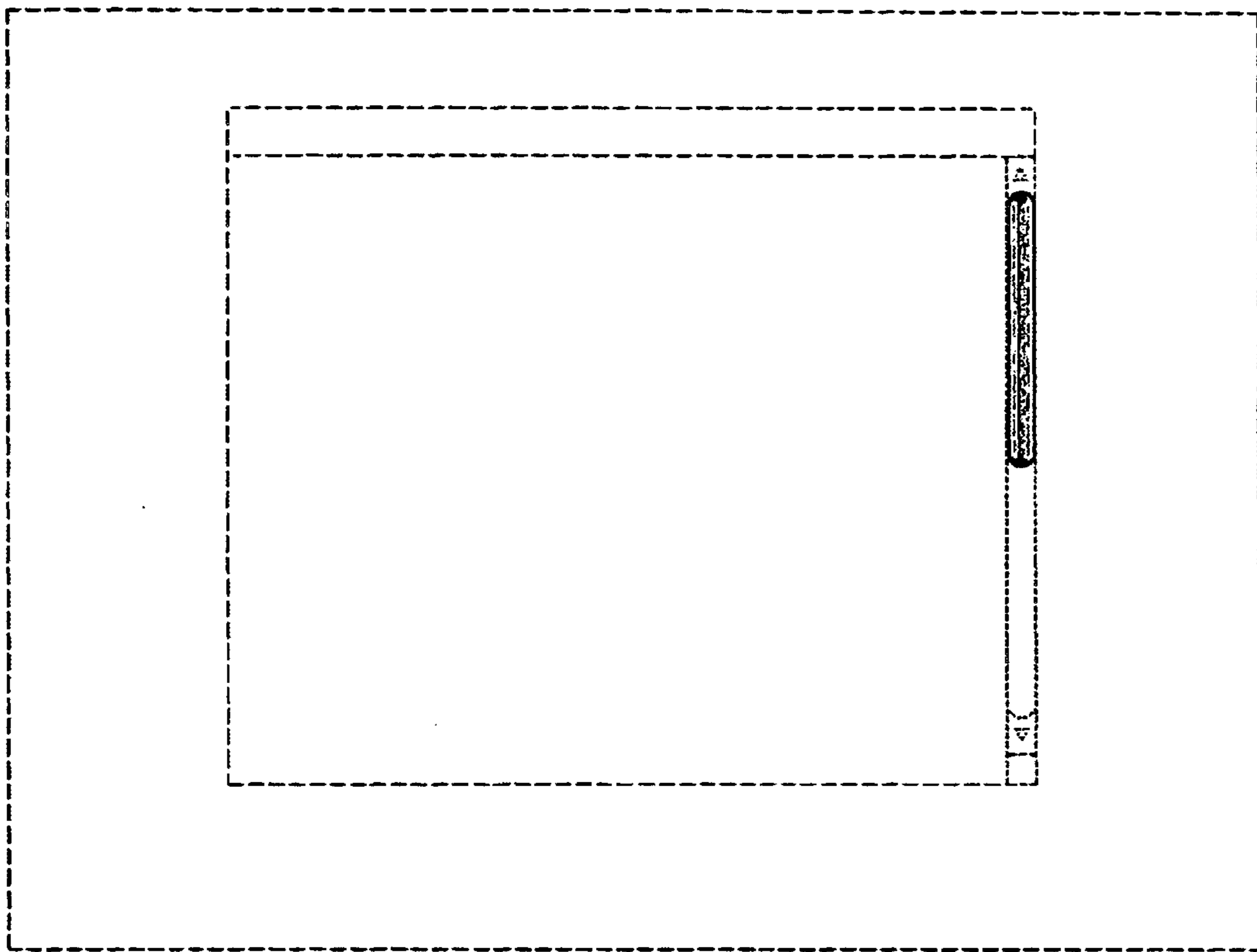

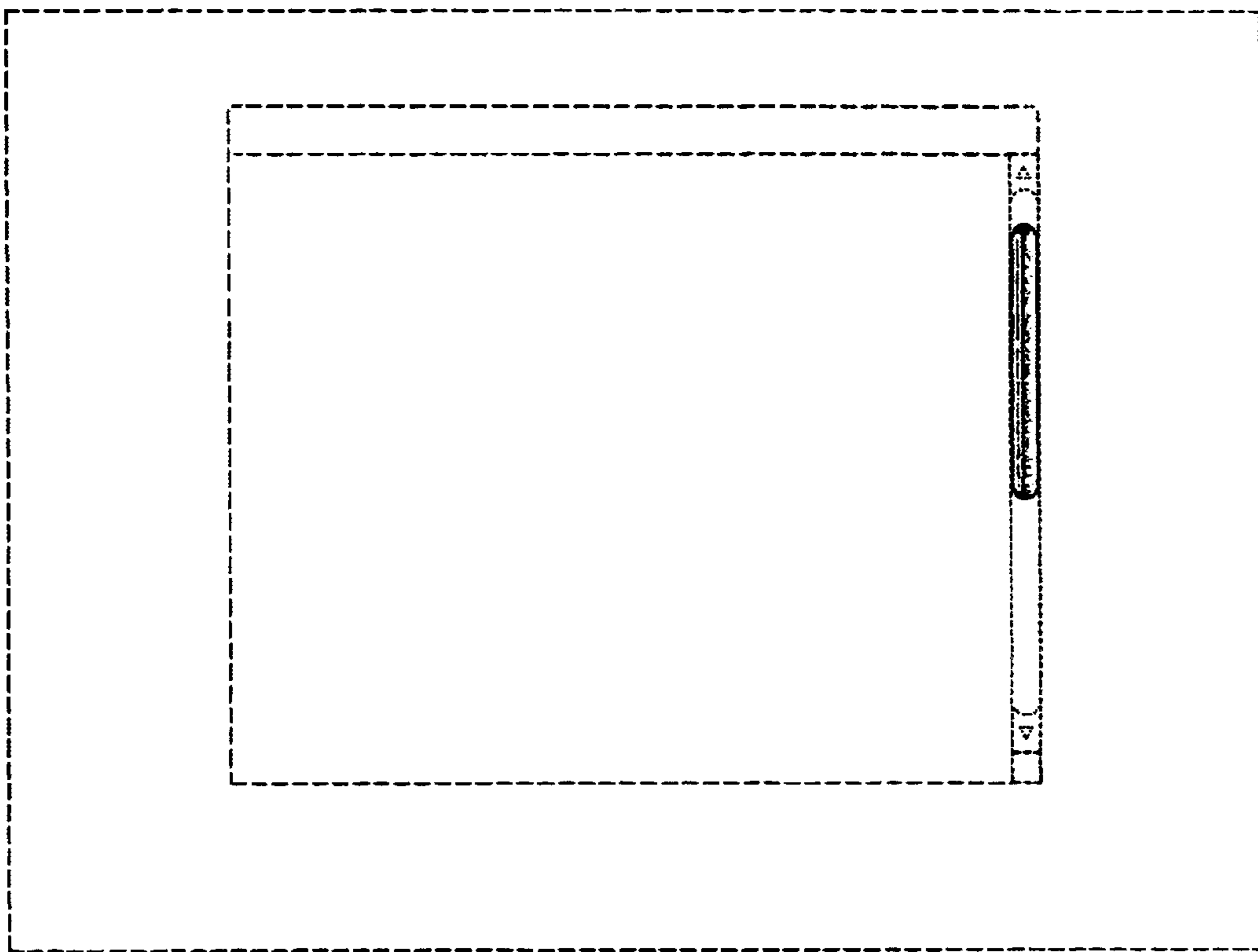

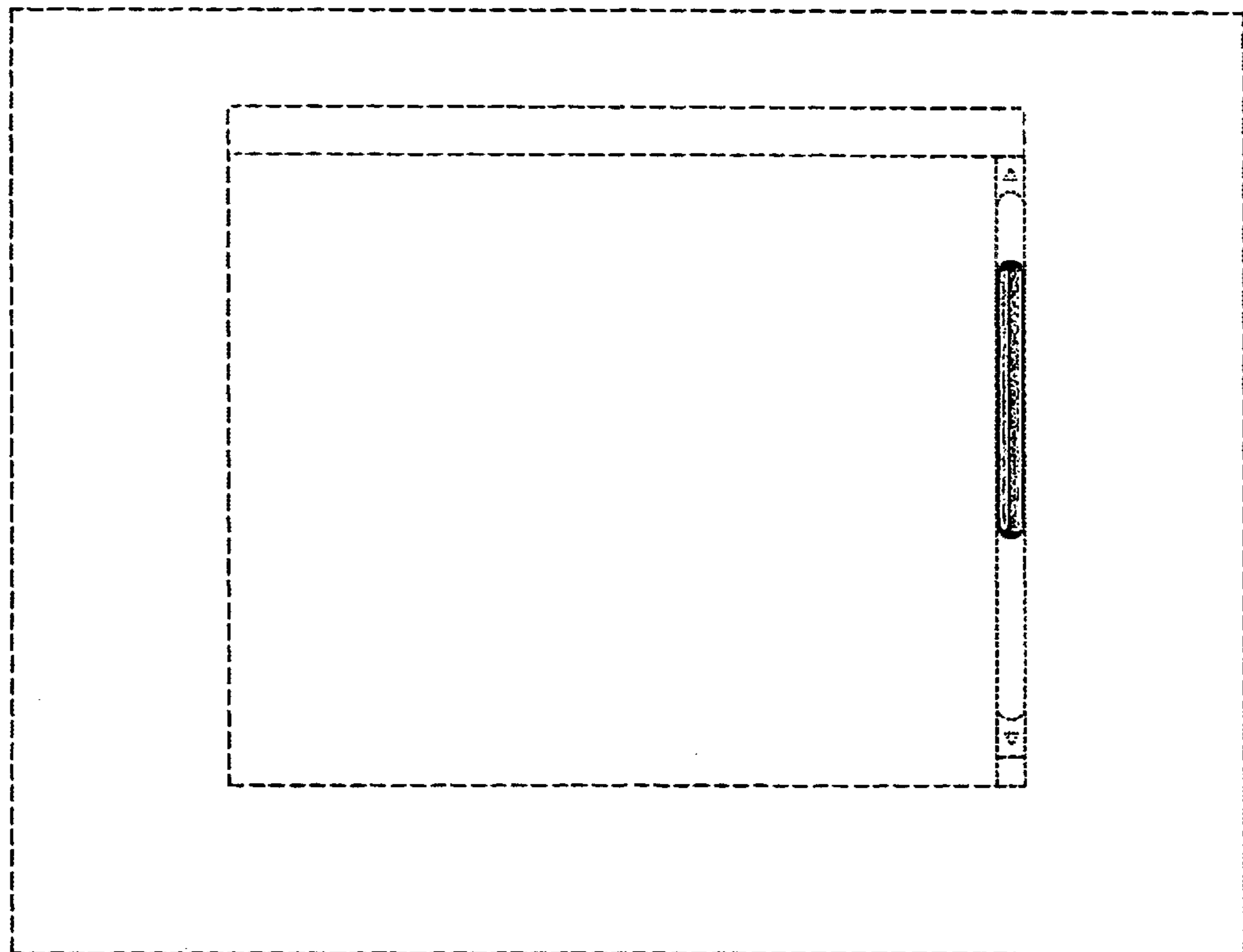

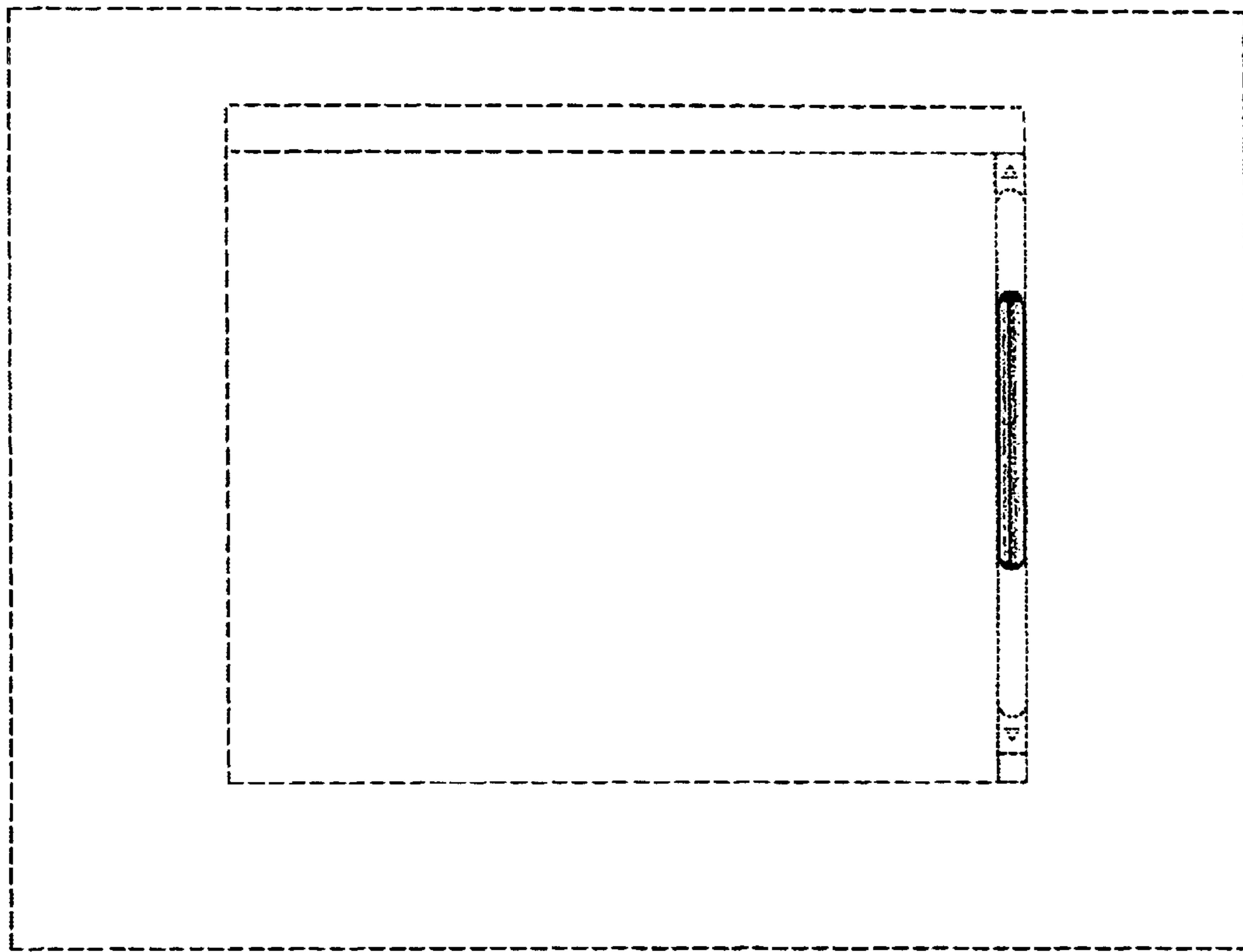

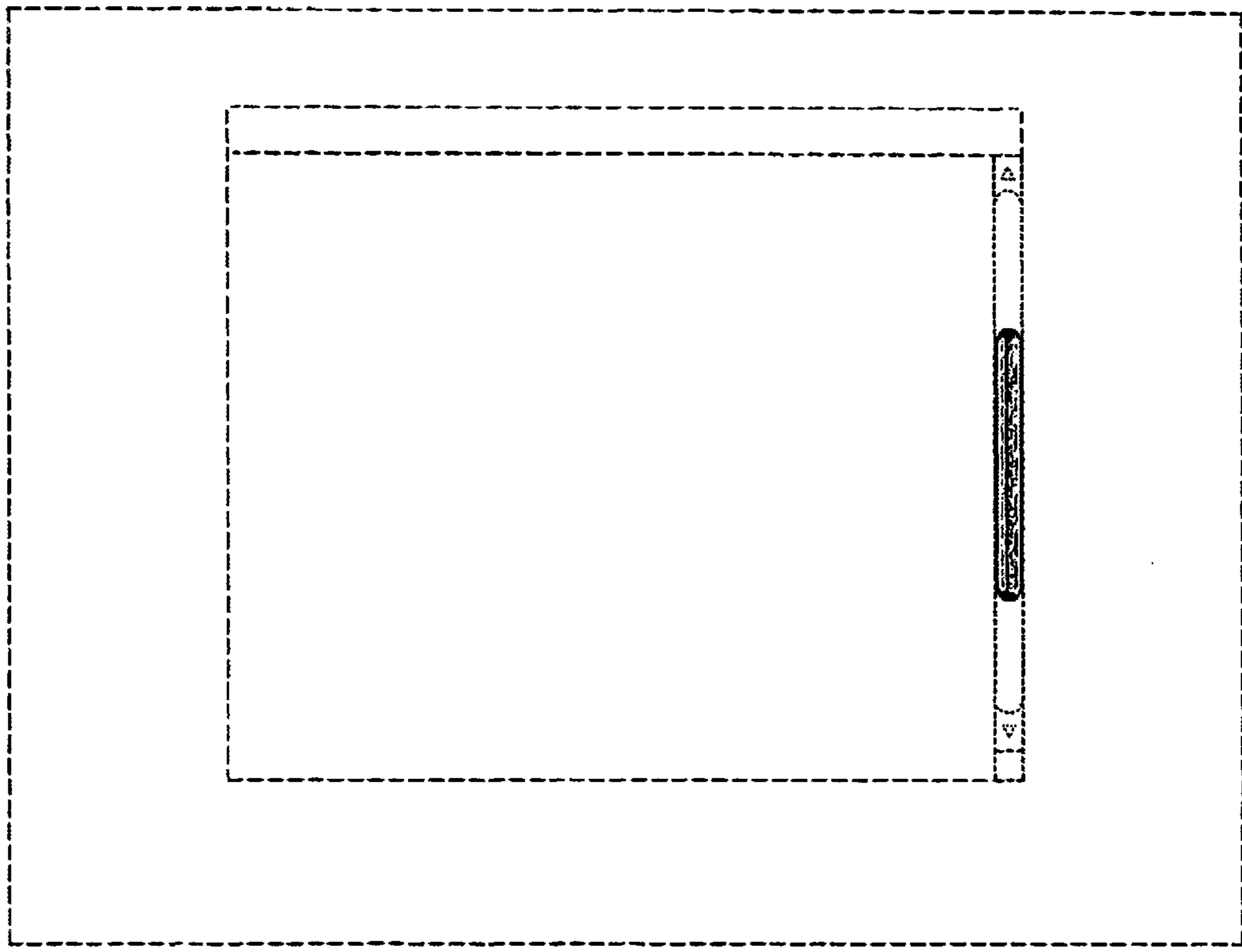

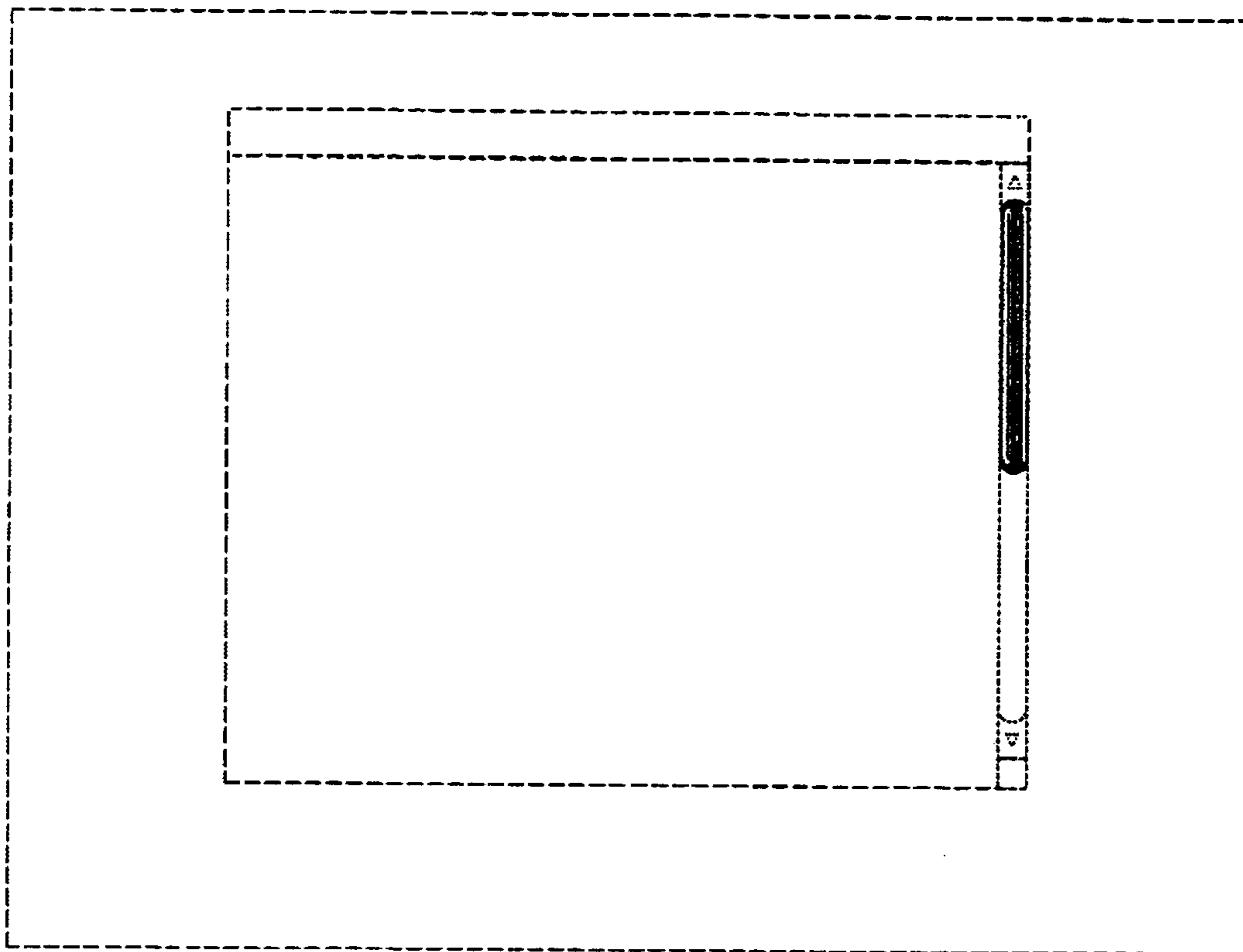

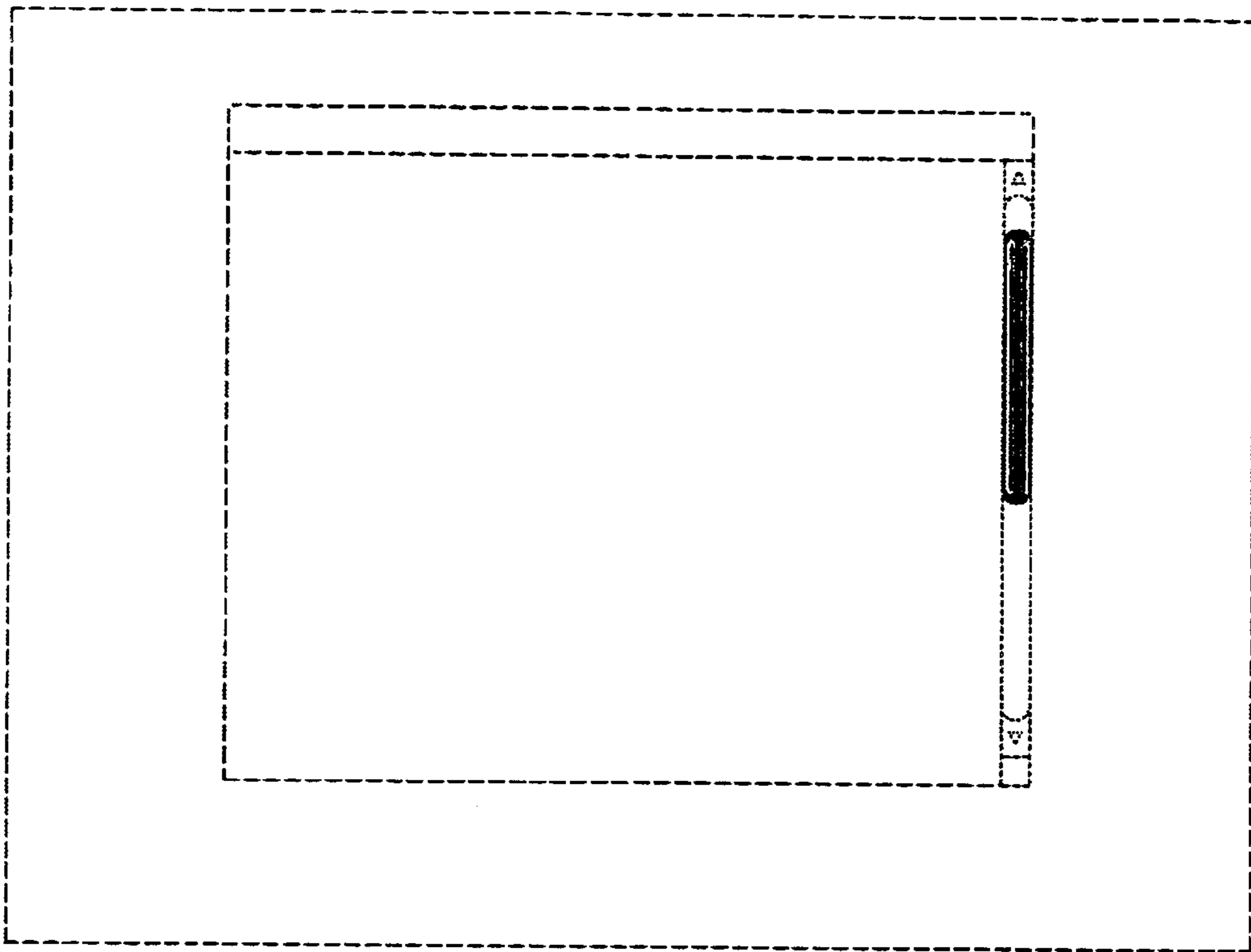

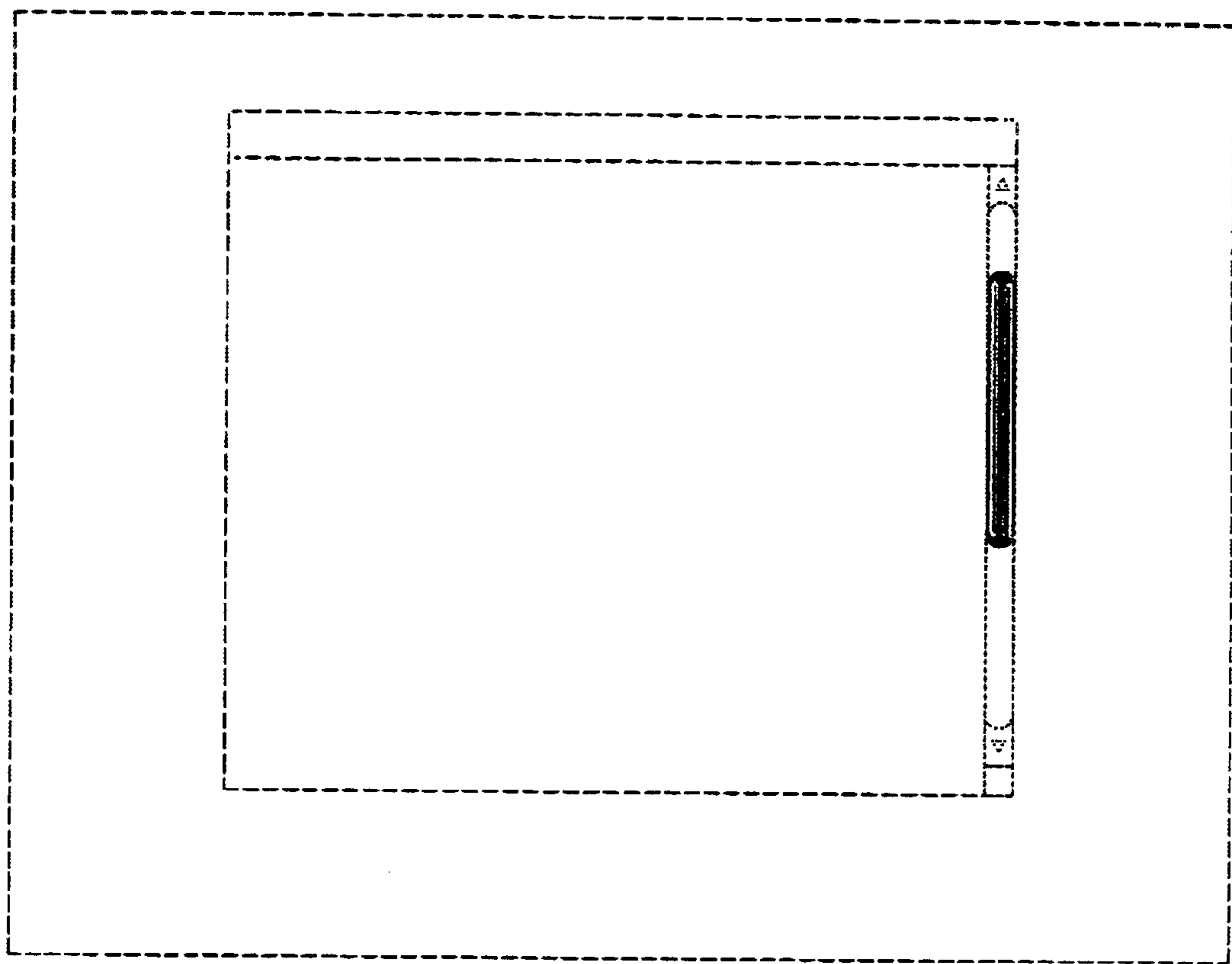

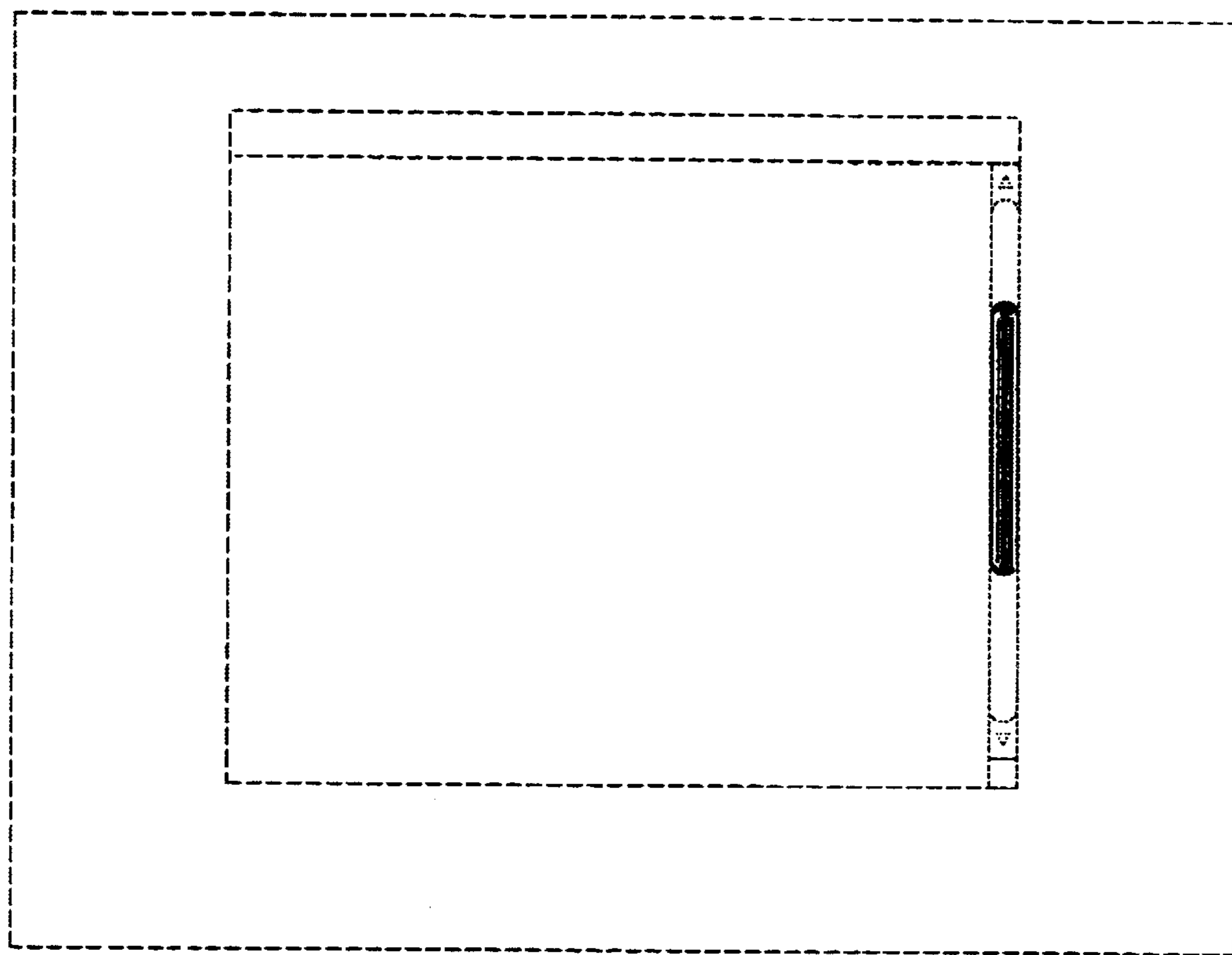

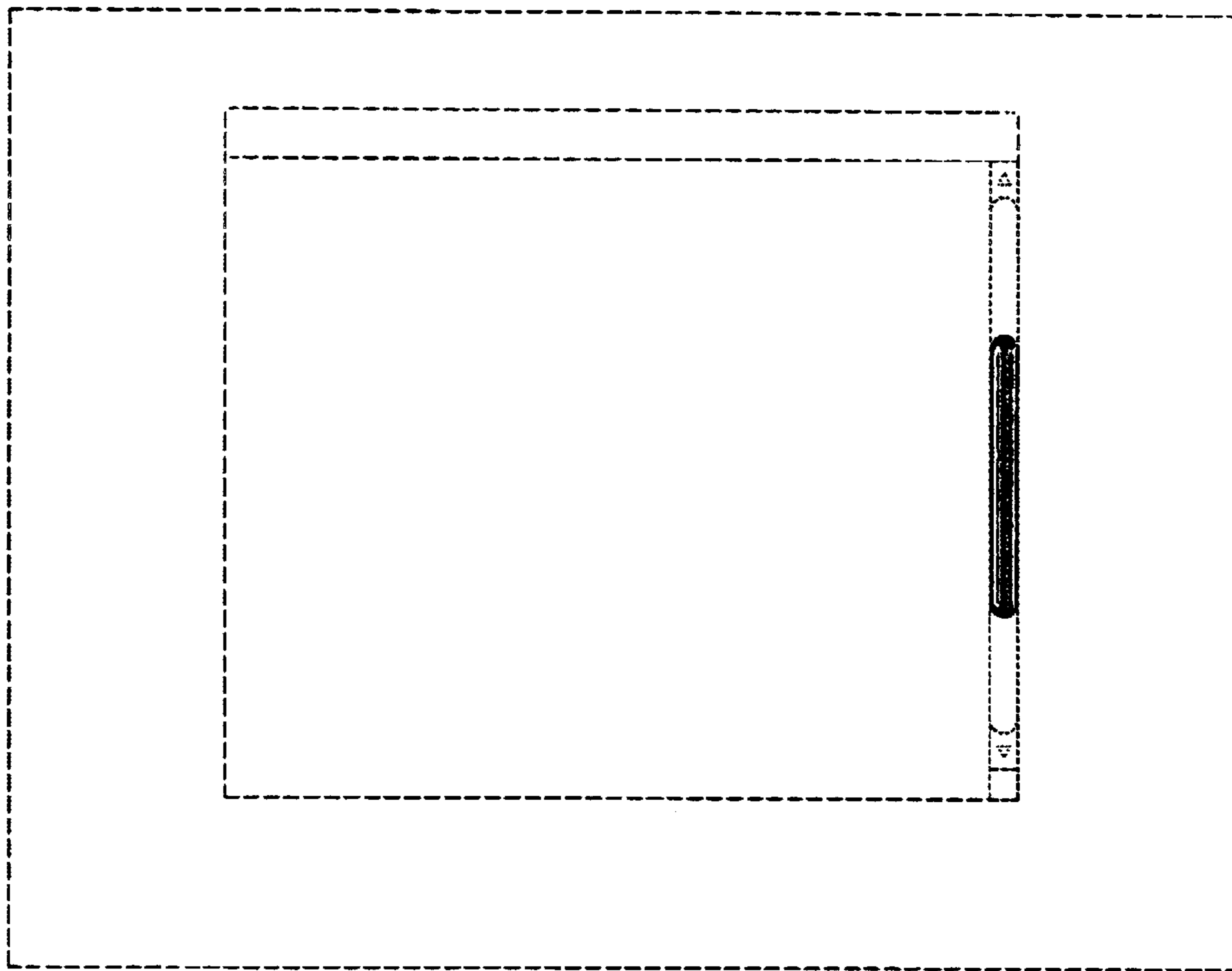

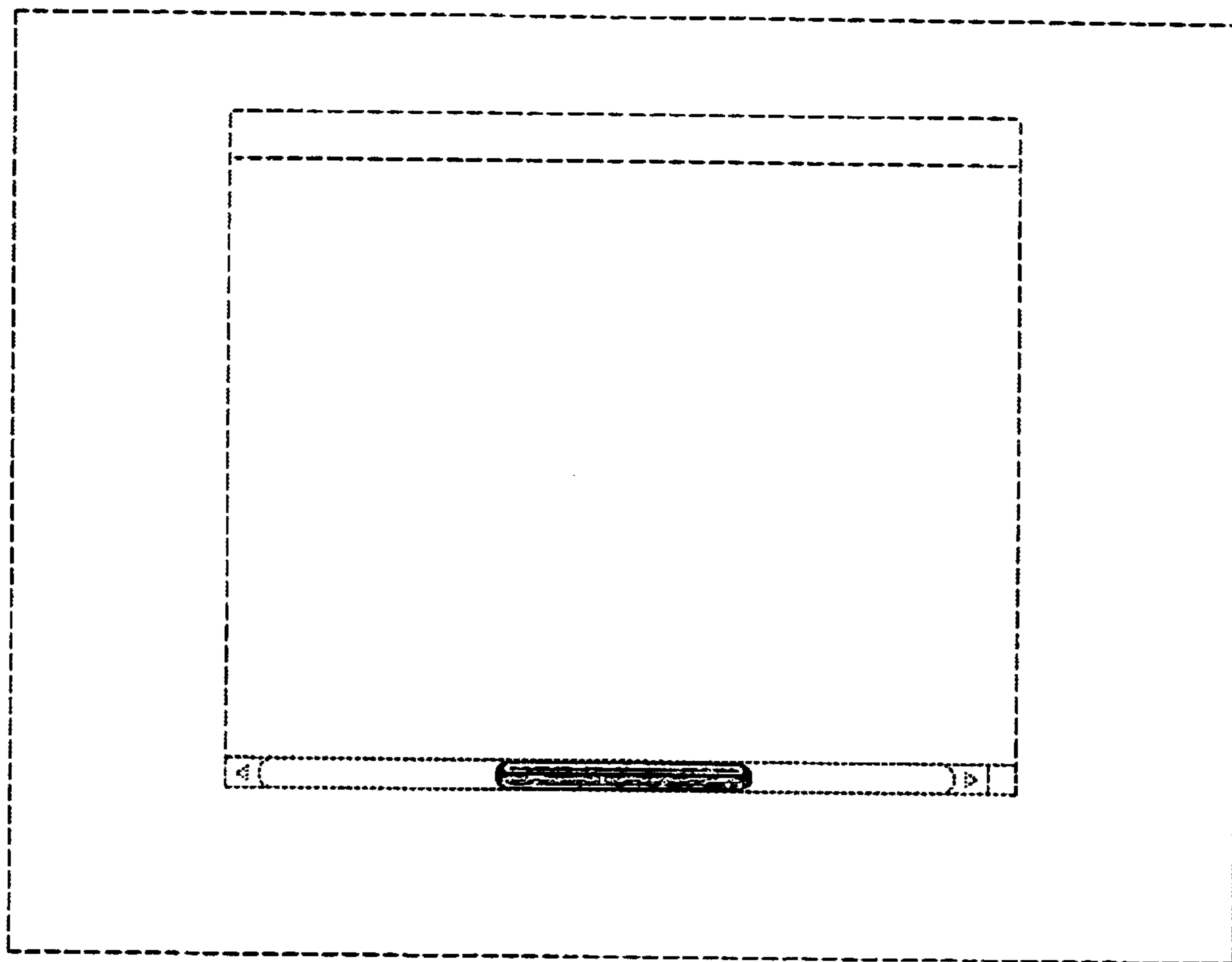

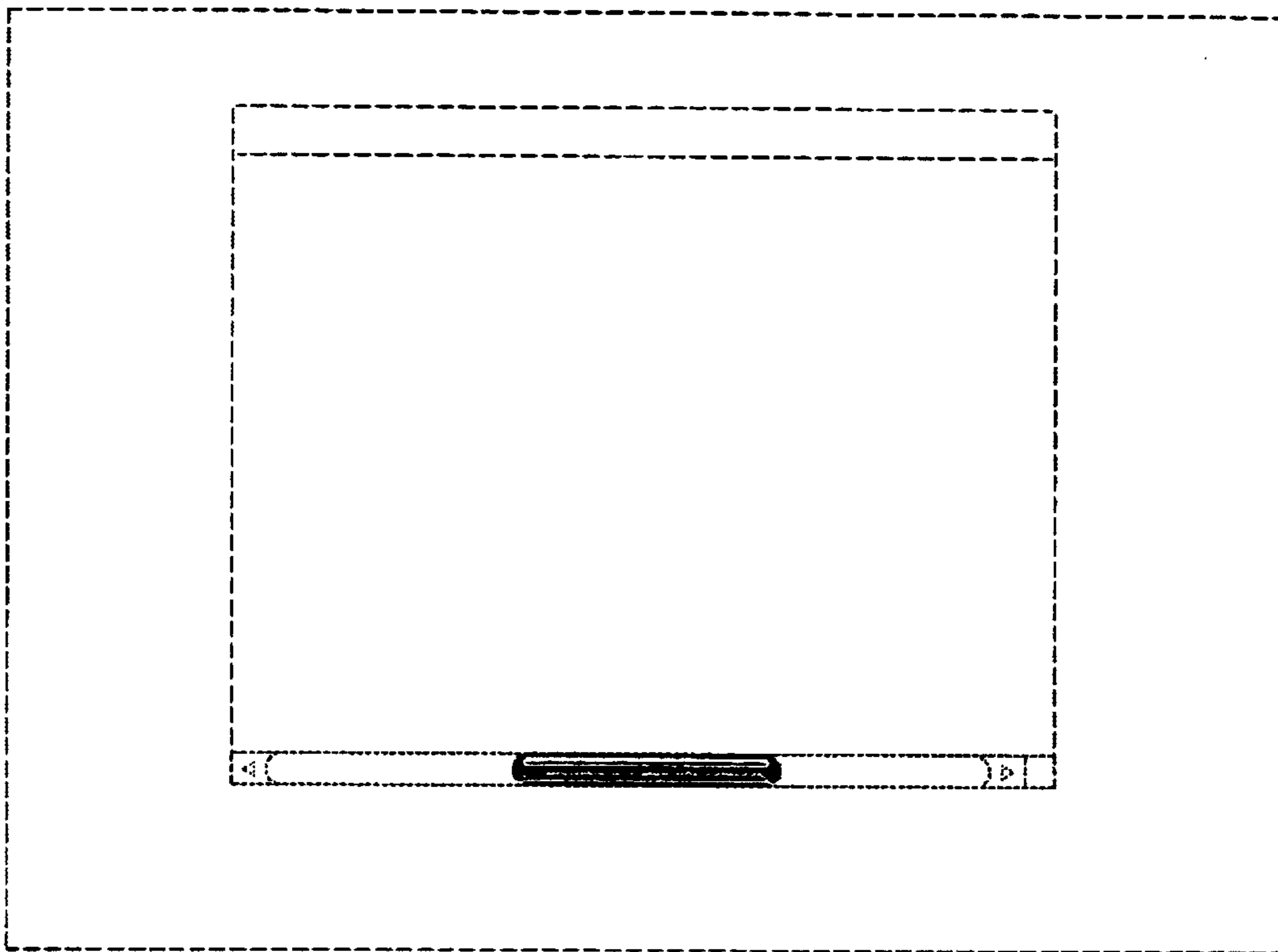
