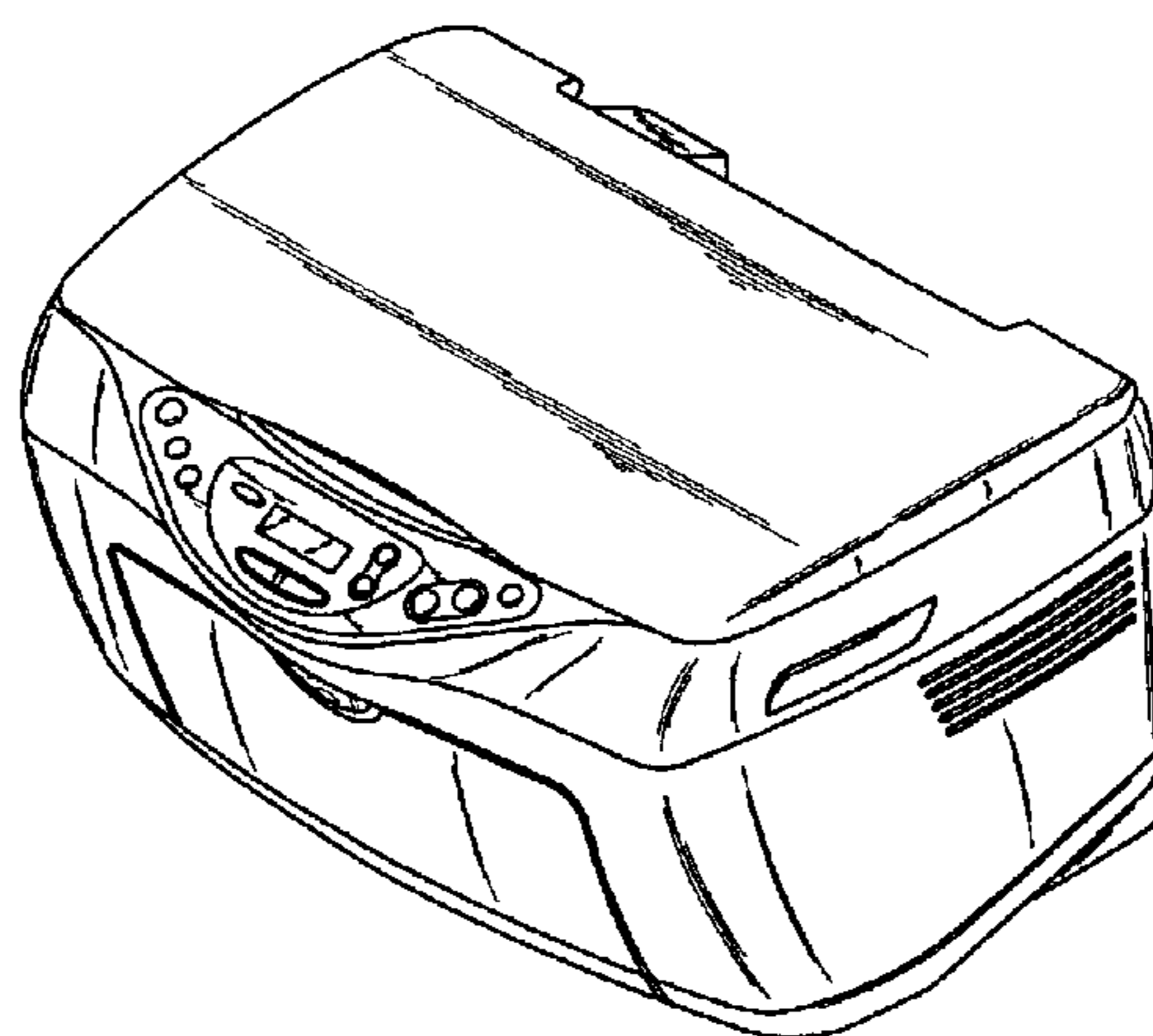
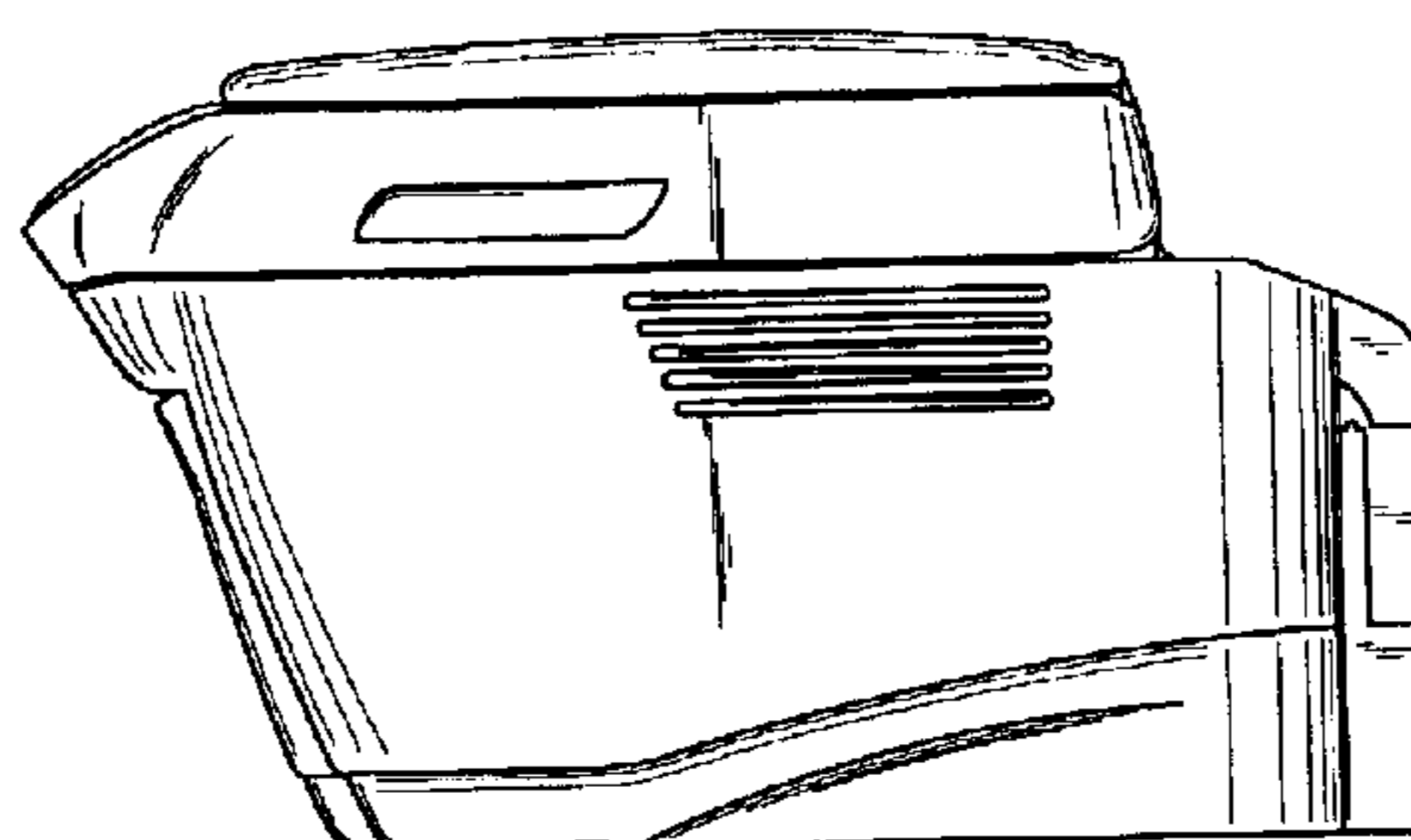

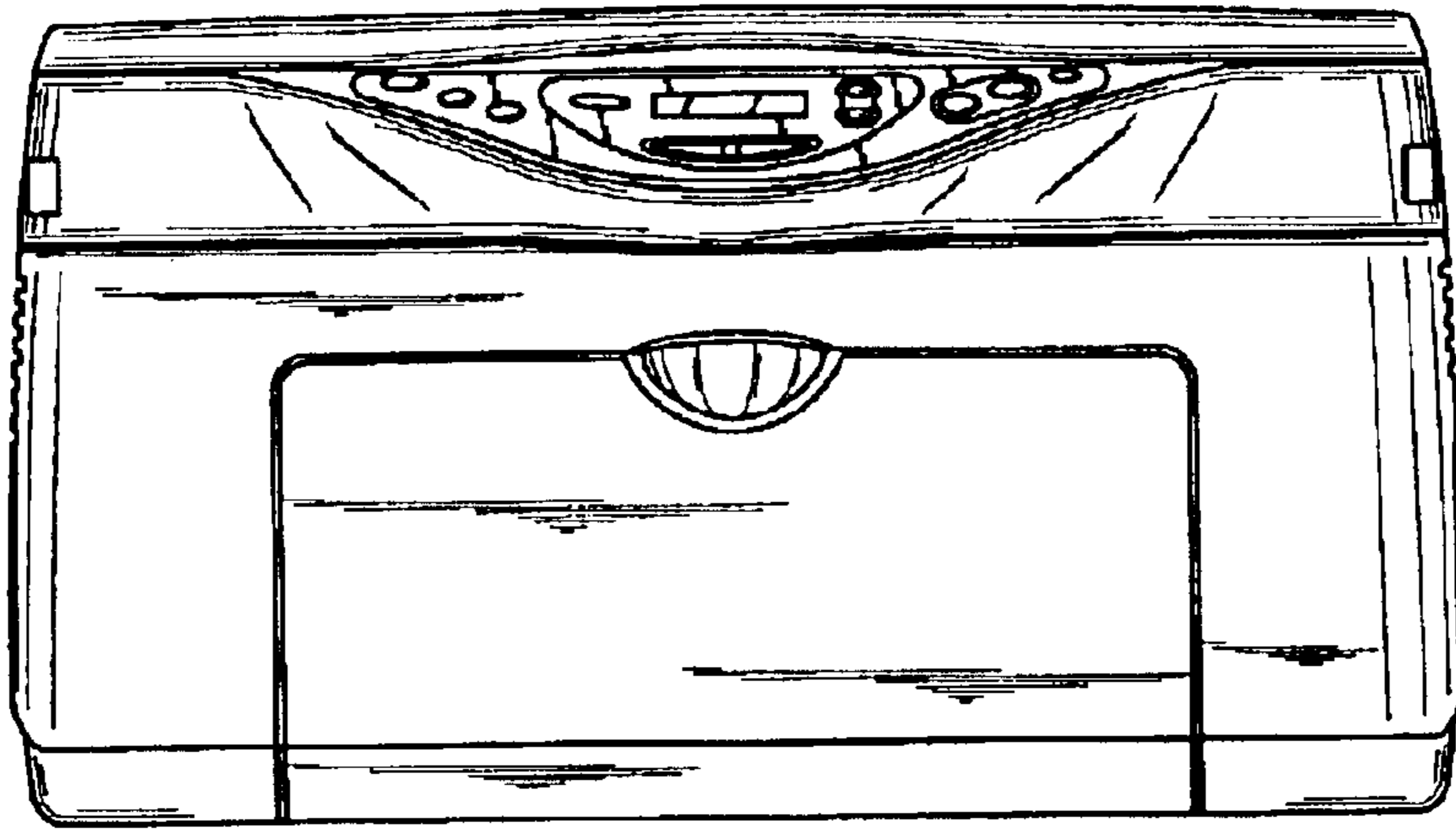
The ornamental design for a printer with scanner, as shown.

**DESCRIPTION**

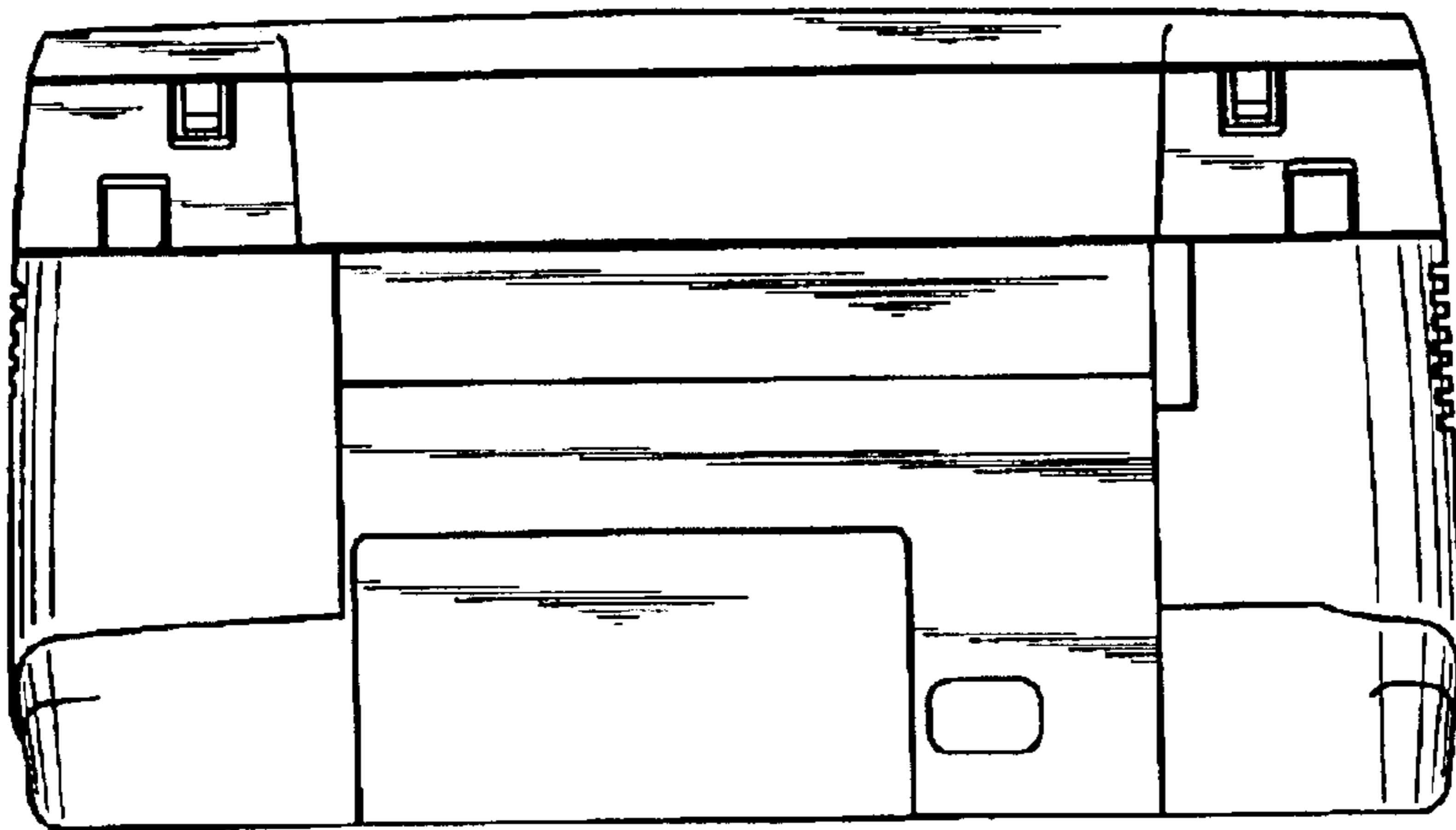

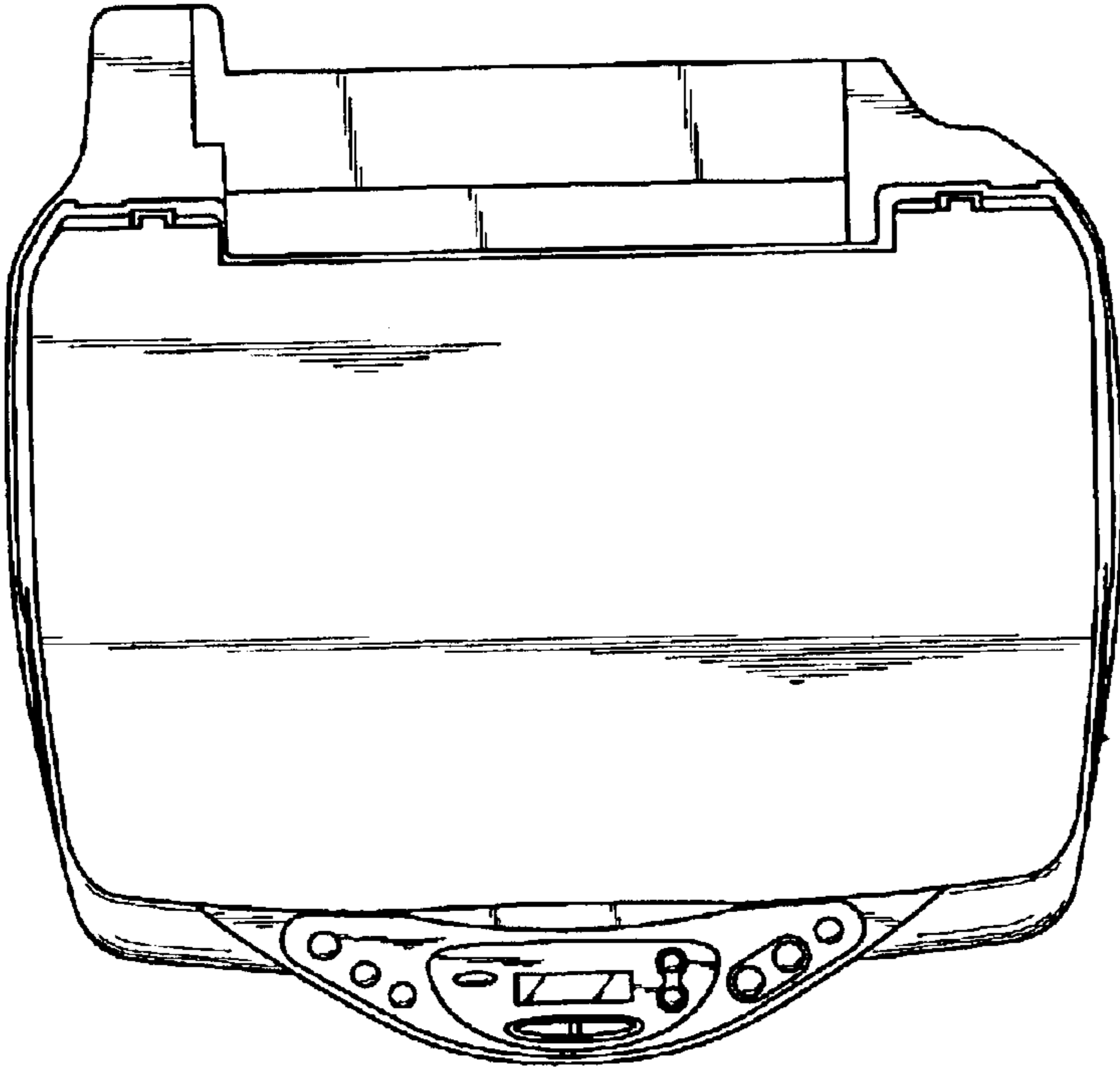

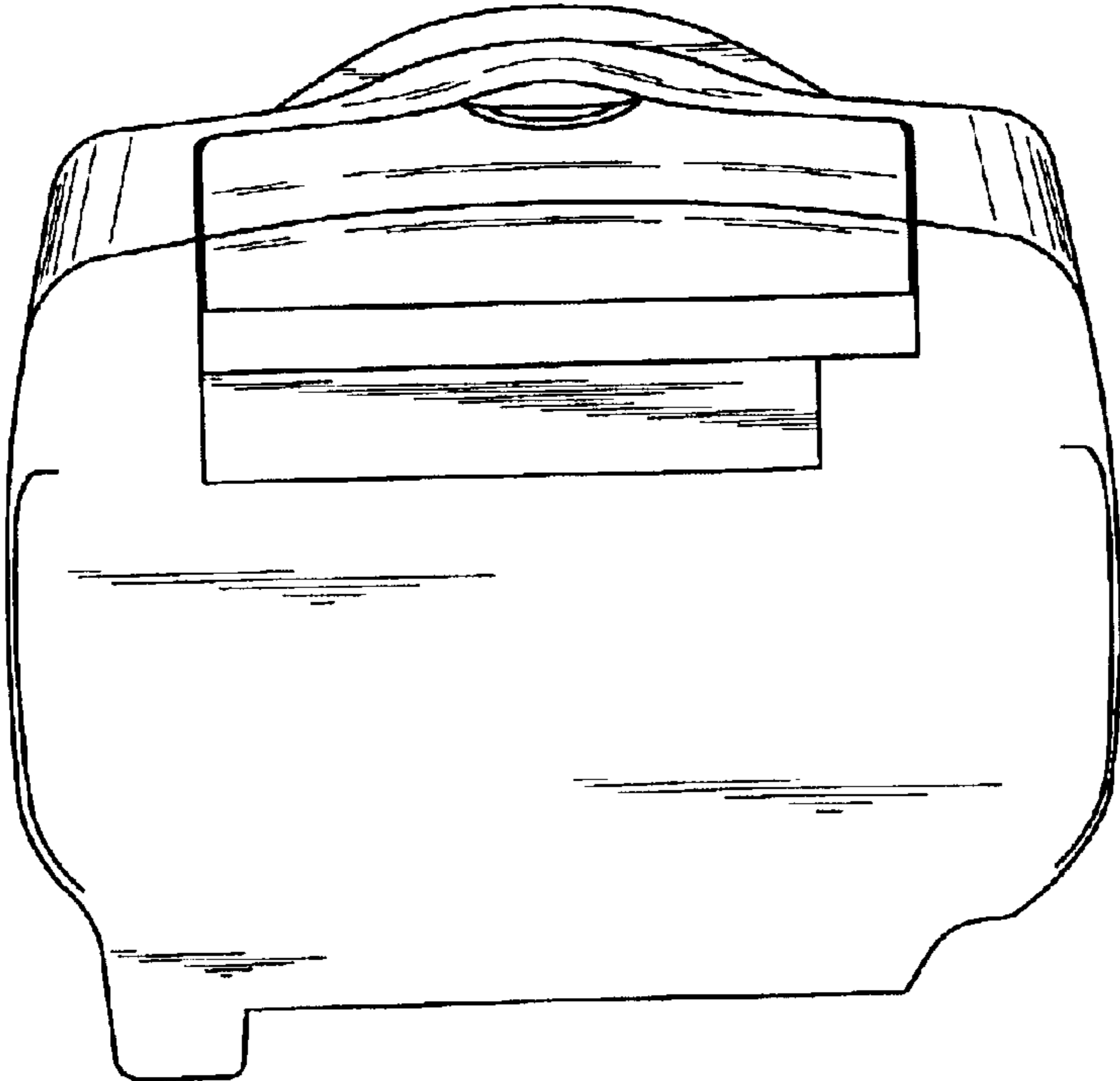
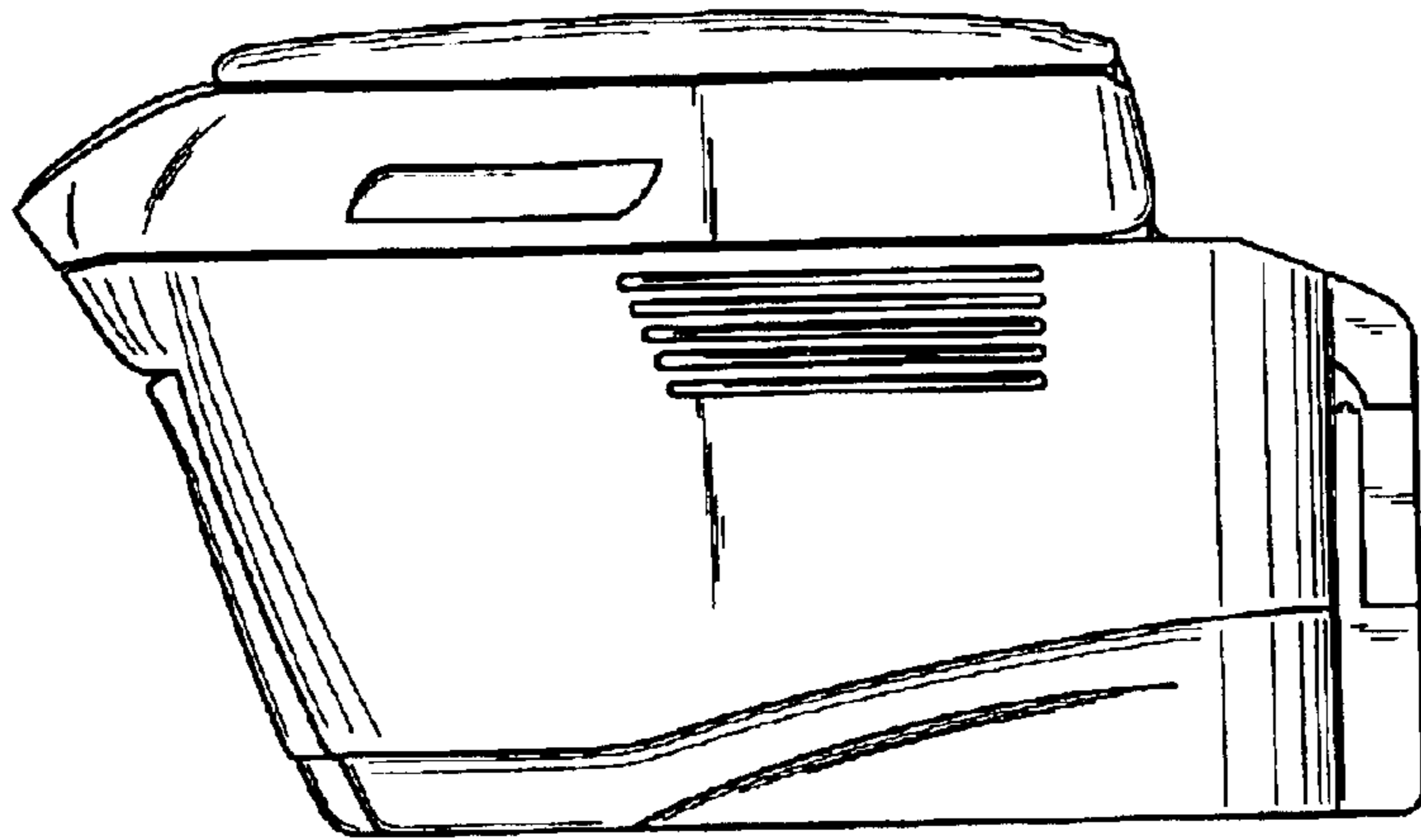
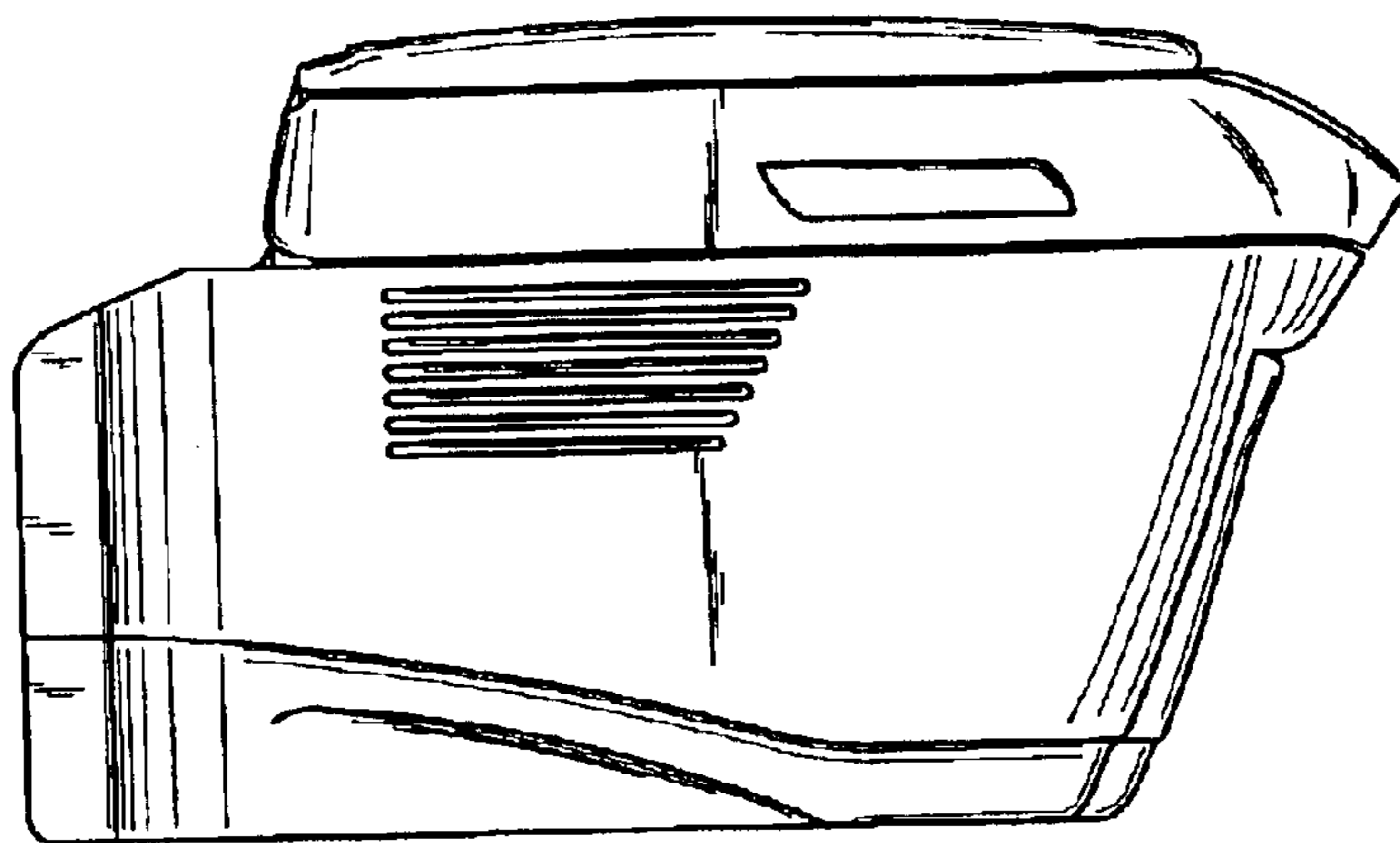


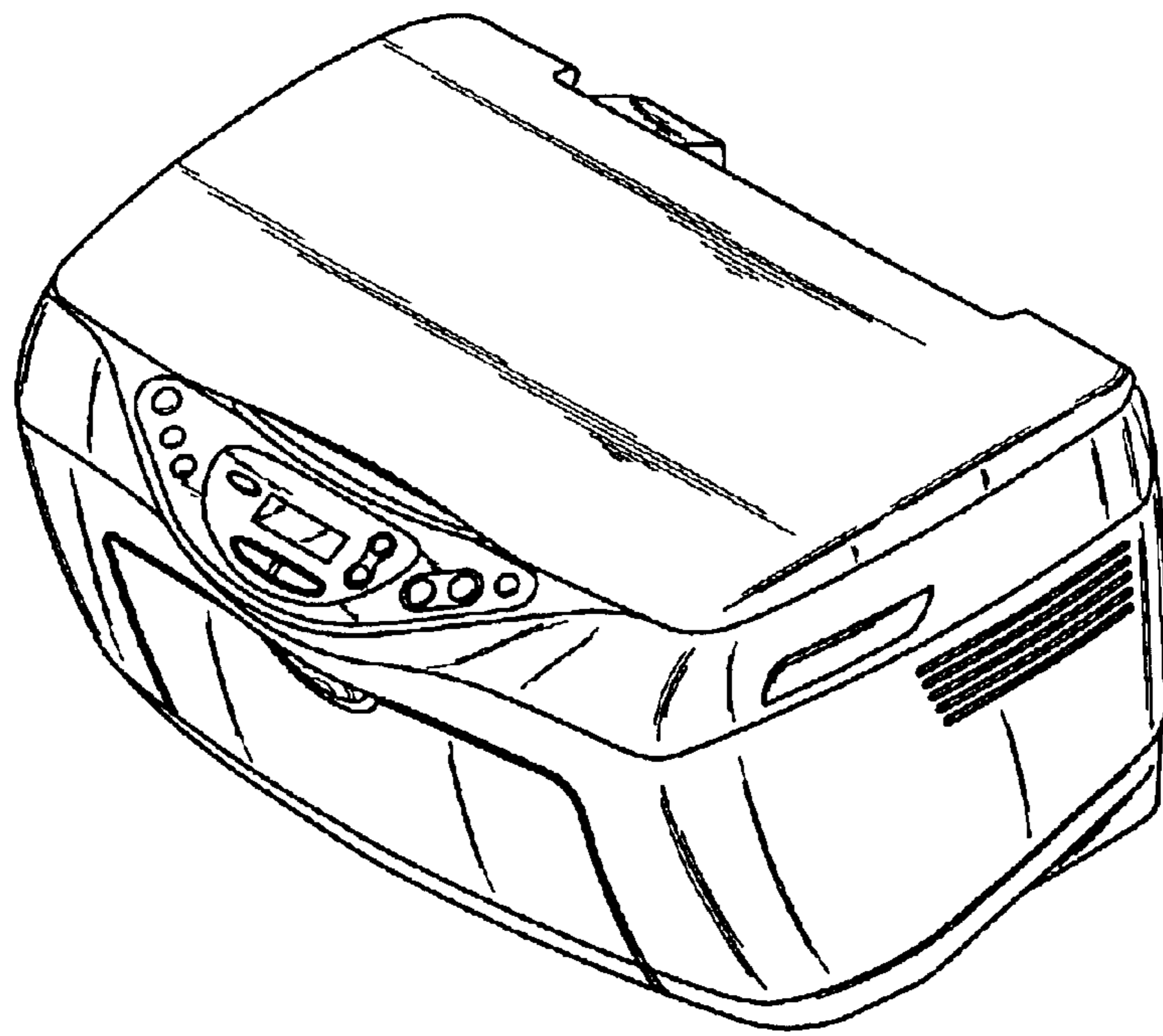
