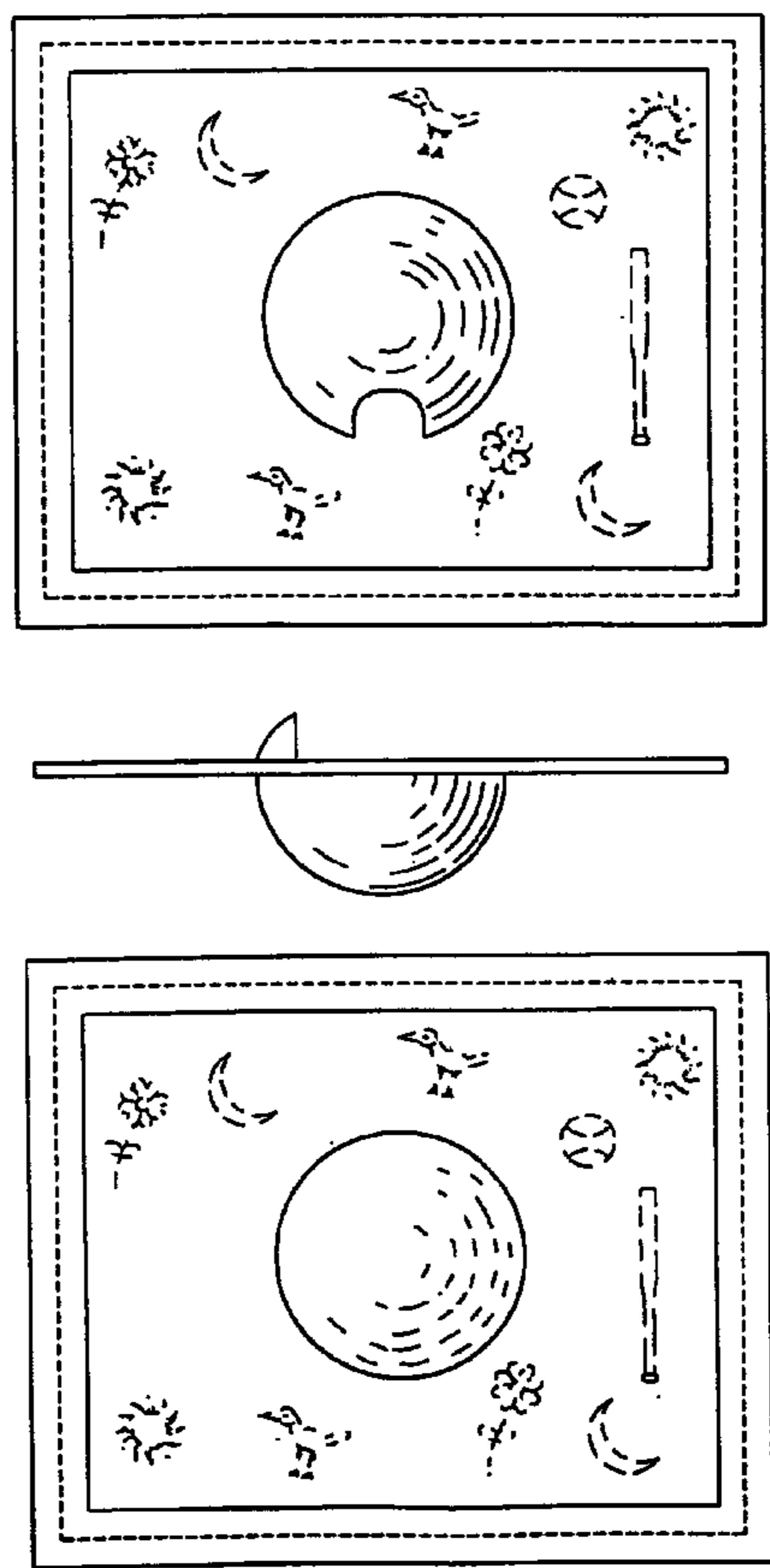
FIG. 8 is a front elevational view of the potty liner of FIG. 7, the elevational views being substantially identical.

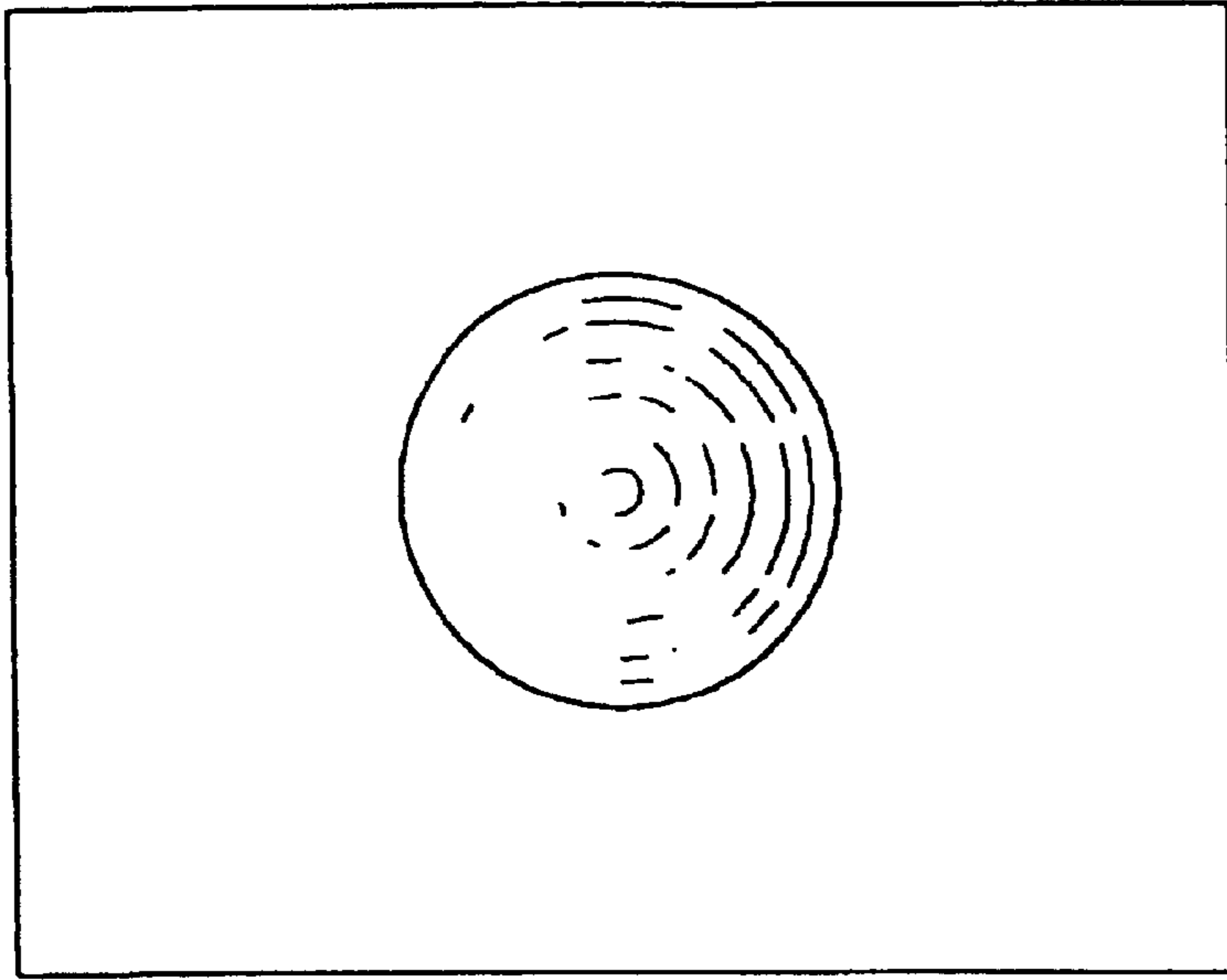

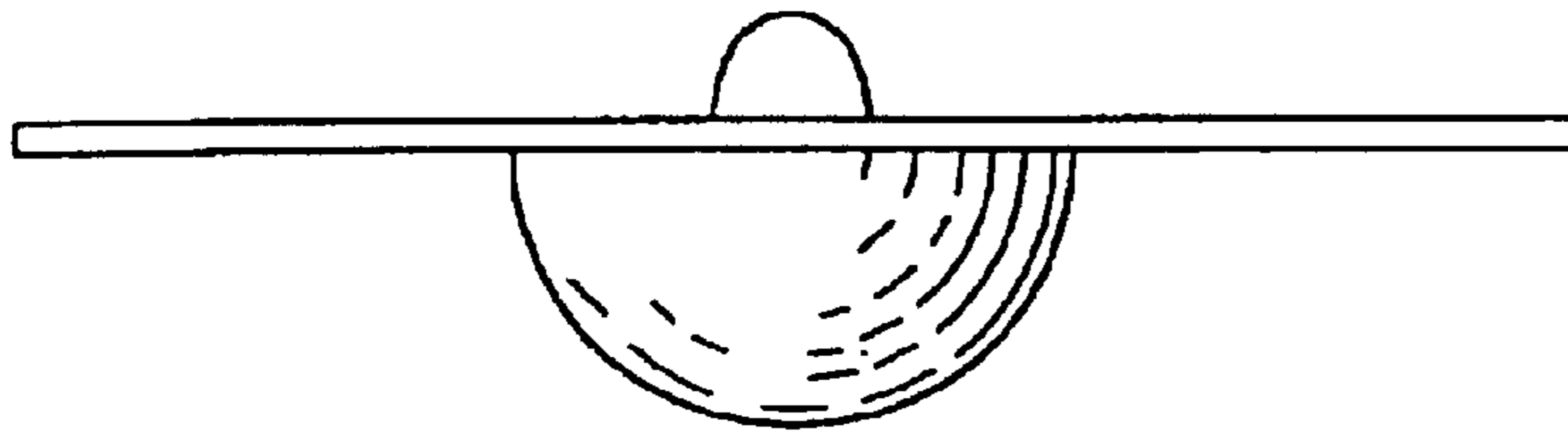

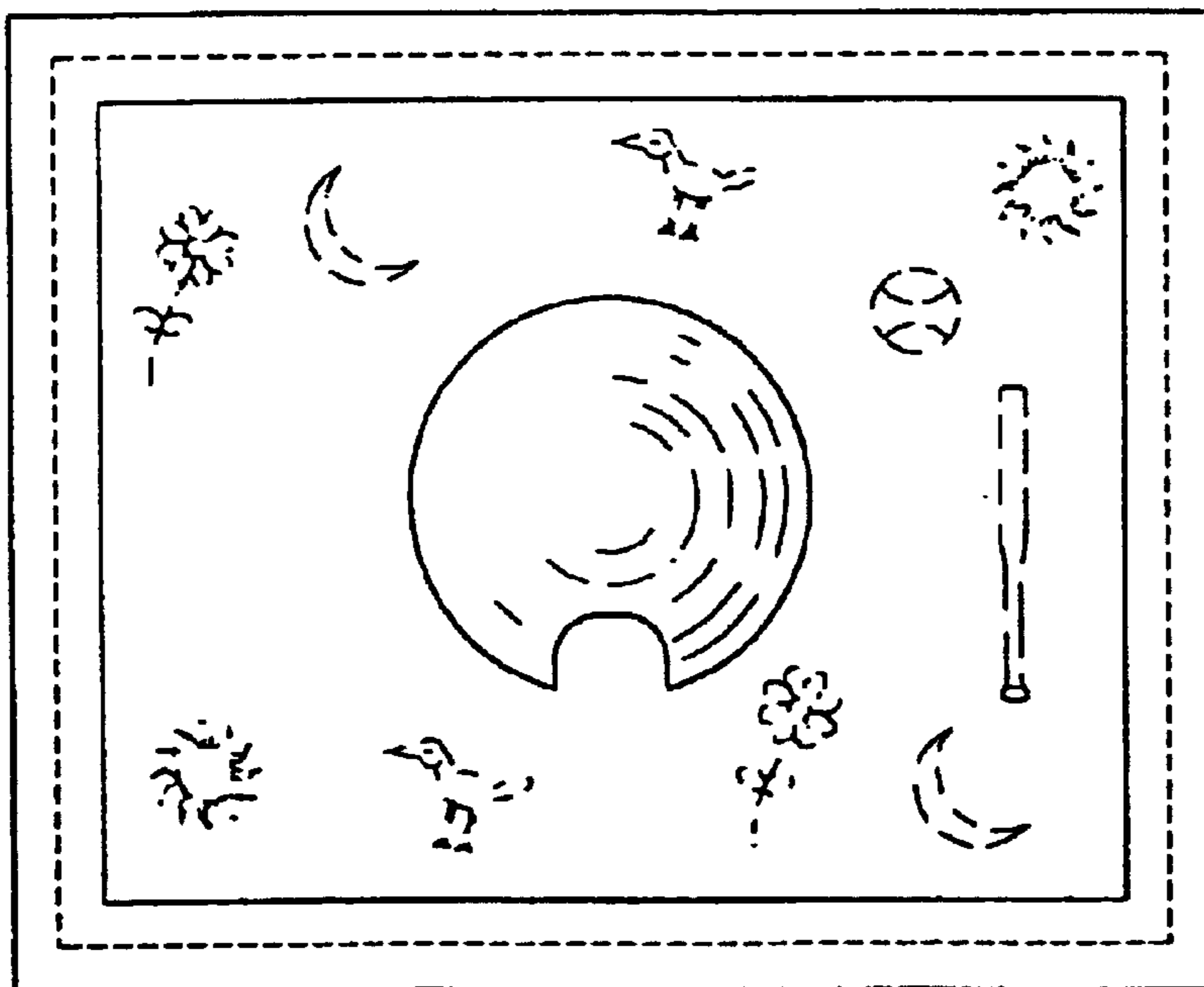

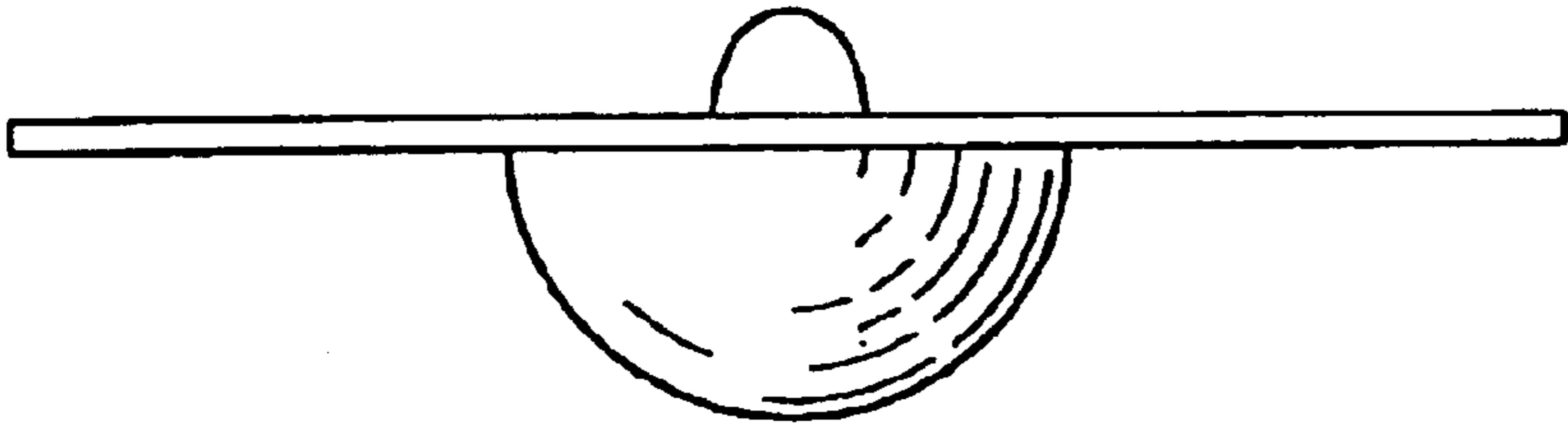

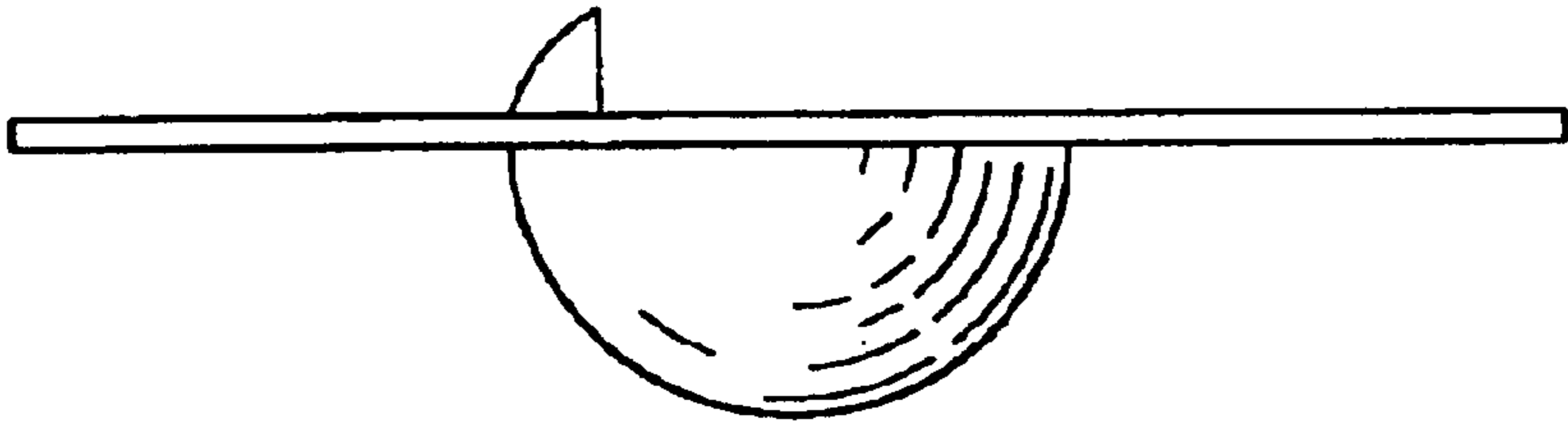

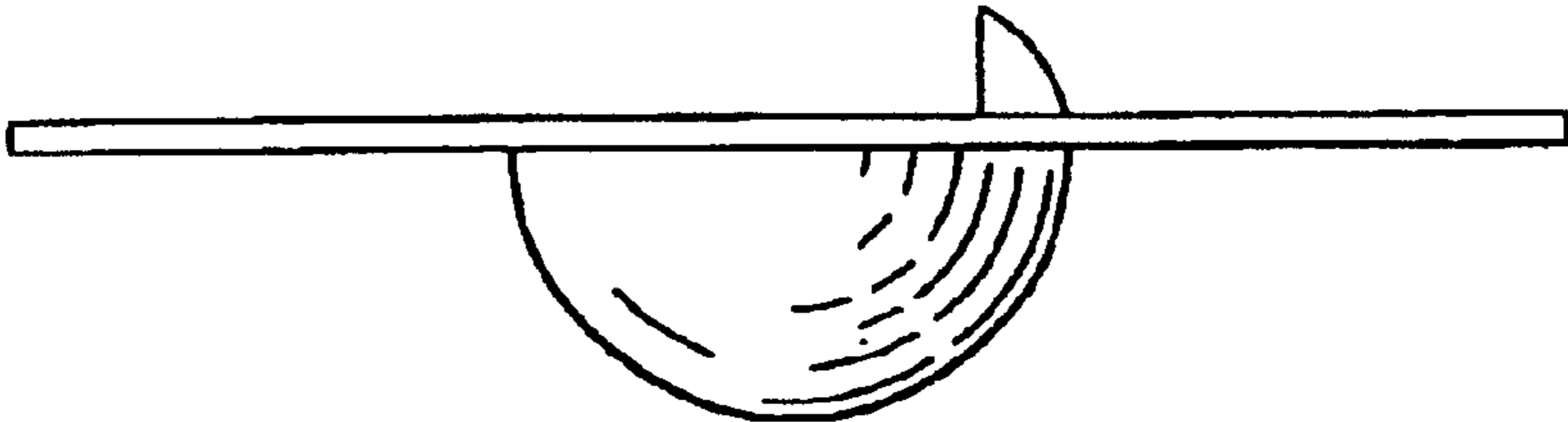

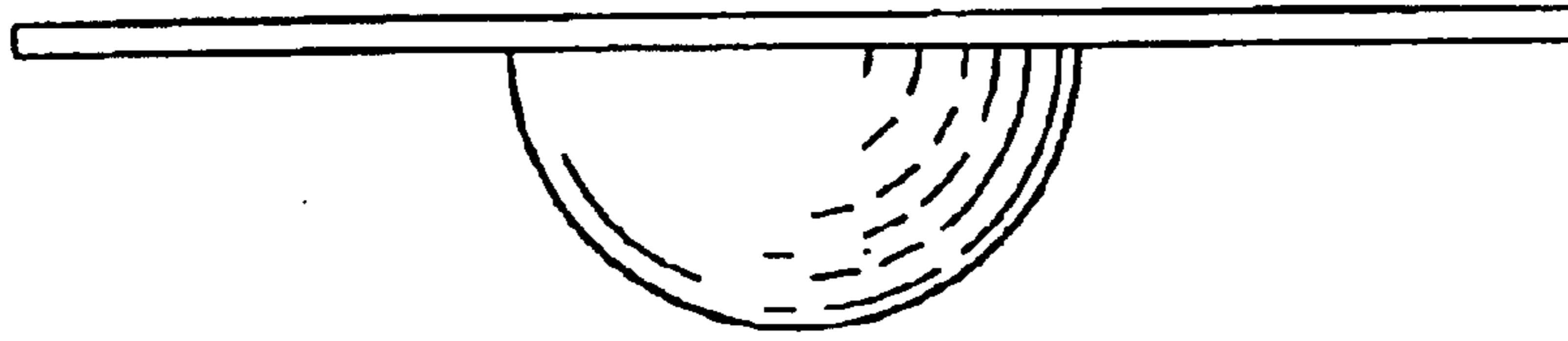

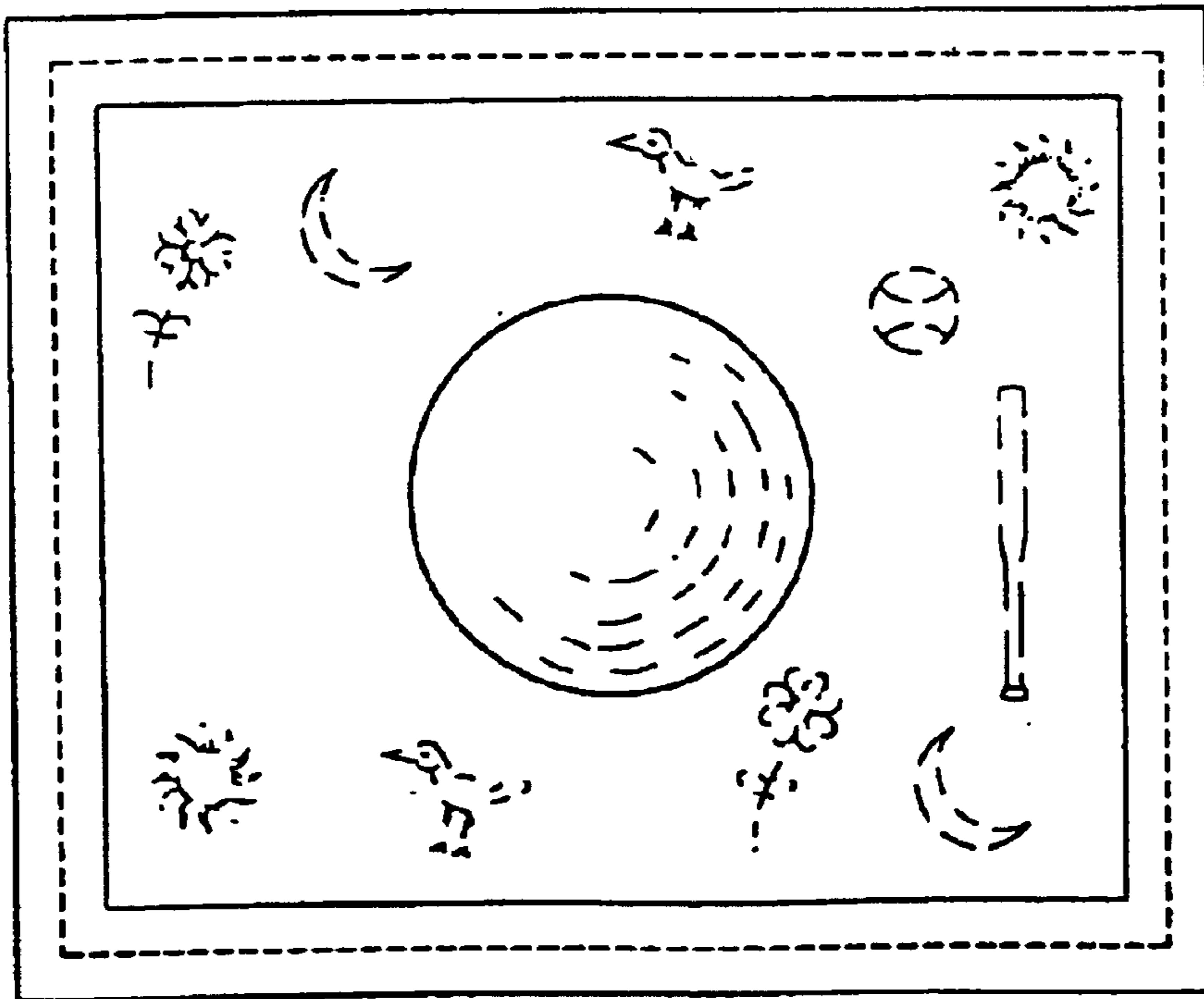
