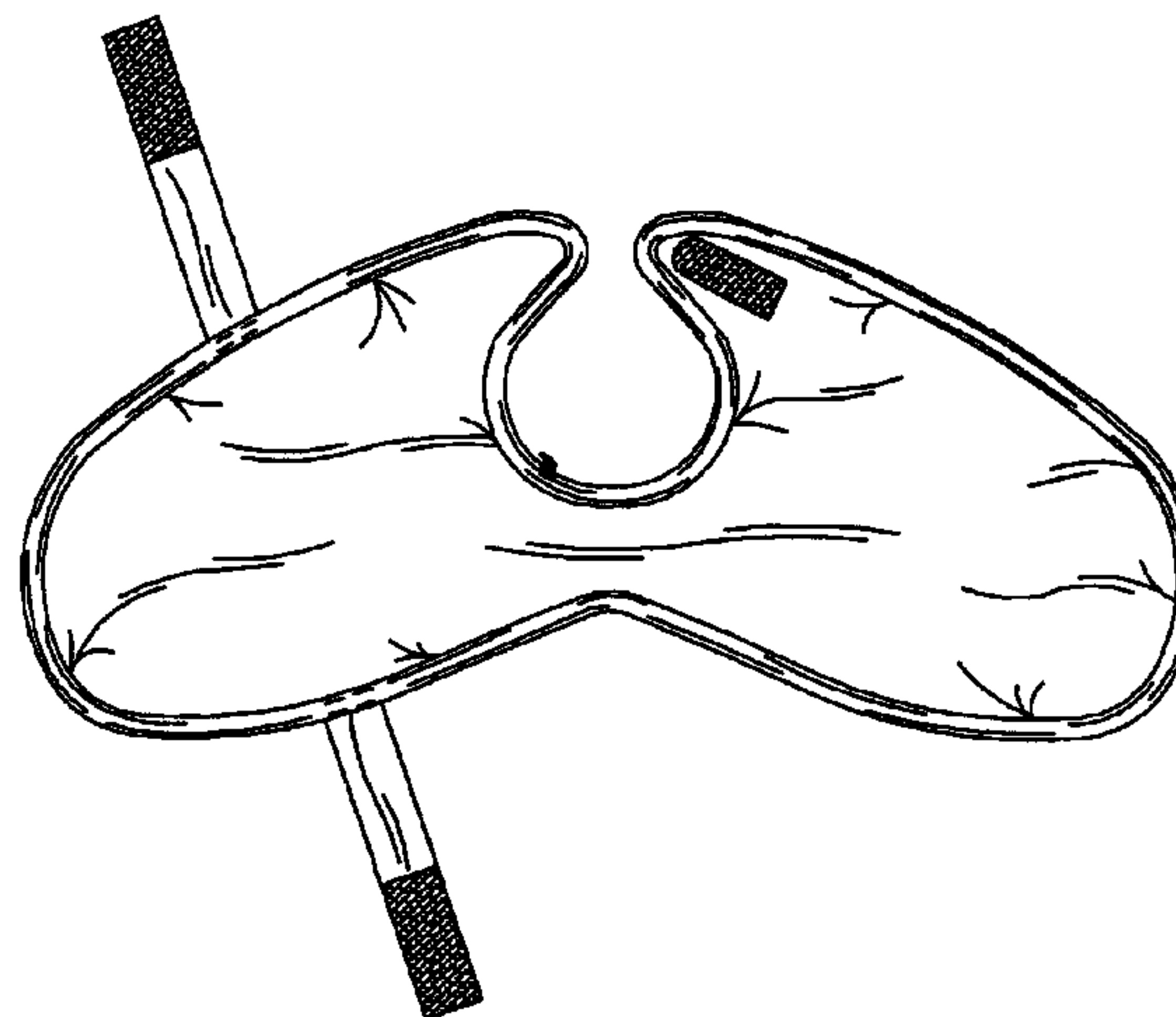
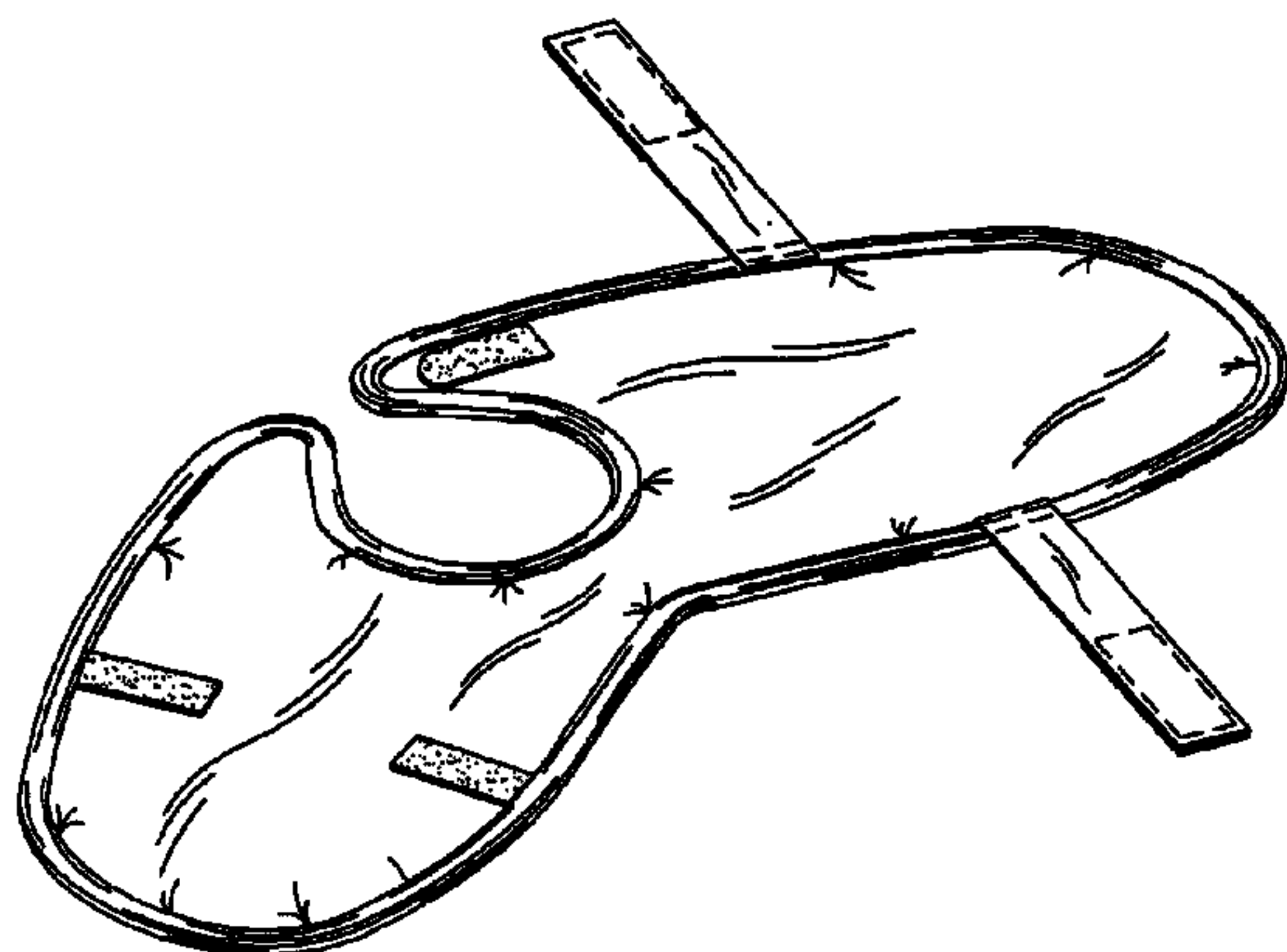
(57) **CLAIM**

I claim the ornamental design for a two-in-one baby bib, as shown and described.

DESCRIPTION

FIG. 1 is an outside perspective view of a two-in-one baby bib showing my new design;

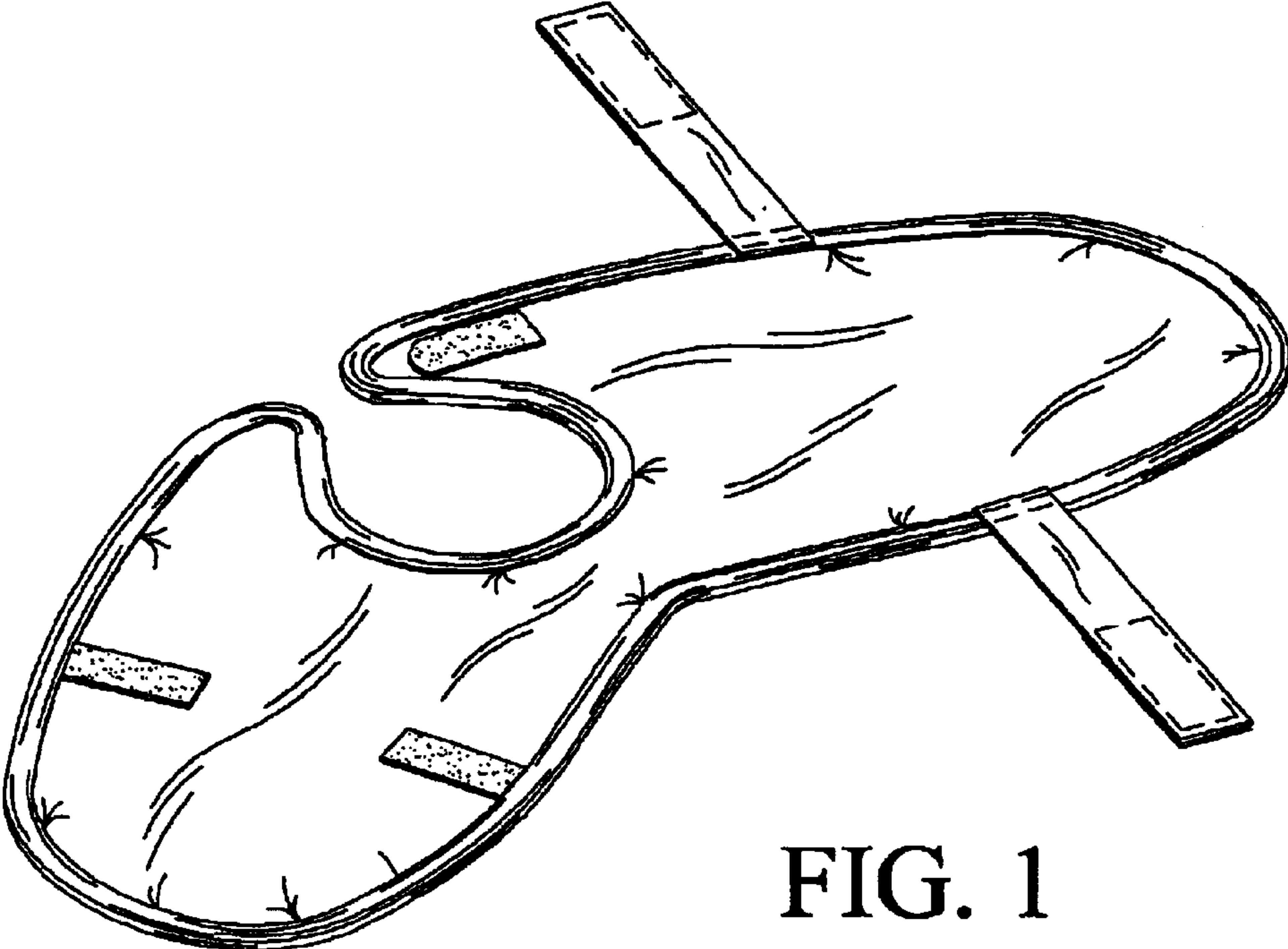

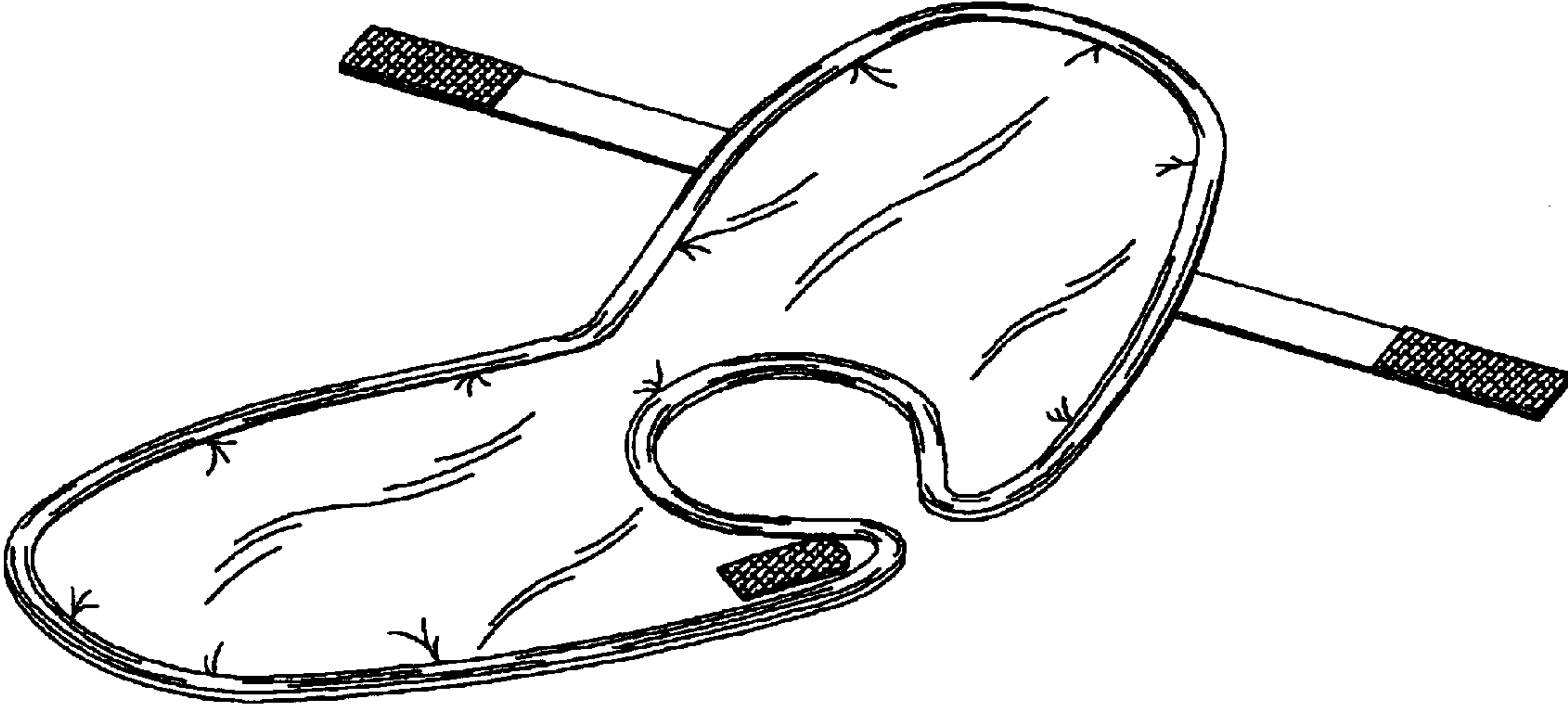

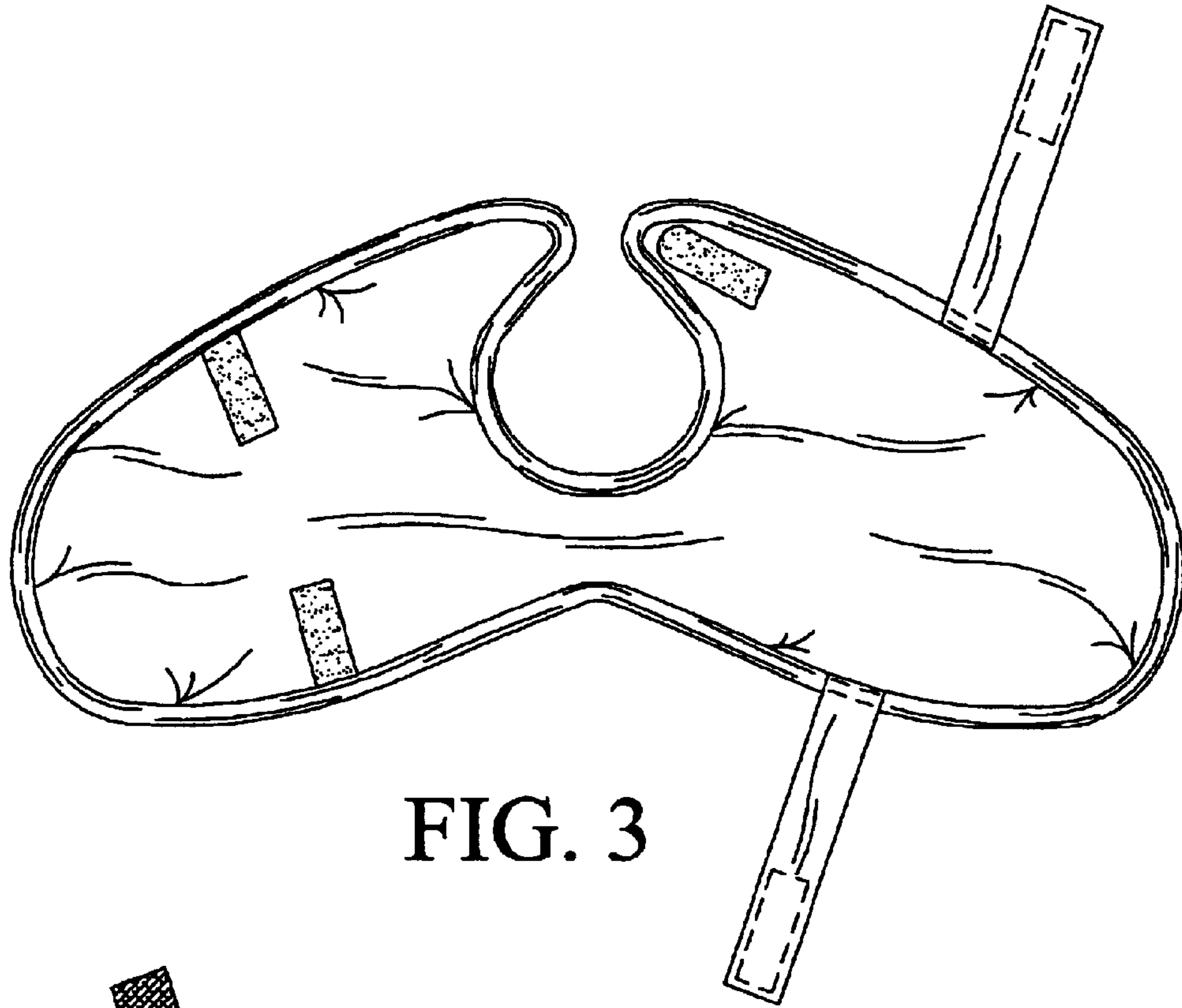

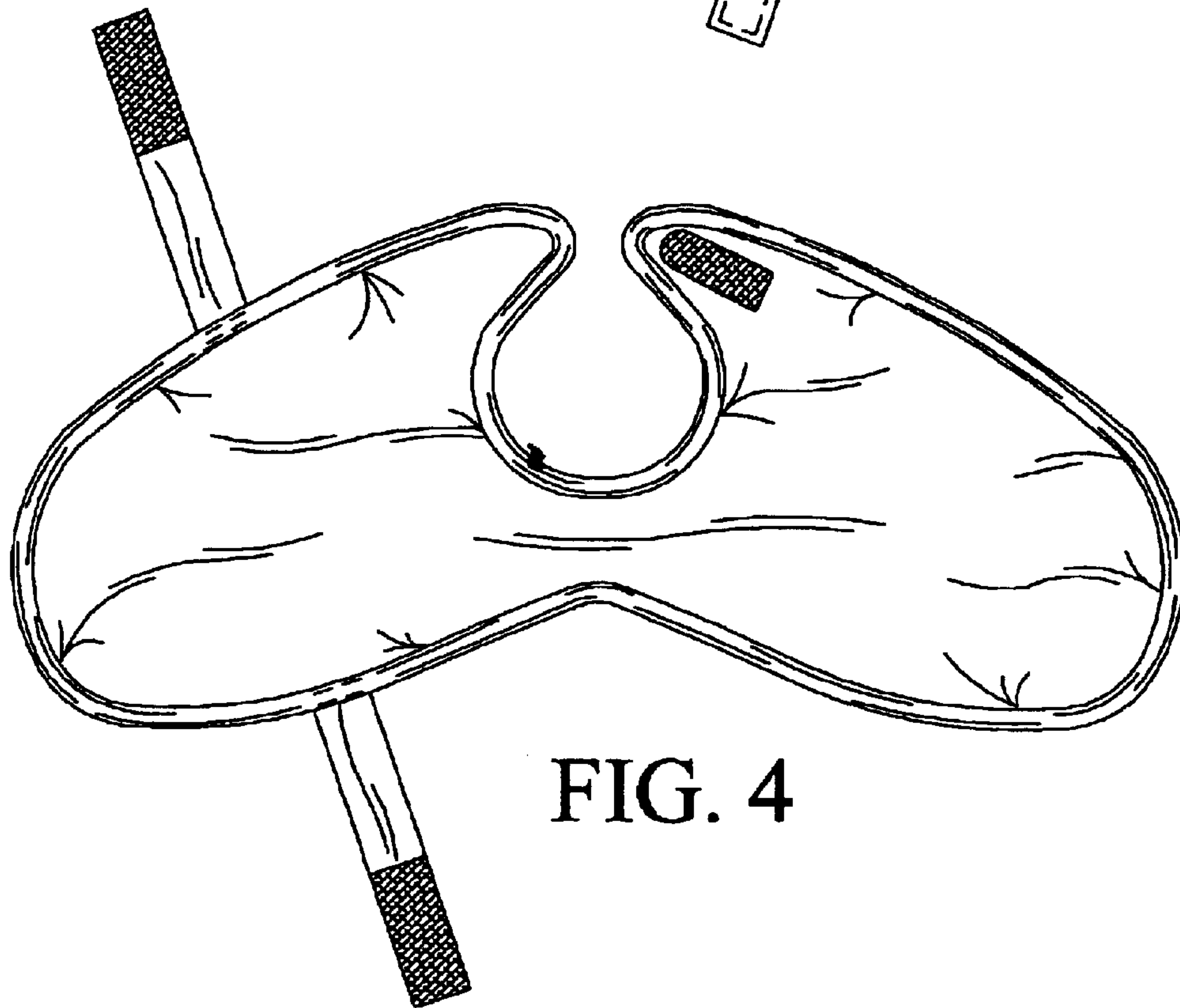
