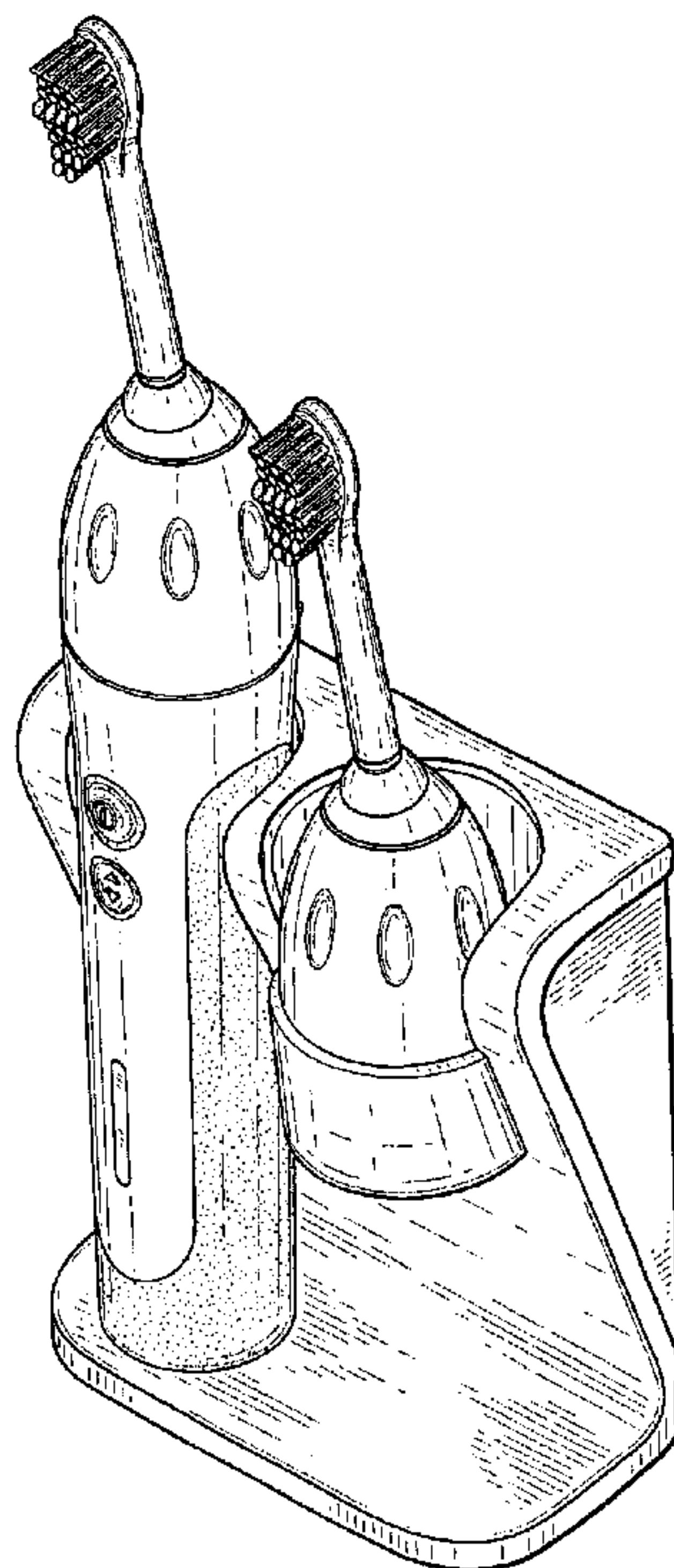
FIG. 1 is a perspective view with assembled toothbrush and extra head;

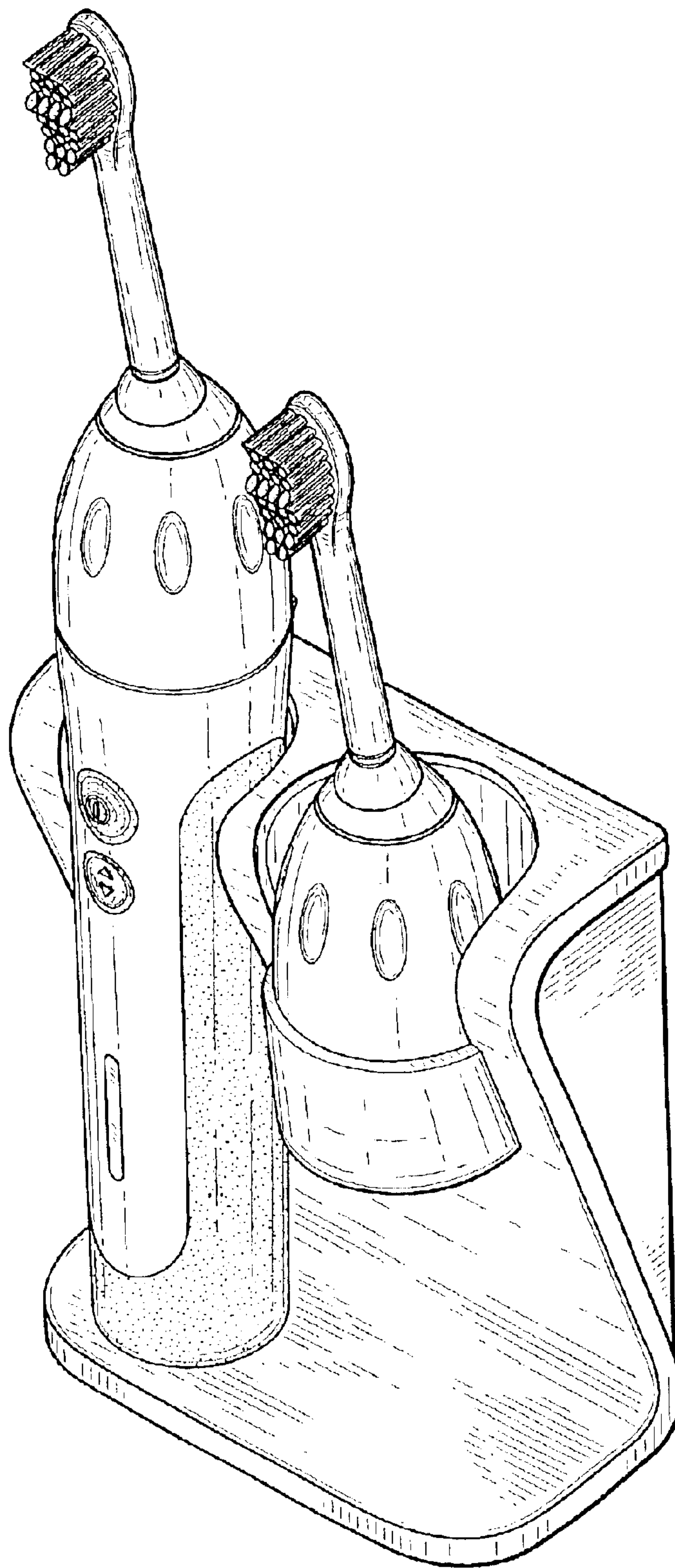

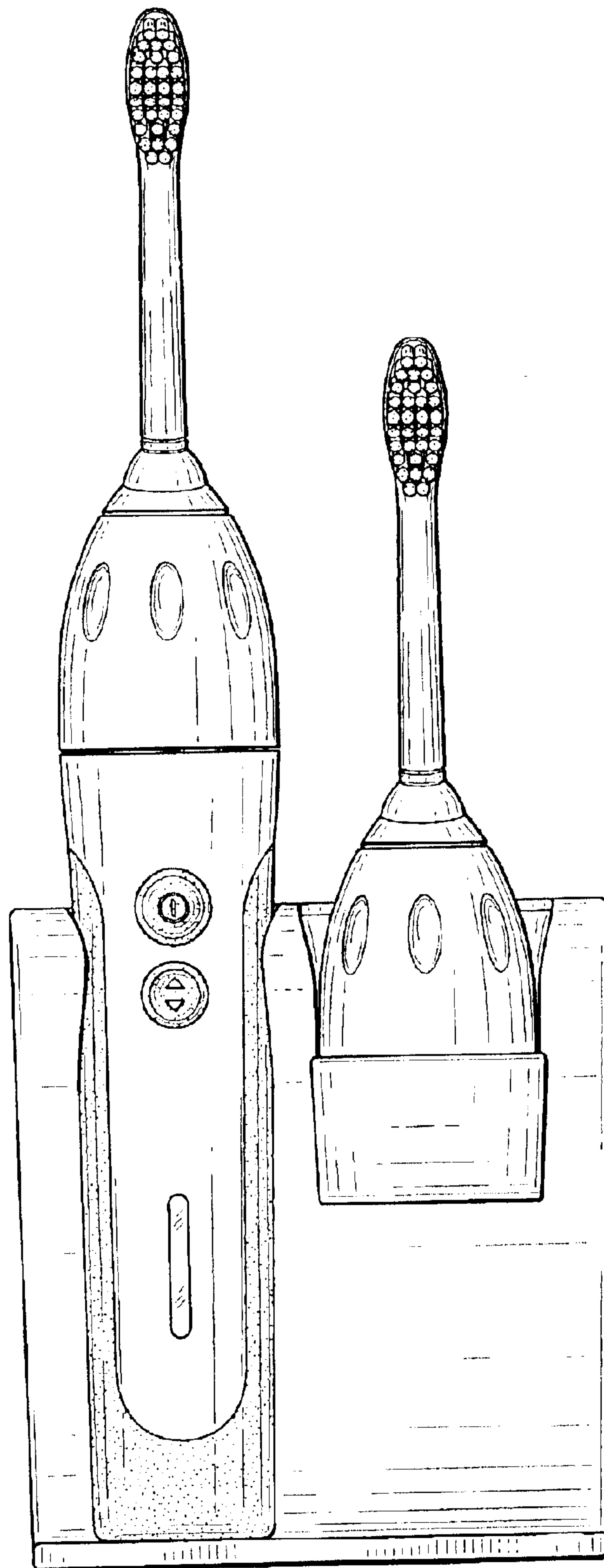

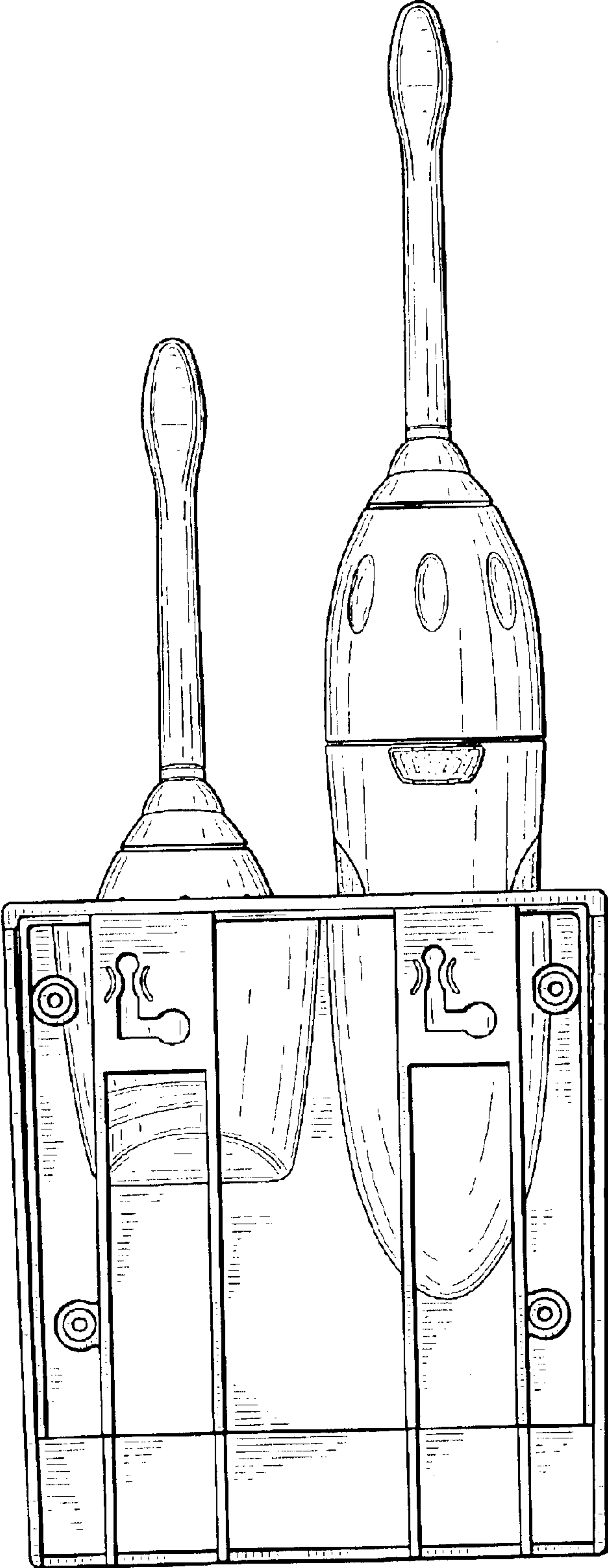

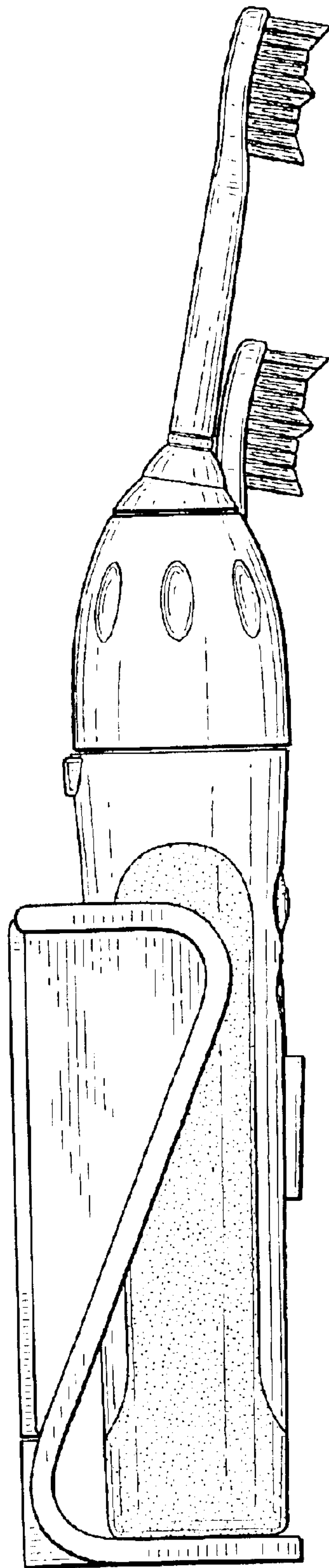

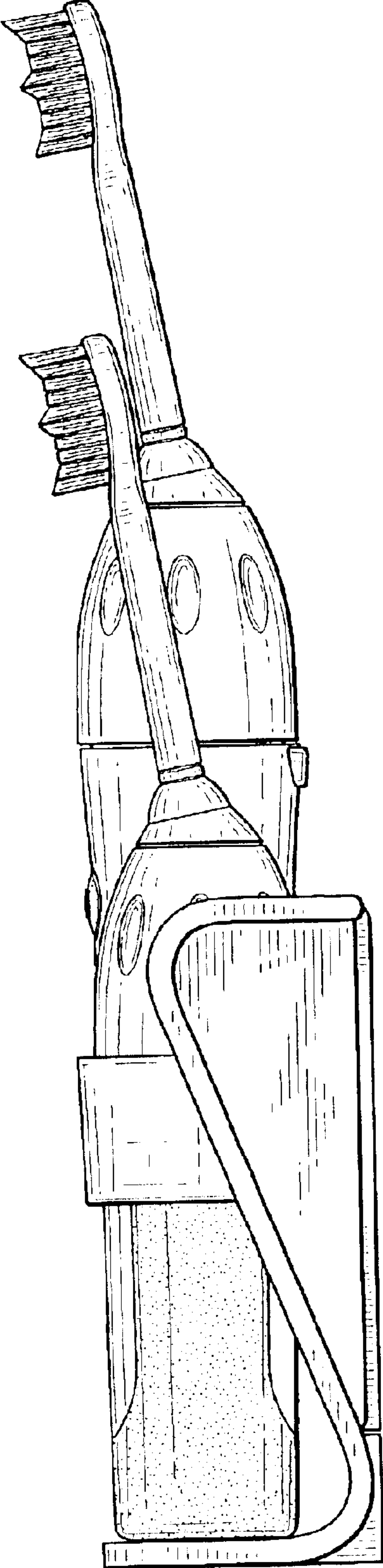

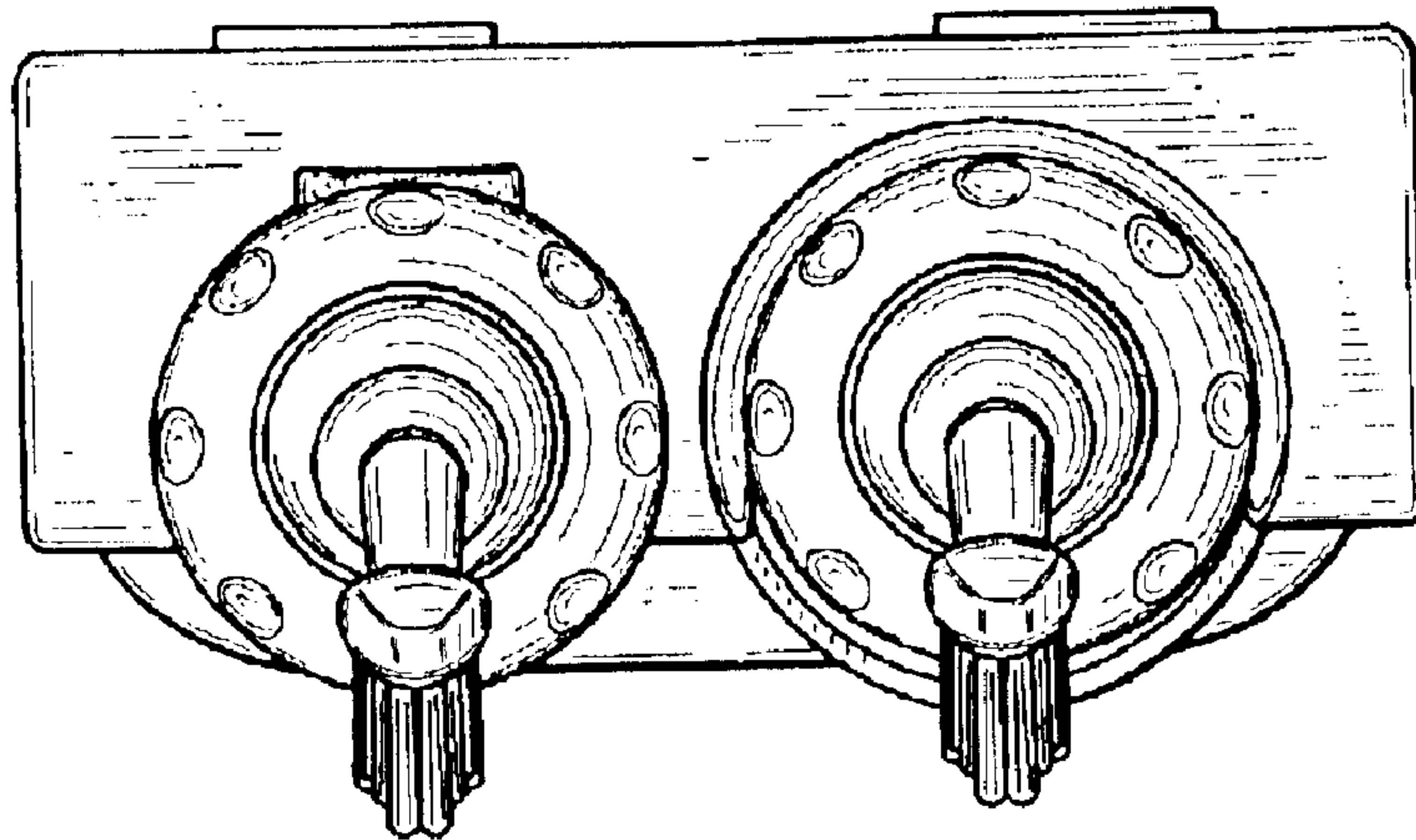

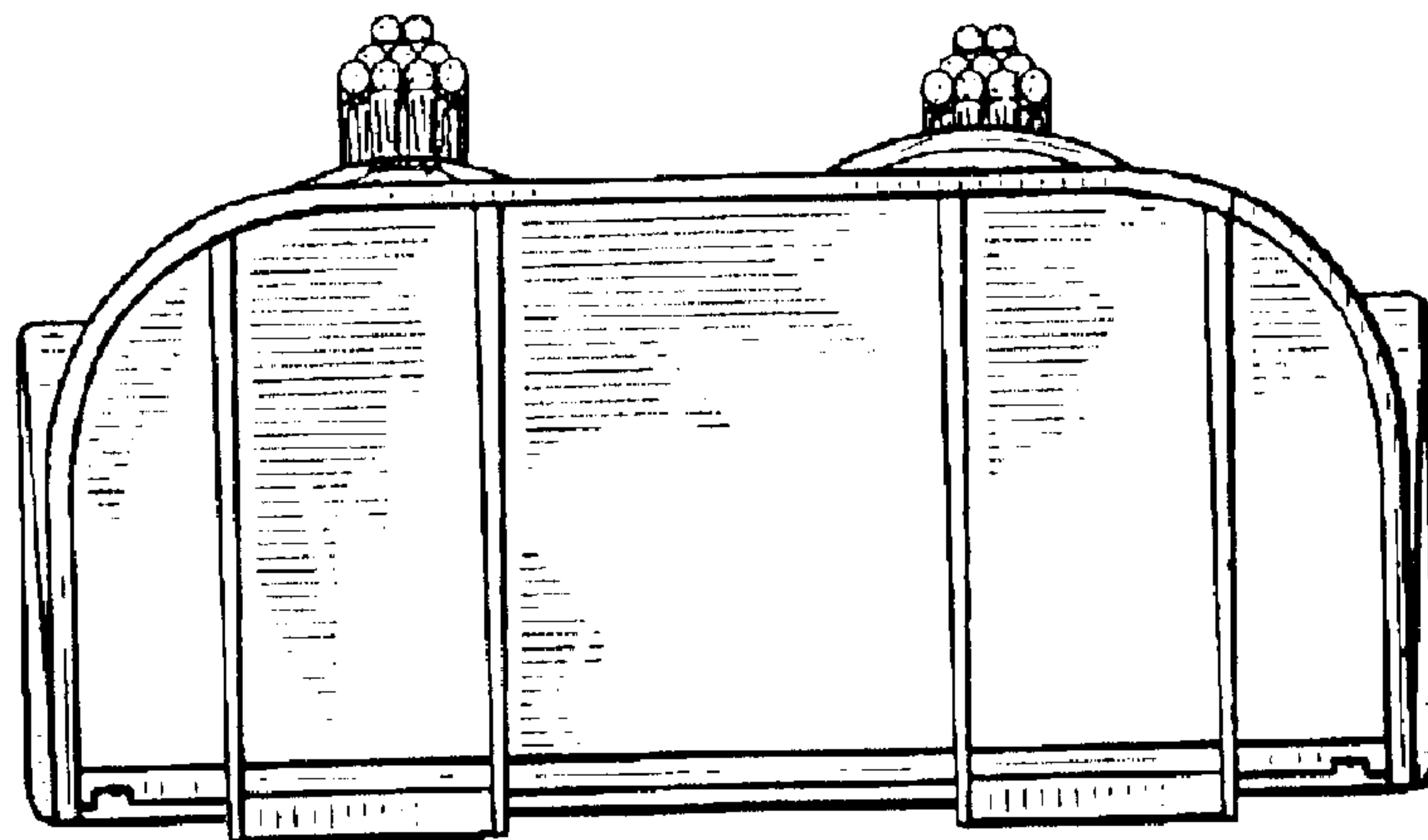
