The ornamental design for an arm, as shown and described.

**DESCRIPTION**

FIG. 1 is a left front perspective view of an arm showing my new design;

FIG. 2 is a right front perspective view, thereof;

FIG. 3 is a side elevational view, the opposite side being a mirror image thereof;

FIG. 4 is a rear elevational view thereof;

FIG. 5 is a top view thereof;

FIG. 6 is a left front perspective view of a second embodiment of an arm showing my new design;

FIG. 7 is a right front perspective view thereof;

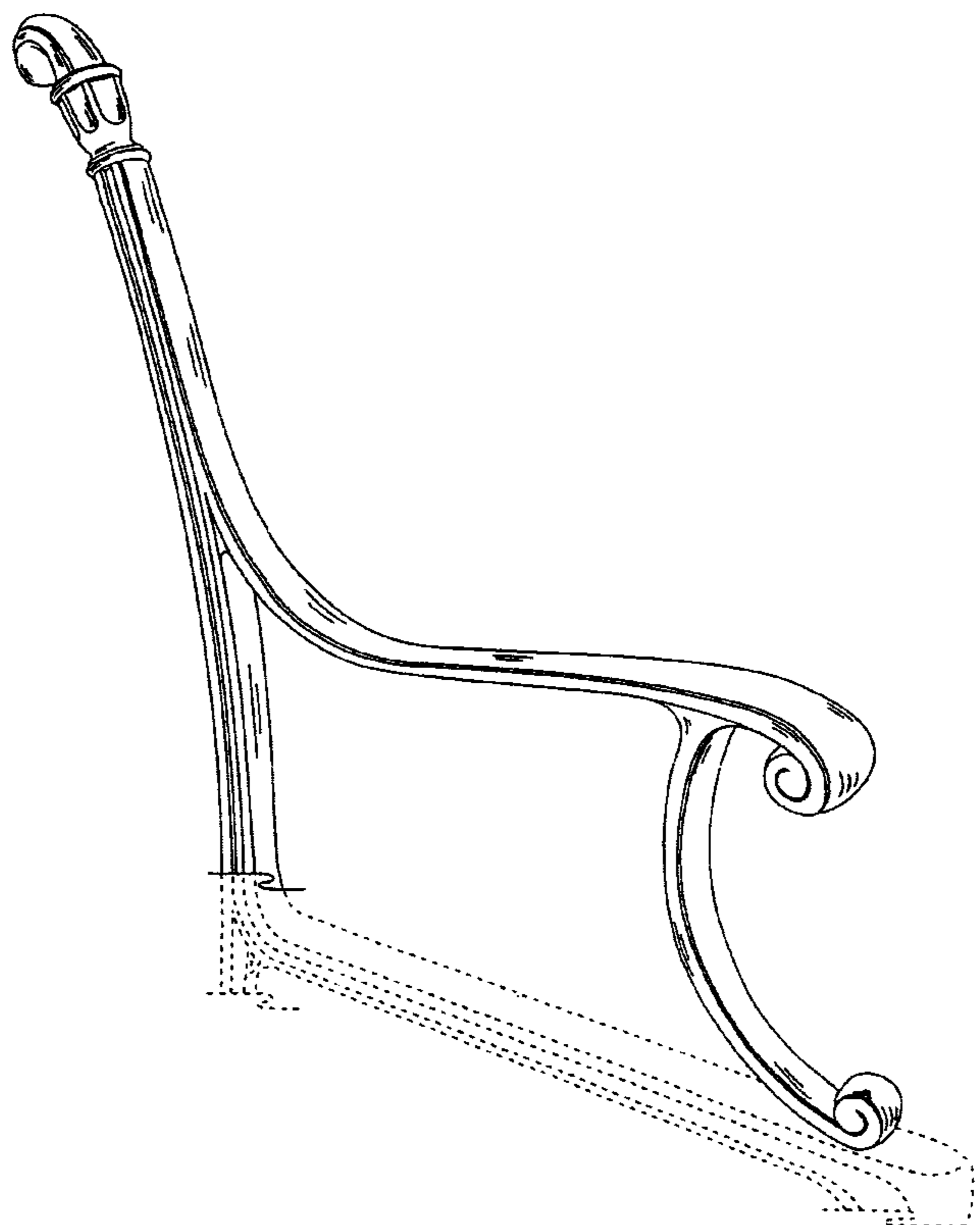
FIG. 8 is a side elevational view, the opposite side being a mirror image thereof;

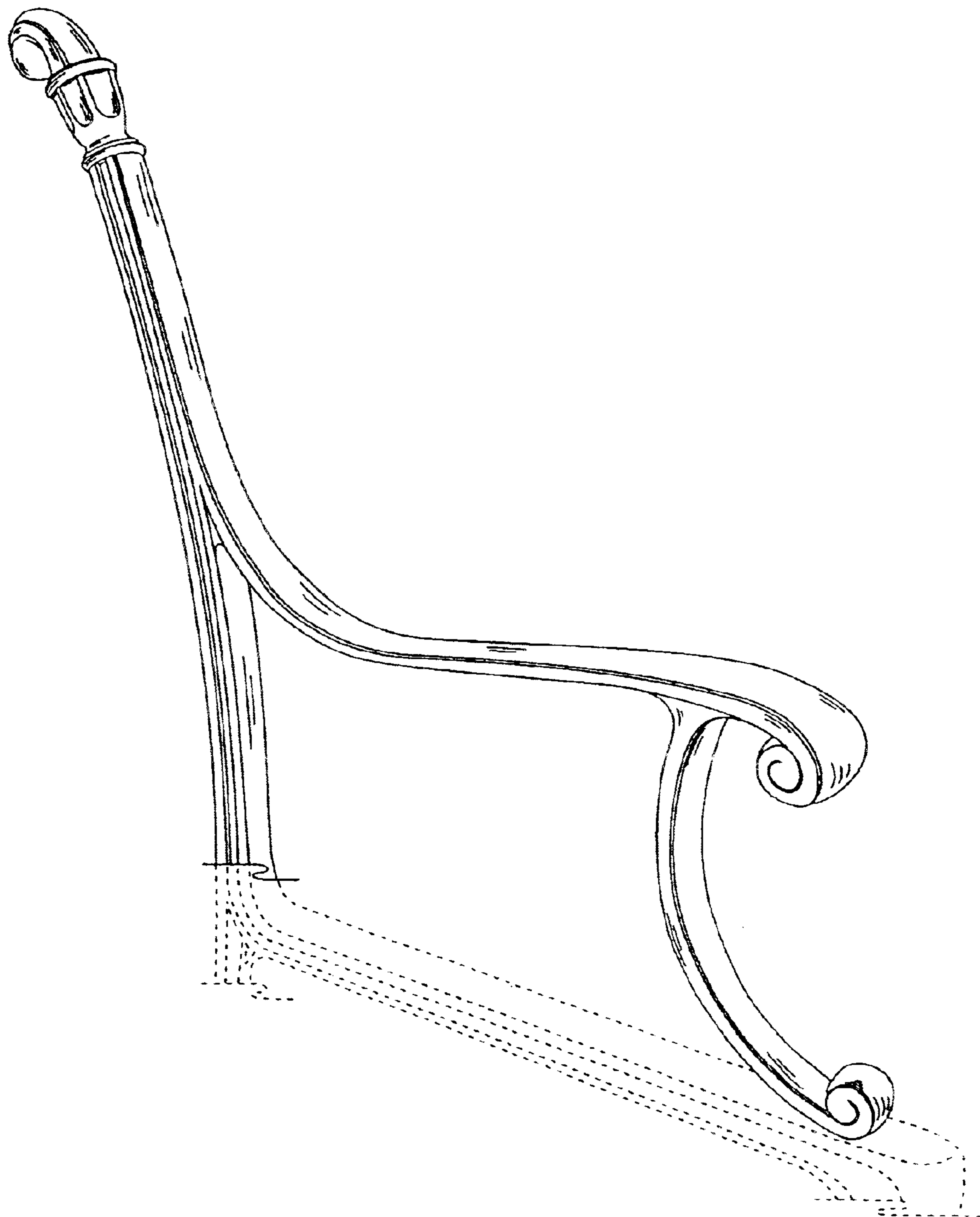

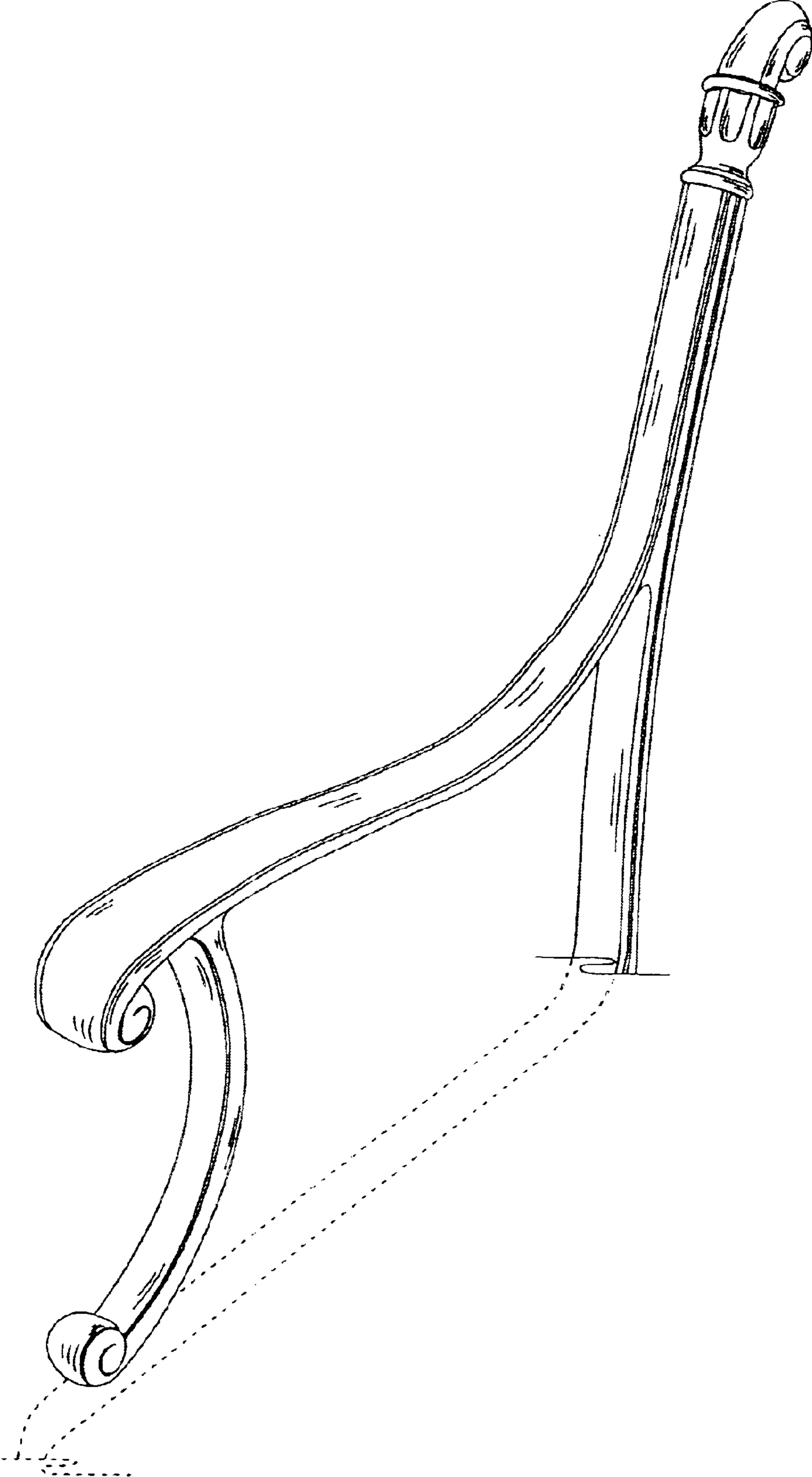

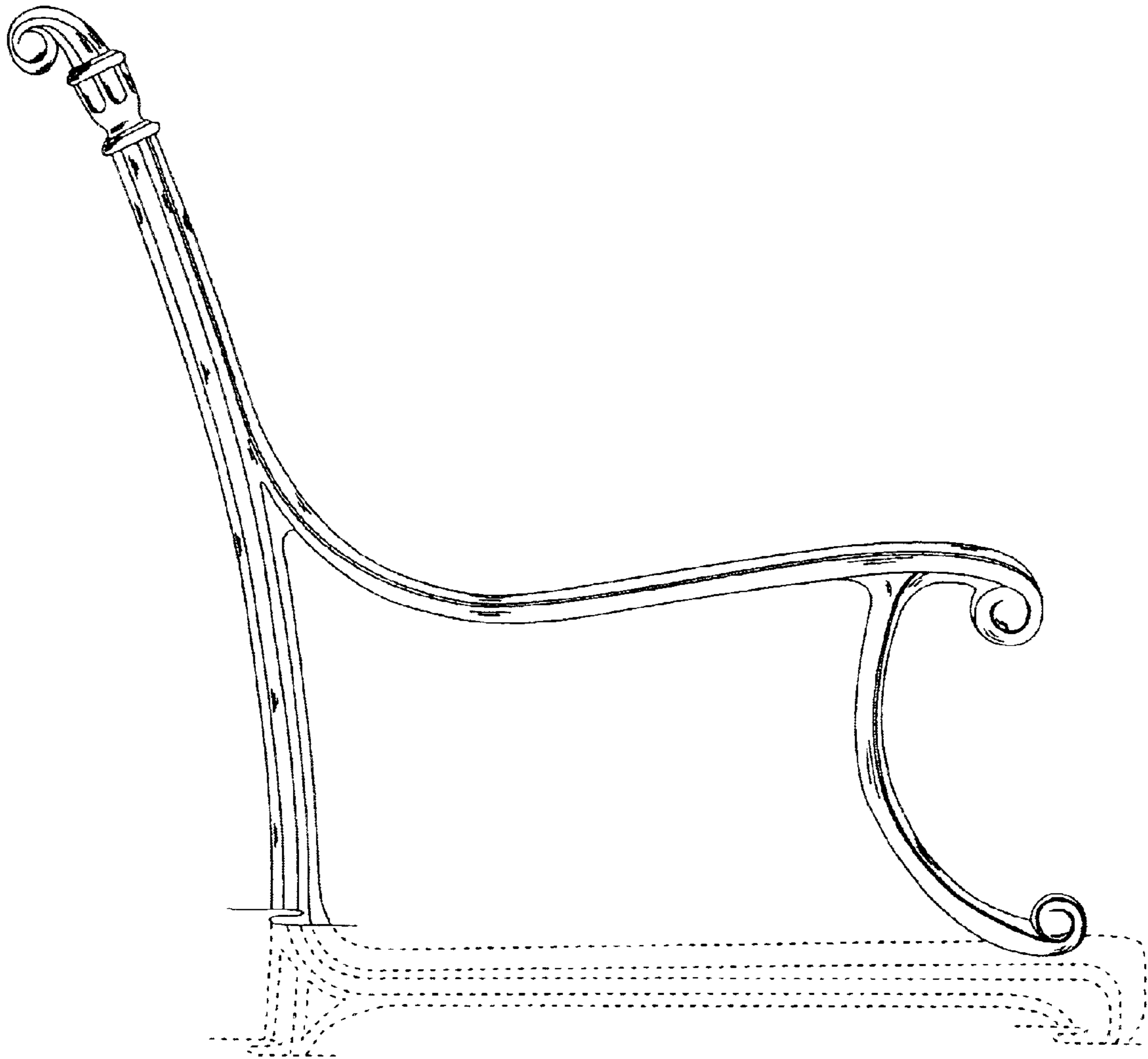

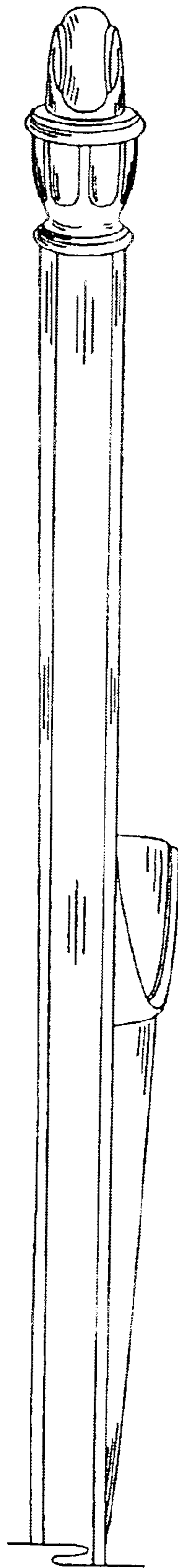

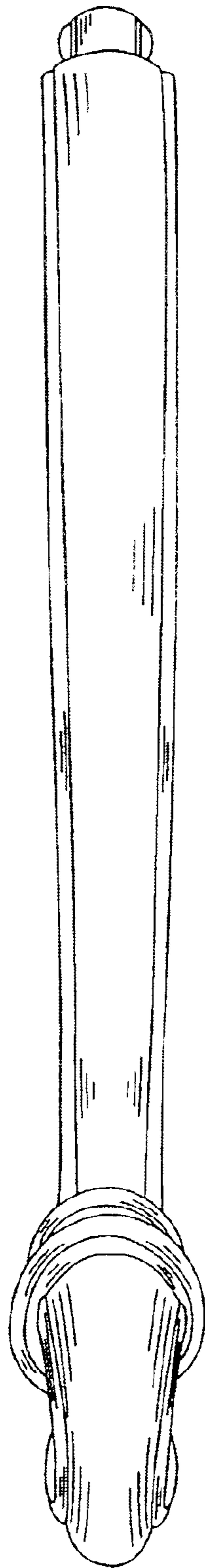

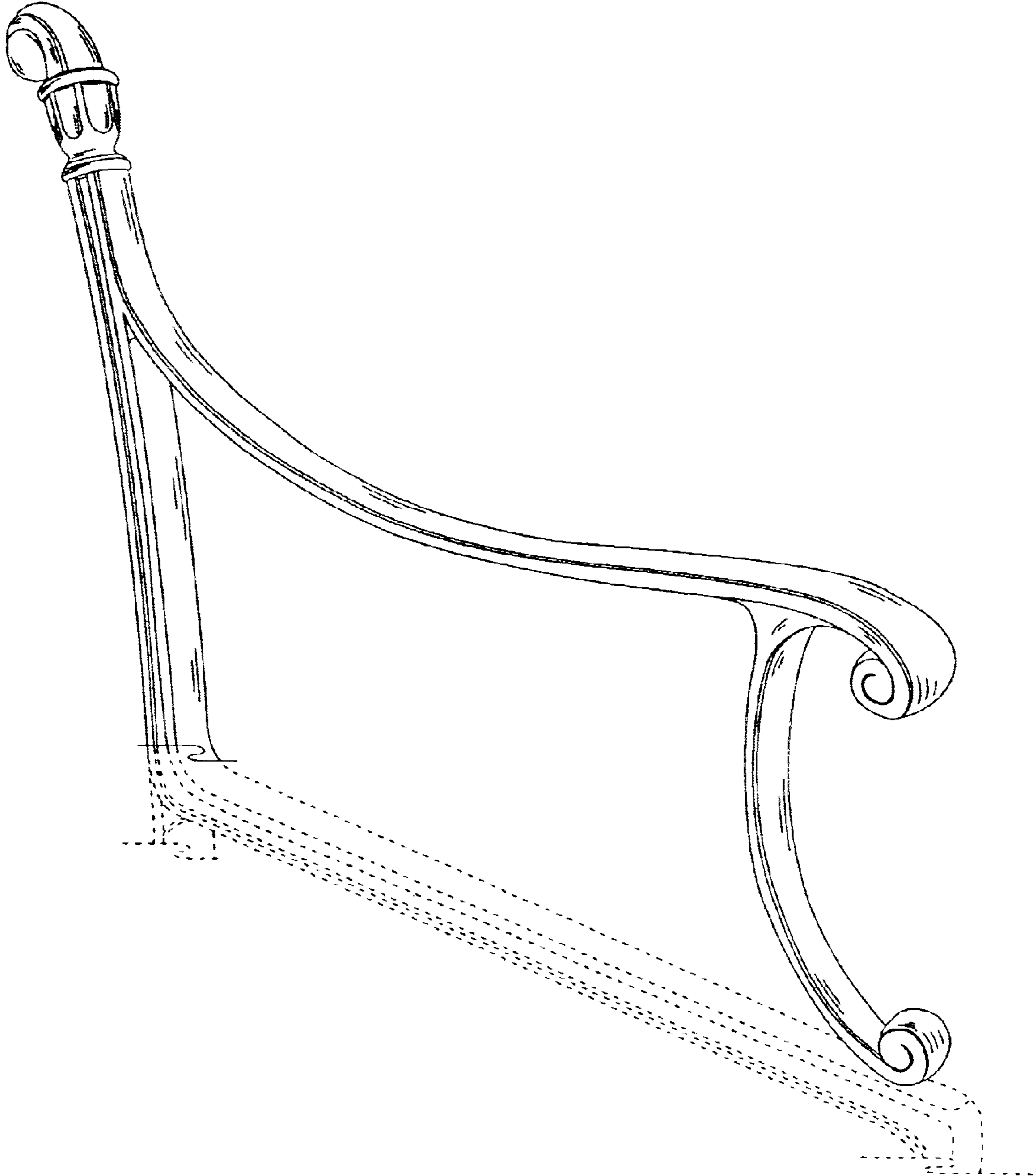

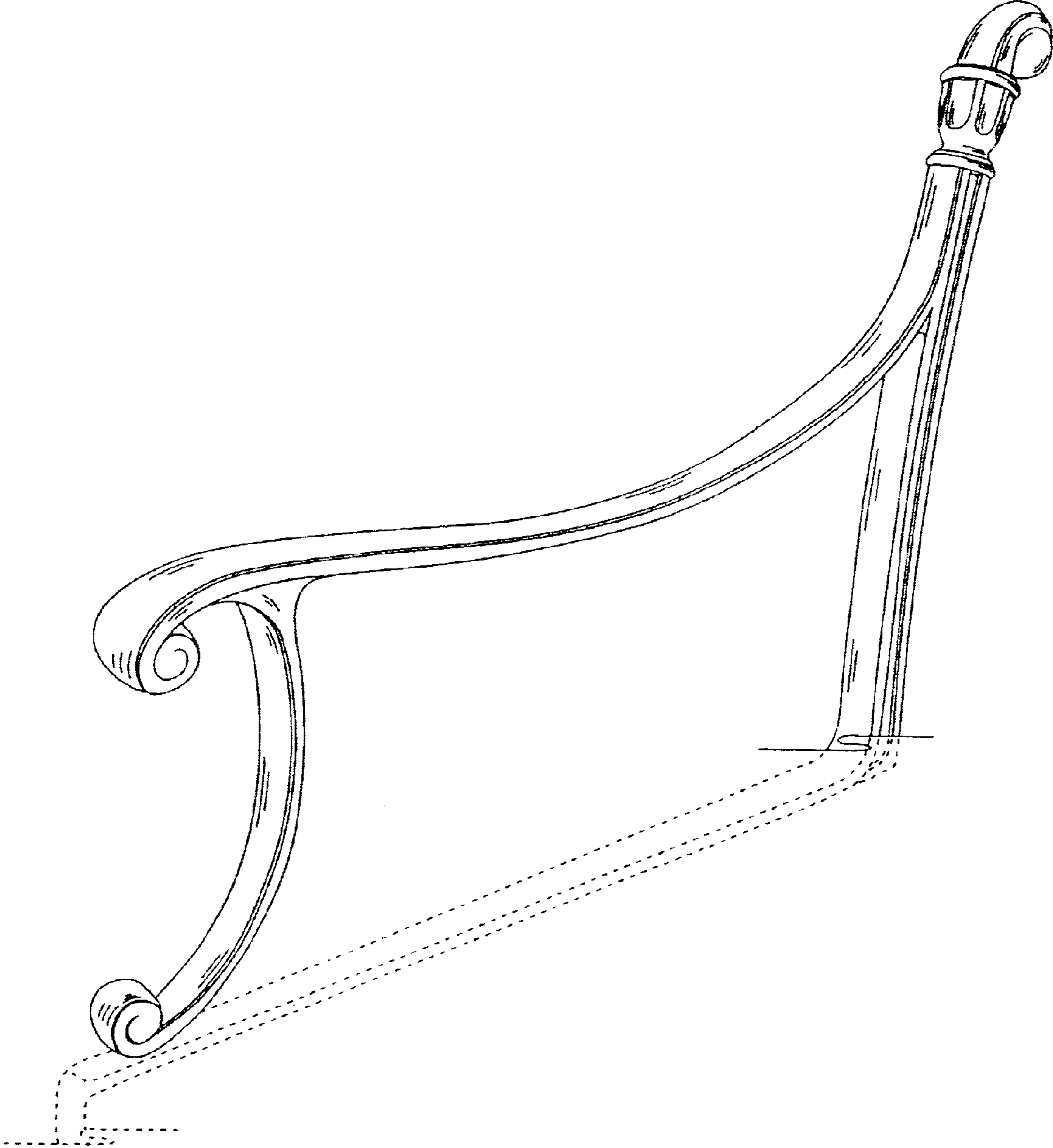

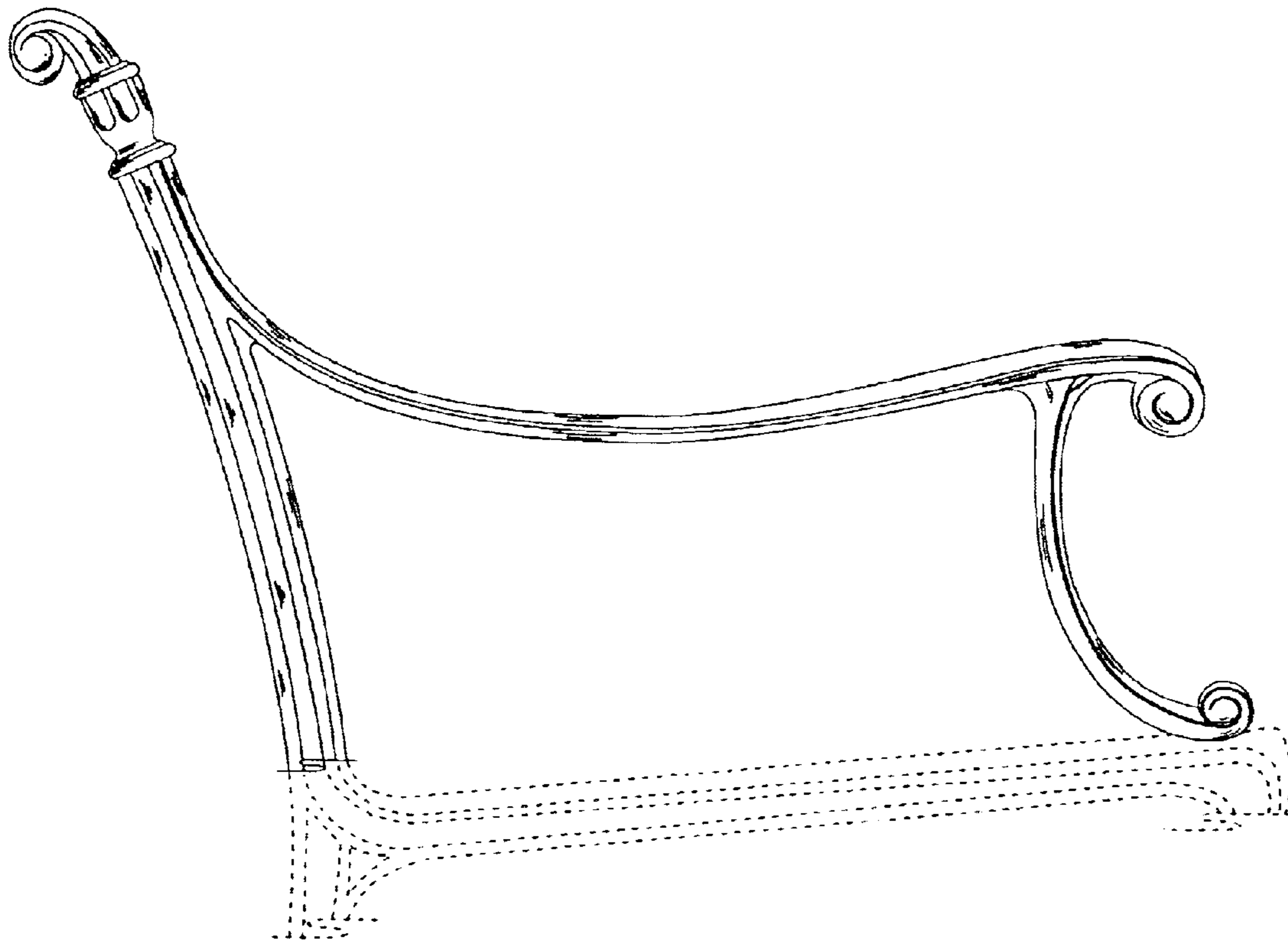

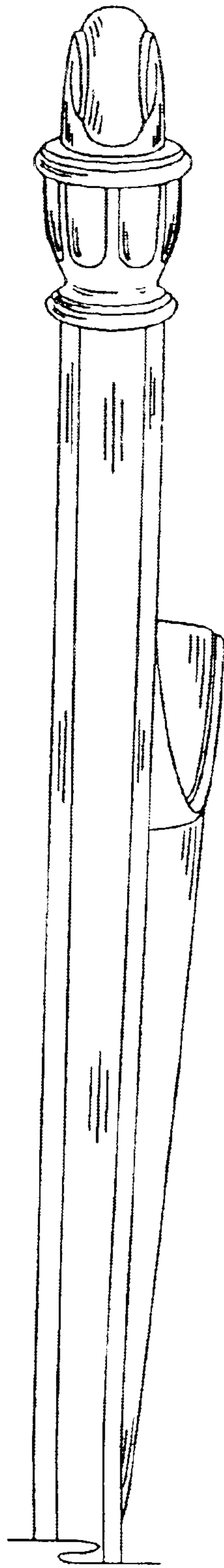

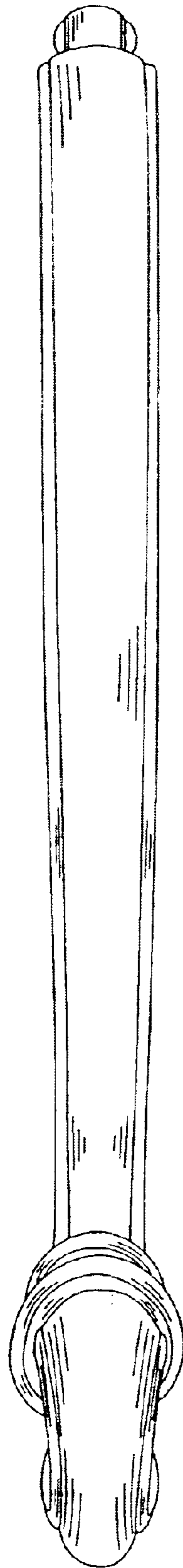
