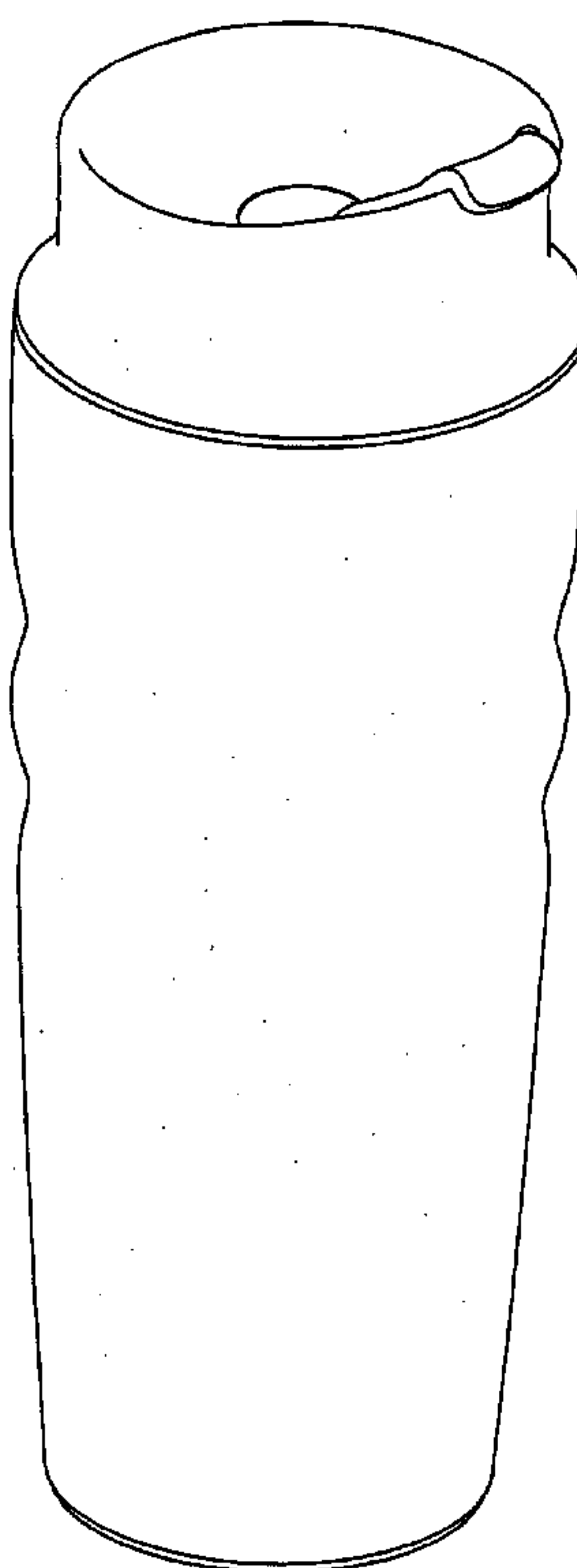
(57) **CLAIM**

The ornamental design for a travel mug with and without handle, as shown and described.

DESCRIPTION

FIG. 1 is an oblique perspective view of a travel mug without a handle;
FIG. 2 is an oblique perspective view of a travel mug of FIG. 1 with a handle;
FIG. 3 is a front view of the travel mug without a handle as shown in FIG. 1;
FIG. 4 is a left side view of the travel mug without a handle;
FIG. 5 is a front view of the travel mug with a handle as shown in FIG. 2; and,
FIG. 6 is a left side view of the travel mug with a handle.

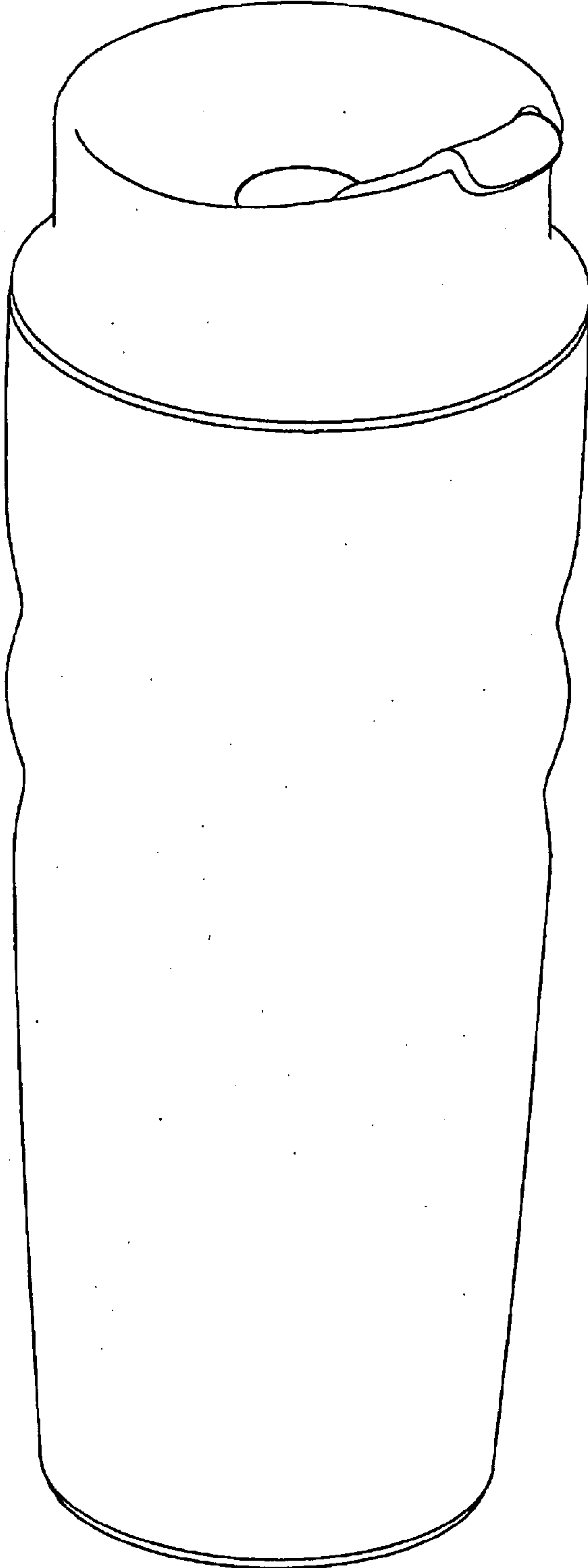

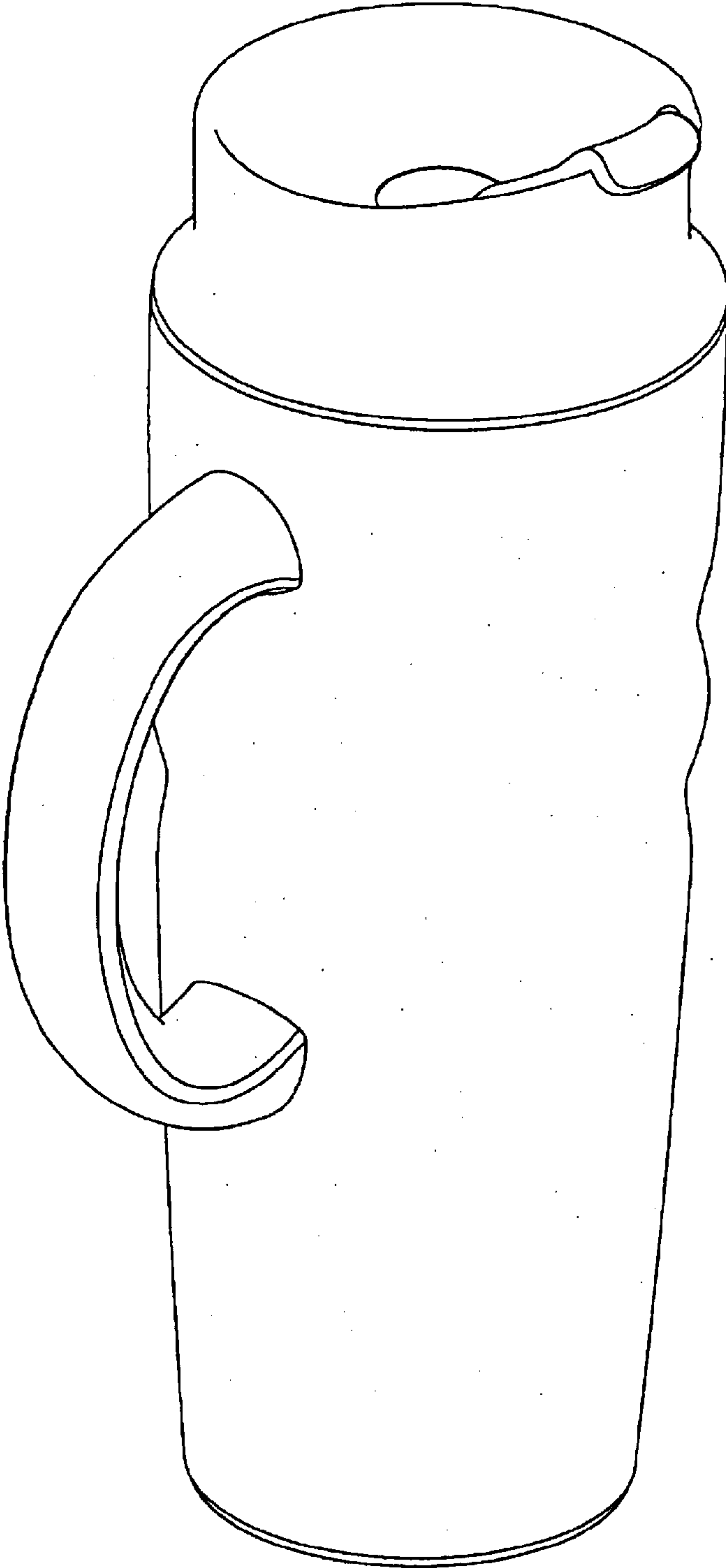

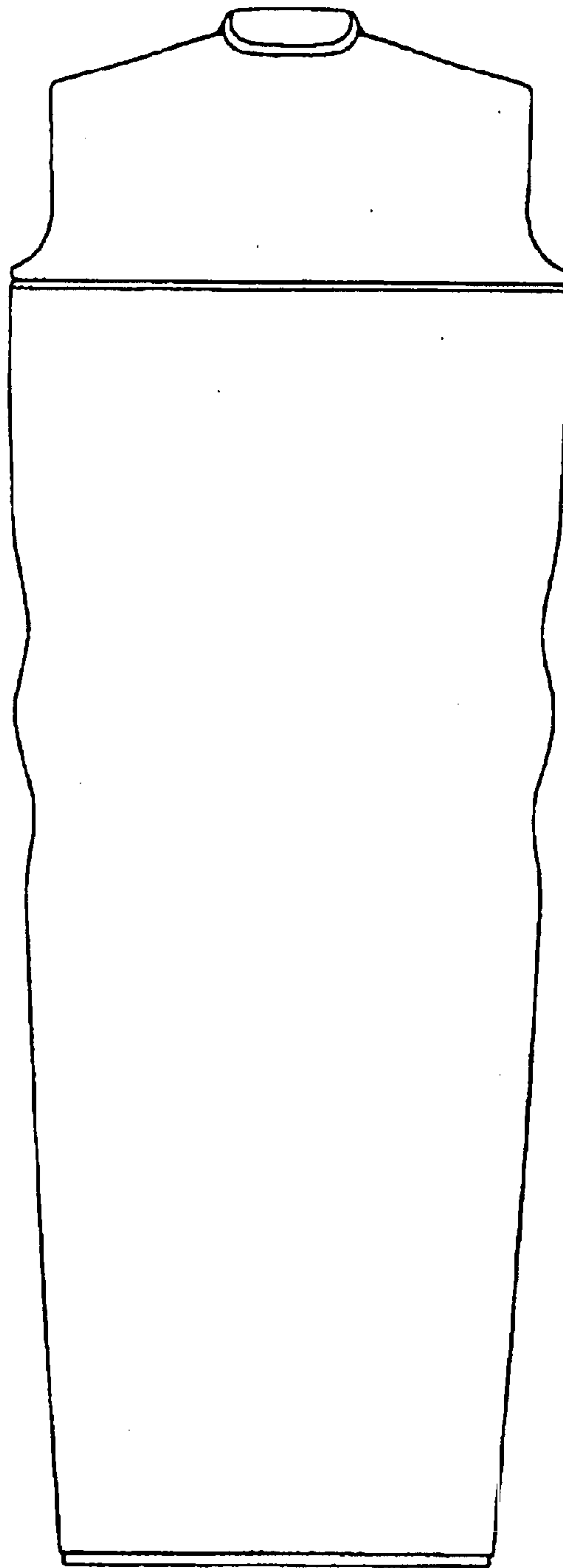

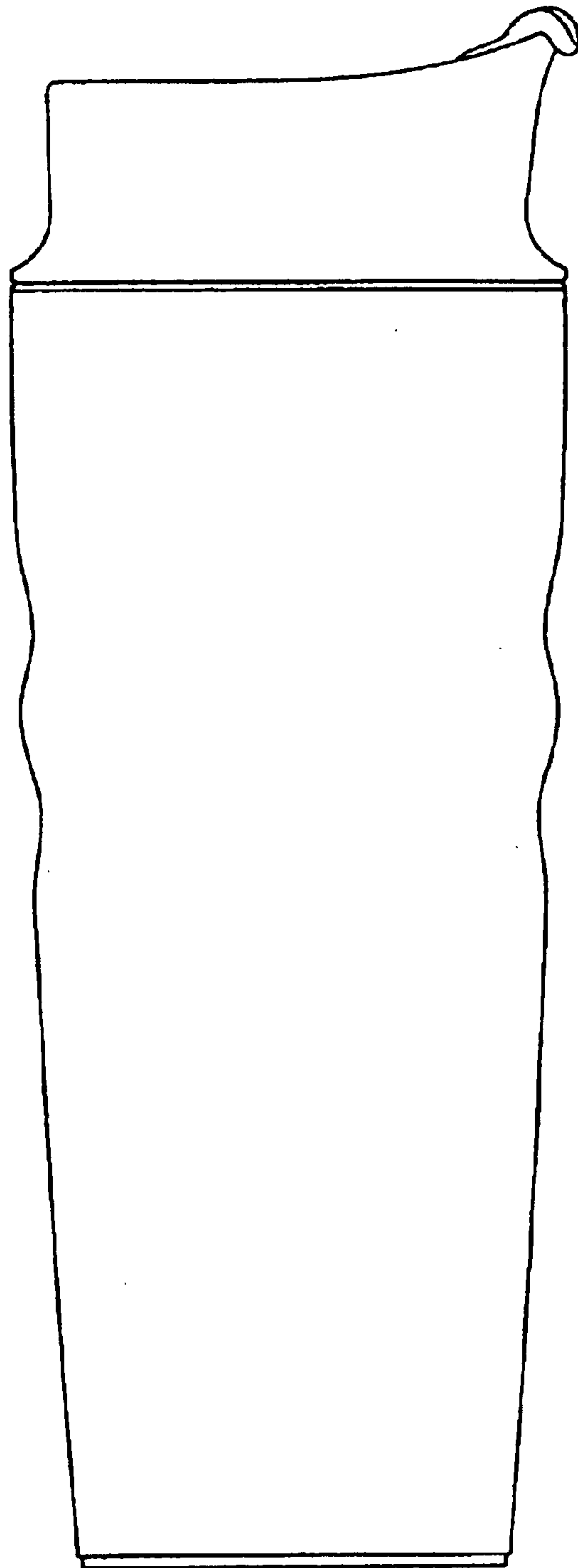

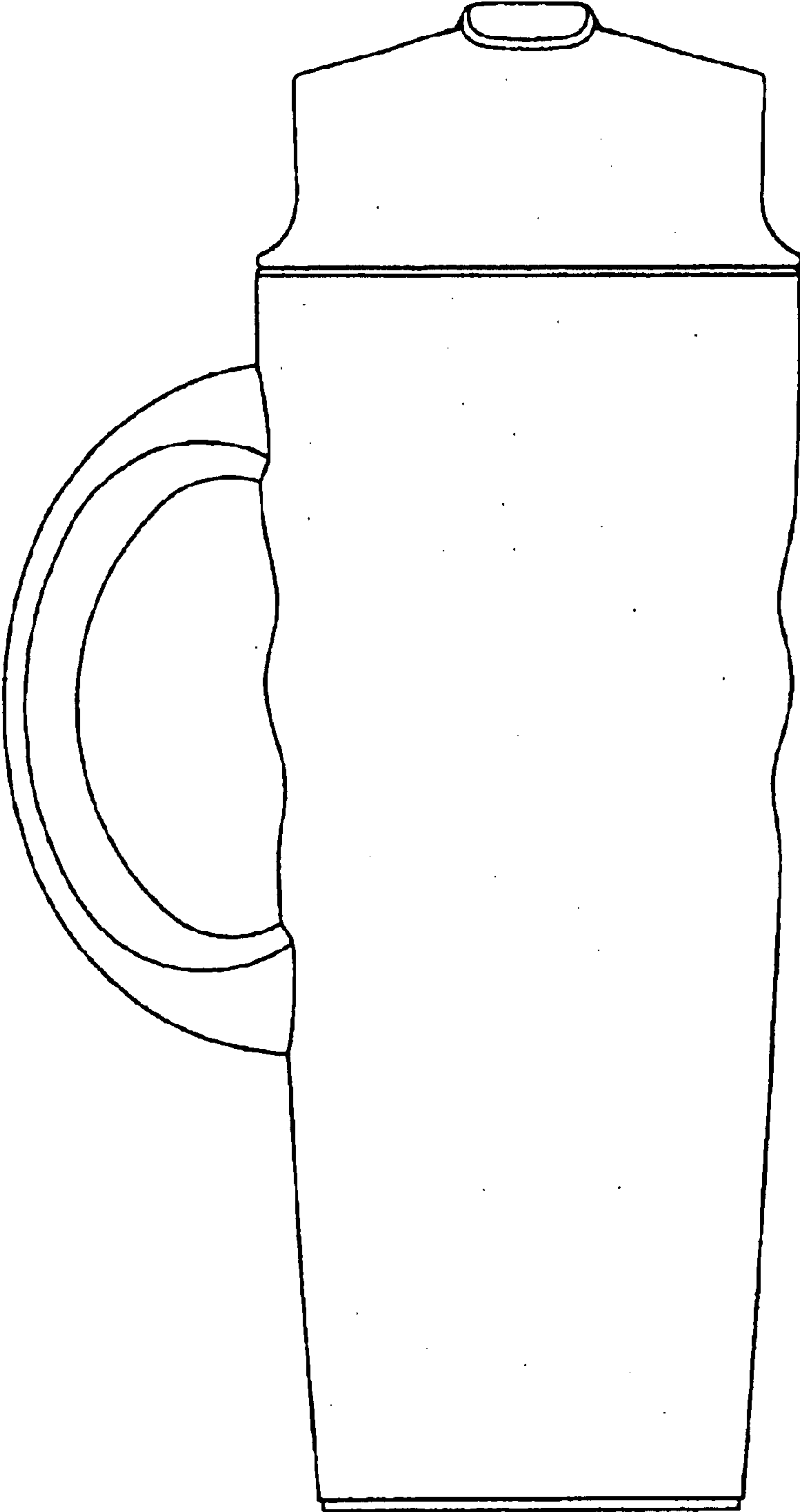

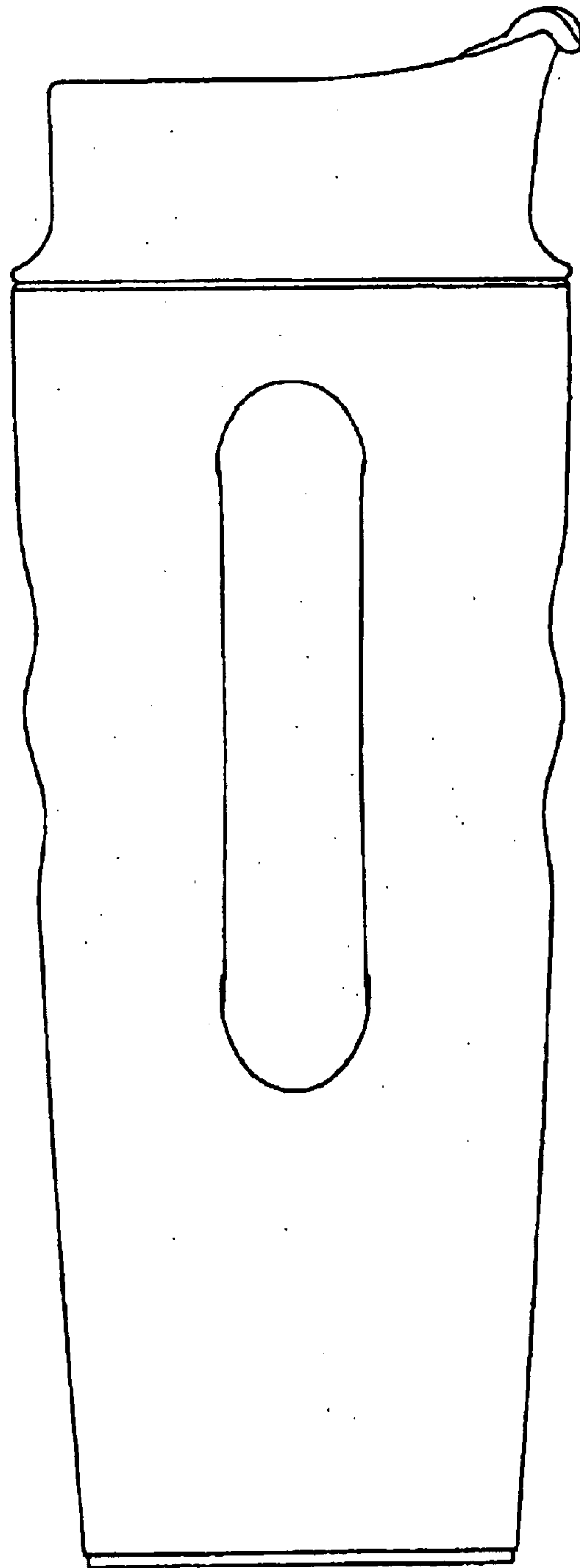
