(57) **CLAIM**

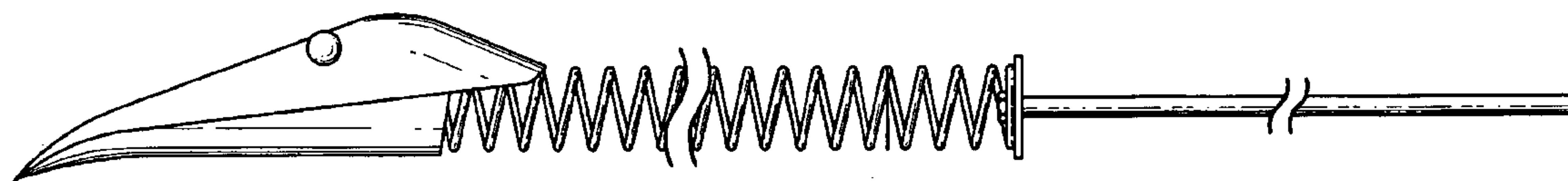
The ornamental design for an avian garden stake, as shown and described herein.

**DESCRIPTION**

FIG. 1 Is a right side elevational view of our avian garden stake with left side elevational view being a mirror image thereof;  
FIG. 2 Is a top plan view thereof;  
FIG. 3 Is a bottom plan view thereof;  
FIG. 4 Is a rear elevational view thereof; and,  
FIG. 5 Is a front elevational view thereof.  
The stake is shown partially broken away in FIGS. 1–3 to indicate indeterminate length of the spring and shaft portions thereof.

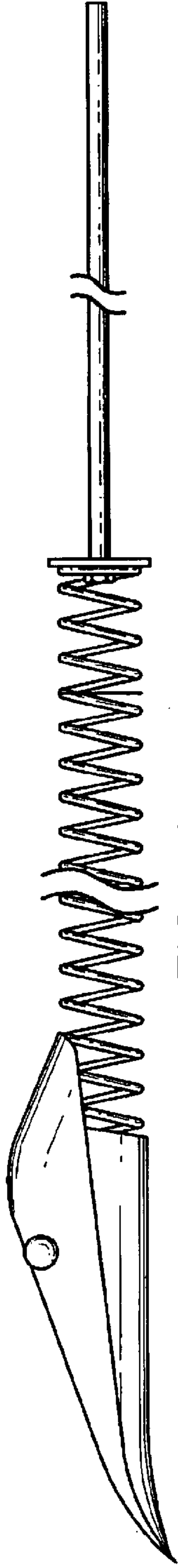

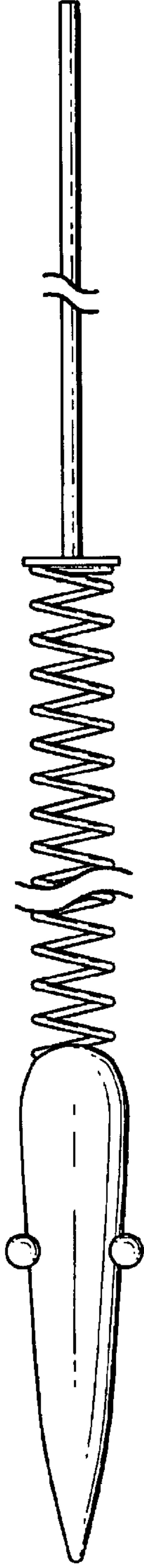

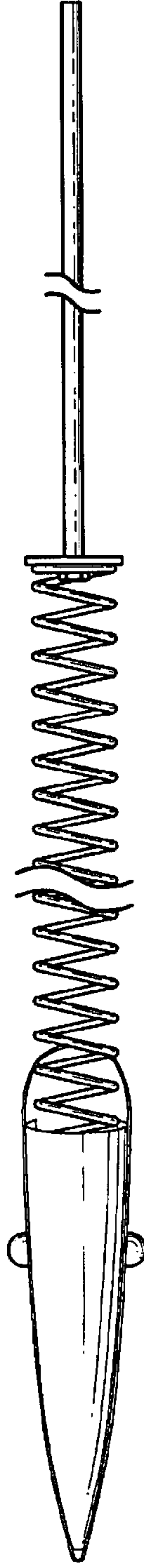

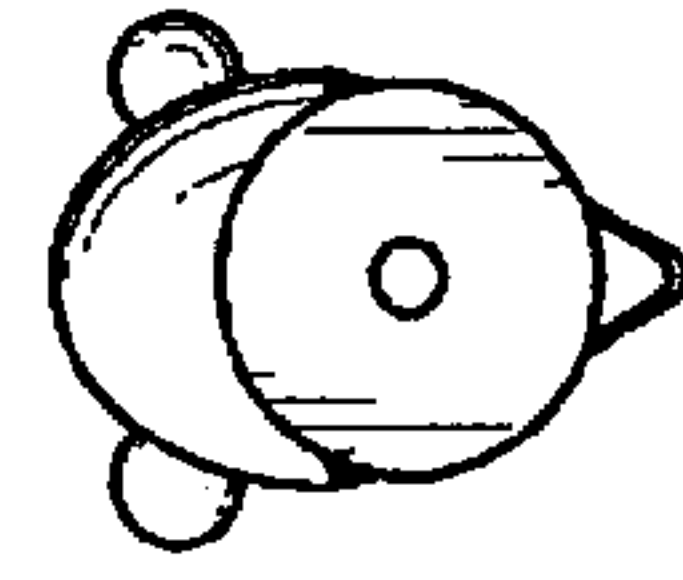

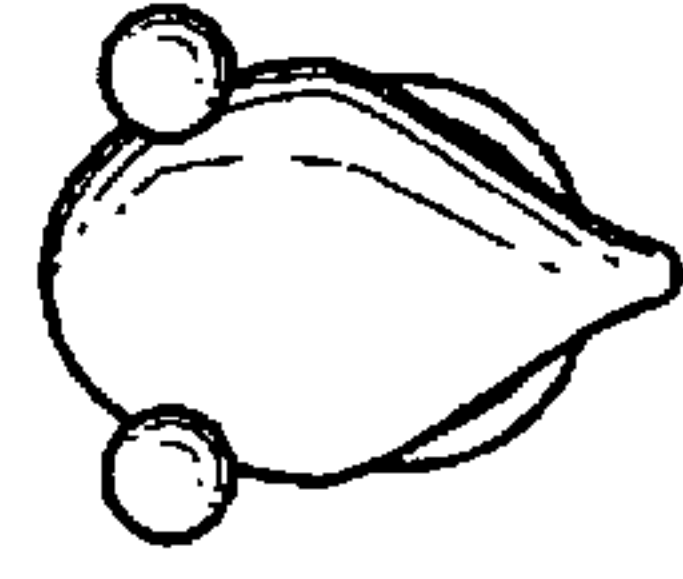
