(57) **CLAIM**

The ornamental design for an automobile bumper, as shown and described.

DESCRIPTION

FIG. 1 is a left-front, perspective view of an automobile bumper of our new design;

FIG. 2 is a front view of our new design;

FIG. 3 is a rear view of our new design;

FIG. 4 is a top view of our new design;

FIG. 5 is a bottom view of our new design;

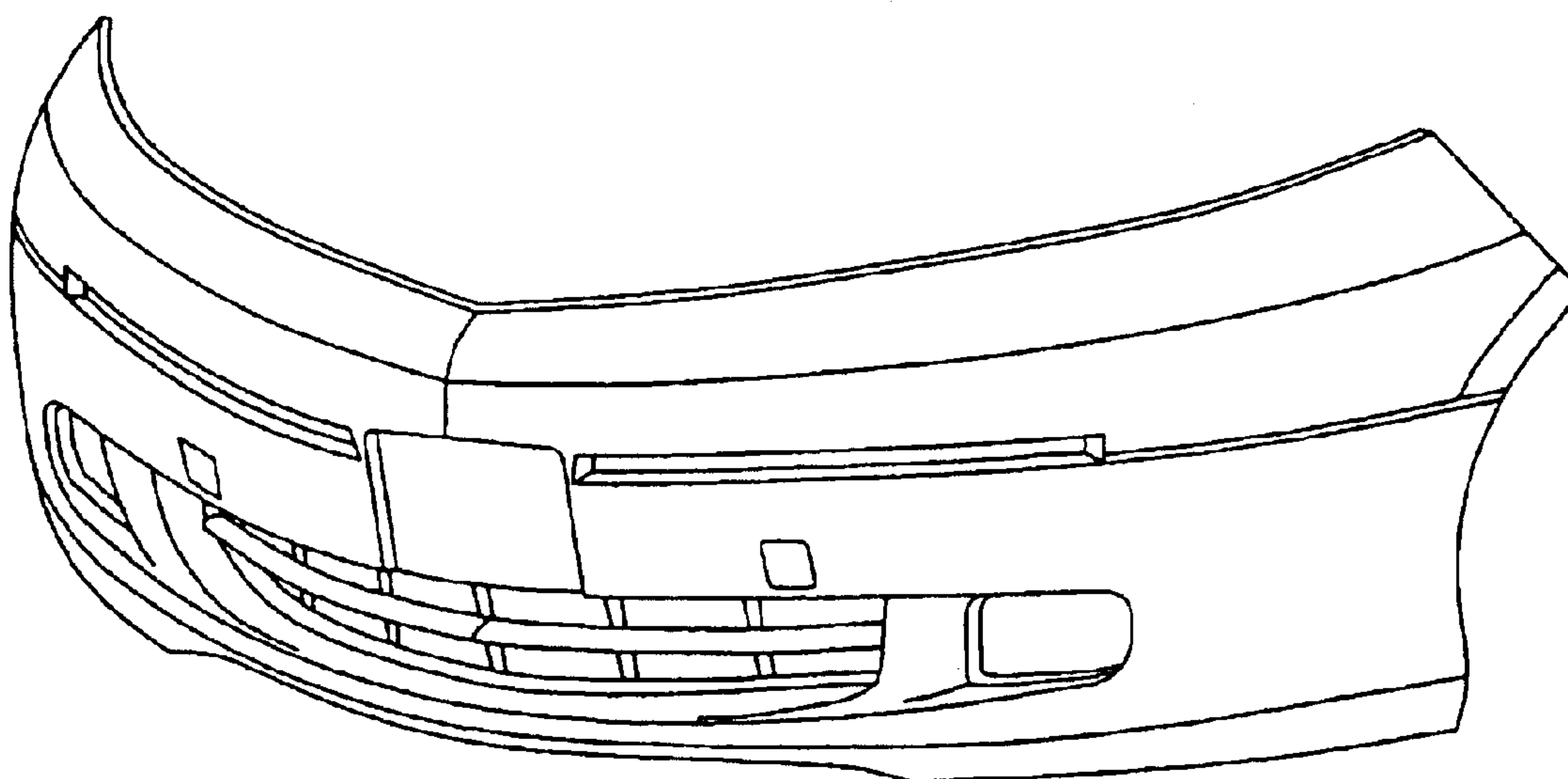
FIG. 6 is a left-side view our new design, the right-side view being a mirror image thereof;

FIG. 7 is a cross-sectional view of our new design taken along the line 7—7 in FIG. 2, showing the profile of that portion of the design;

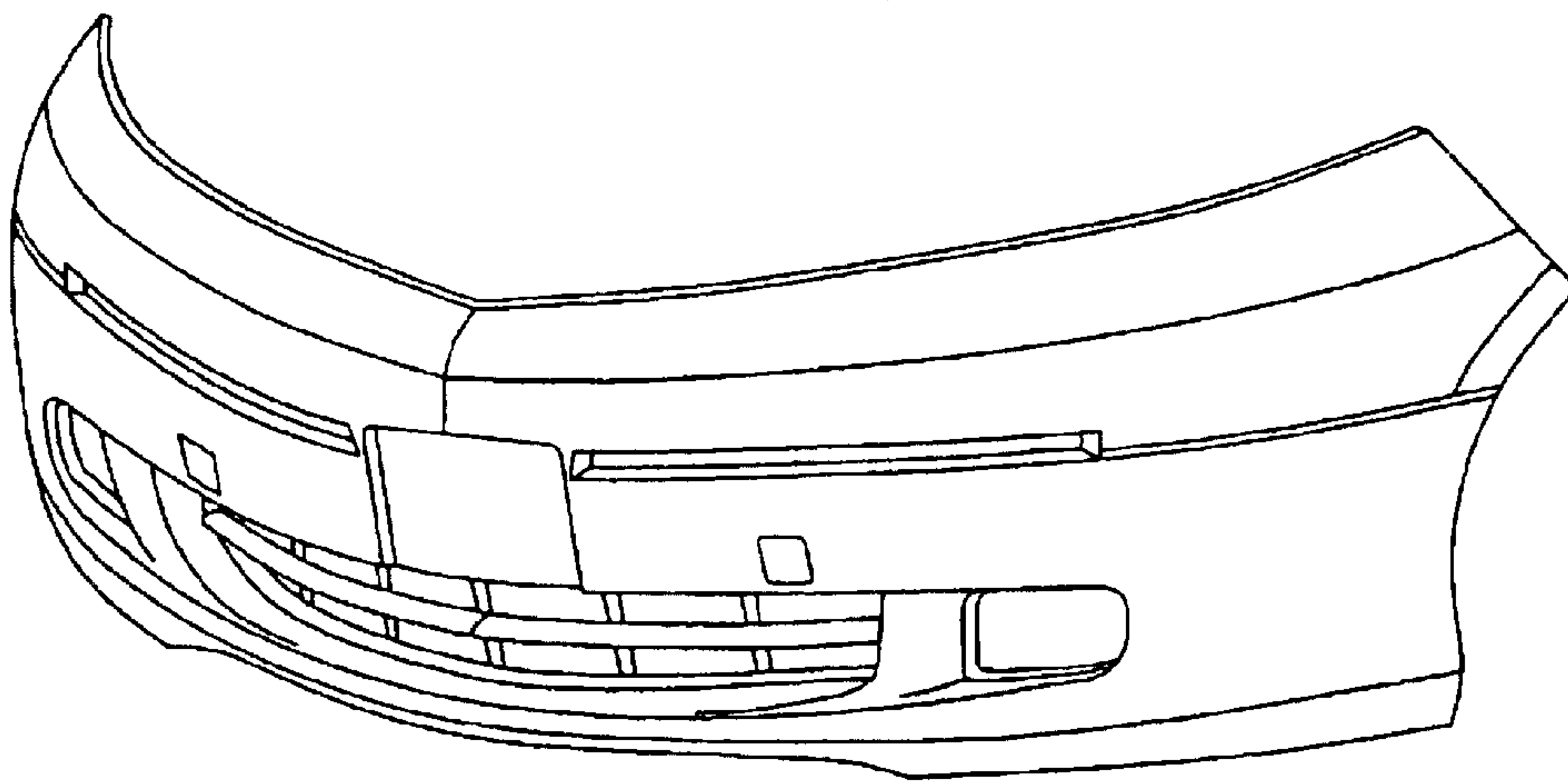

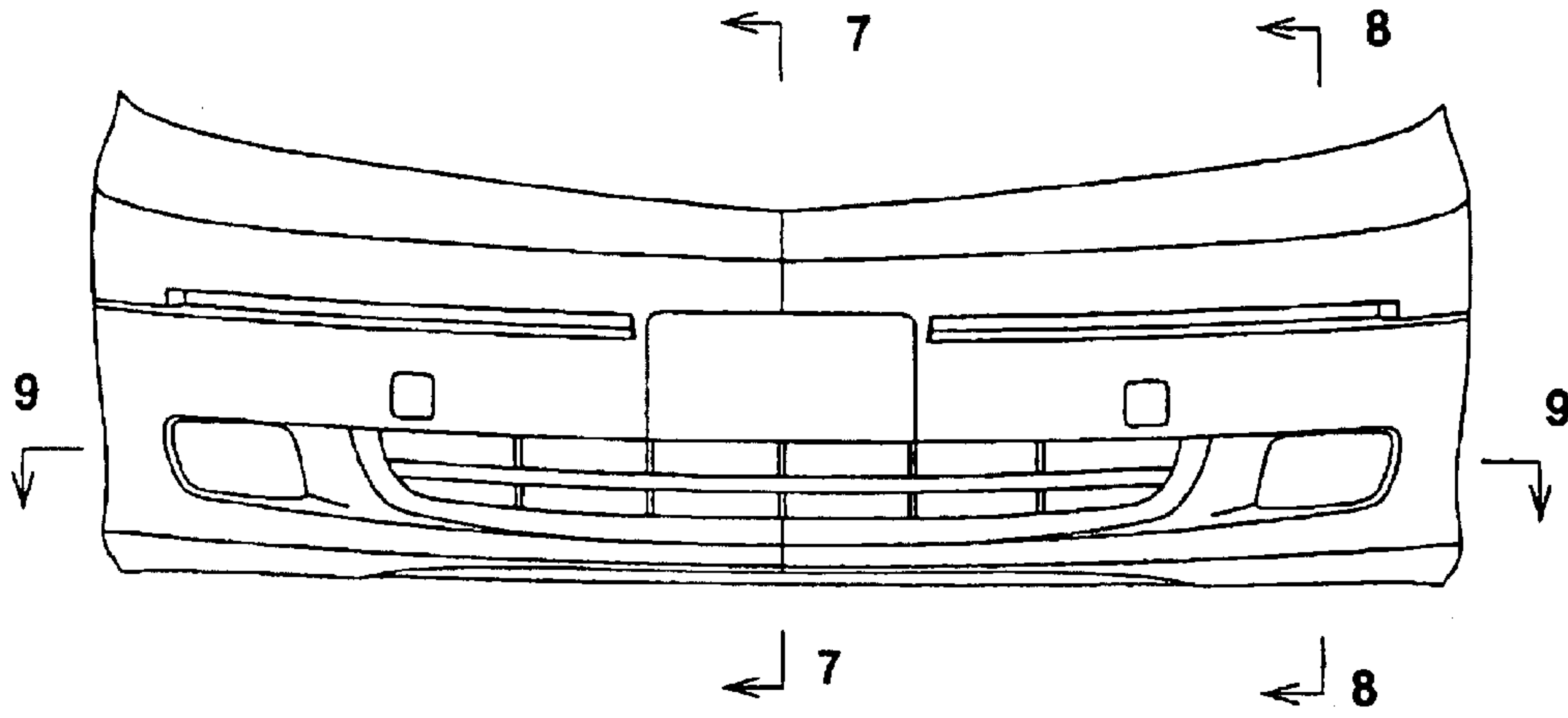

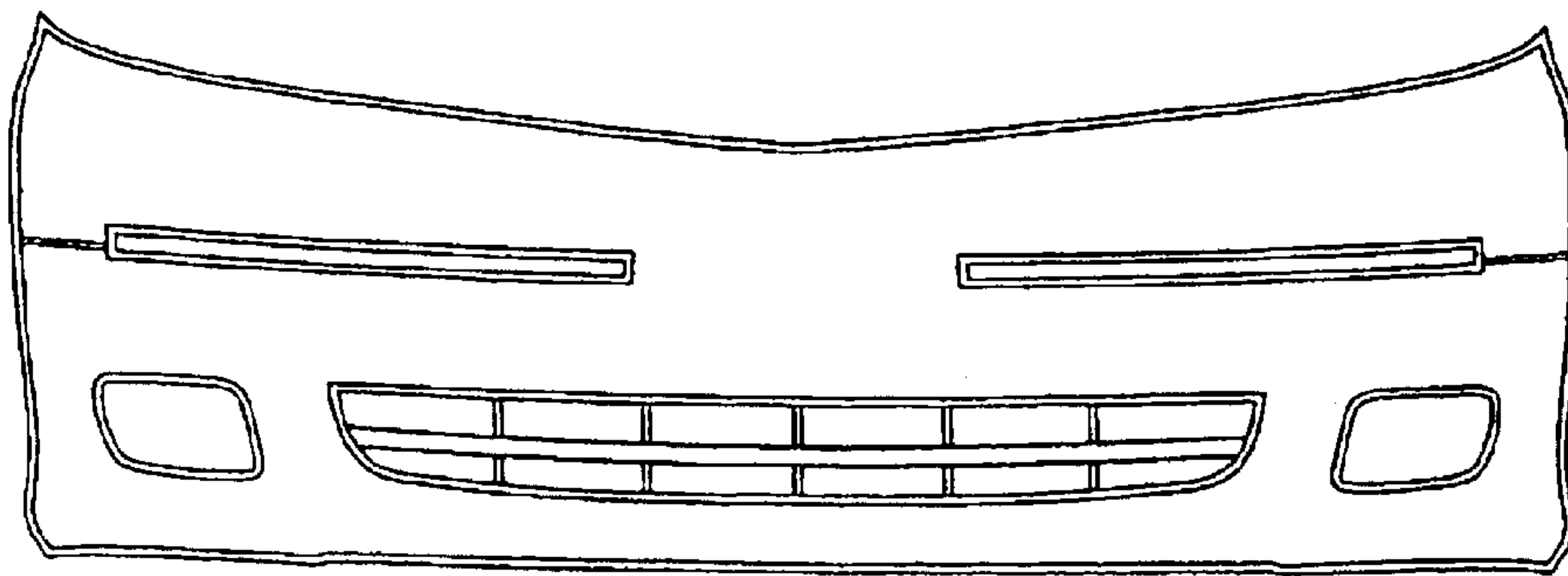

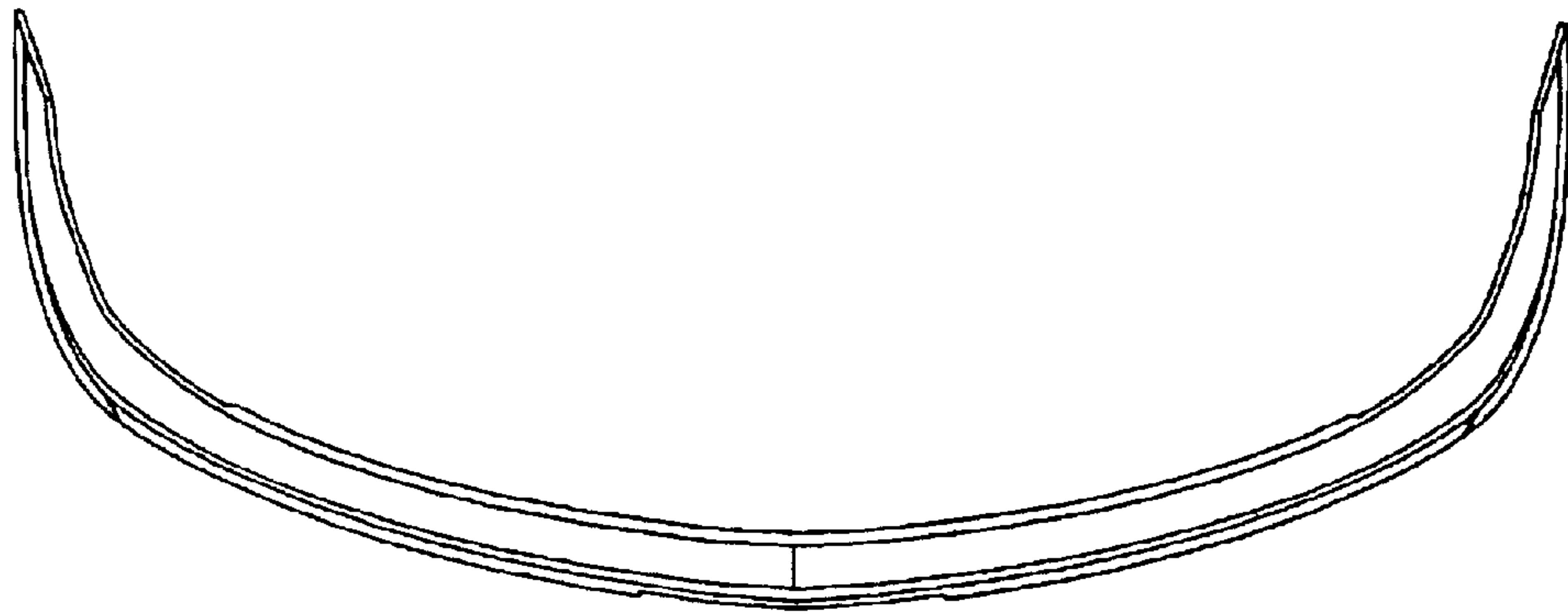

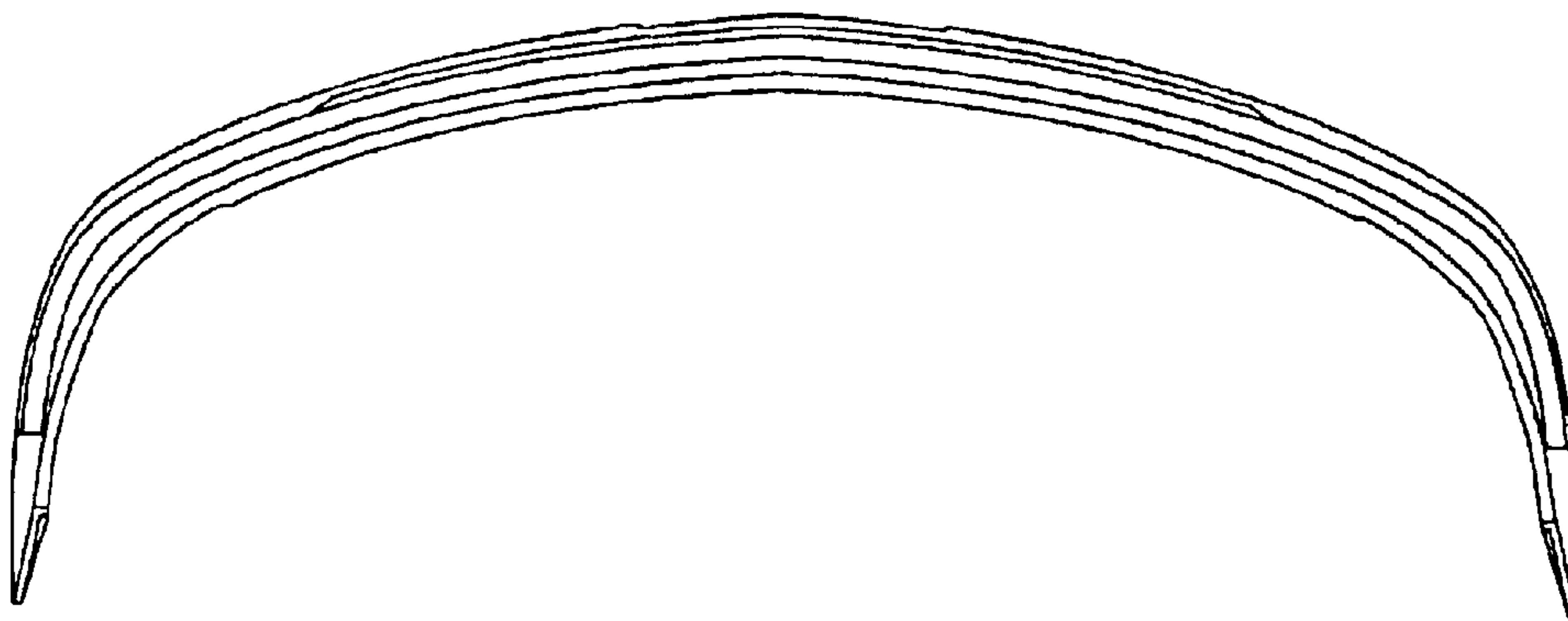

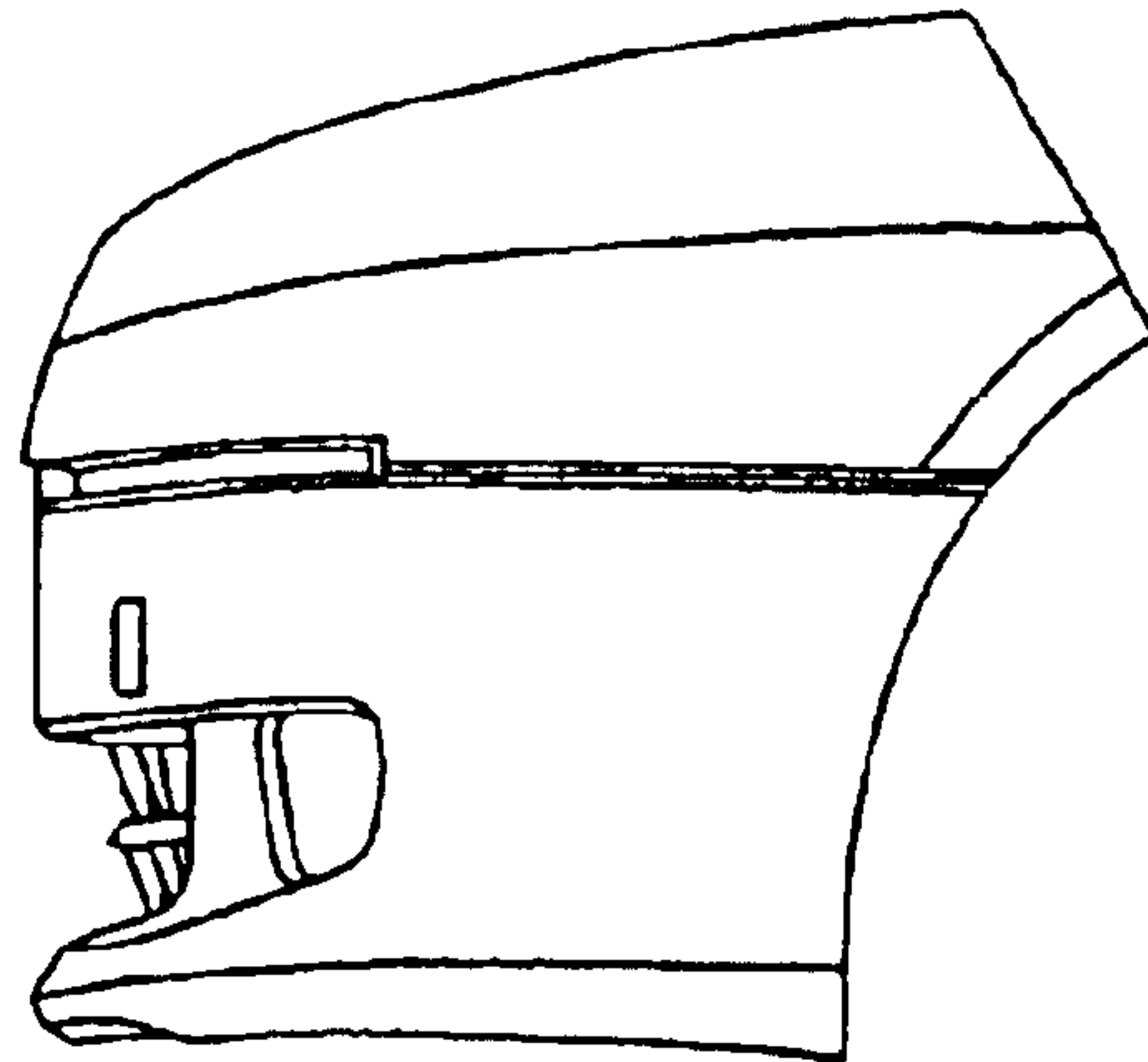

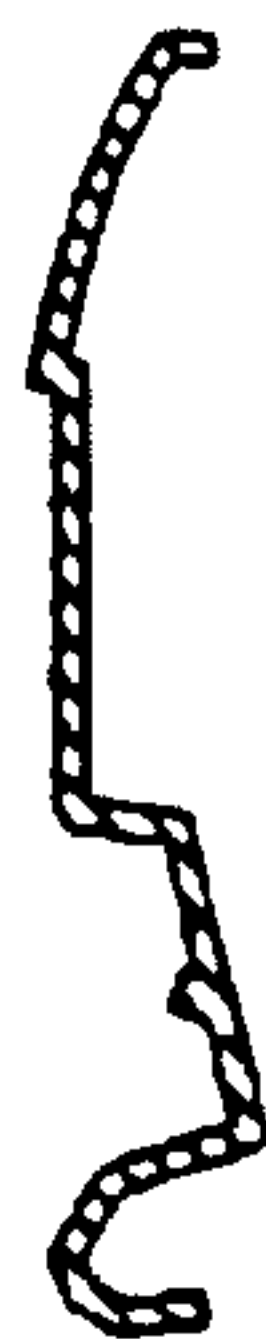

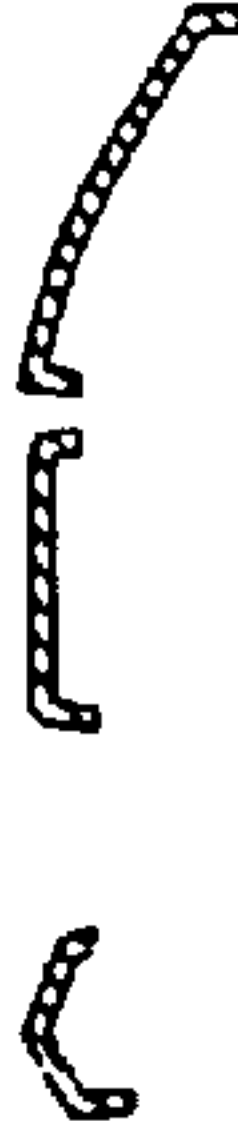

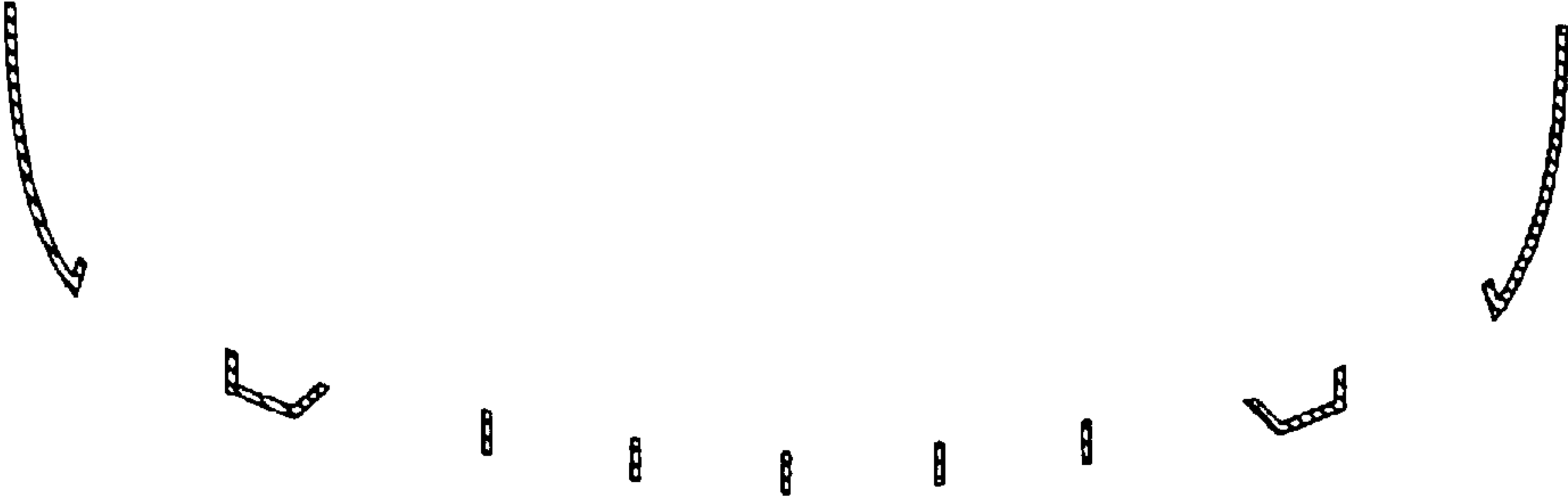
