FIG. 1 is a front view of sunglasses in accordance with this invention.

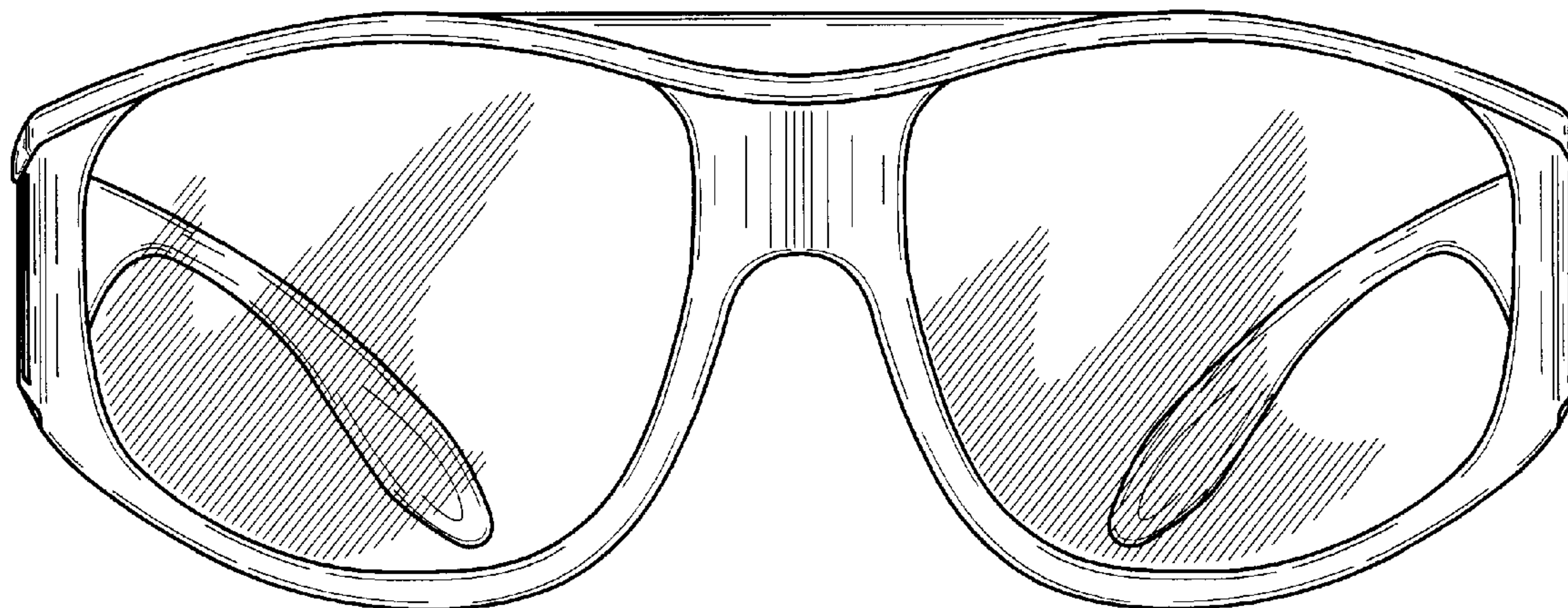
FIG. 2 is a rear view of the design shown in FIG. 1.

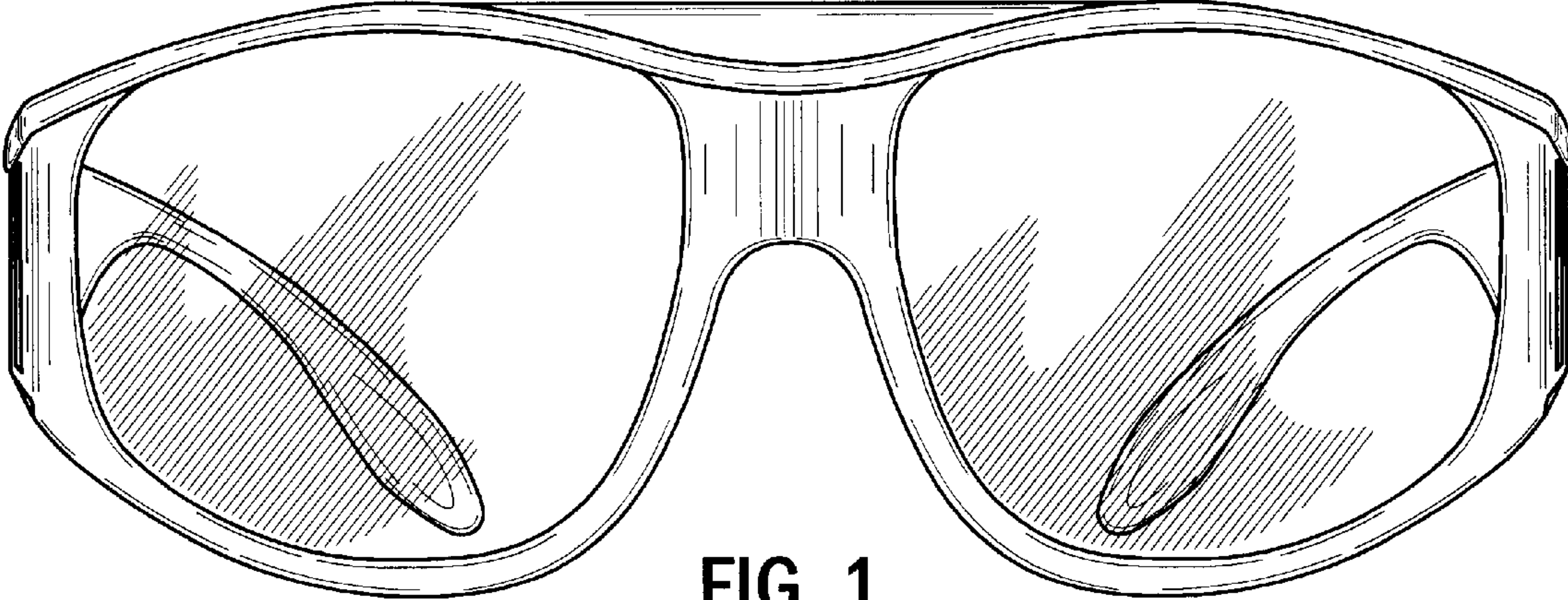

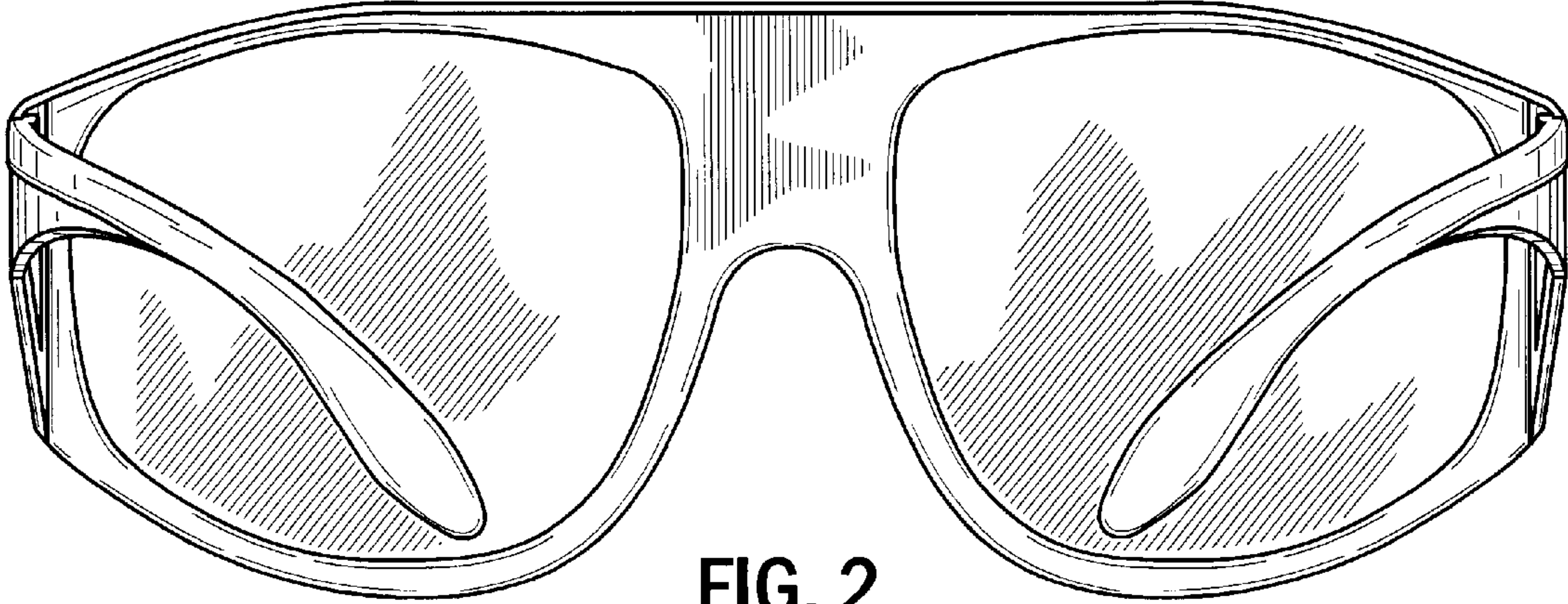

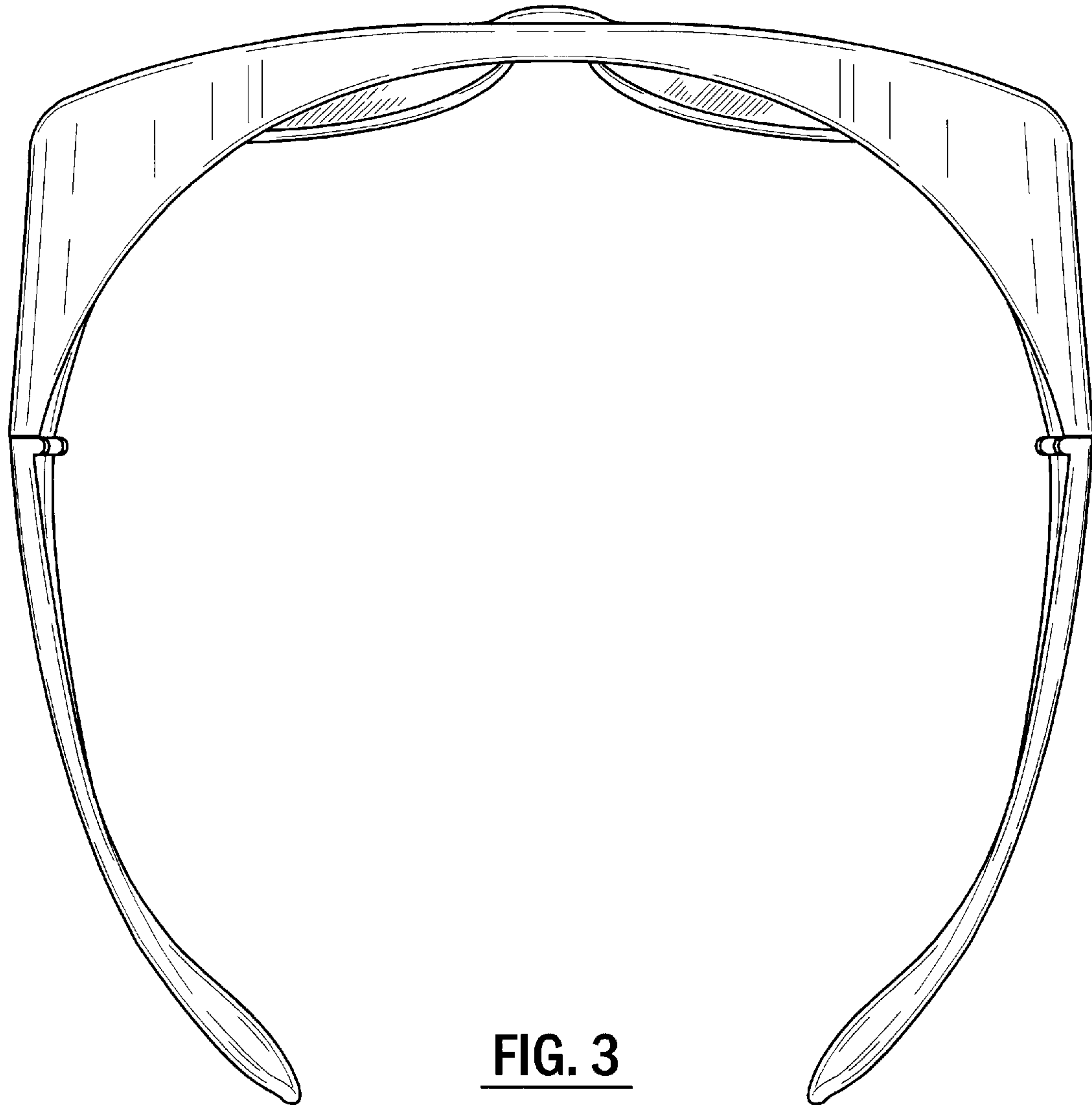

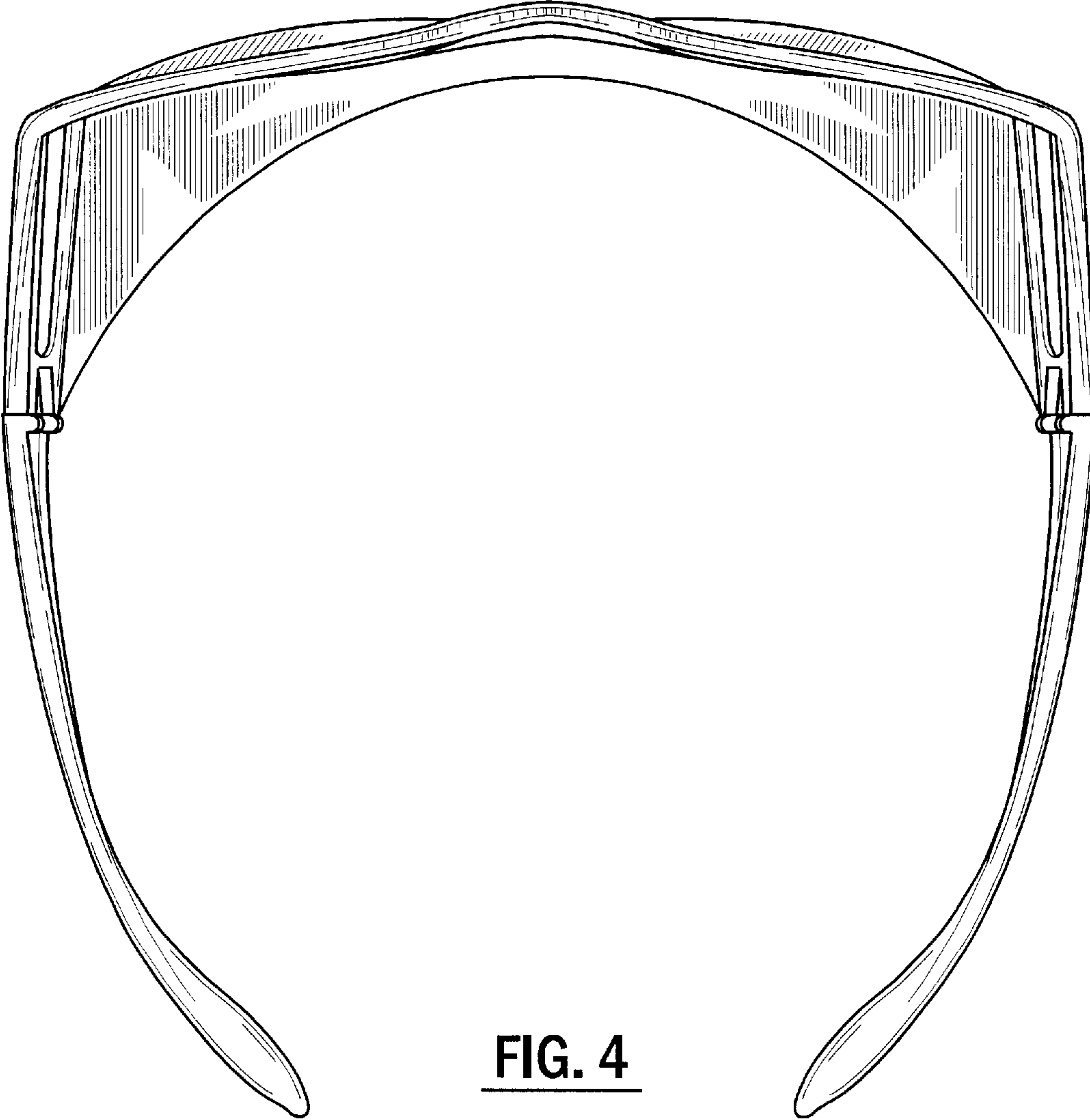

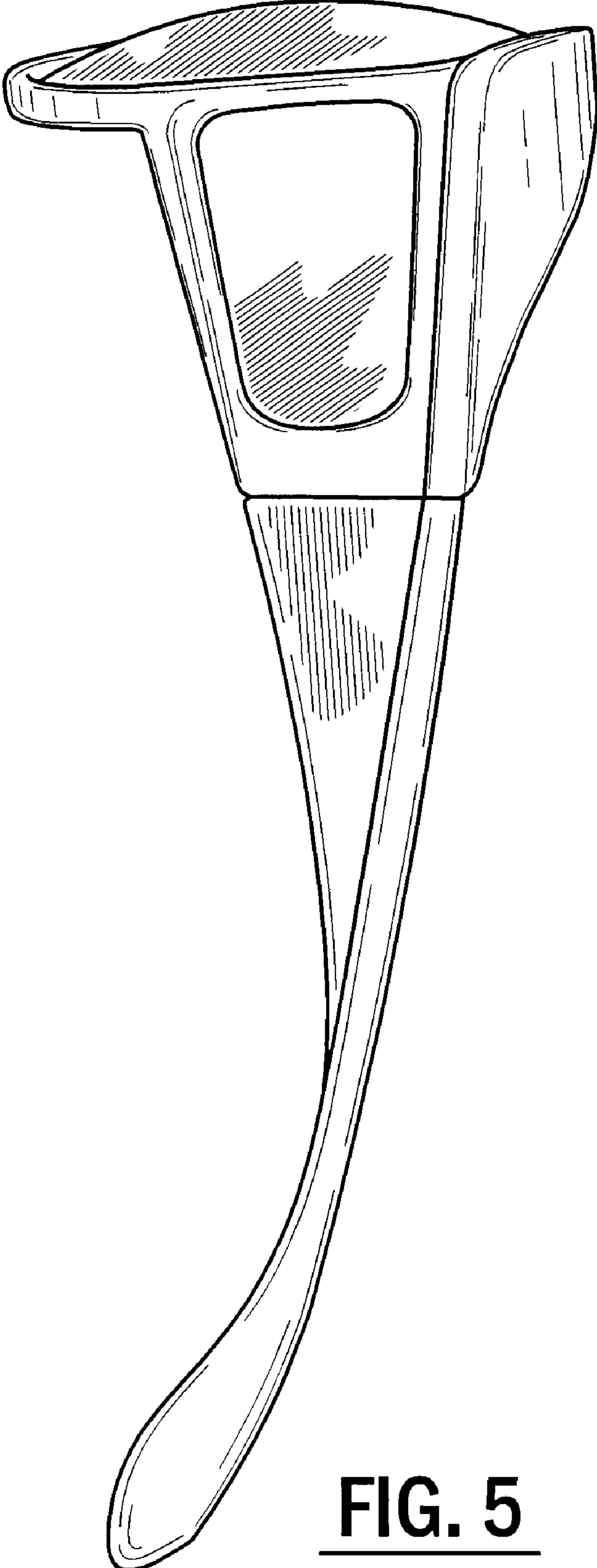
