(57) **CLAIM**

The ornamental design for a highlighter pen with cap and body, as shown and described.

DESCRIPTION

FIG. 1 is a lower right perspective view of a pen with a cap and body showing my new design;
 FIG. 2 is an inverted lower left perspective view of the pen in FIG. 1, with the cap removed and attached to the opposite end of the body;
 FIG. 3 is a side view of the pen shown in FIG. 1;
 FIG. 4 is a bottom plan view thereof;
 FIG. 5 is a top plan view thereof;
 FIG. 6 is a front elevational view thereof;
 FIG. 7 is an inverted lower left perspective view of the pen body in FIG. 1, shown separately for ease of illustration;
 FIG. 8 is a bottom plan view thereof;
 FIG. 9 is a front elevational view thereof;
 FIG. 10 is a left elevational view thereof;
 FIG. 11 is a top plan view thereof;
 FIG. 12 is a rear elevational view thereof;

 FIG. 14 is a left perspective view of the cap in FIG. 1, shown separately for ease of illustration;

 FIG. 16 is a bottom plan view thereof;

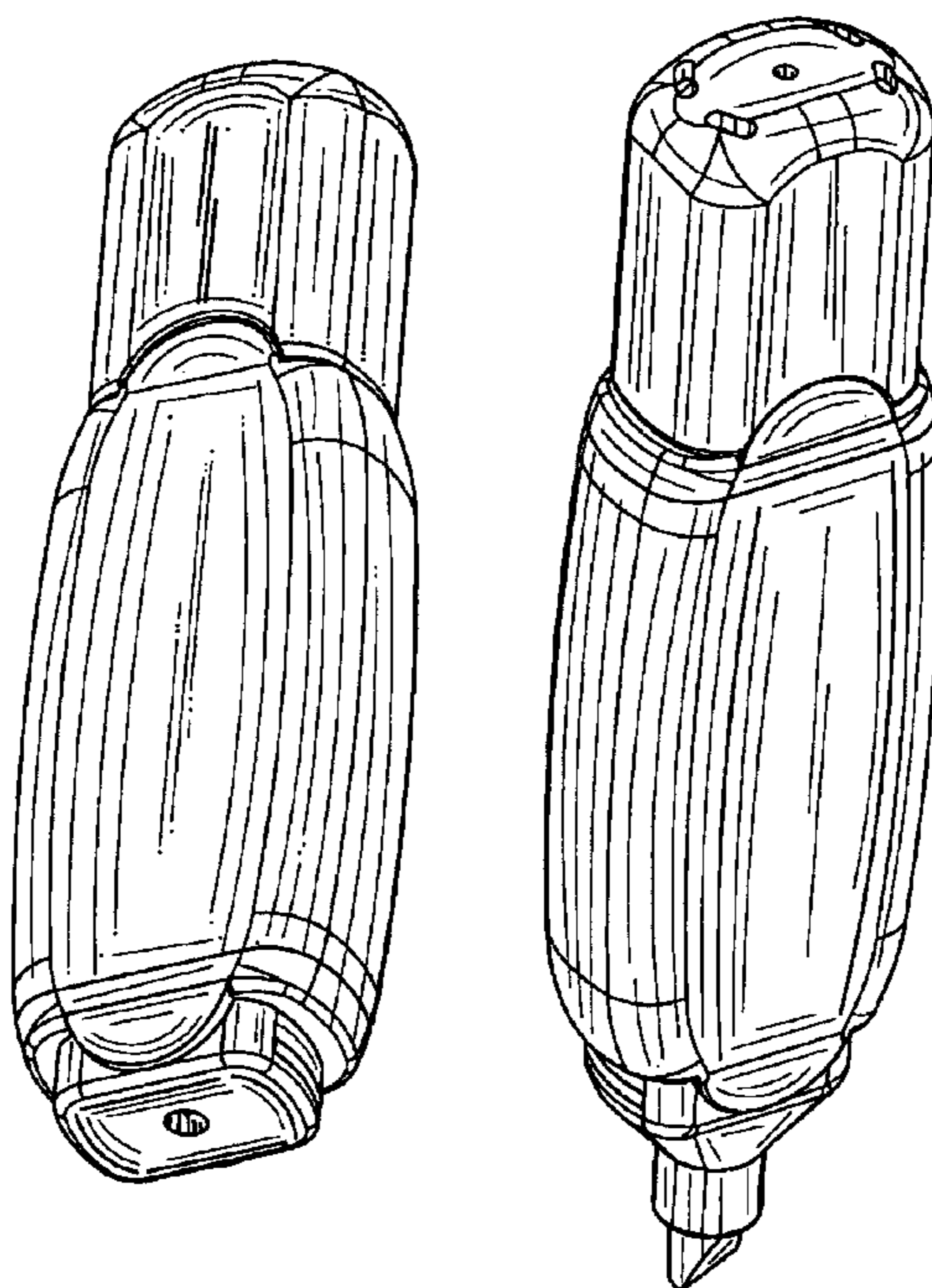

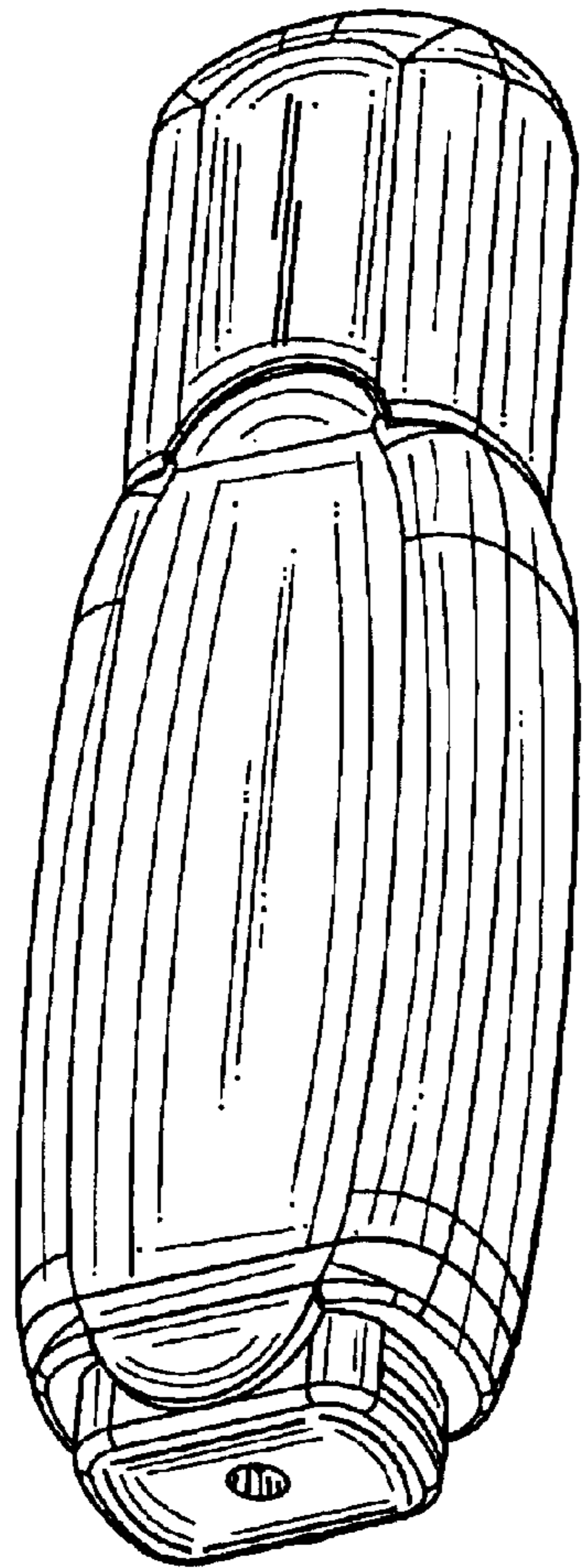

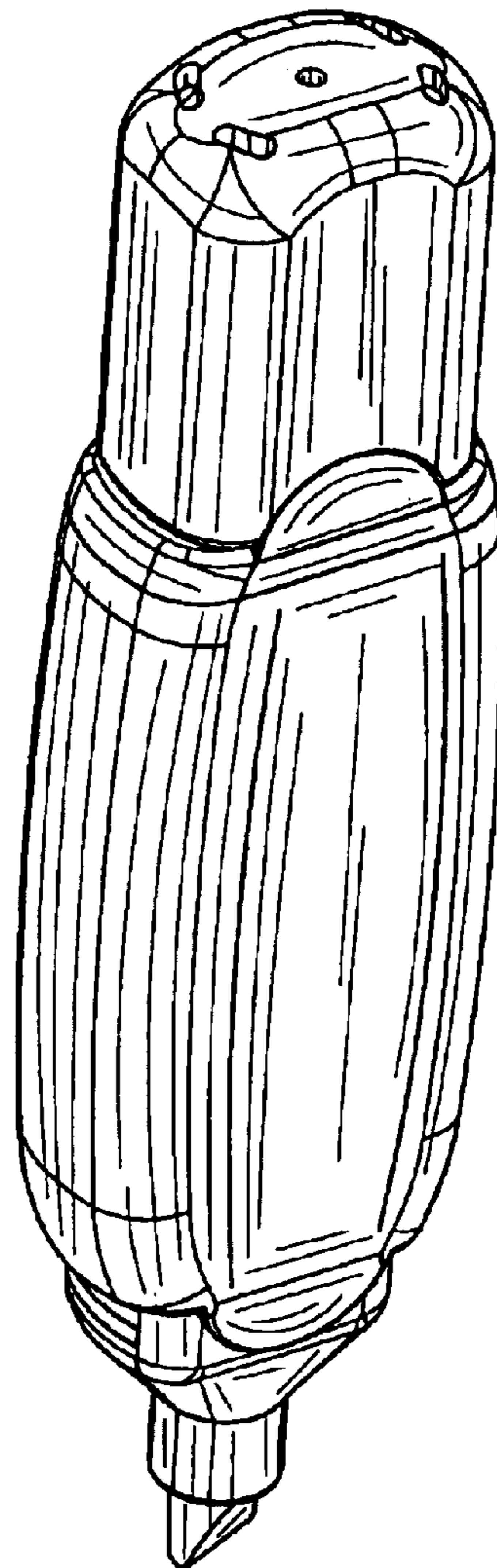

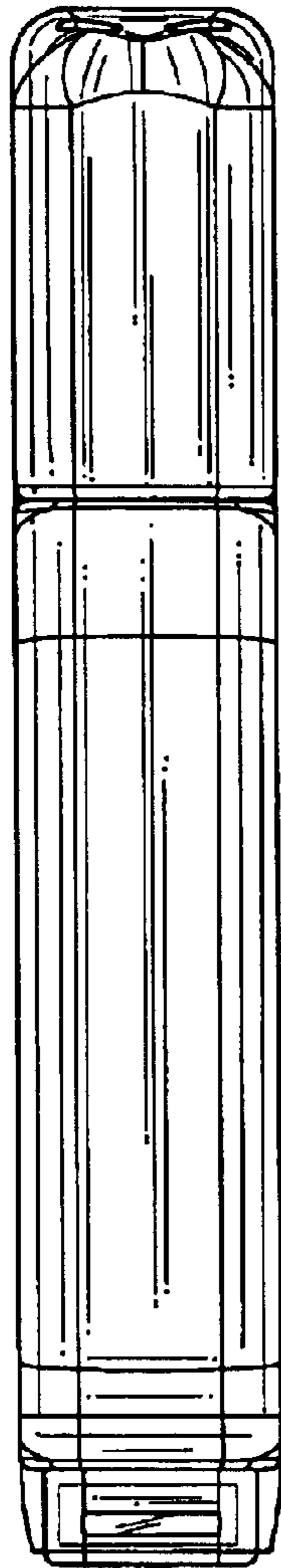

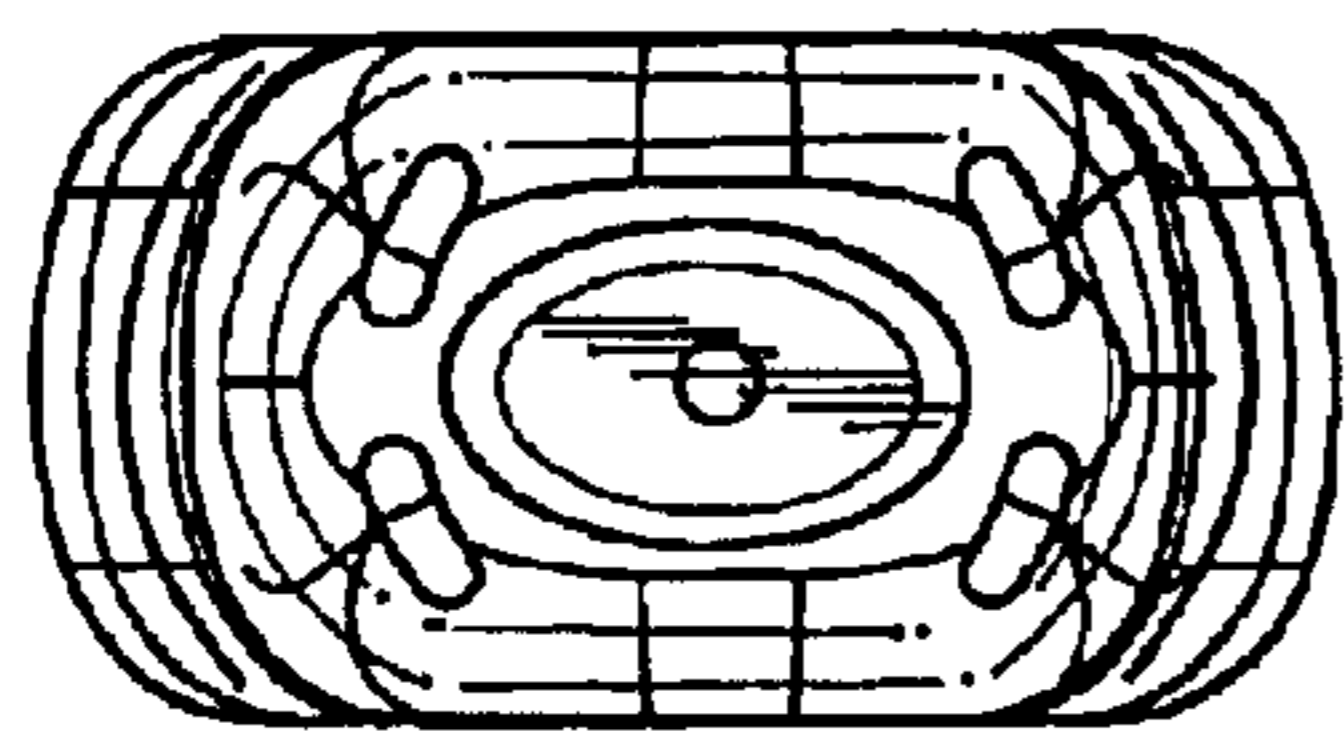
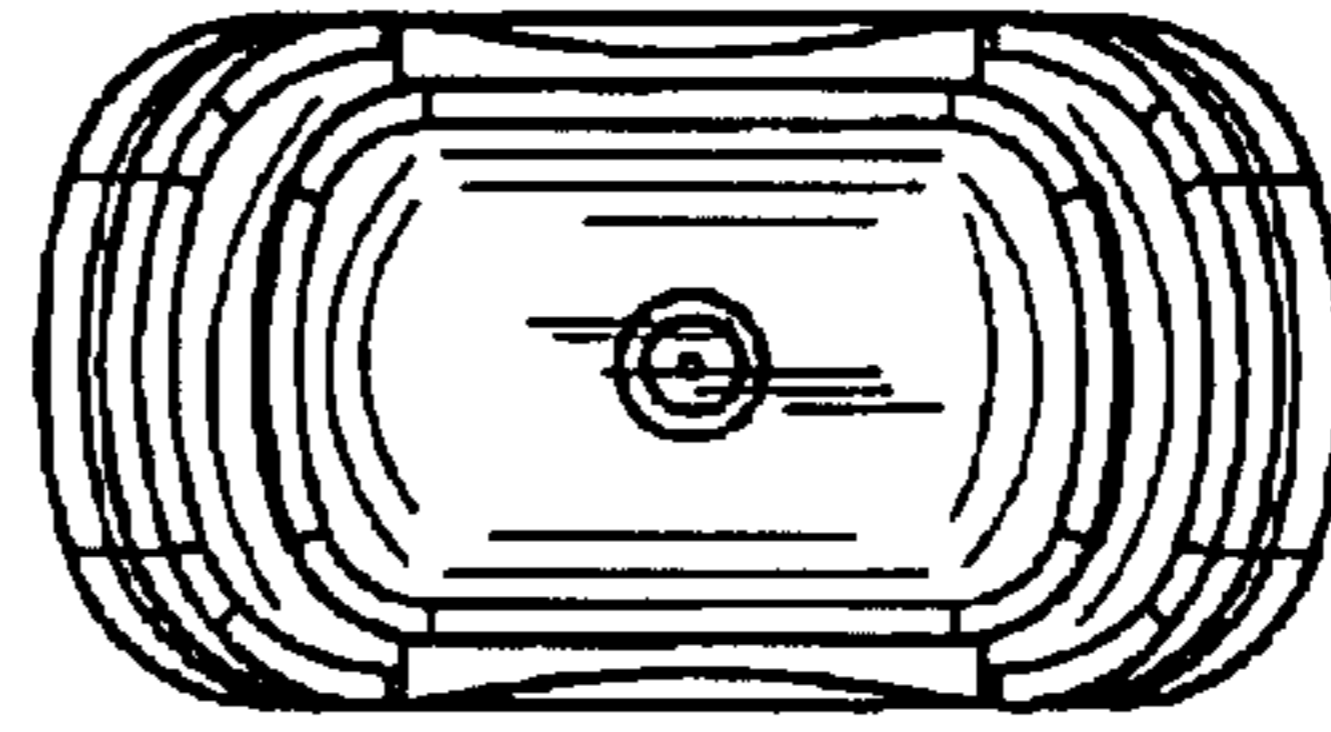

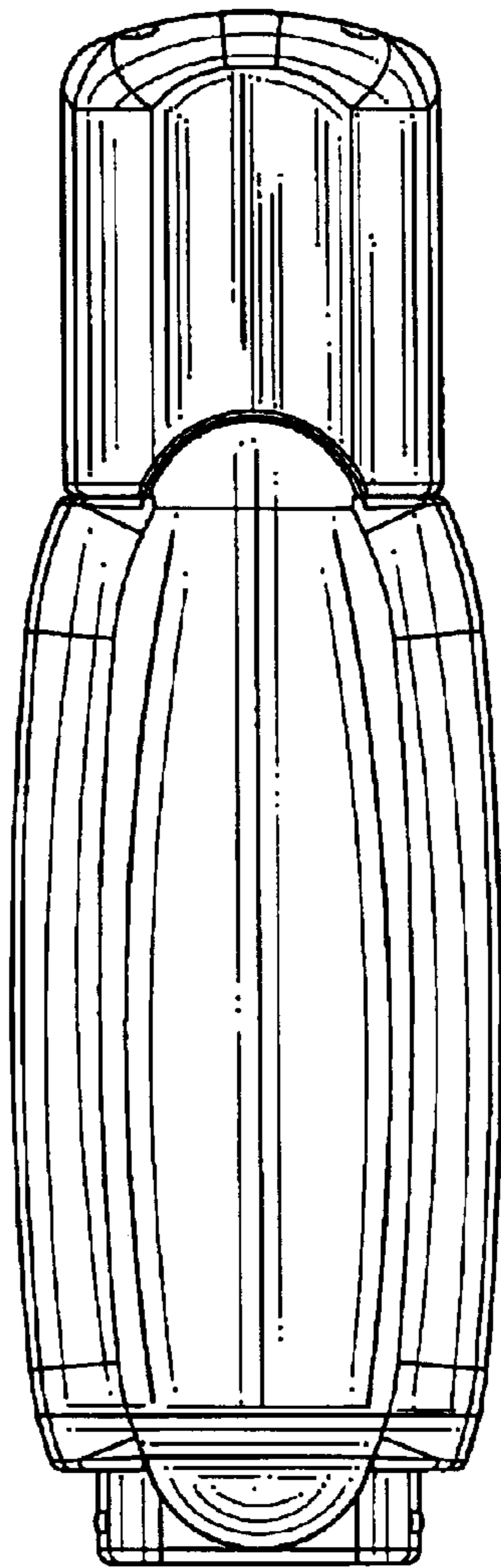

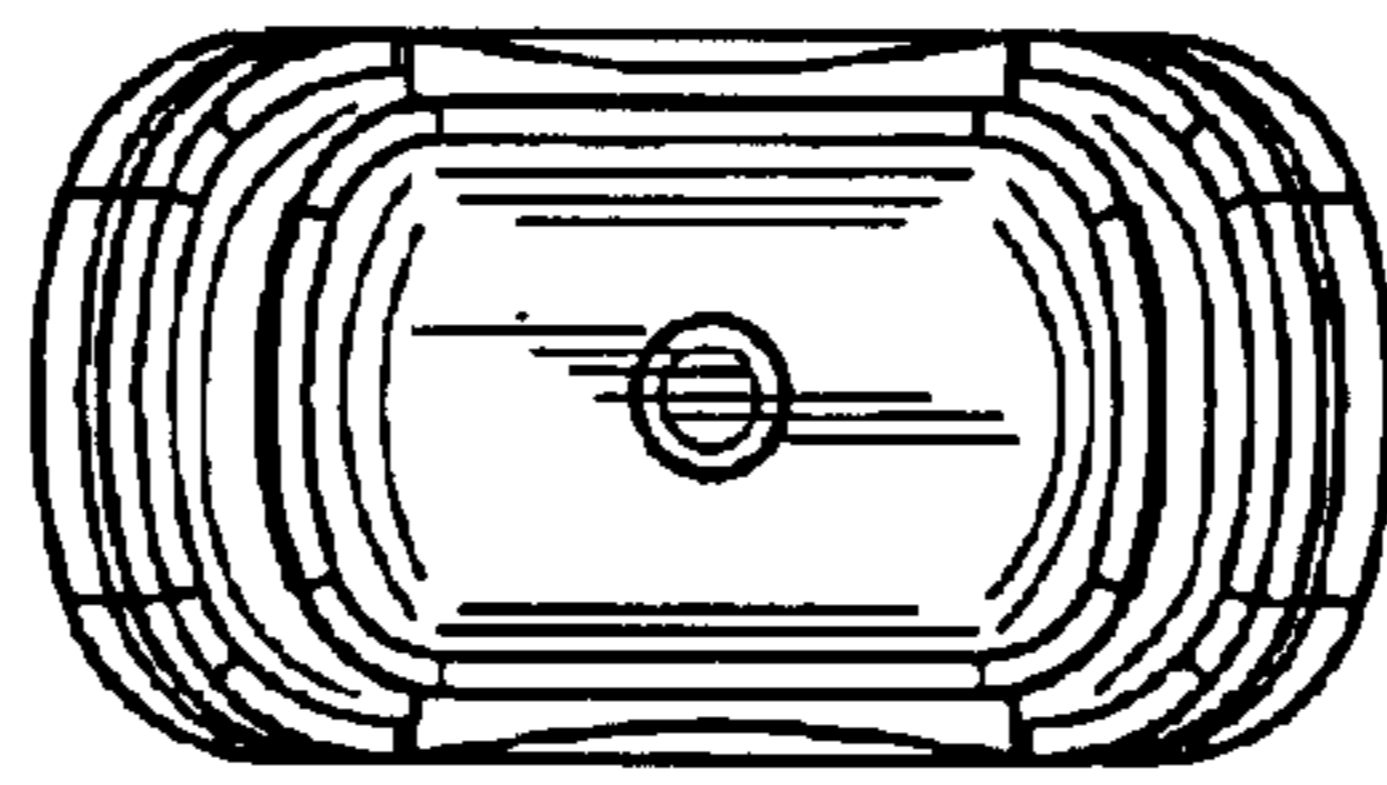

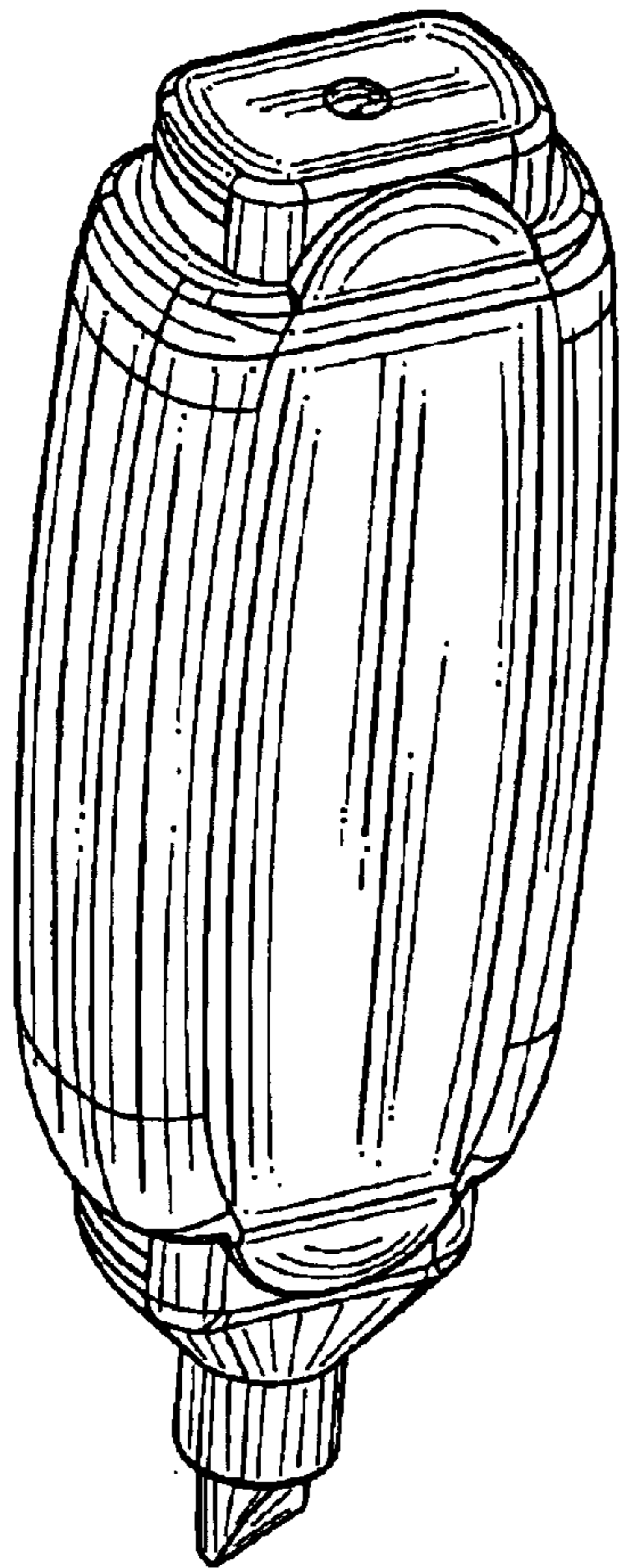

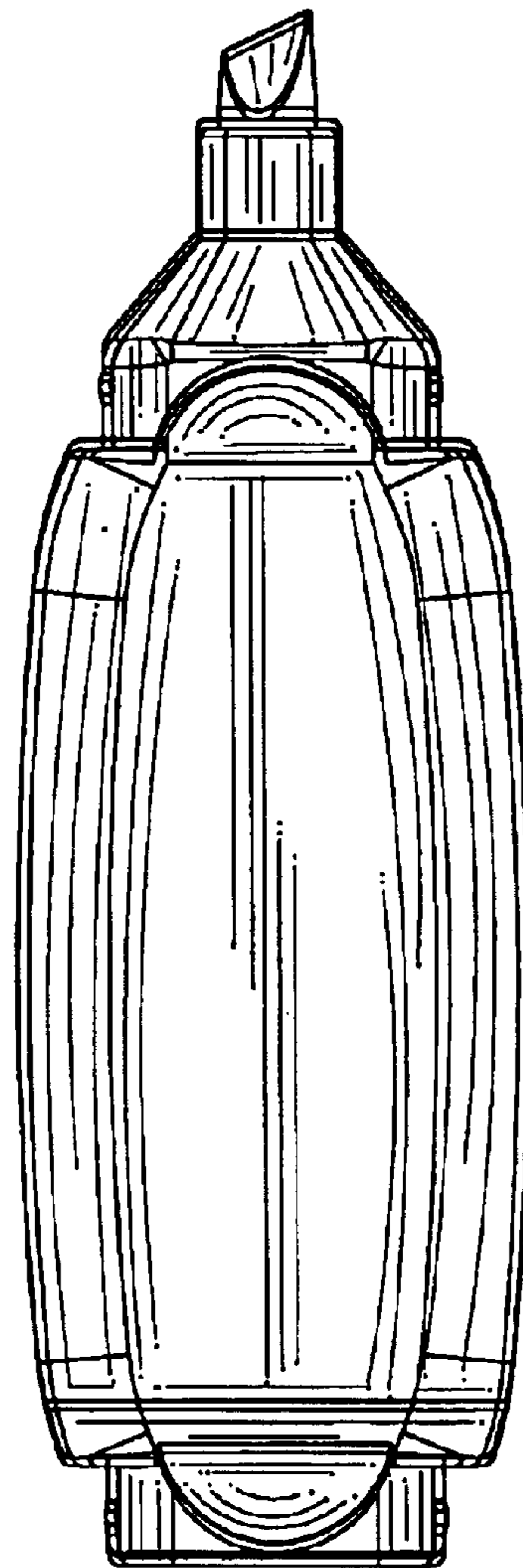

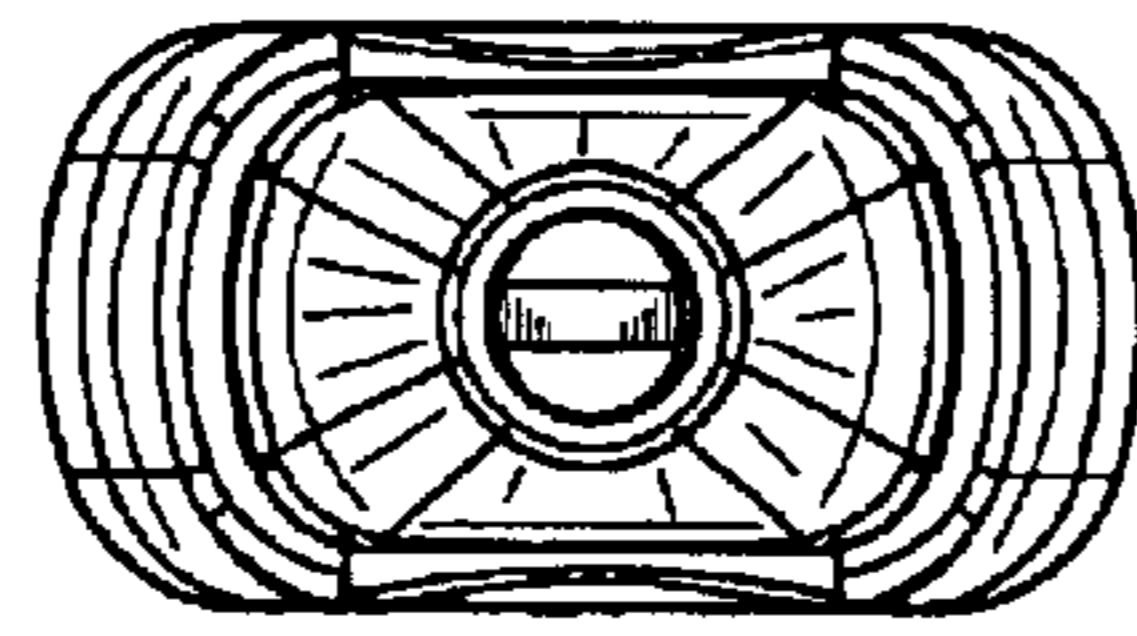

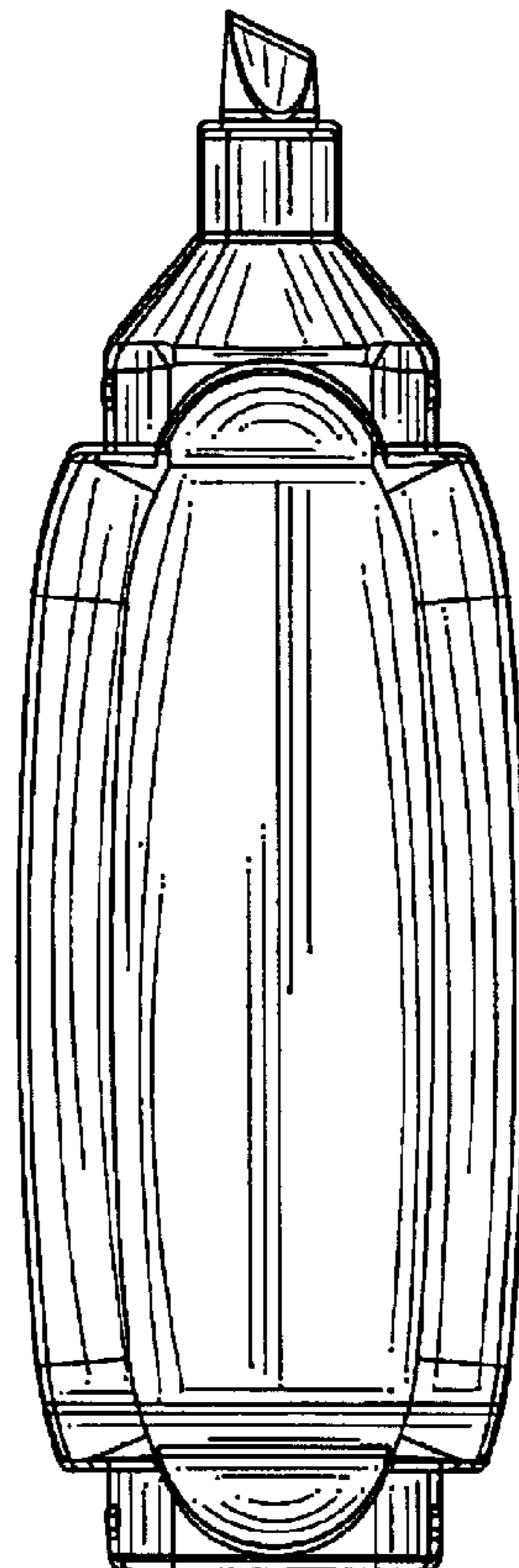

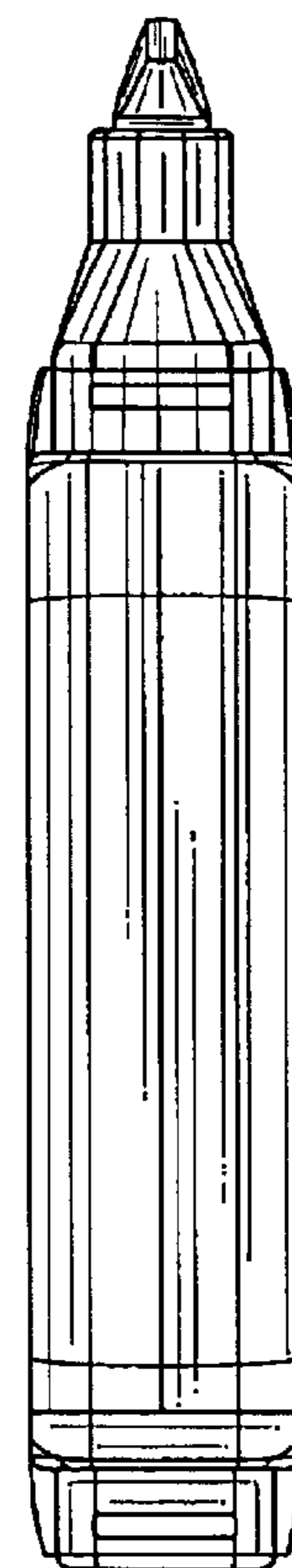

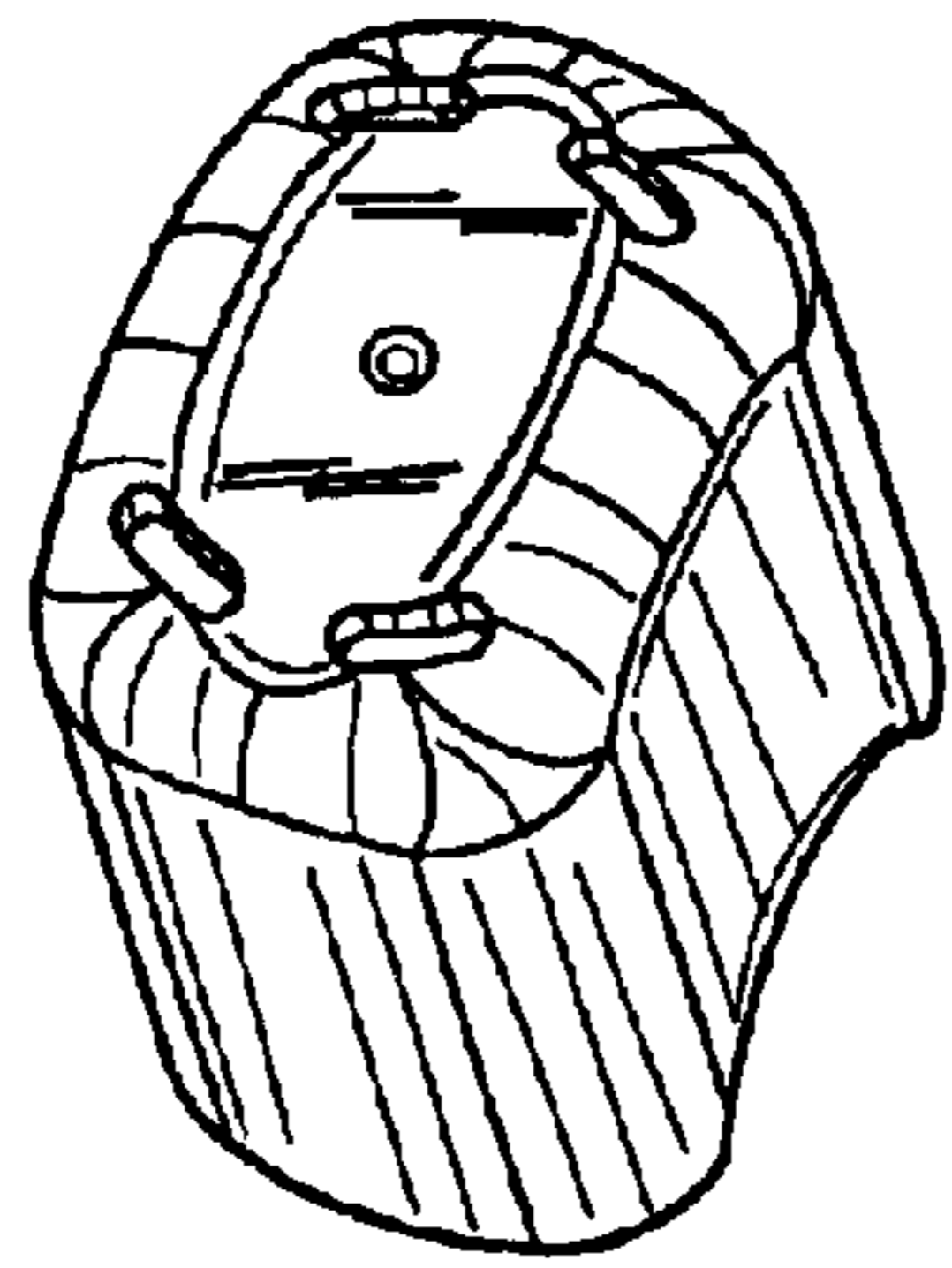

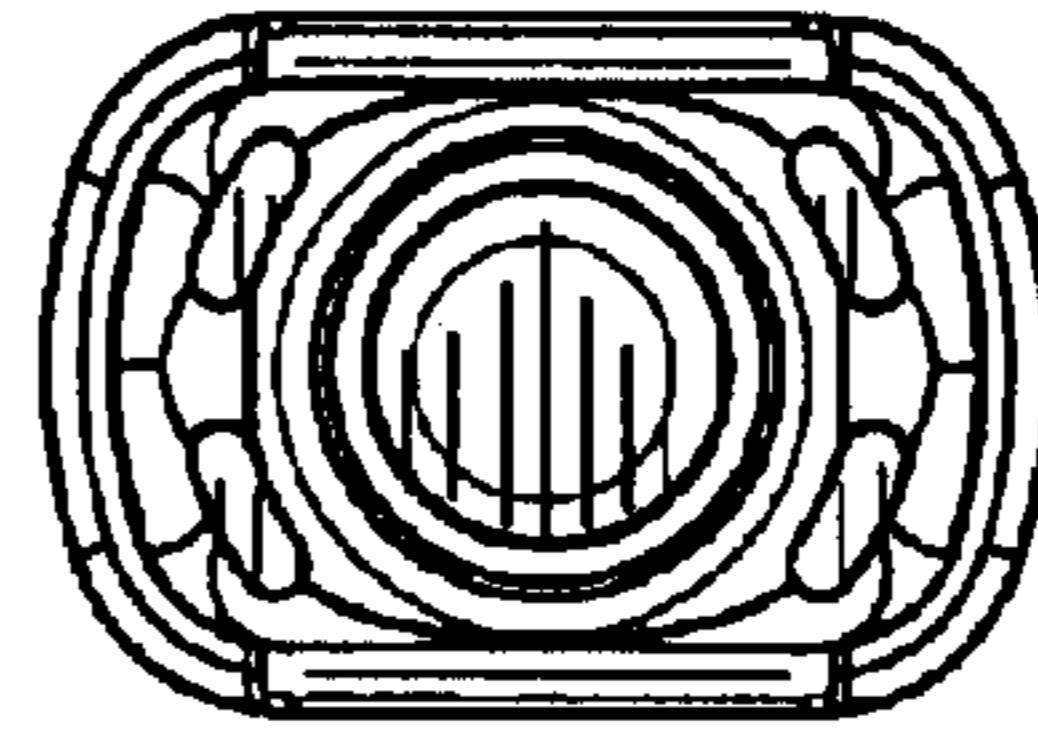

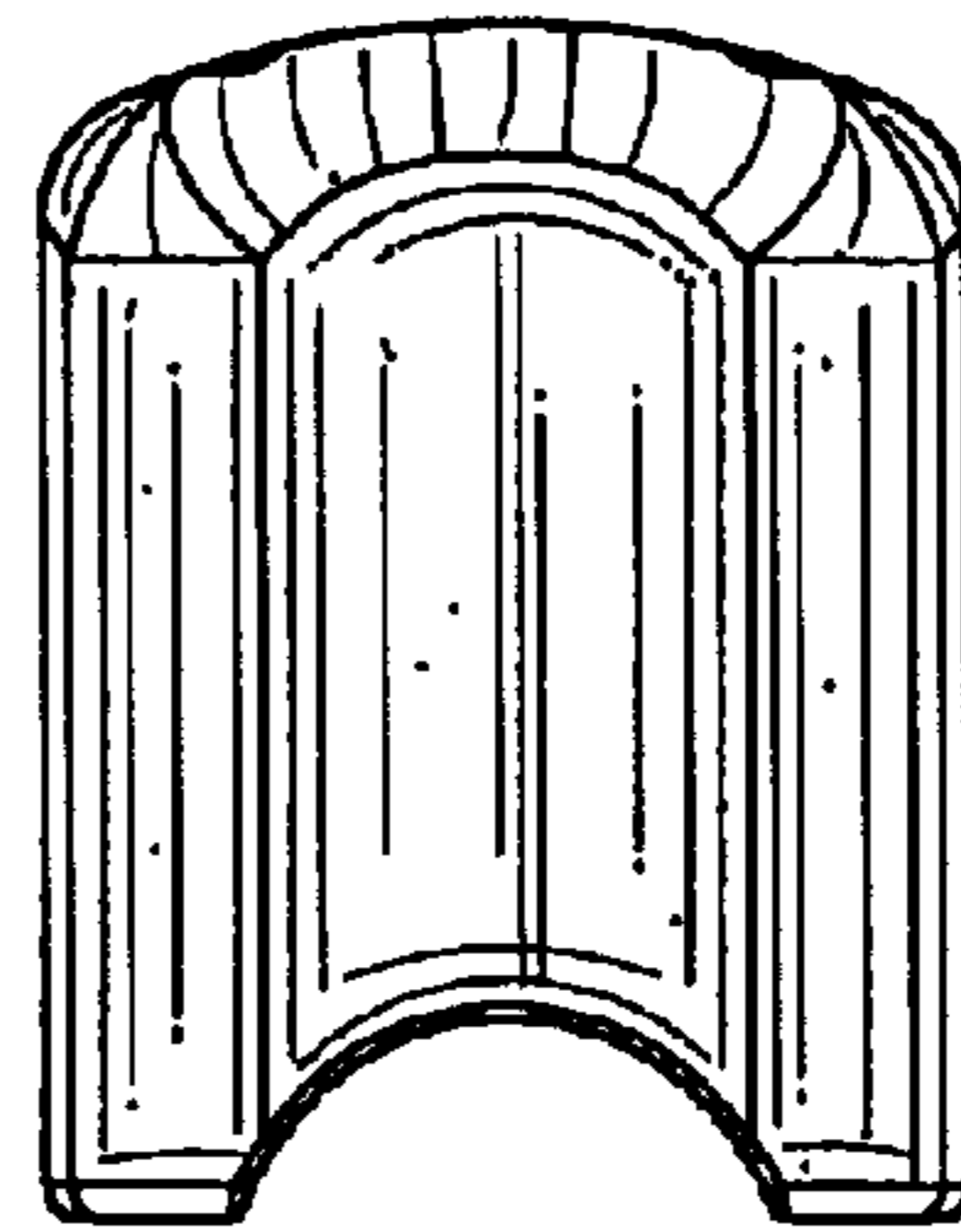

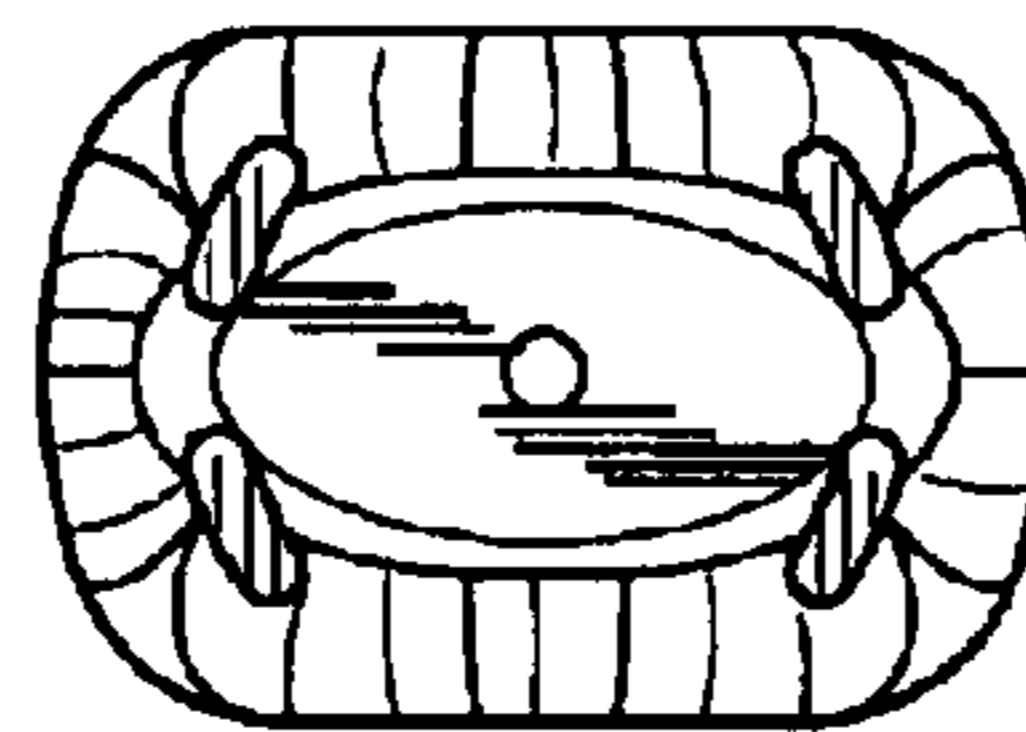
