DESCRIPTION

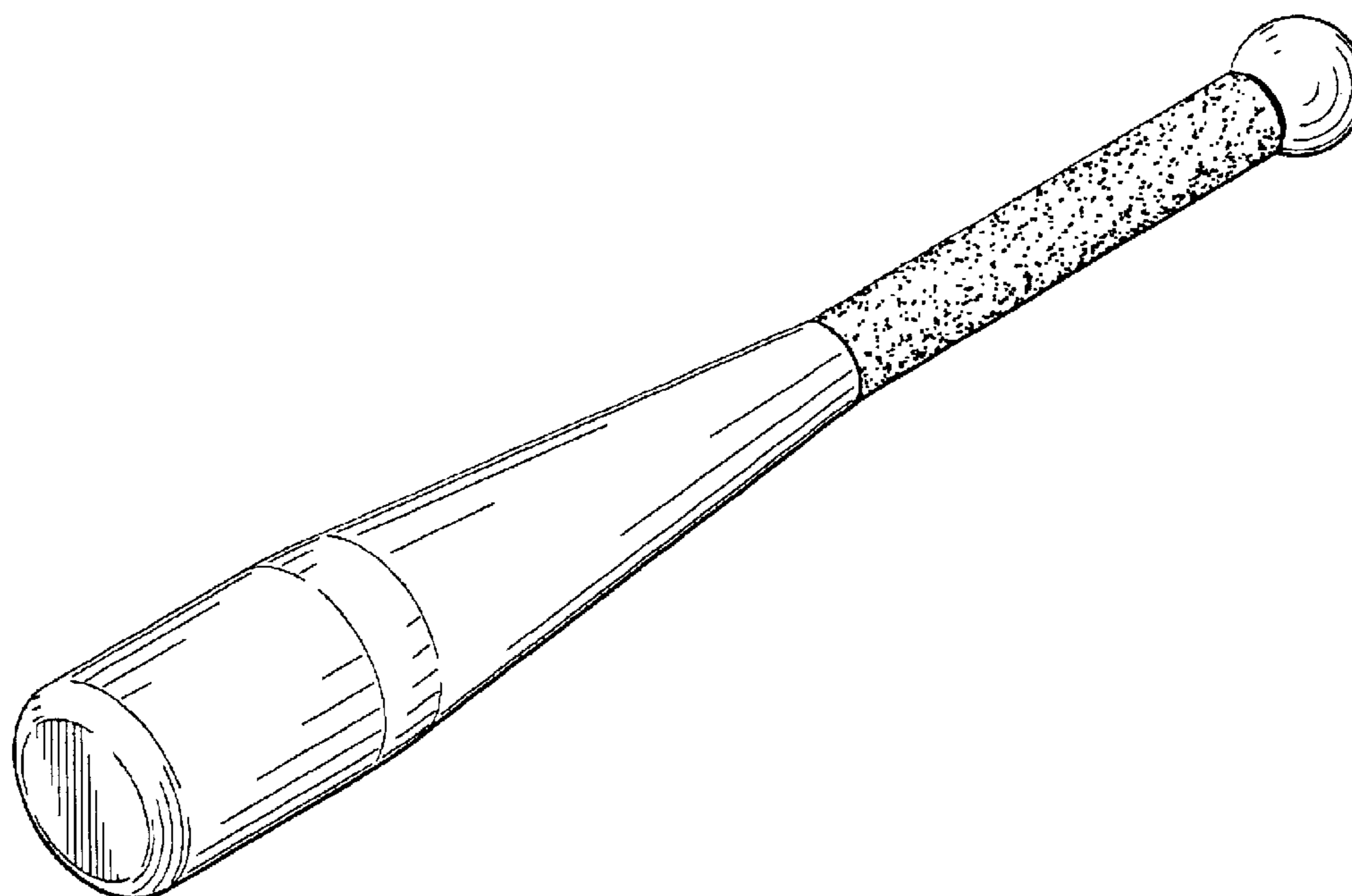
FIG. 1 is a perspective view of the circular weight training apparatus;

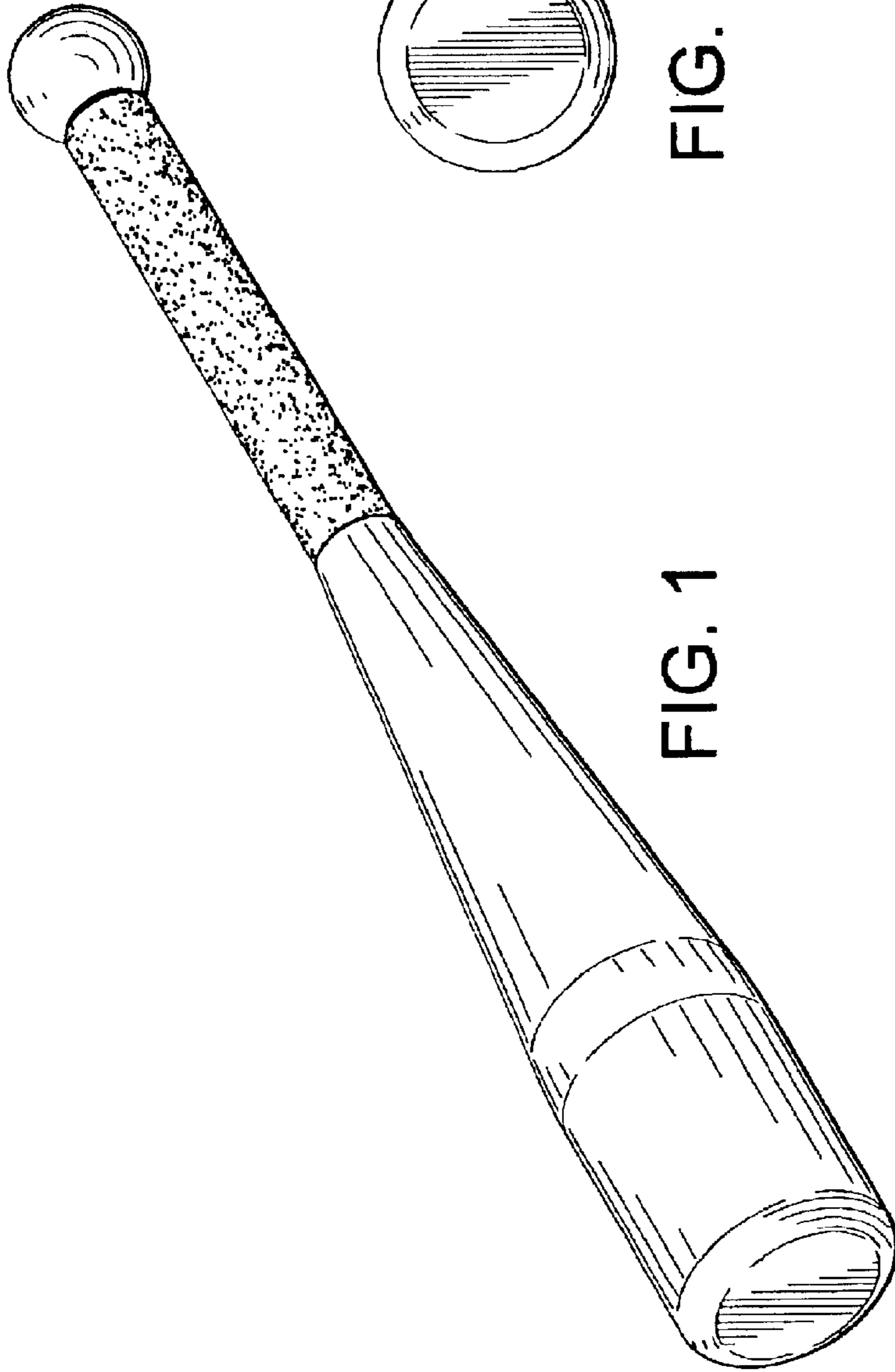

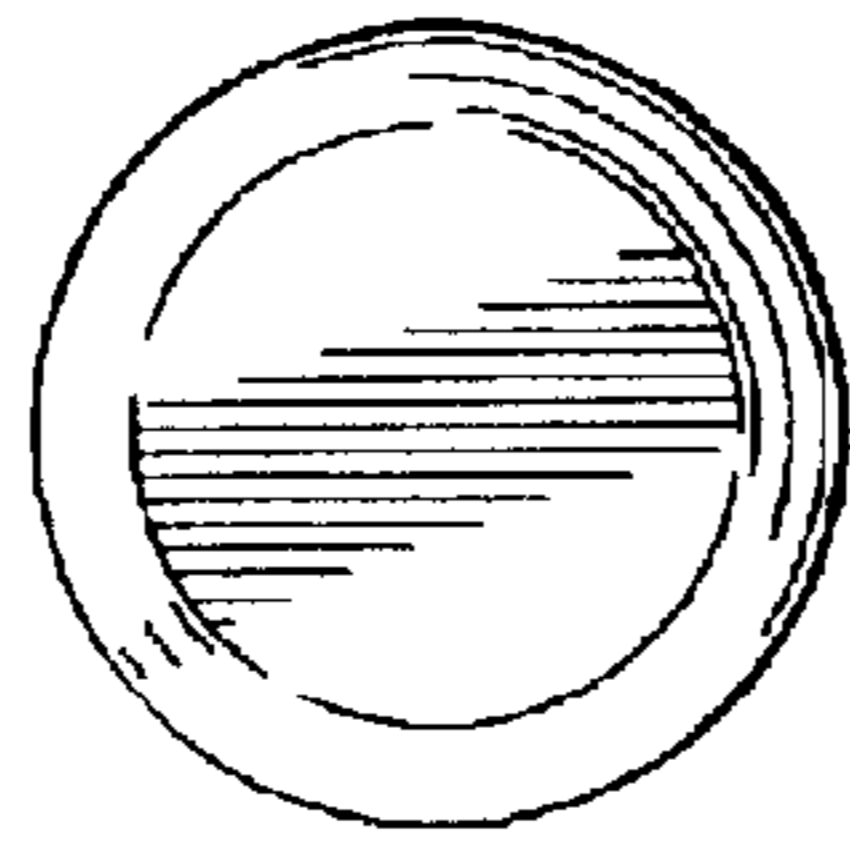

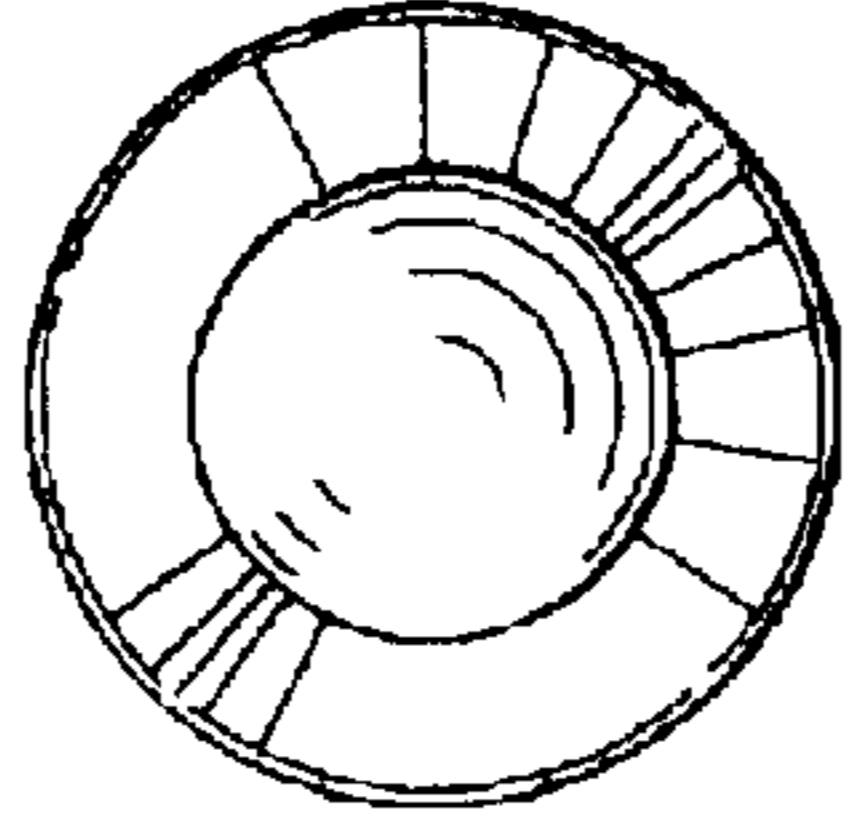

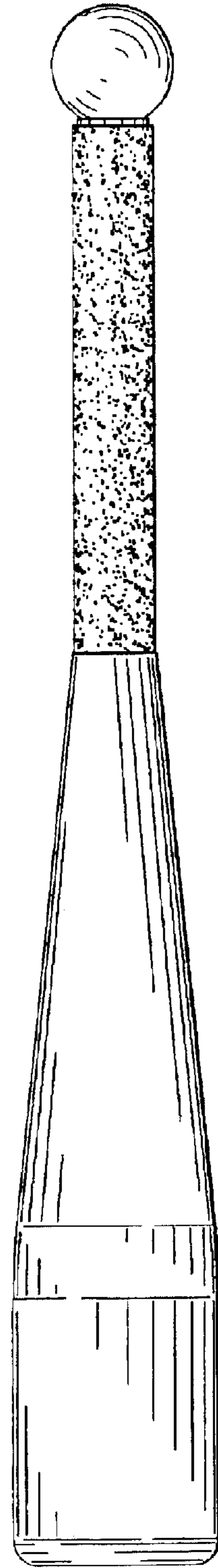
