FIG. 7 is a right-side view thereof.

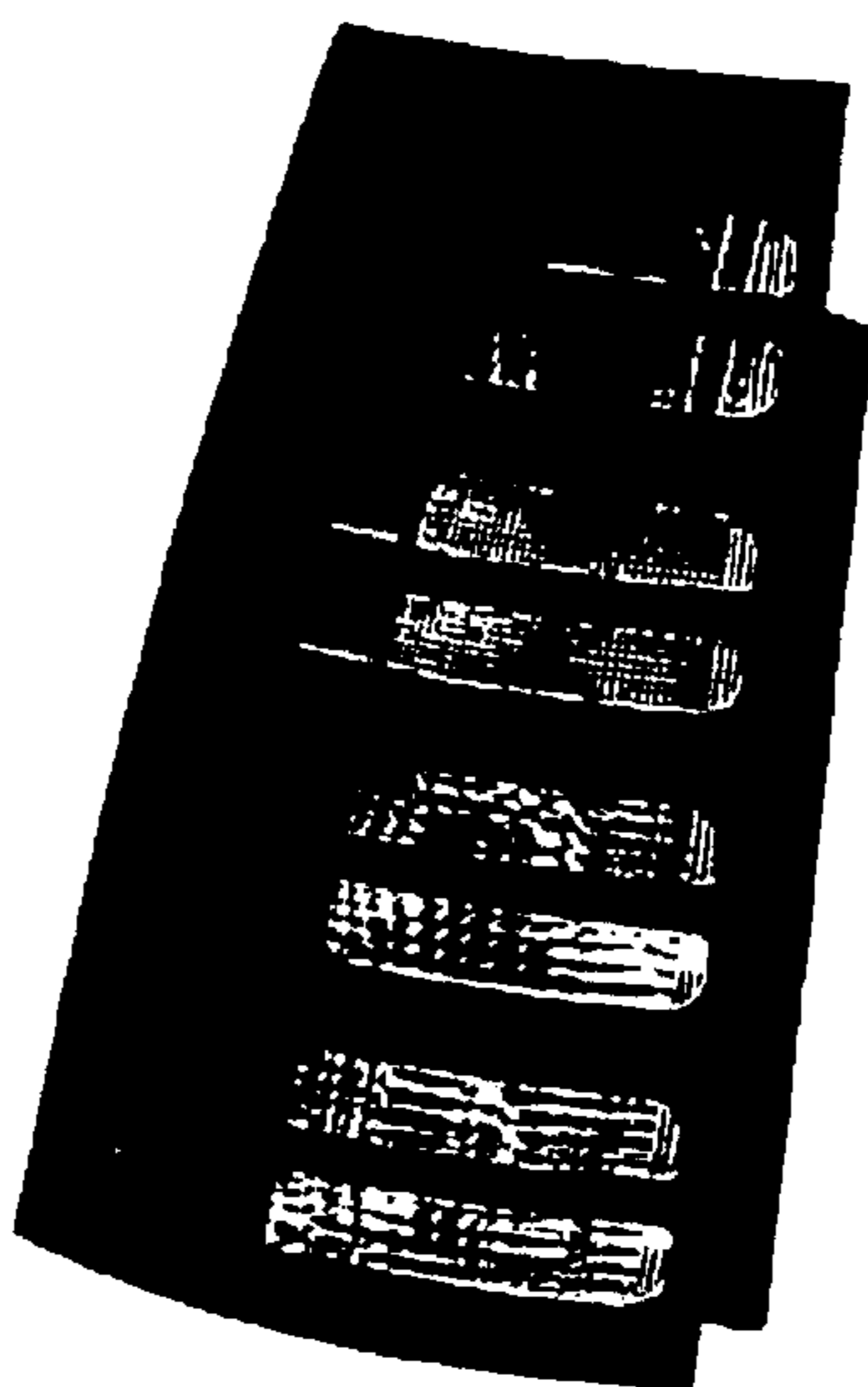

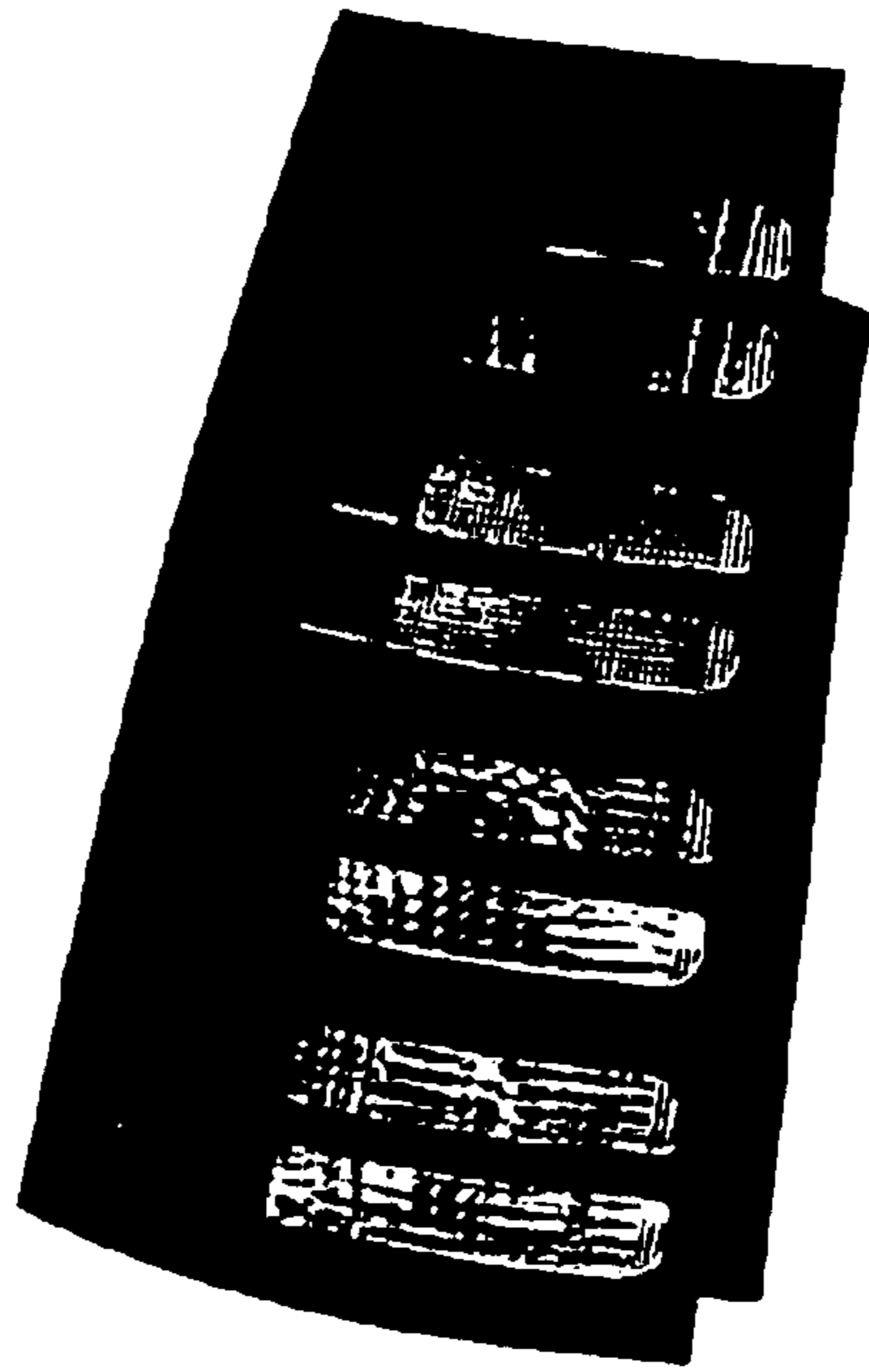

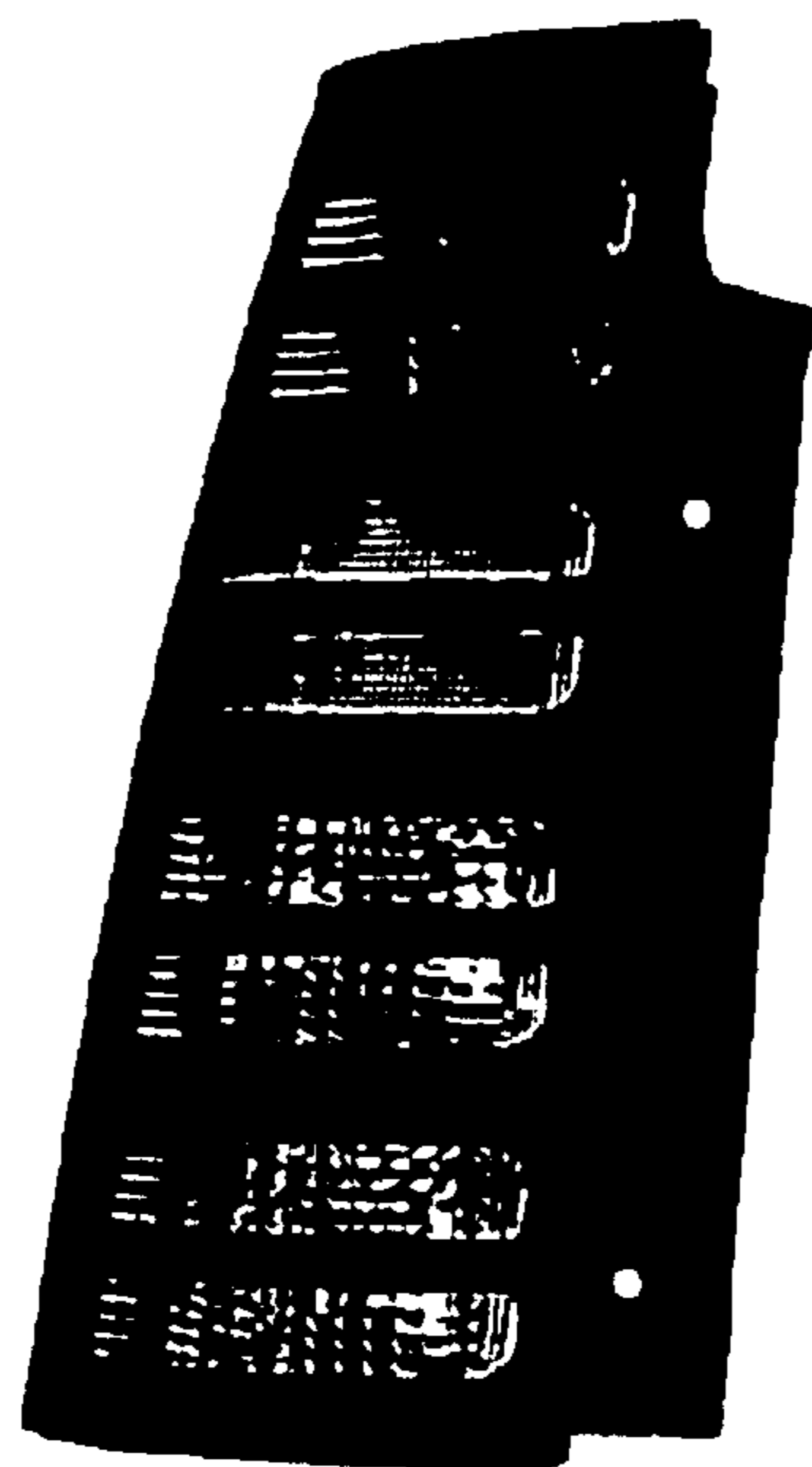

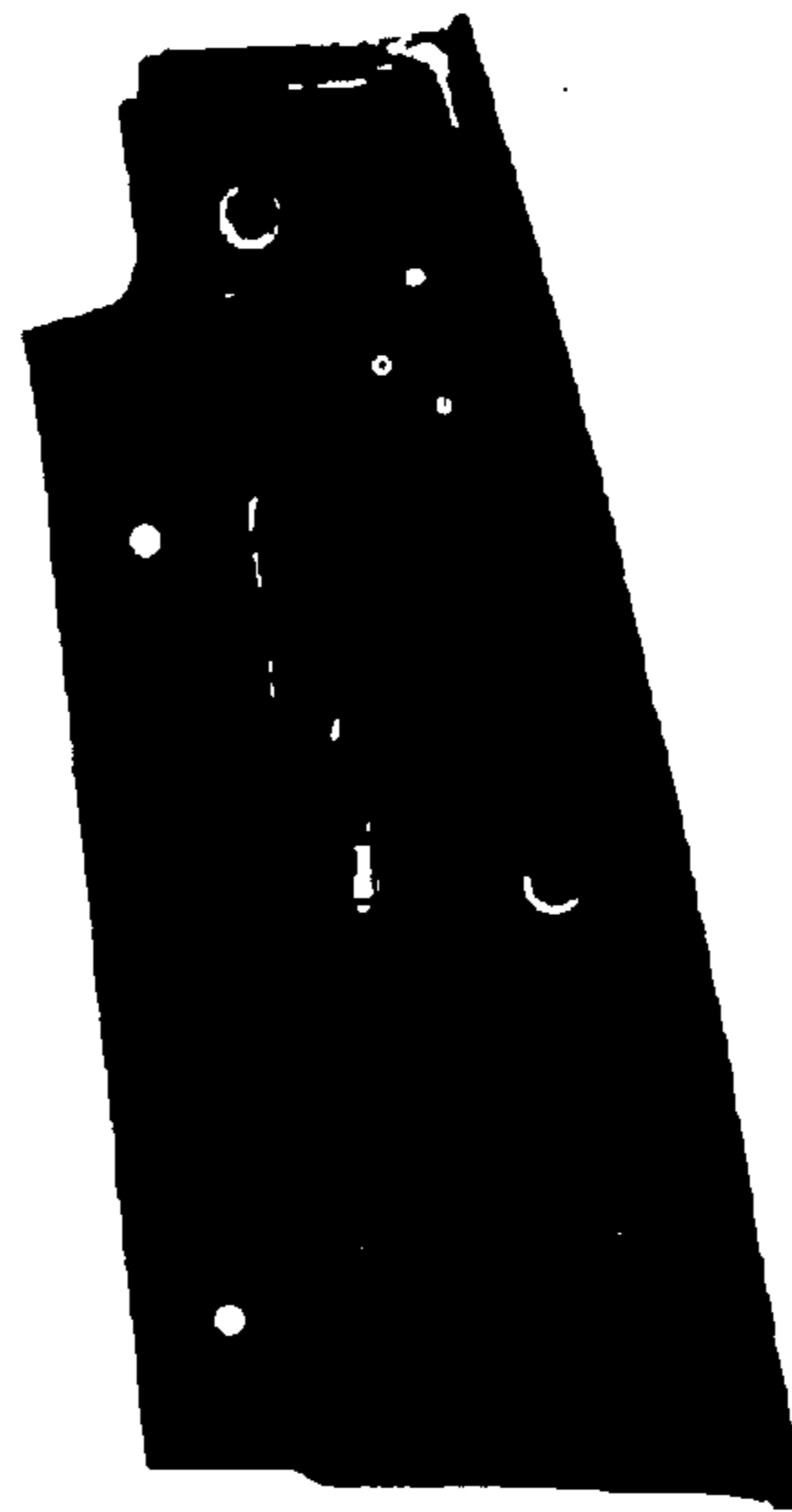

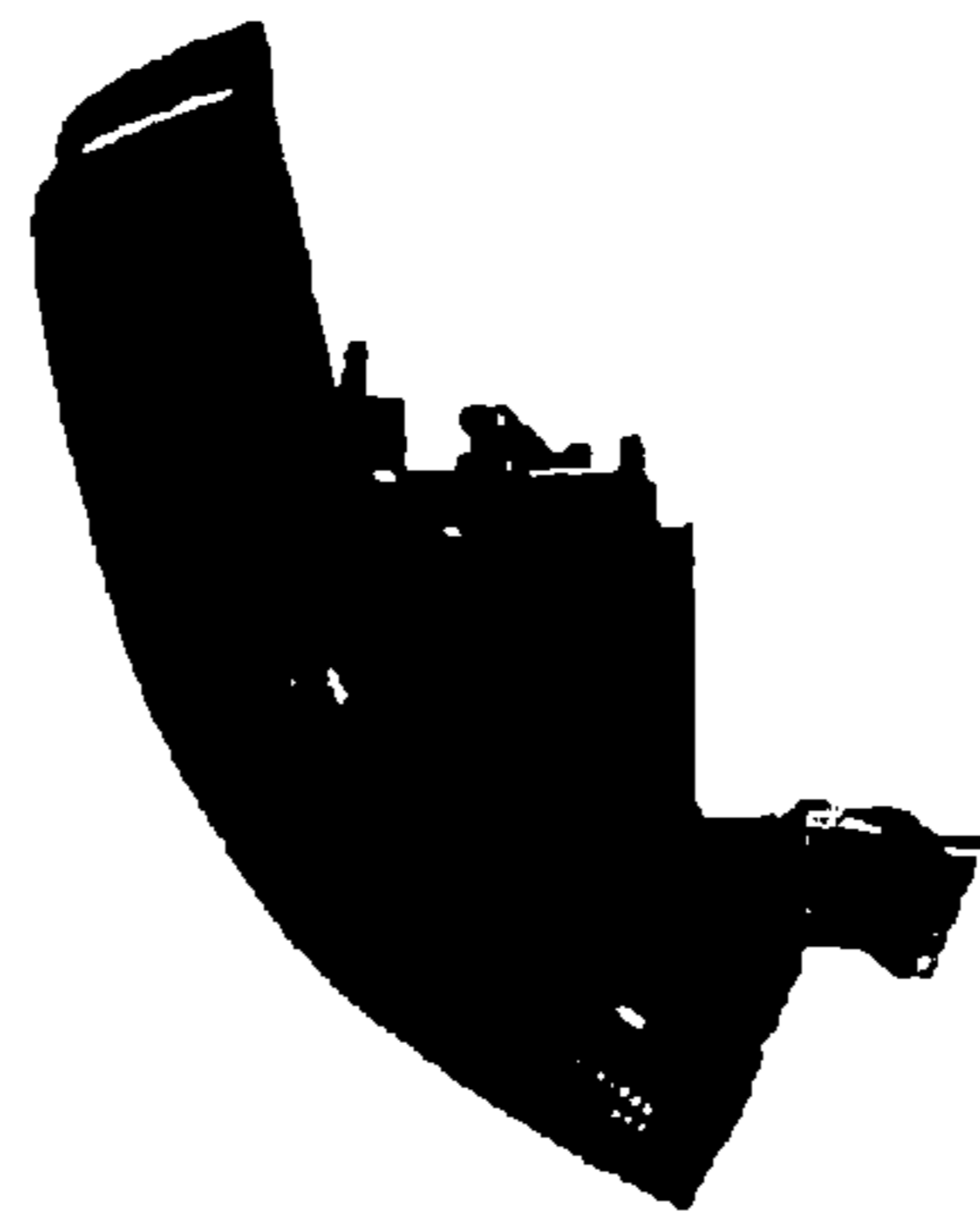

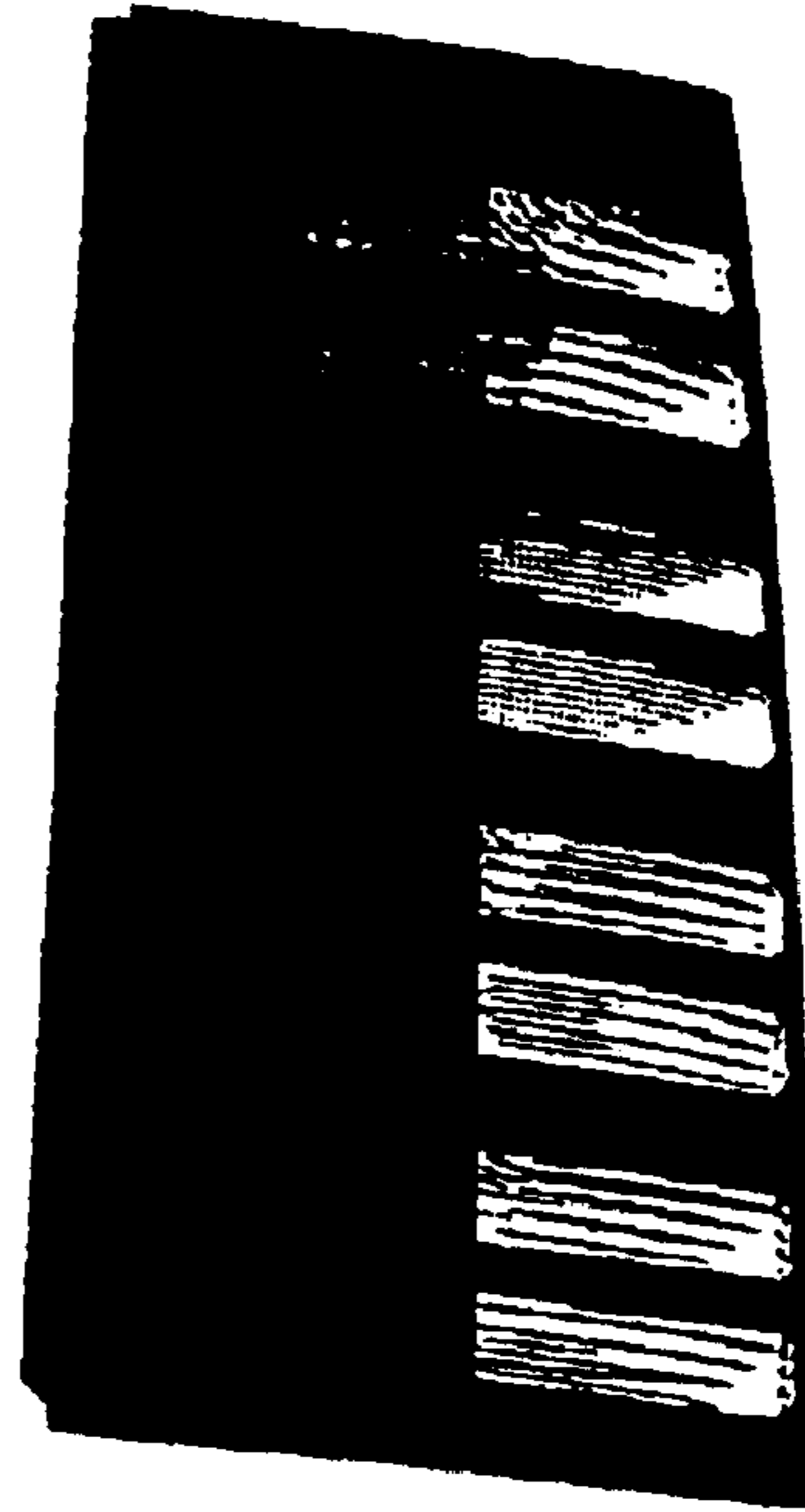

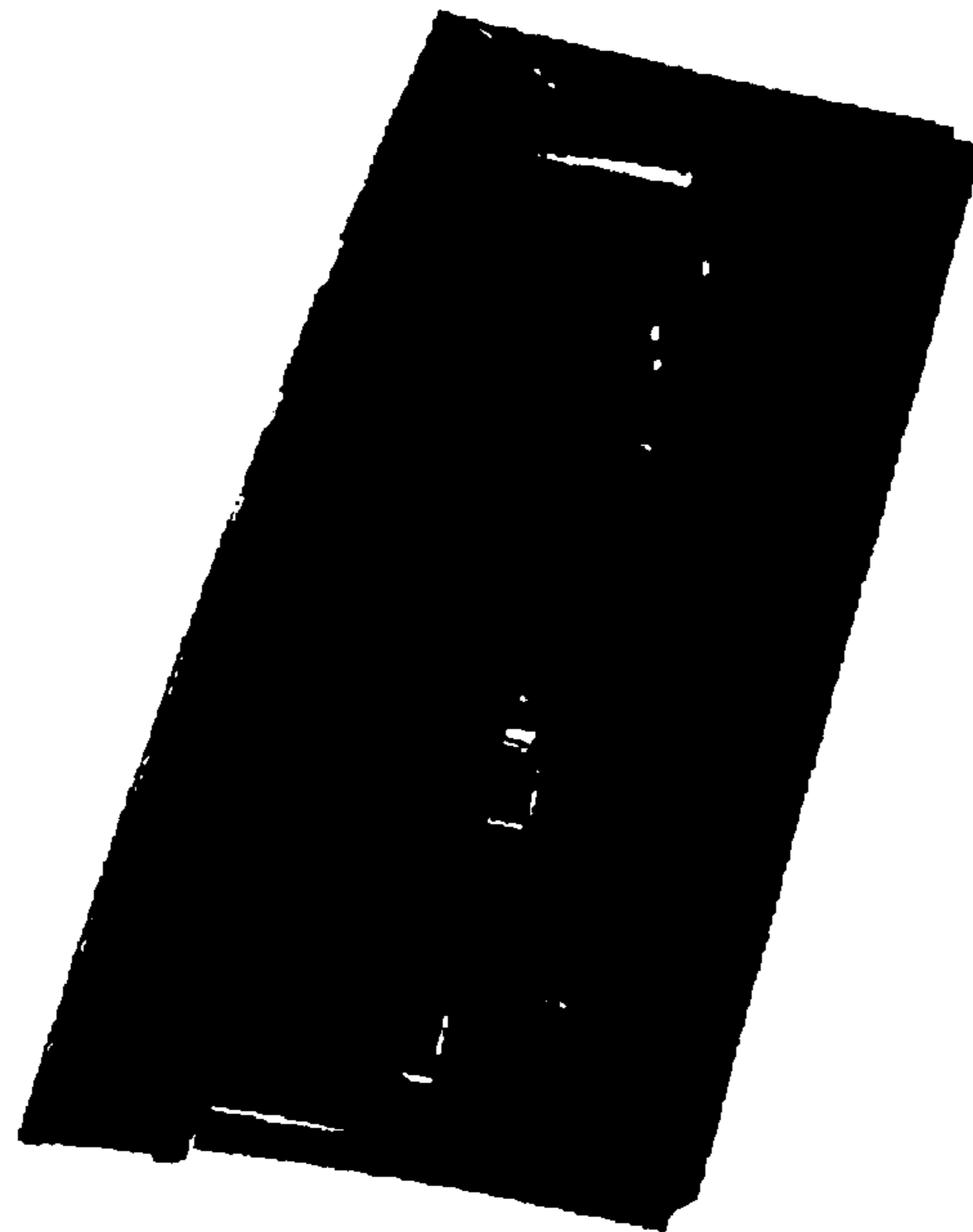

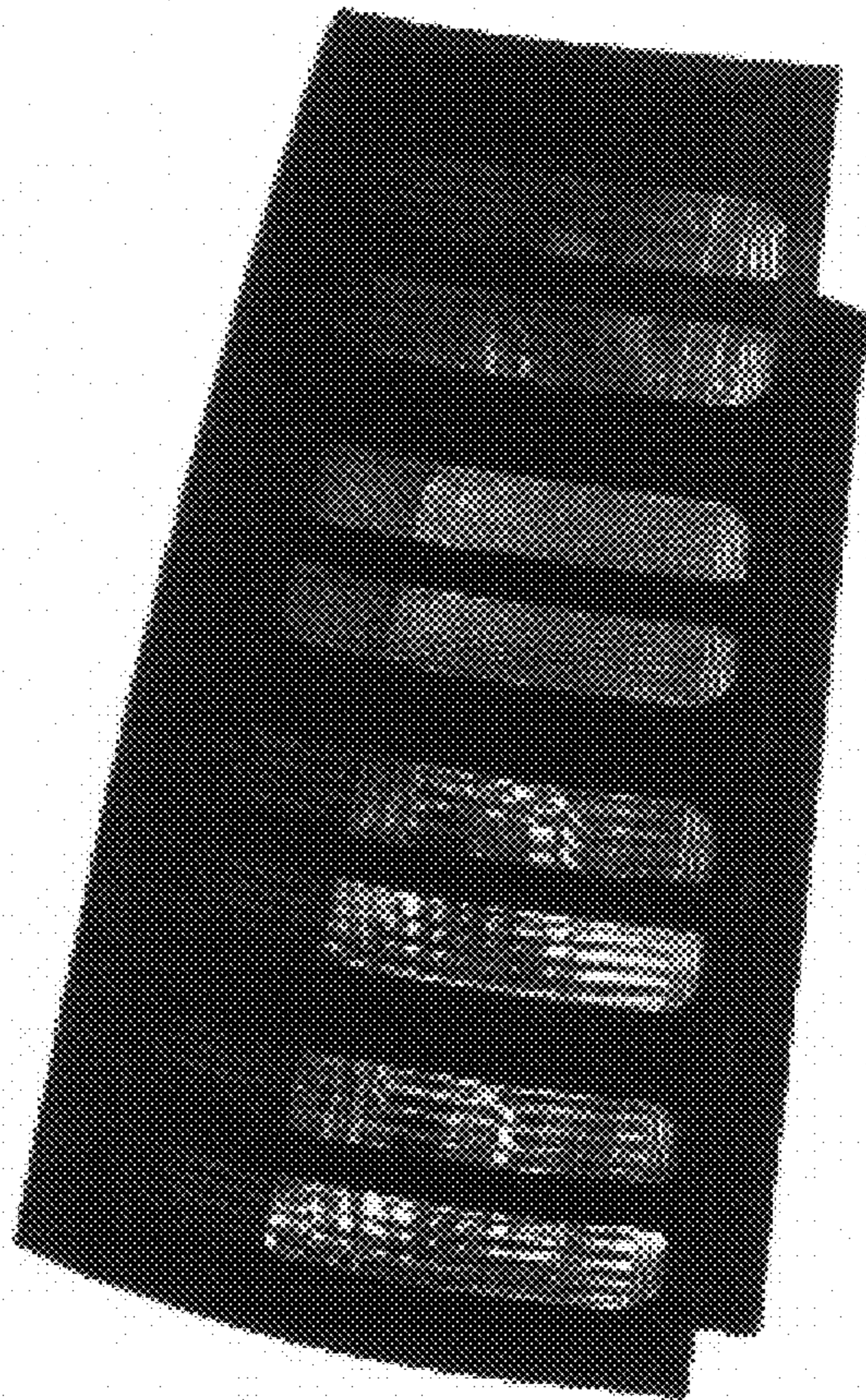
FIG. 1 is a front perspective view of a rear combination lamp for an automobile showing our new design;

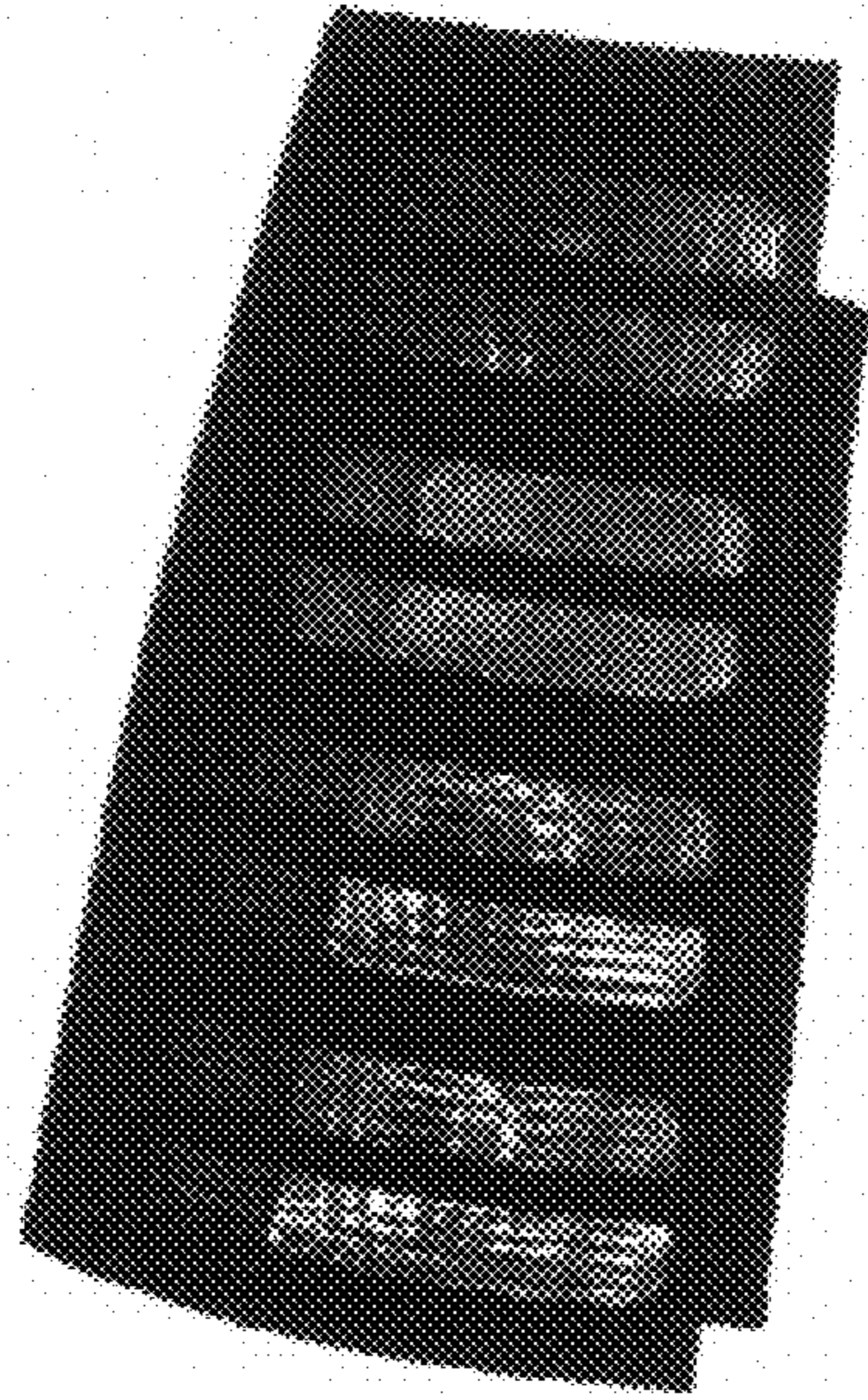

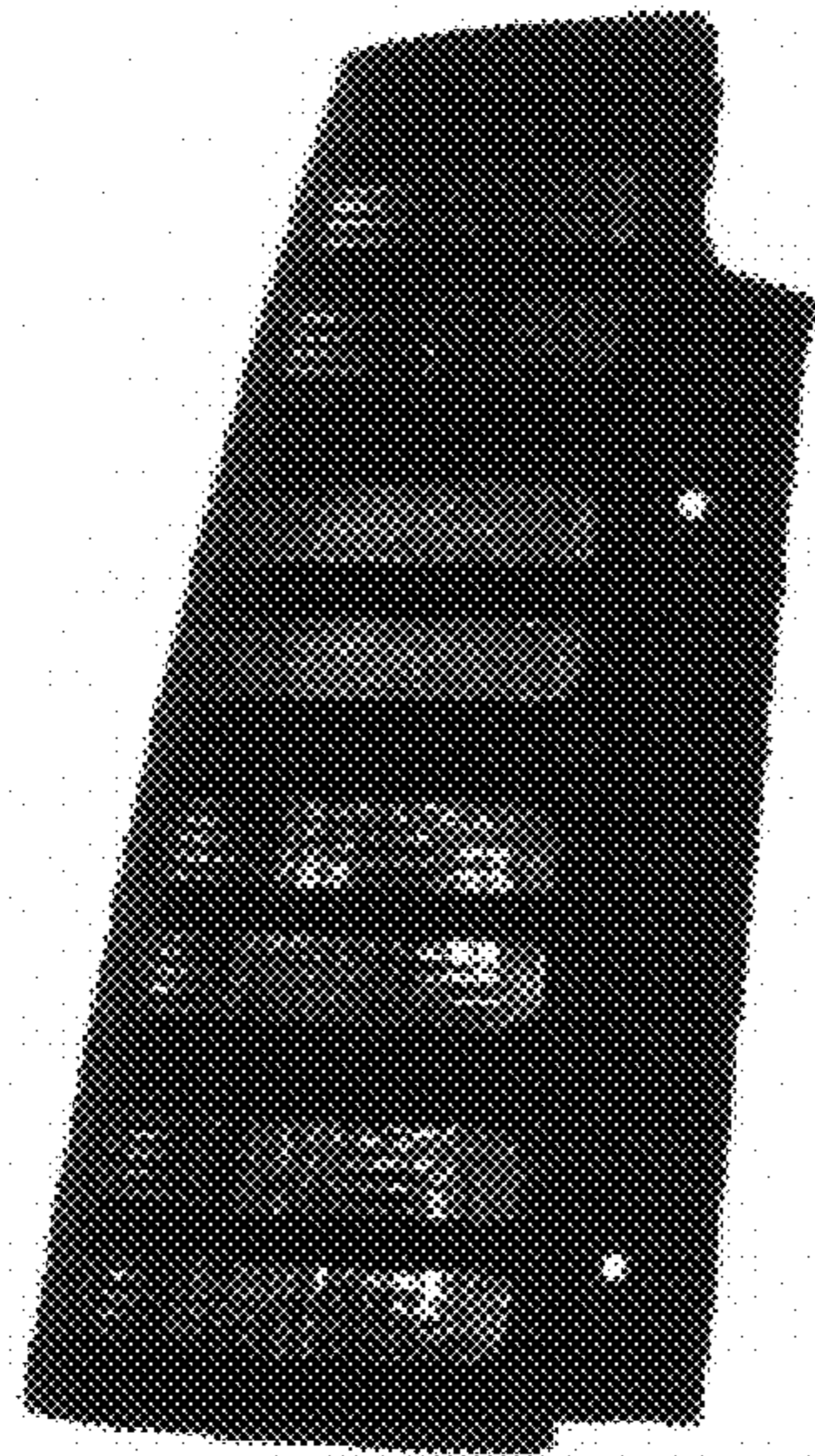

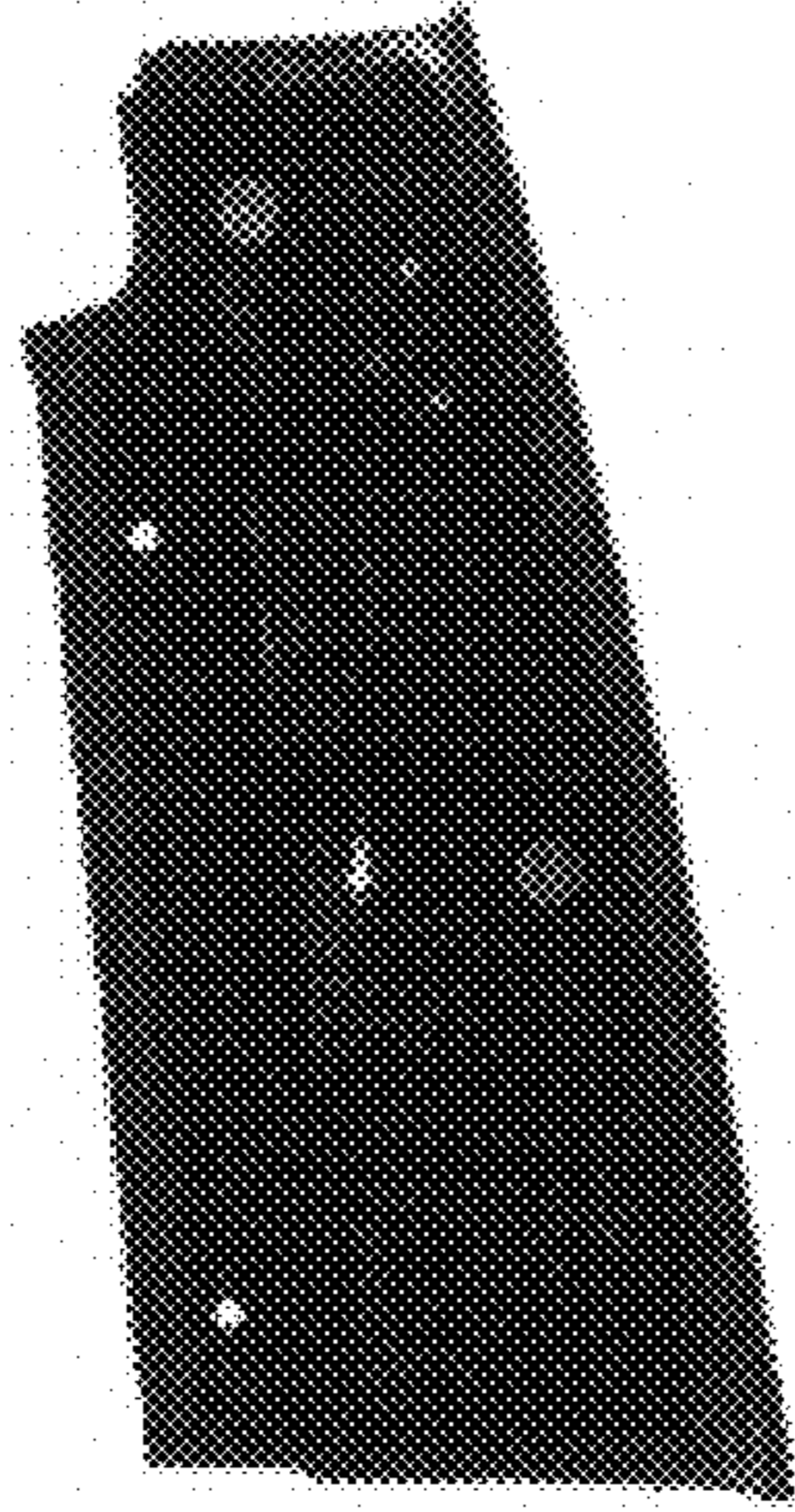

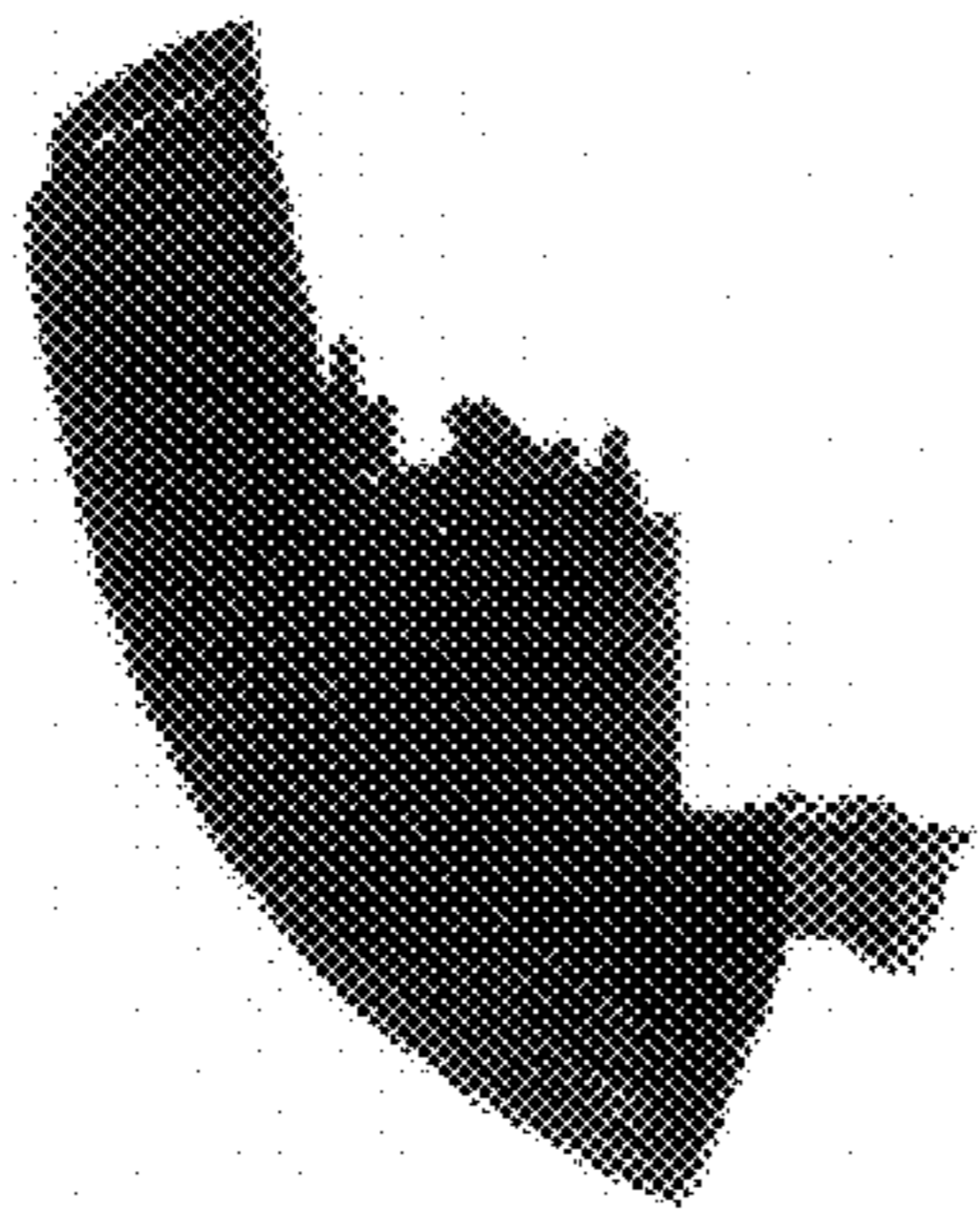

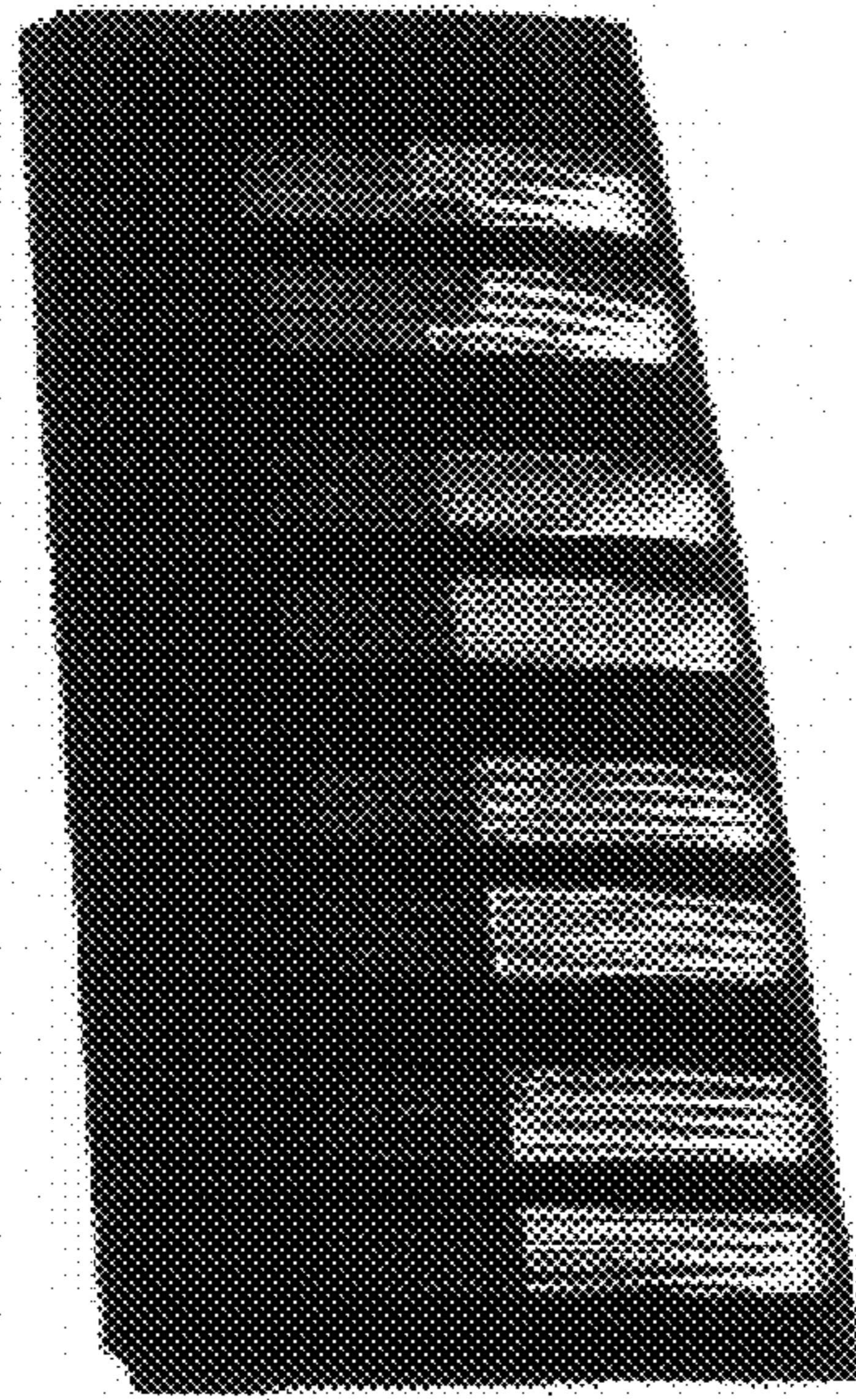

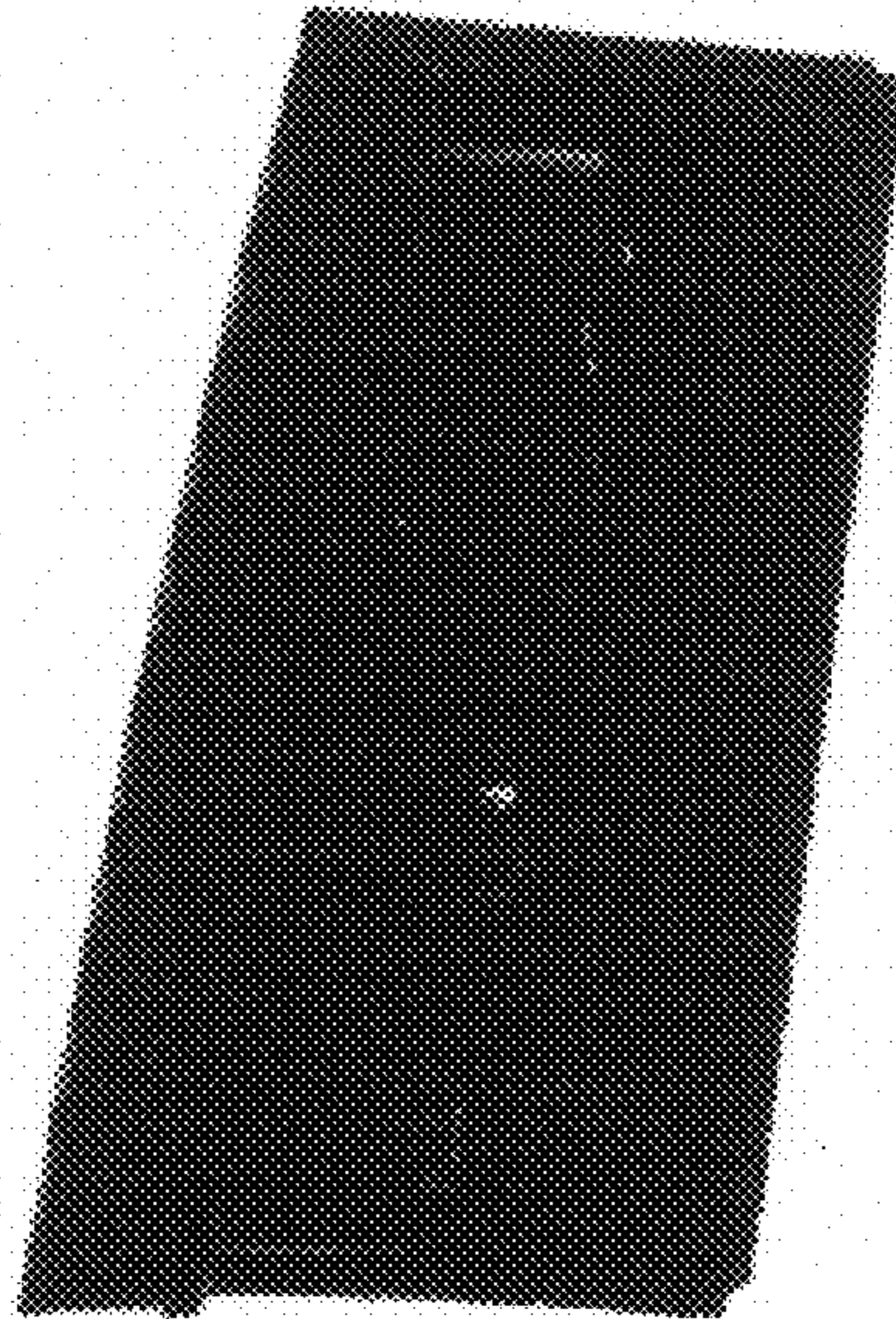
