FIG. 2 is a top view thereof;

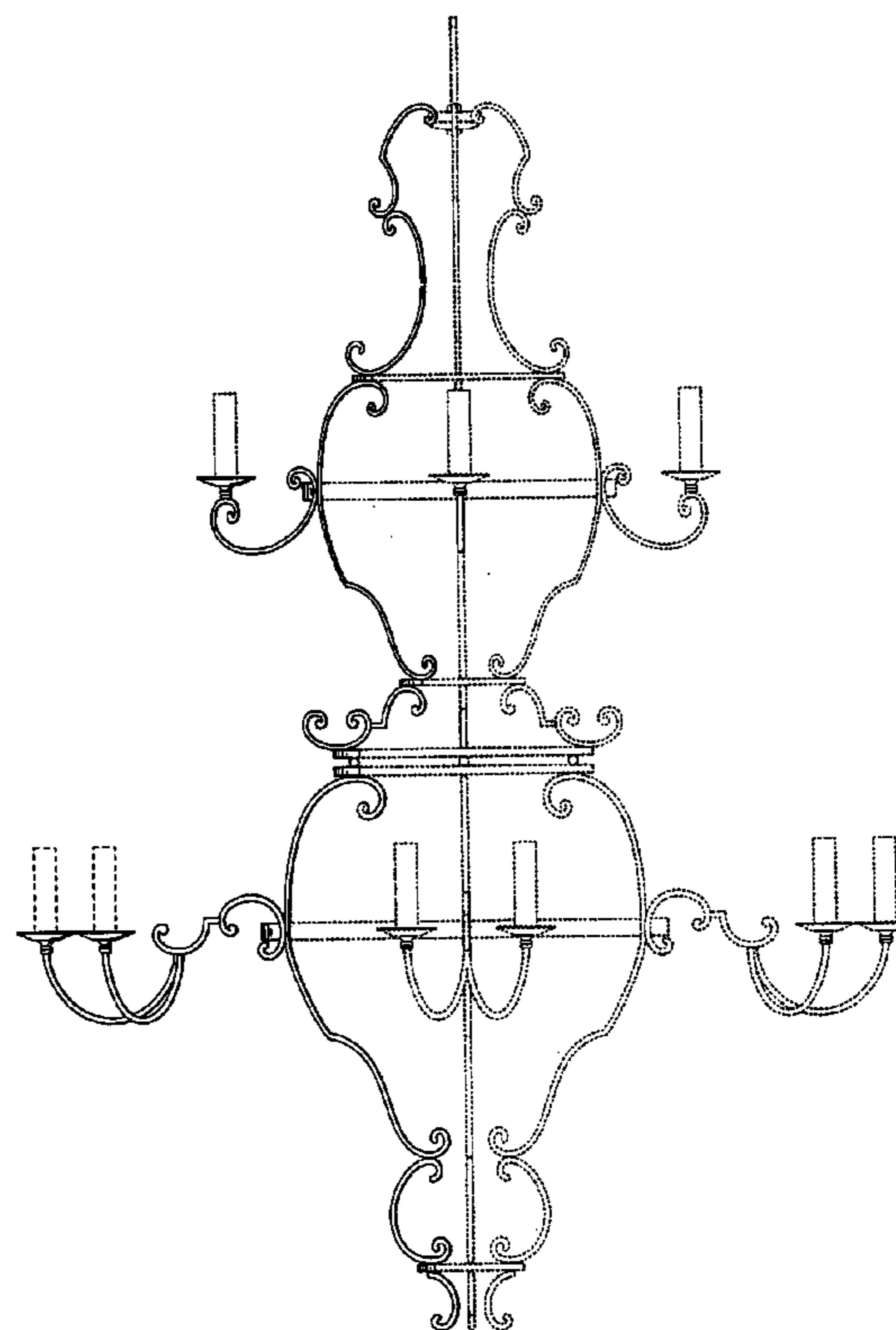
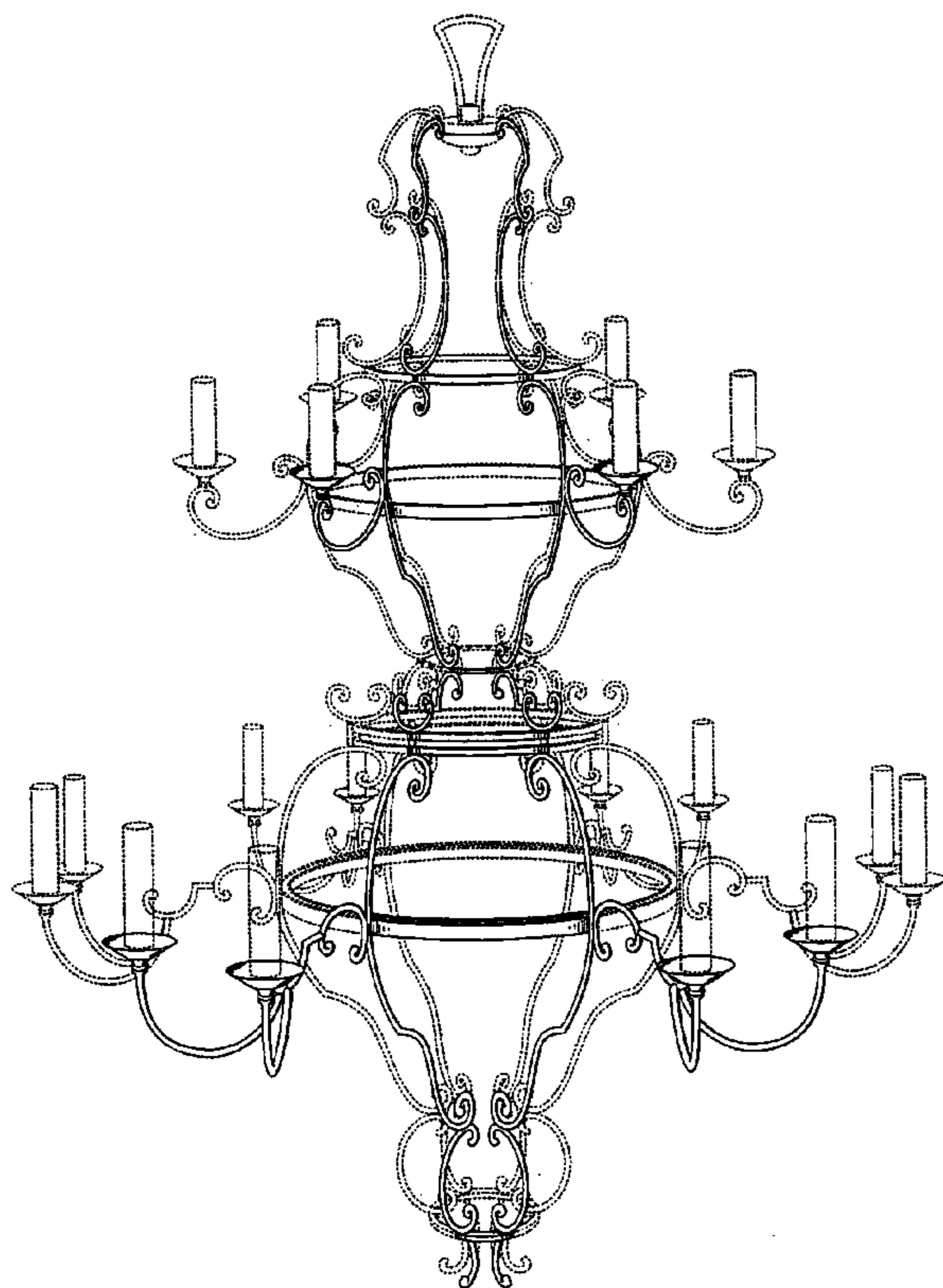
FIG. 3 is a front view thereof;

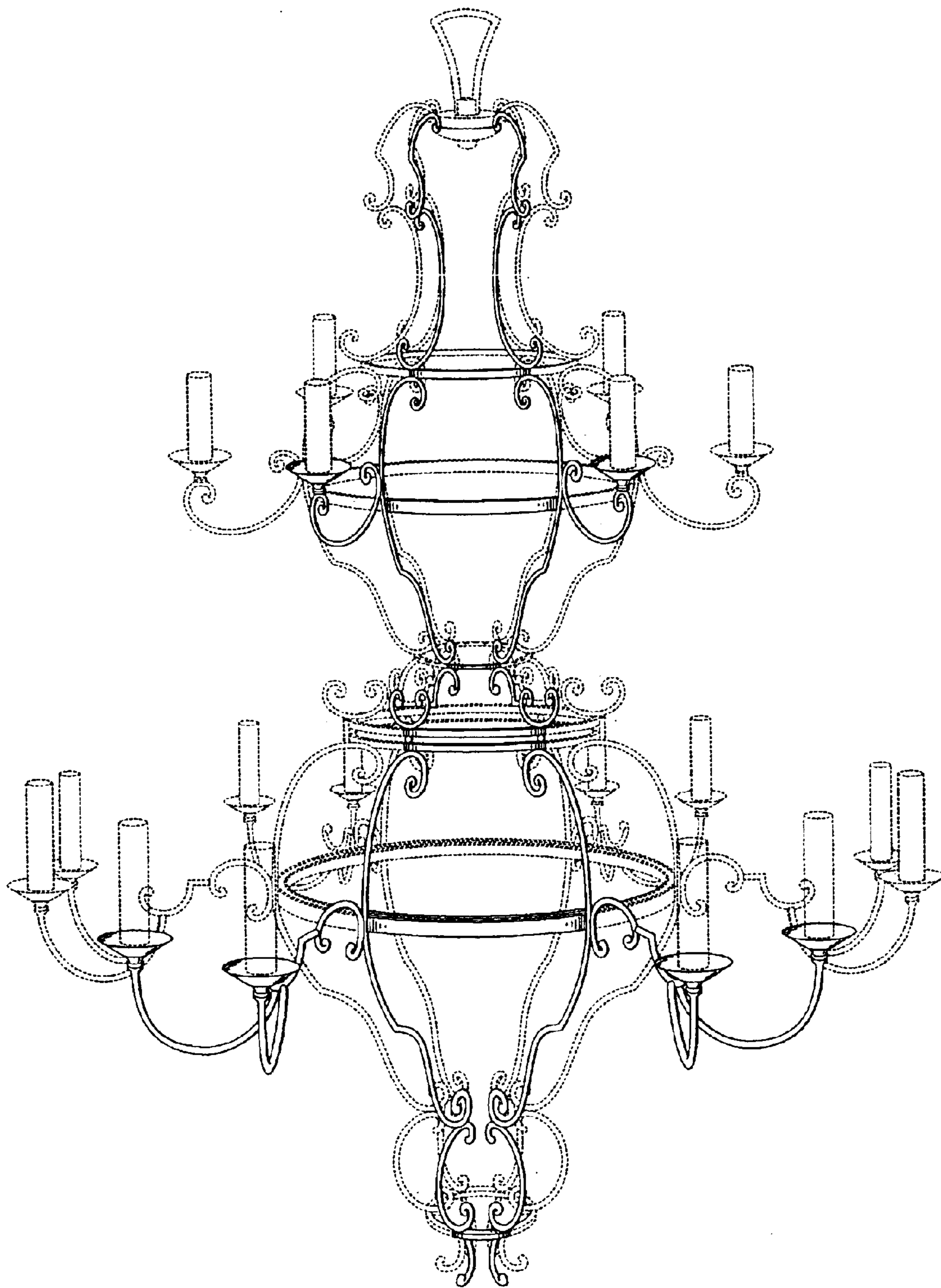
FIG. 4 is a side view identical to the mirror image of the other side thereof; and,

FIG. 5 is a bottom view thereof.

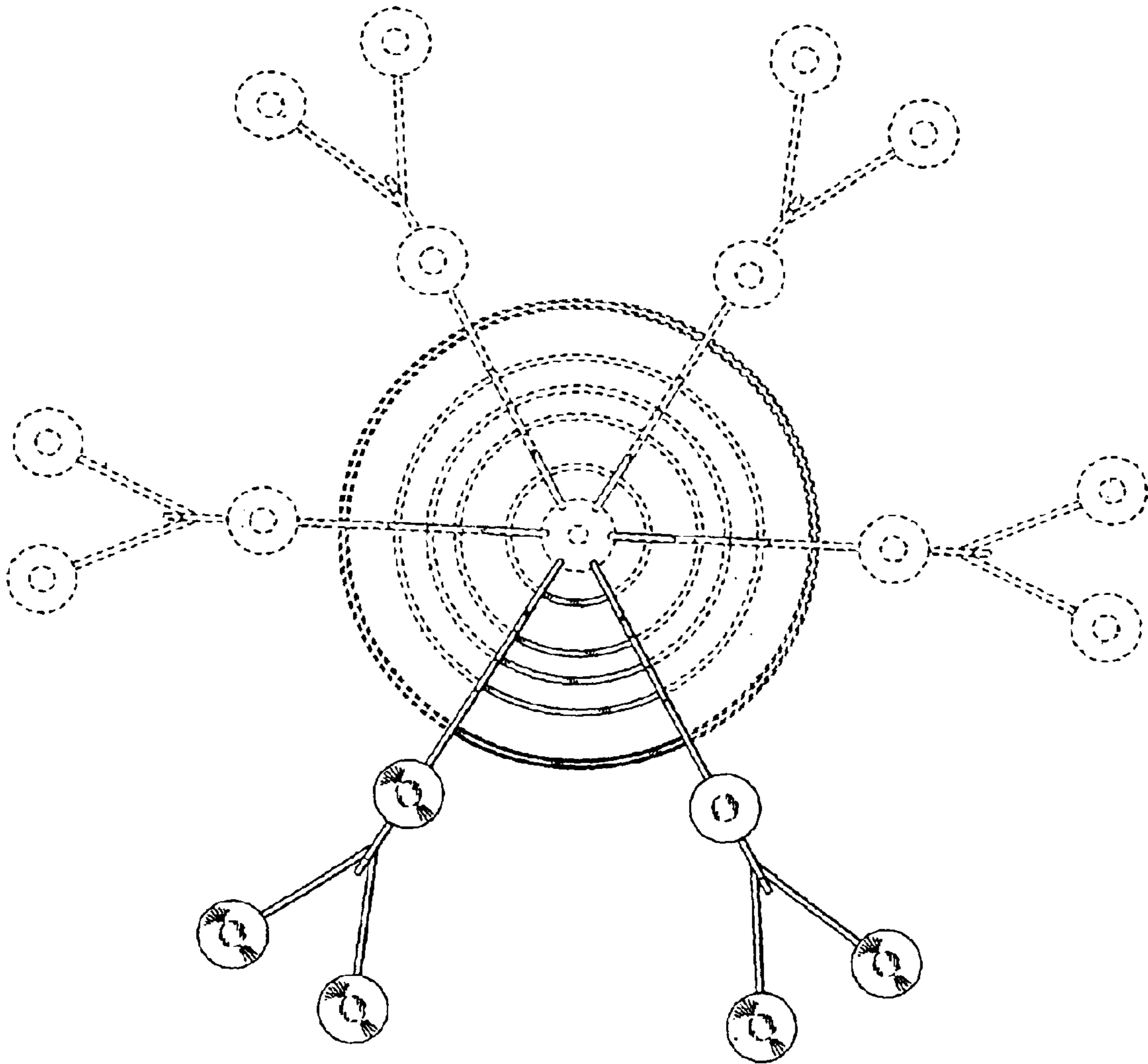

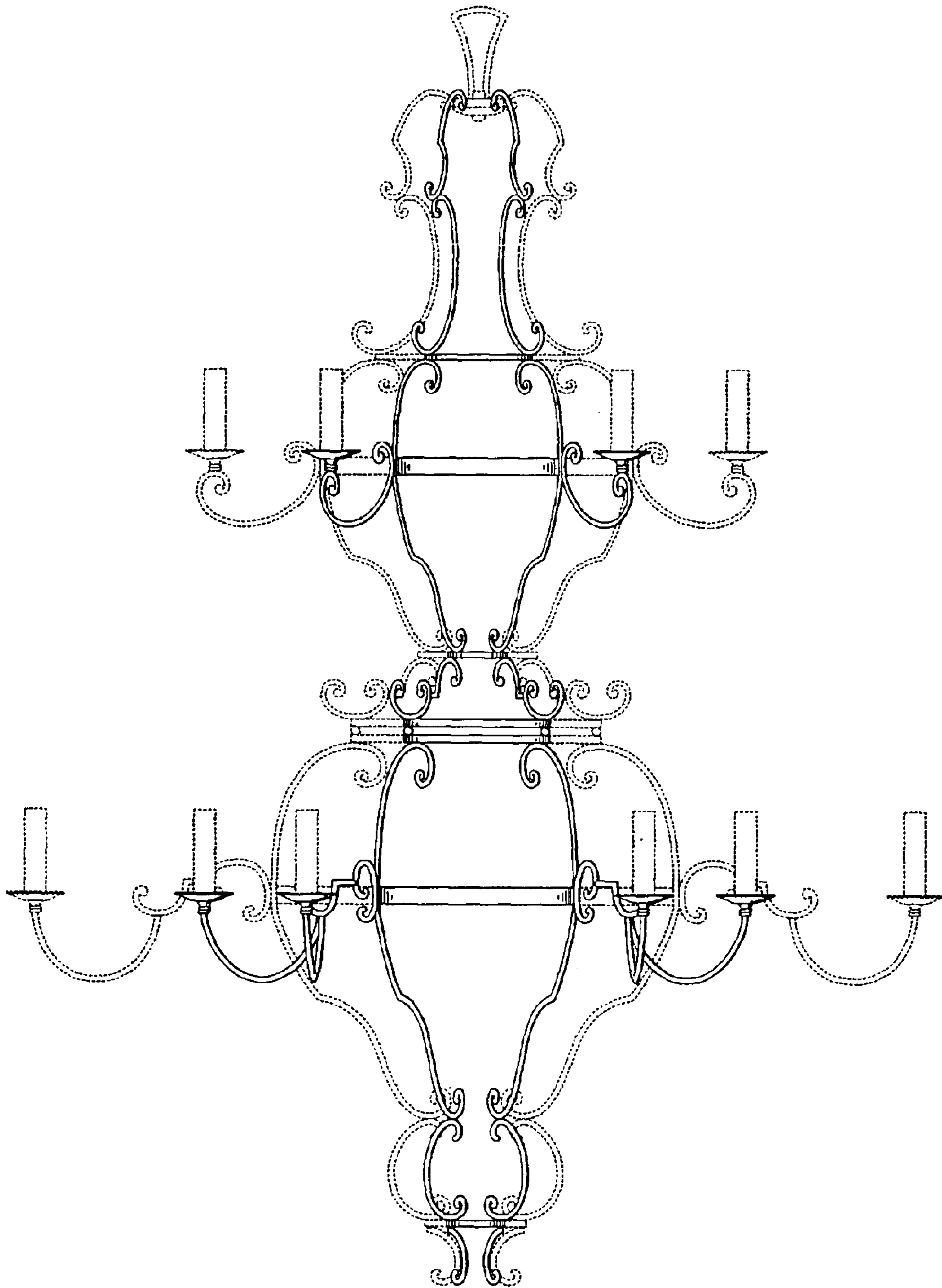




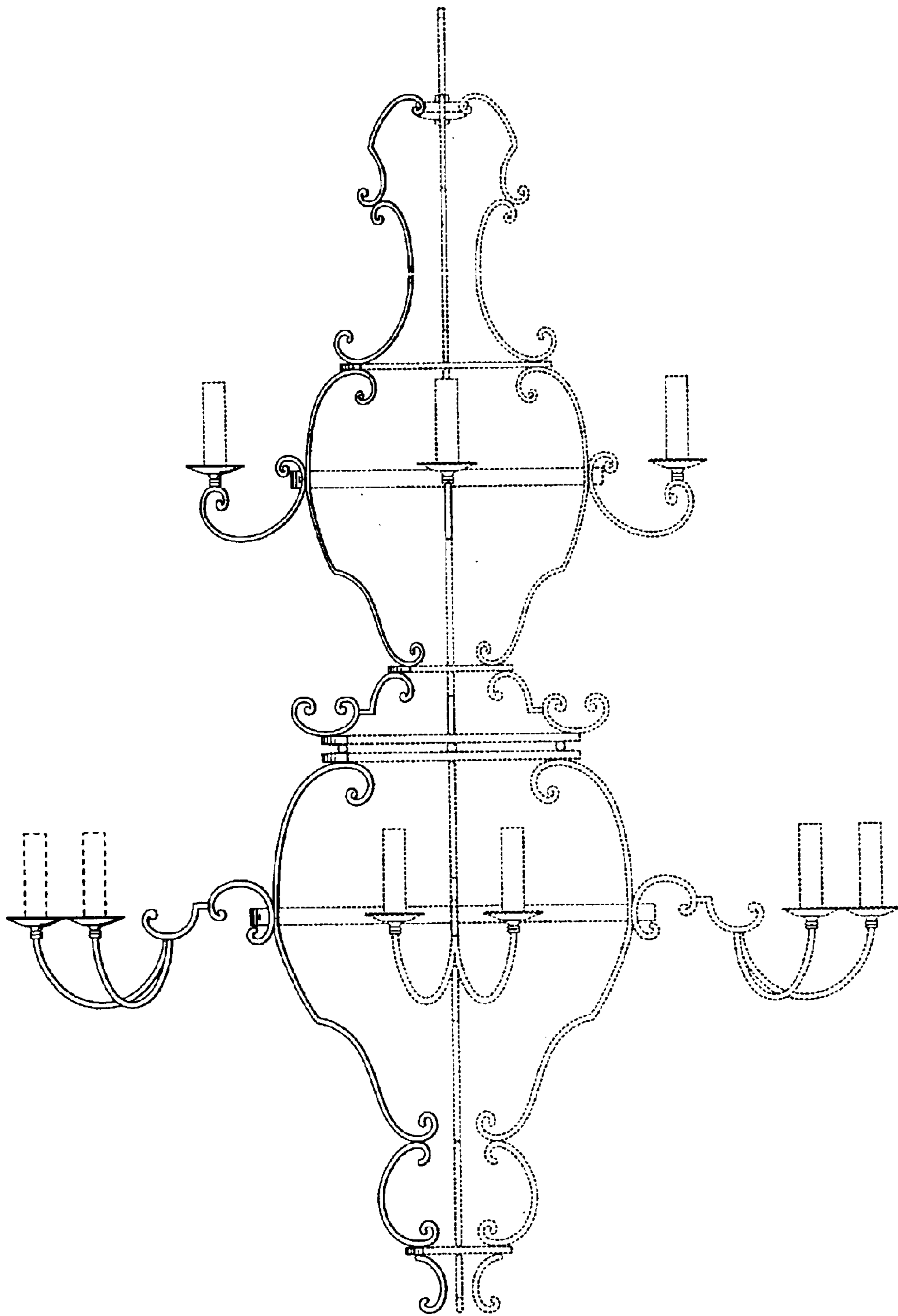

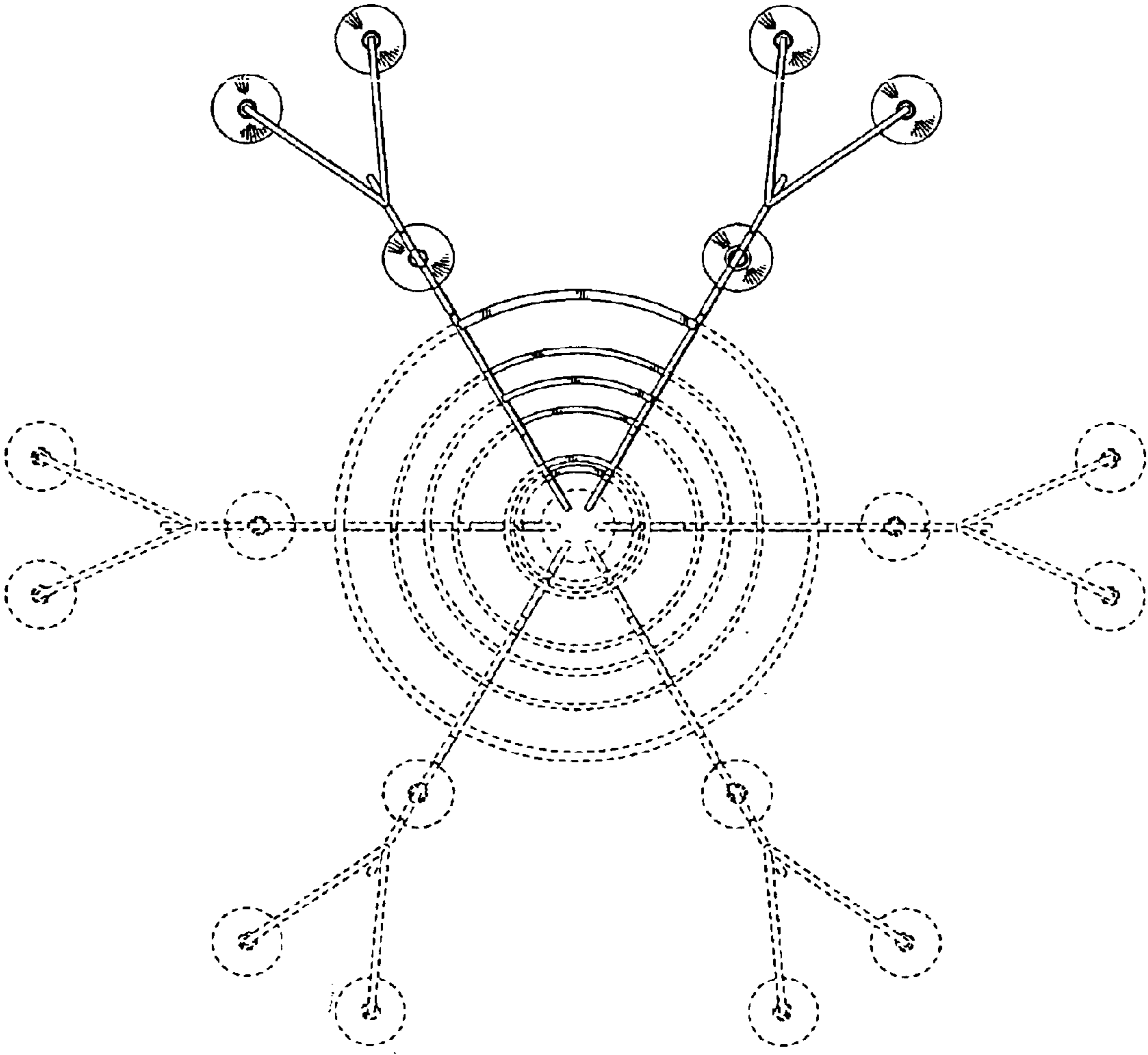
