The ornamental design for a helmet eye shield, as shown and described.

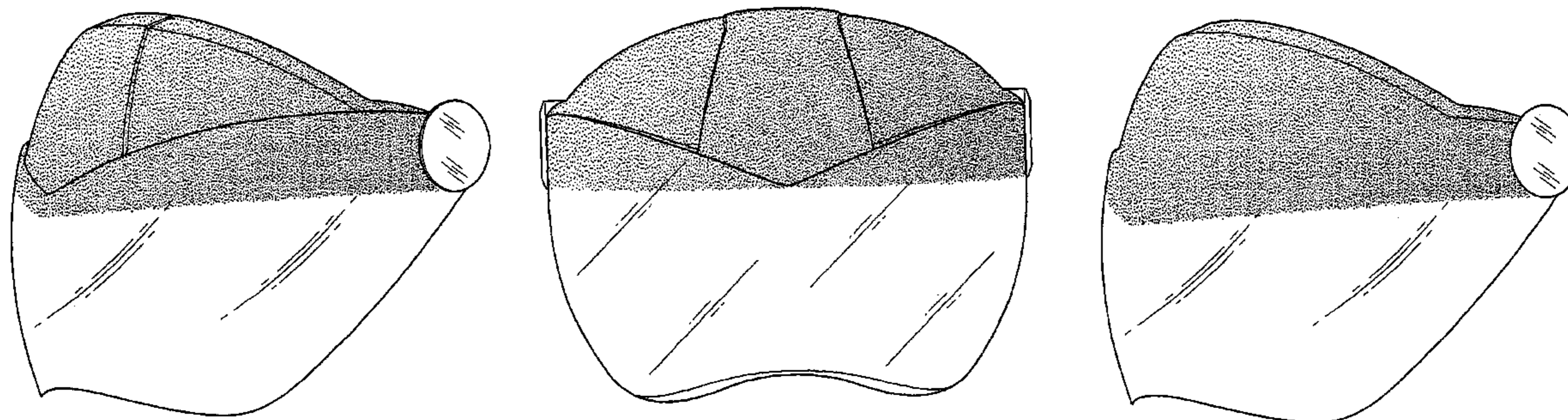
**DESCRIPTION**

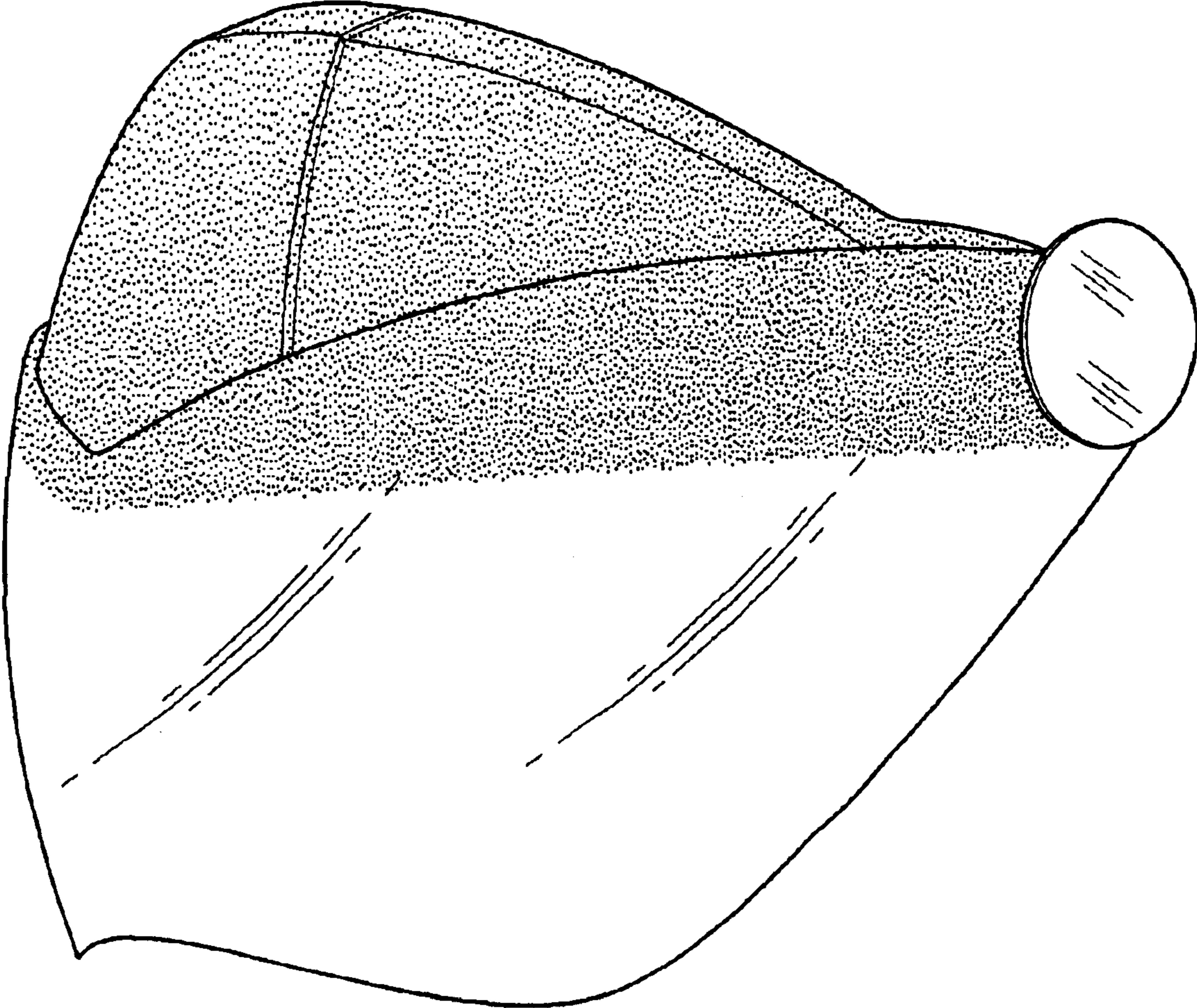
FIG. 1 is a perspective illustration, from the front and left side, of a first embodiment of the helmet eye shield according to our design;

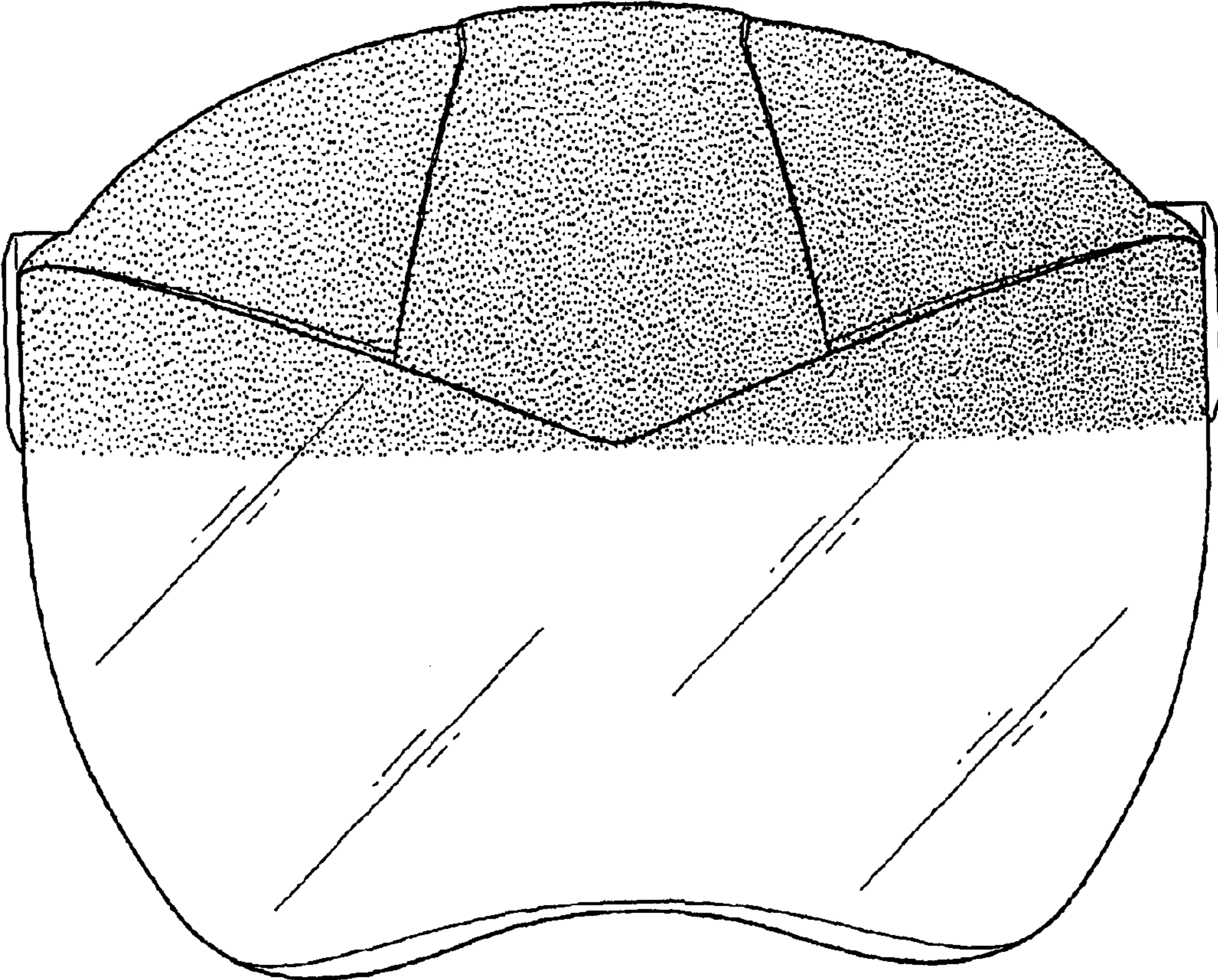

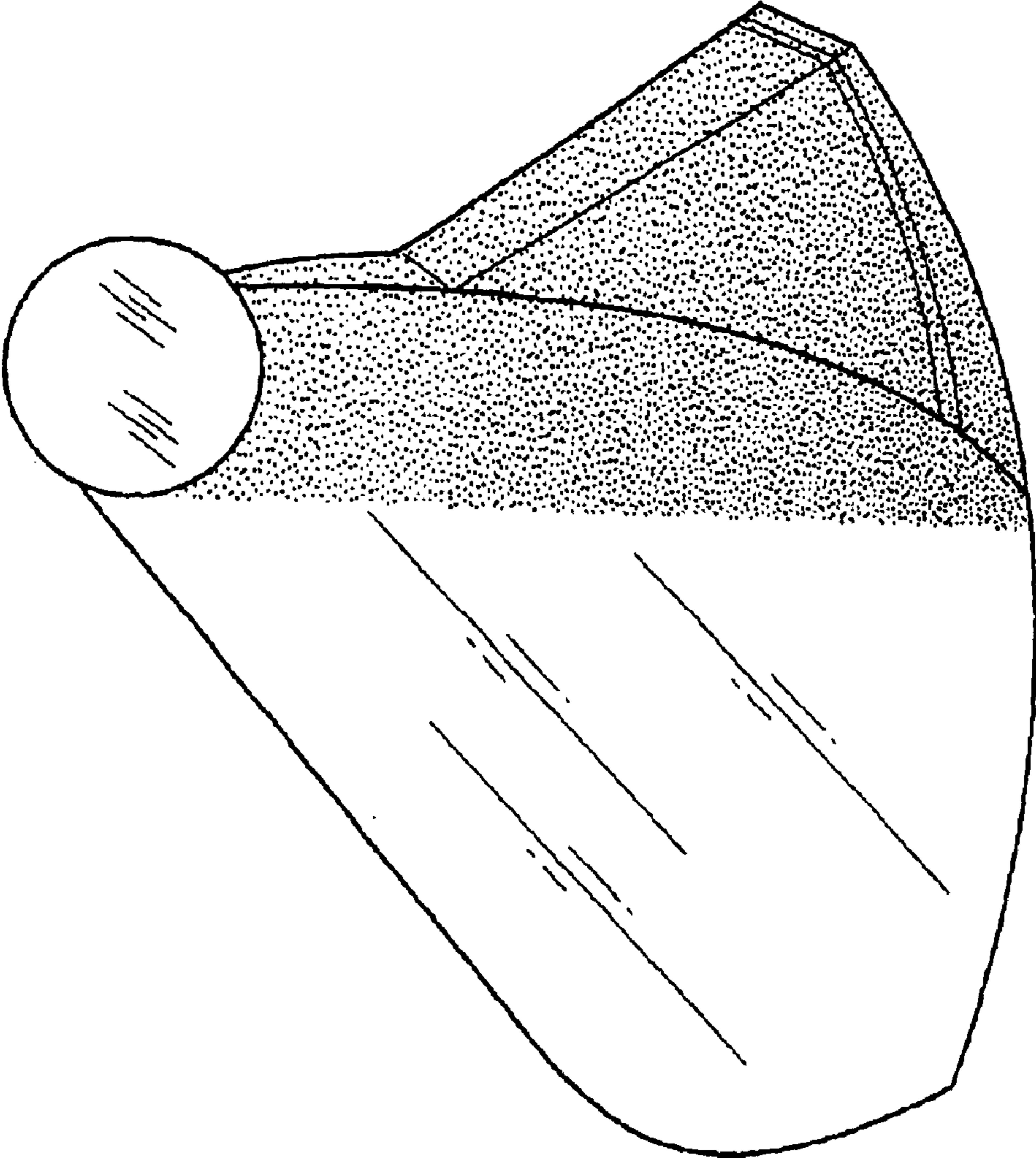




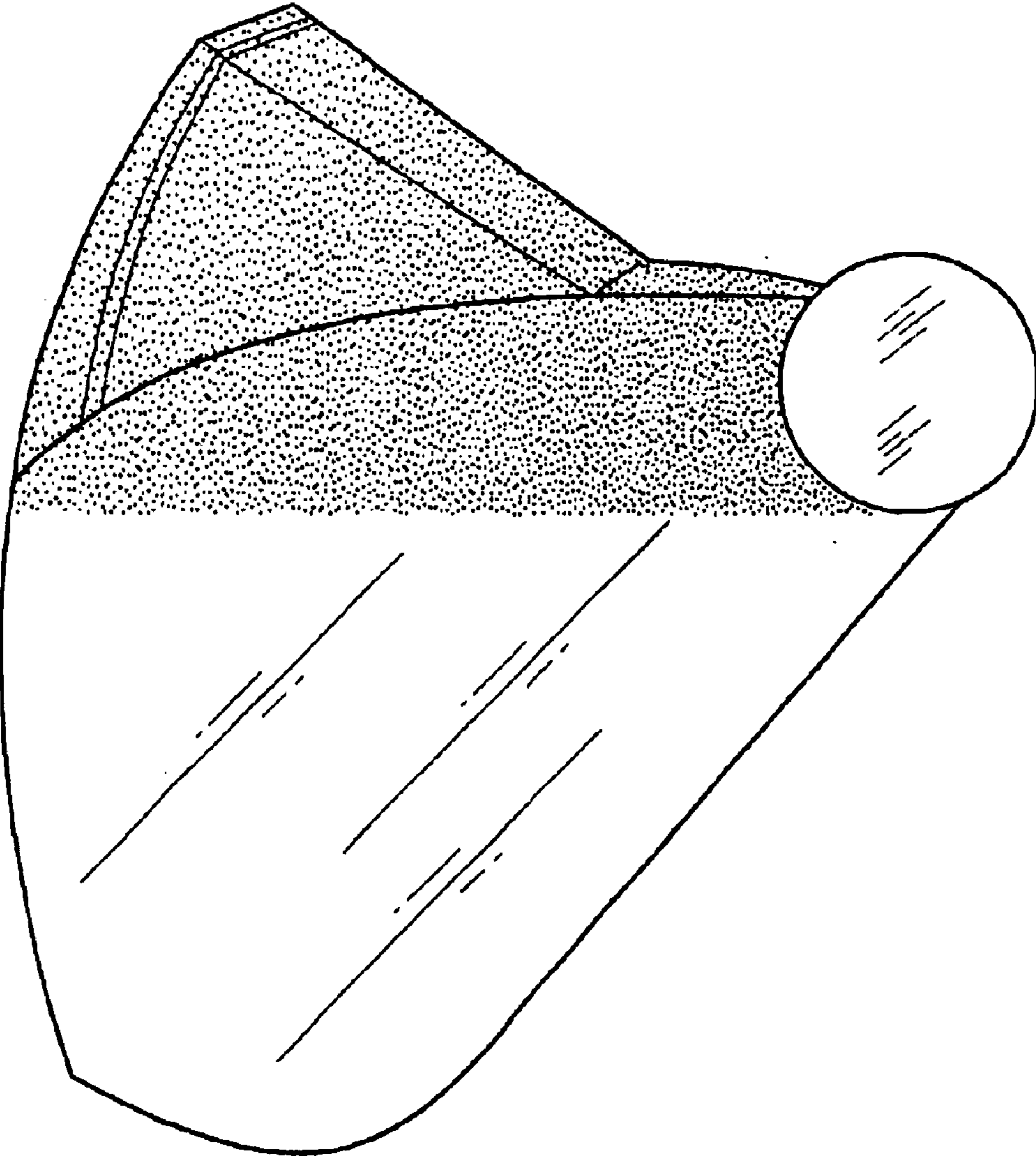

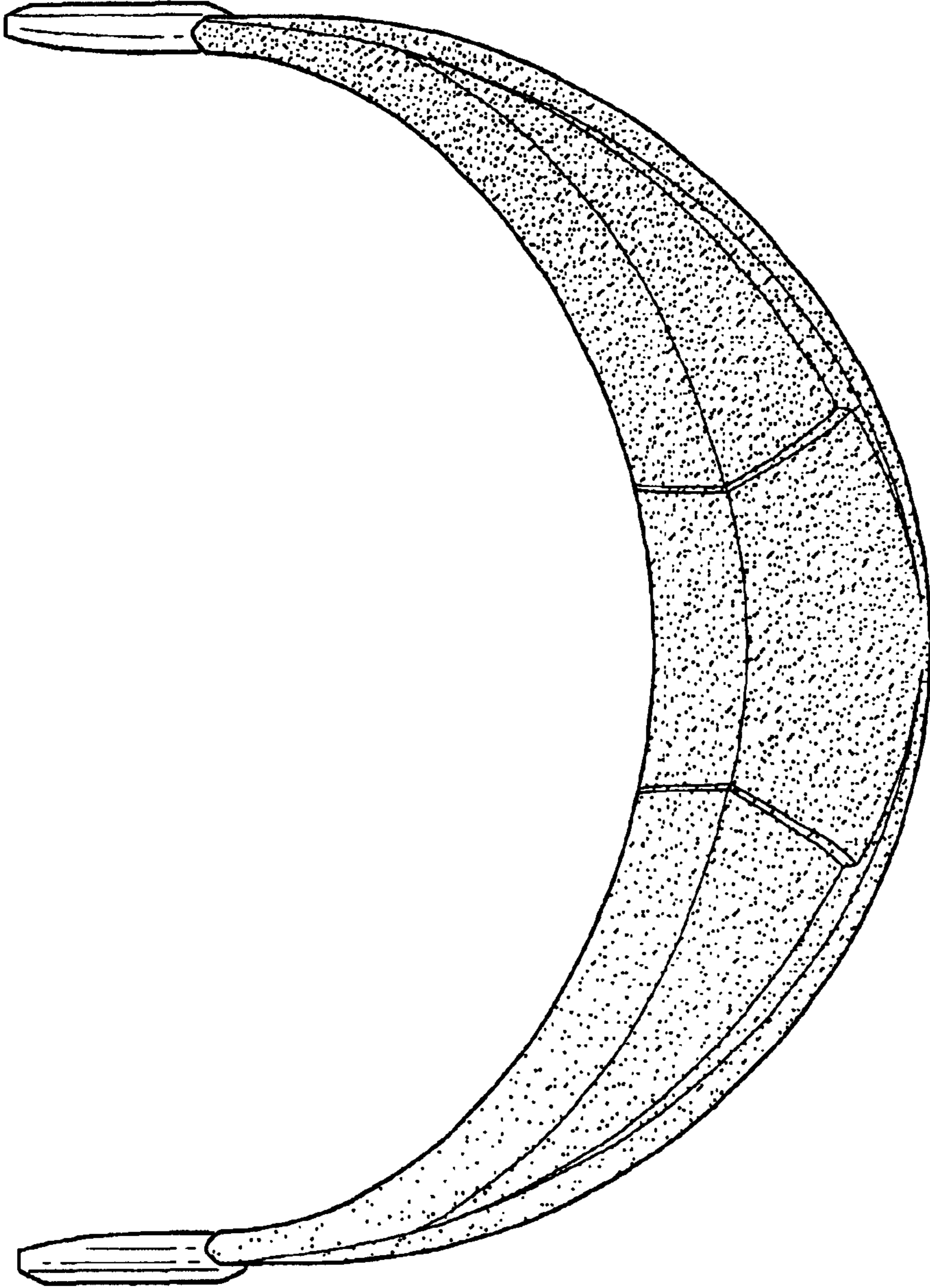

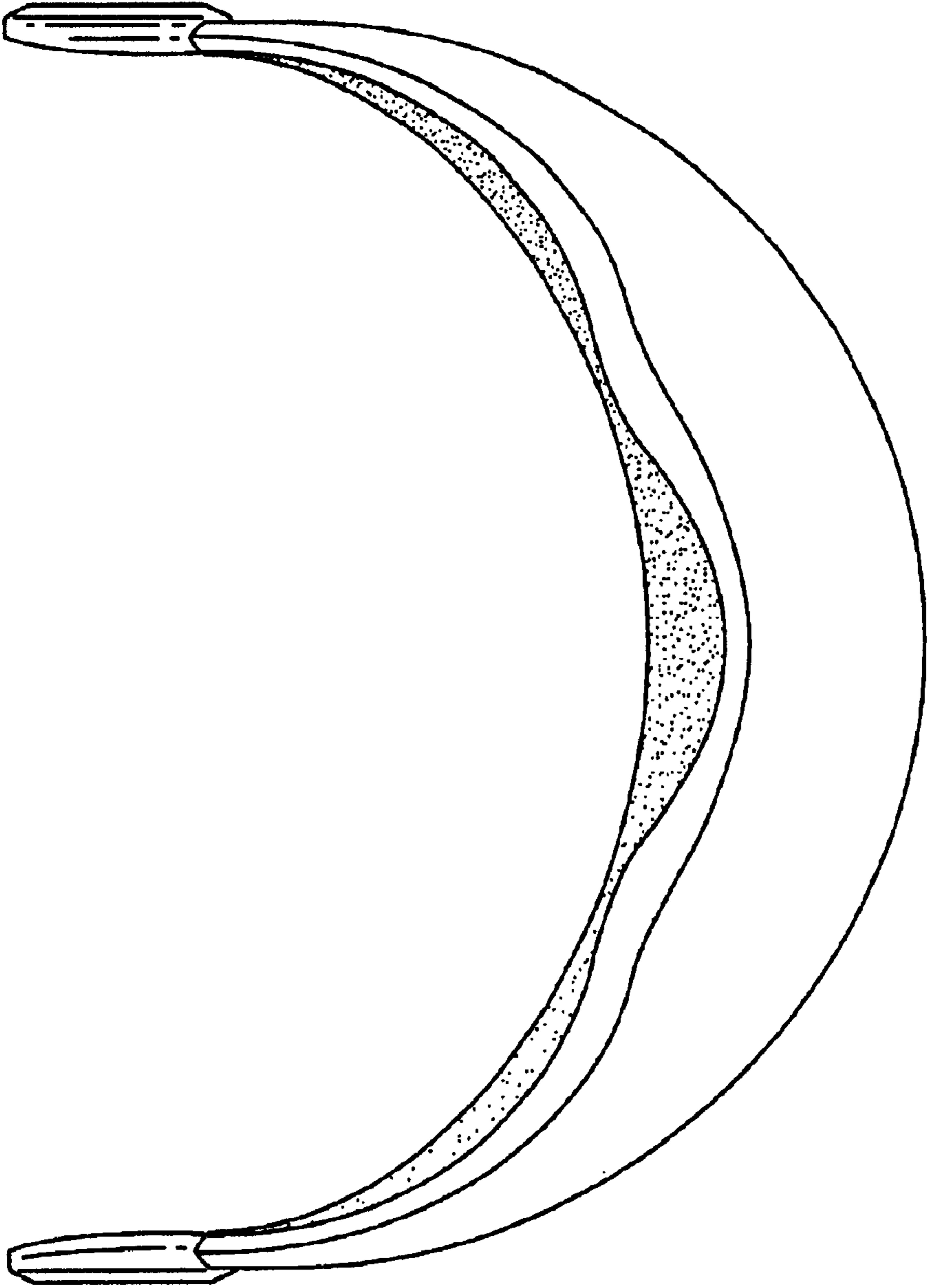

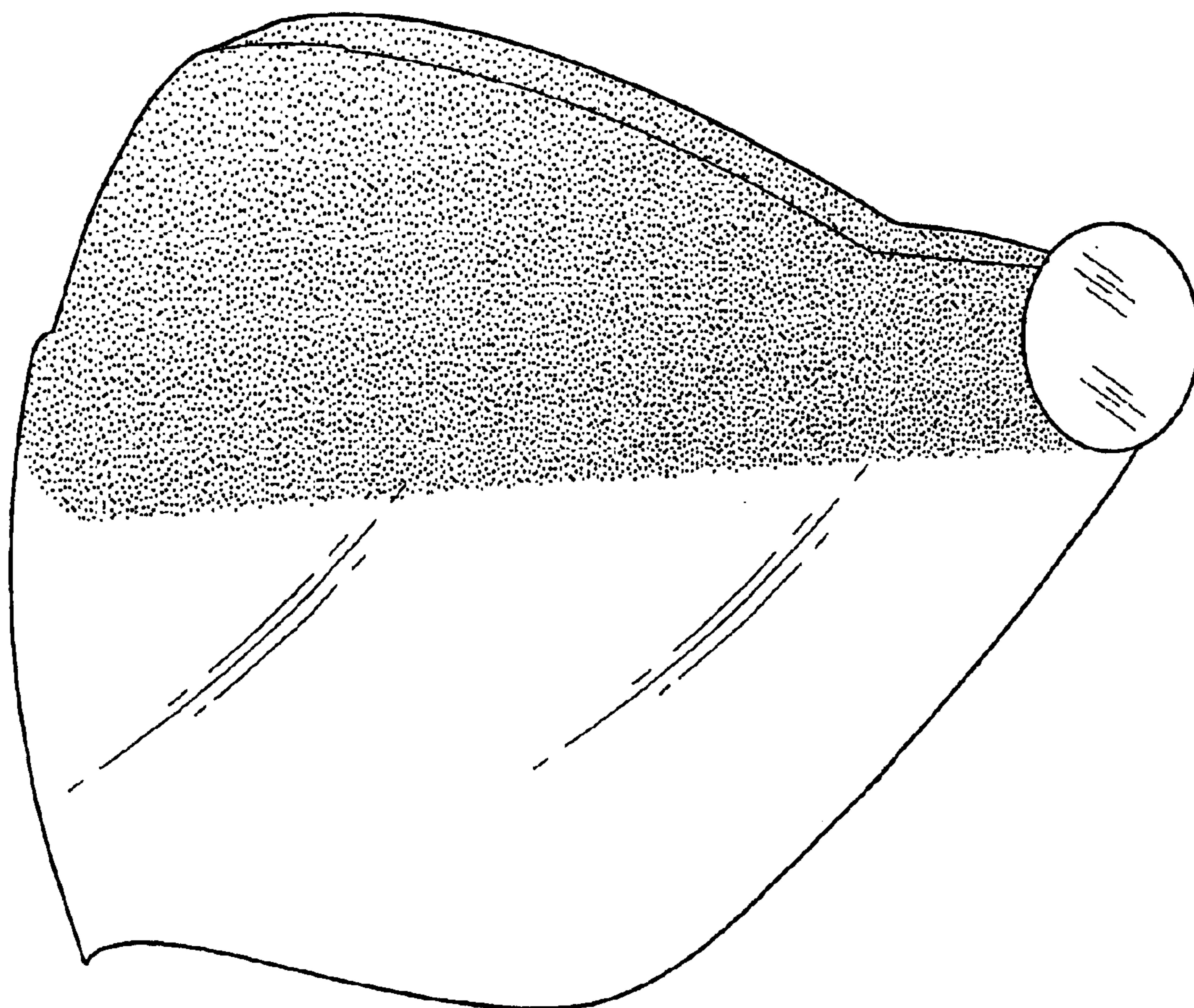

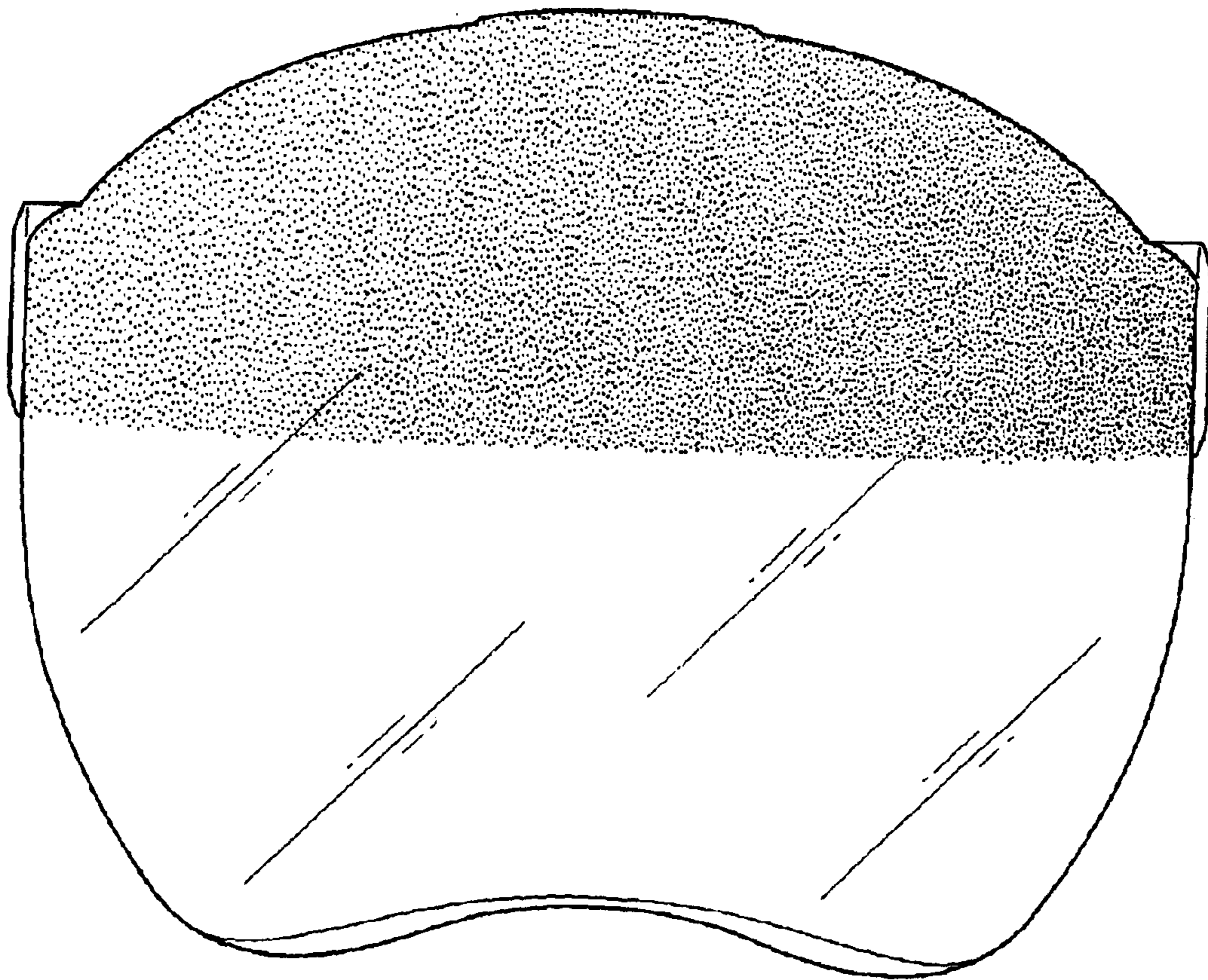

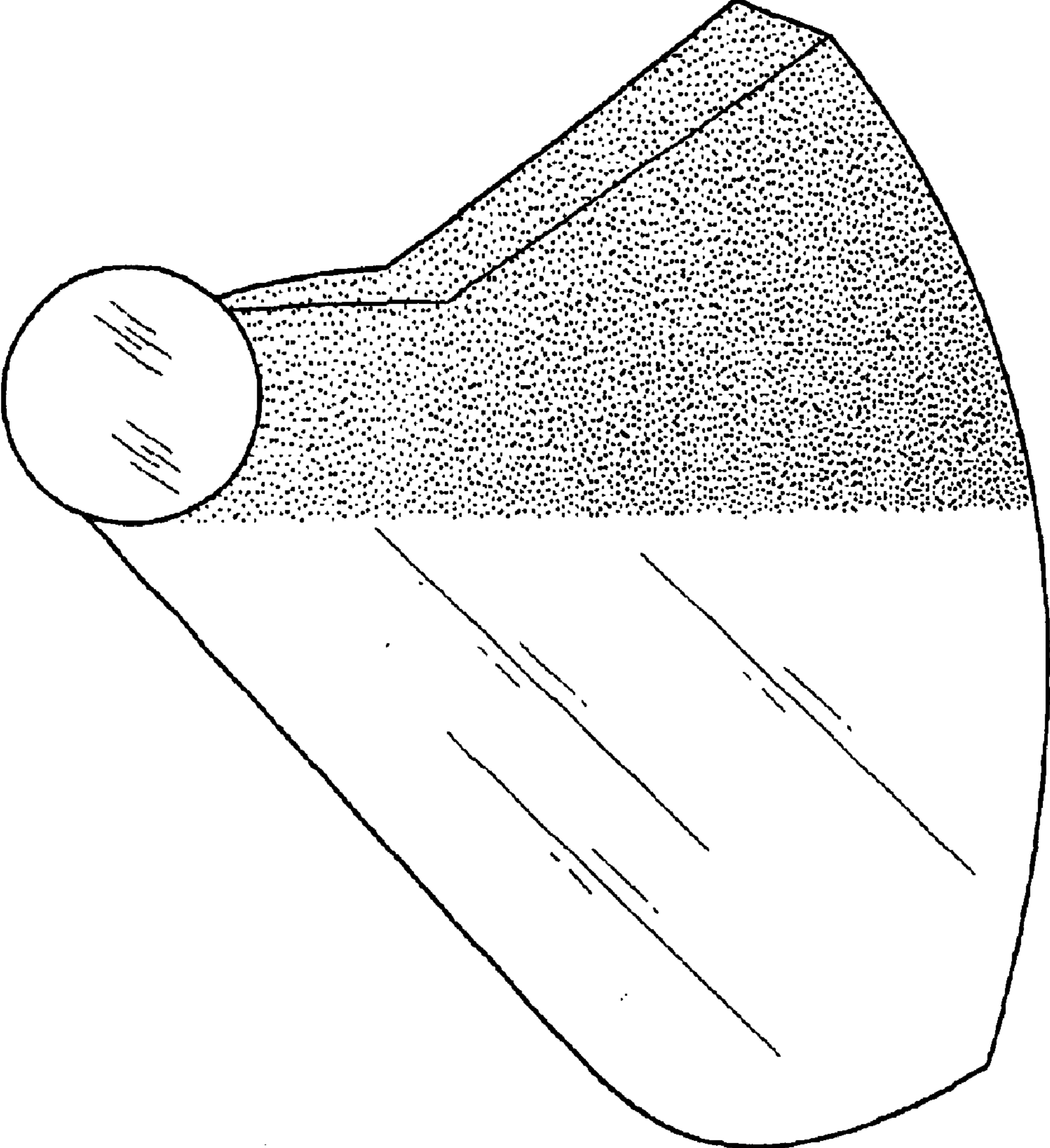

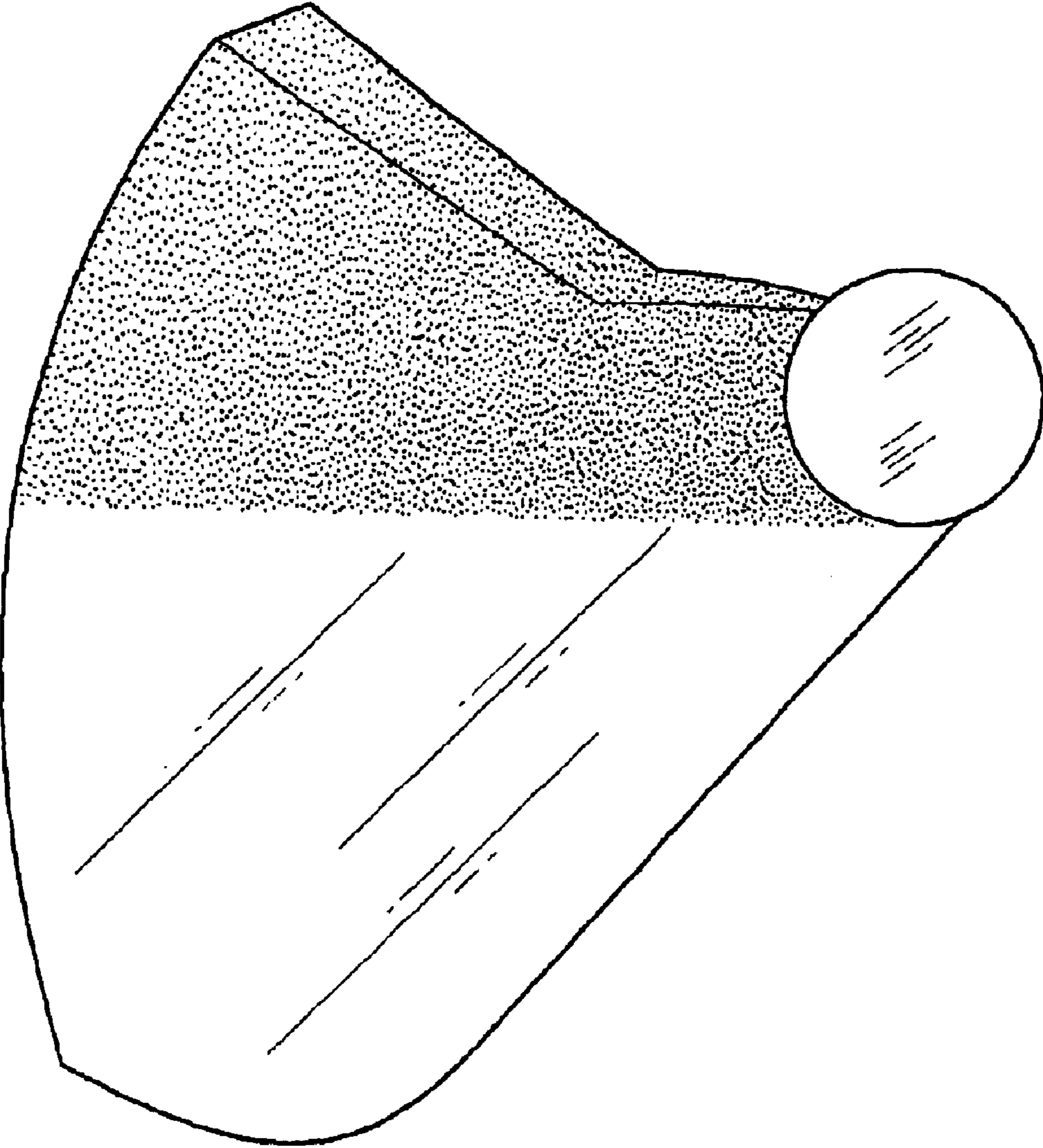




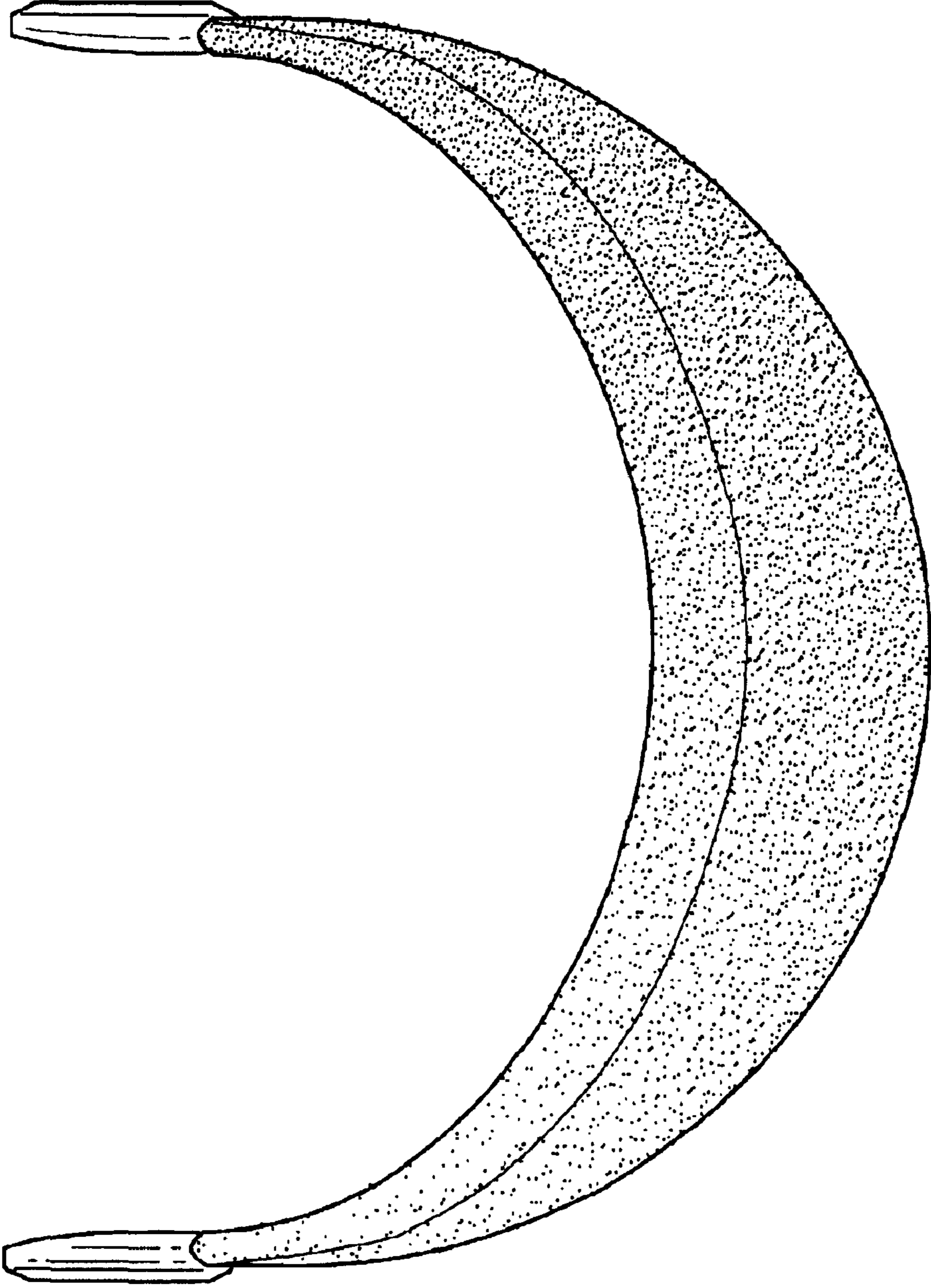

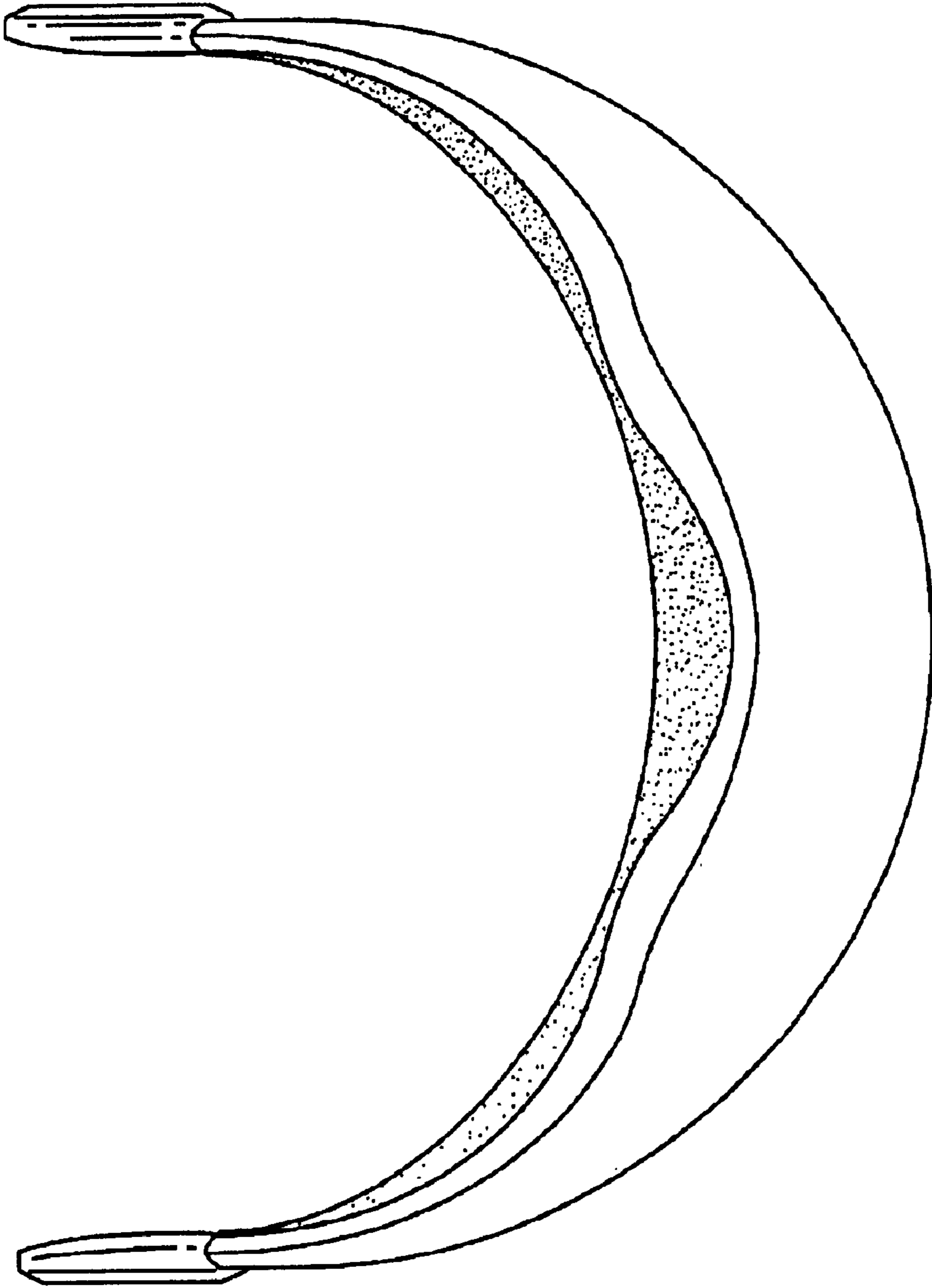
