(57) **CLAIM**

The ornamental design for a piece of luggage, as shown and described.

DESCRIPTION

FIG. 1 provides a front view of the piece of luggage with the towing handle in the collapsed position.

FIG. 2 provides a rear view of the piece of luggage with the towing handle in the collapsed position.

FIG. 3 provides a right side view of the piece of luggage with the towing handle in the collapsed position.

FIG. 4 provides a left side view of the piece of luggage with the towing handle in the collapsed position.

FIG. 5 provides a top view of the piece of luggage with the towing handle in the collapsed position.

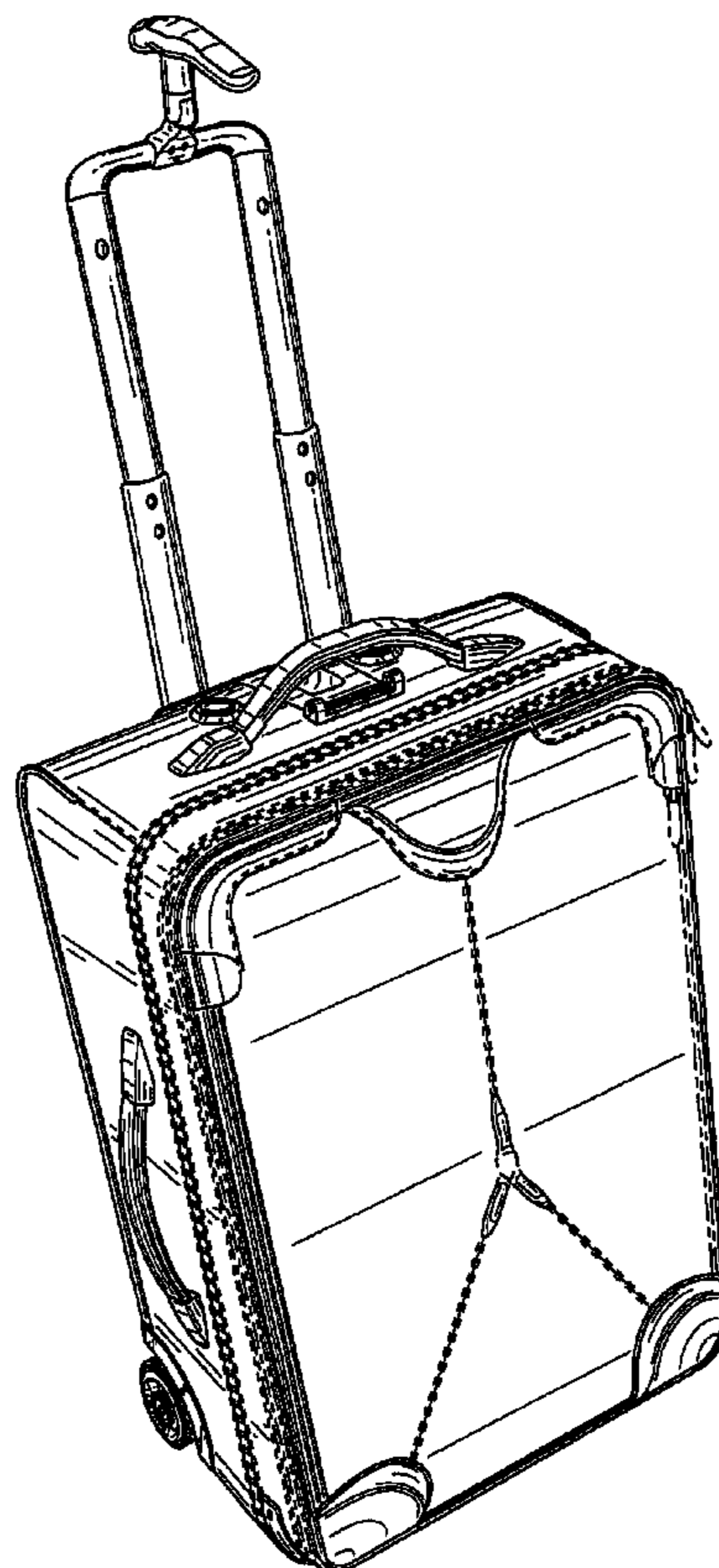
FIG. 6 provides a bottom view of the piece of luggage with the towing handle in the collapsed position; and,

FIG. 7 provides a perspective view of the piece of luggage with the towing handle in the raised position.

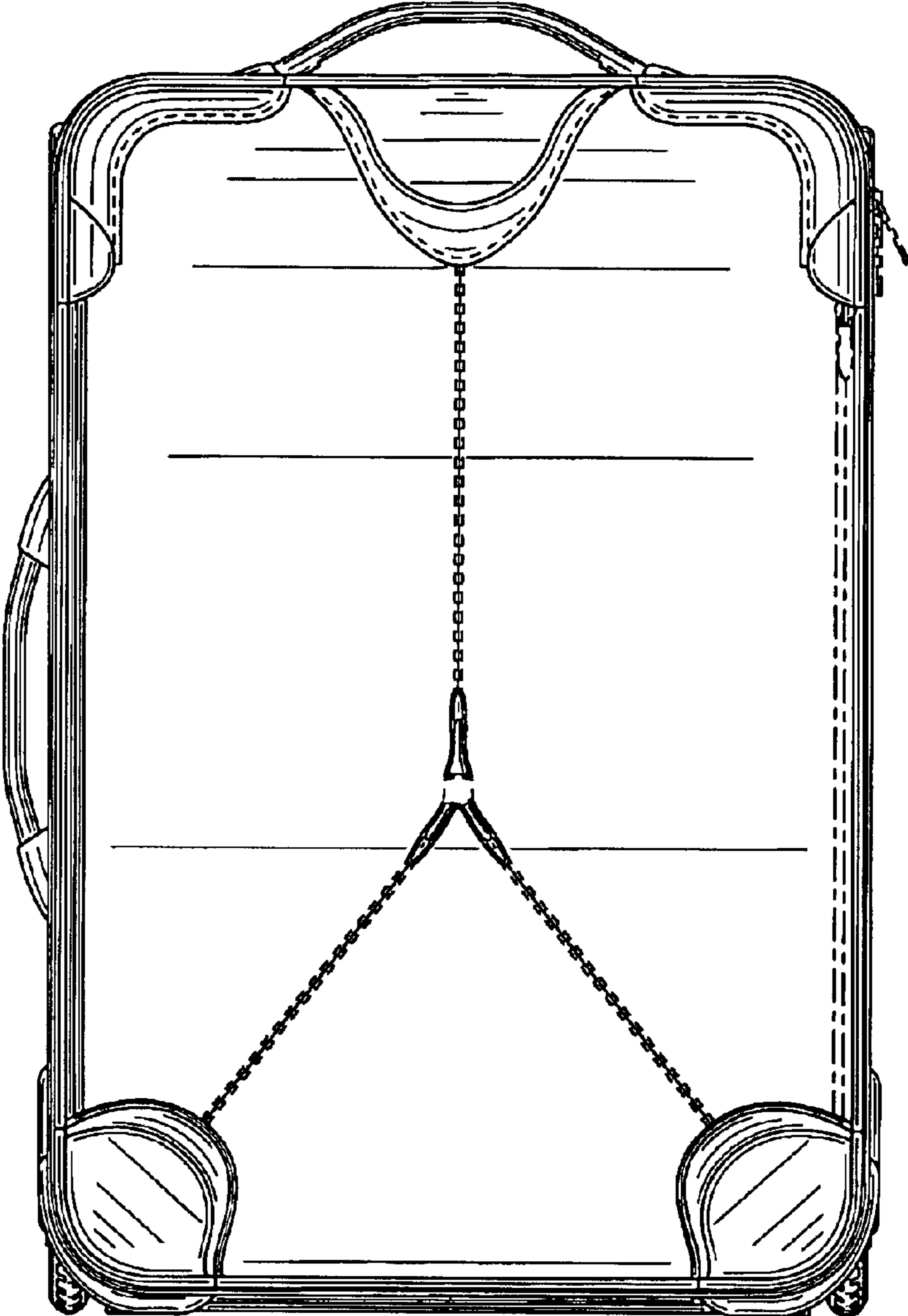

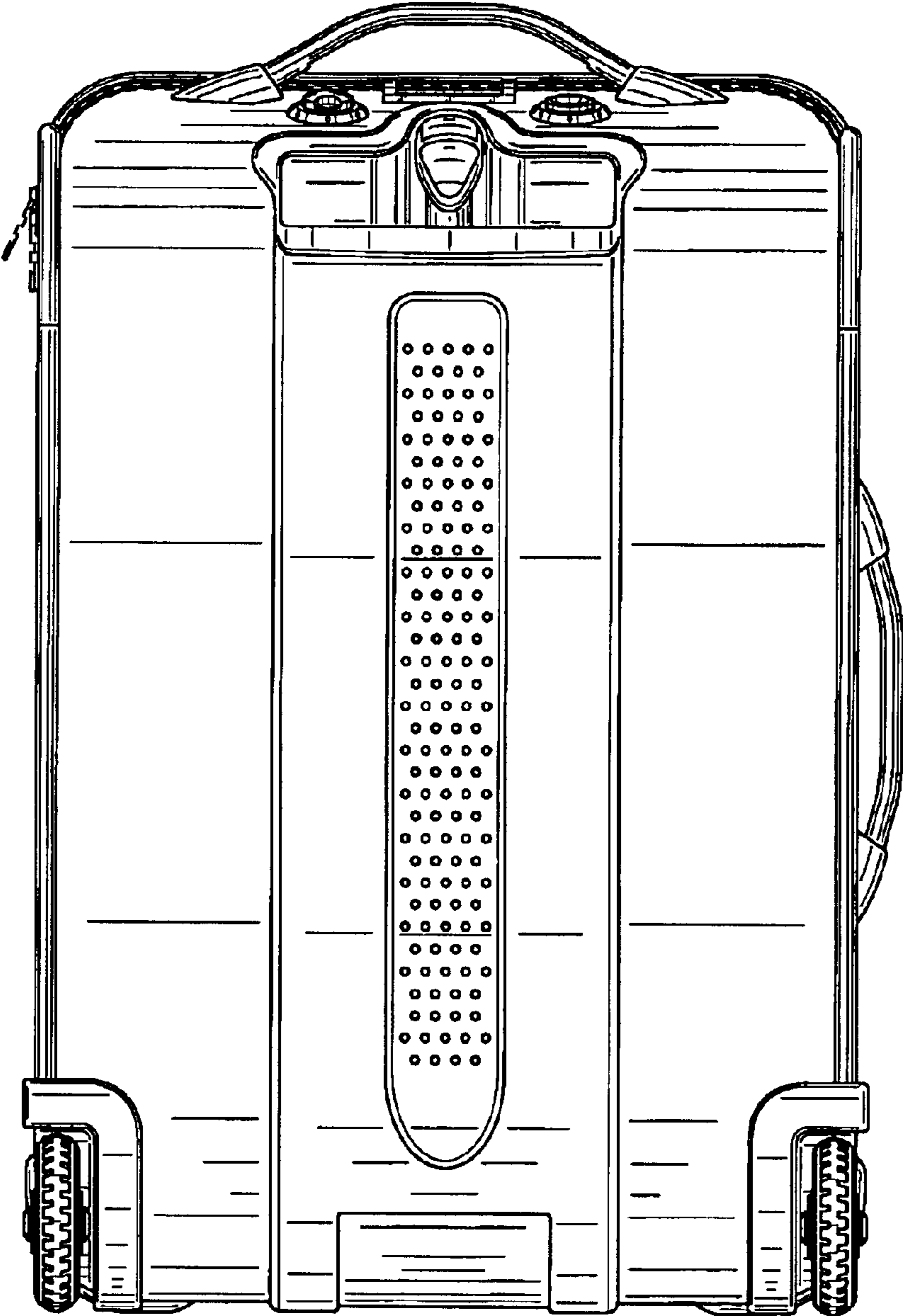

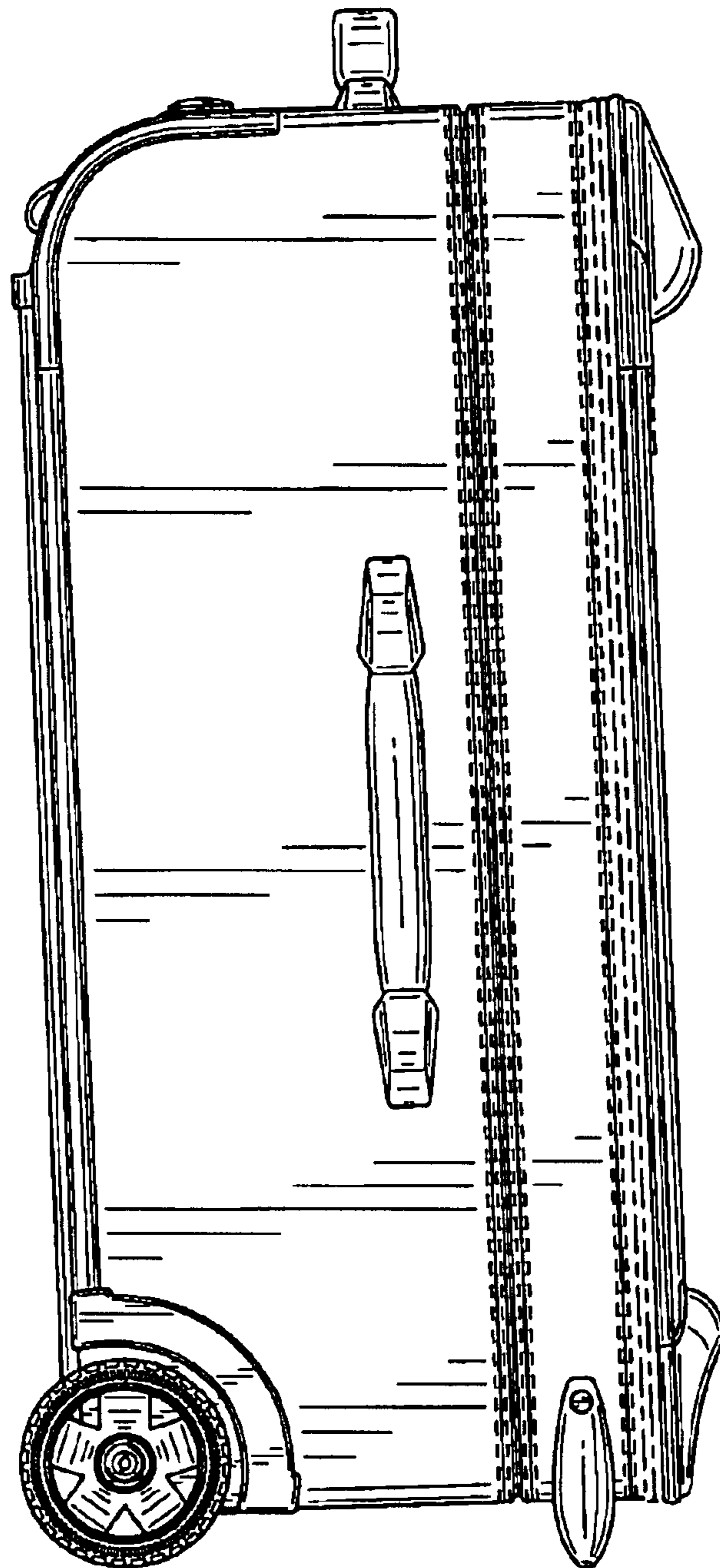

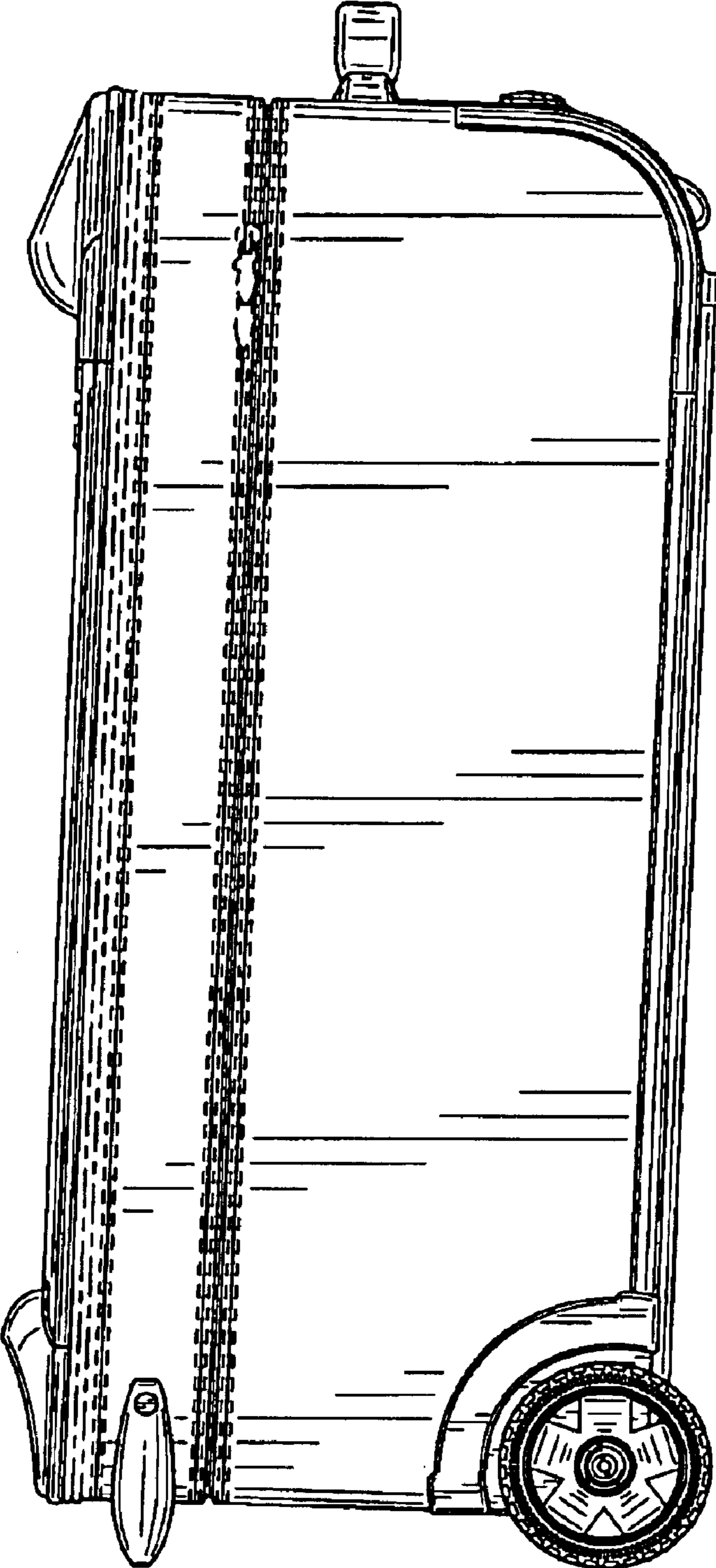

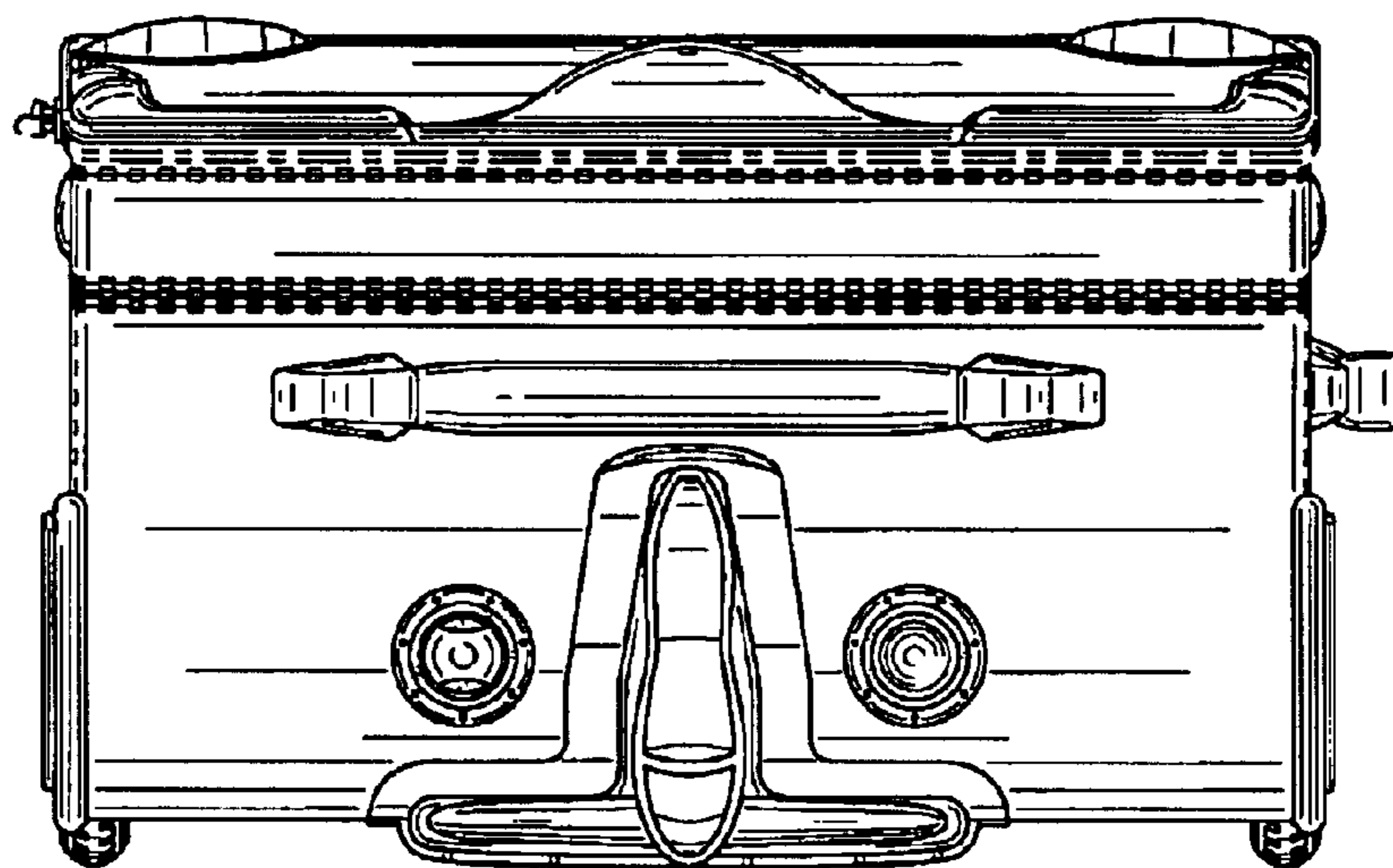

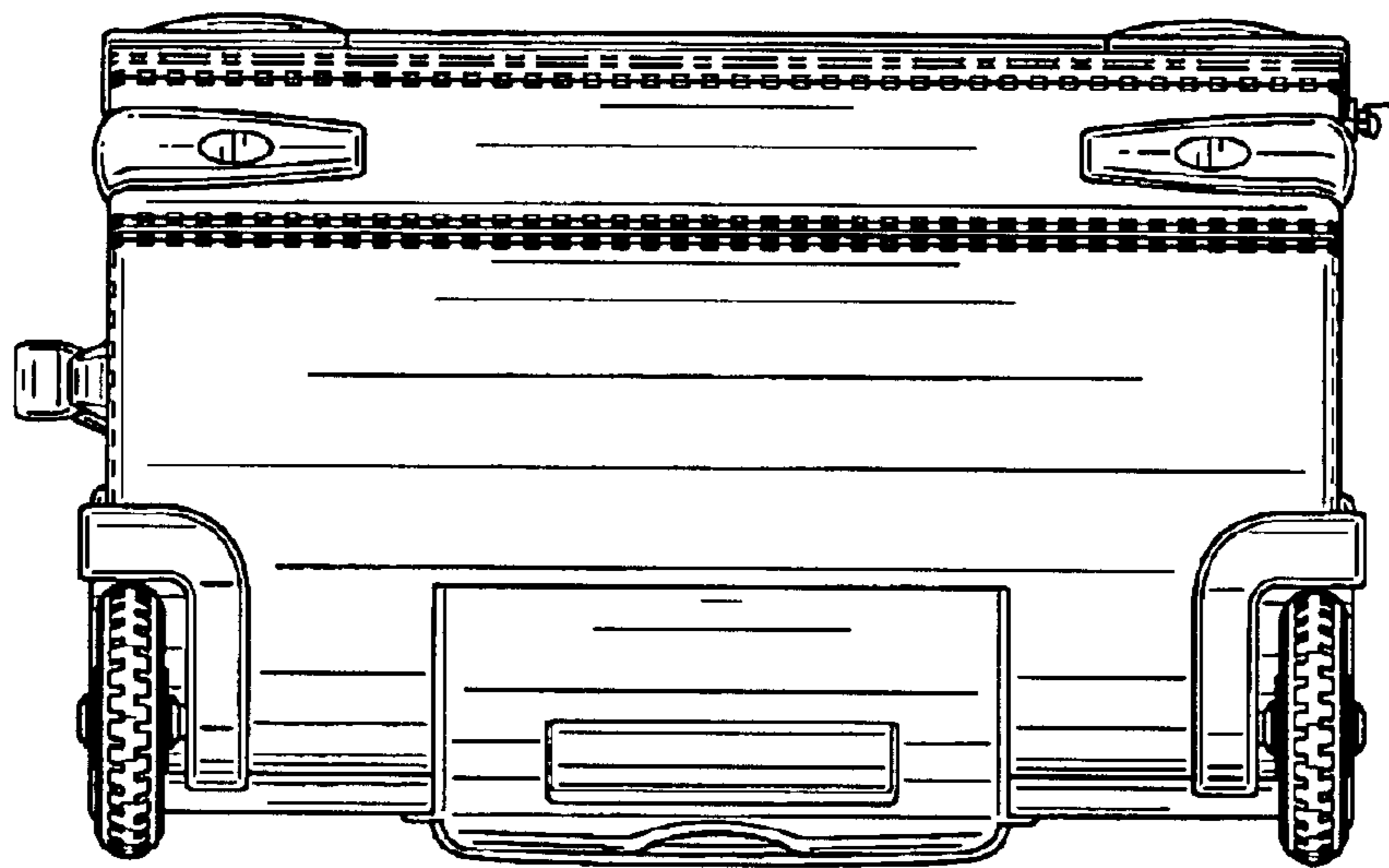

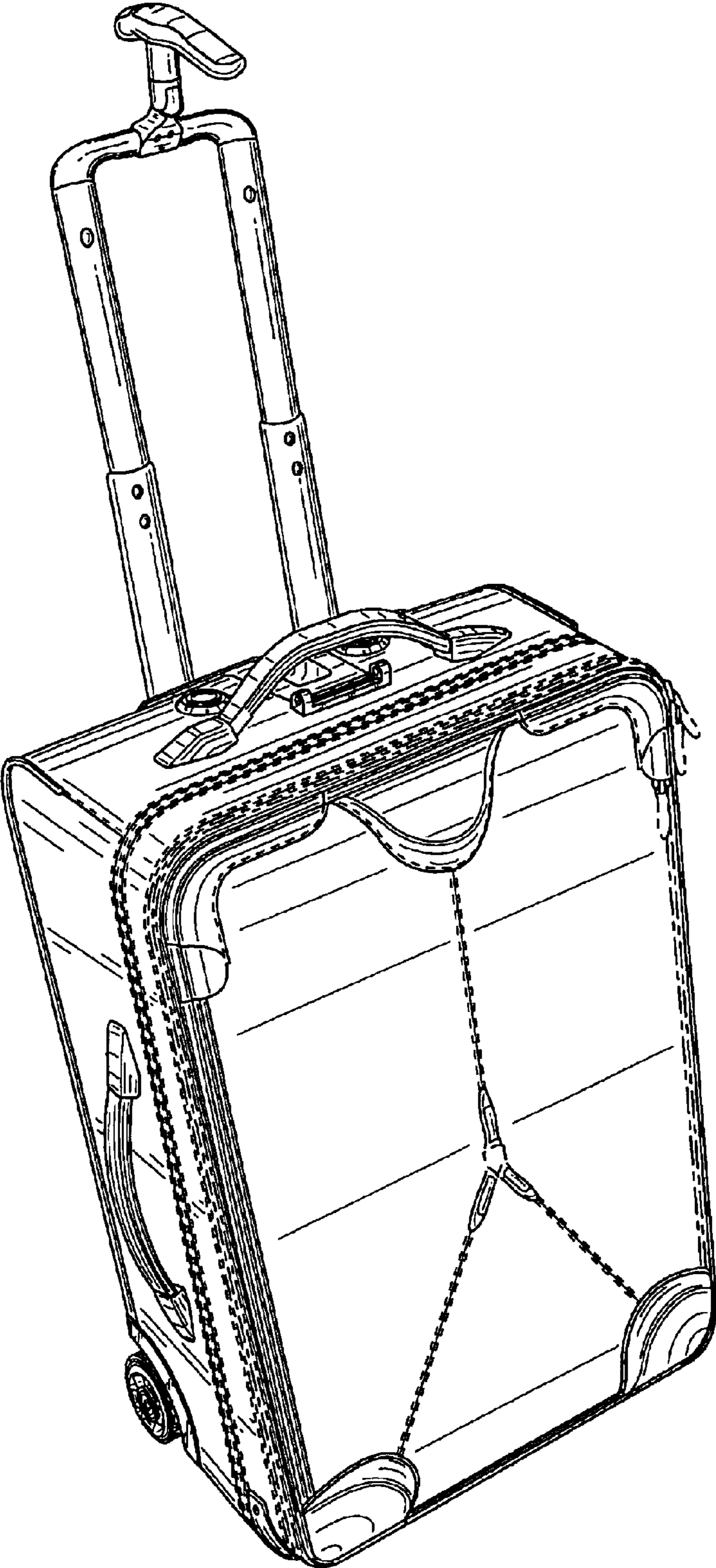
