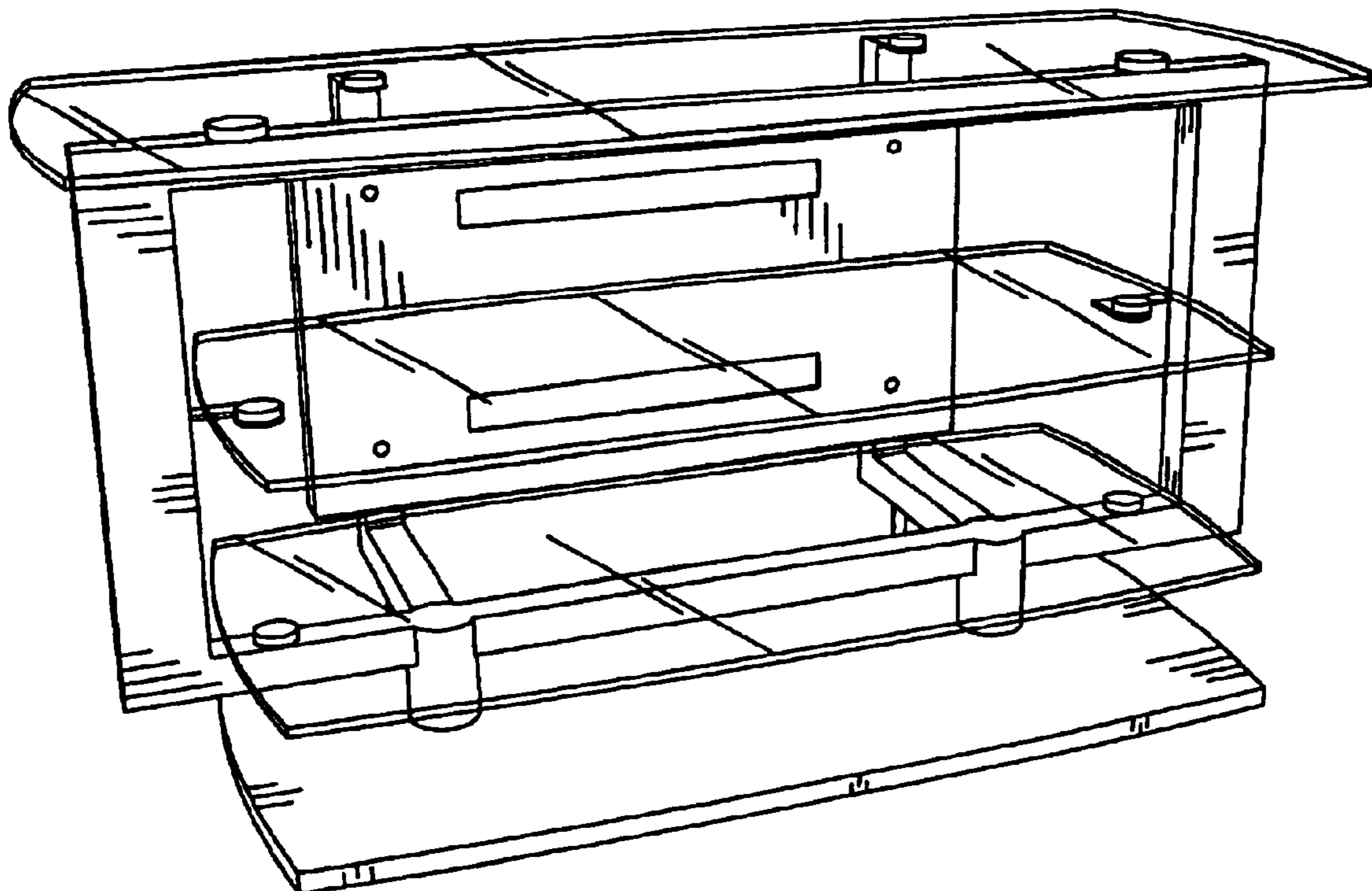

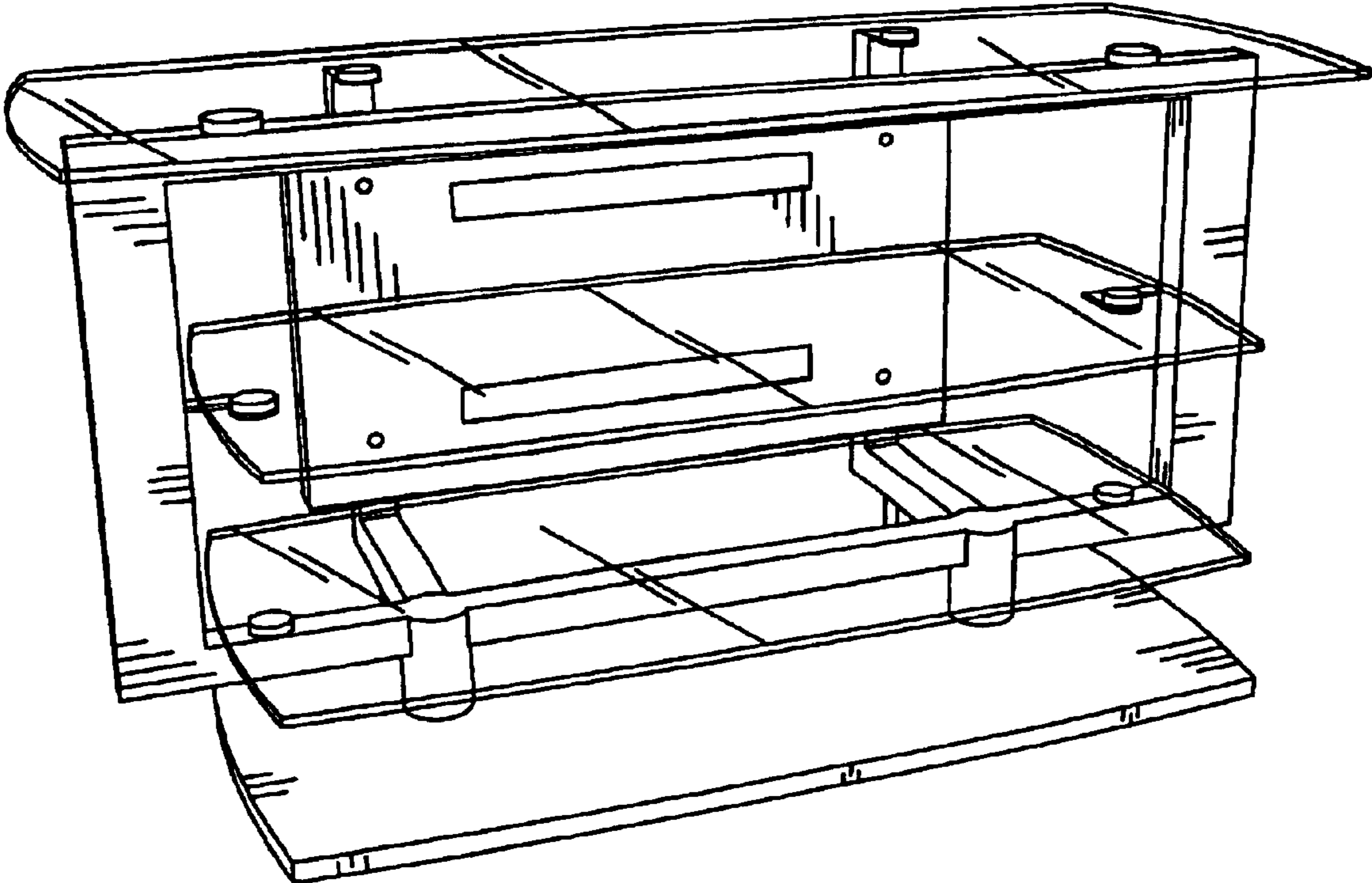
The ornamental design for an audio/video stand with double wide frame, as shown and described.

**DESCRIPTION**

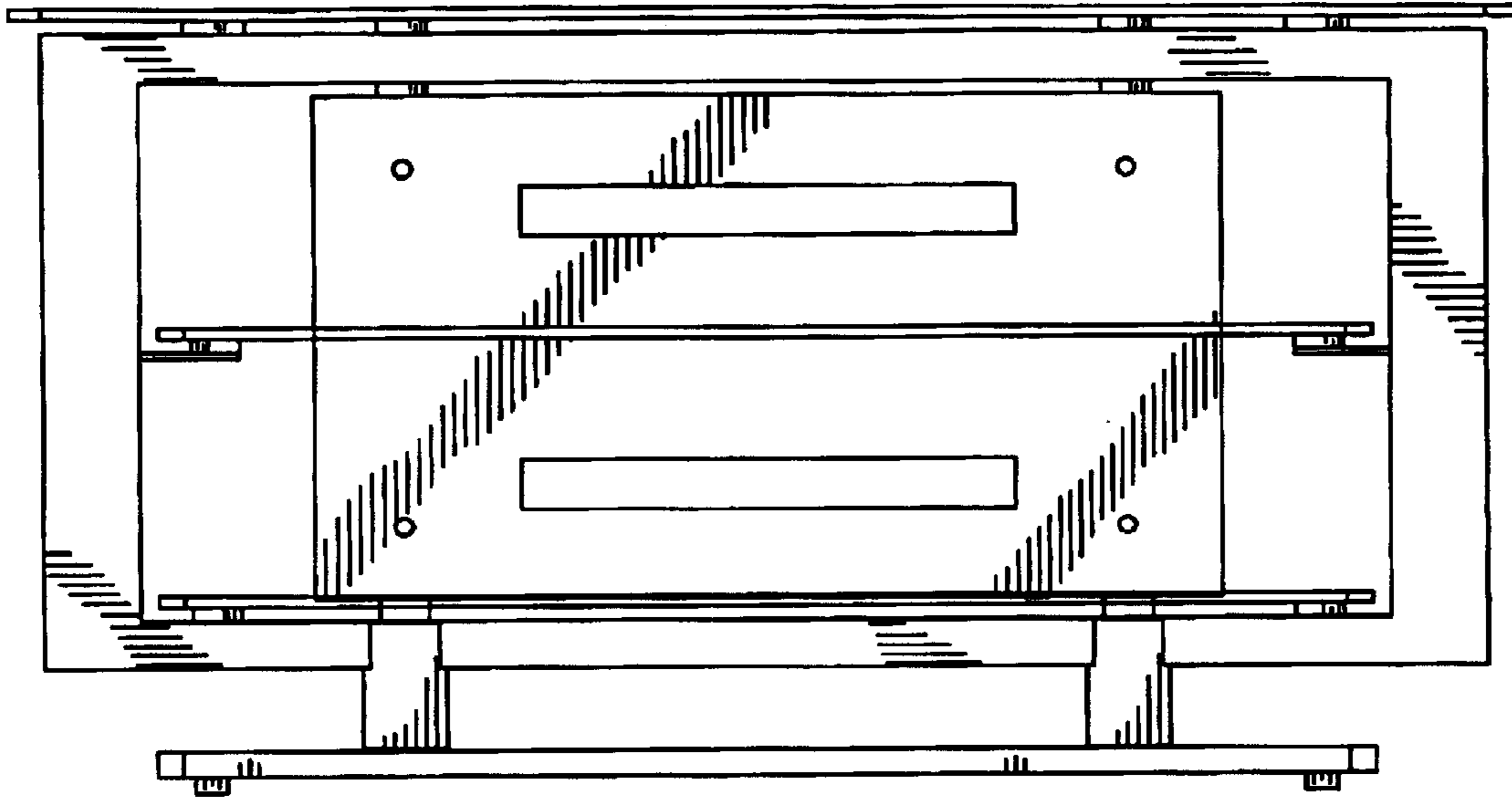

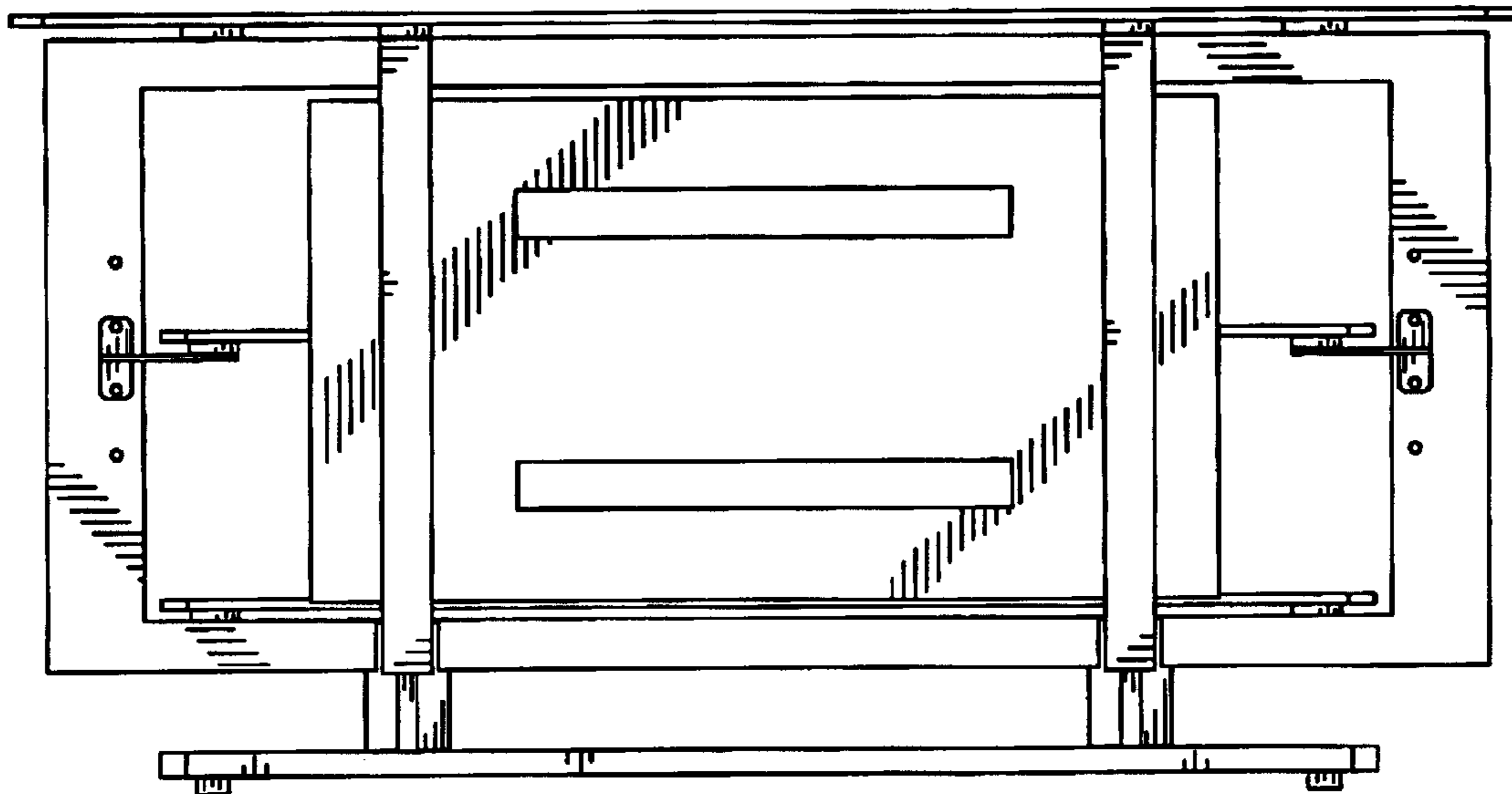




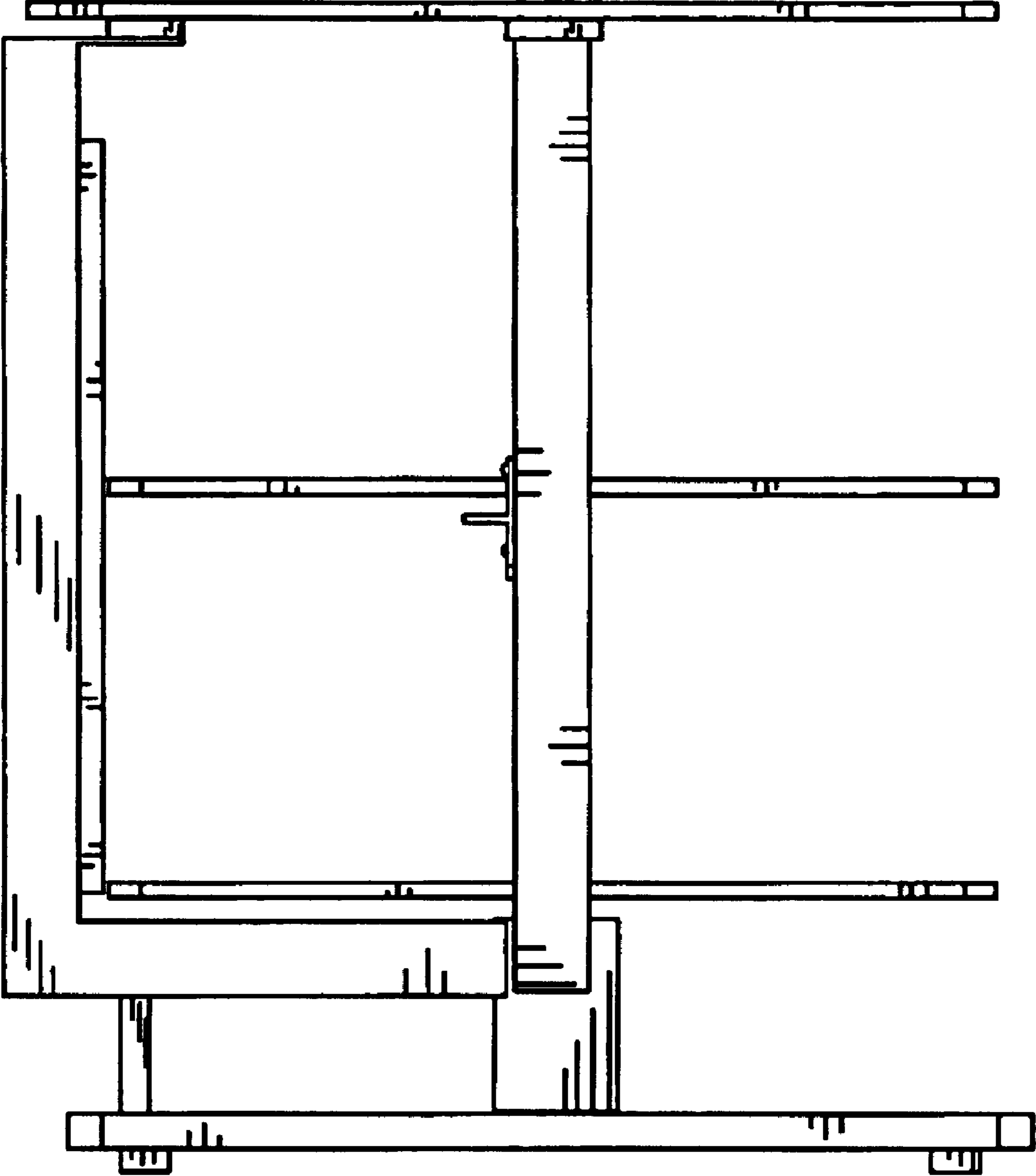

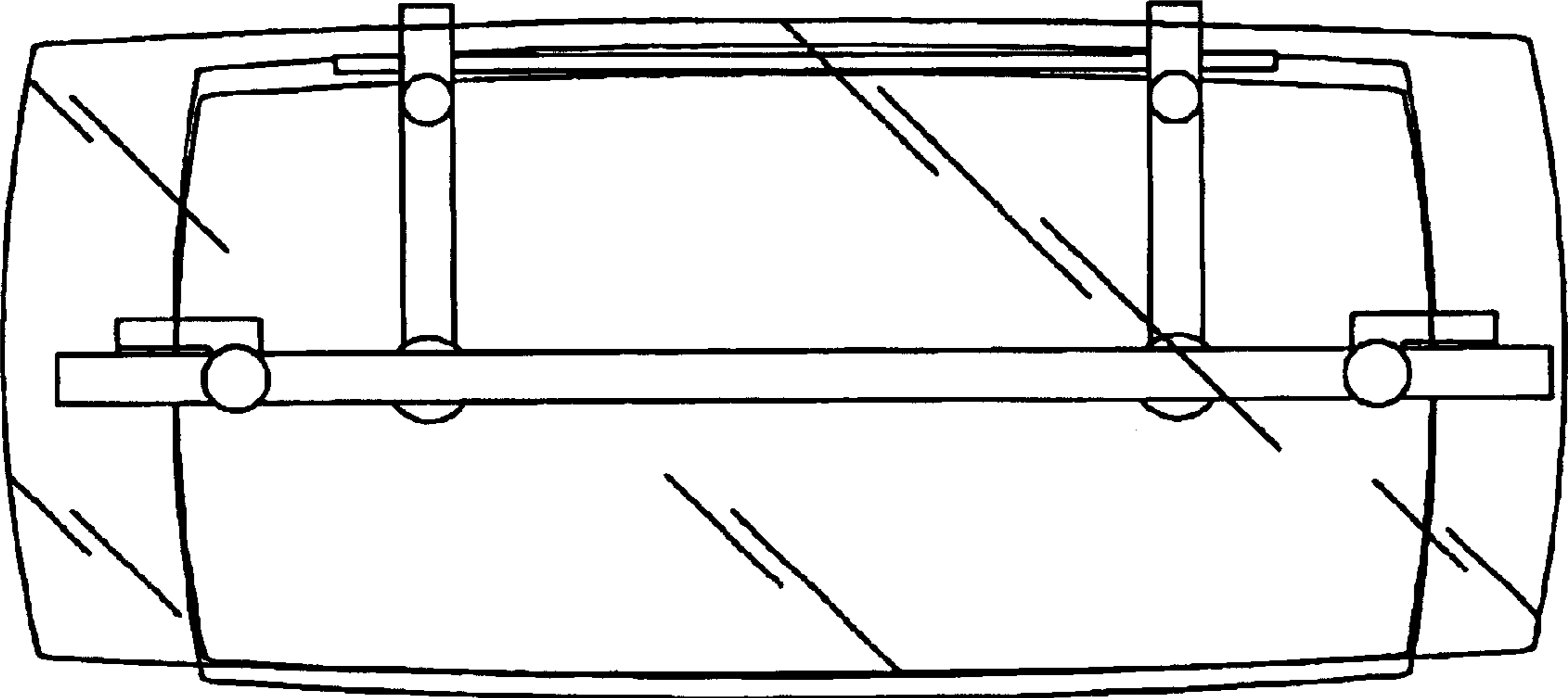

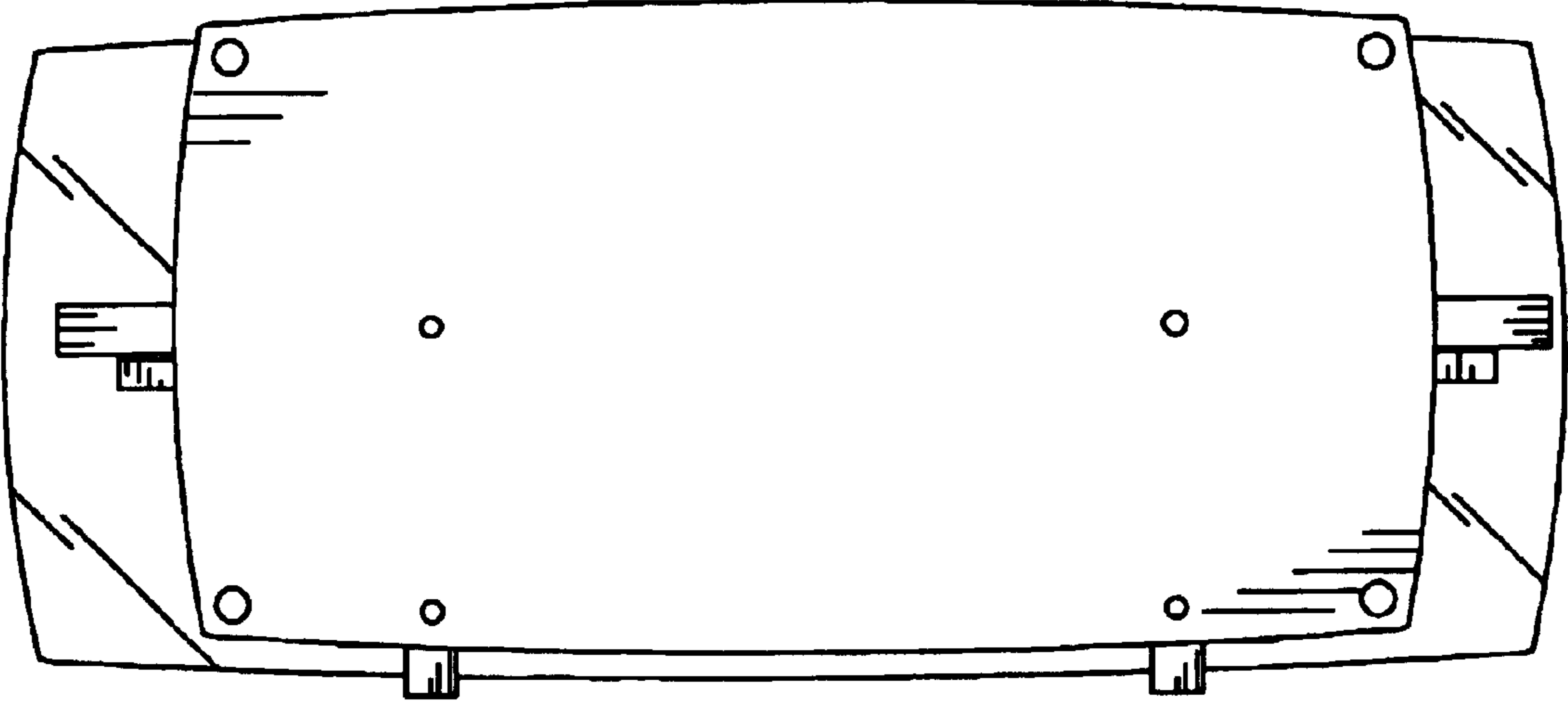
