FIG. 2 is a right side elevational view thereof; and,

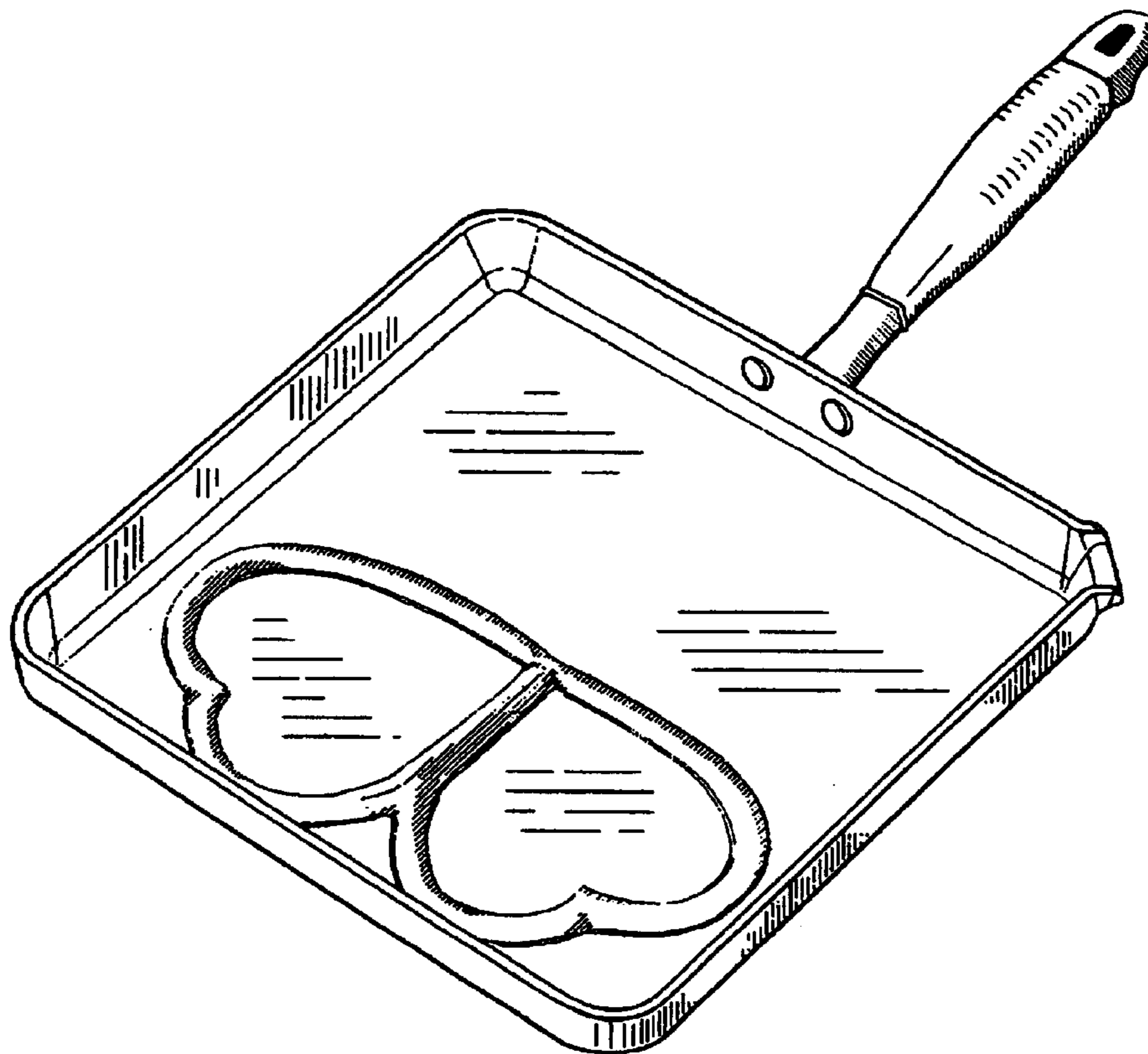
FIG. 3 is a top plan view thereof.

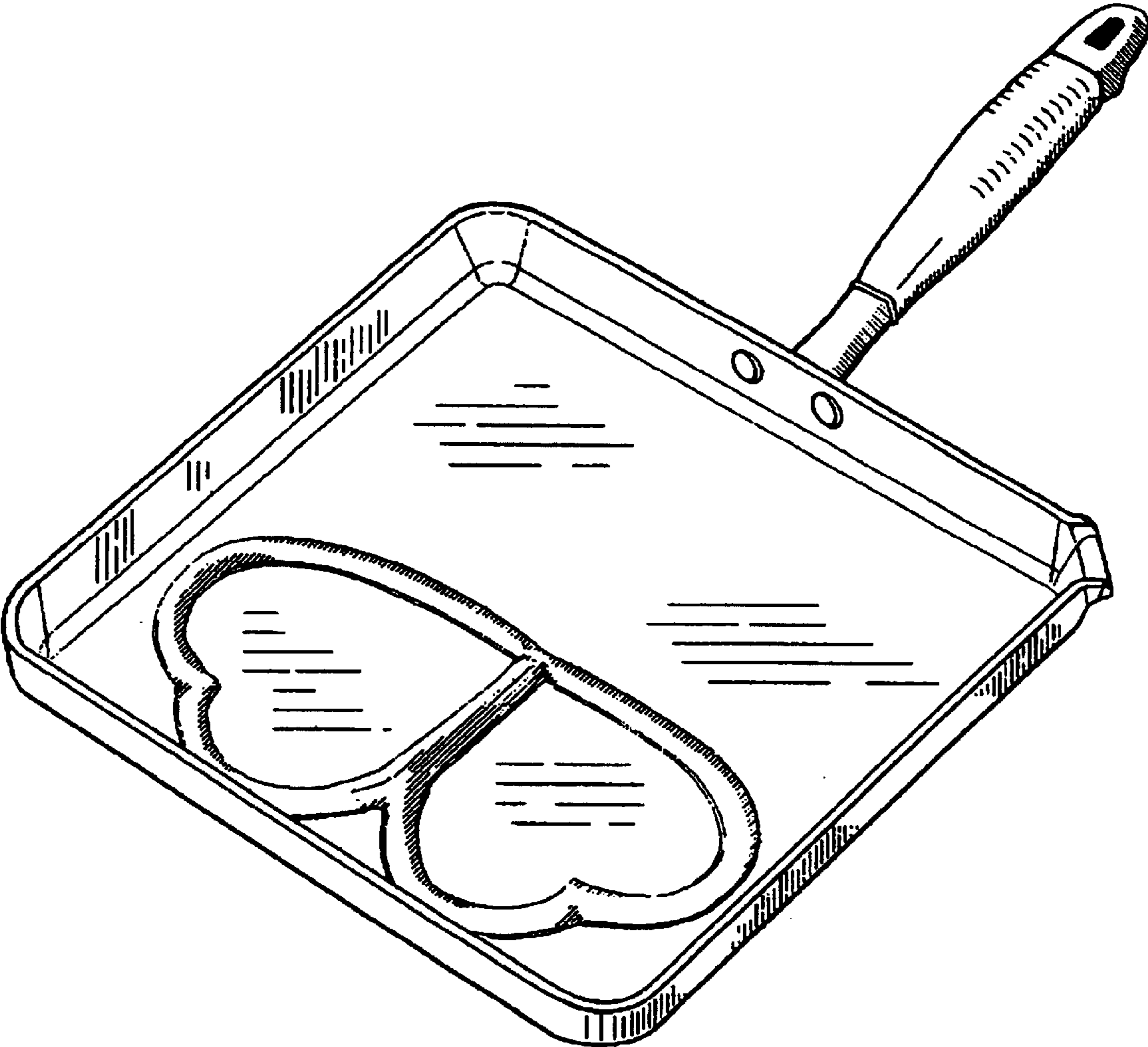

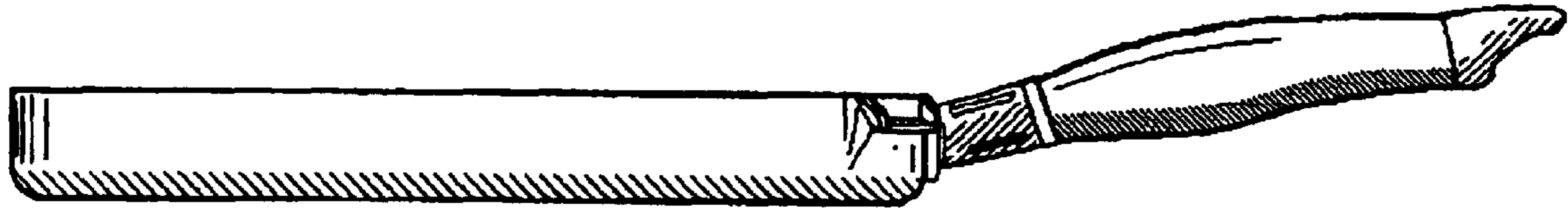

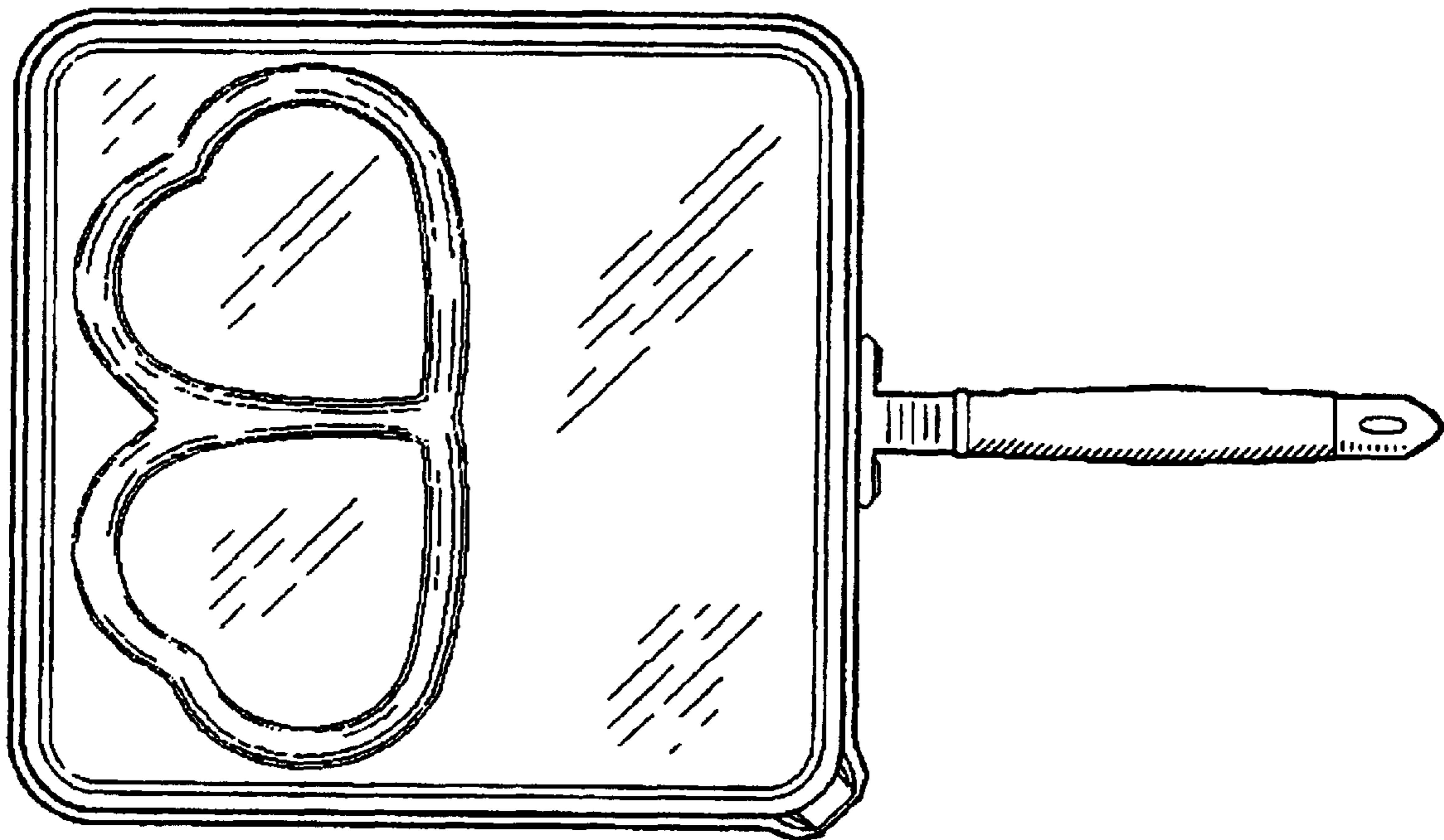
