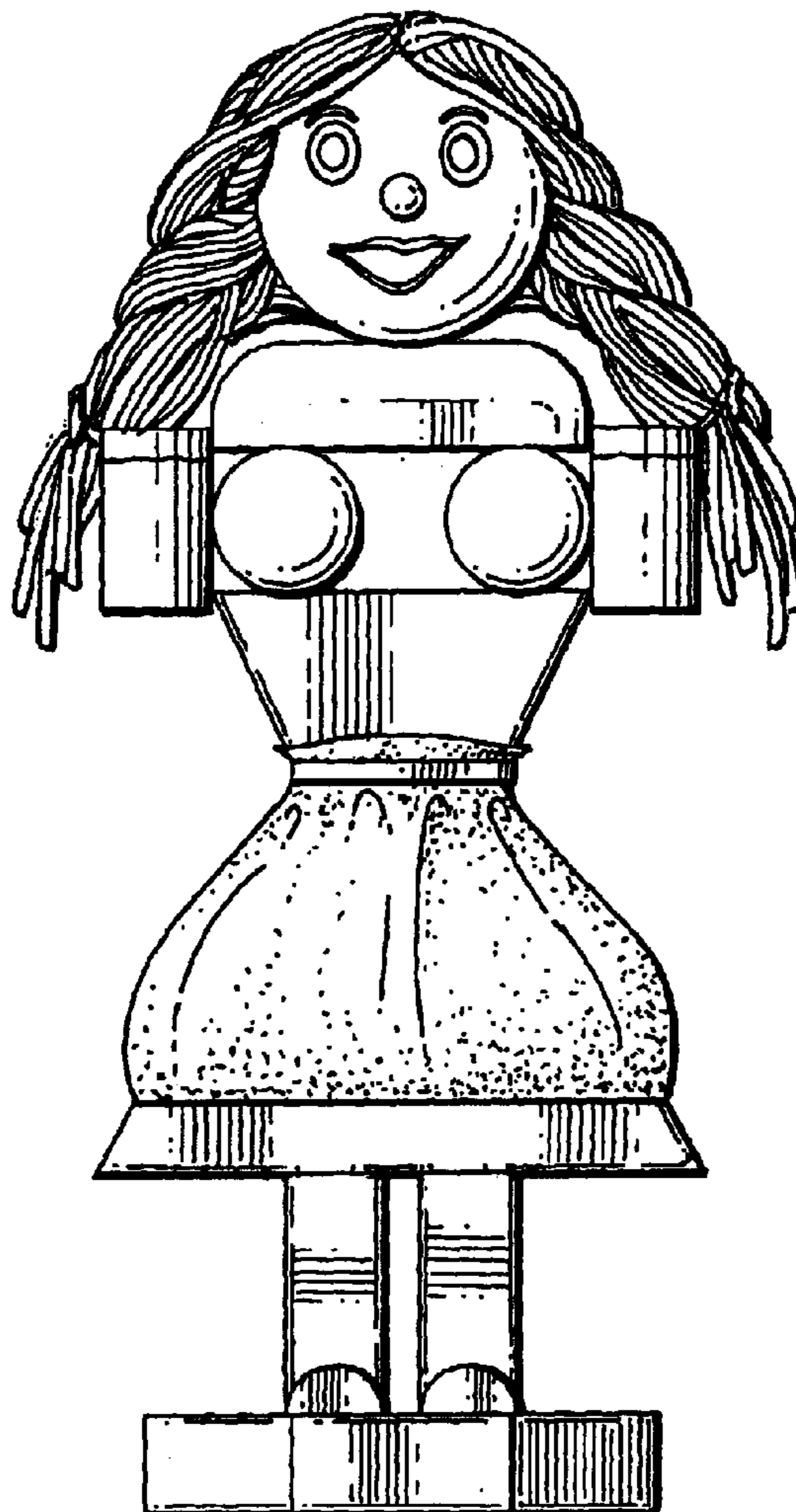
FIG. 1 is a front view of a nutcracker showing a new design;

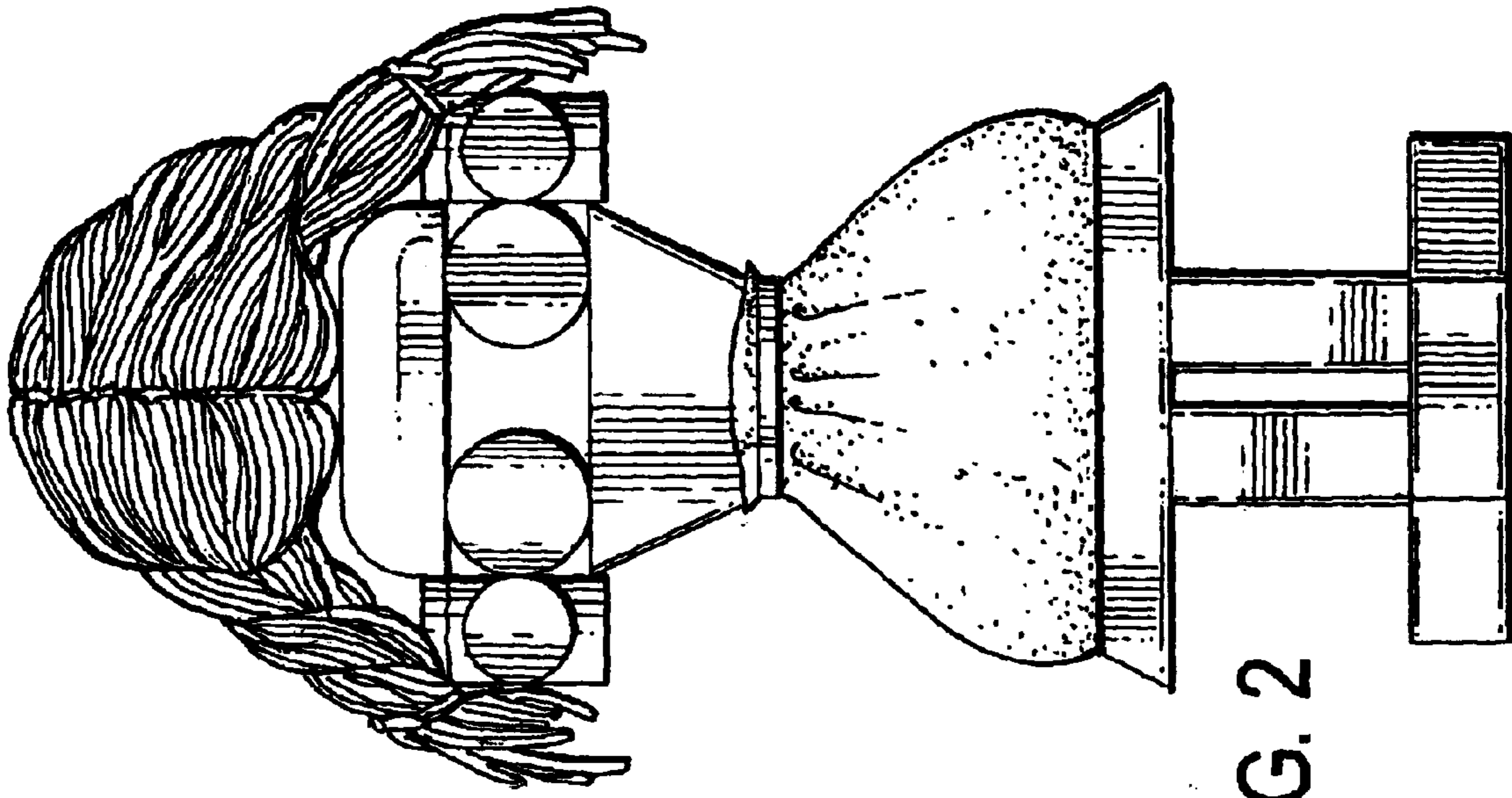

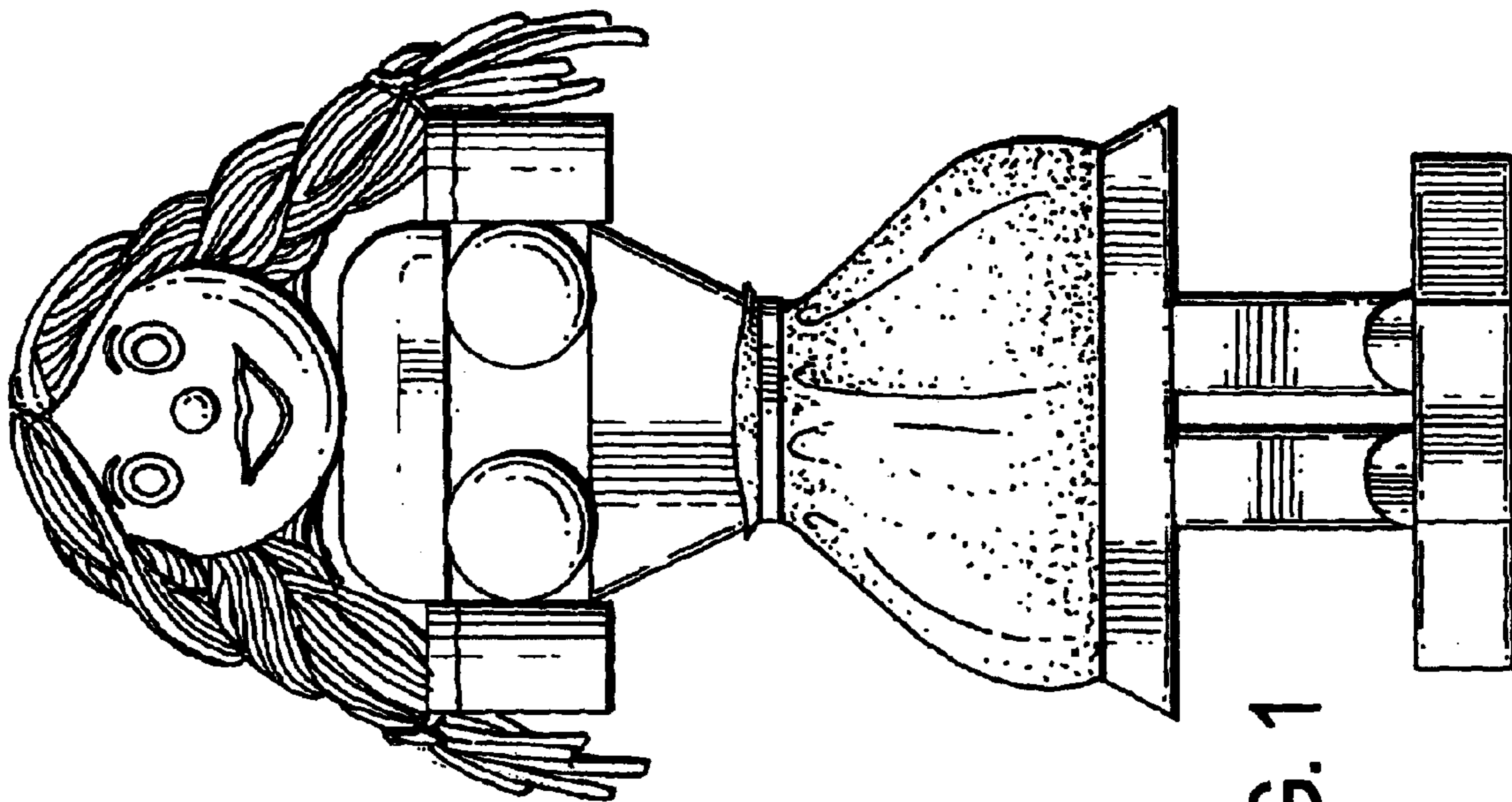

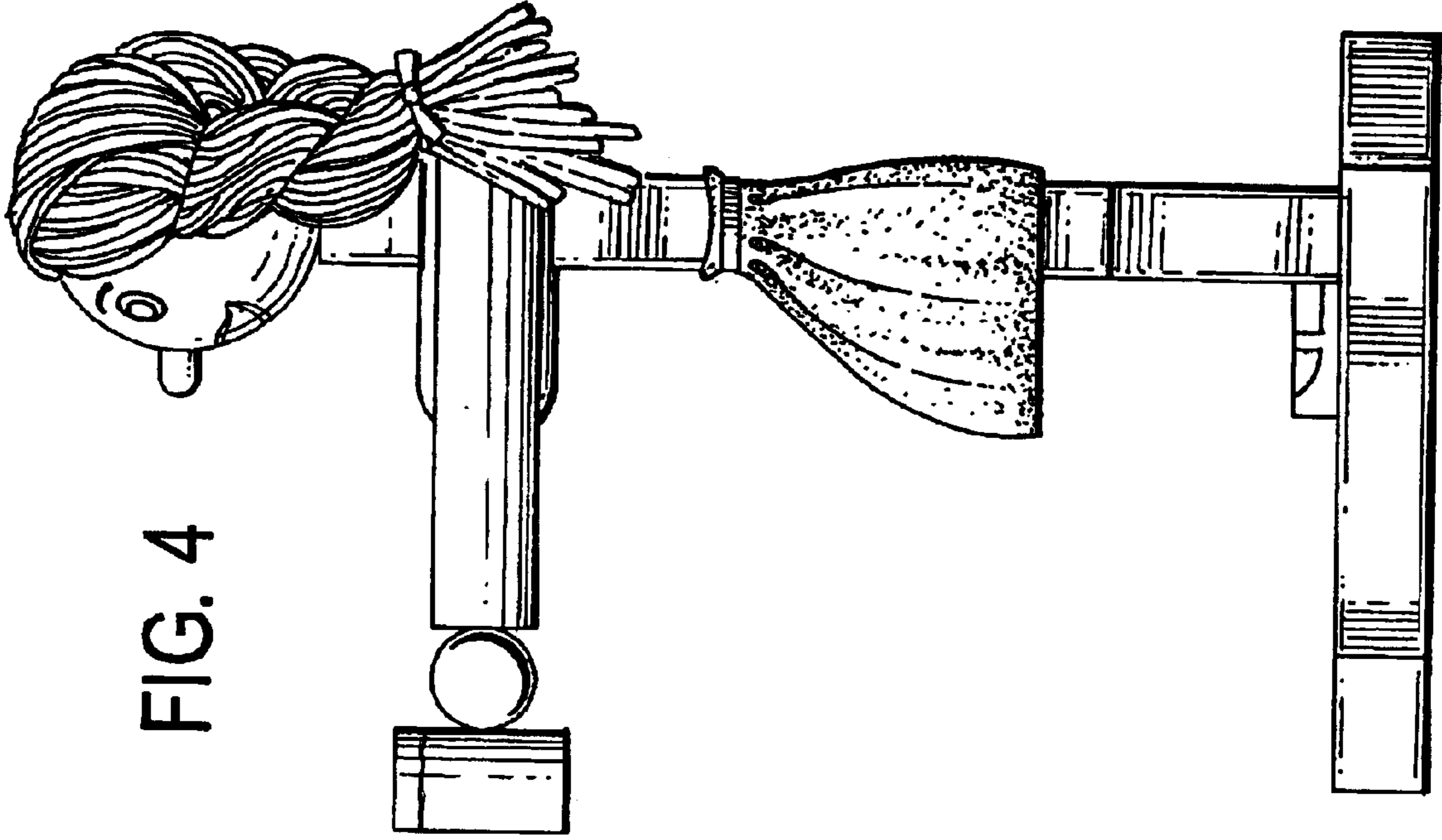

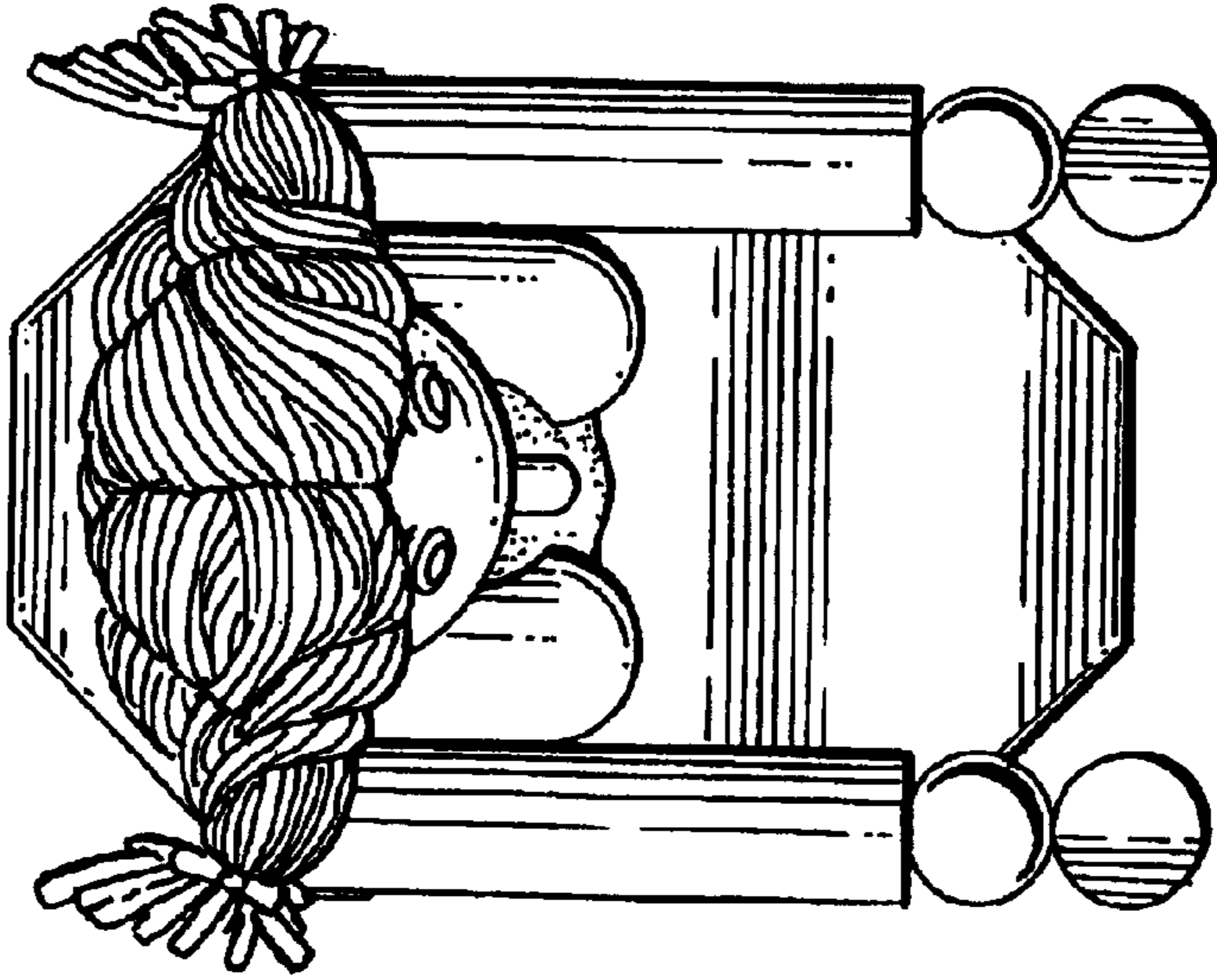

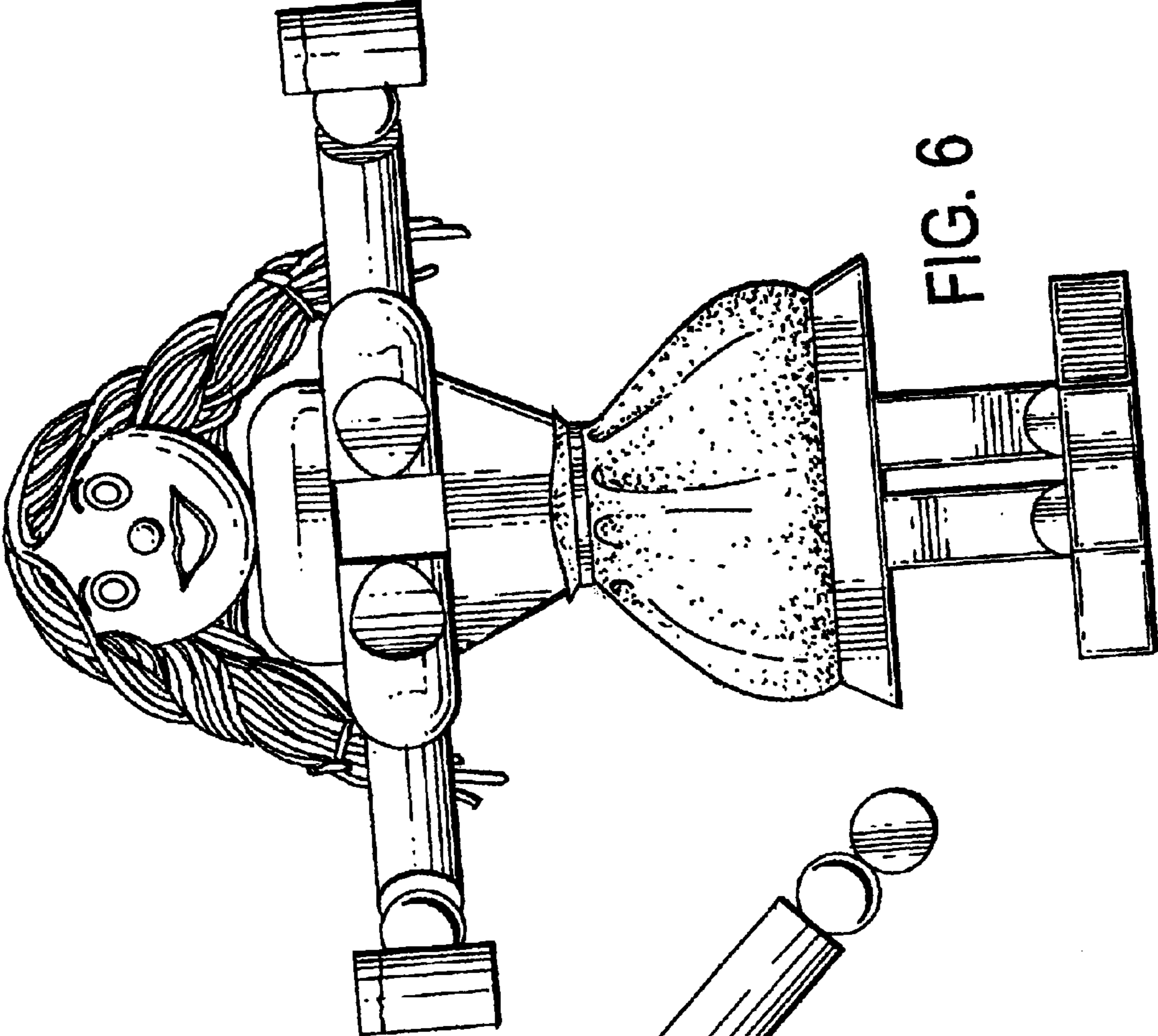

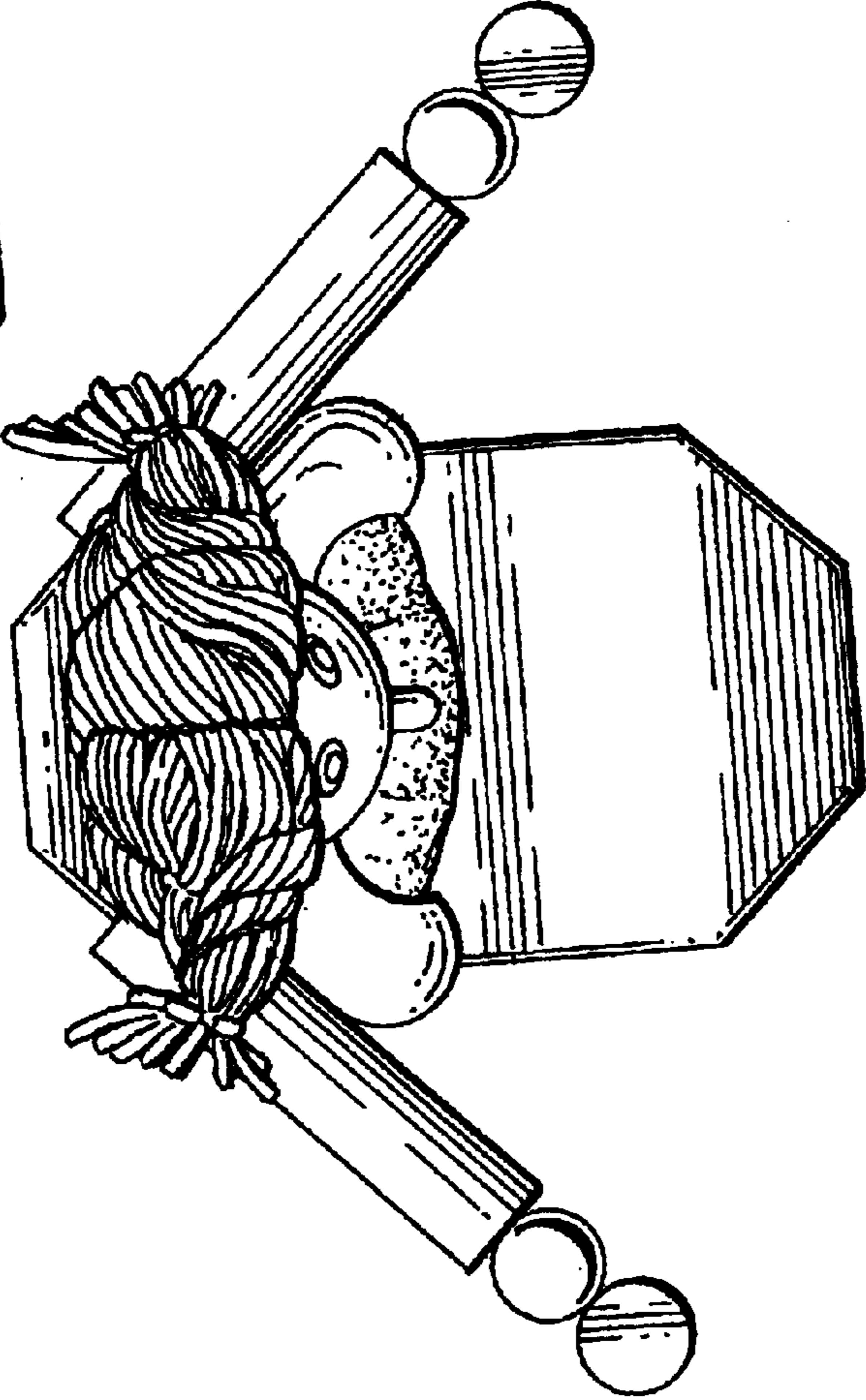
