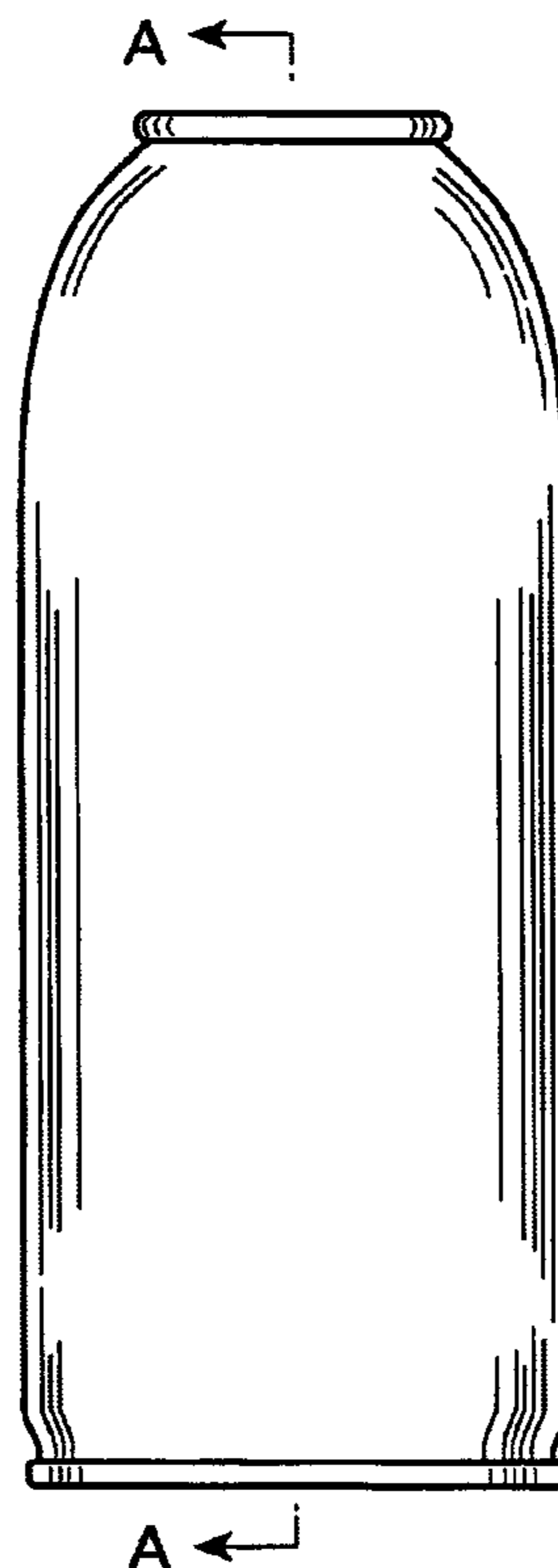
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front elevational view of a can showing our new design, a rear, left and right views being the same image; FIG. 2 is a top plan view thereof; FIG. 3 is a bottom plan view thereof; and, FIG. 4 is a cross sectional view thereof, taken along line 4-4 of FIG. 1.

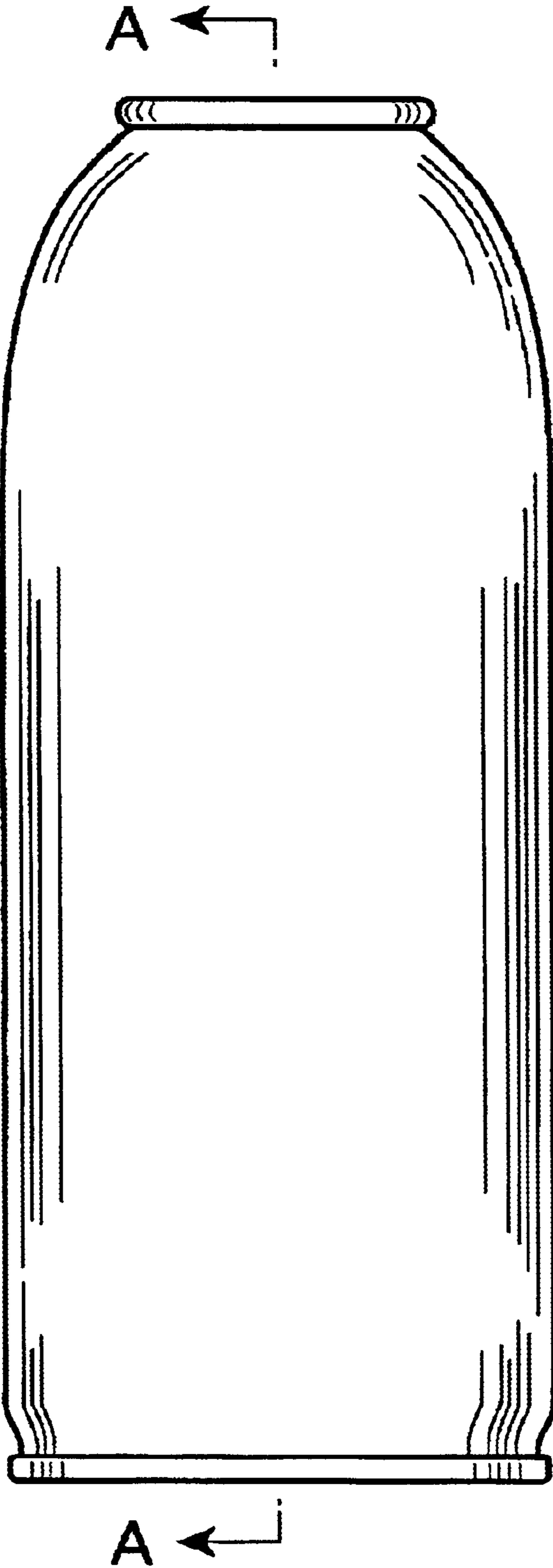

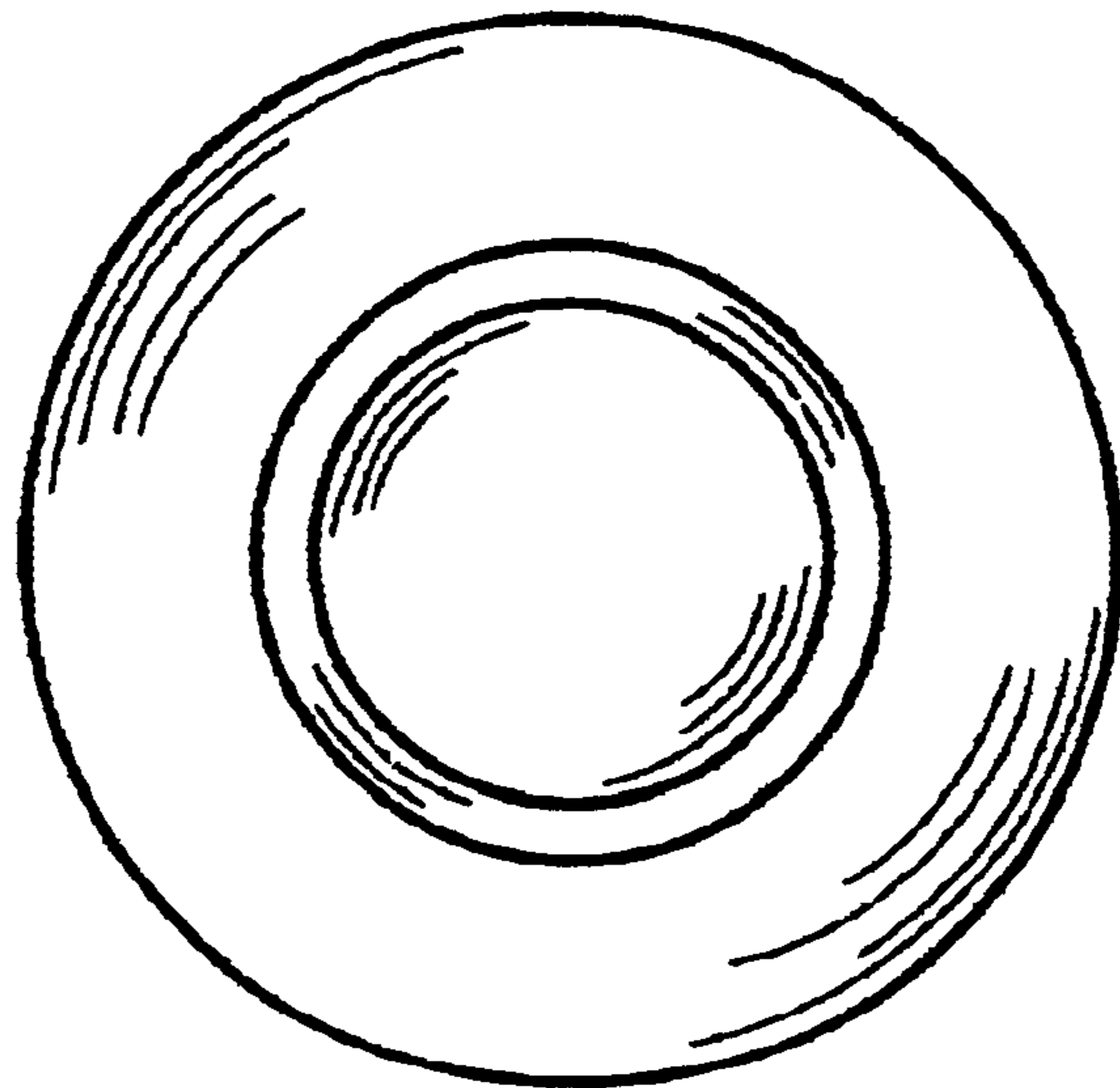

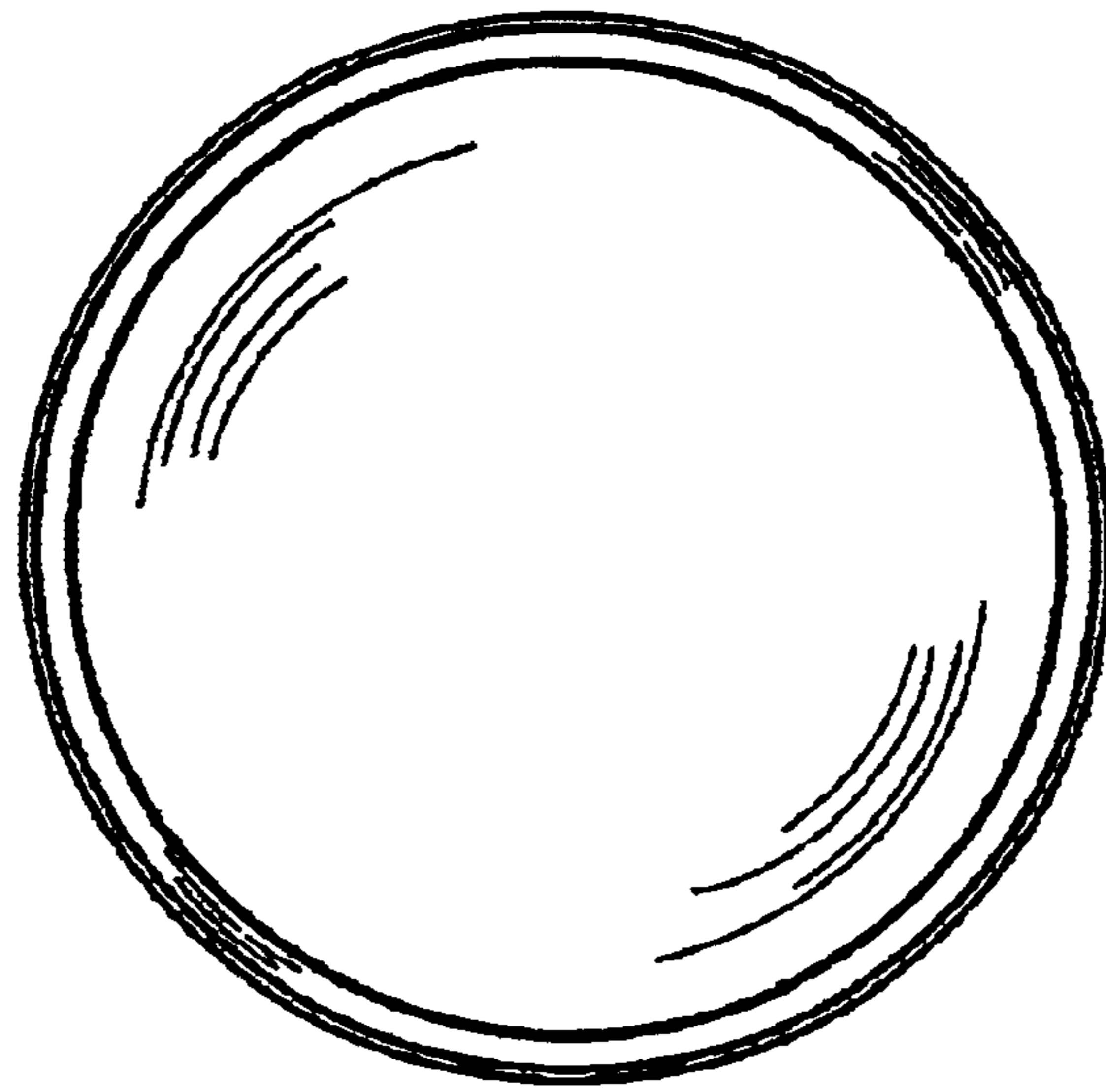

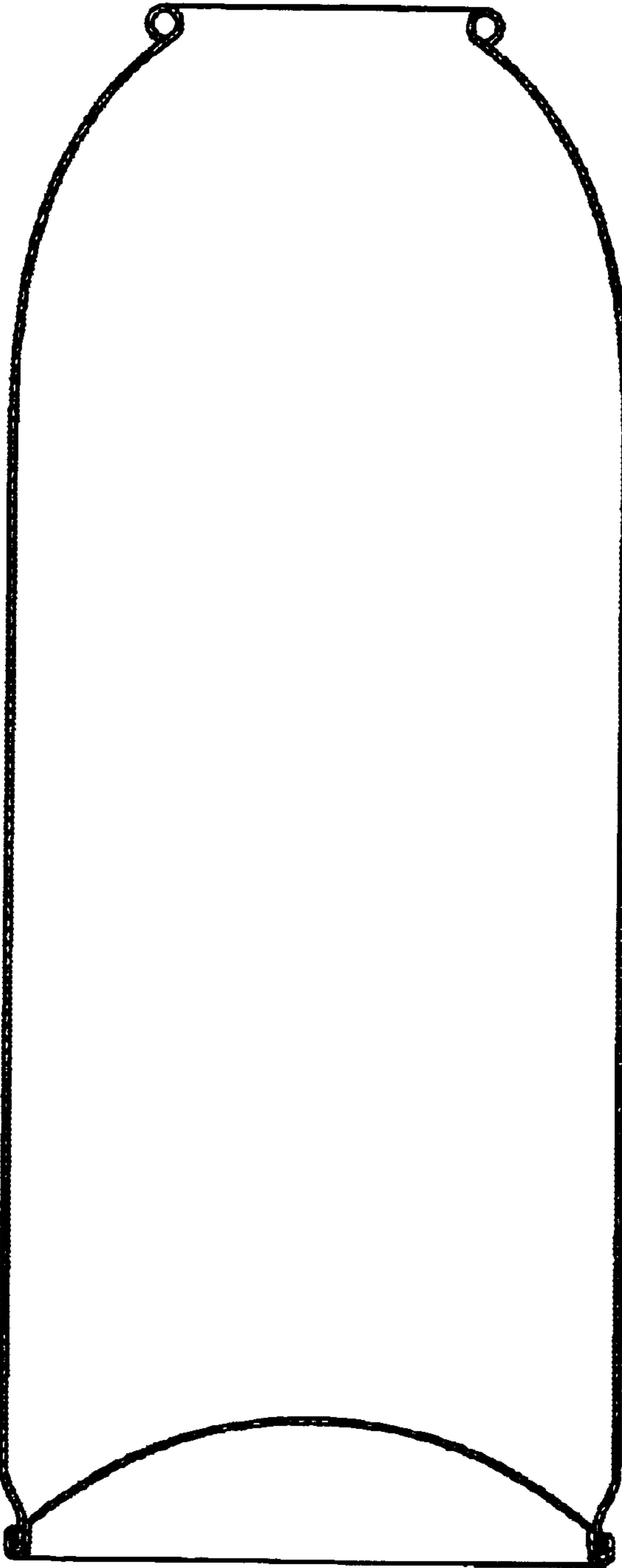
